The ornamental design for an element of upper, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of one side of an element of upper showing one embodiment my new design;

FIG. 2 is a side elevational view of the other side of the element of upper as shown in FIG. 1;

FIG. 3 is a rear elevational view of the element of upper as shown in FIG. 1;

FIG. 4 is a top plan view of the element of upper as shown in FIG. 1;

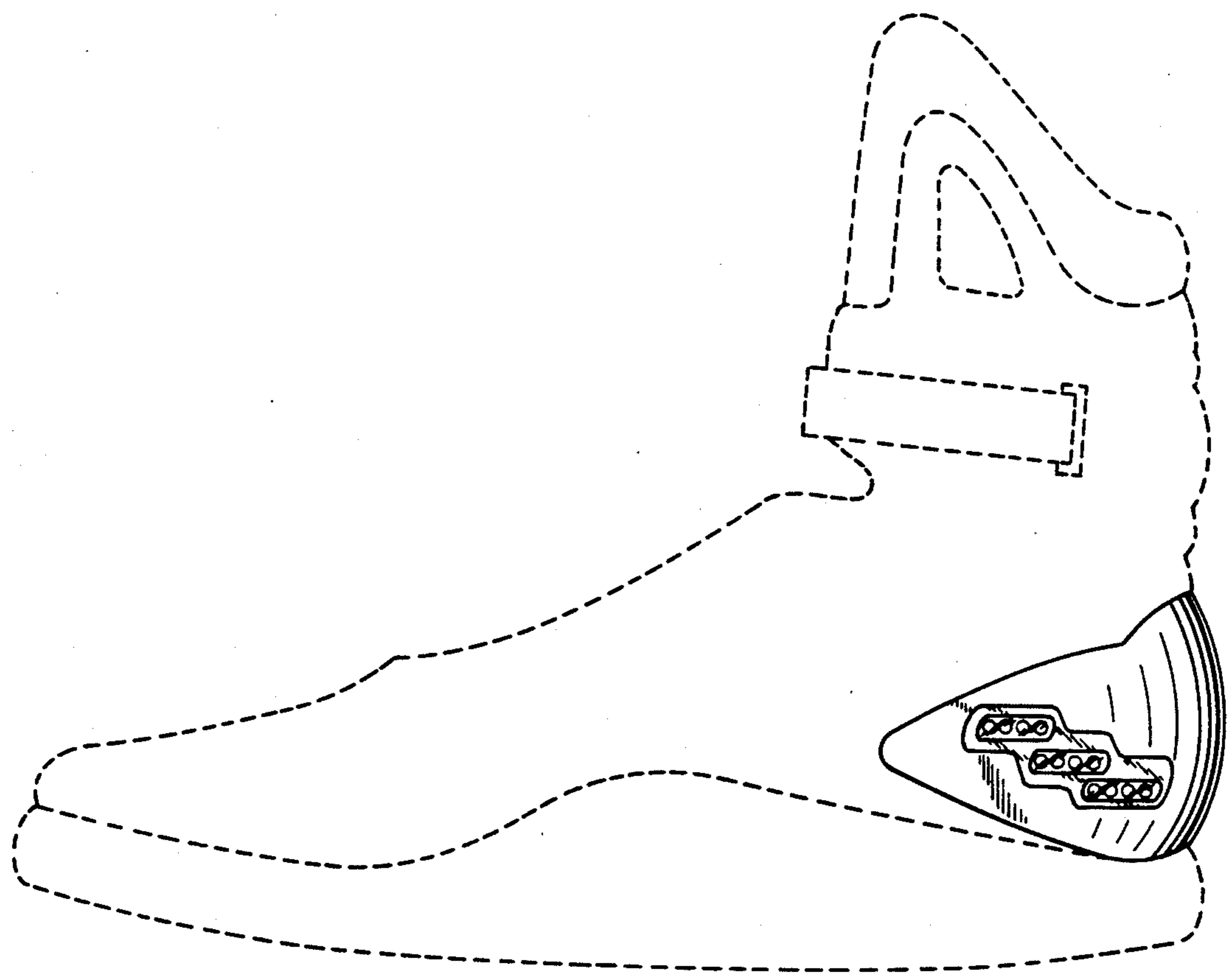
FIG. 5 is a side elevational view of one side of an element of upper showing another embodiment of my new design;

The broken line showing of a shoe in FIGS. 1-8 is for illustrative purposes only and forms no part of the claimed design.



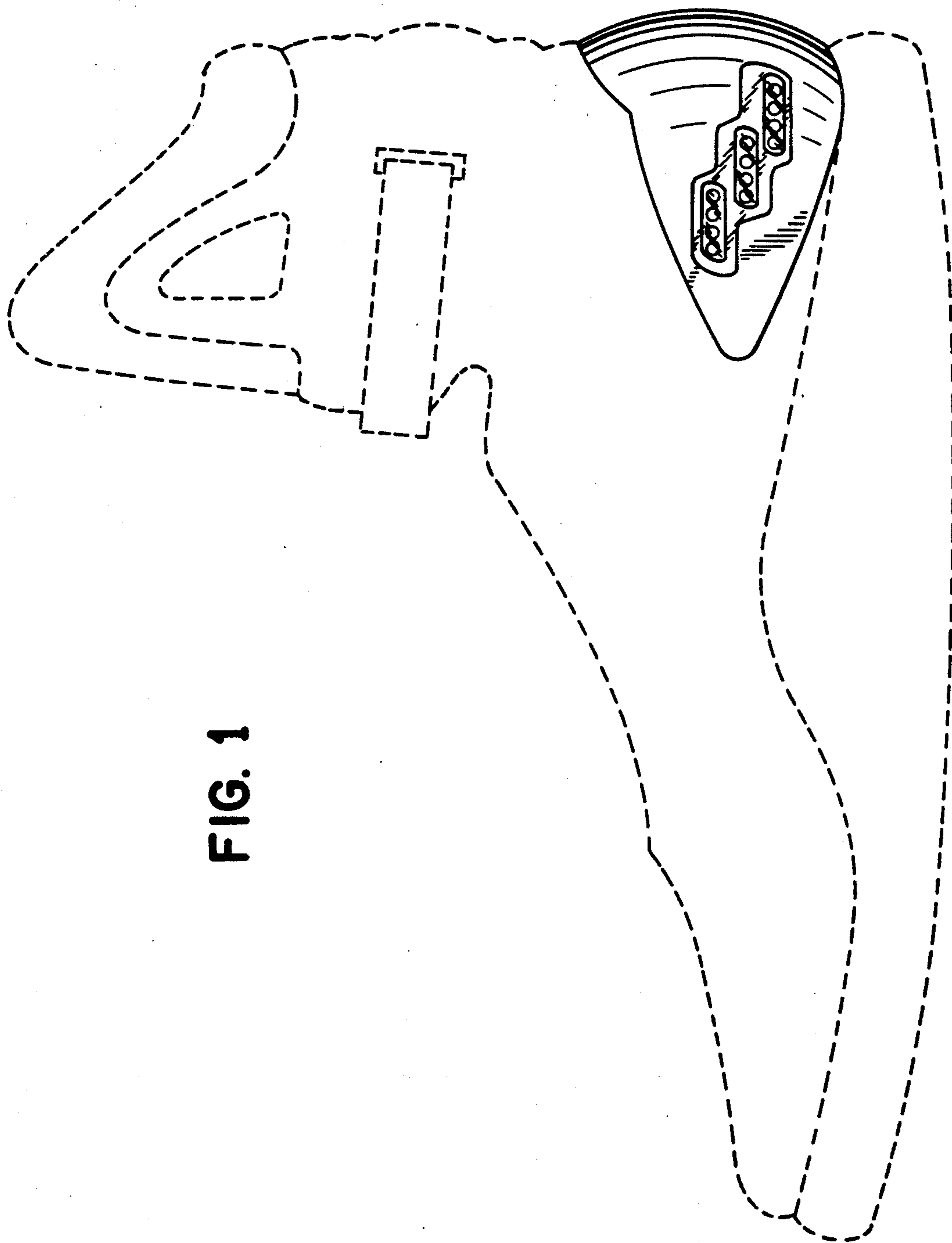

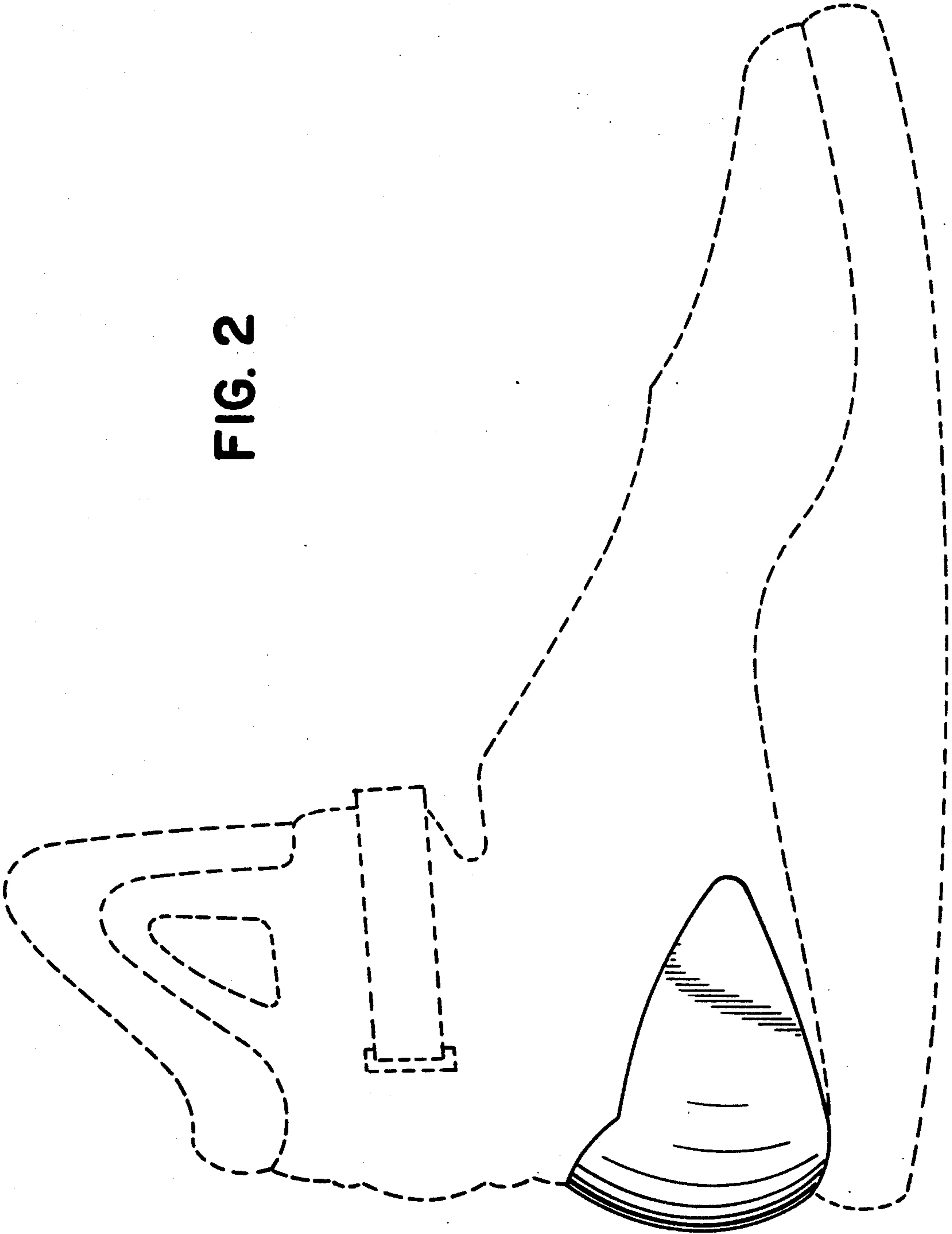

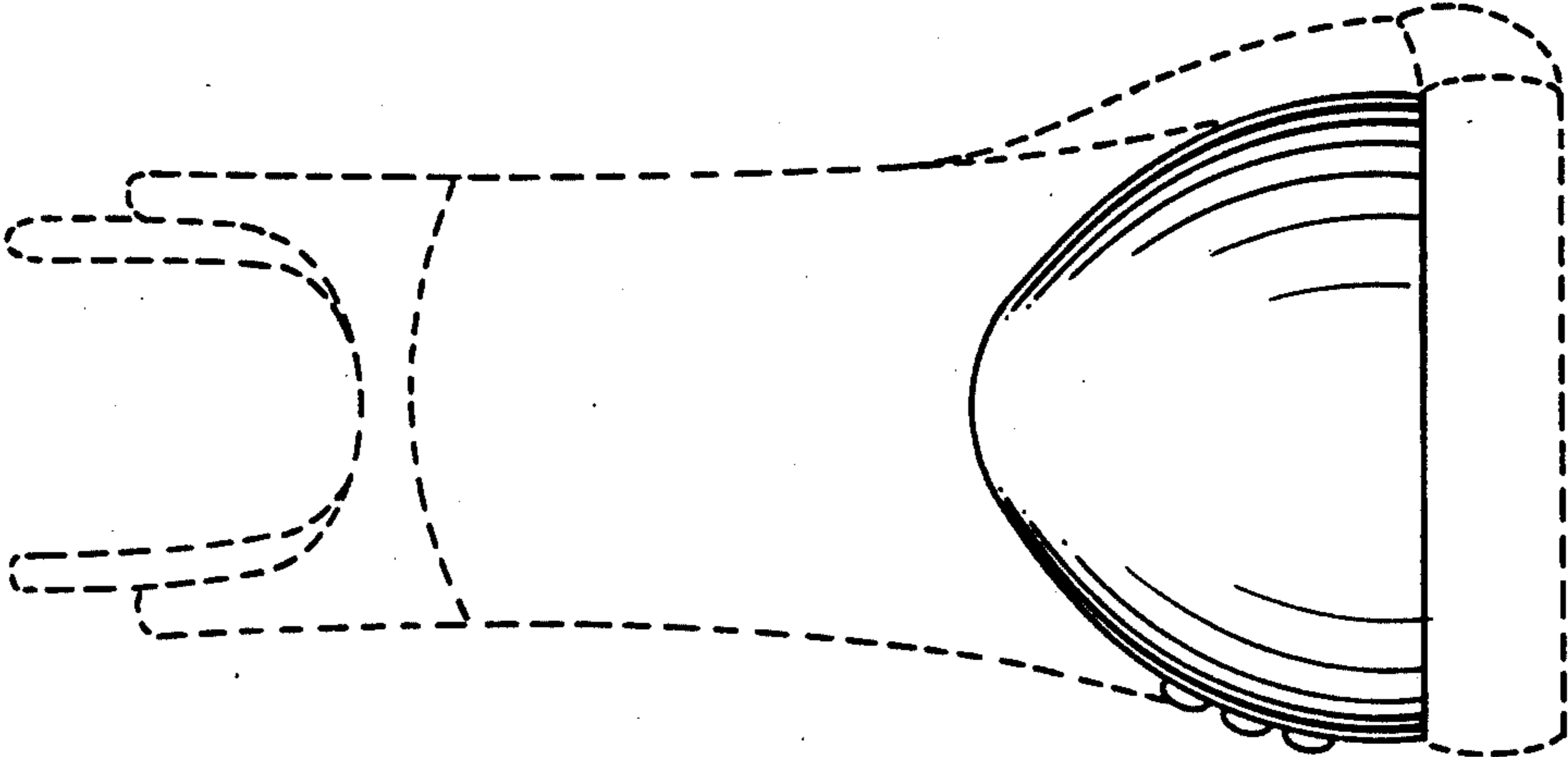
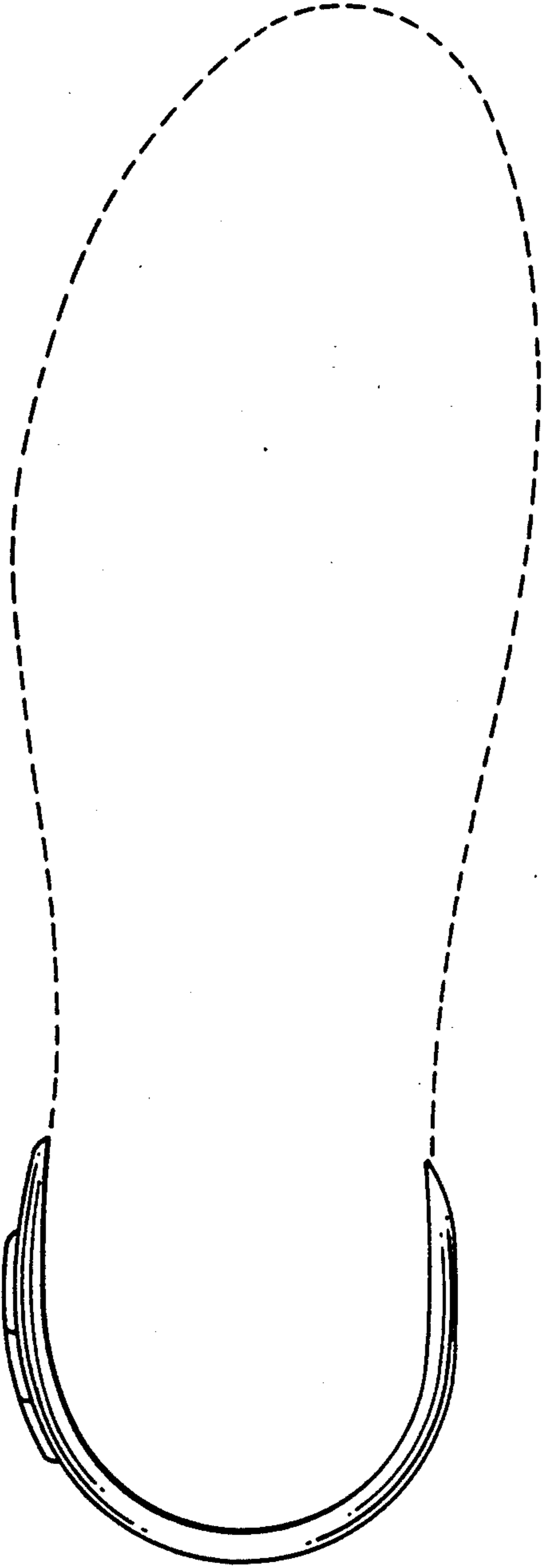

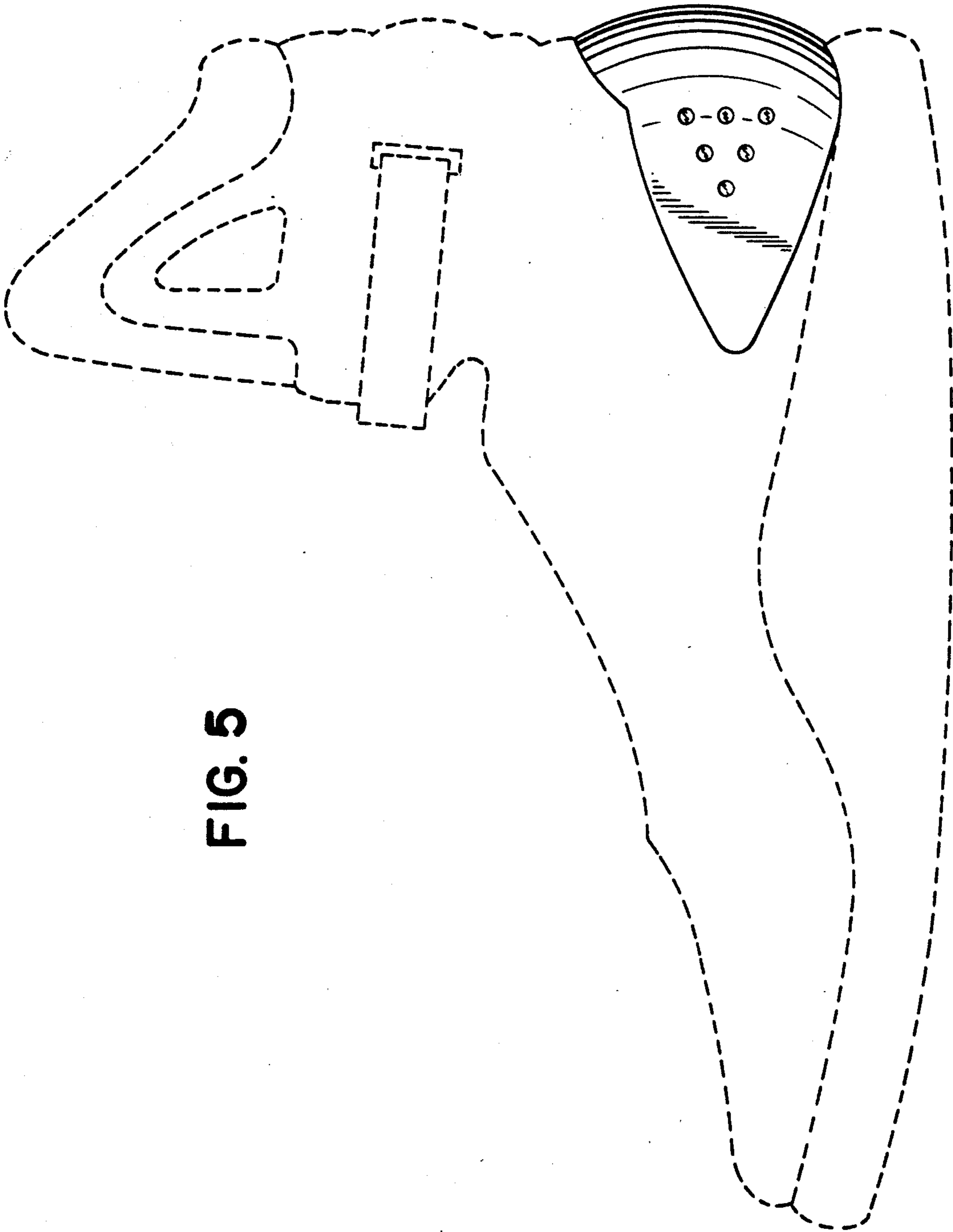

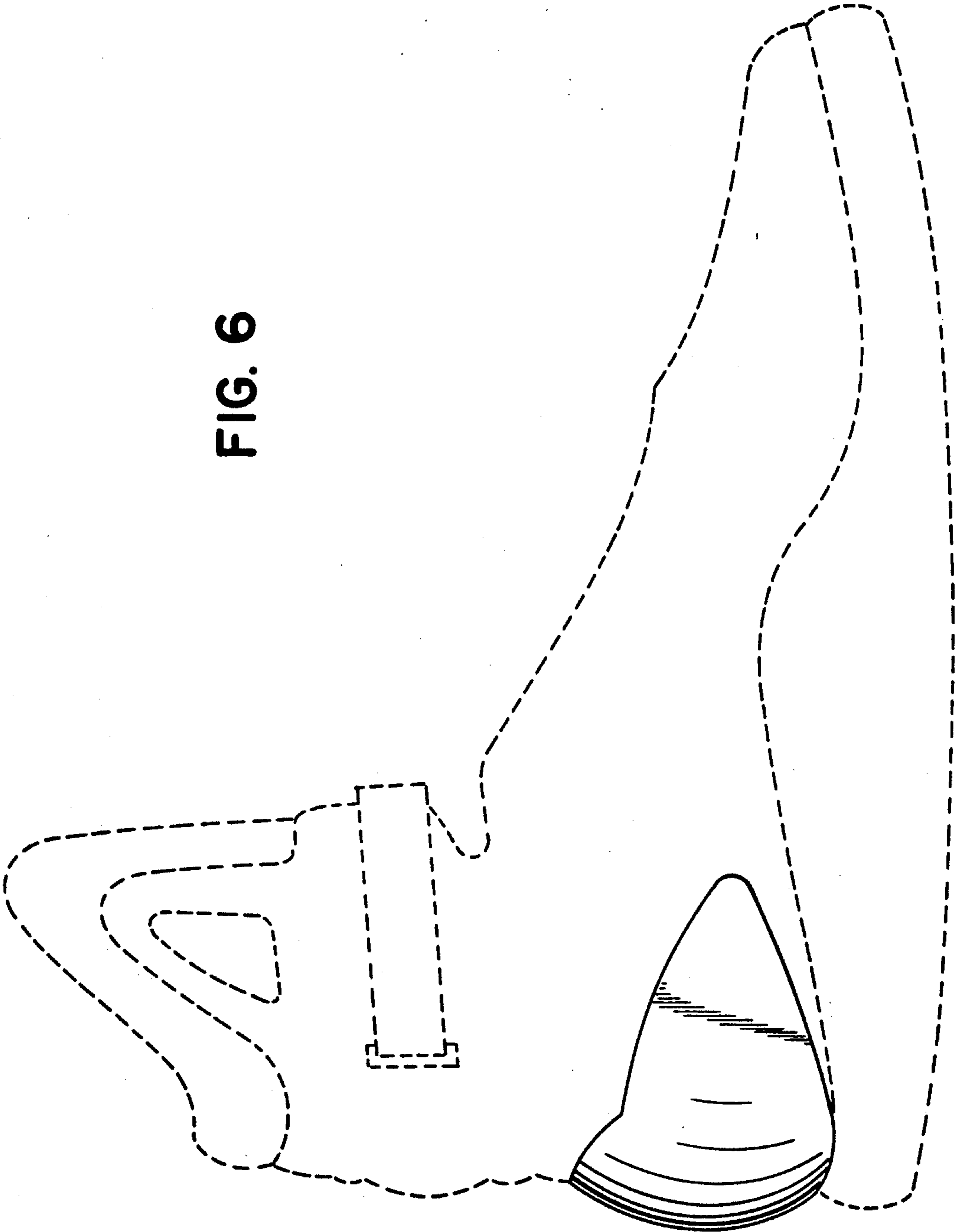

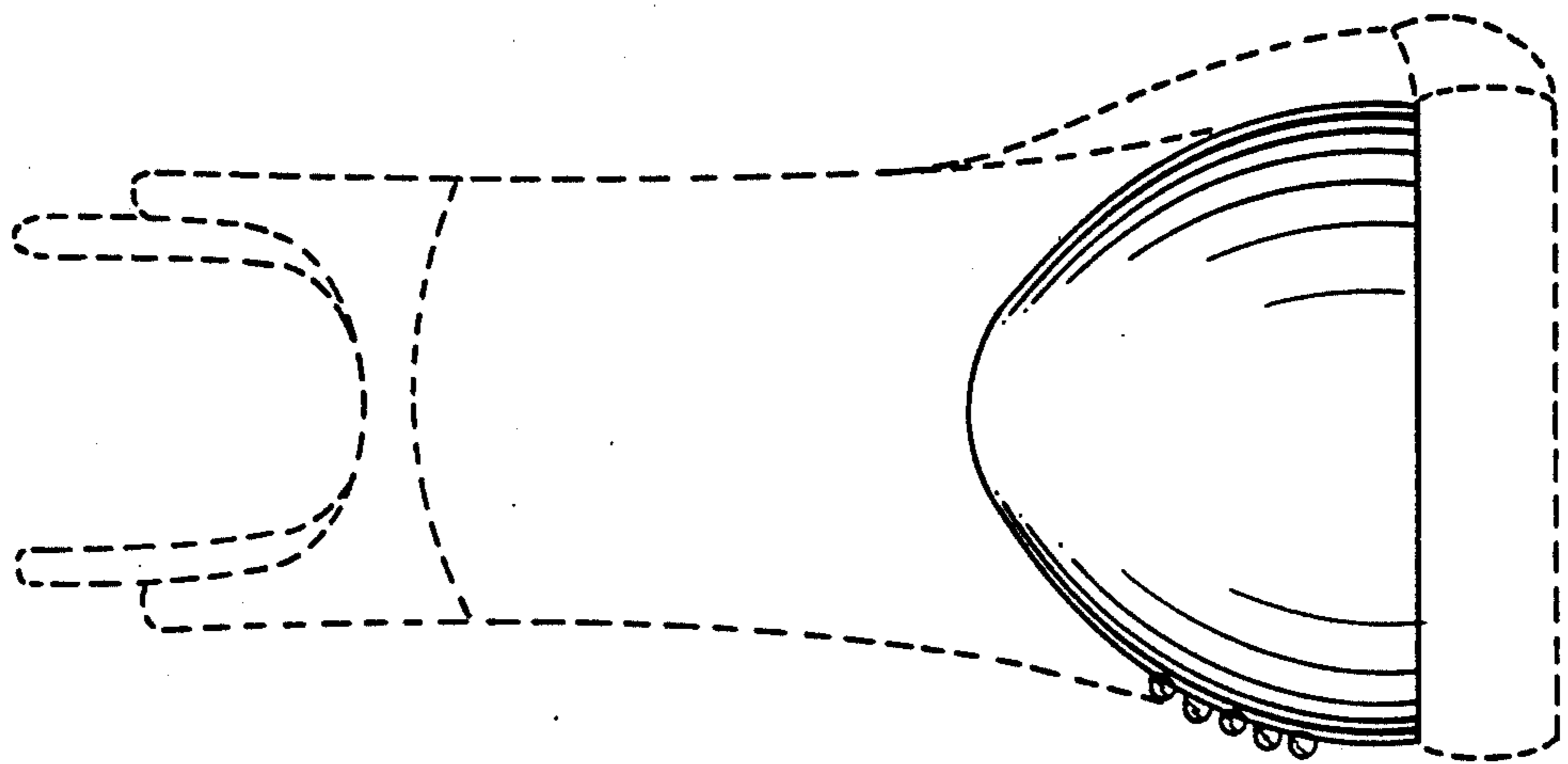
