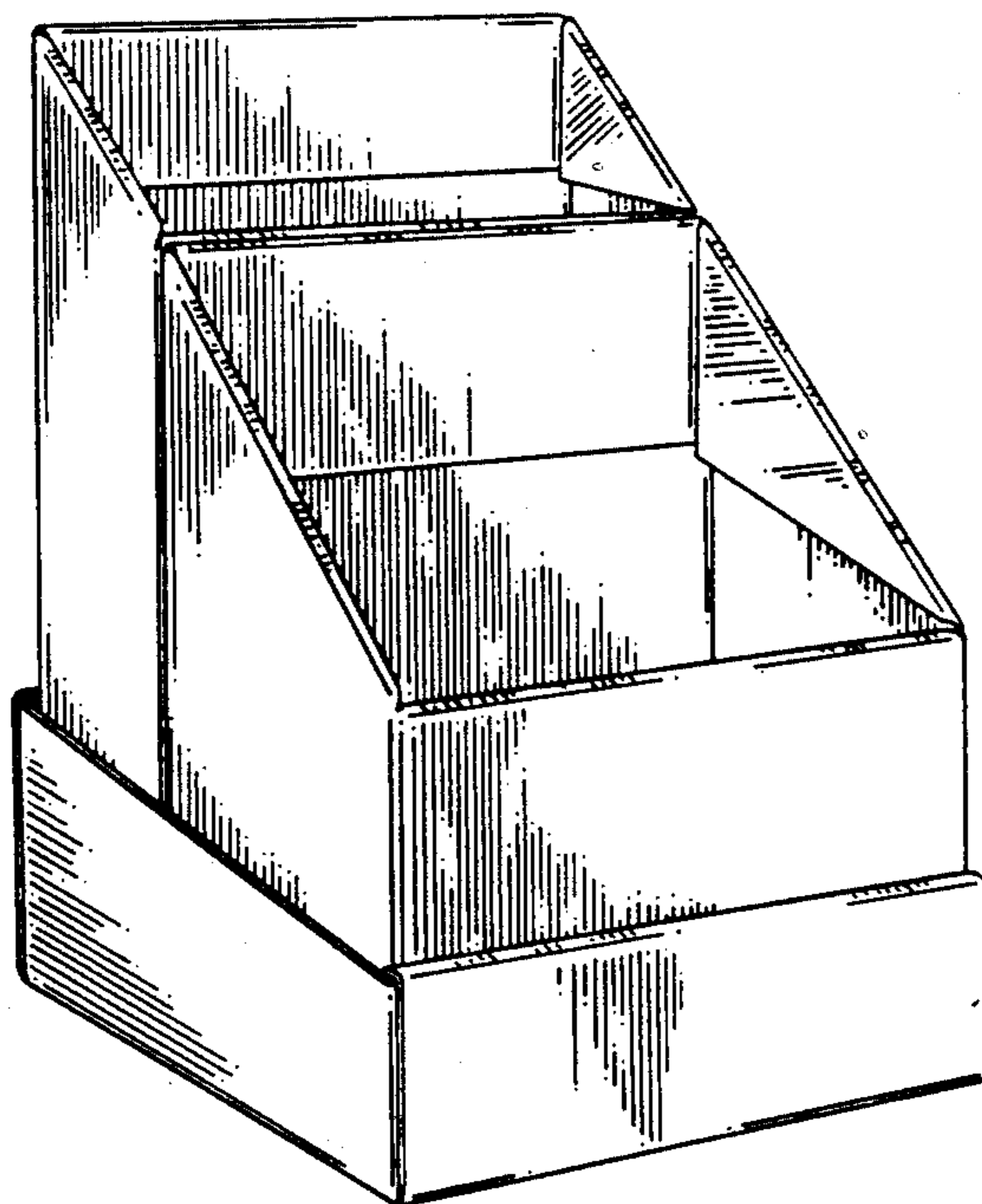

[57] CLAIM

The ornamental design for a file for recyclable paper materials, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the file for recyclable paper materials showing my new design;
 FIG. 2 is a left side elevational view thereof;
 FIG. 3 is a right side elevational view thereof;
 FIG. 4 is a top plan view thereof;
 FIG. 5 is a bottom plan view thereof;
 FIG. 6 is a front elevational view thereof;
 FIG. 7 is a rear elevational view thereof; and,
 FIG. 8 is a perspective view thereof, the article having been moved to an alternative position for use.



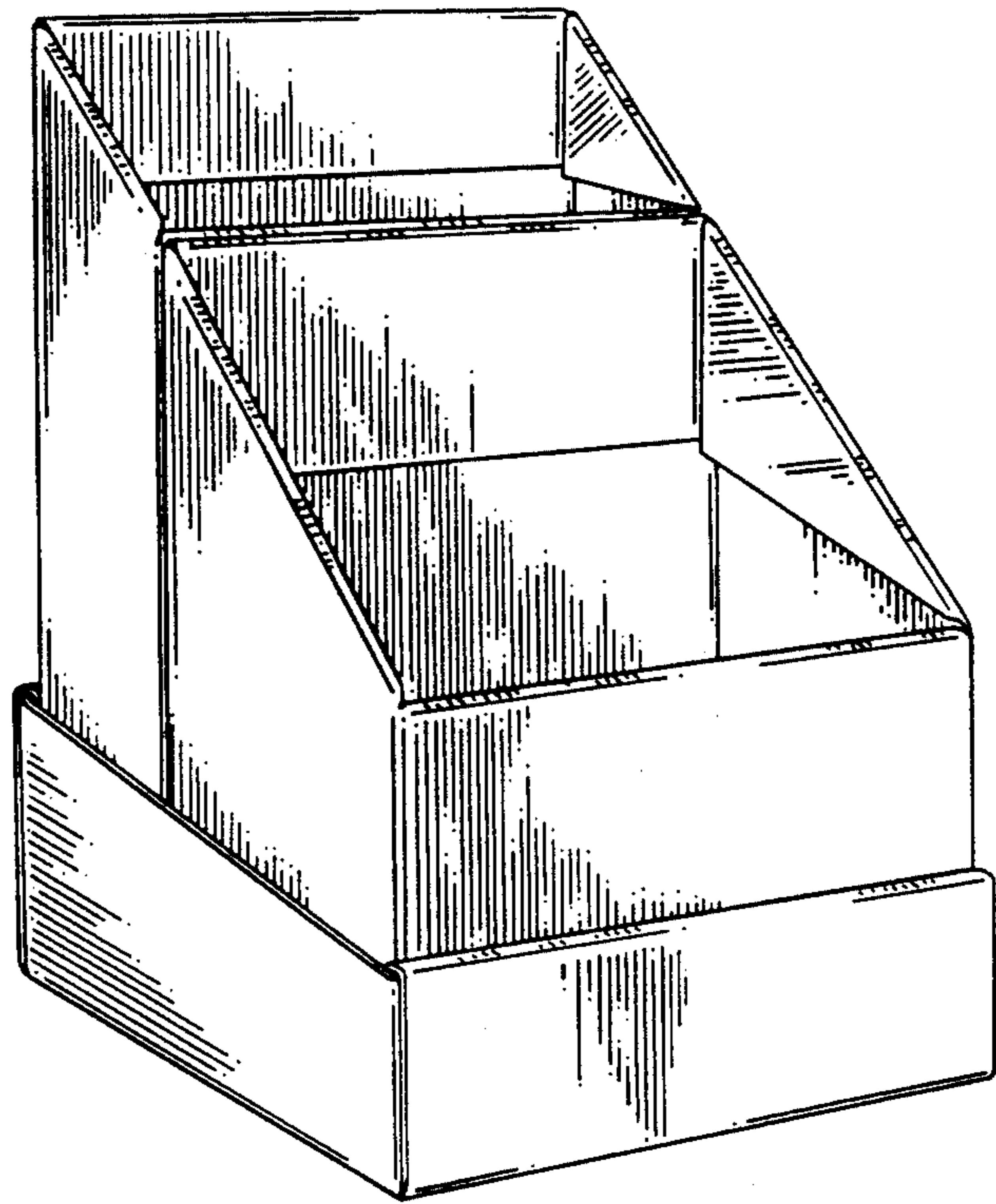

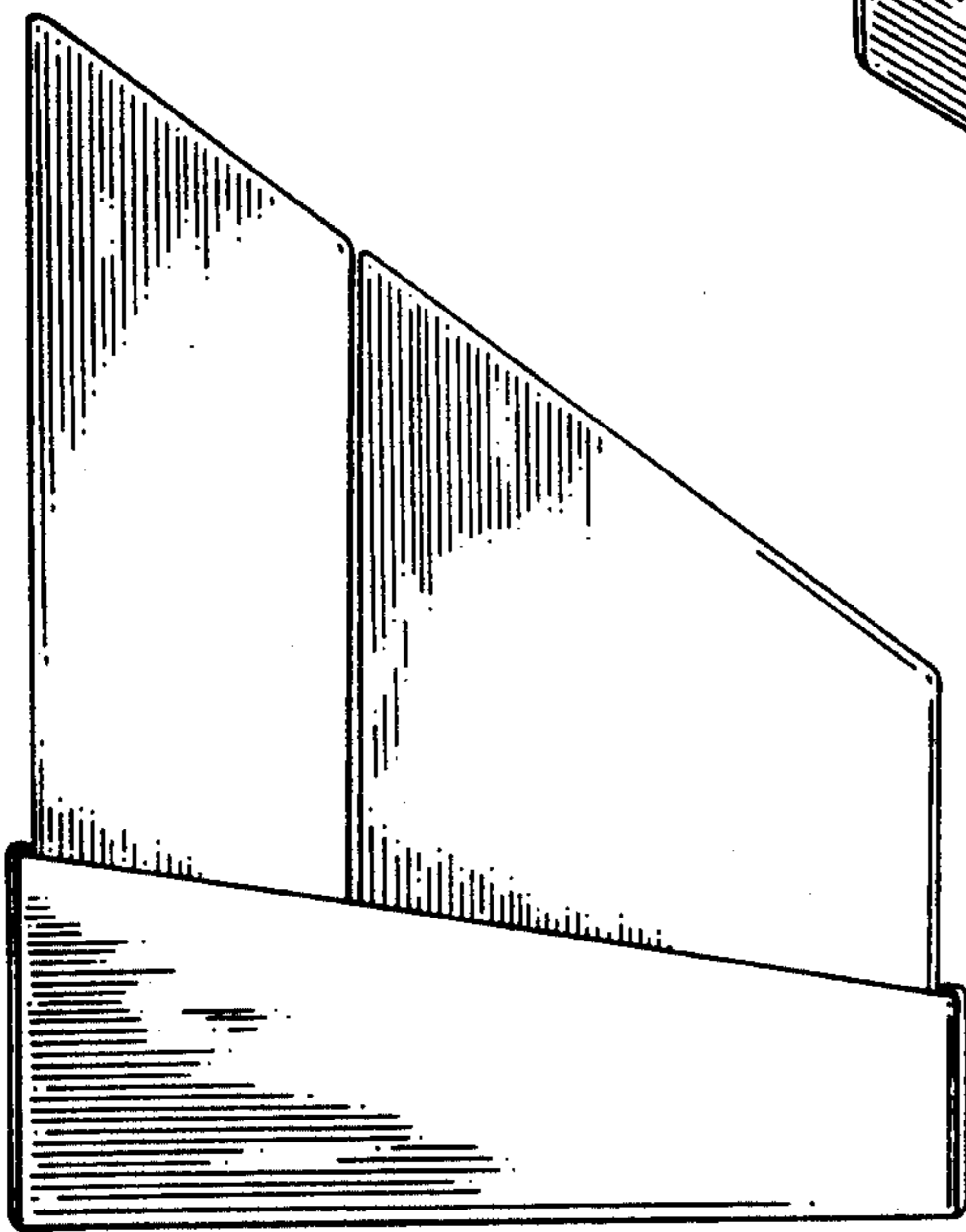

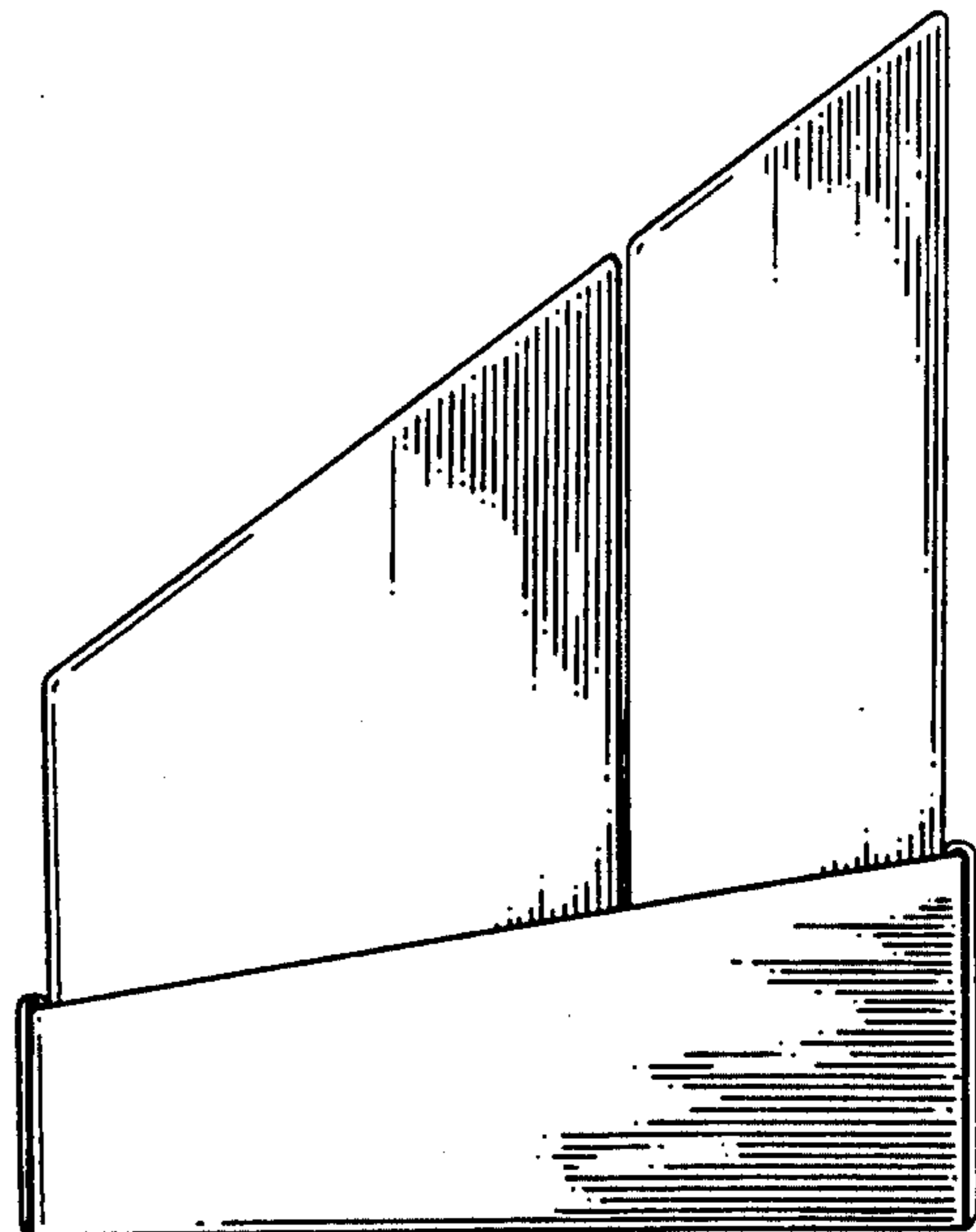

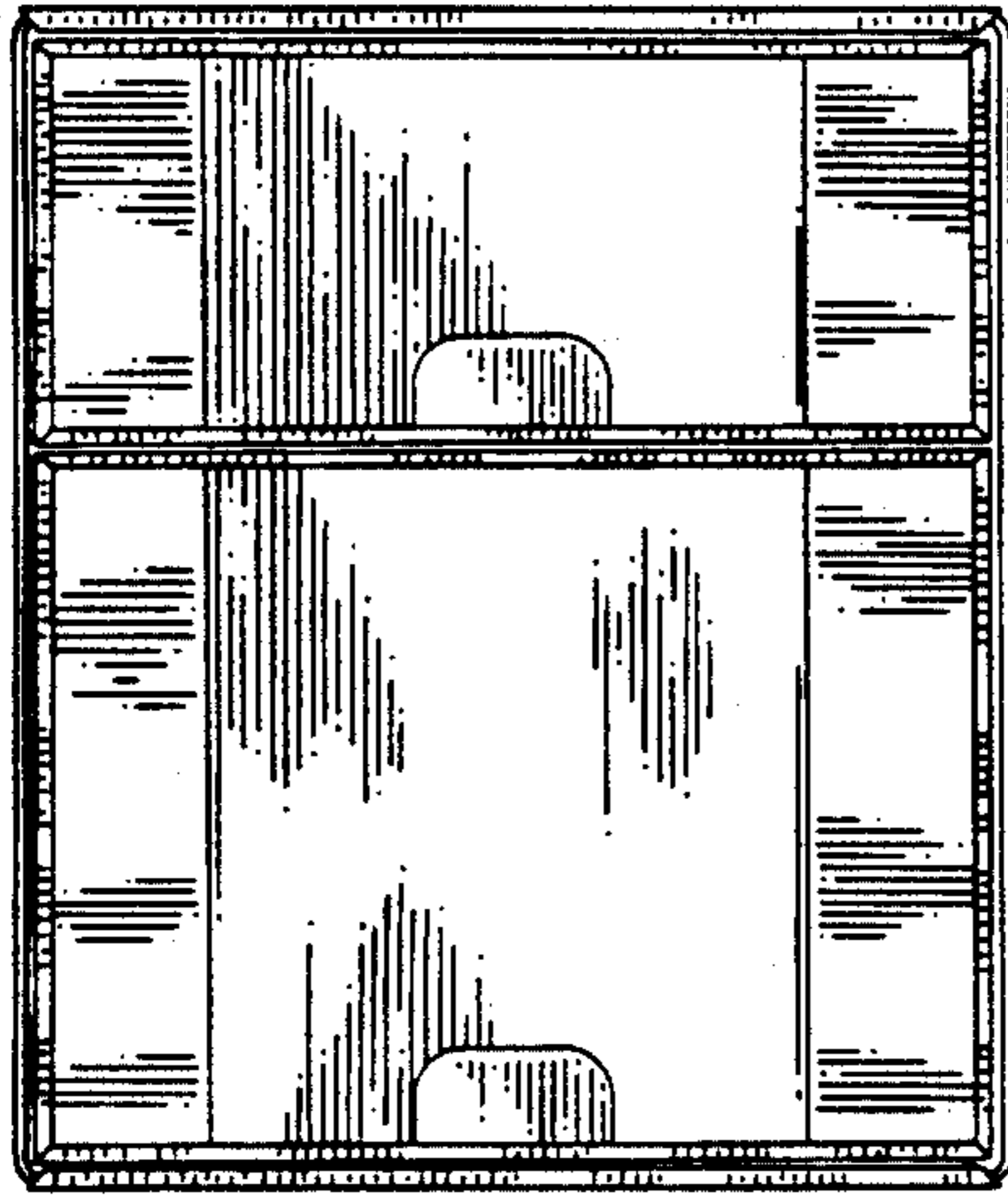

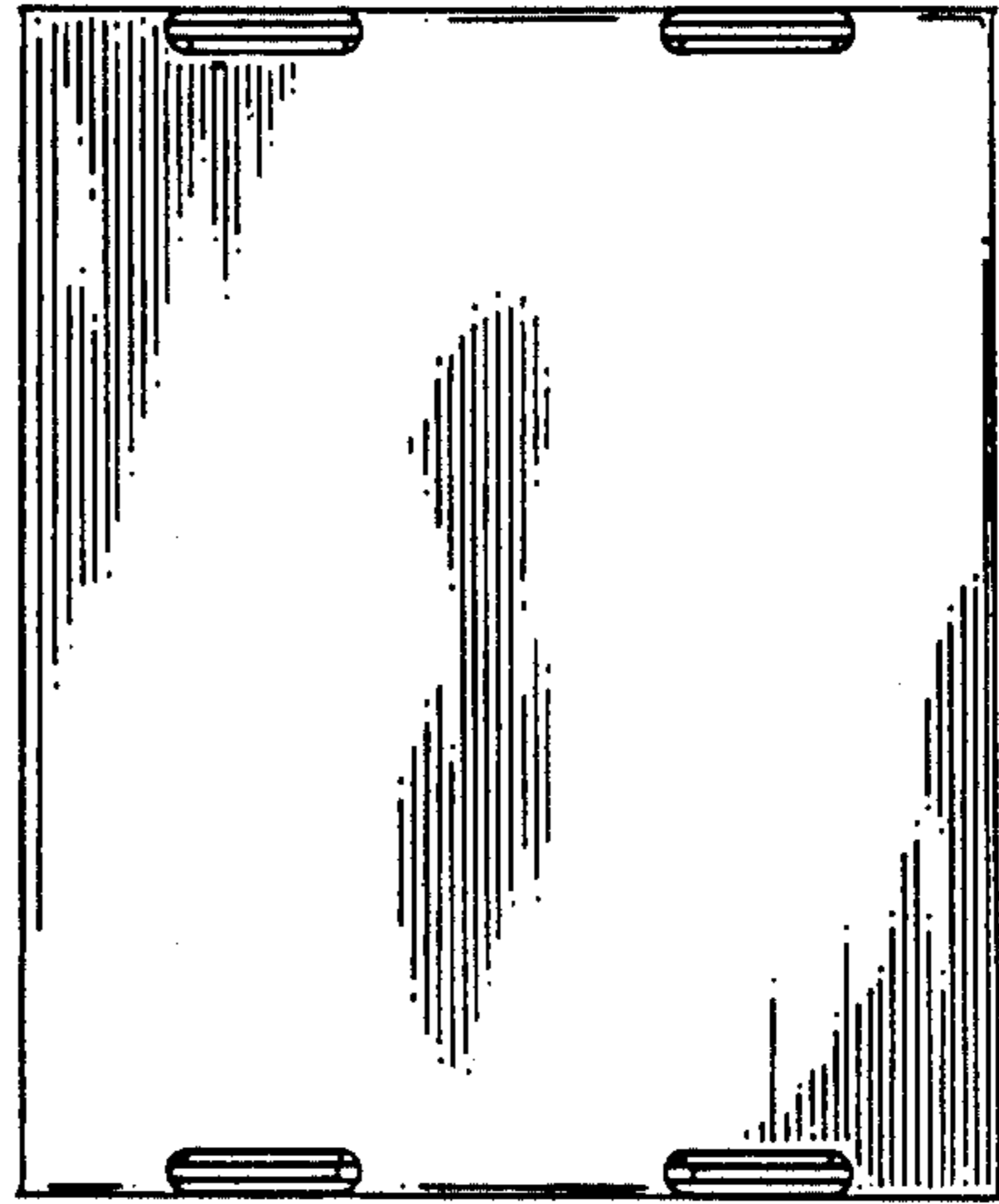

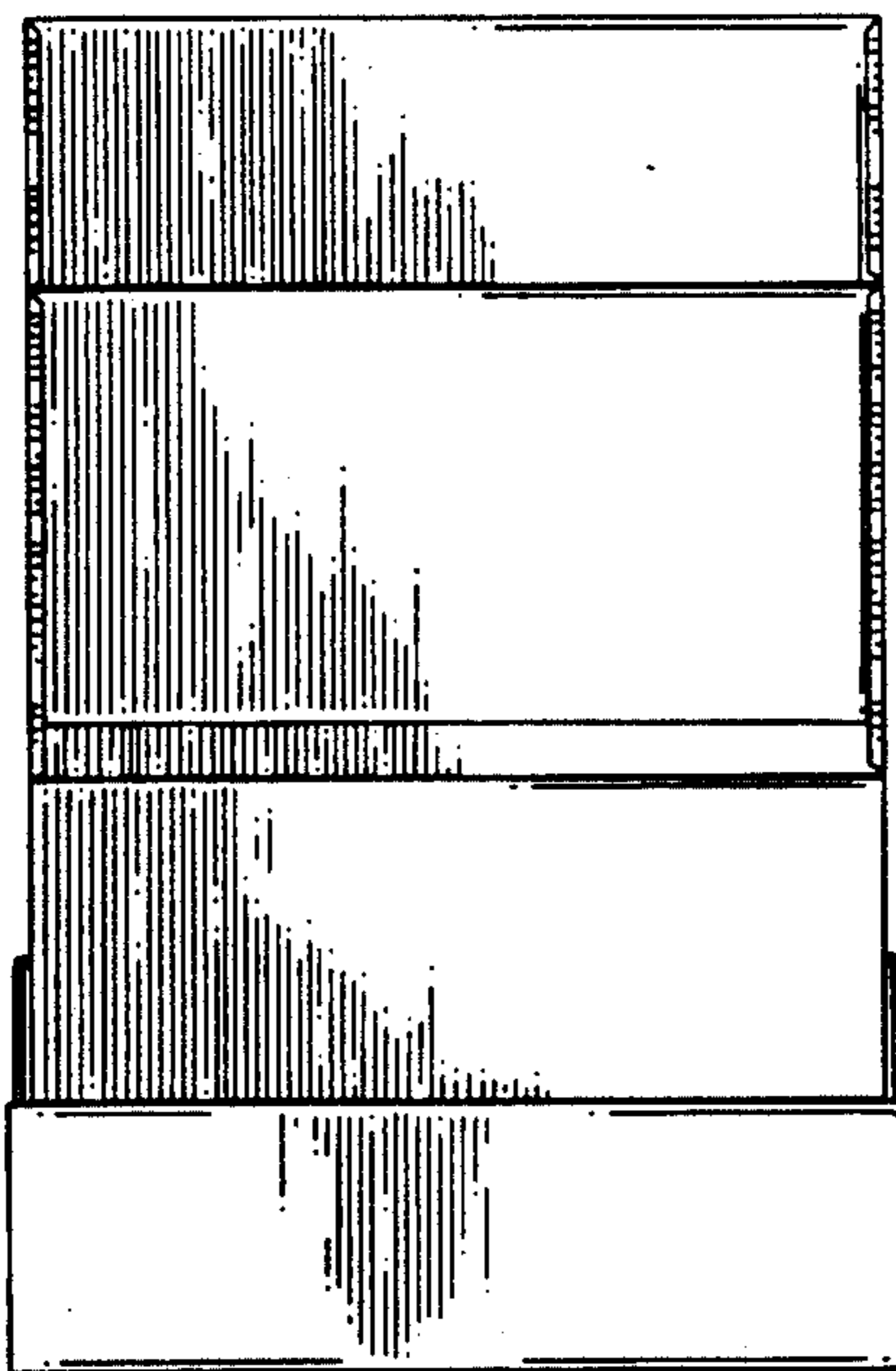

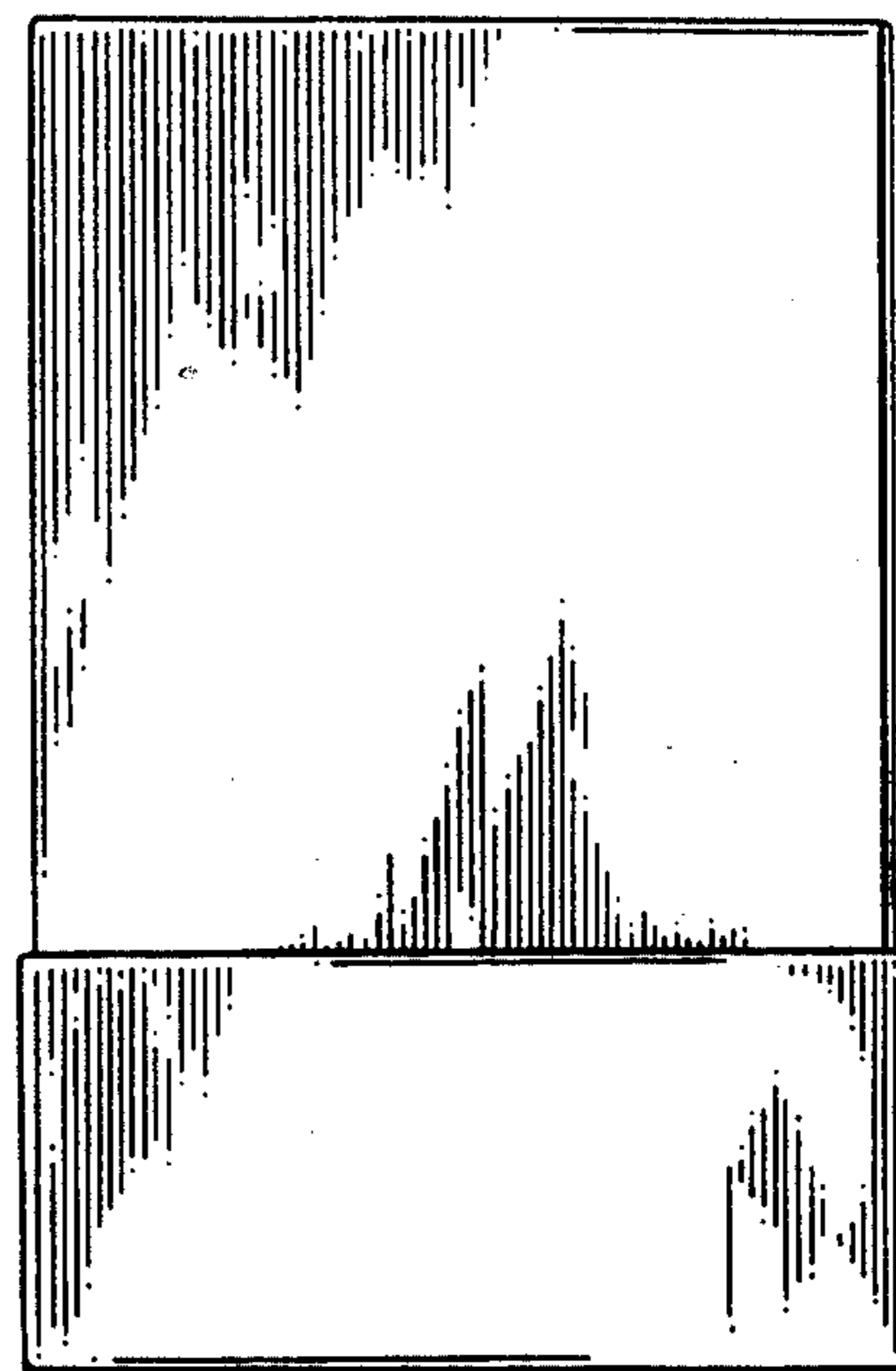

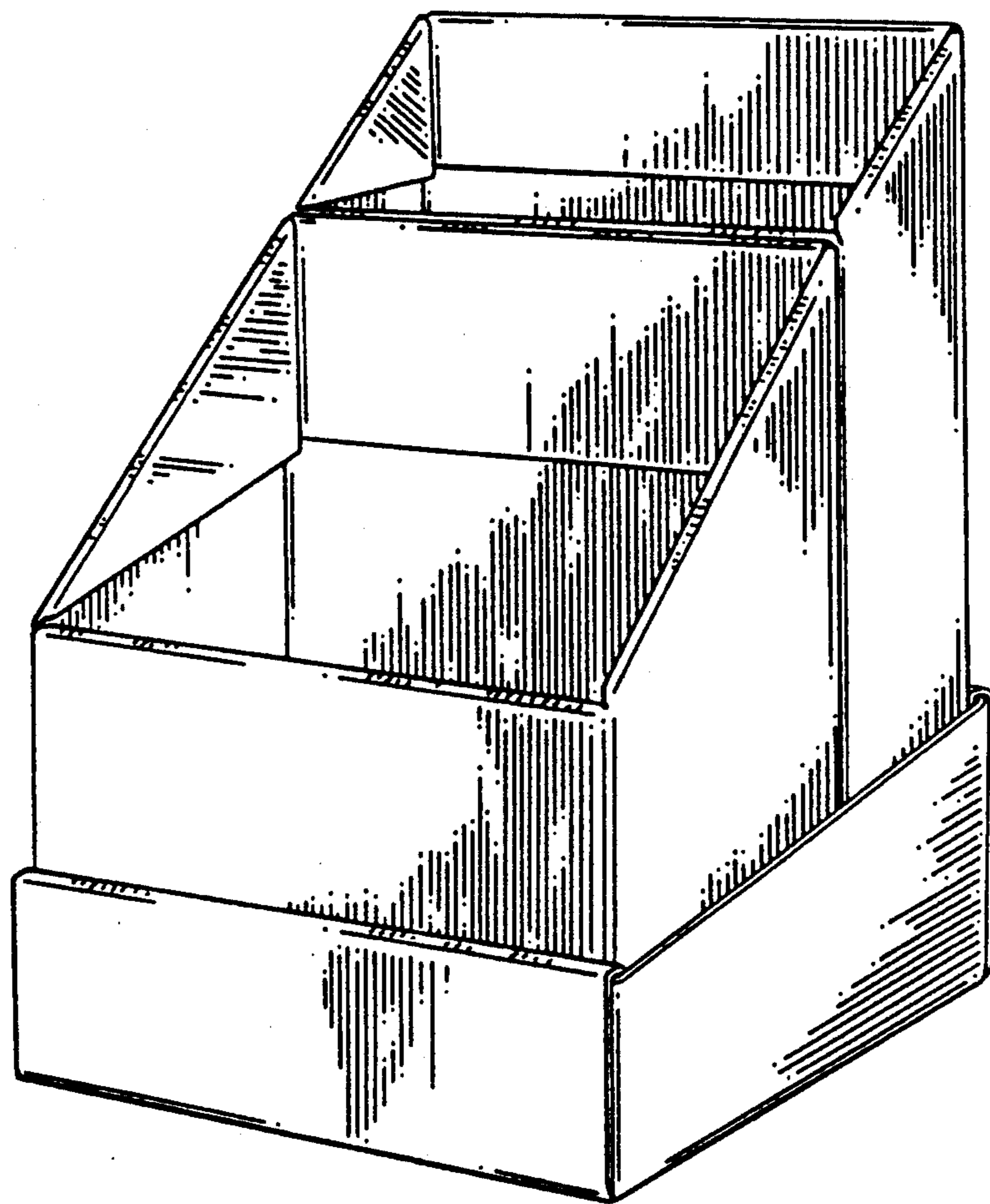
