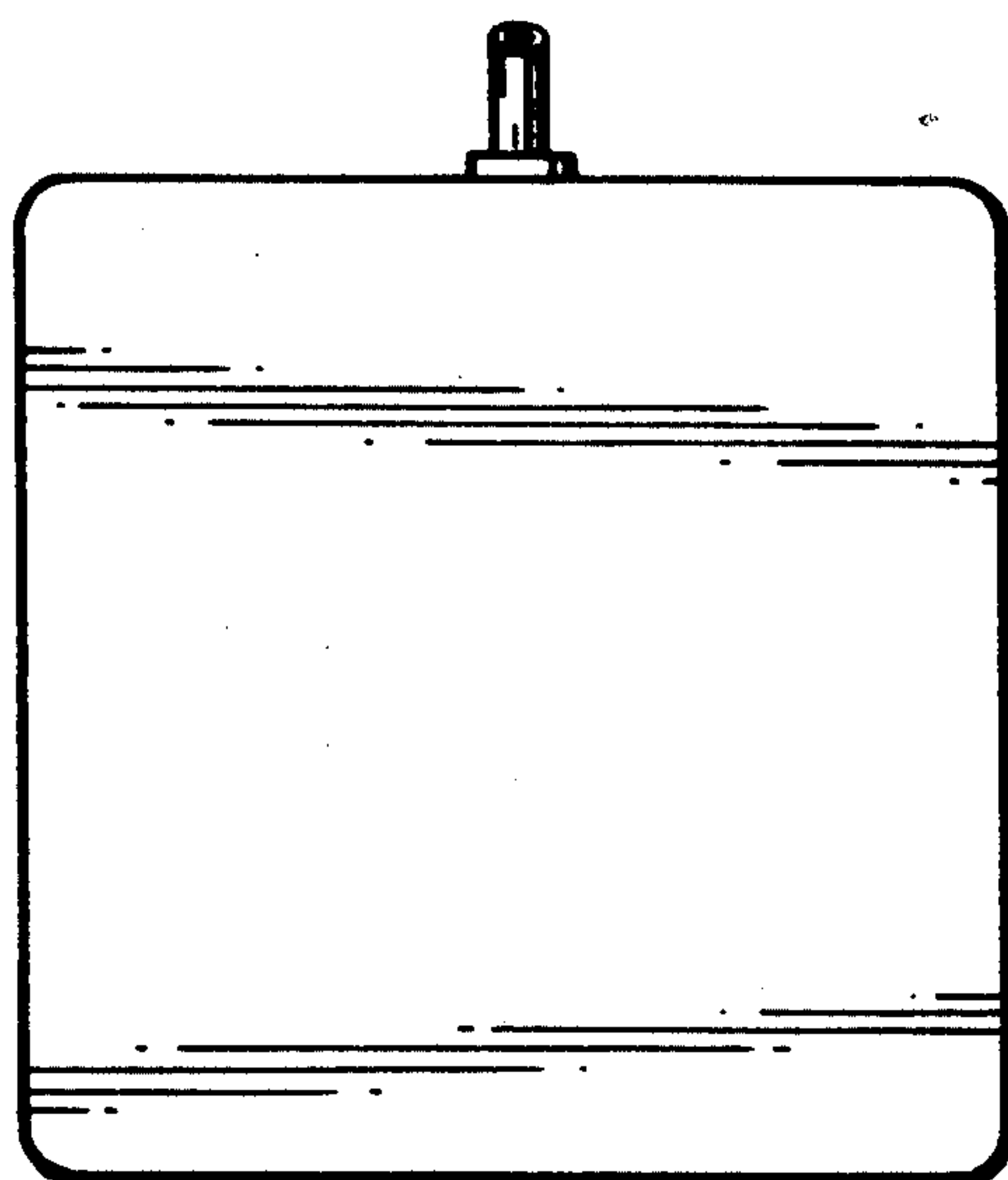

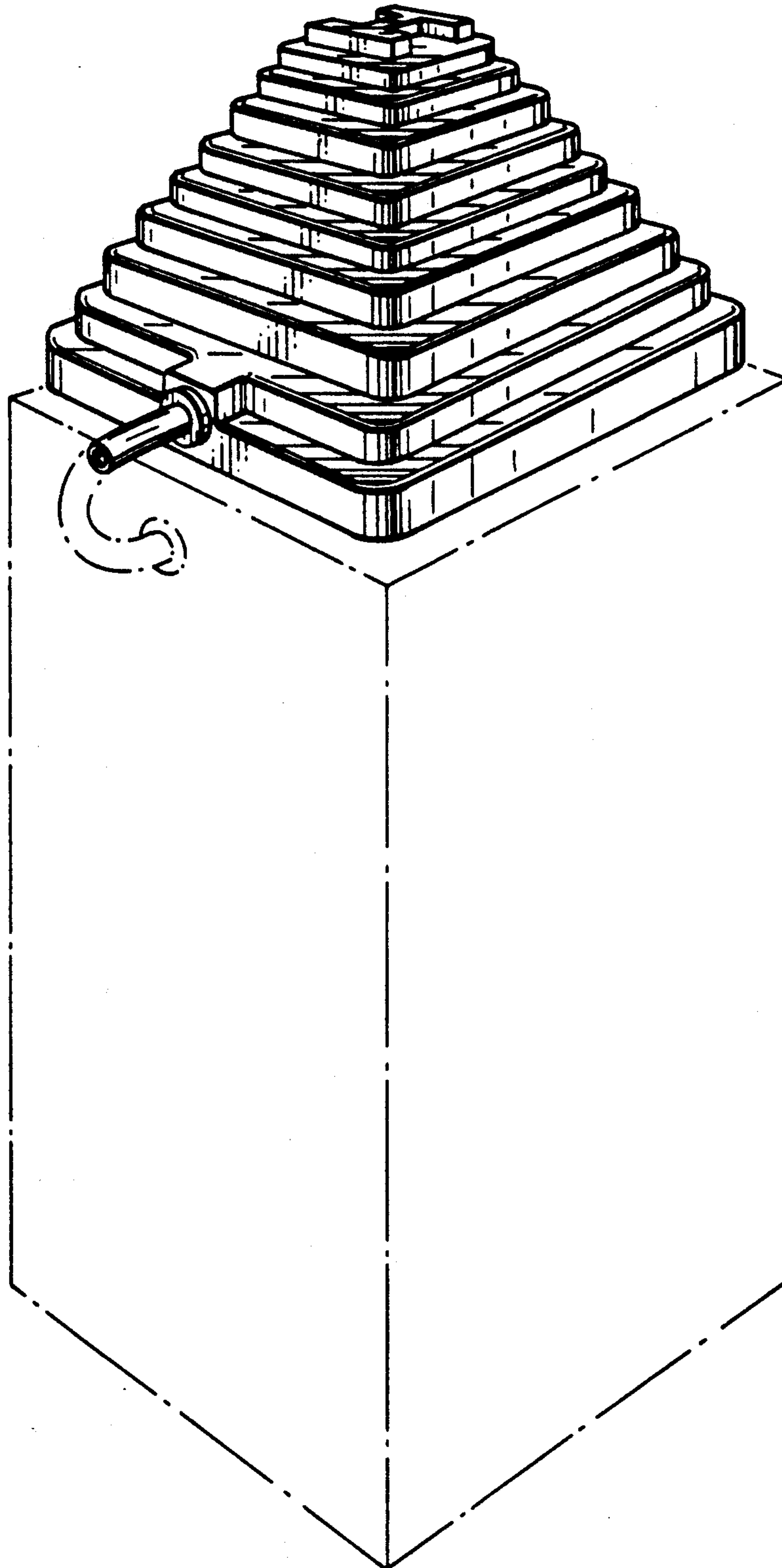
The ornamental design for a collapsible water cooler container, as shown and described.

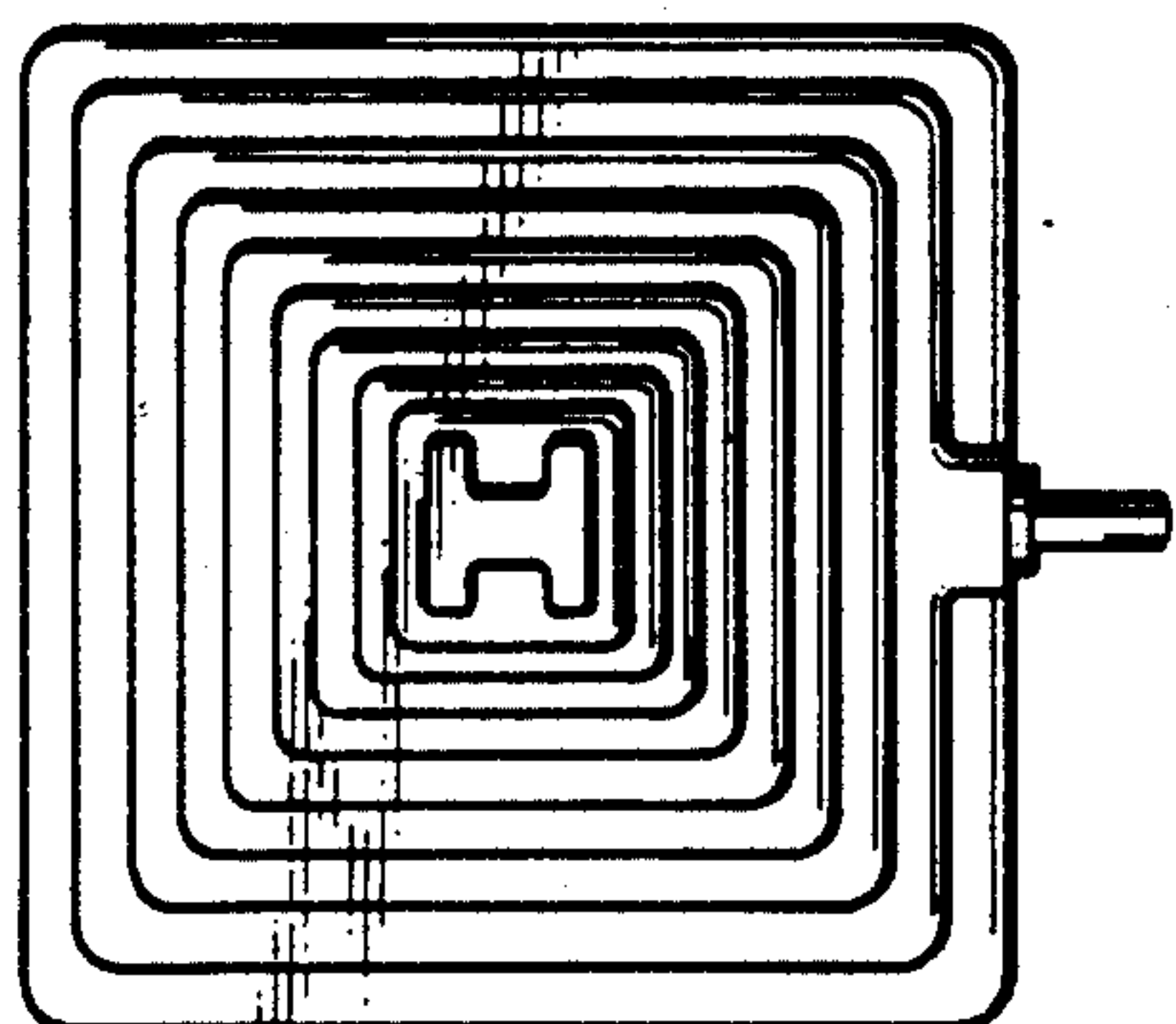
**DESCRIPTION**

FIG. 1 is a top, front, right perspective view of a collapsible water cooler container showing my new design;  
 FIG. 2 is a top plan view thereof;  
 FIG. 3 is a left side elevational view, the right side elevational view being a mirror image thereof;  
 FIG. 4 is a front elevational view thereof;  
 FIG. 5 is a rear elevational view thereof; and,  
 FIG. 6 is a bottom plan view thereof.  
 The broken line showing of water cooler base is for illustrative purposes only and forms no part of the claimed design.

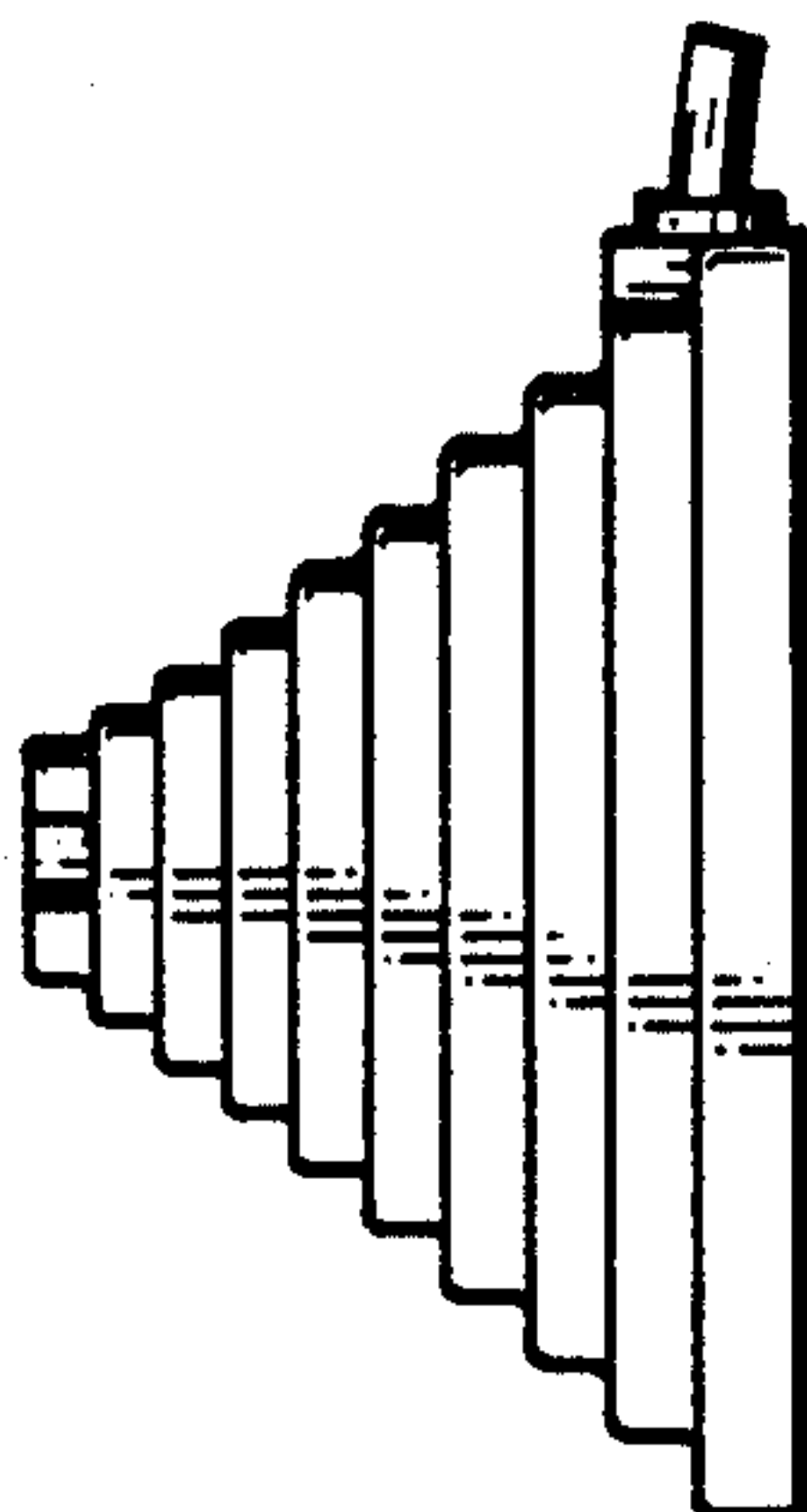

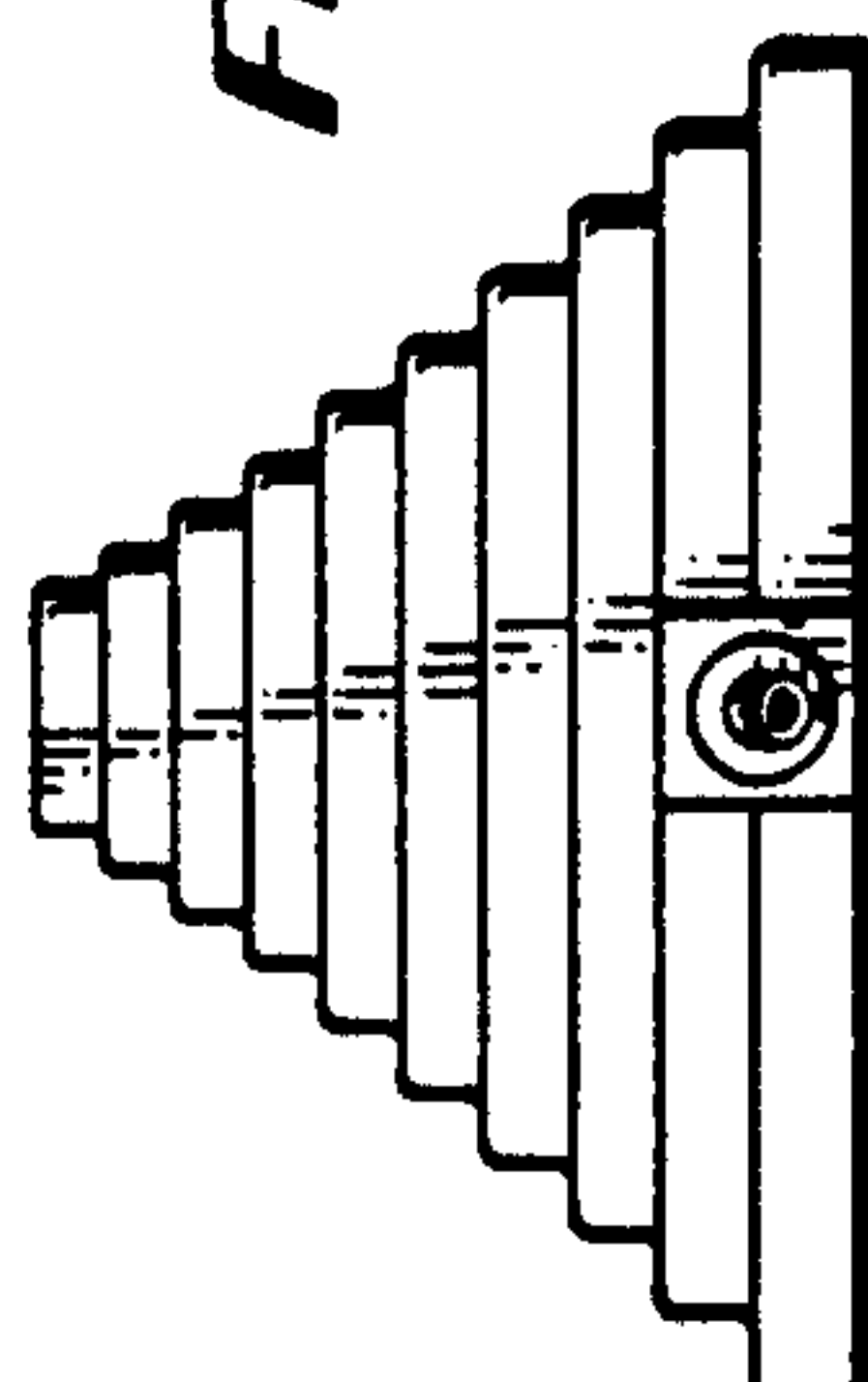




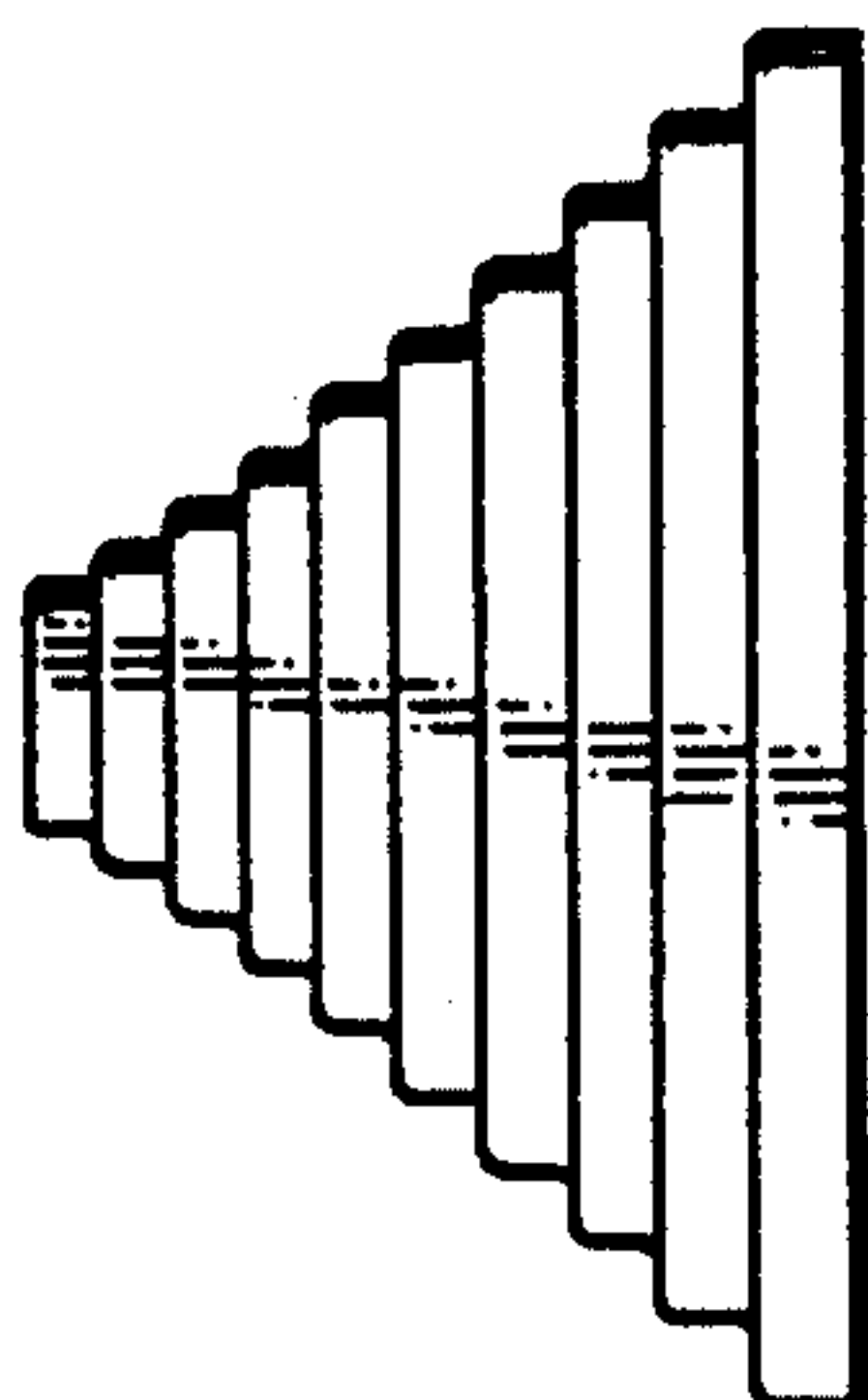

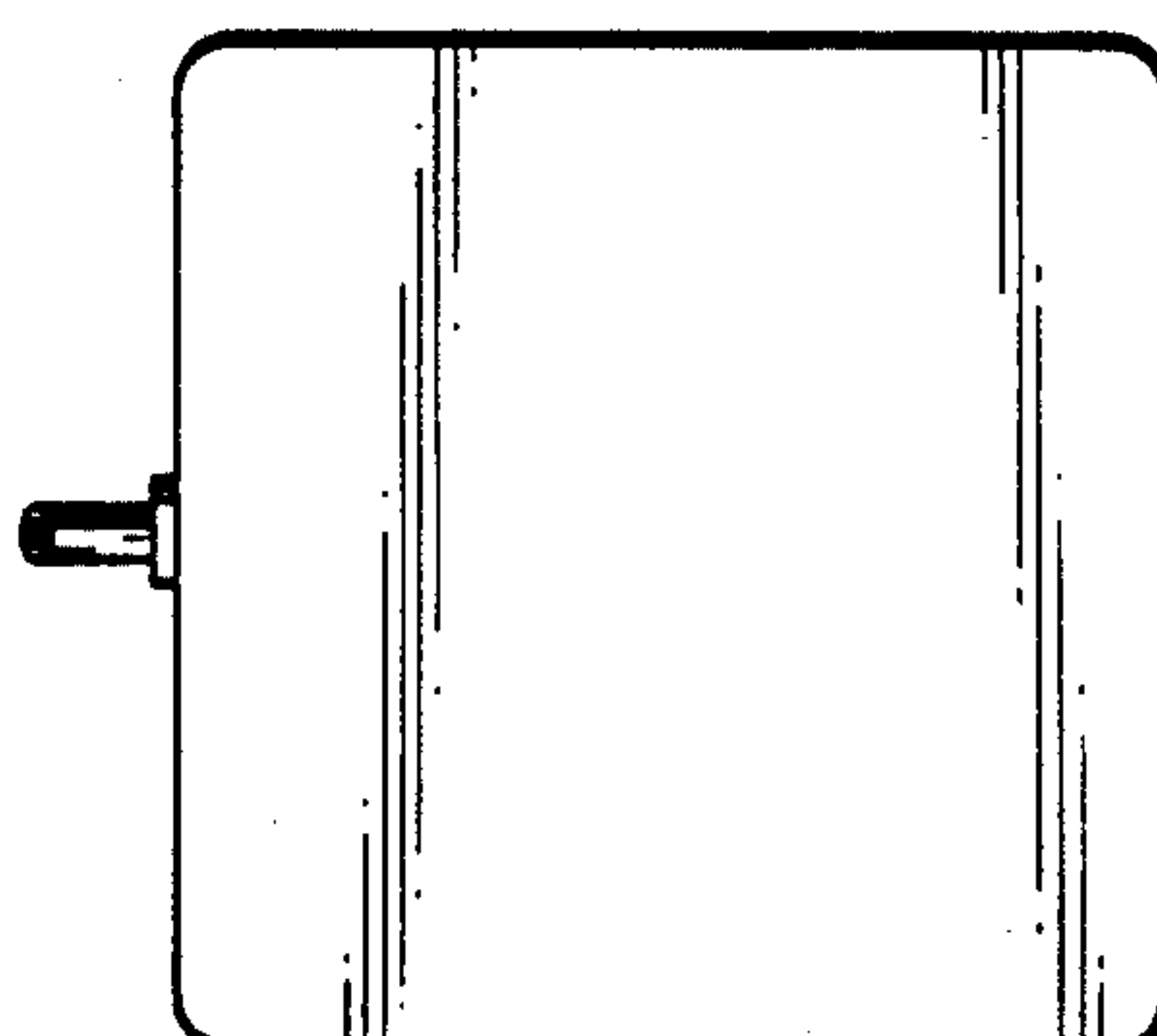
