FIG. 5 is a rear elevational view thereof;

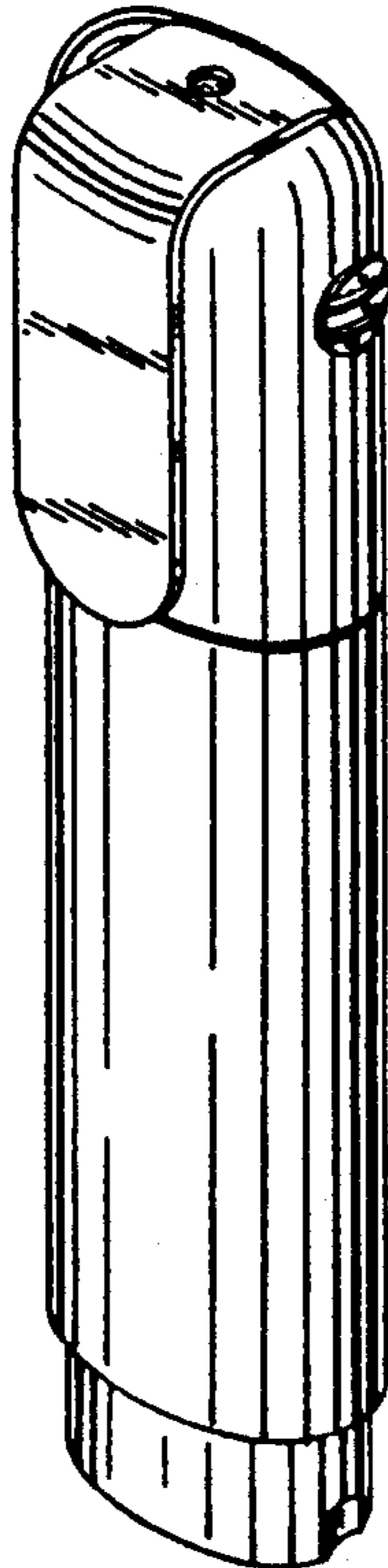
FIG. 6 is a top, right front perspective view;

FIG. 7 is a top, right front perspective view in an exploded condition;

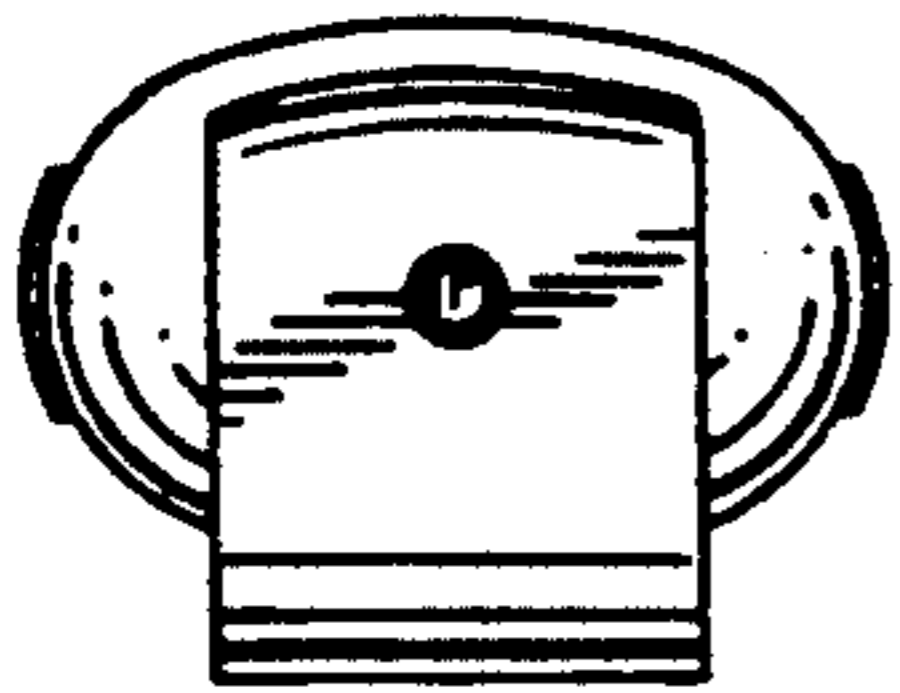
FIG. 8 is a front elevational view of FIG. 7;

FIG. 9 is a right side elevational view of FIG. 7, the left side being a mirror image thereof; and,

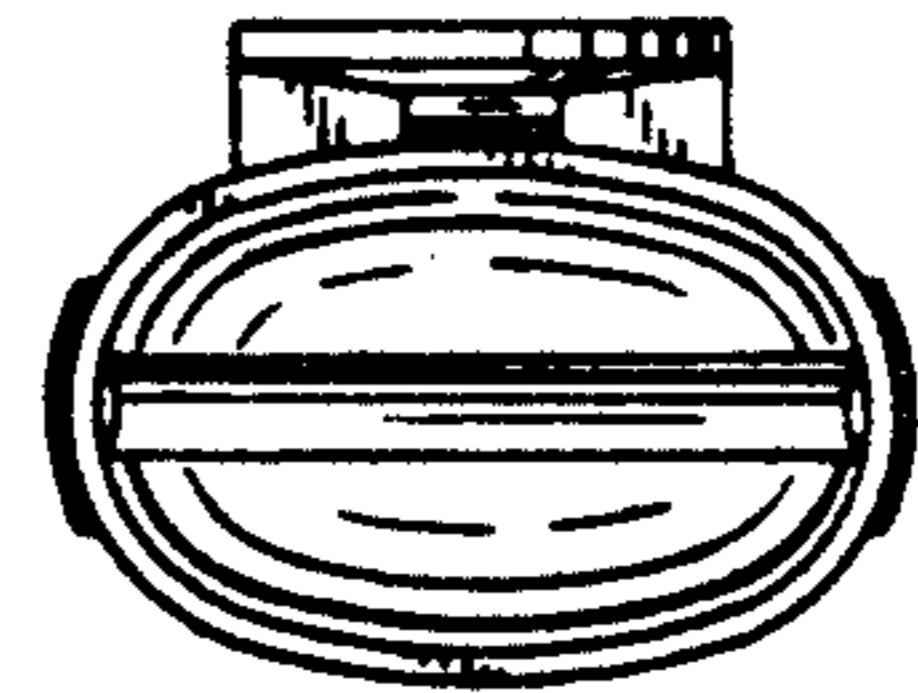
FIG. 10 is a rear elevational view of FIG. 7.



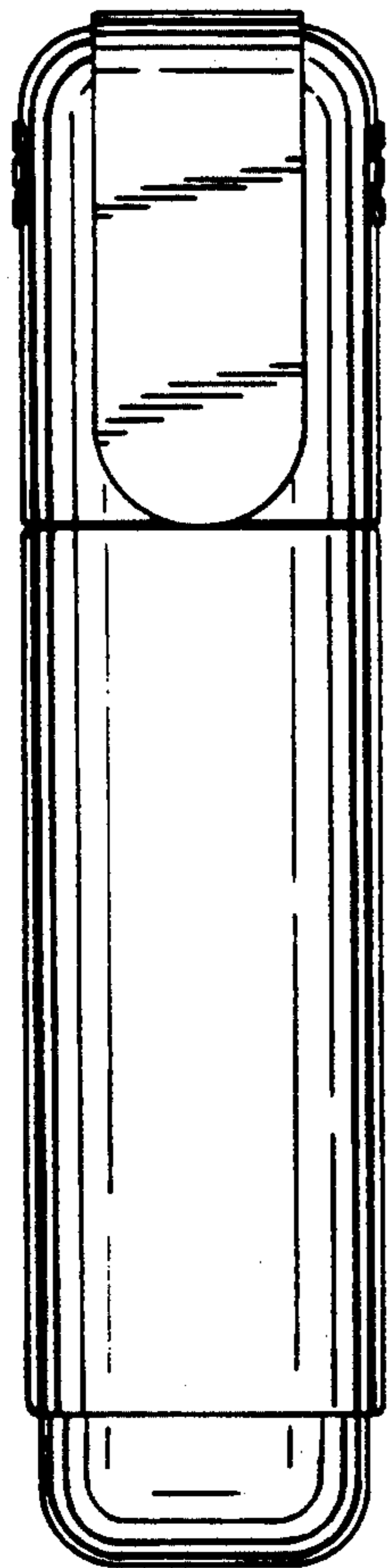

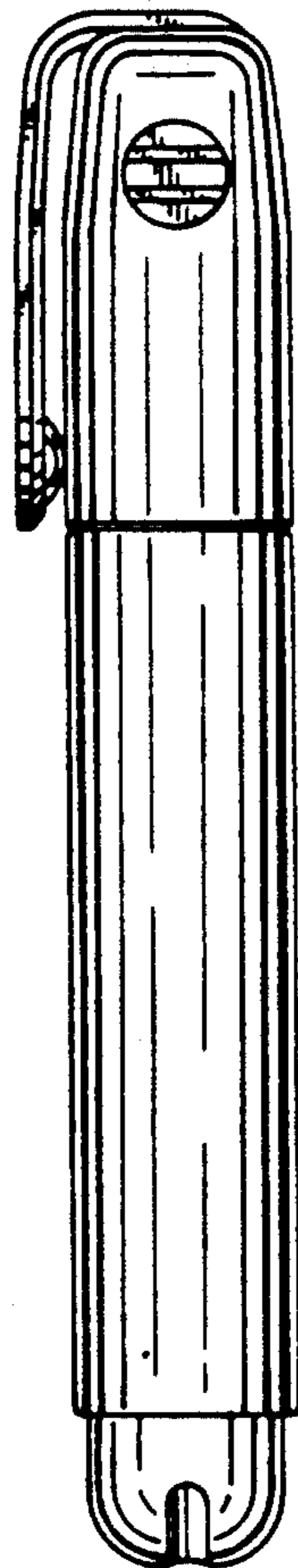

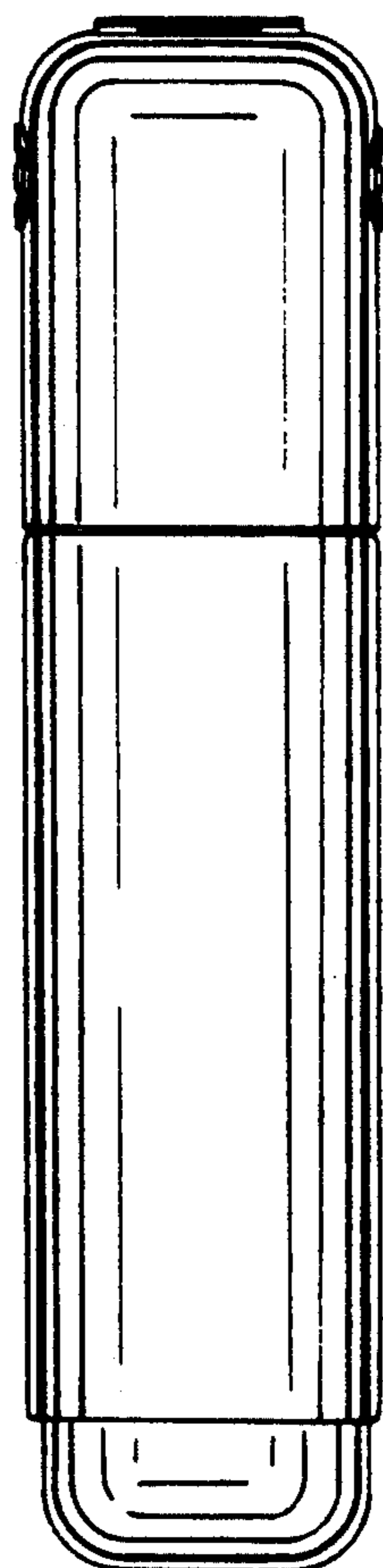

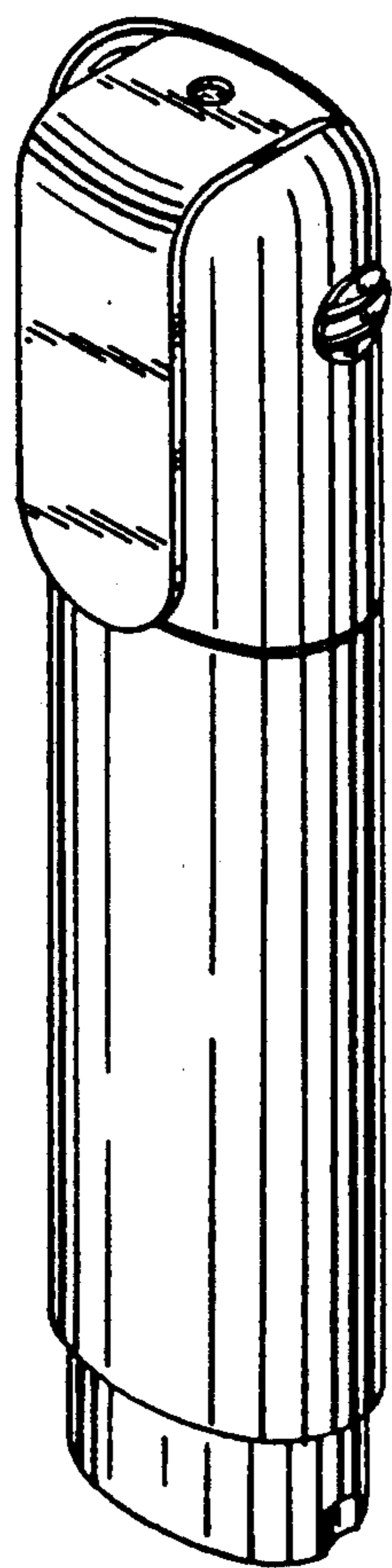

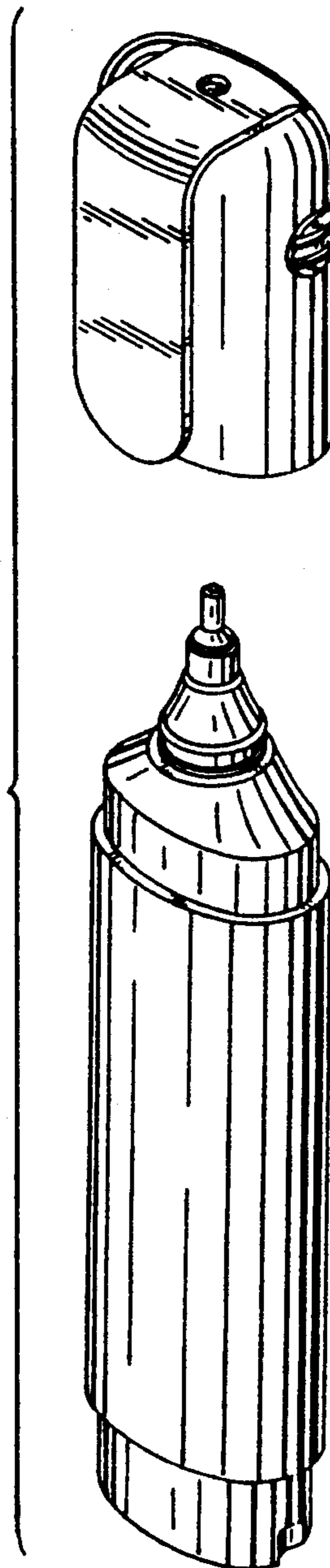

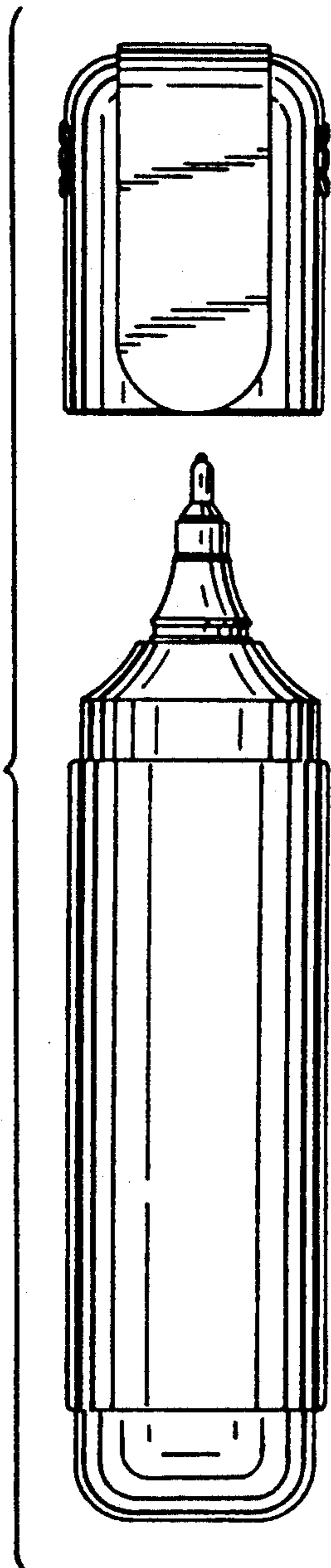

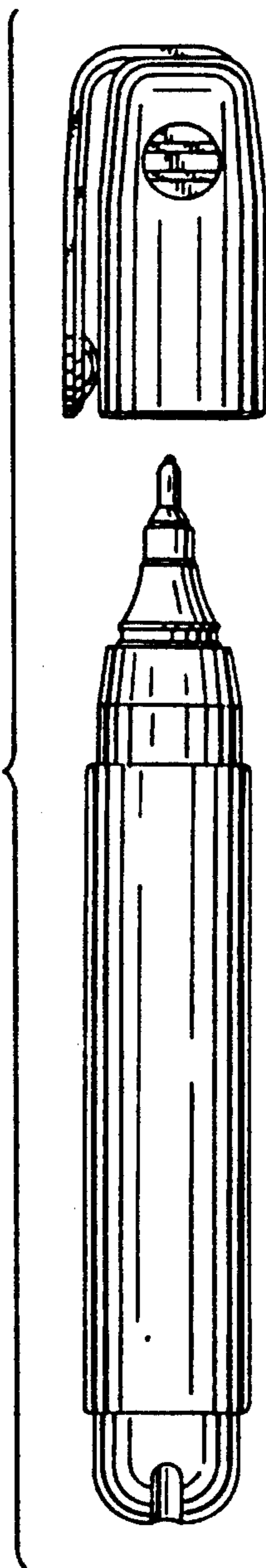
