[57] **CLAIM**

The ornamental design for combined thumb and finger grip for nail clippers, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevational view of a combined thumb and finger grip for nail clippers showing my new design, the side opposite being a mirror image of the side shown;

FIG. 2 is a top, front perspective view of the lower component of FIG. 1, shown separately for clarity of illustration;

FIG. 3 is a top plan view thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a rear end elevational view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a perspective view of the upper component of FIG. 1, shown separately for clarity of illustration;

FIG. 9 is a top plan view thereof;

FIG. 10 is a front elevational view thereof;

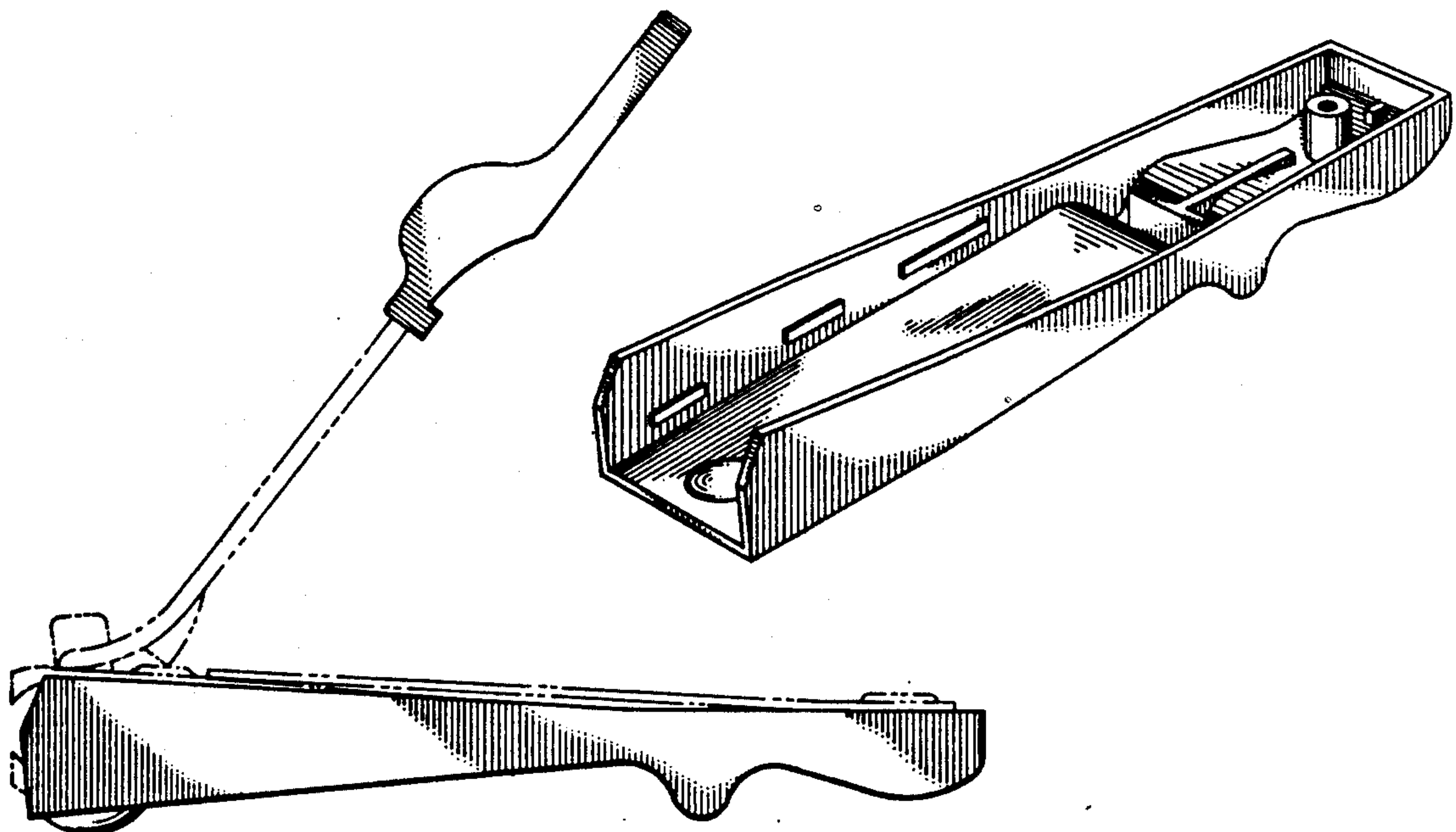
FIG. 11 is a right side elevational view thereof;

FIG. 12 is a rear elevational view thereof;

FIG. 13 is a bottom plan view thereof; and,

FIG. 14 is a right side elevational view of the combined clipper elements, shown in an alternate relationship.

The broken line showing of the clipper is for illustrative purposes only and forms no part of the claimed design.



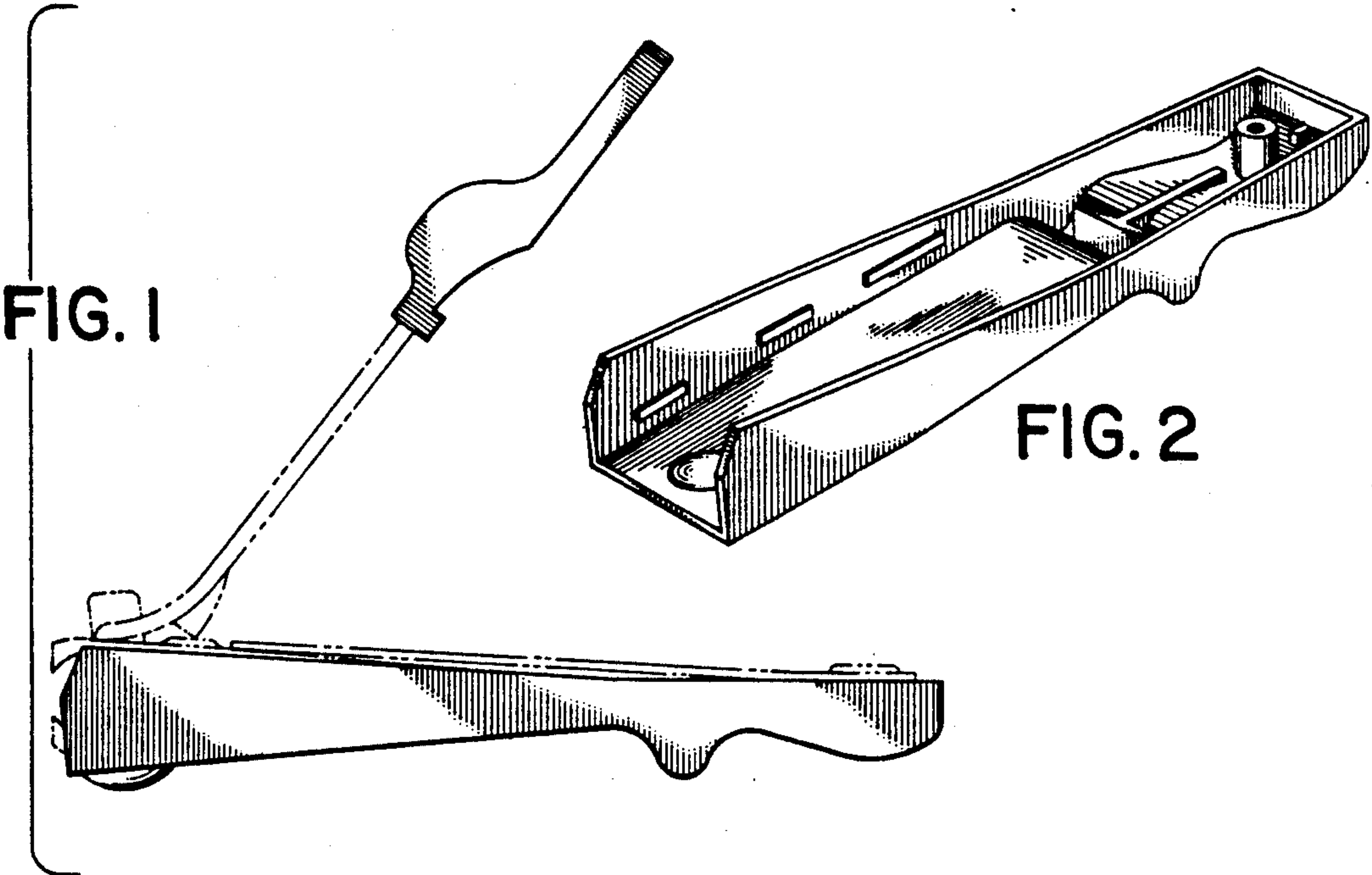

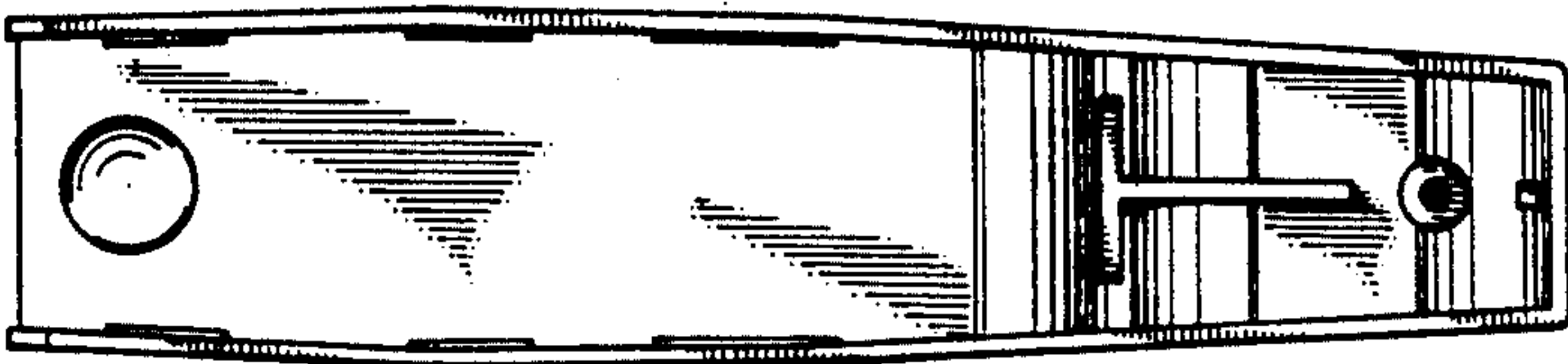

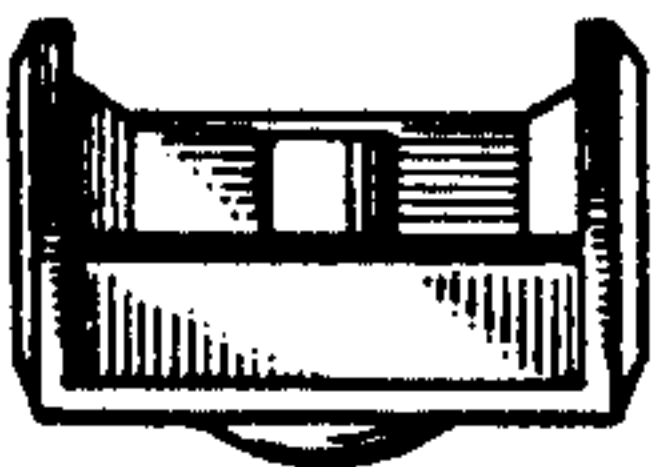

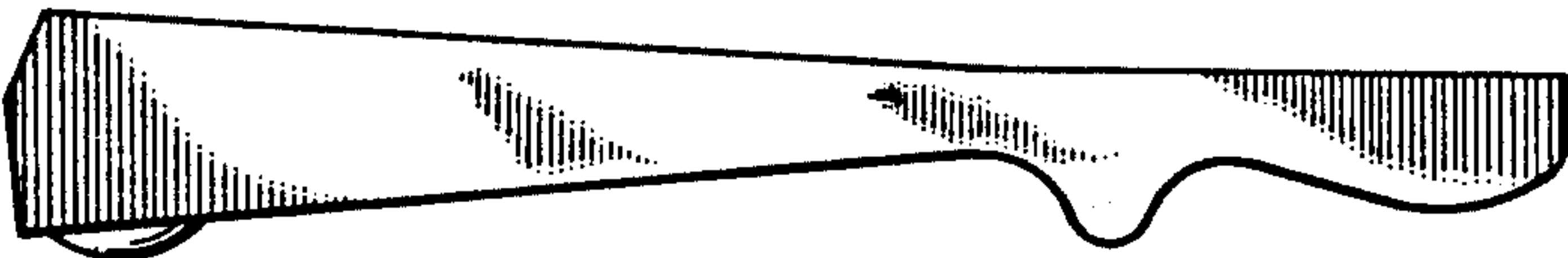

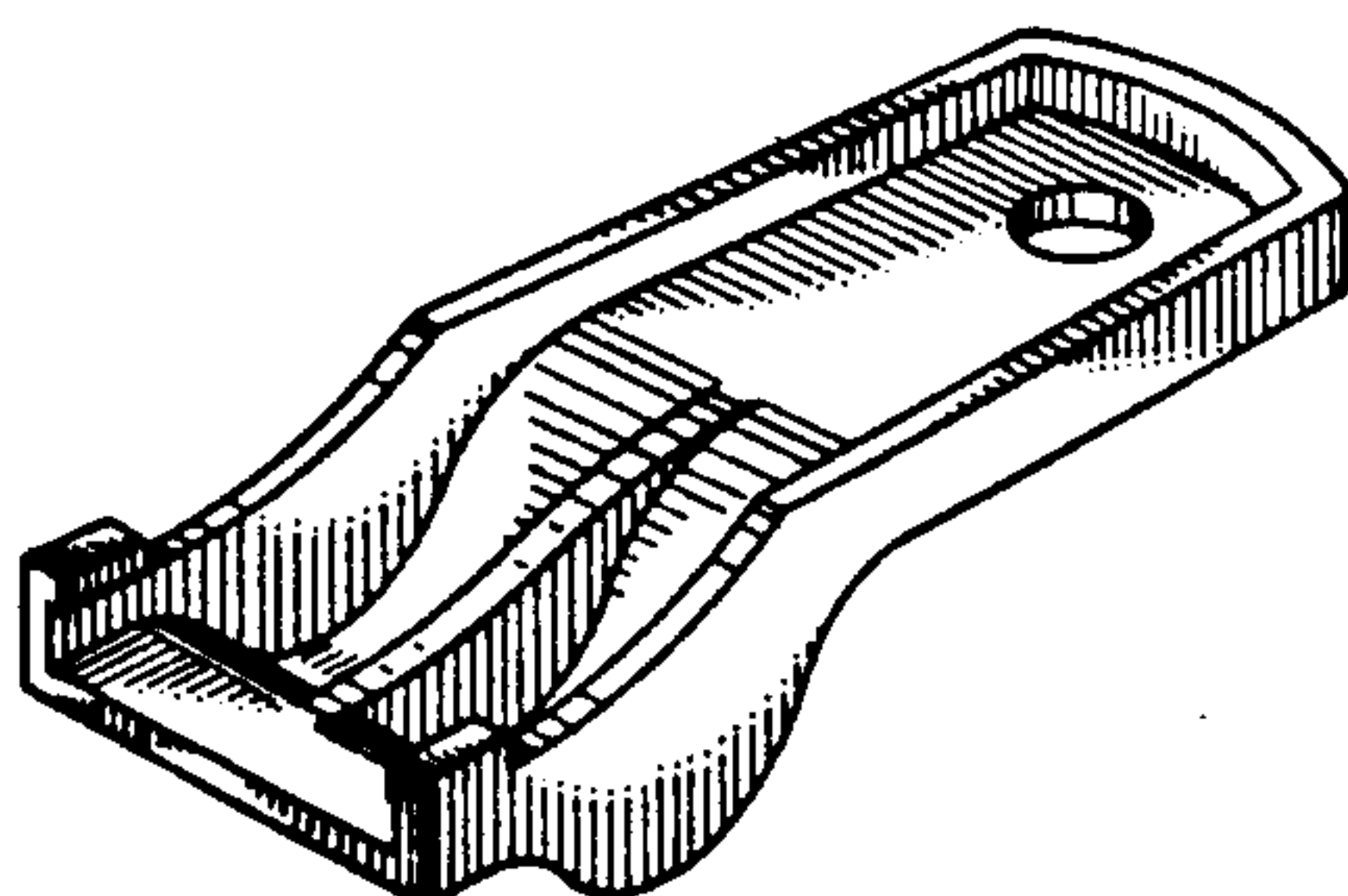

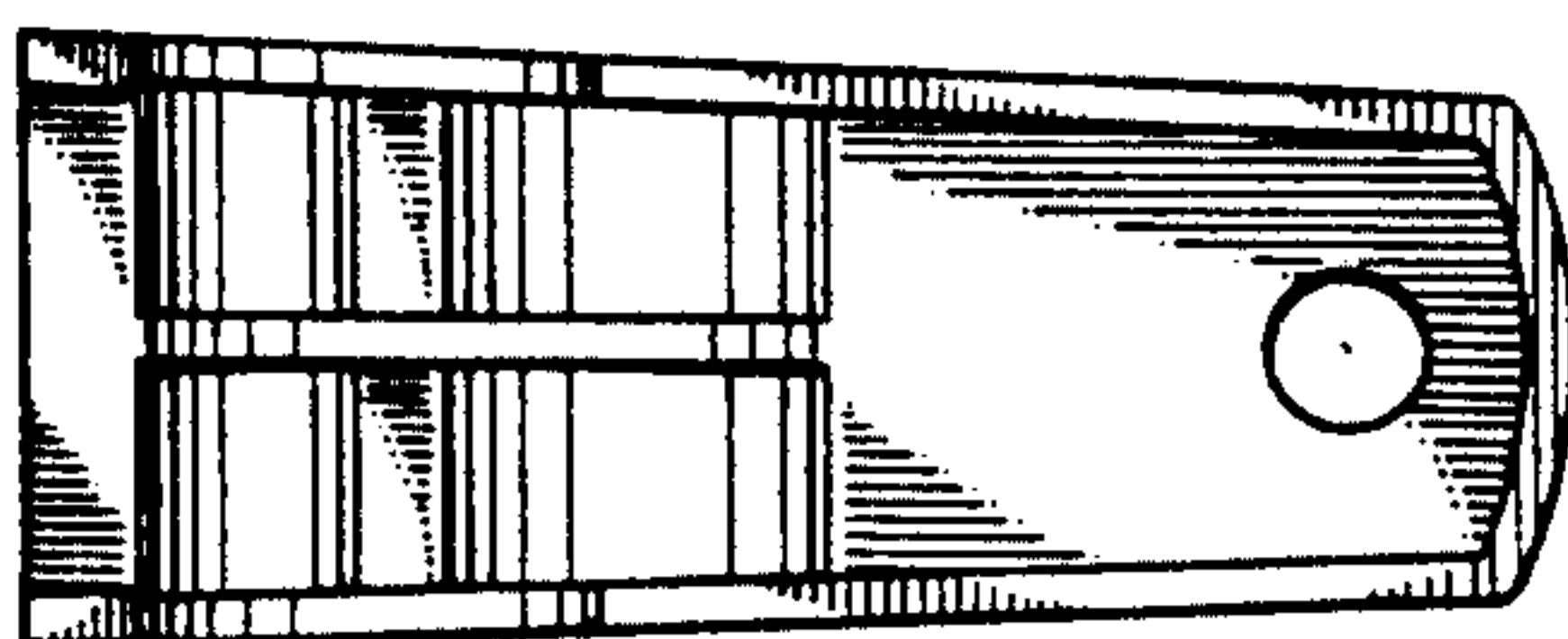

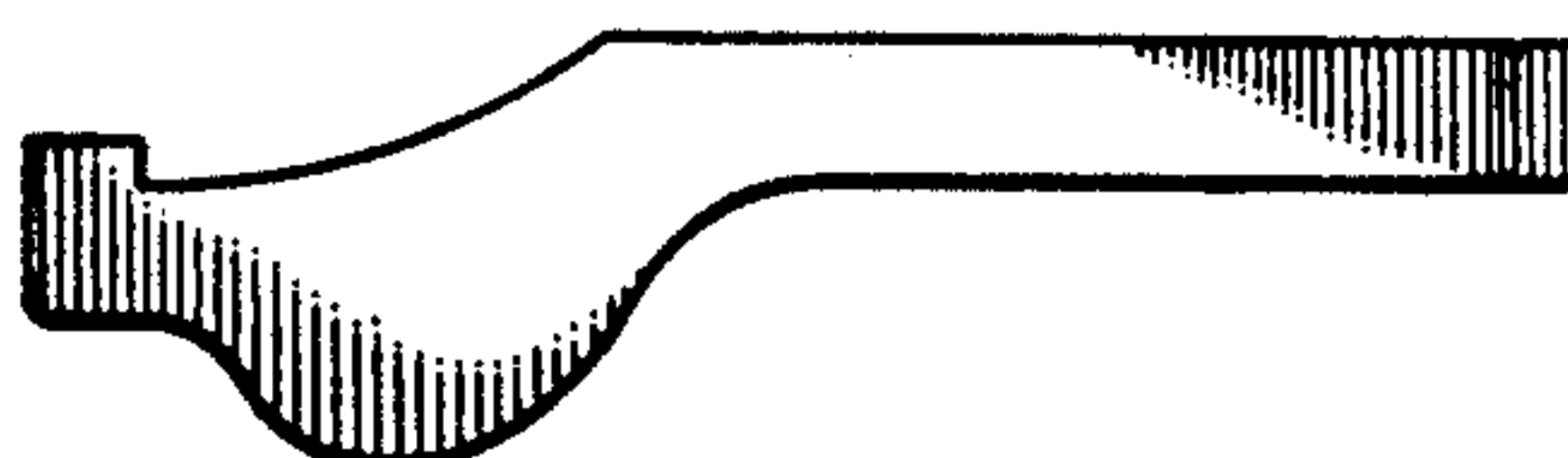

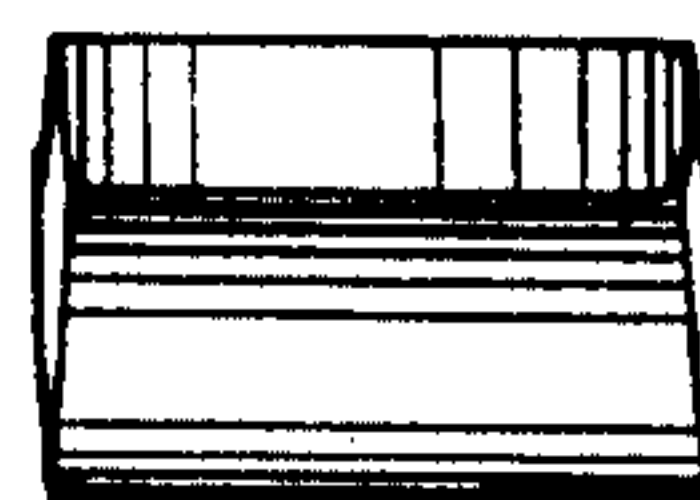

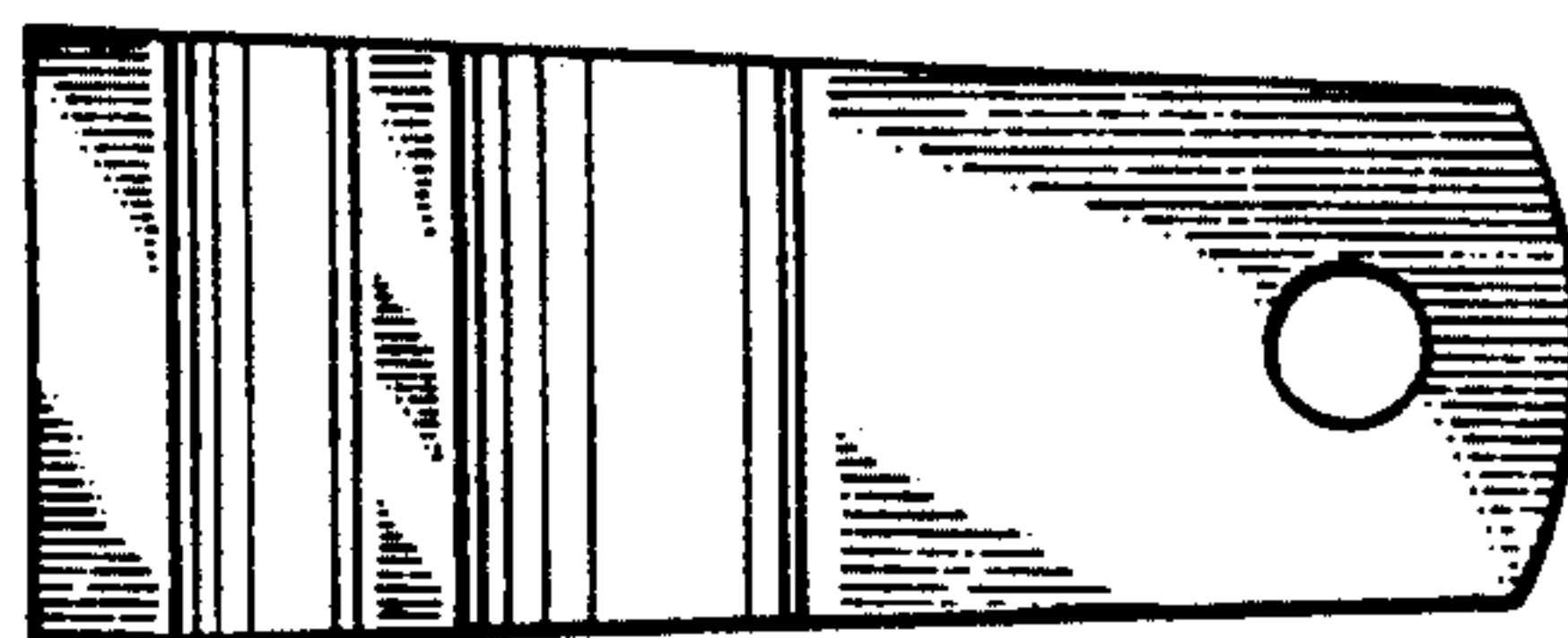
