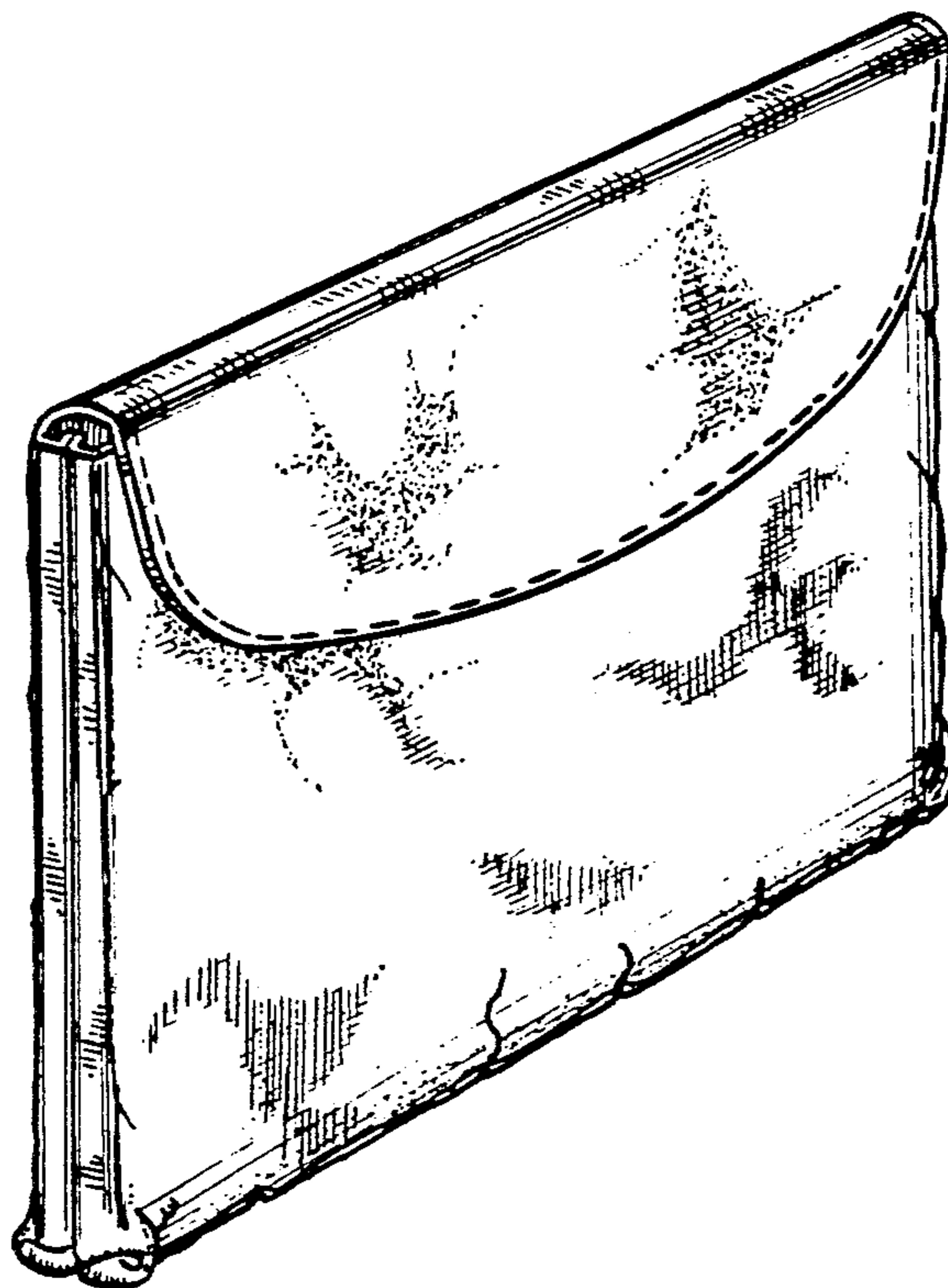

[57] **CLAIM**

The ornamental design for a carrying case for firearms, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a carrying case for firearms showing my new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a left side elevational view thereof;
 FIG. 4 is a left-side elevational view thereof with the flap in open condition;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is a front elevational view thereof showing the flap thereof in an open position;
 FIG. 8 is a rear elevational view thereof; and,
 FIG. 9 is a rear elevational view thereof in use.



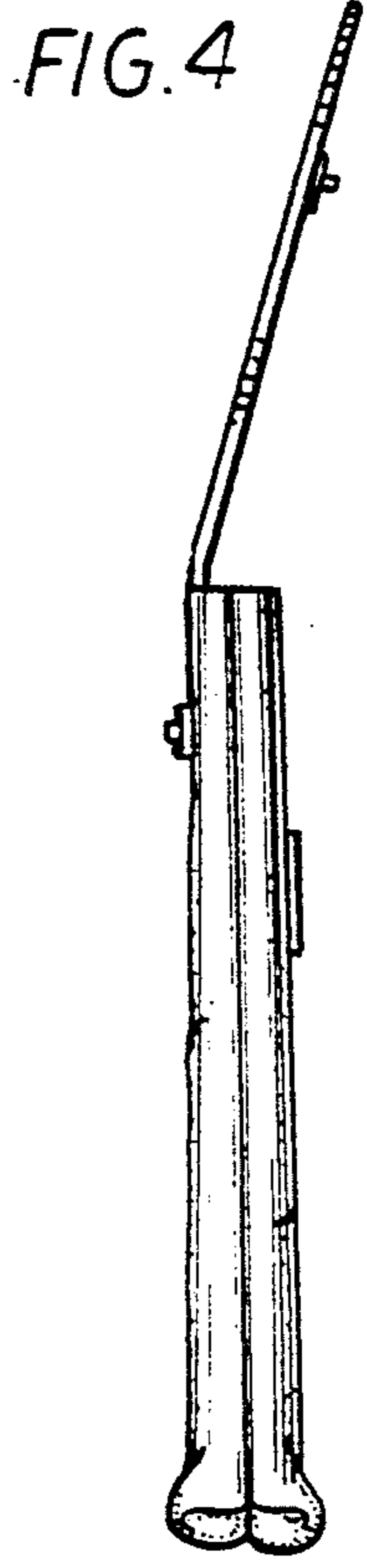
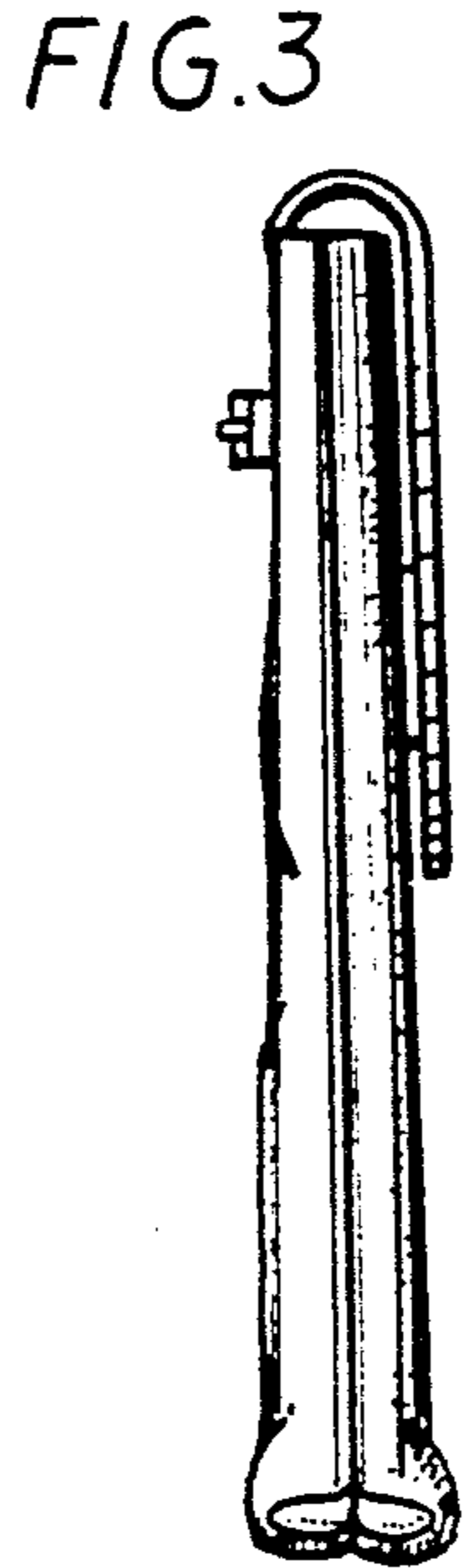
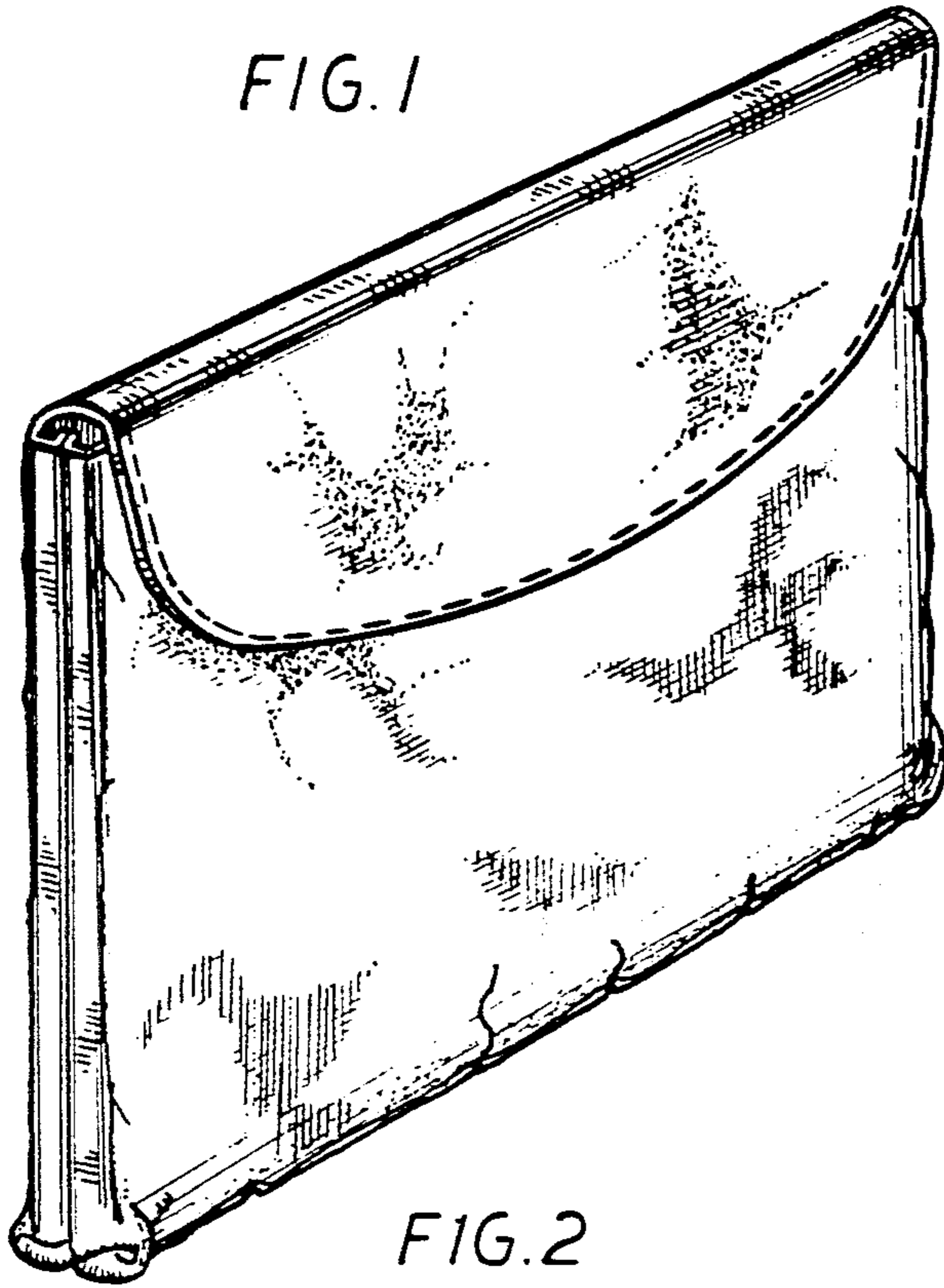

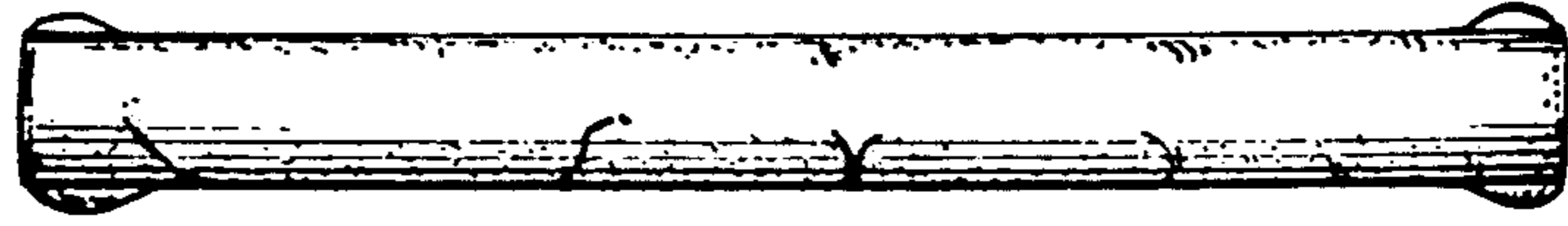
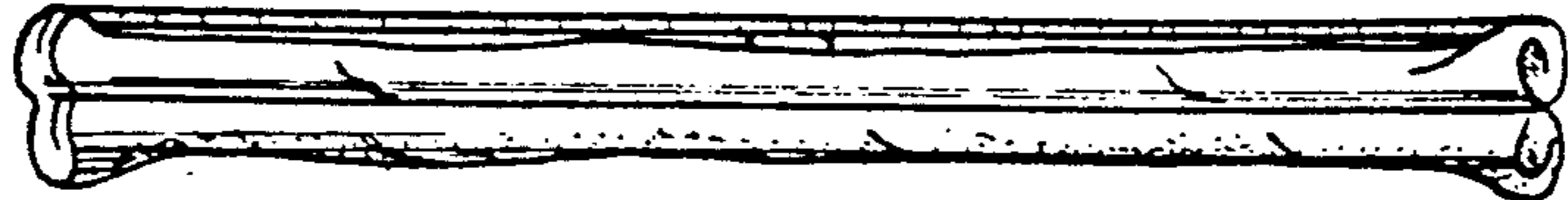

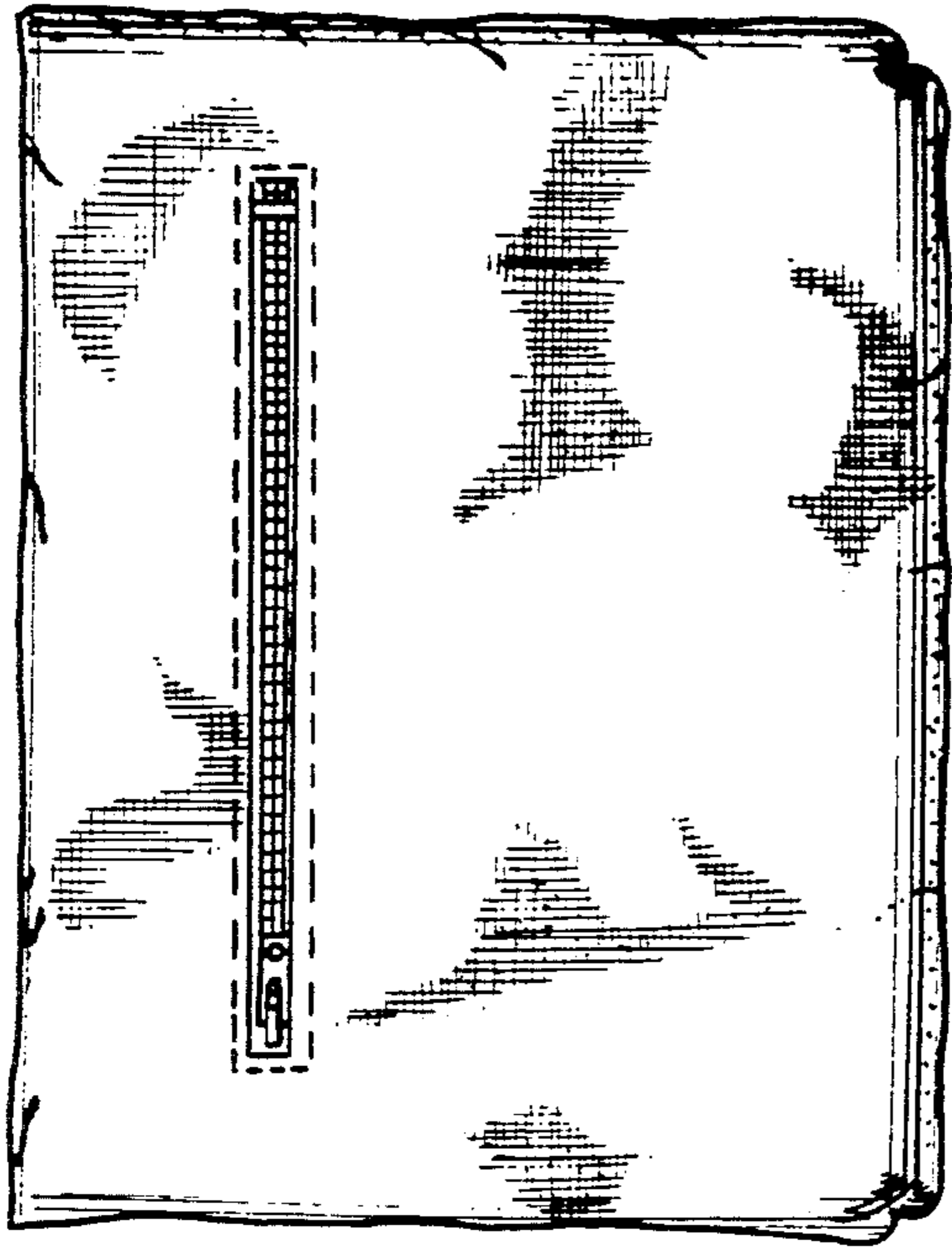

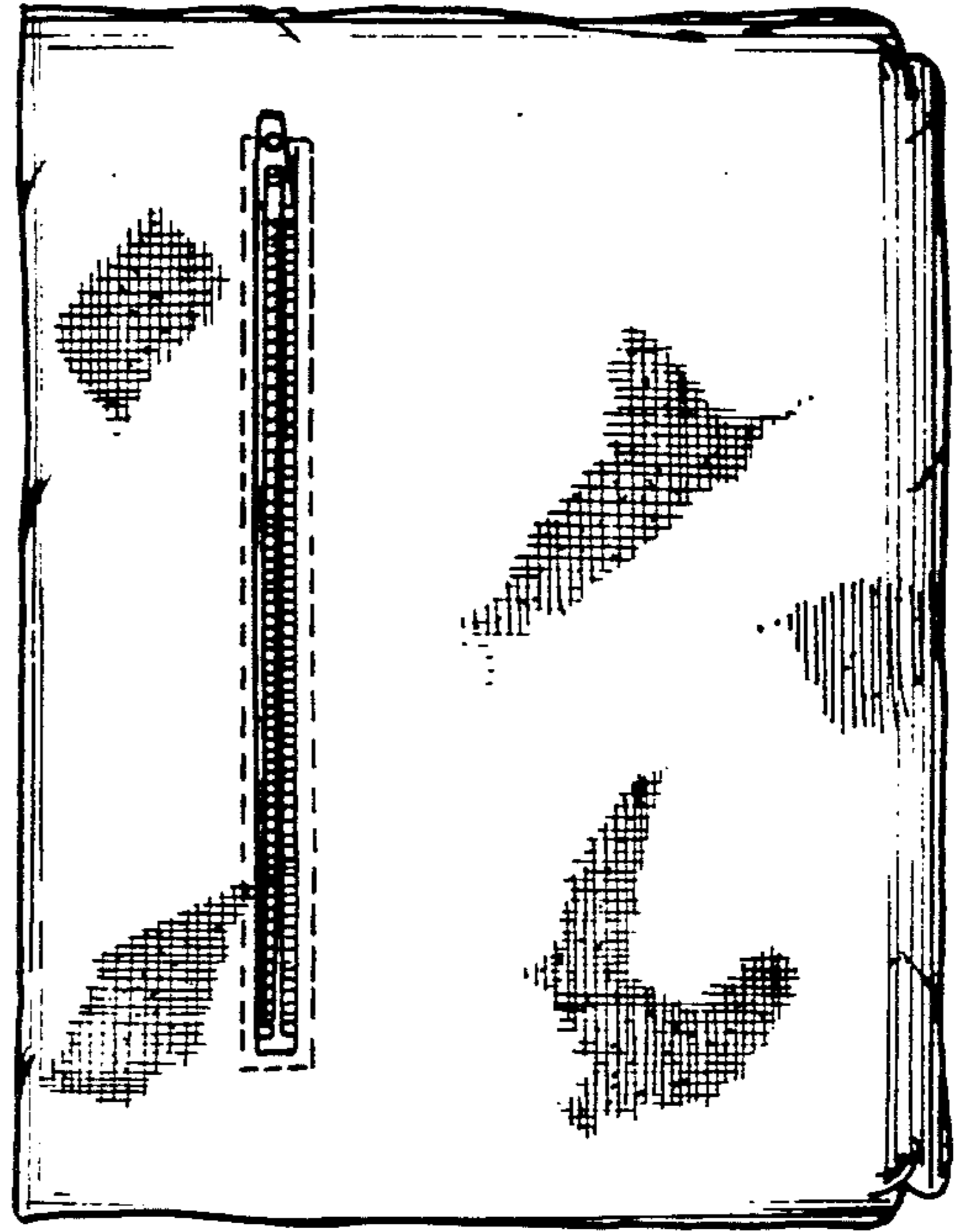

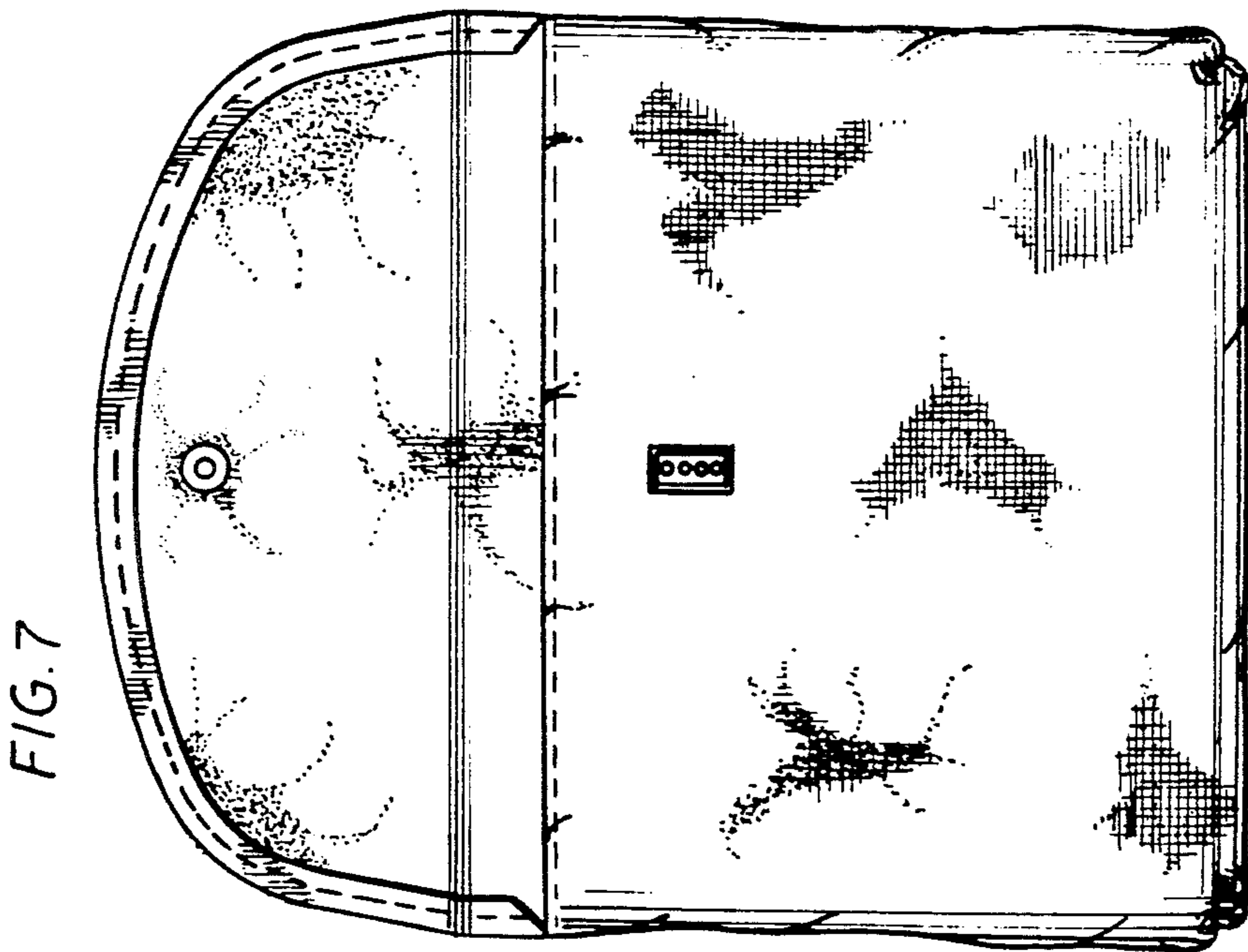
