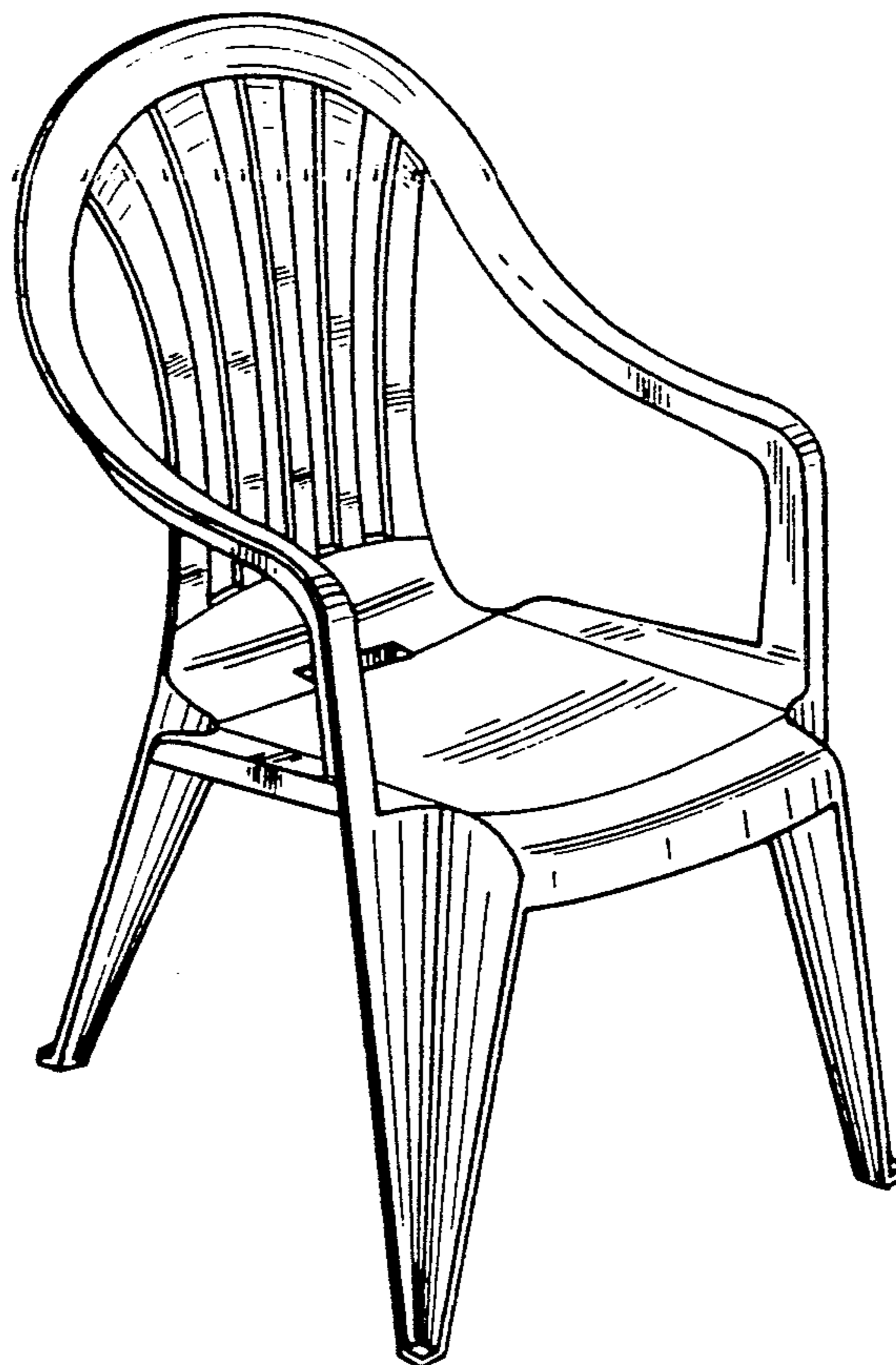

The ornamental design for an armchair, as shown and described.

**DESCRIPTION**

FIG. 1 is a left-front perspective view of an armchair showing my new design;  
FIG. 2 is a left side elevational view, the right side being a mirror image thereof;  
FIG. 3 is a front elevational view;  
FIG. 4 is a rear elevational view;

FIG. 6 is a bottom plan view thereof.



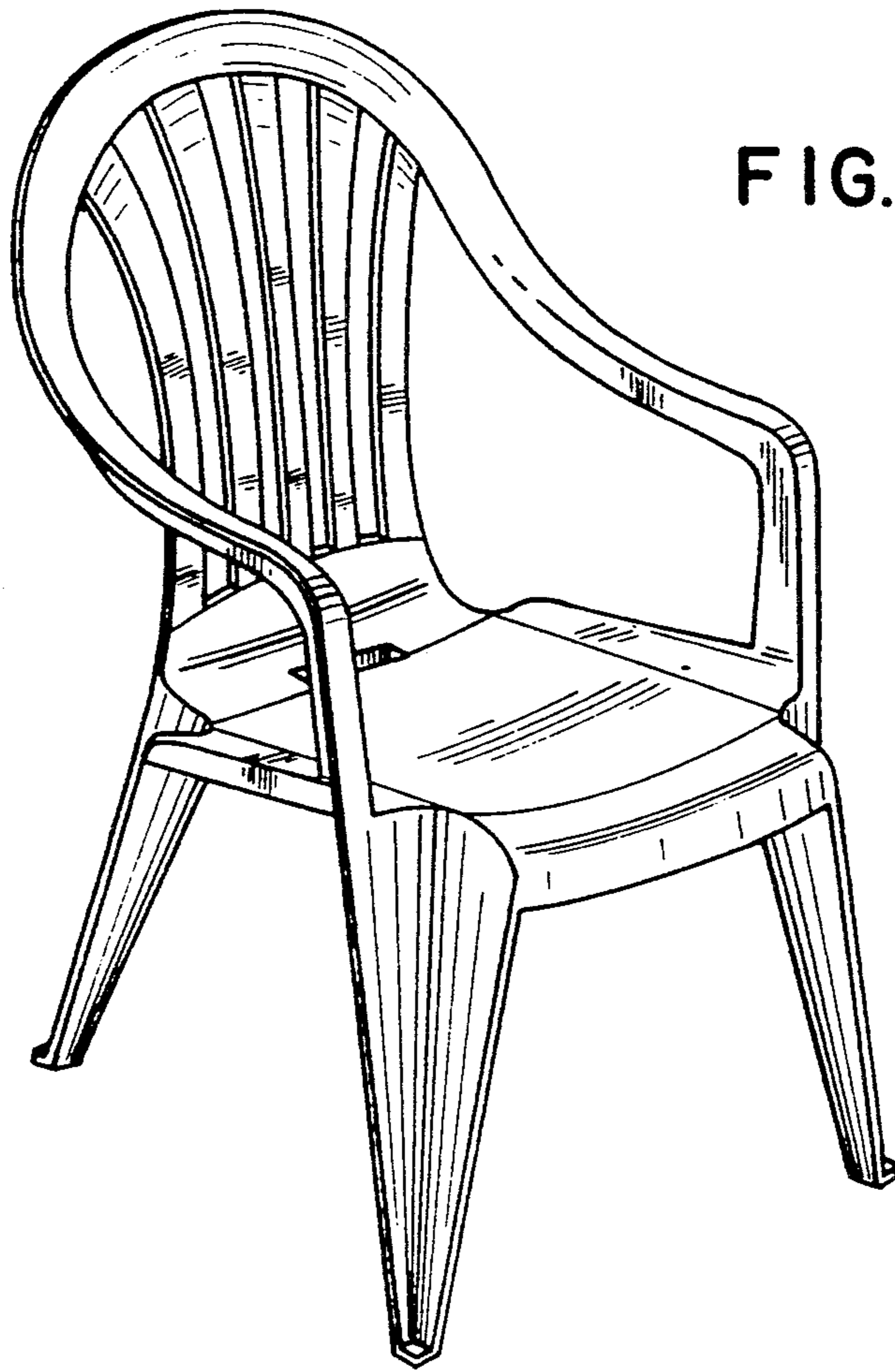

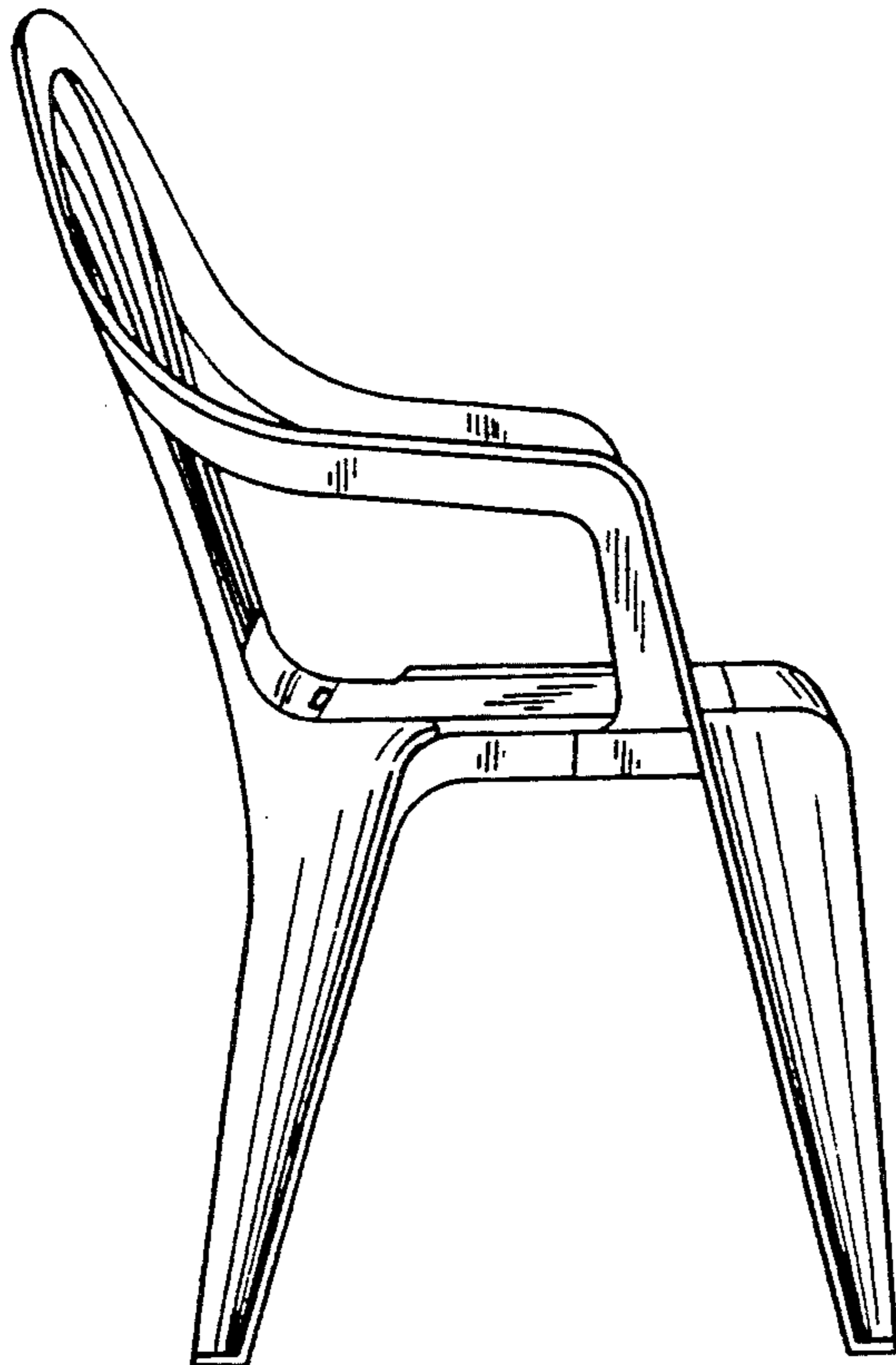

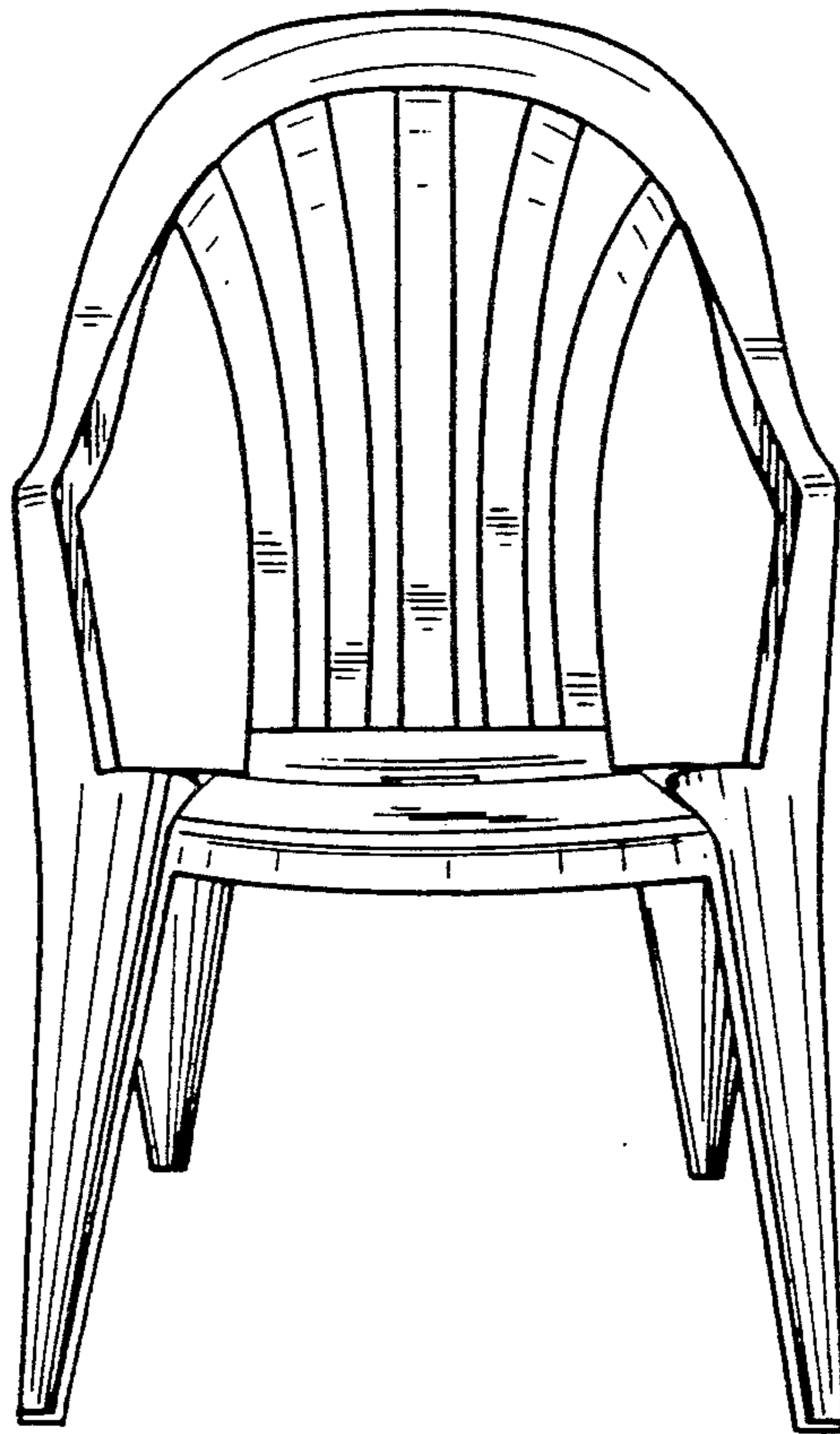
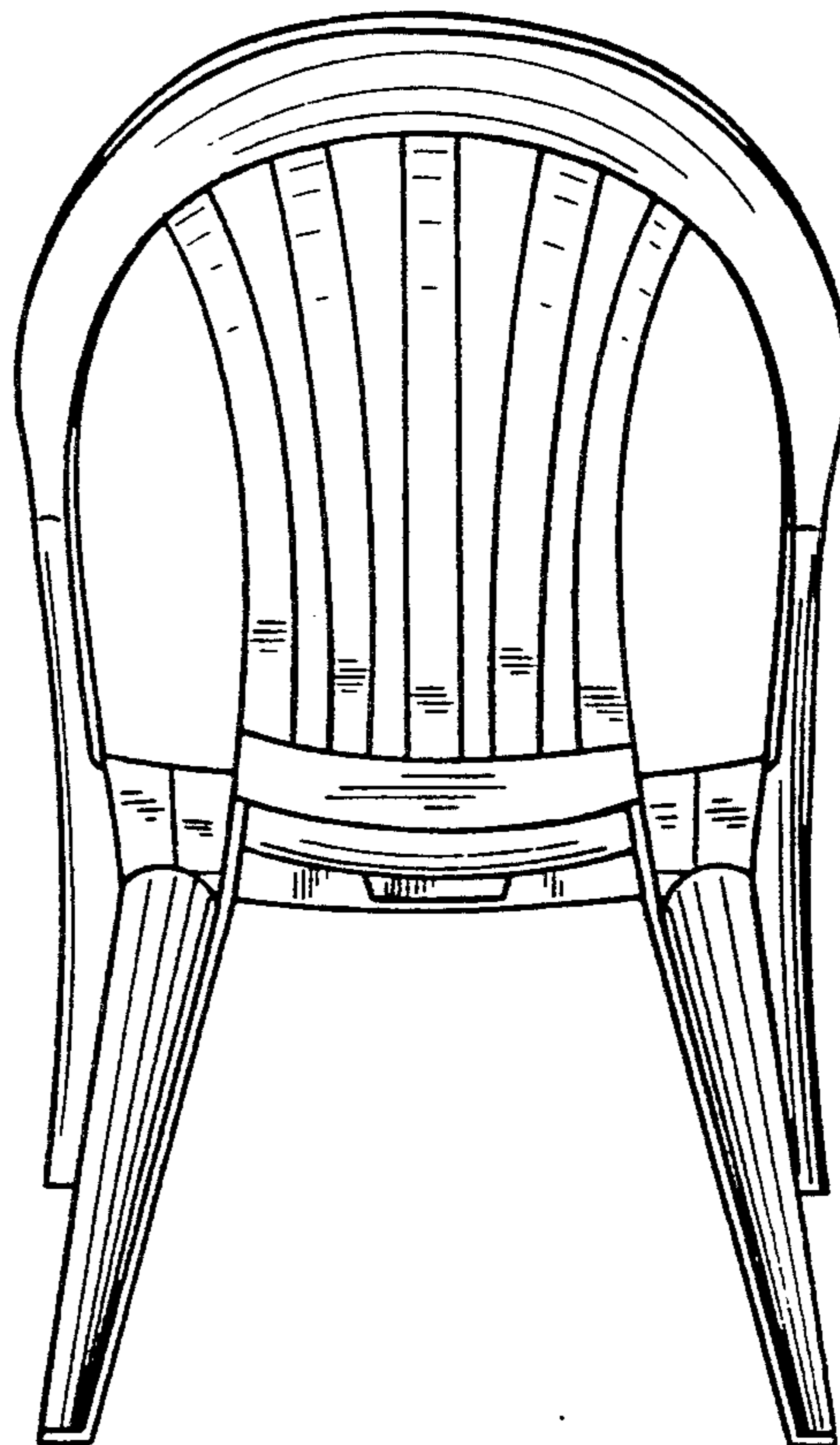

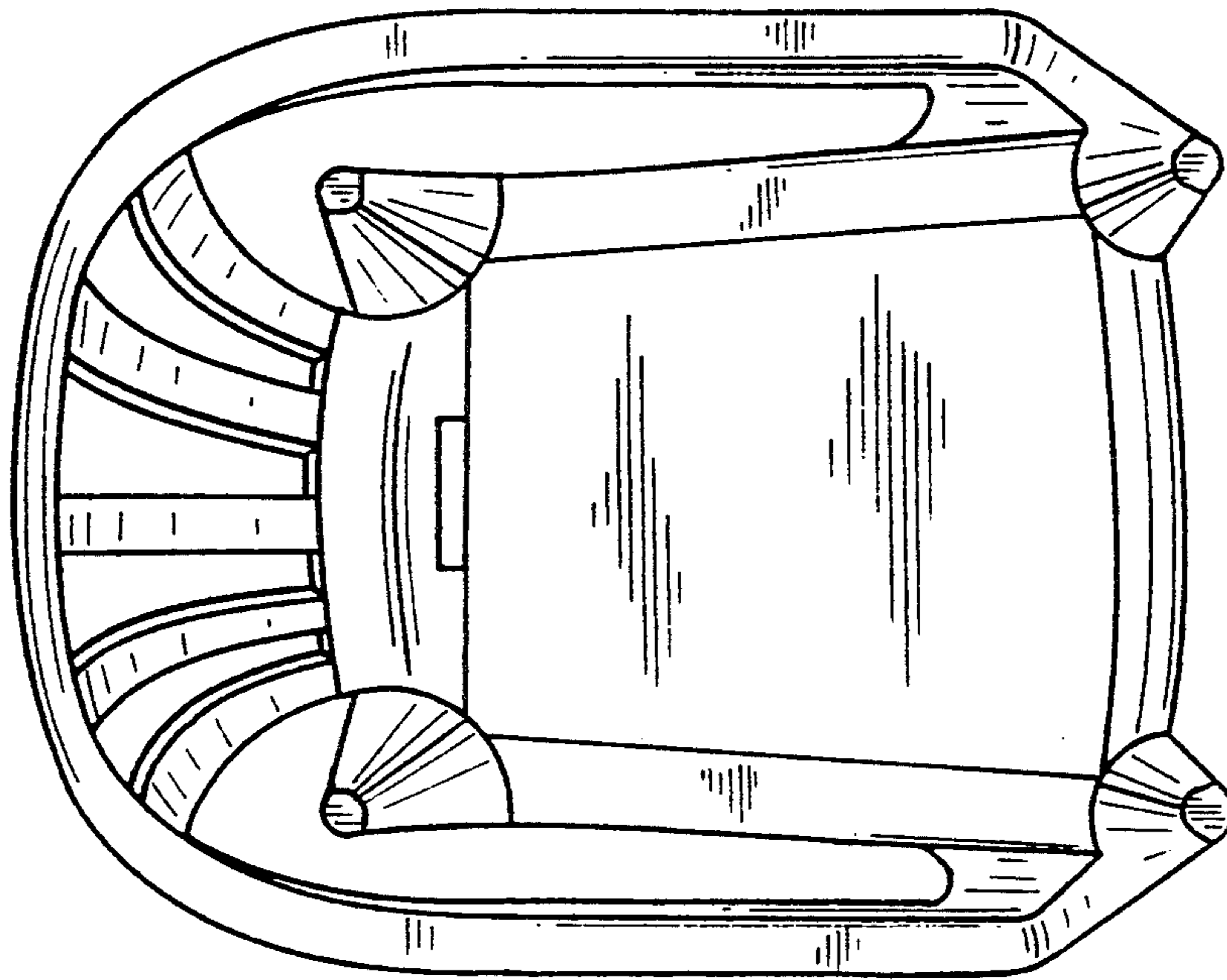

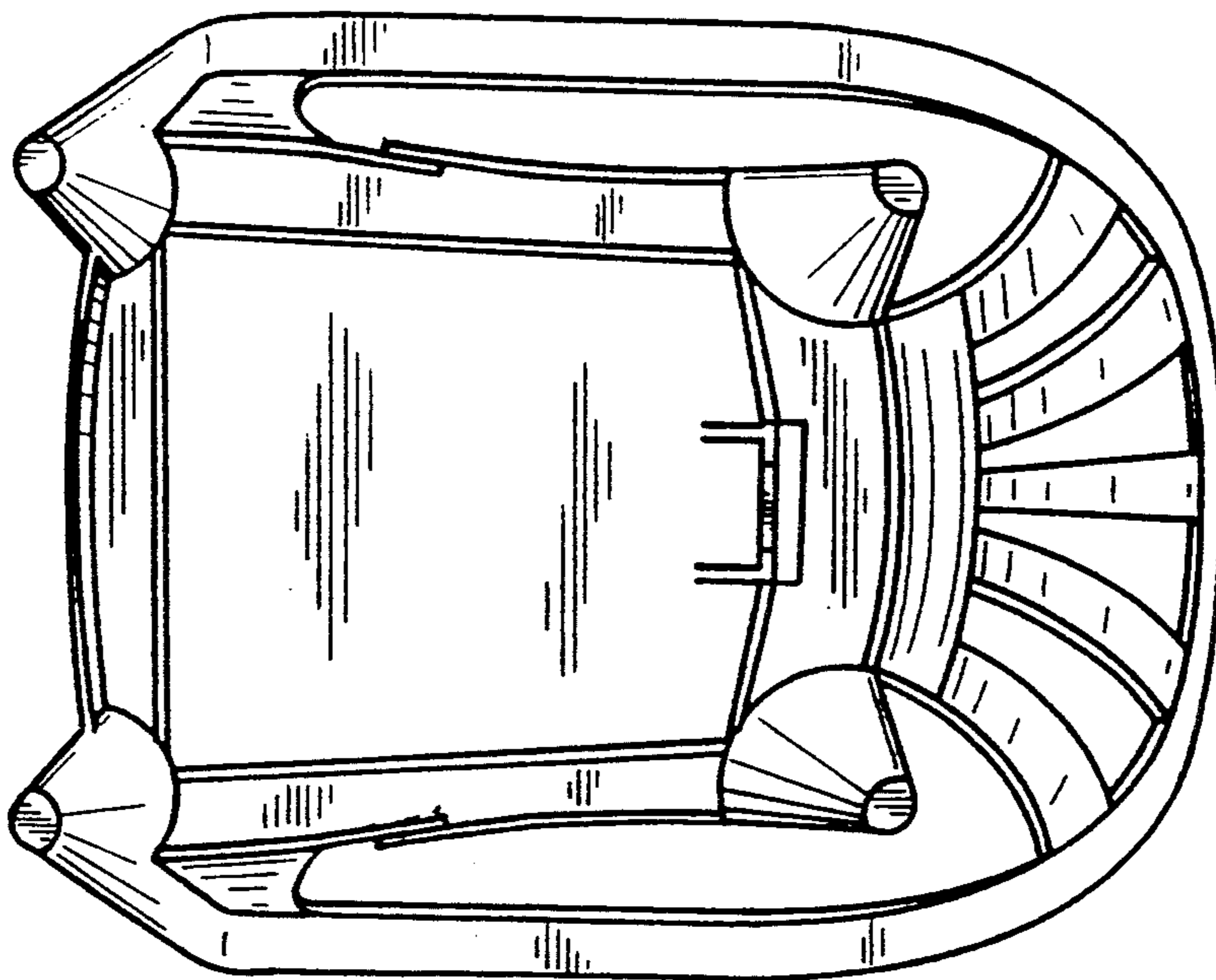
