[57] **CLAIM**

The ornamental design for a combined storage and dispensing receptable for plastic bags, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, and left side perspective view of a combined storage and dispensing receptacle for plastic bags showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a rear elevational view thereof; and,  
FIG. 5 is a right side elevational view thereof, the left side being a mirror image of that shown.

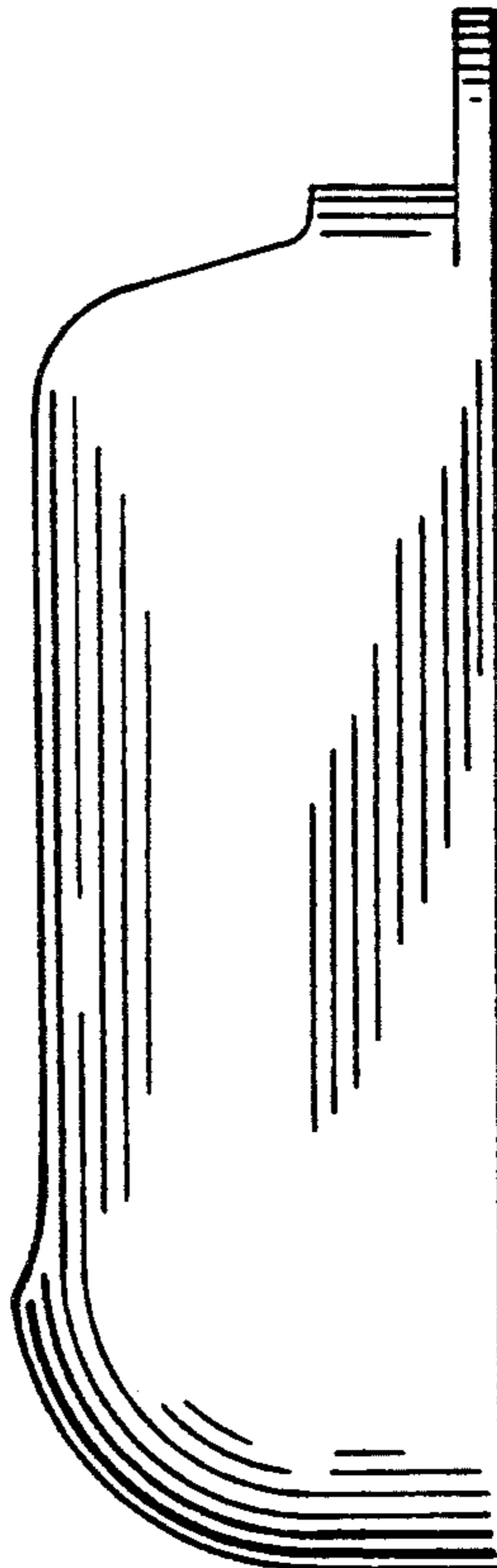
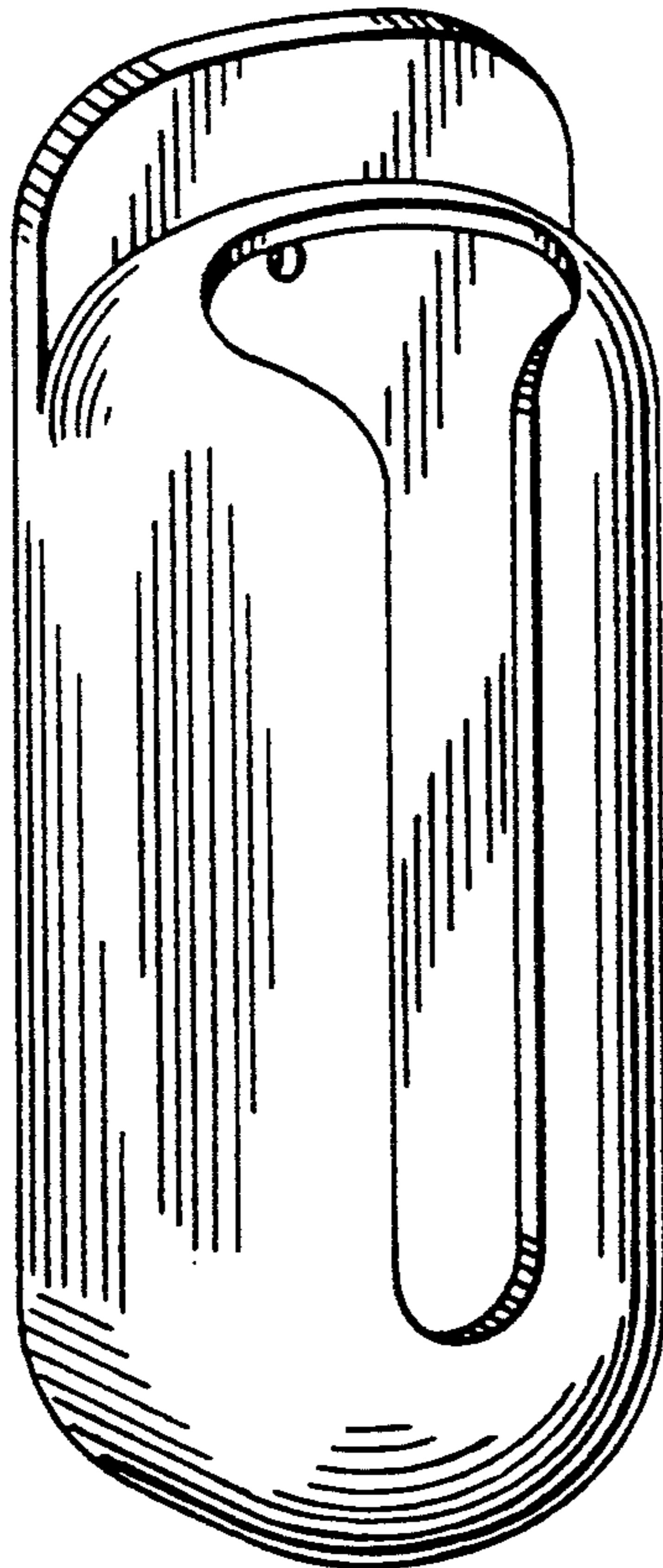

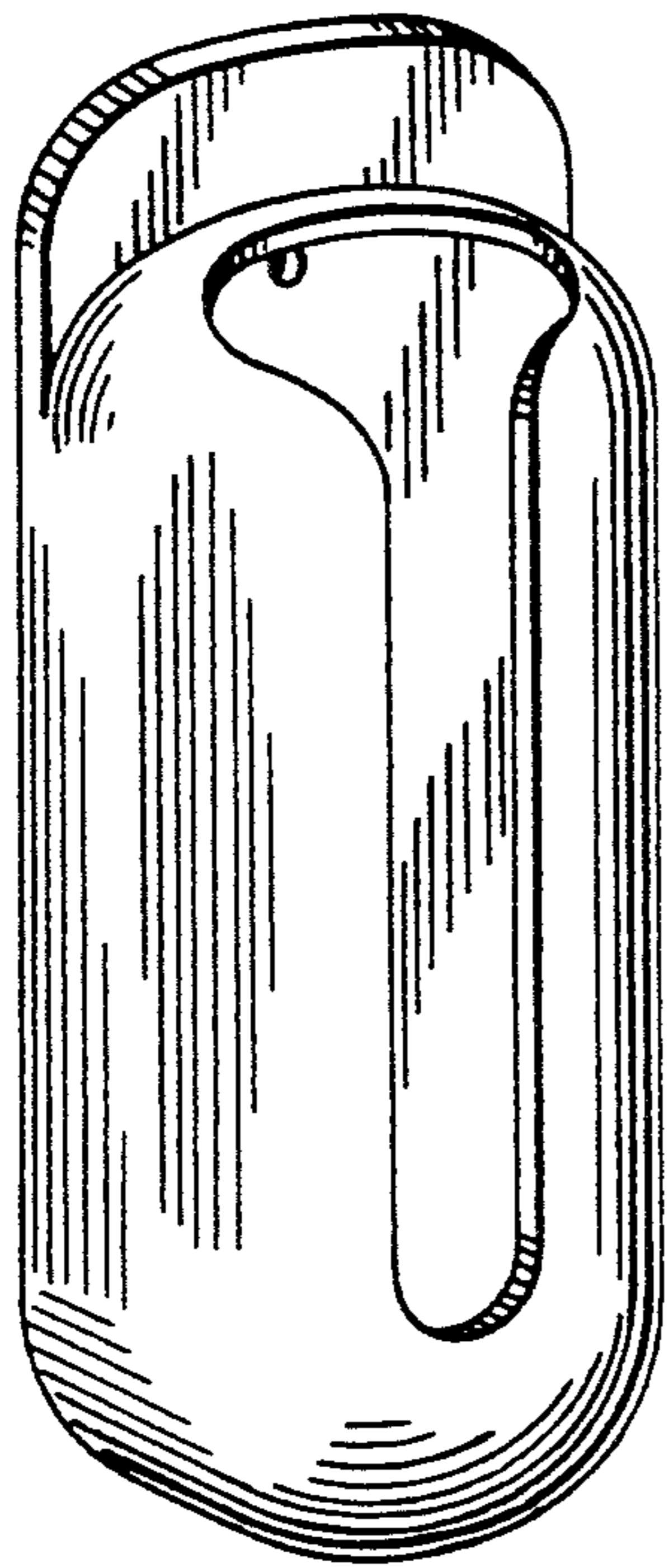

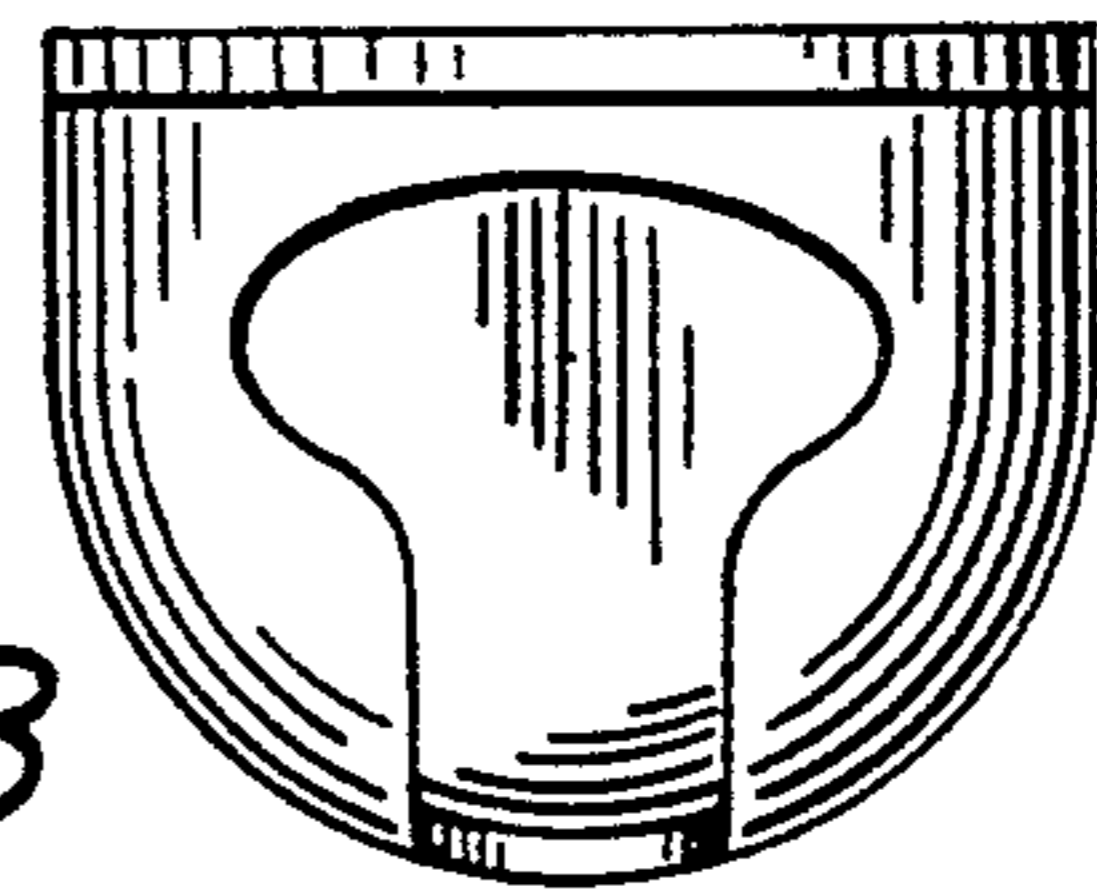
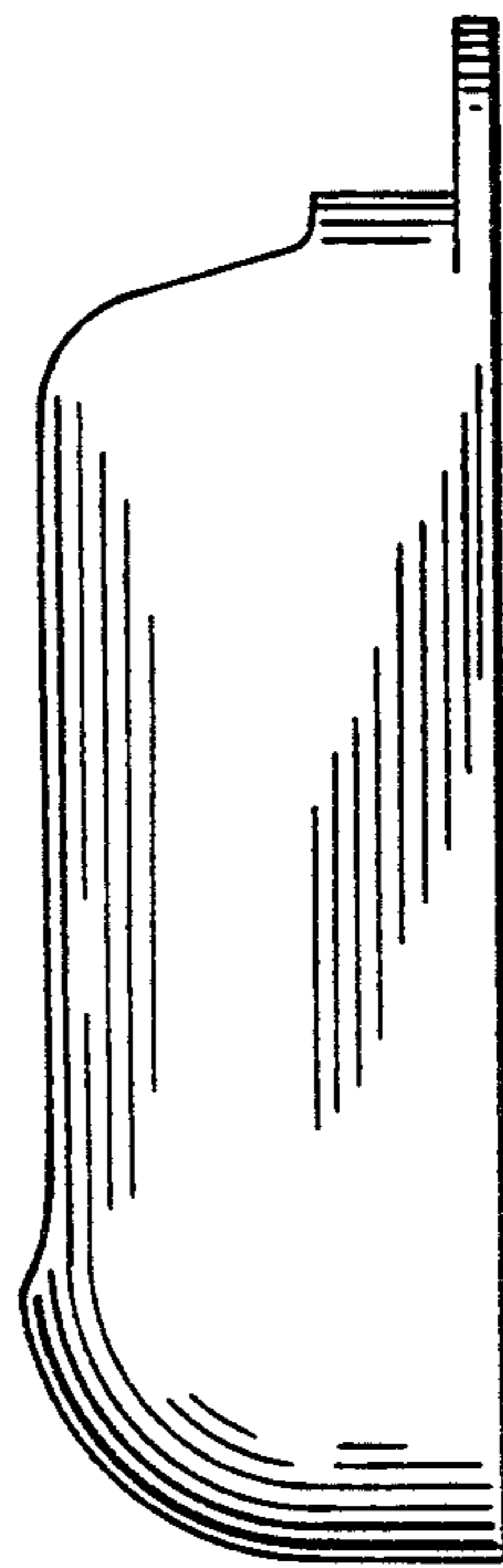

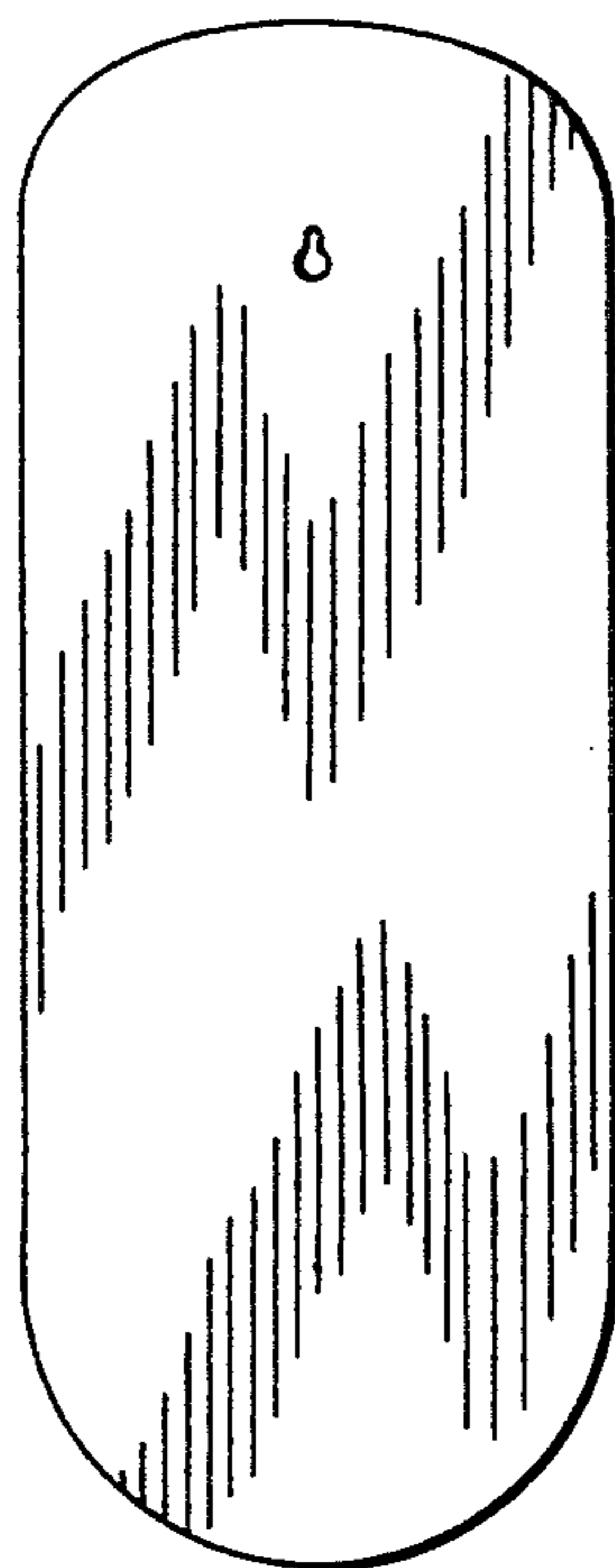

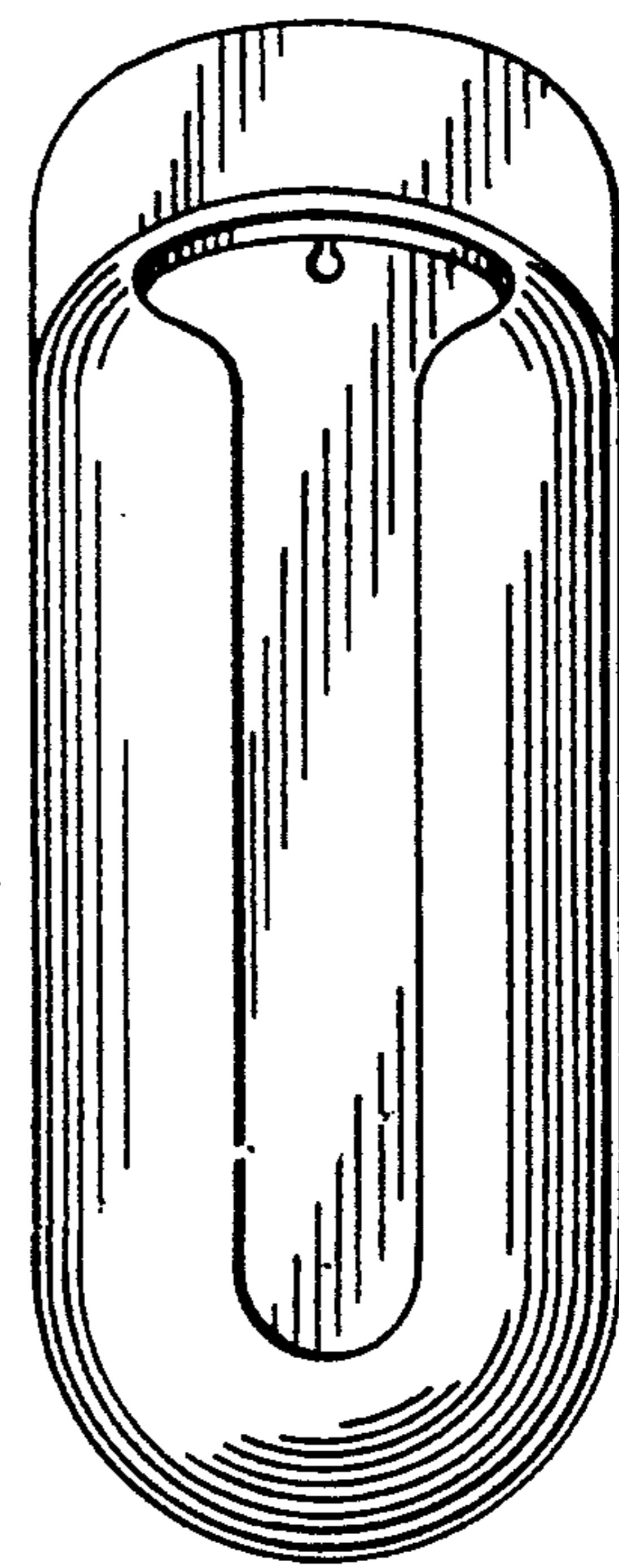
