The ornamental design for a cutoff insert, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a cutoff insert showing our new design;

FIG. 2 is a top, rear and right side perspective view;

FIG. 3 is a front elevational view;

FIG. 4 is a bottom plan view;

FIG. 5 is a right side elevational view;

FIG. 6 is a top plan view;

FIG. 7 is a rear elevational view; and,

FIG. 8 is a left side elevational view thereof.

FIGS. 1 and 2 have been drawn on an enlarged scale with respect to FIGS. 3-8.

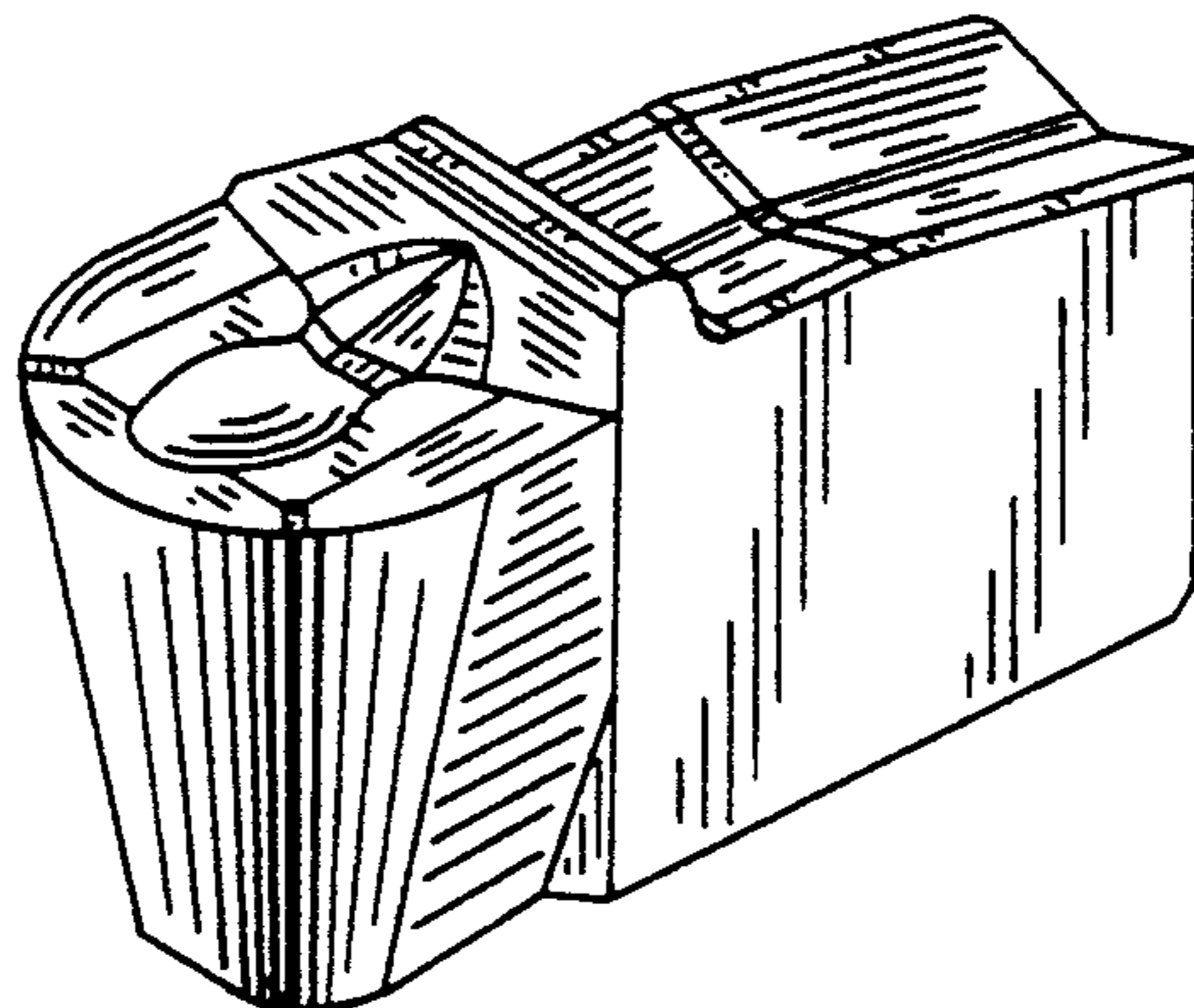

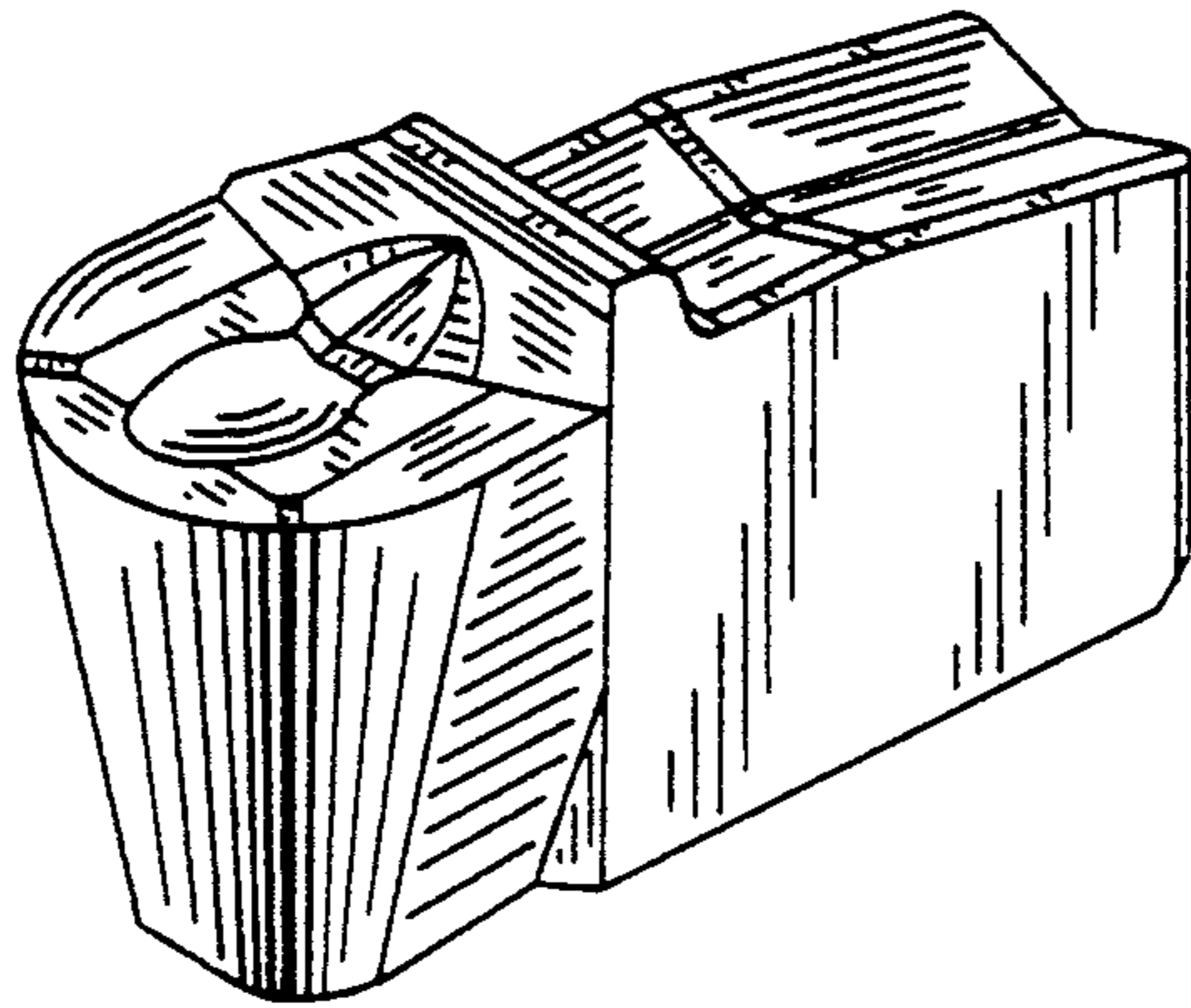

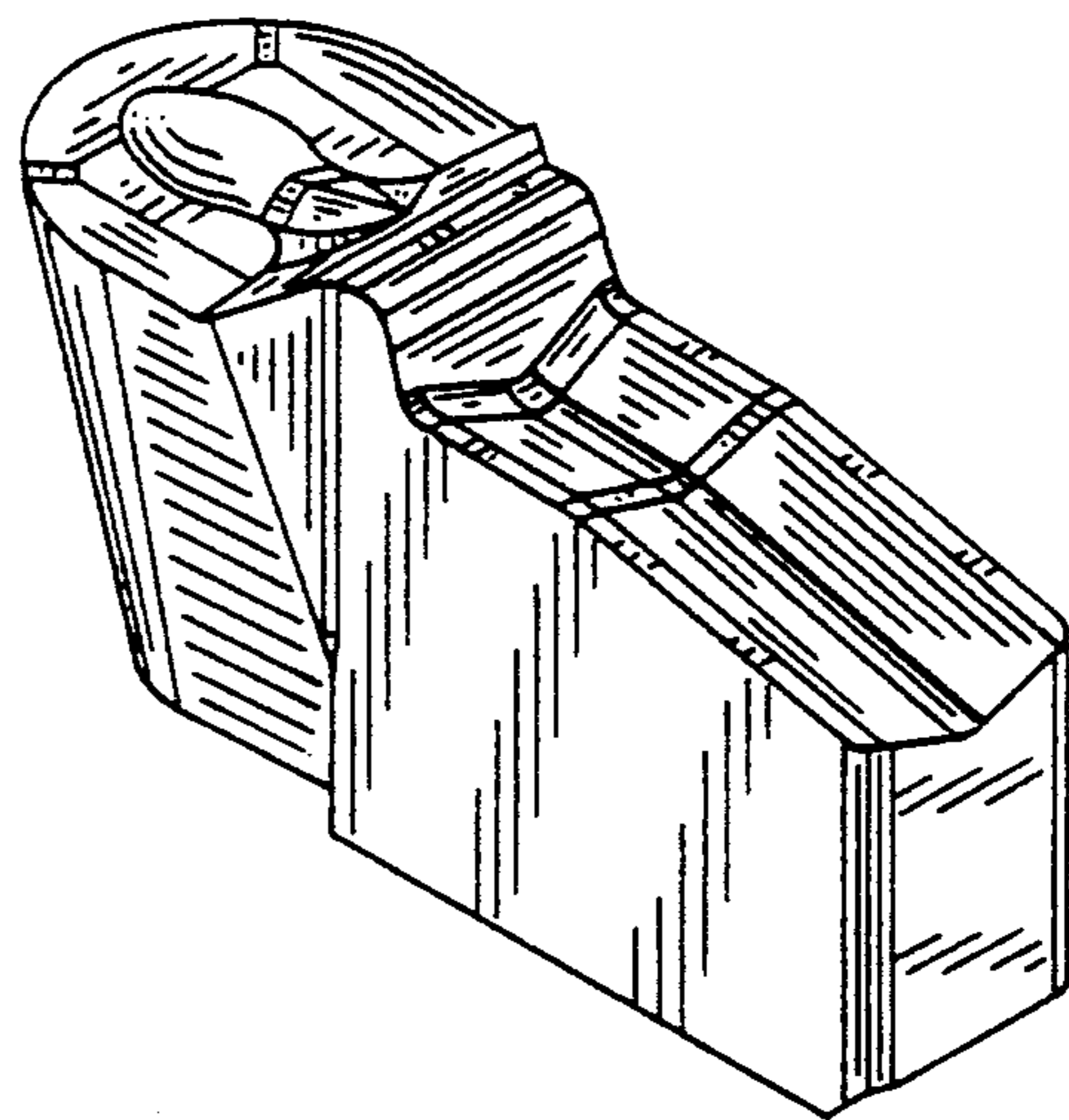

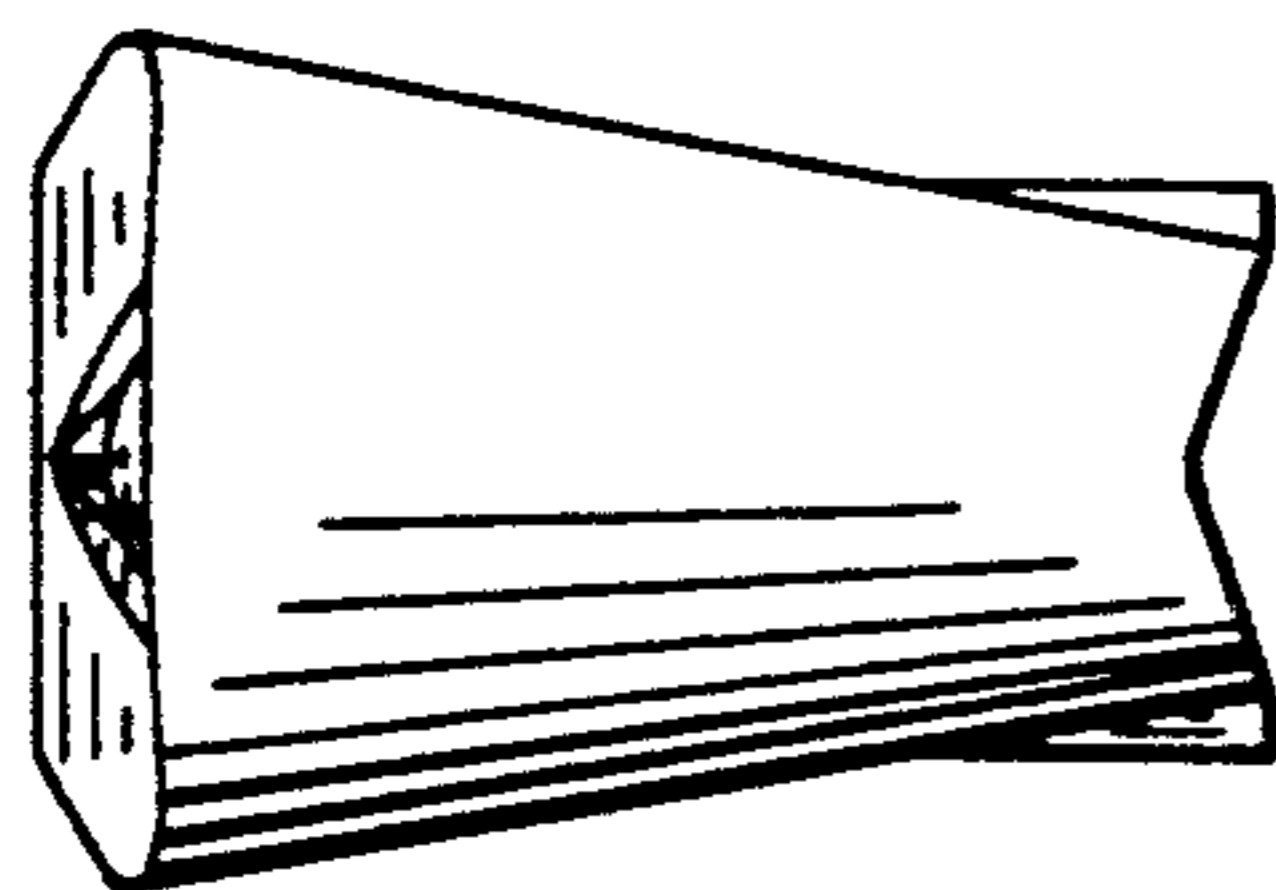

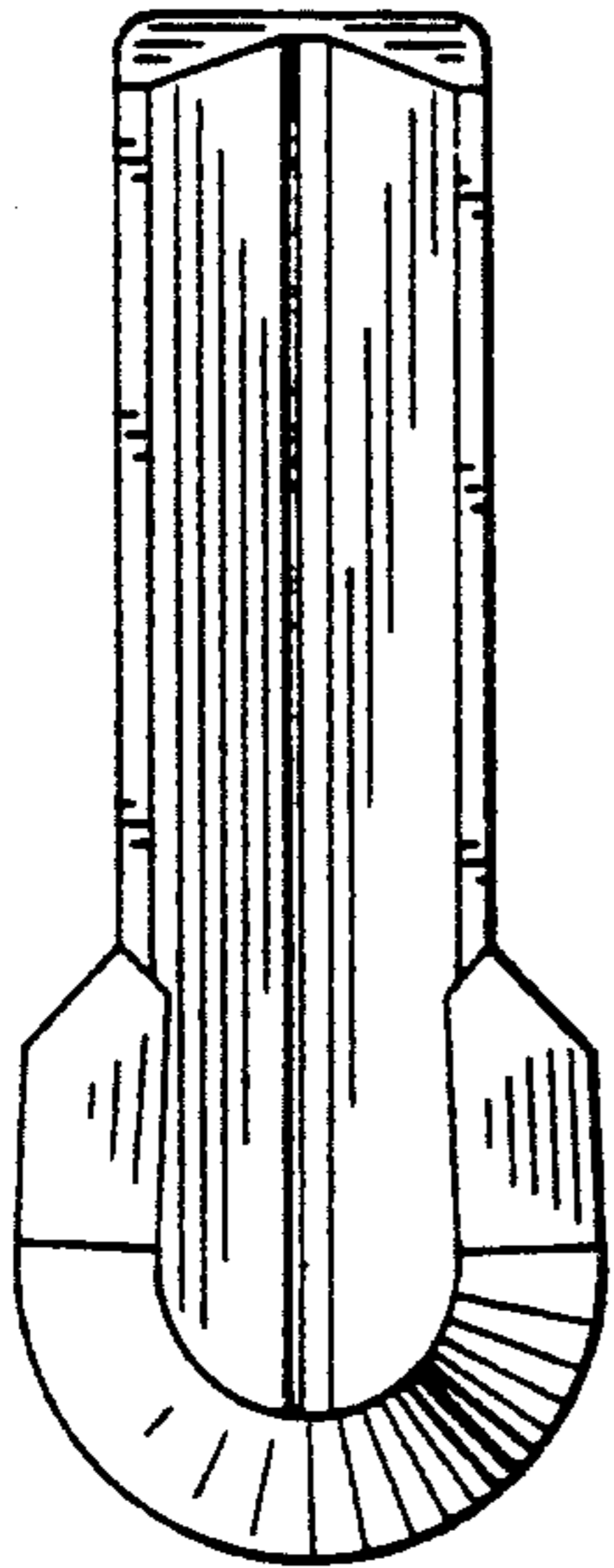

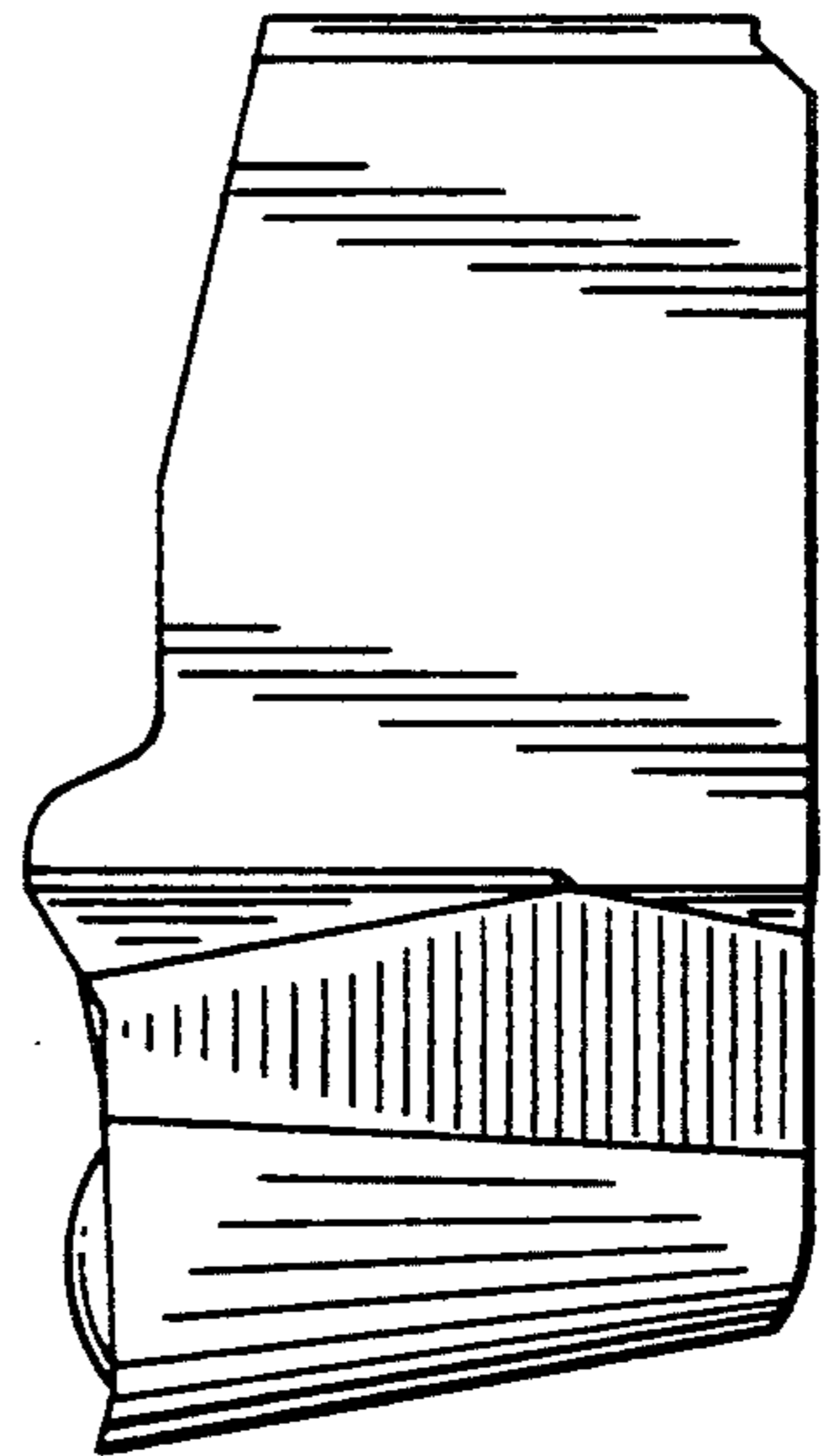

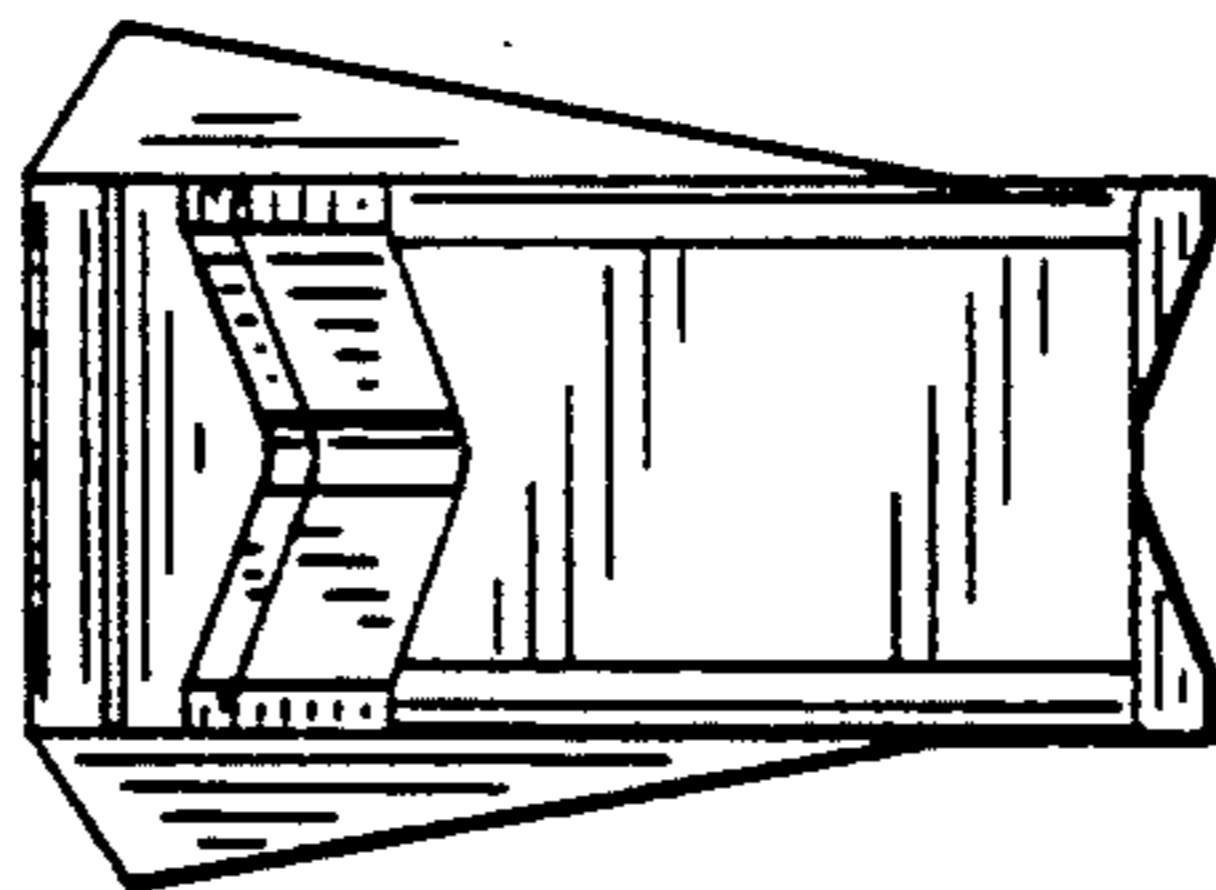

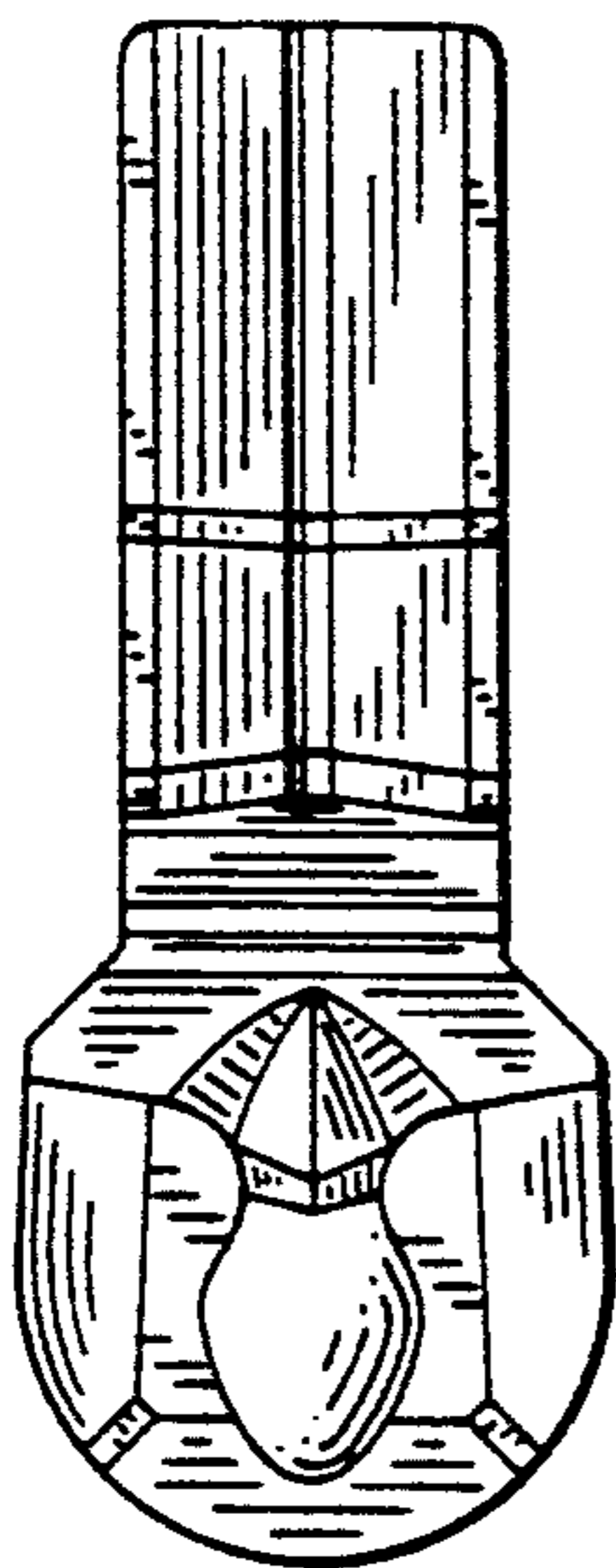
