### DESCRIPTION

FIG. 1 is a side elevational view of a shoe upper showing my new design;

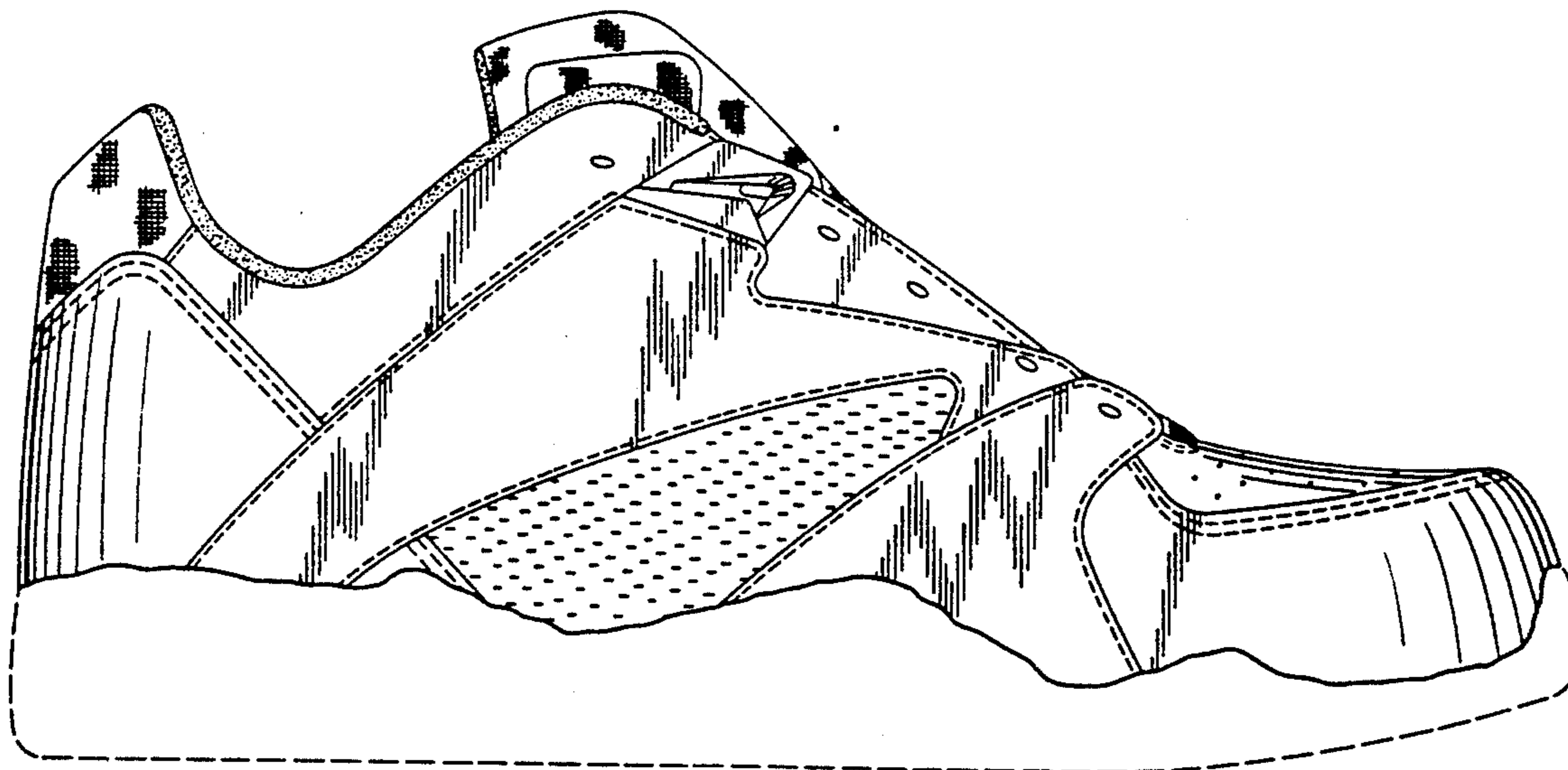
FIG. 2 is a side elevational view of the other side of the shoe upper;

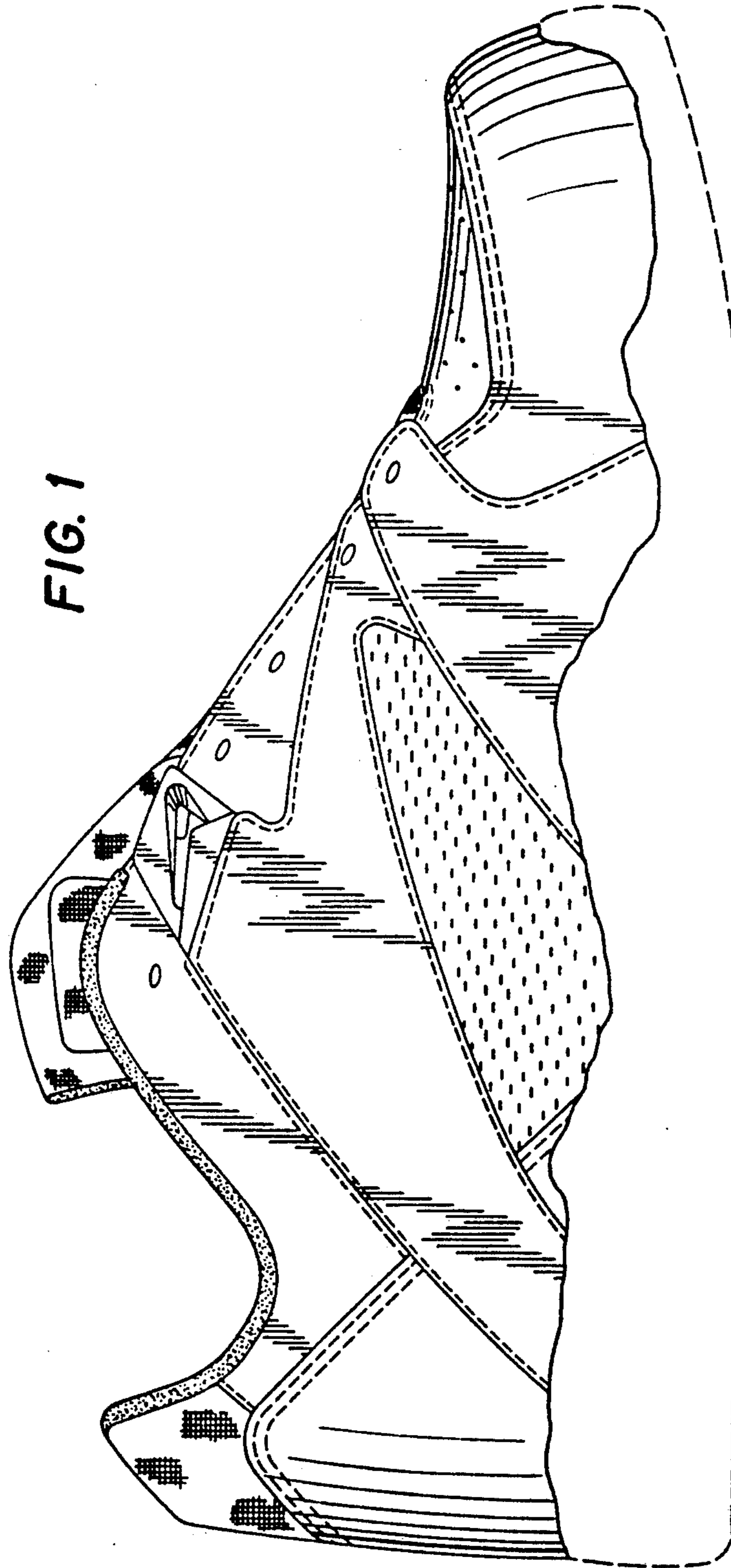
FIG. 3 is a front elevational view of the shoe upper;

The broken line showing the sole of the shoe is for illustrative purposes only and forms no part of the claimed design.





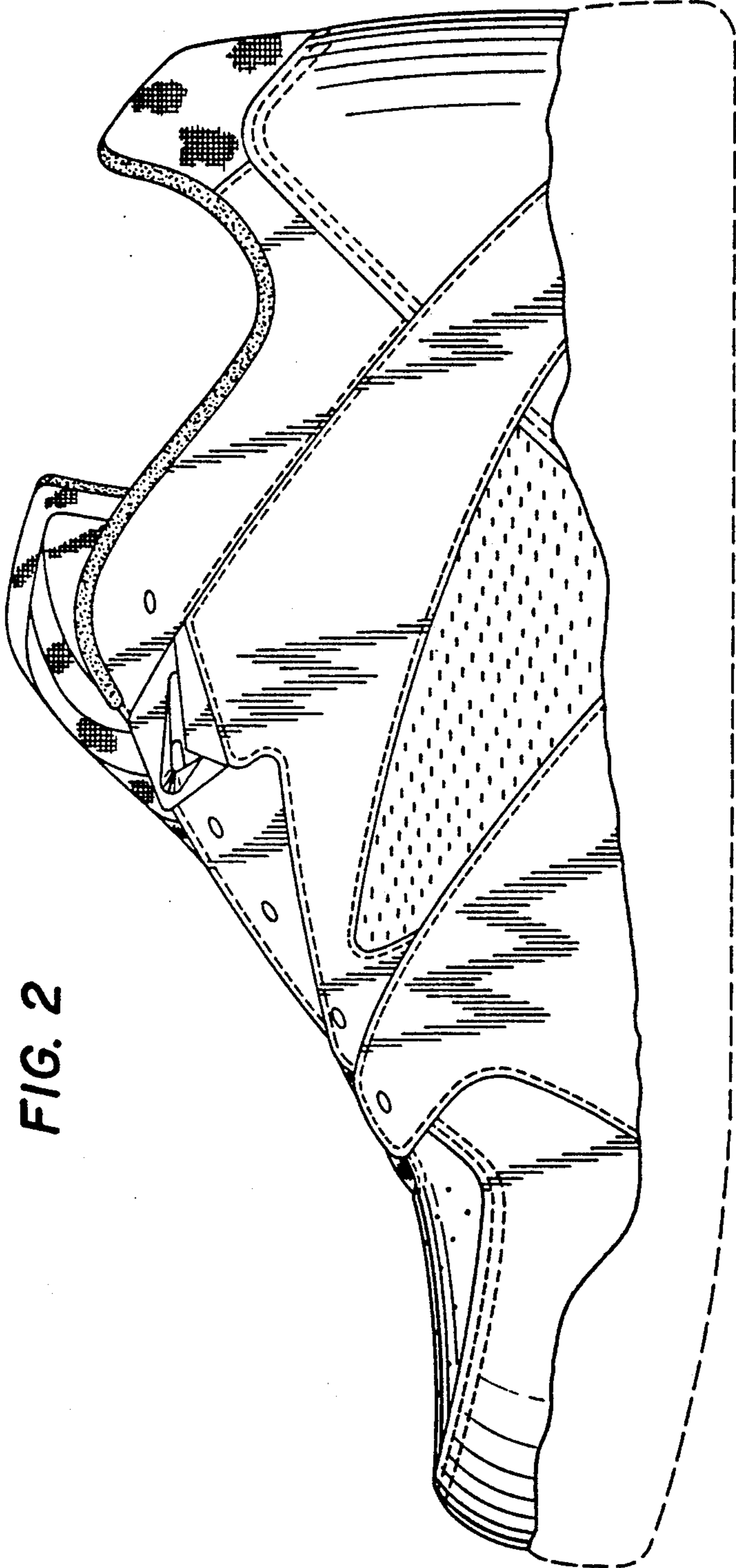

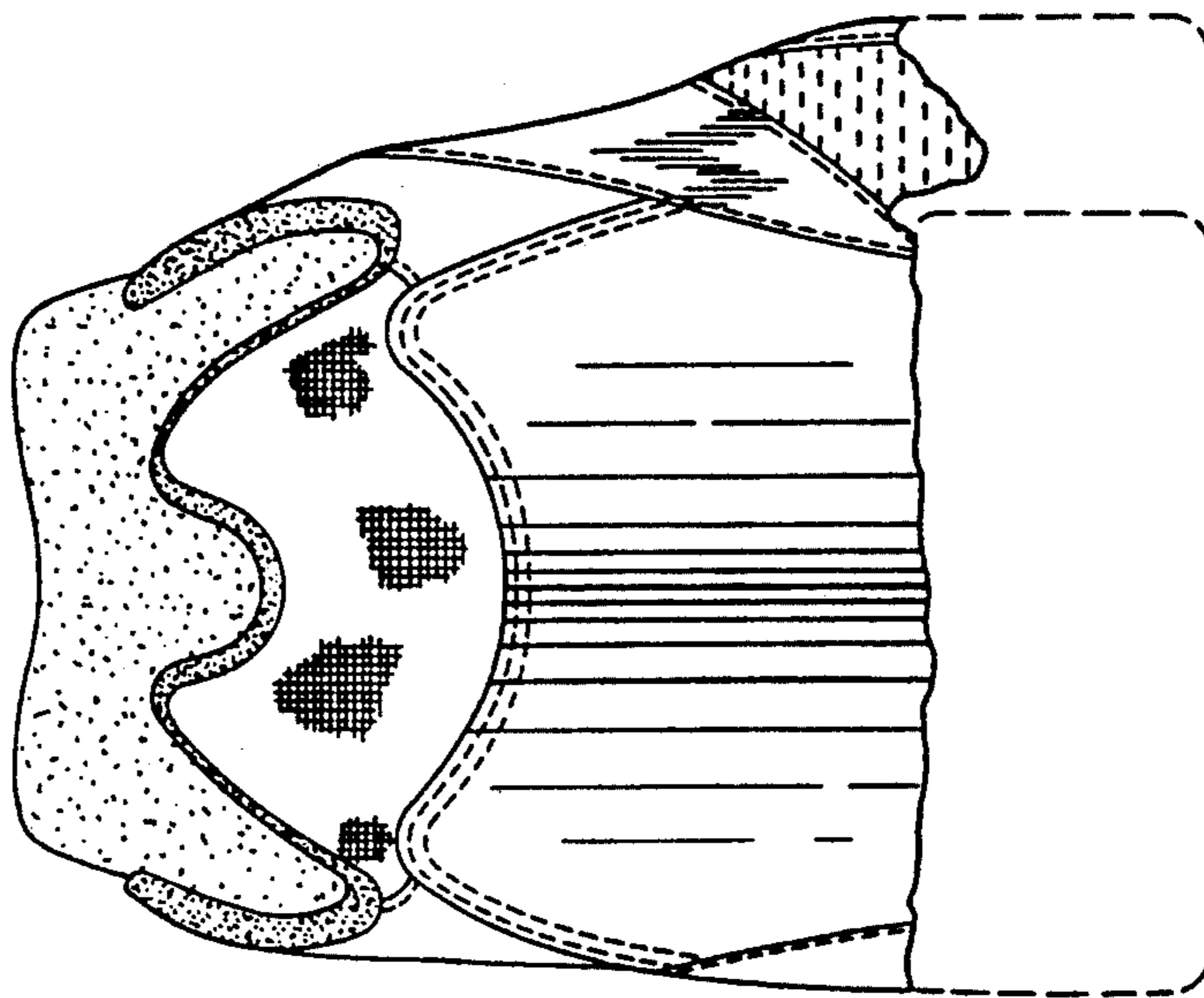
