[57] CLAIM

The ornamental design for a bathroom accessory, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and right side perspective view of a bathroom accessory as embodied in a shelf showing my new design;

FIG. 2 is an enlarged top plan view thereof;

FIG. 3 is an enlarged front elevational view thereof;

FIG. 4 is an enlarged left side elevational view thereof, the right side being a mirror image of that shown;

FIG. 5 is an enlarged rear elevational view thereof;

FIG. 6 is an enlarged bottom plan view thereof;

FIG. 7 is a top, front, and right side perspective view of a bathroom accessory as embodied in a soap dish showing my new design;

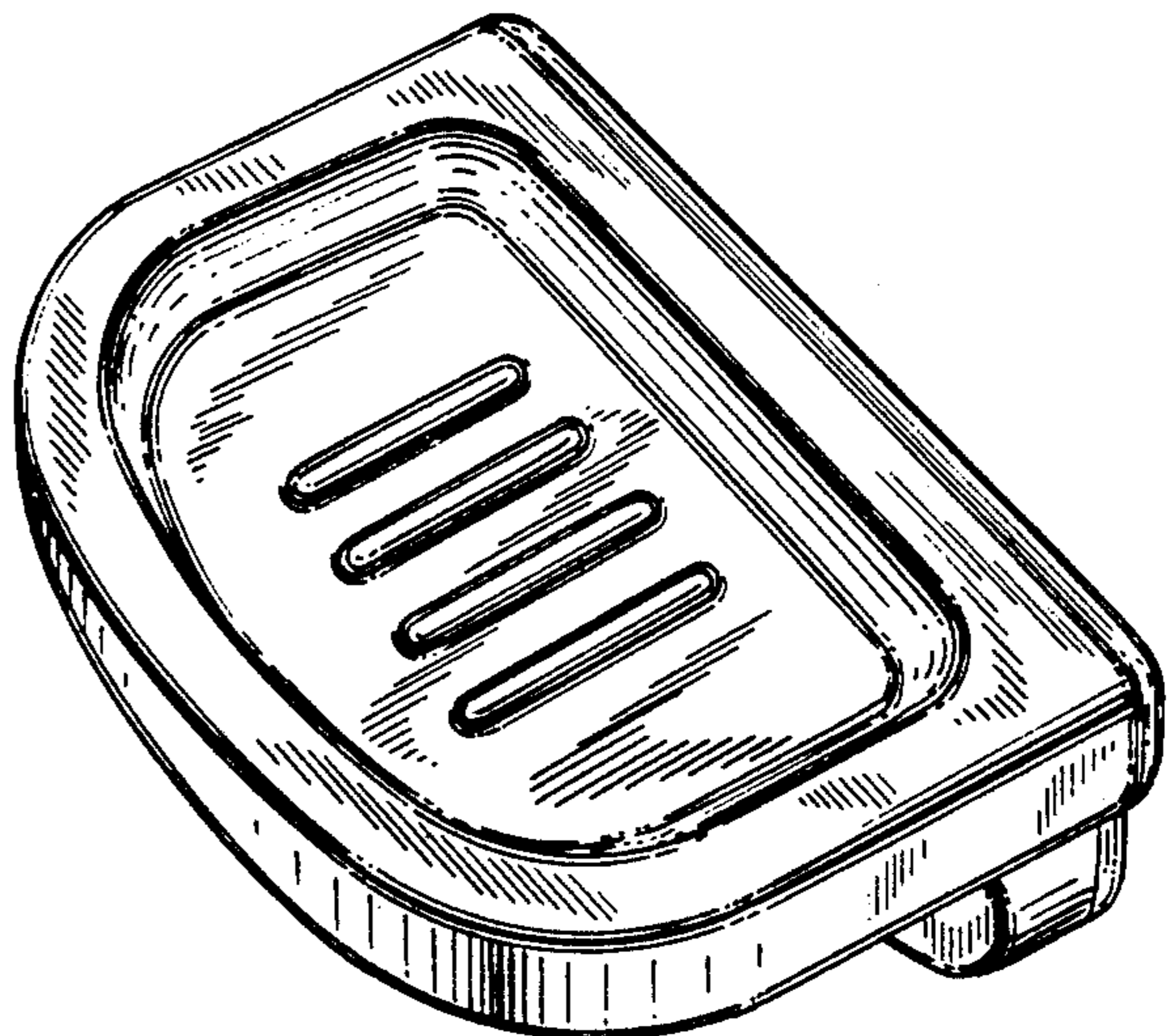
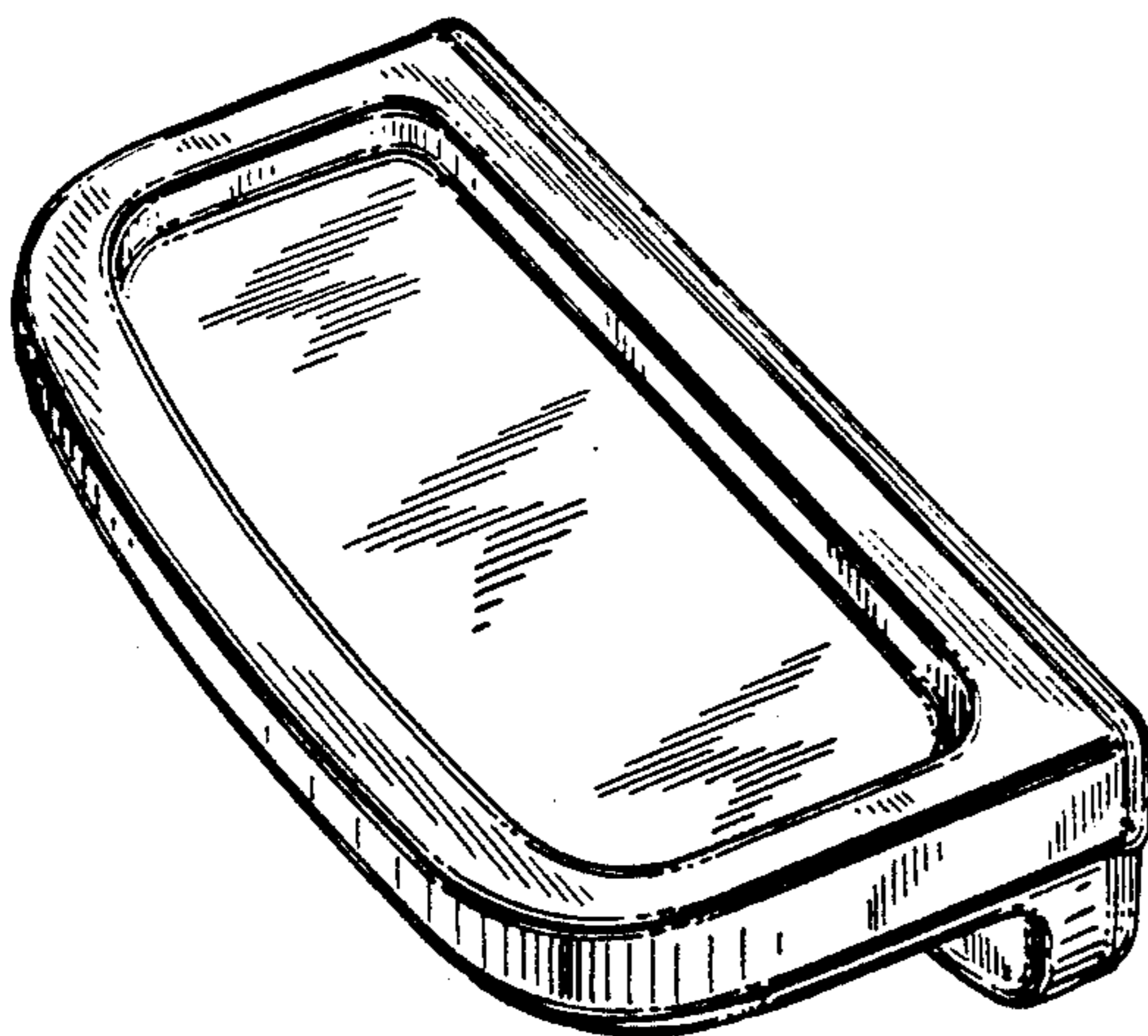
FIG. 8 is a top plan view thereof;

FIG. 12 is a bottom plan view thereof.



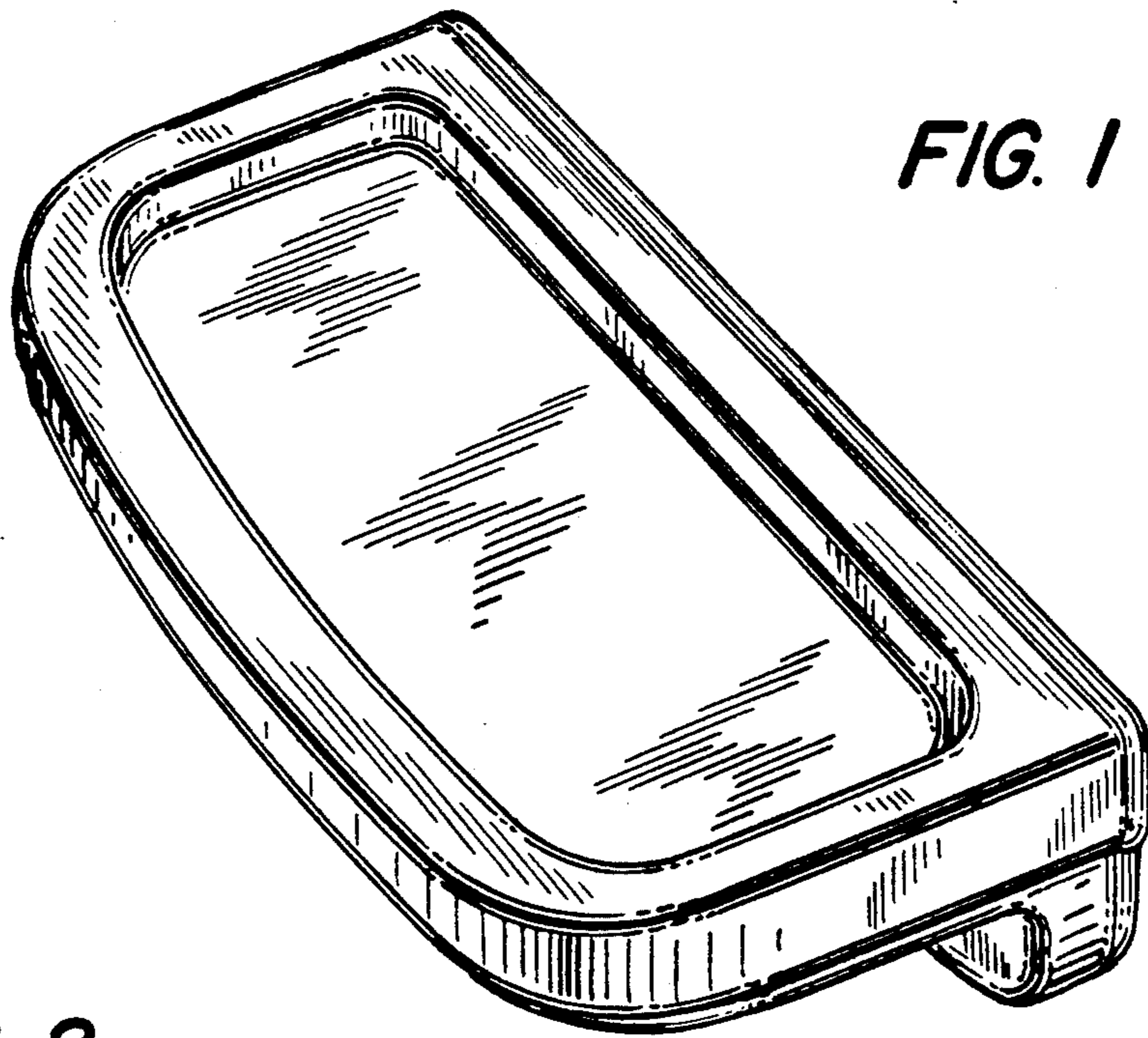

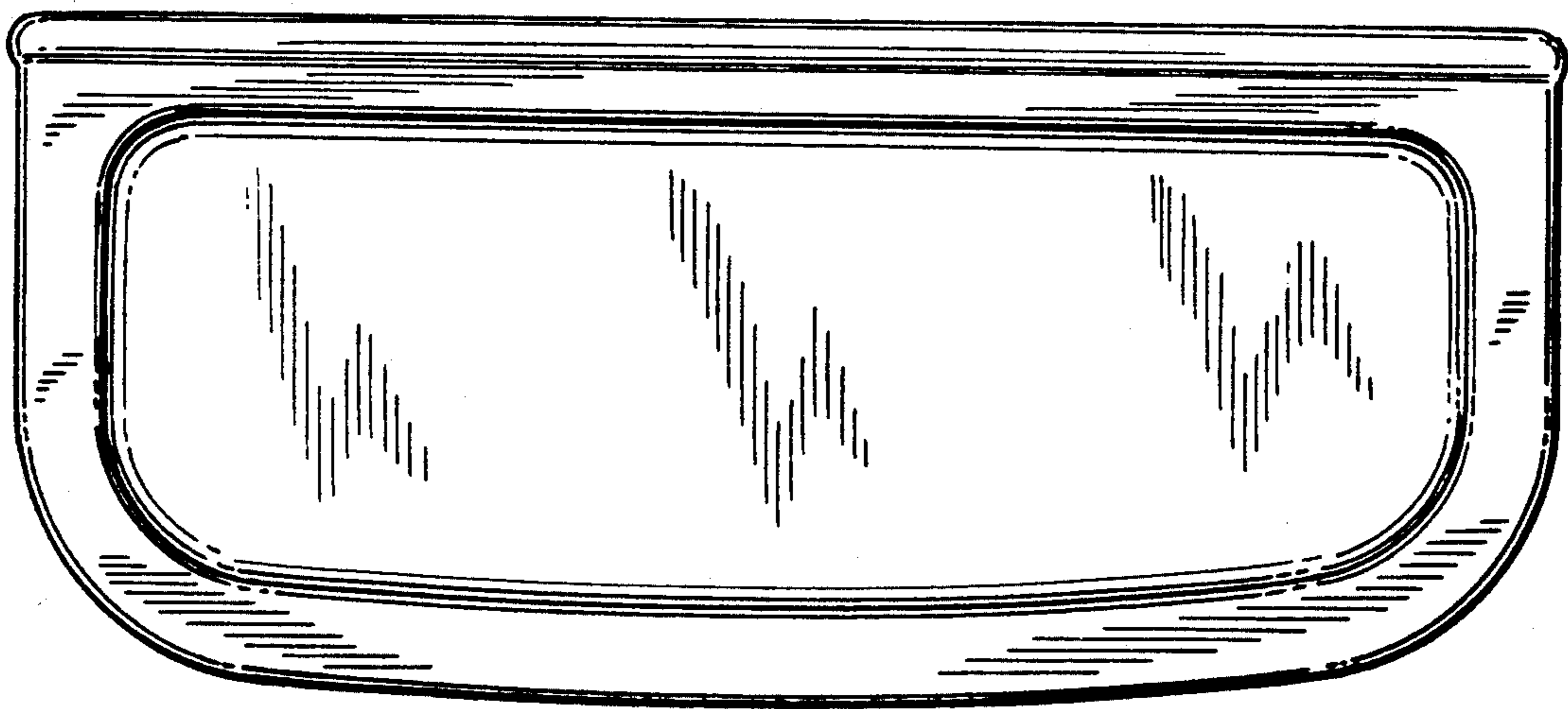

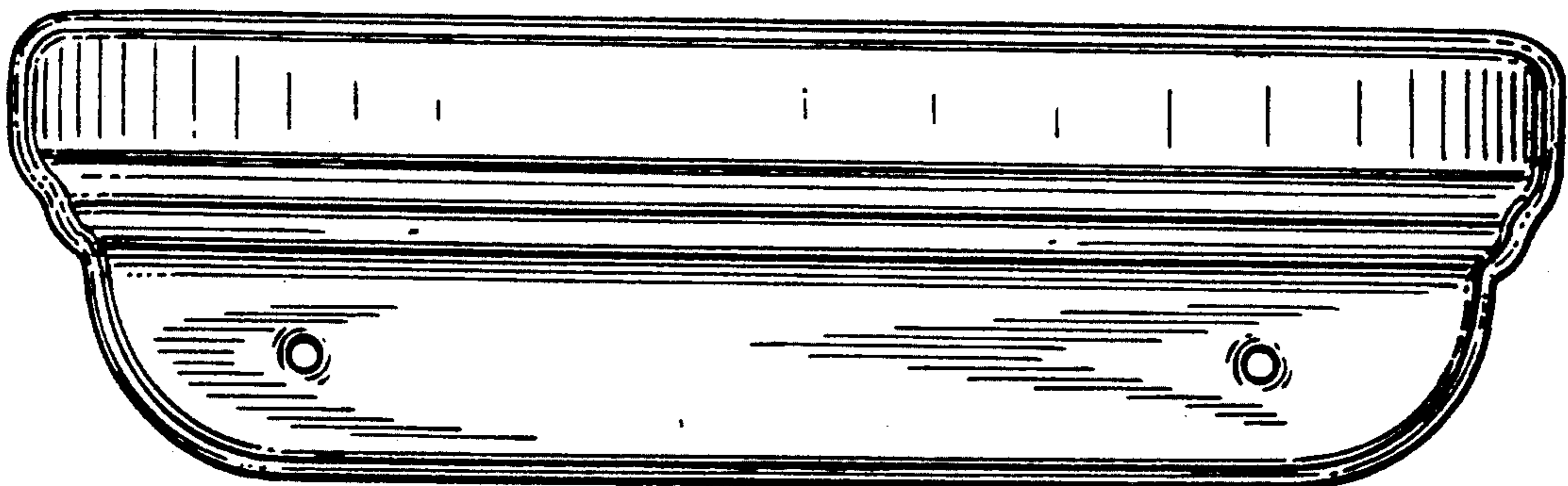

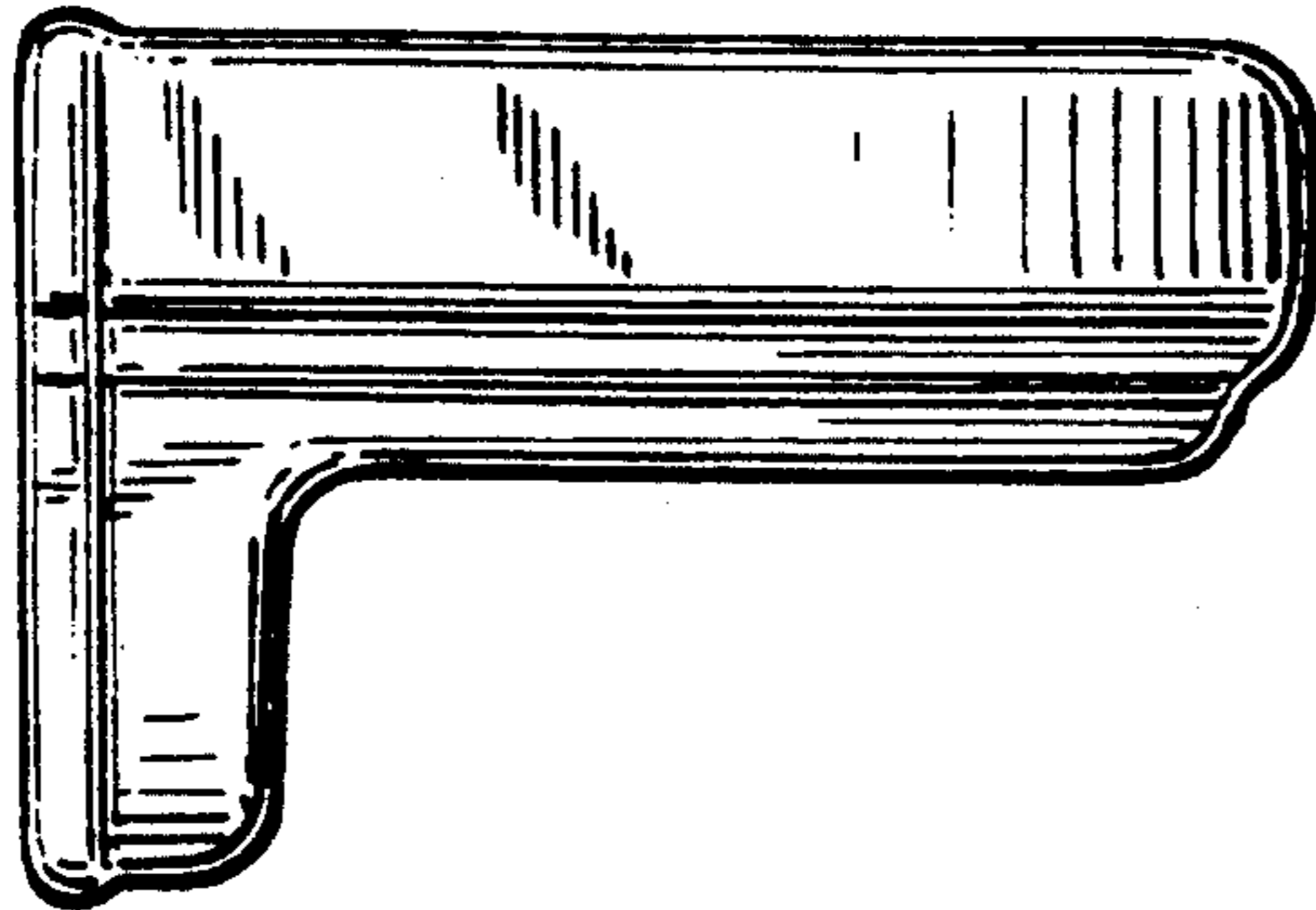

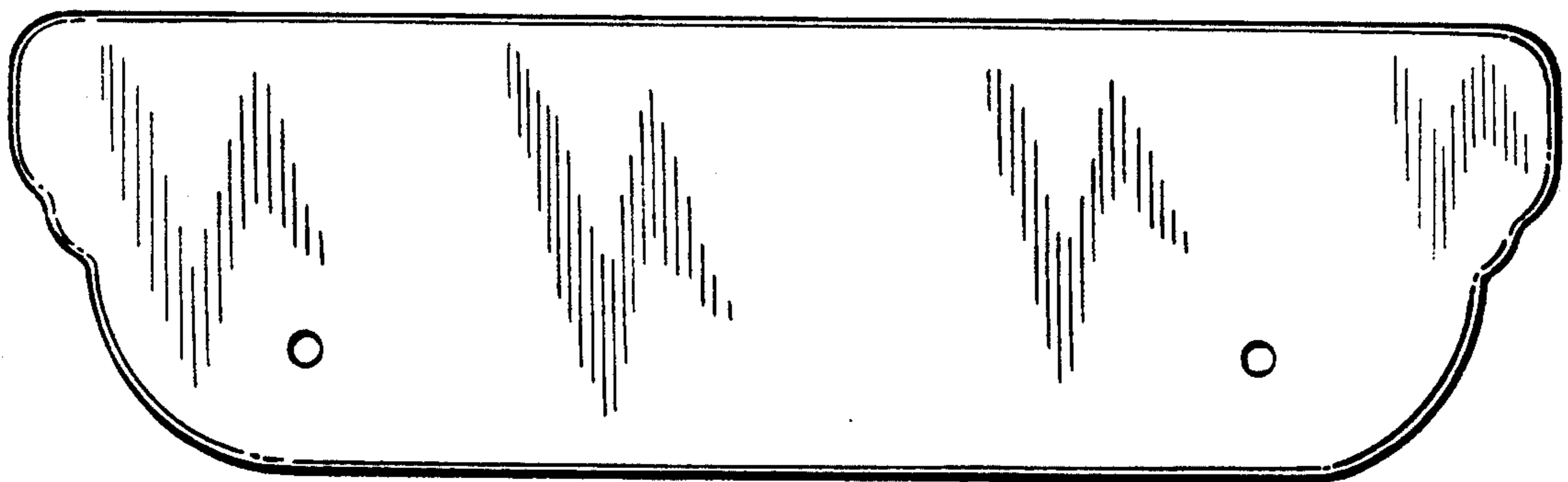

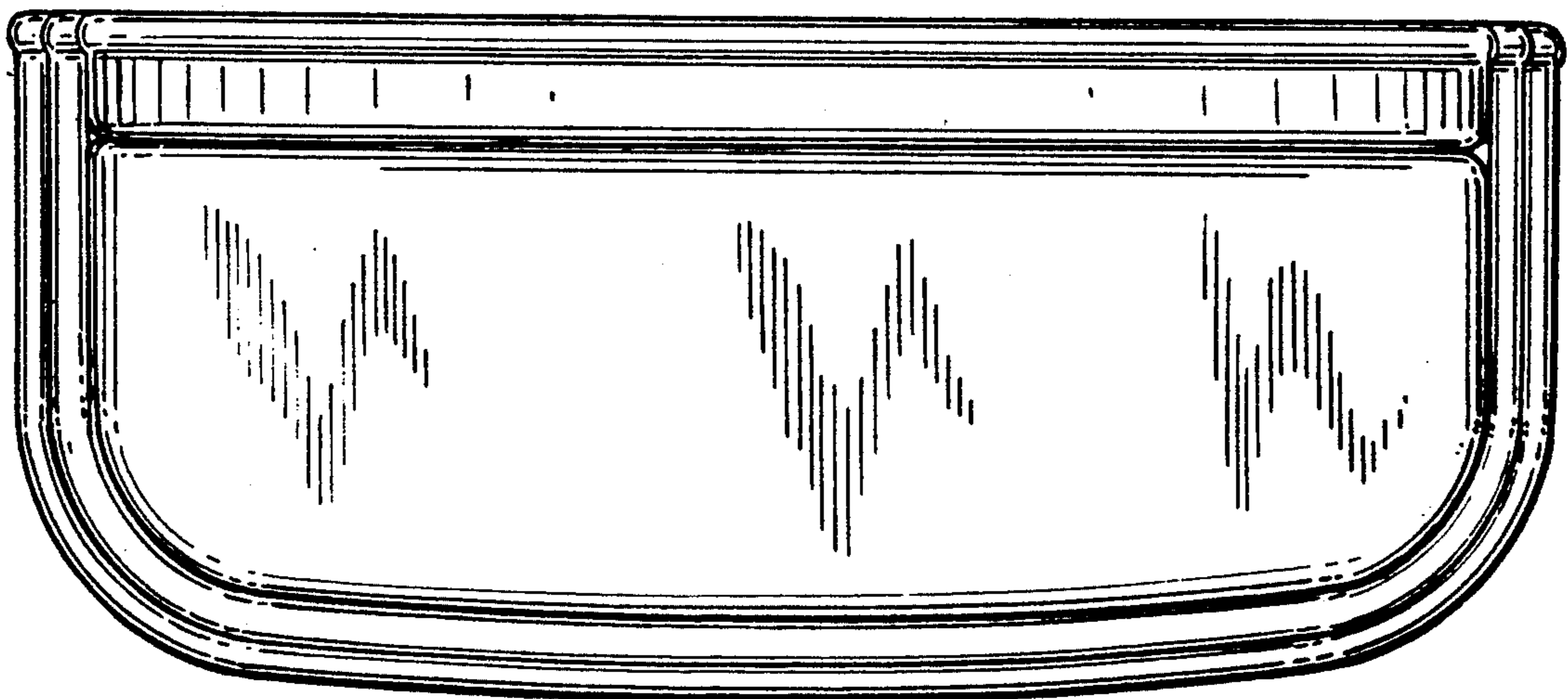

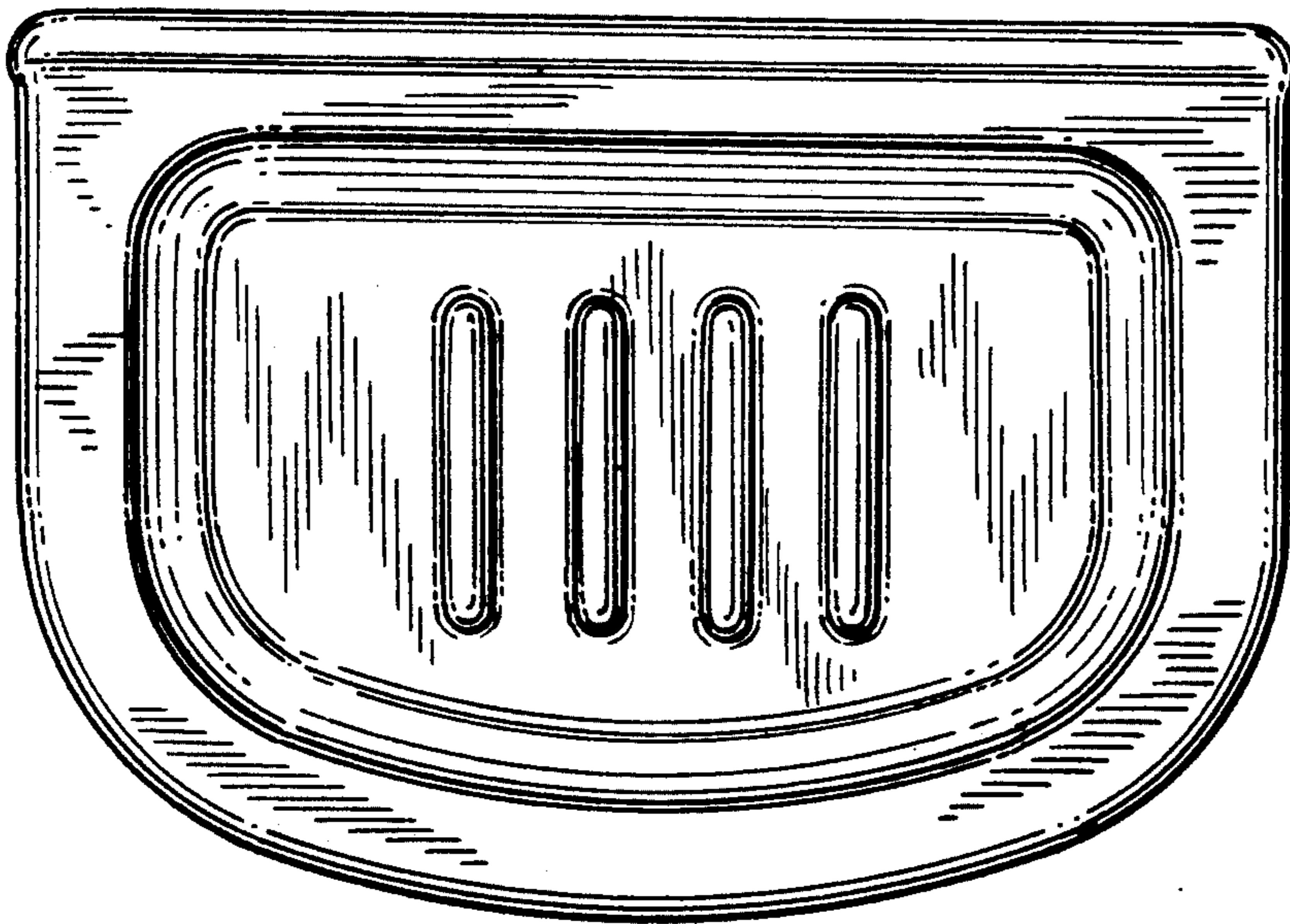
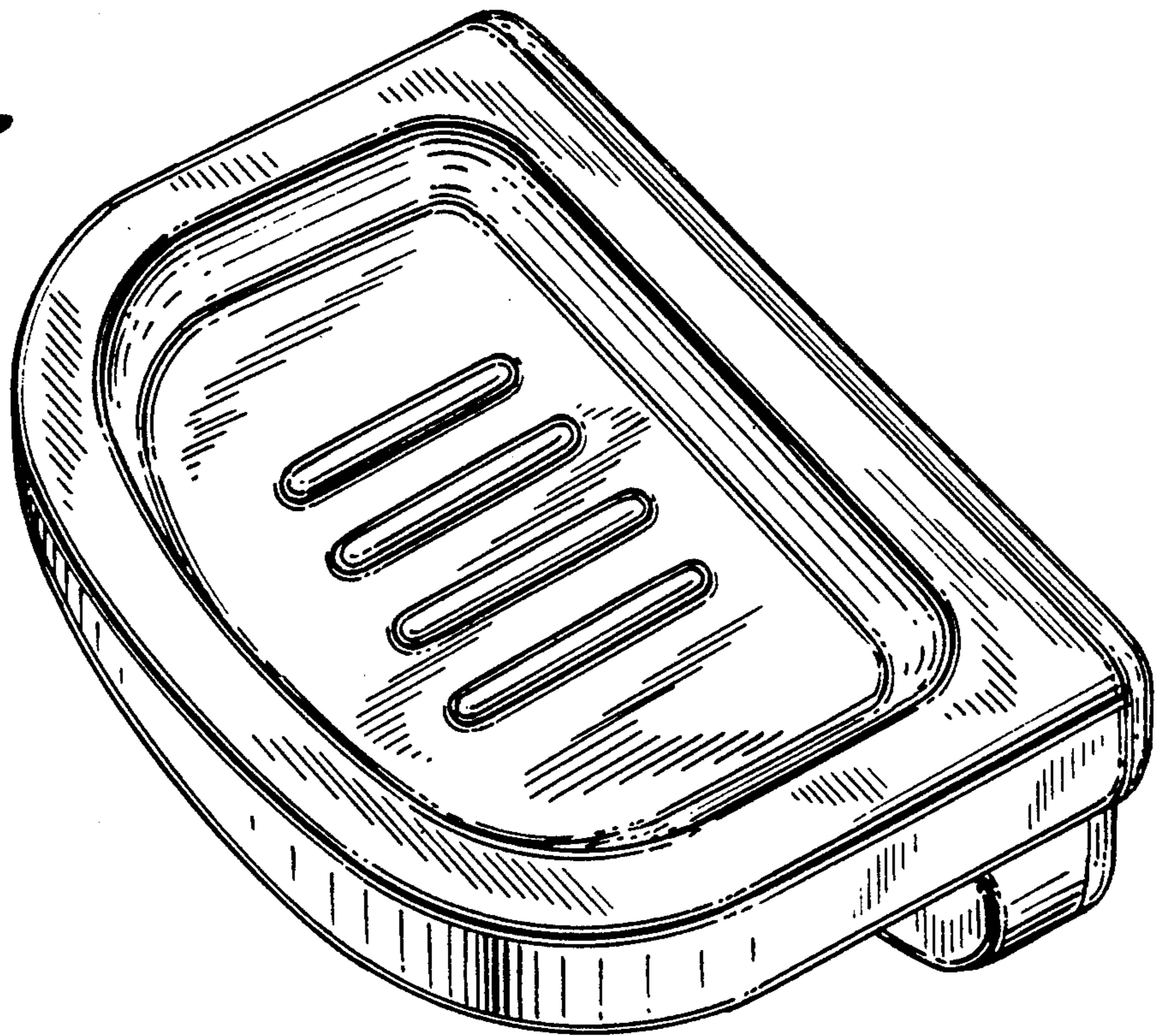

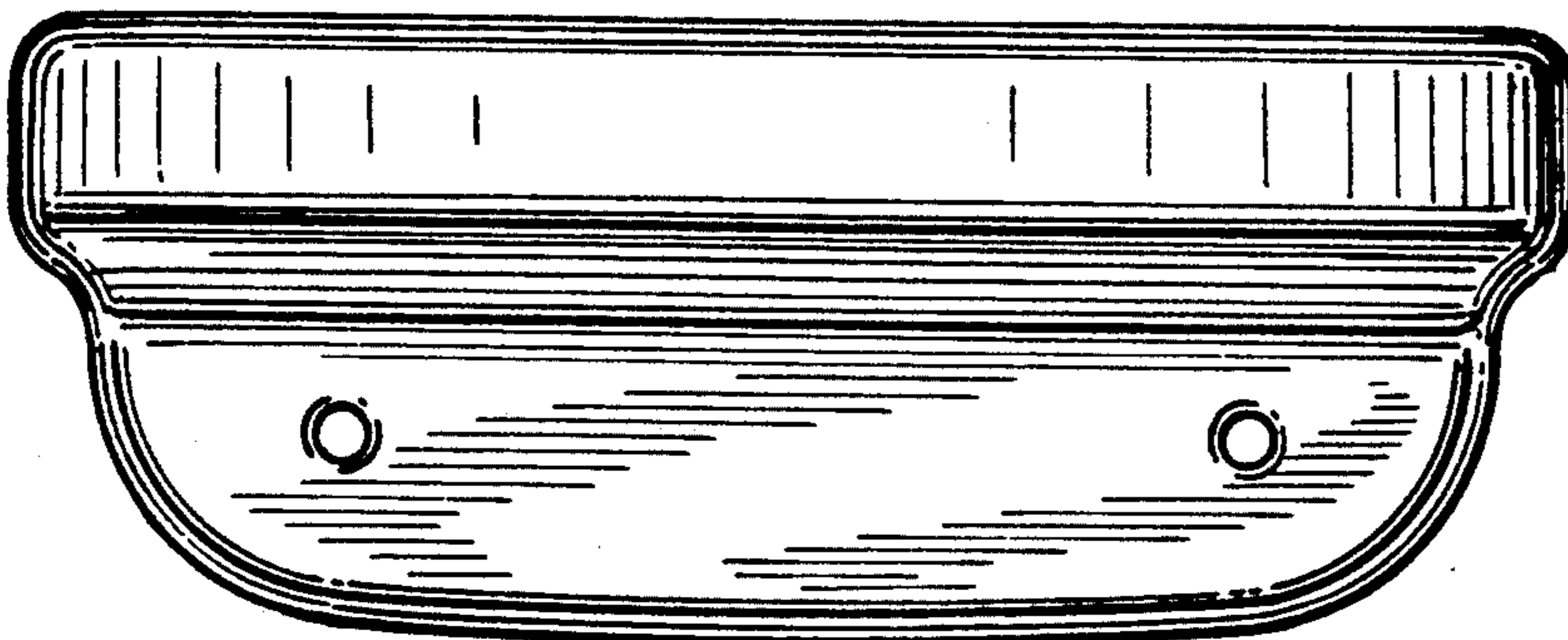

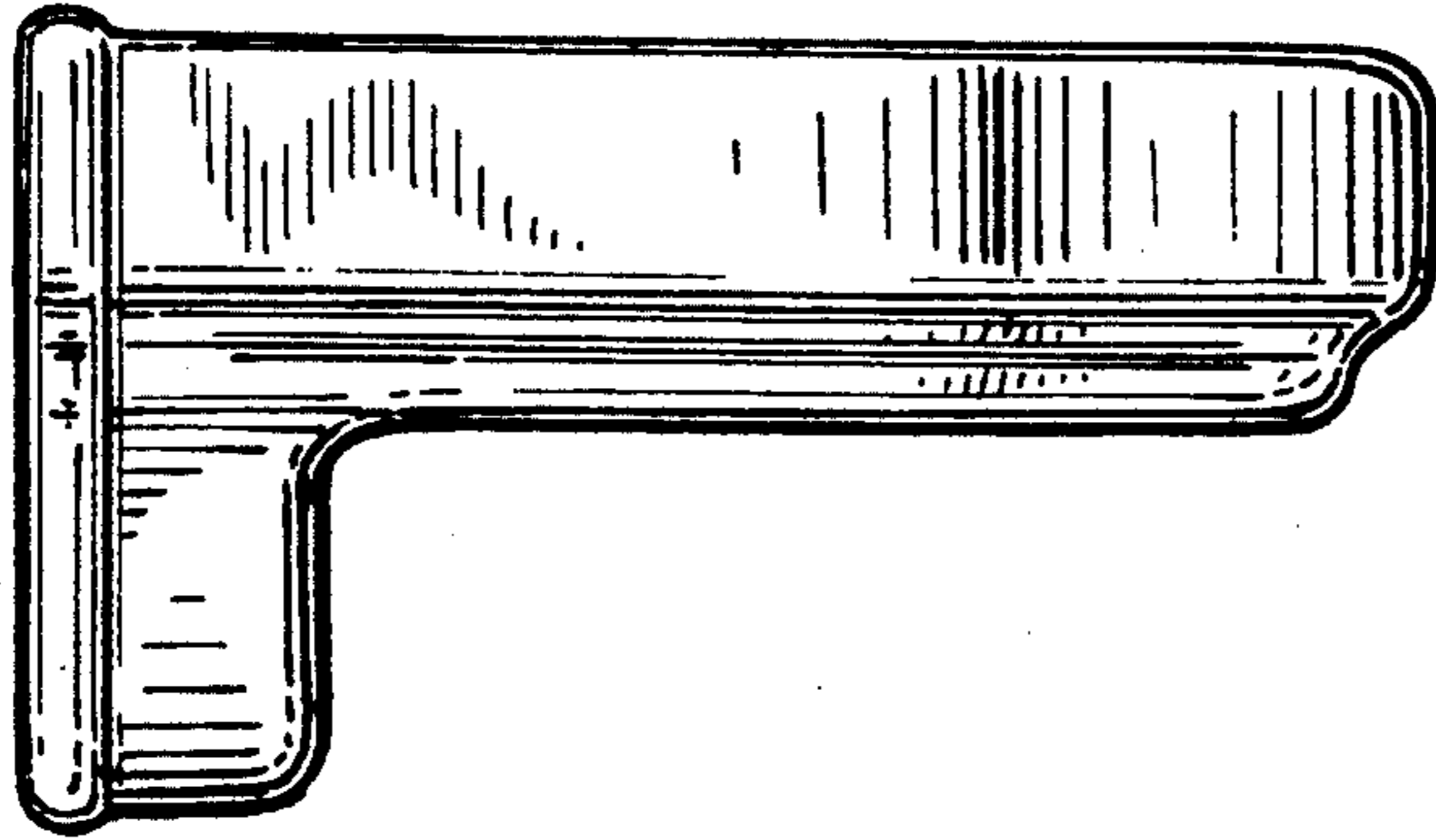

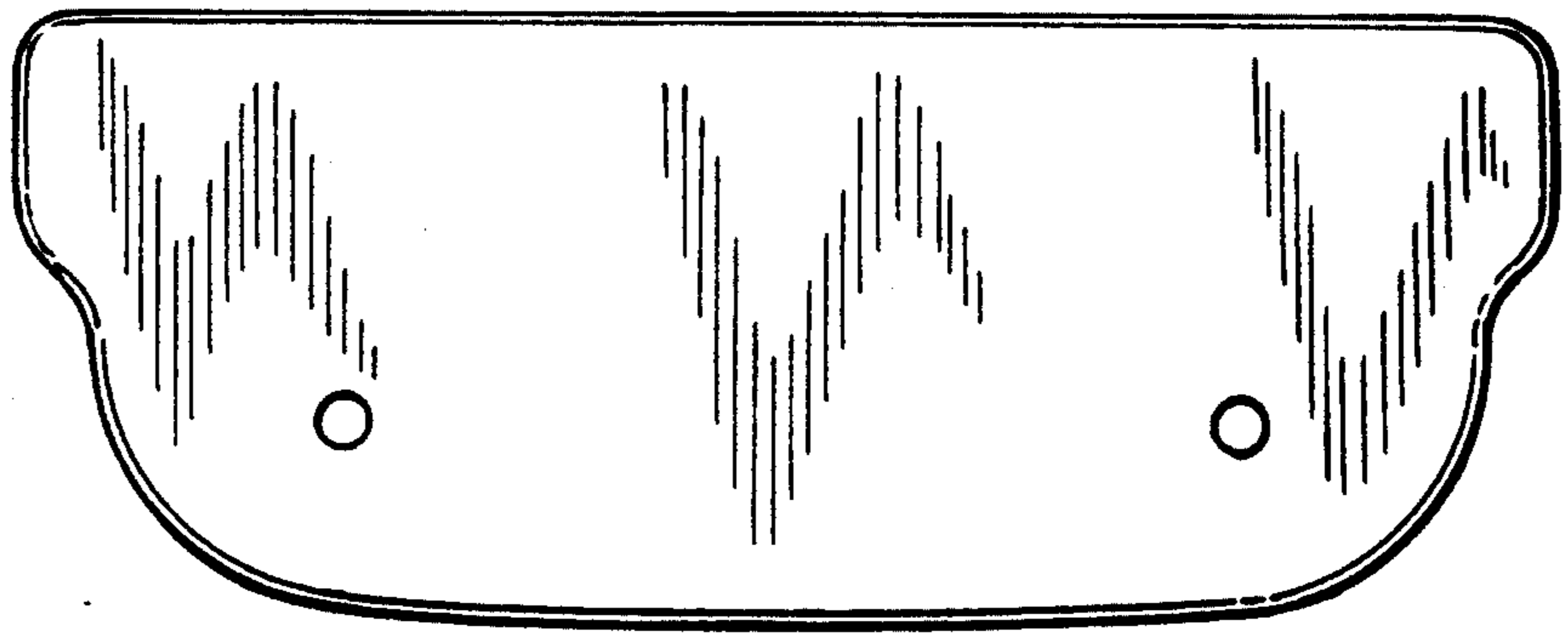
