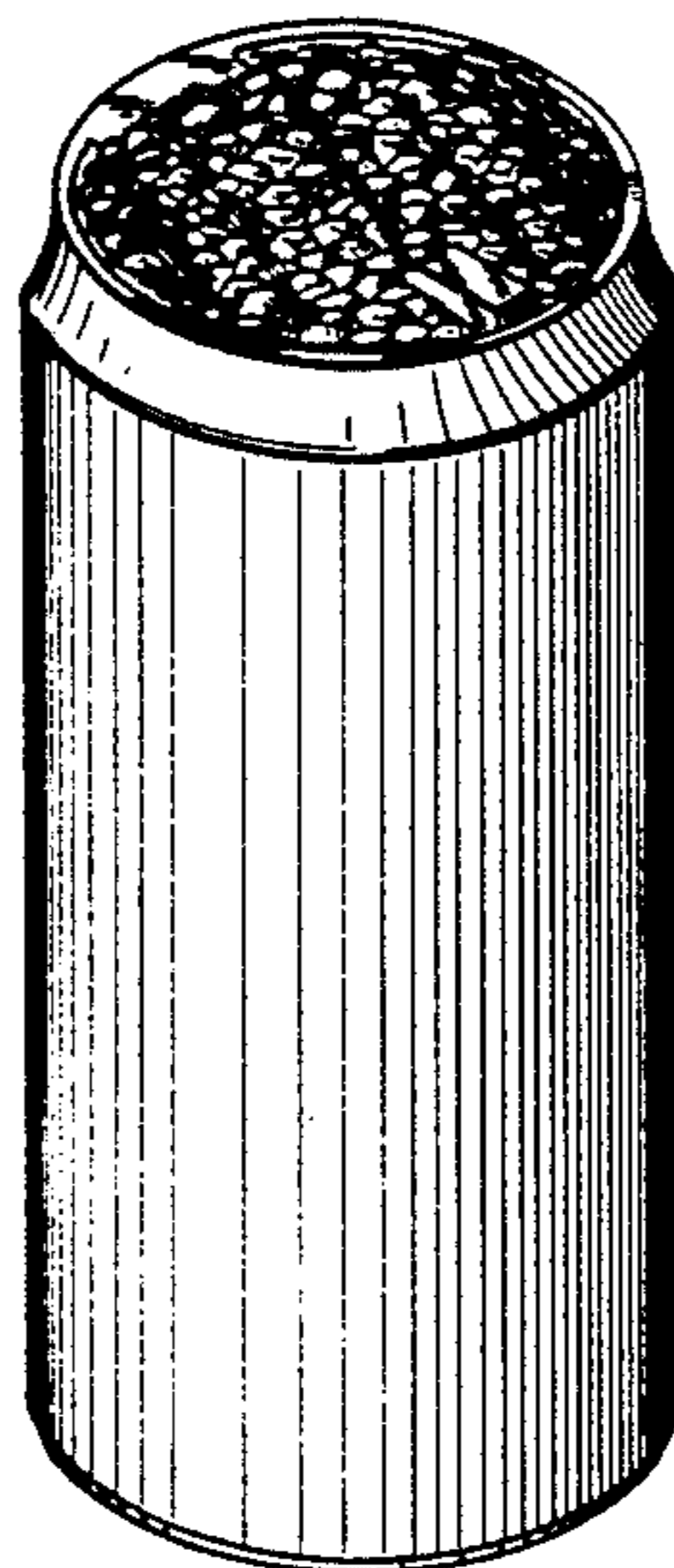

The ornamental design for a merchandizing display bin for beverage cans, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a merchandizing display bin for beverage cans showing my new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a side elevational view thereof, the opposite side being a mirror image thereof;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a top plan view thereof; and,
 FIG. 6 is a bottom plan view thereof.



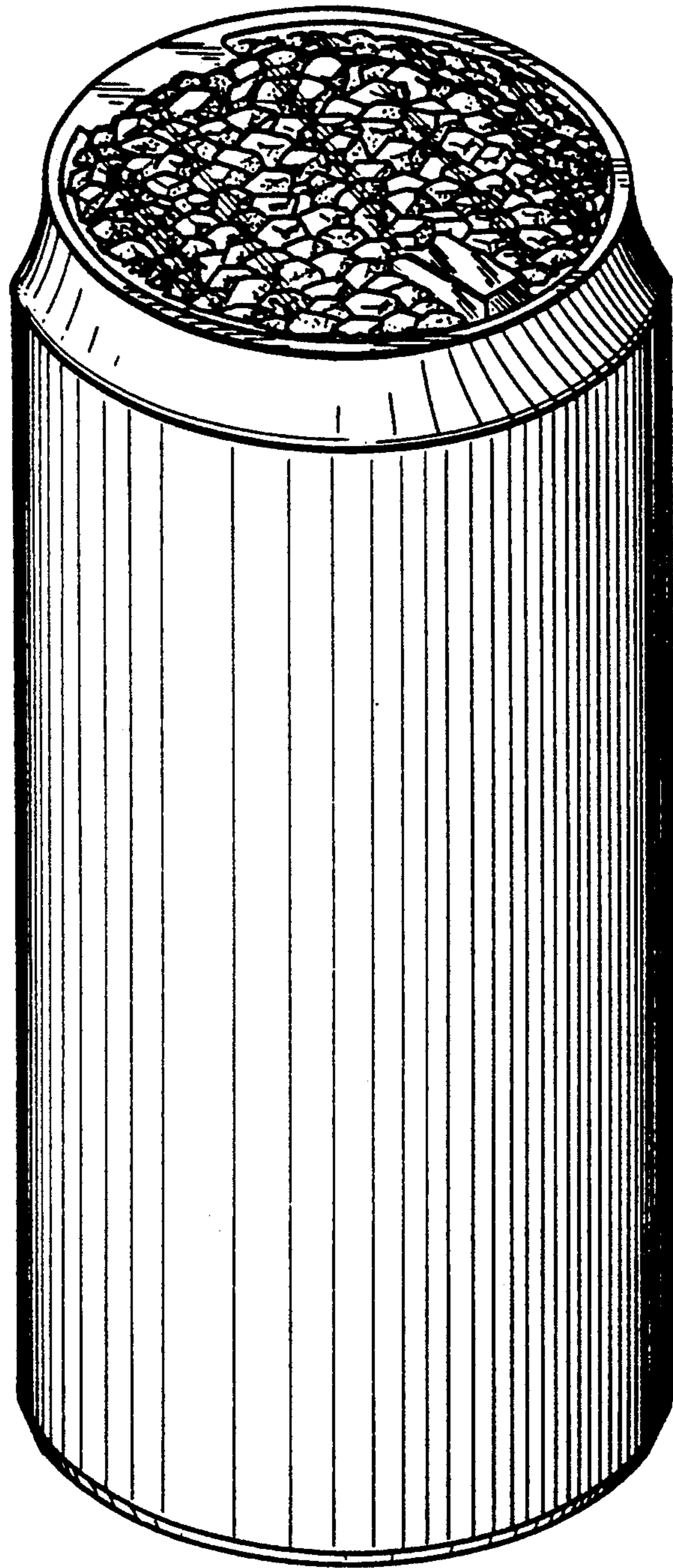

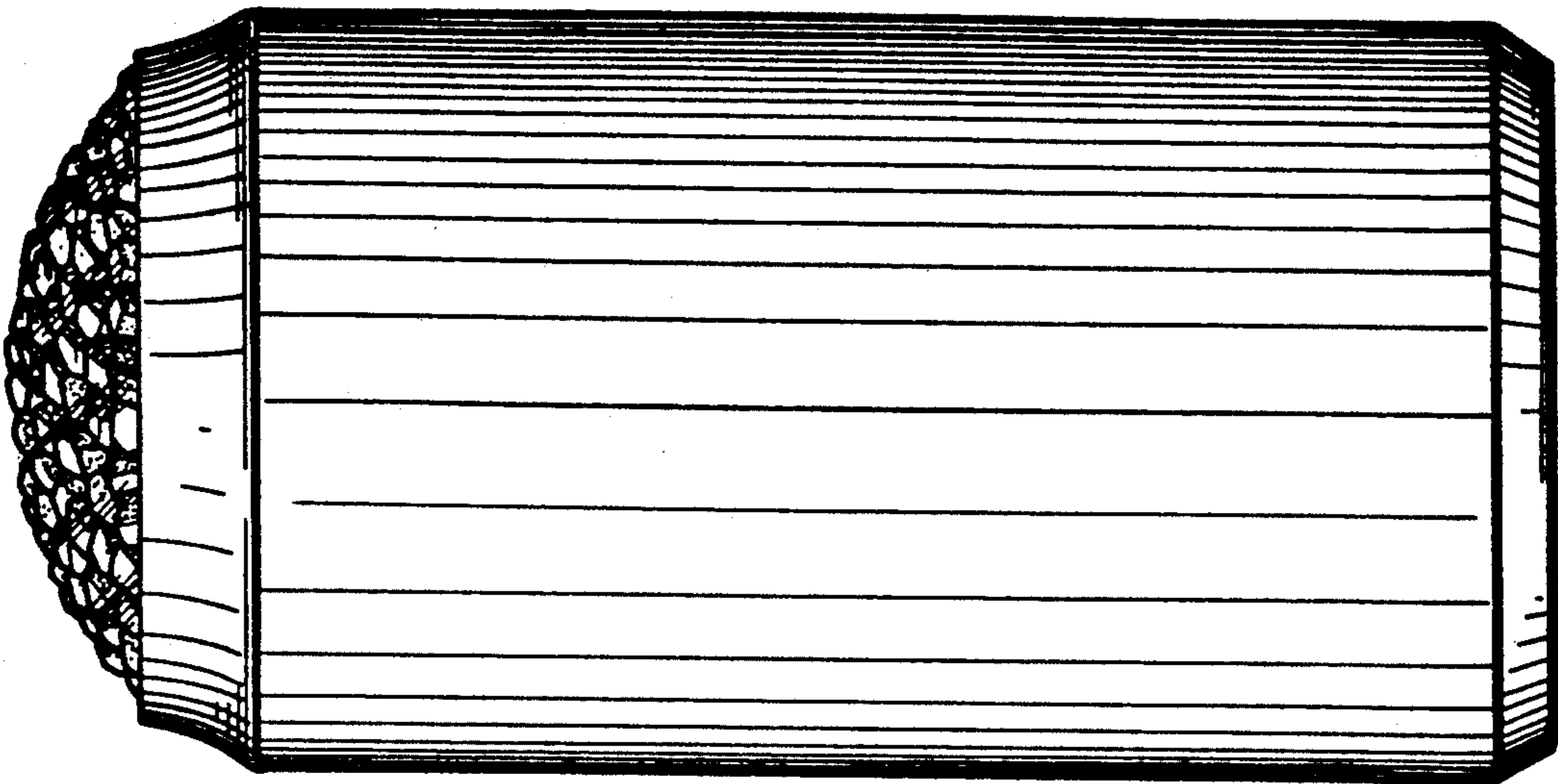

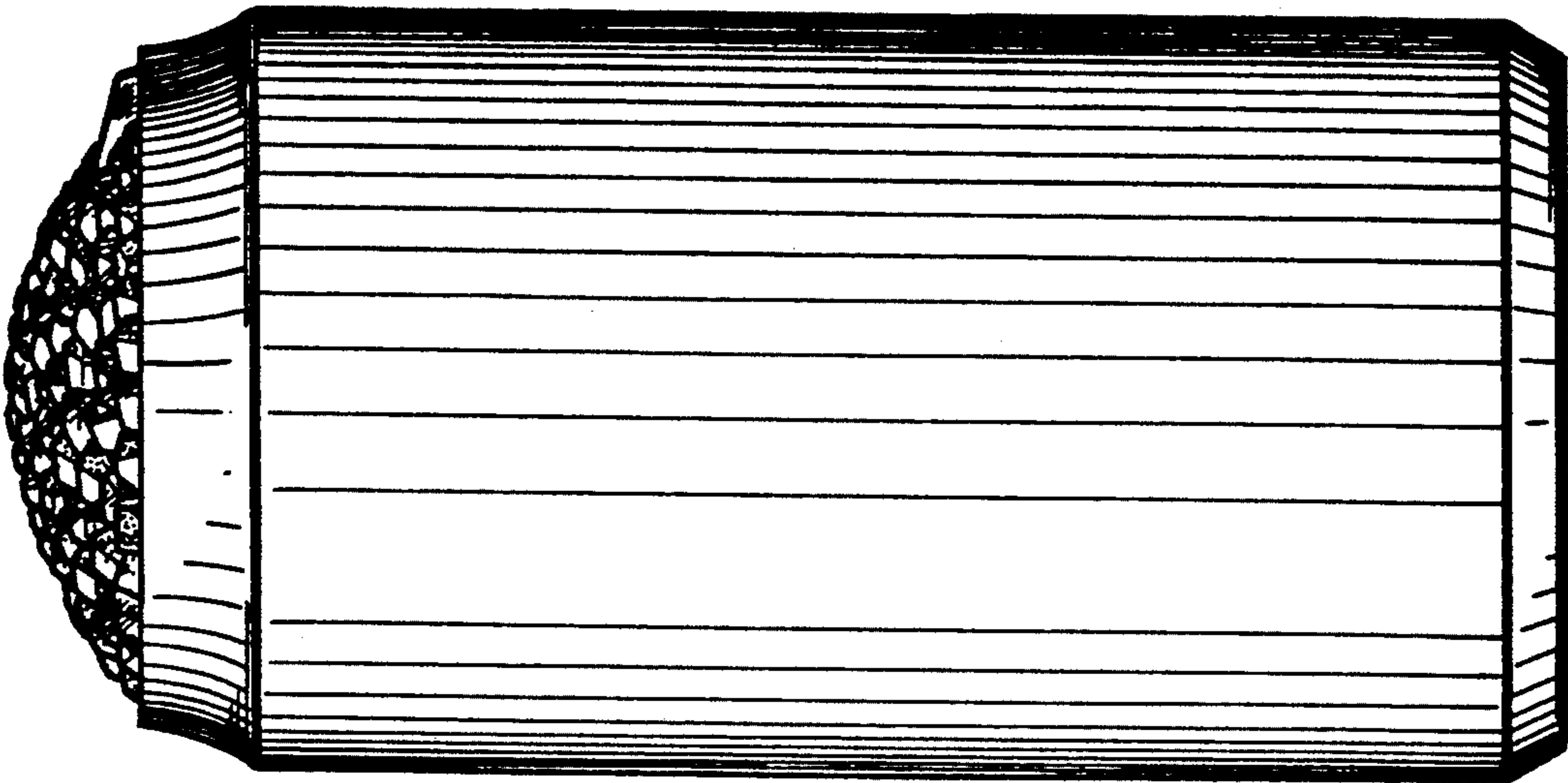

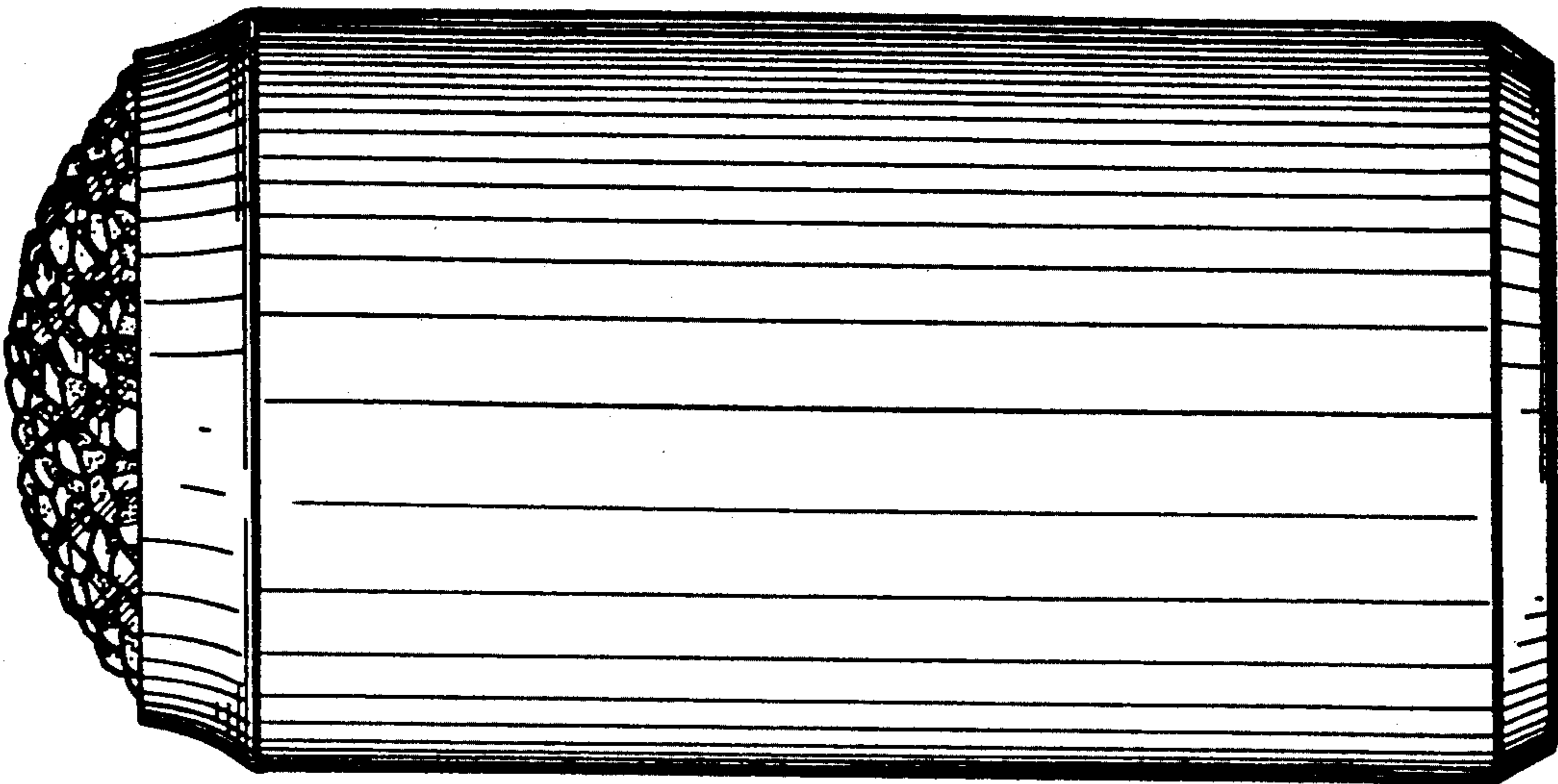

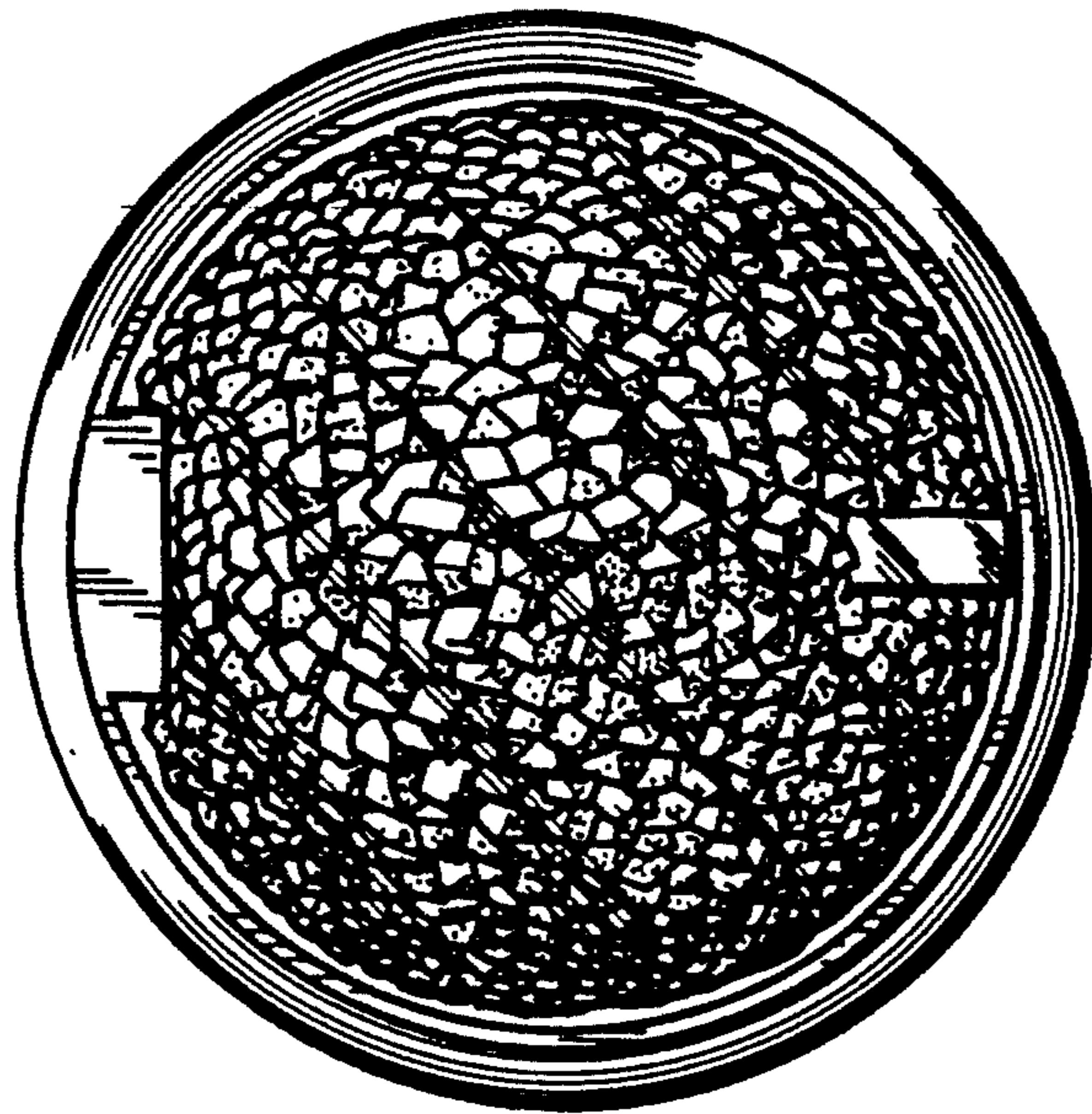

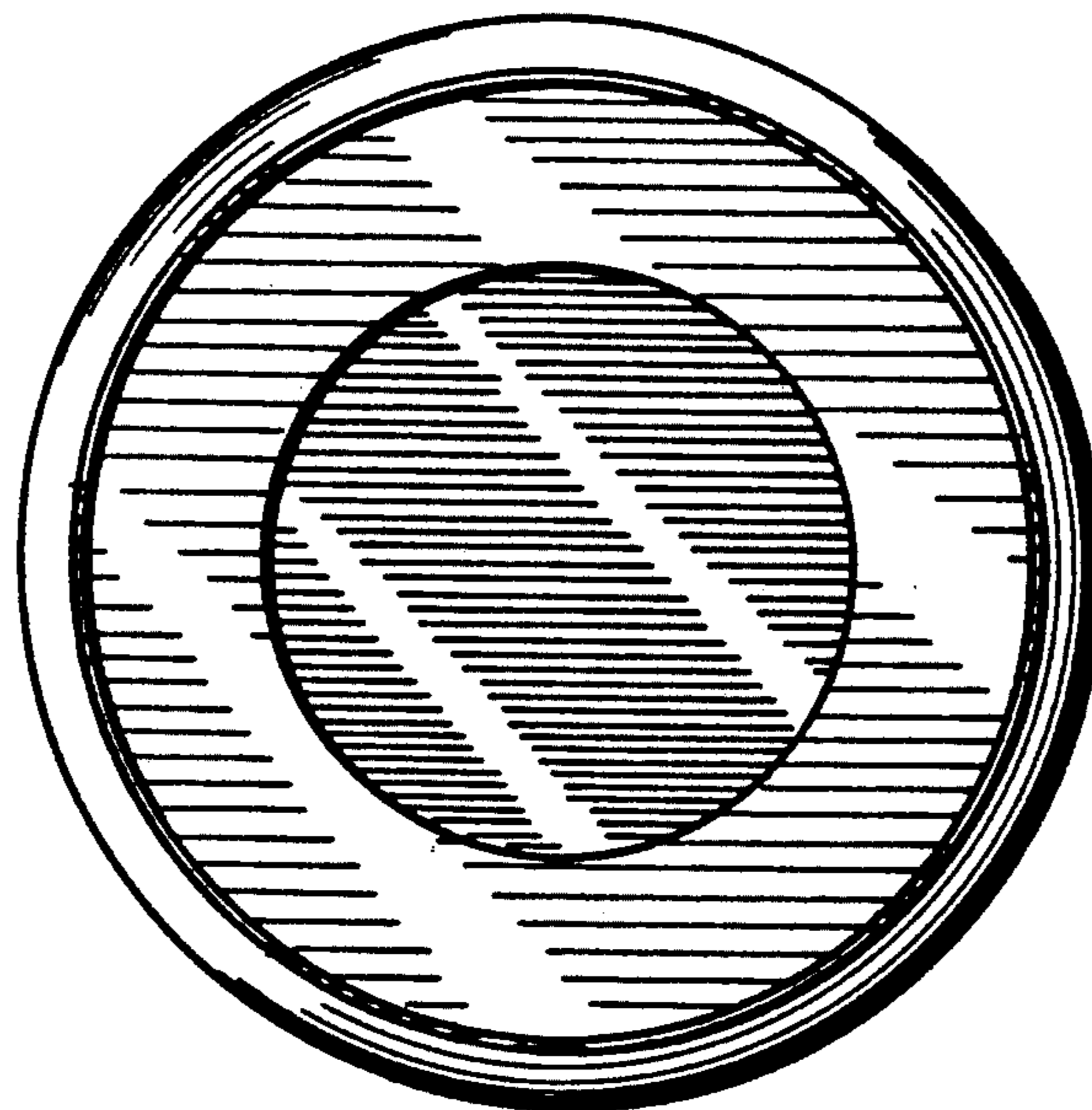
