DESCRIPTION

FIG. 1 is a front elevational view of a combined bottle and cap embodying my new design;
 FIG. 2 is a view from the left side thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a view from the right side thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom plan view thereof;

 FIG. 8 is an exploded perspective view thereof.

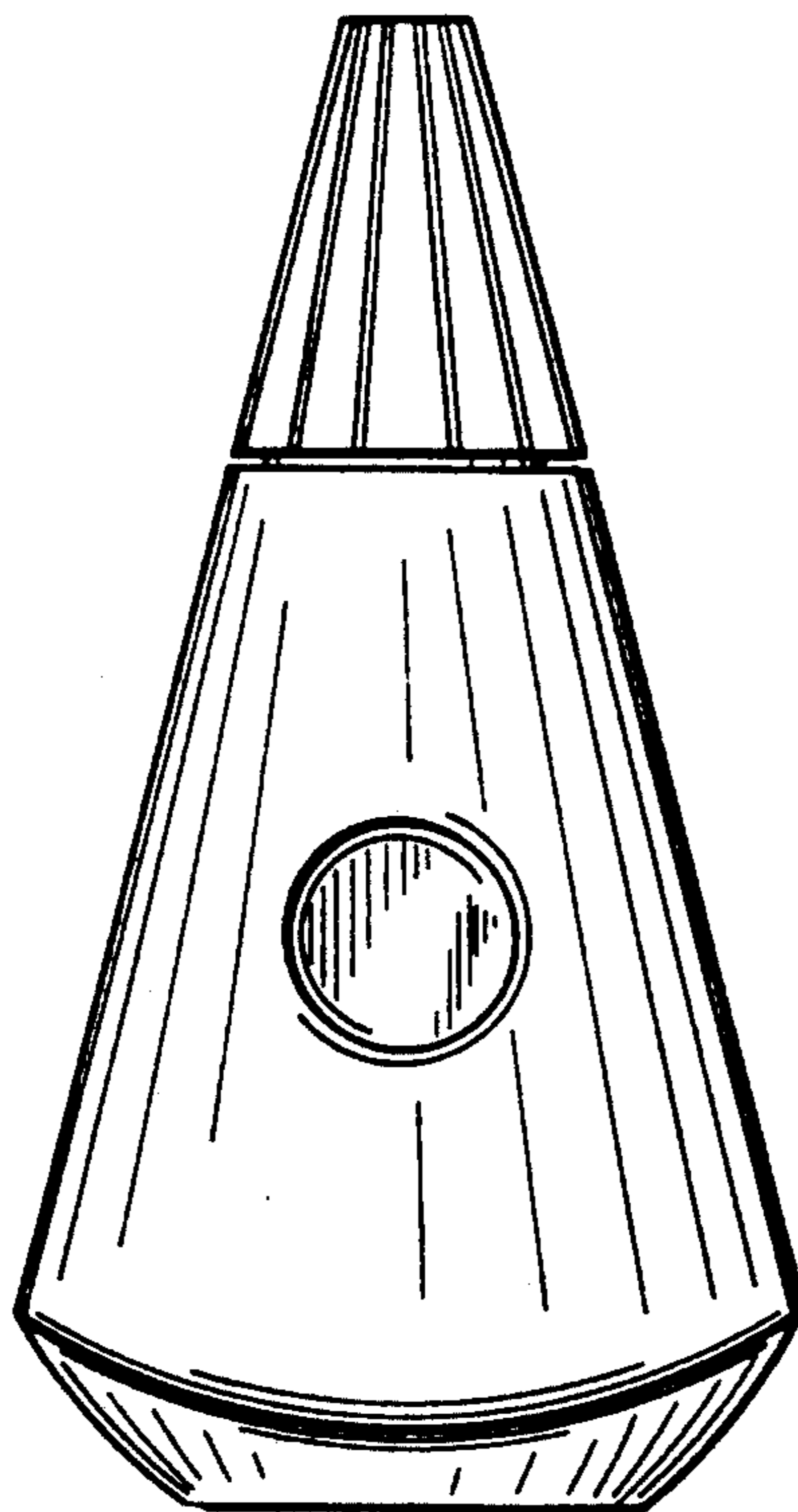

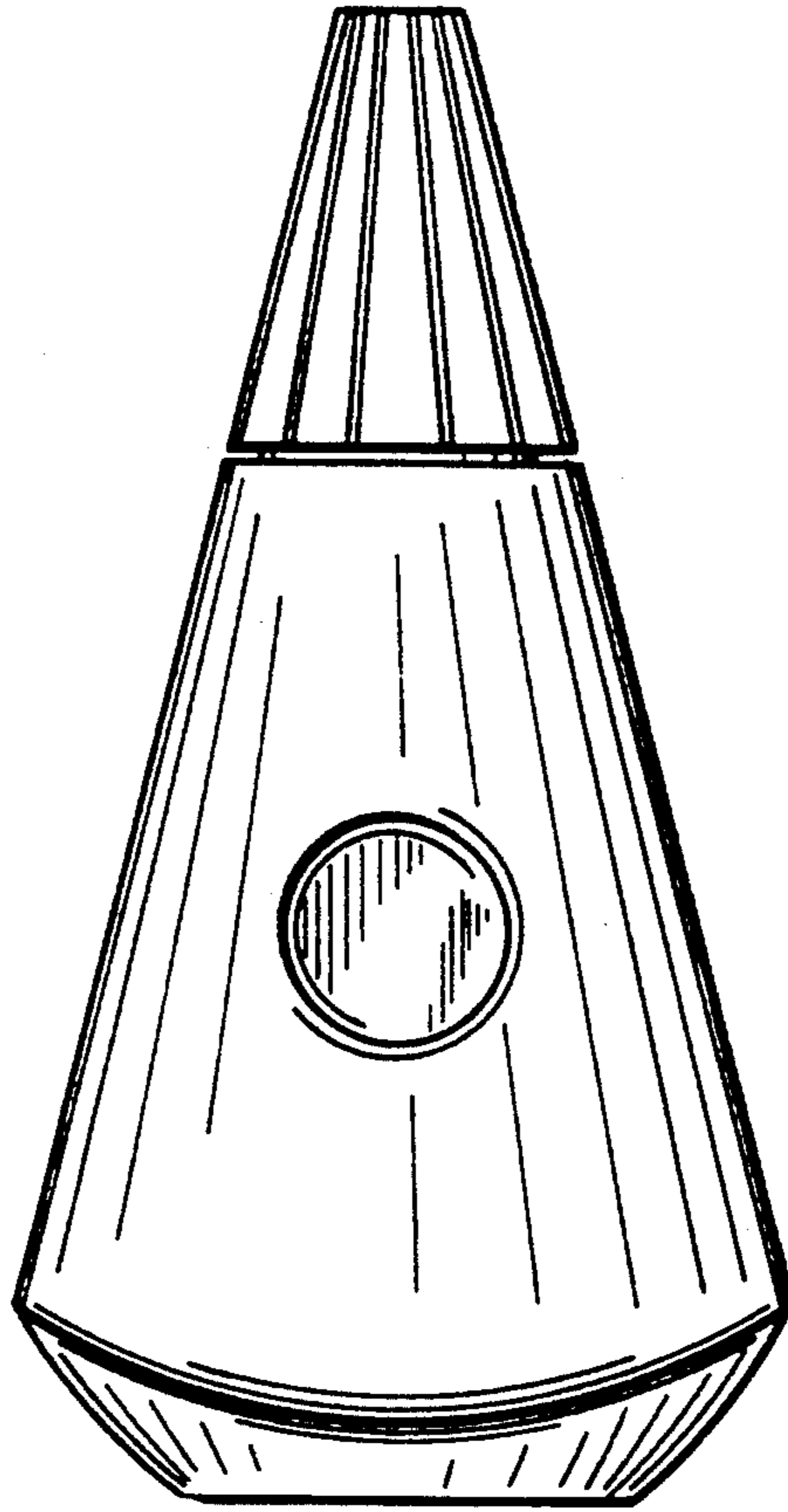

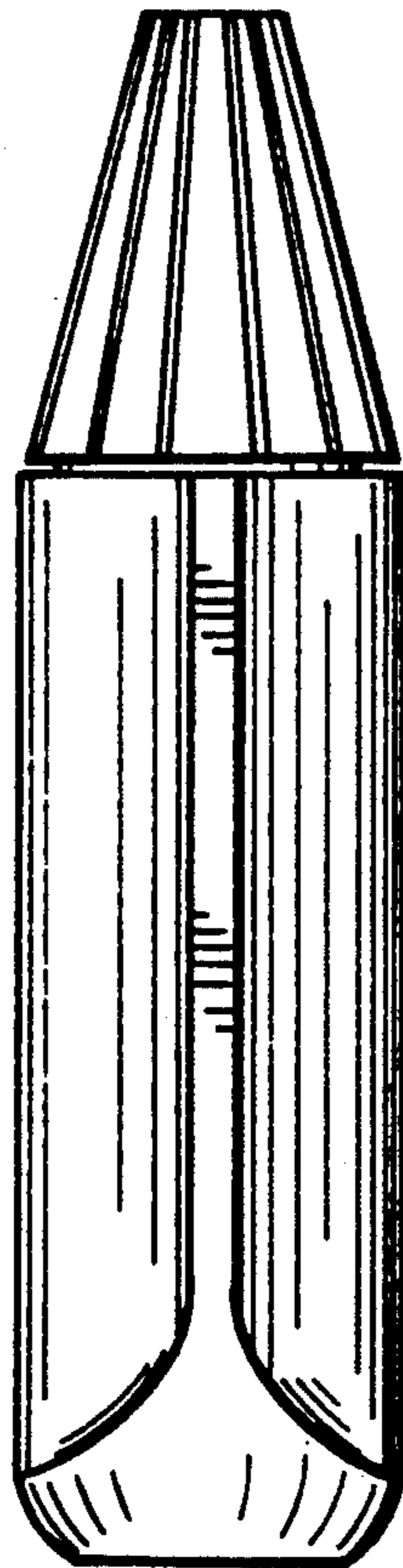

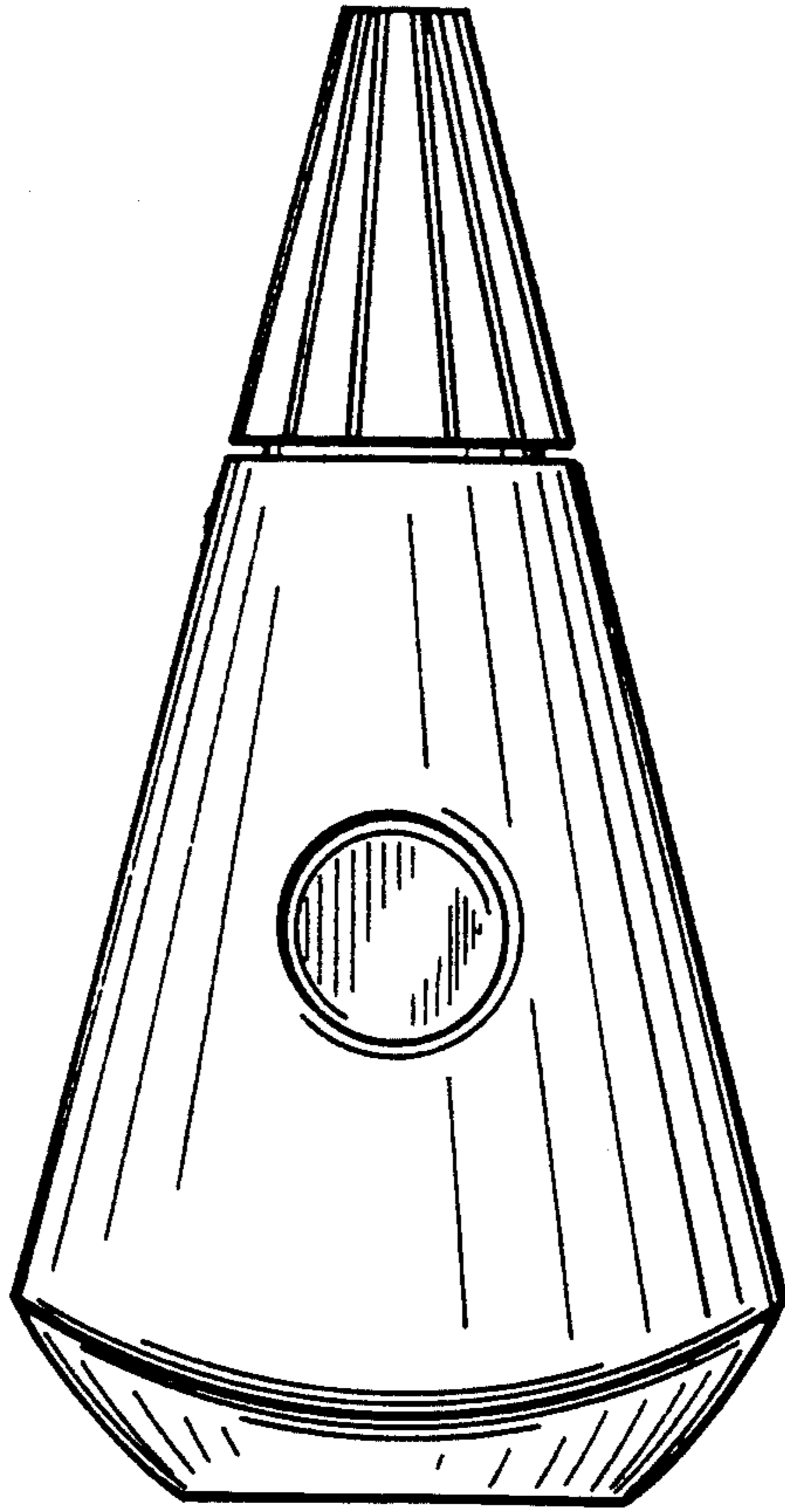

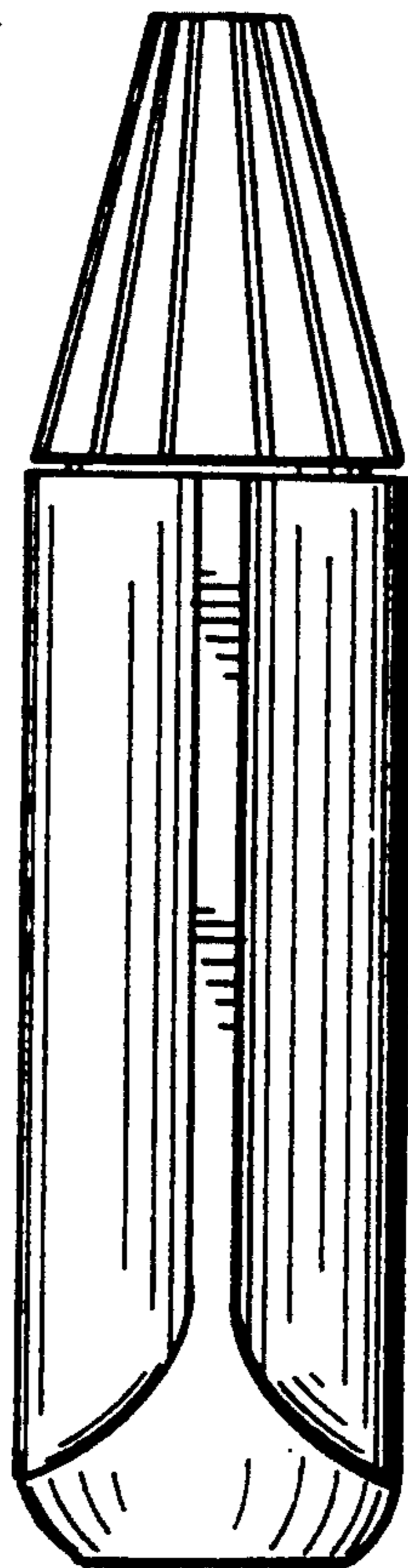

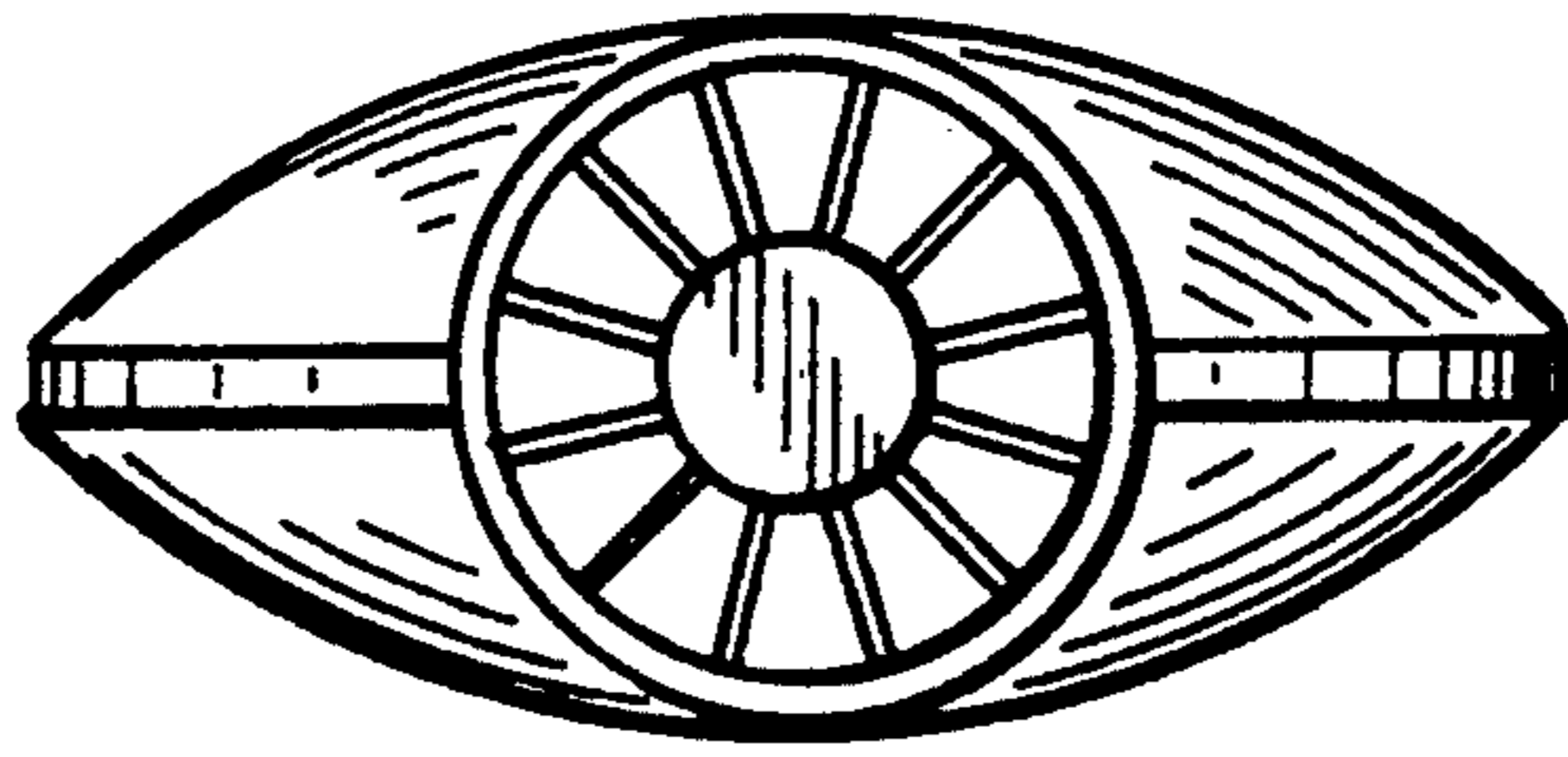

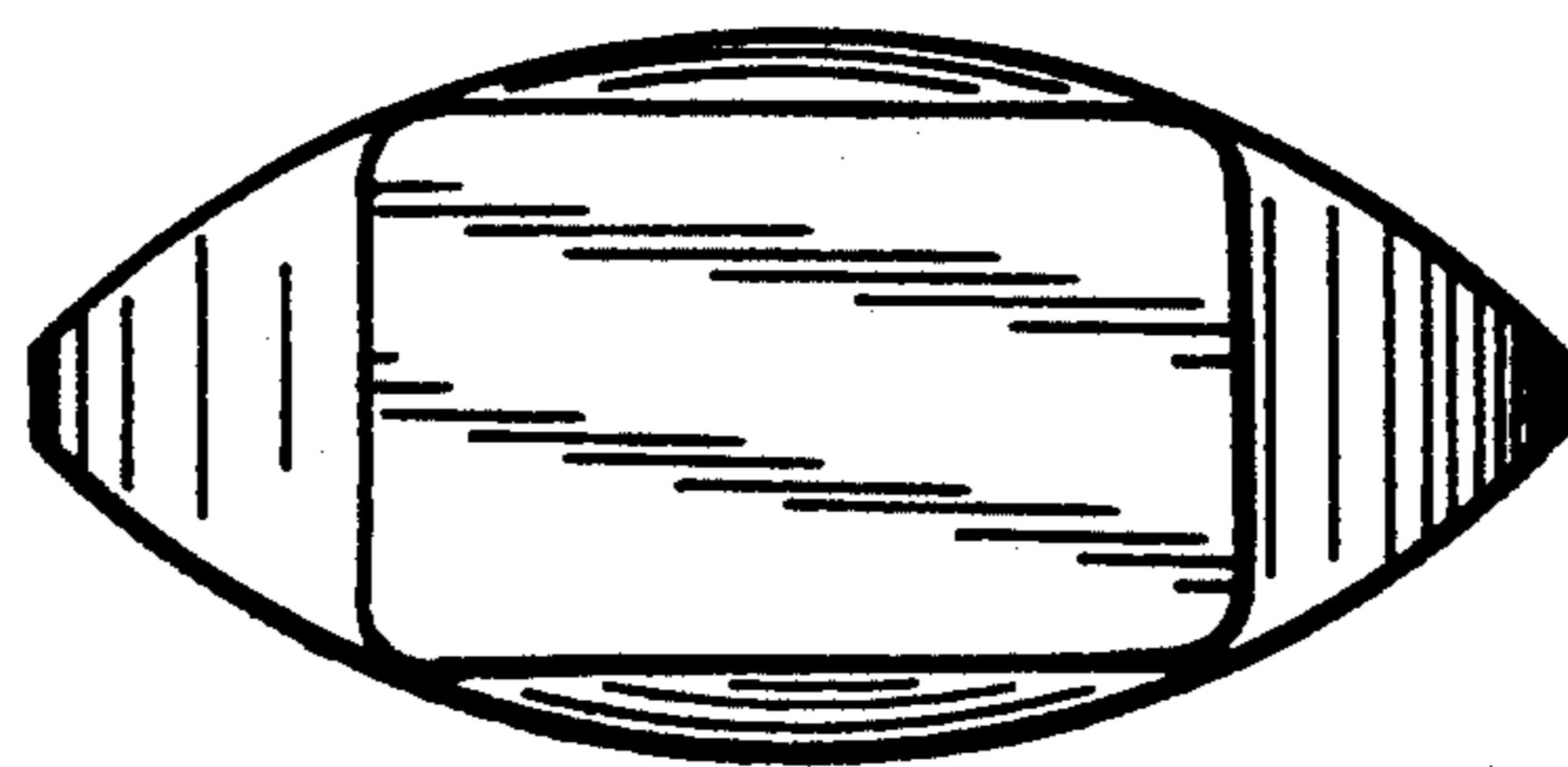

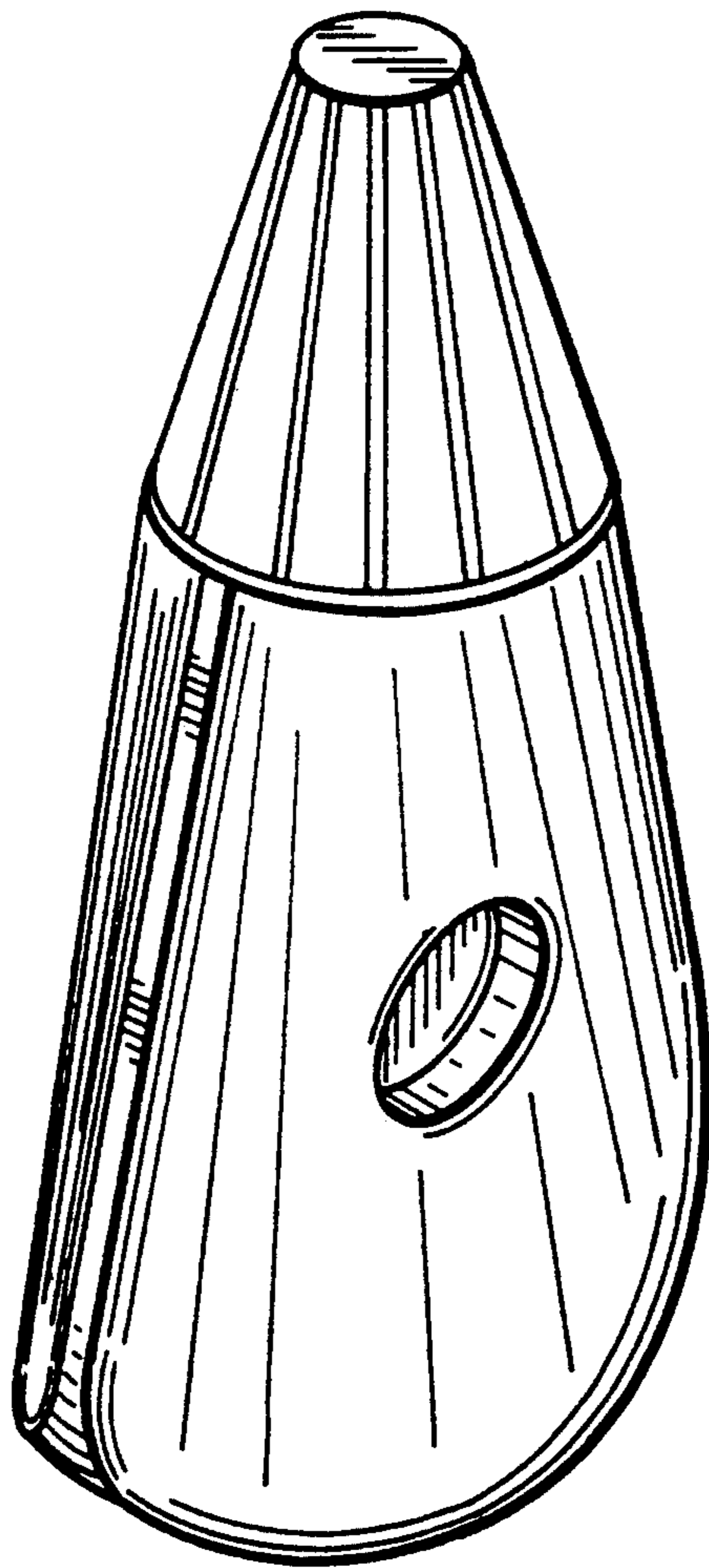
