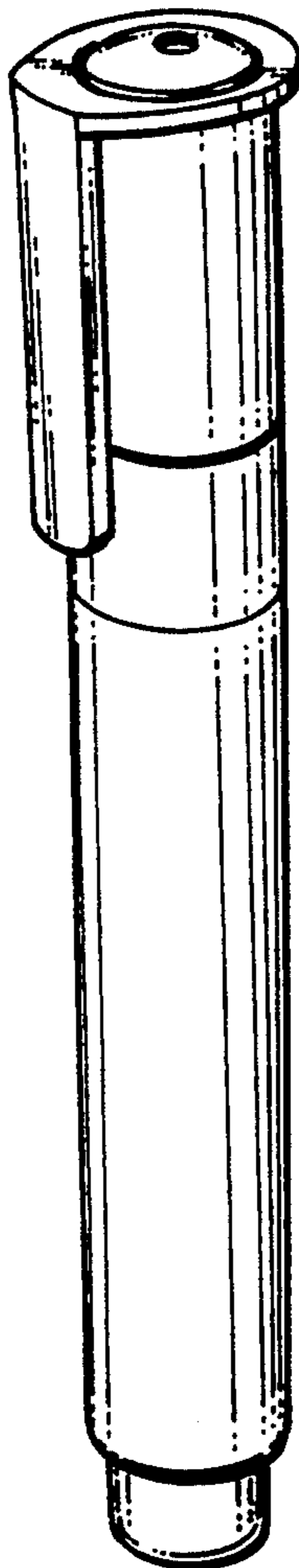

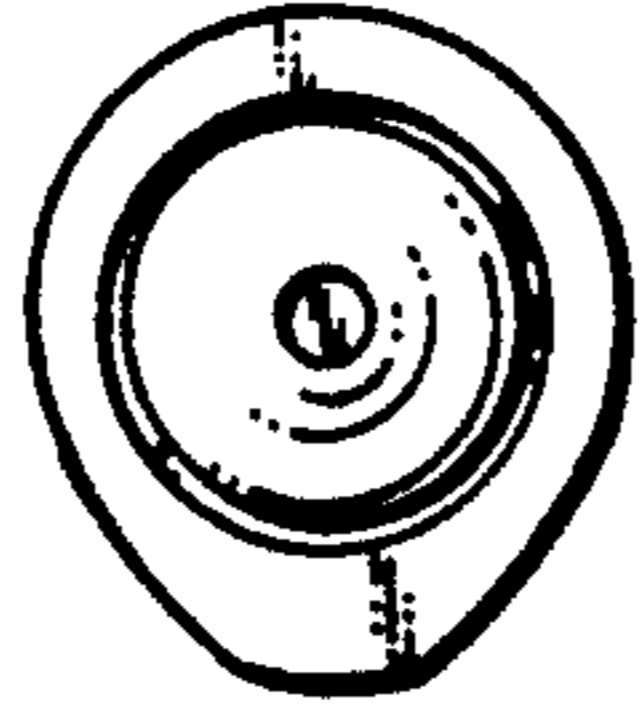
[57] **CLAIM**

The ornamental design for a correction fluid dispenser, as shown and described.

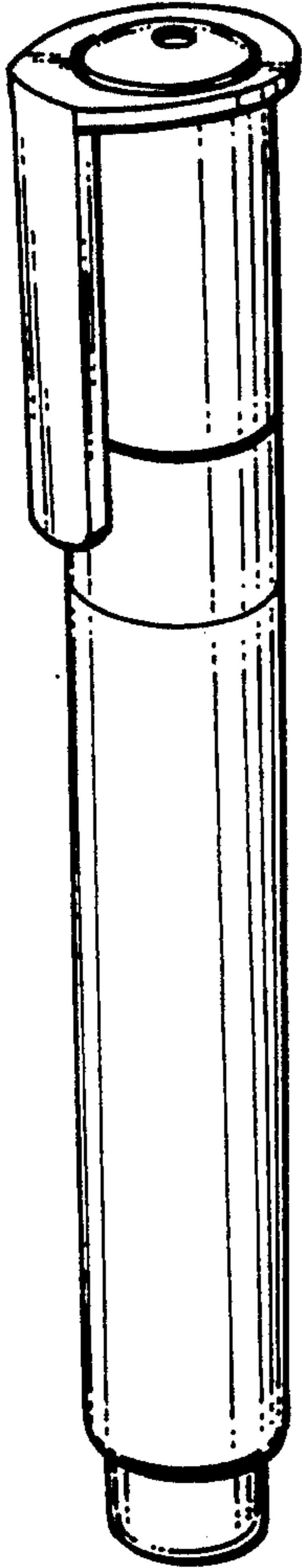
**DESCRIPTION**

FIG. 1 is a top, right front perspective view of a correction fluid dispenser showing my new design;

 FIG. 10 is a rear elevational view of FIG. 7.

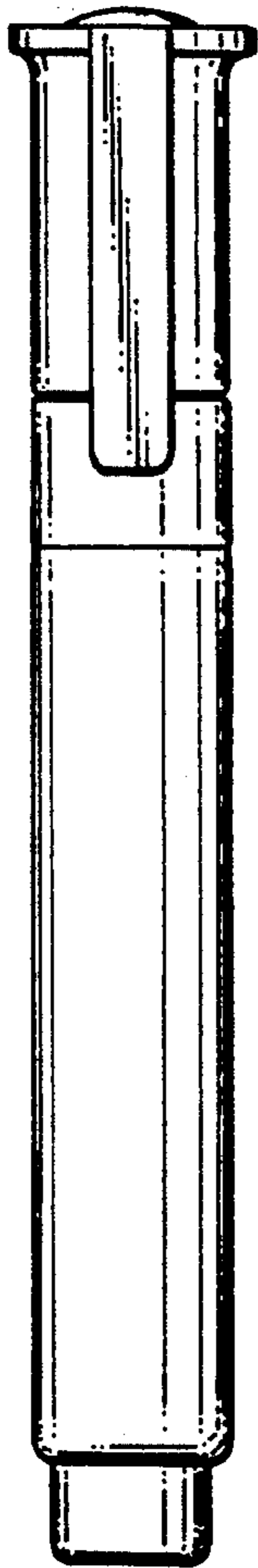




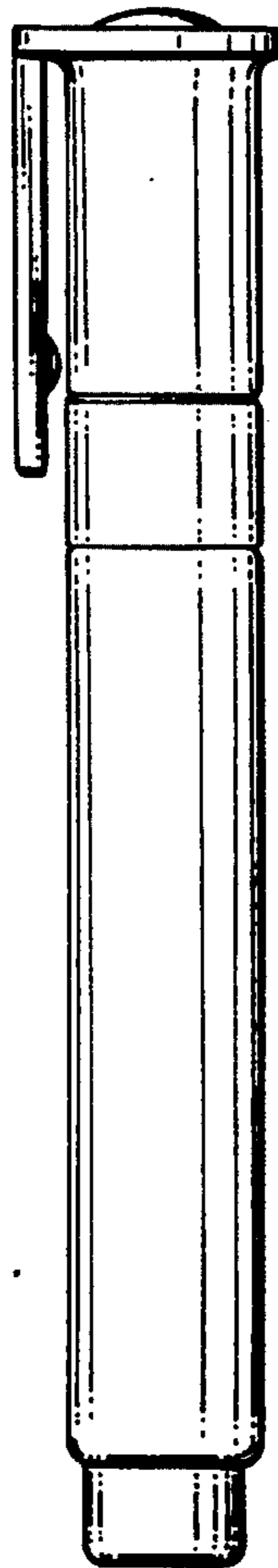

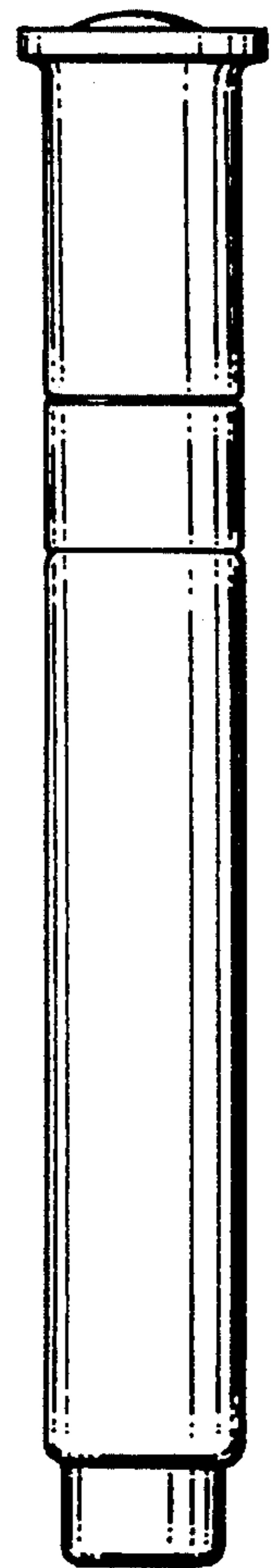

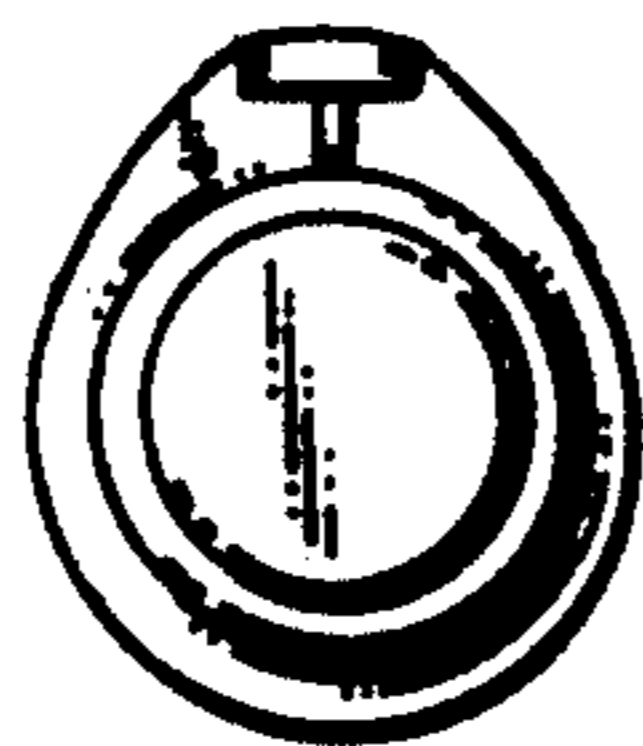

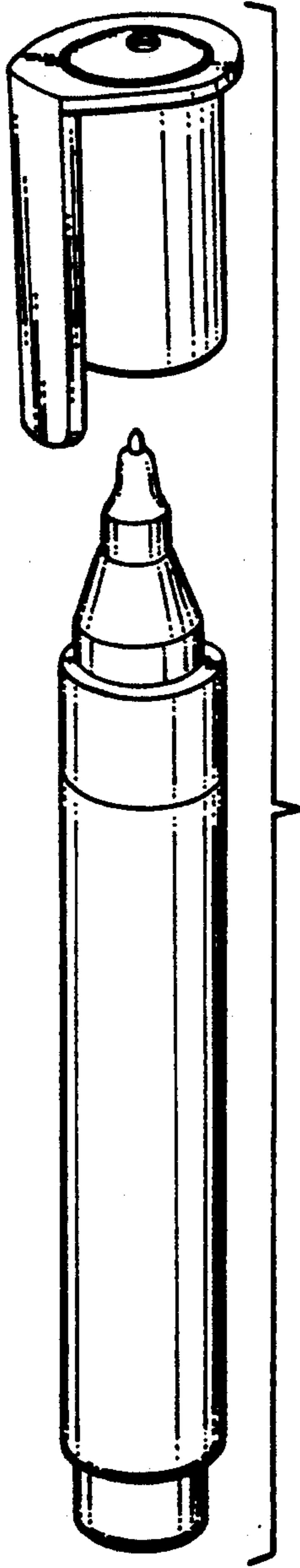

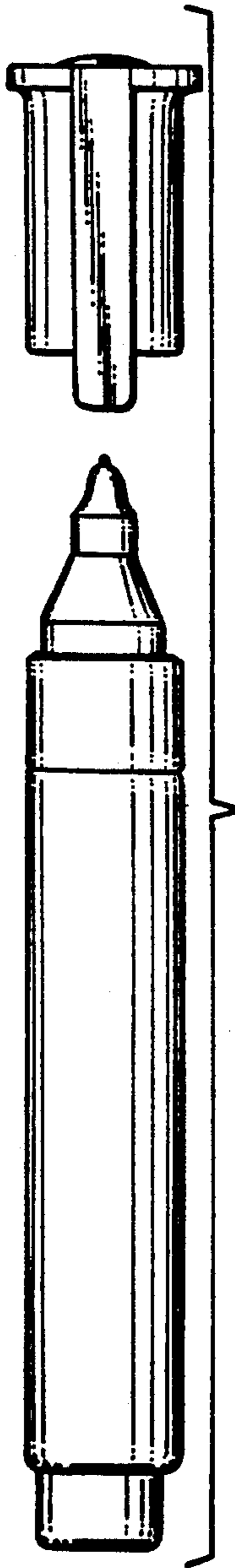

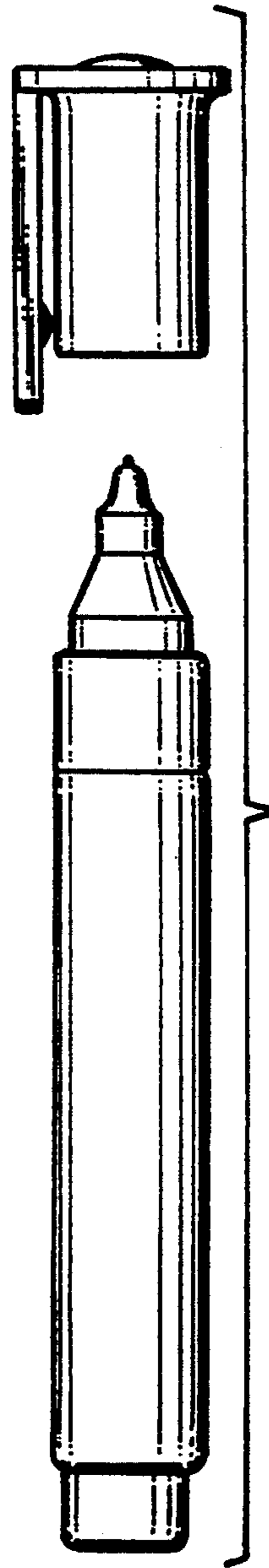

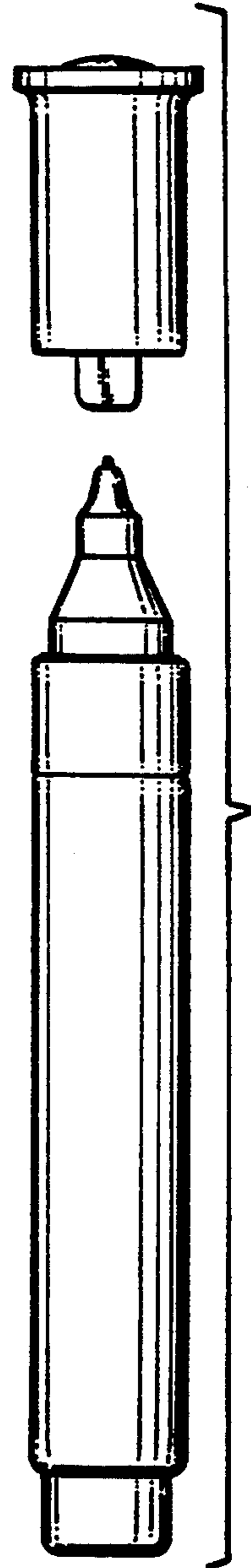
