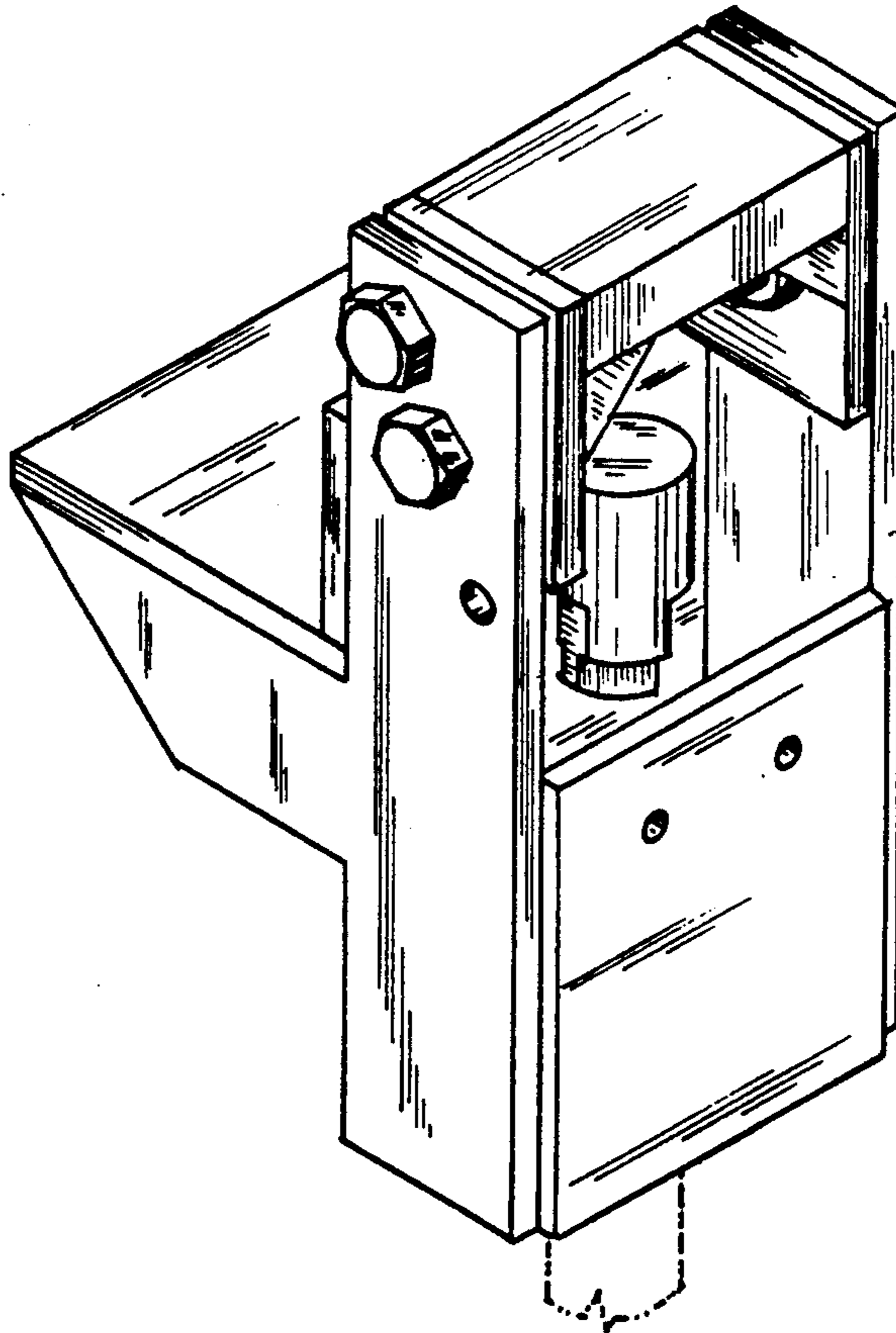

[57] **CLAIM**

The ornamental design for the a pier lifter for elevating building footings, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a pier lifter for elevating building footings showing my new design; FIG. 2 is a top plan view thereof; FIG. 3 is a left side elevational view thereof with the right side being a mirror image; FIG. 4 is a bottom plan view thereof; FIG. 5 is a front elevational view thereof; and, FIG. 6 is a rear elevational view thereof. The broken line showing of a pipe shaft is for illustrative purposes only and forms no part of the claimed design.



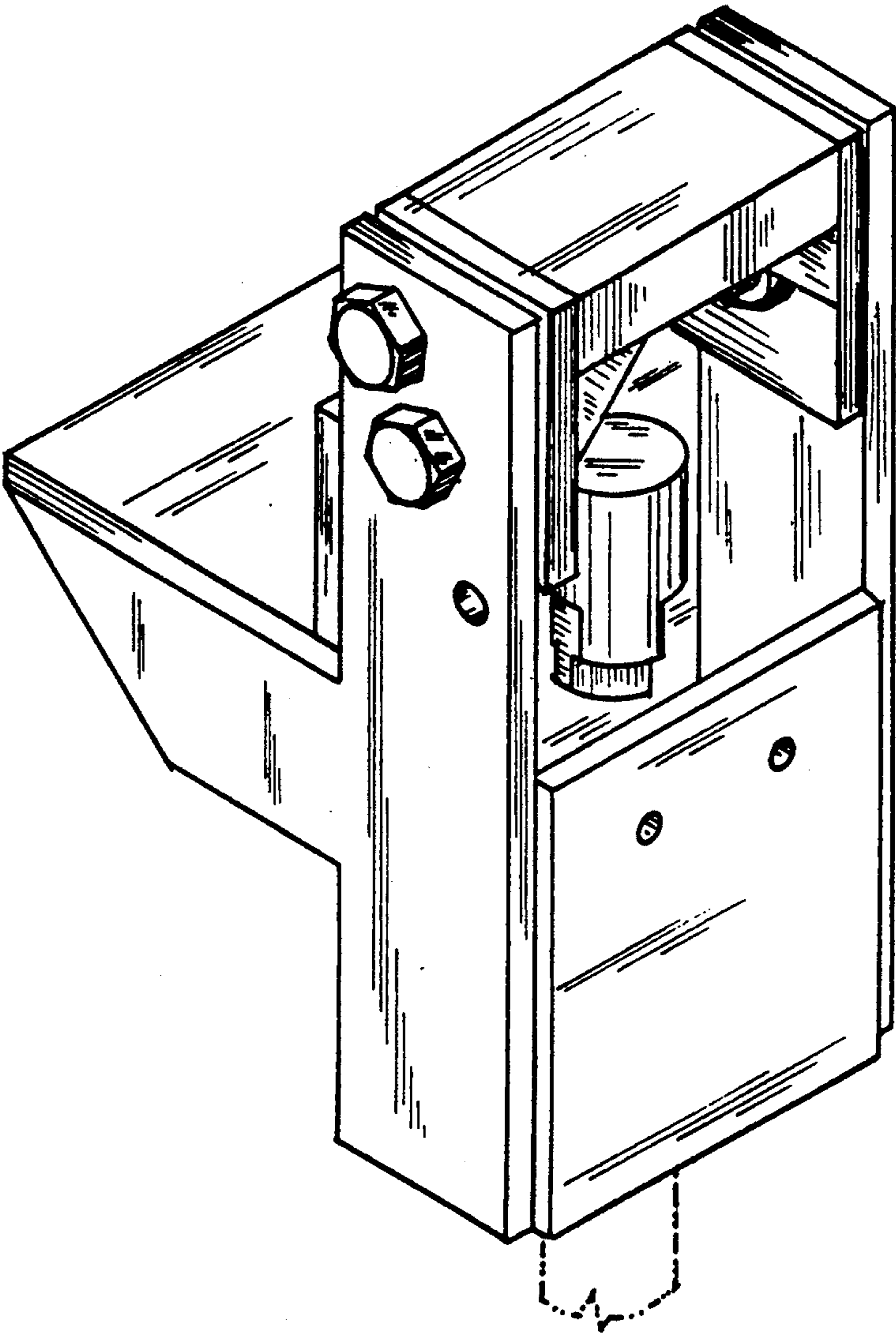

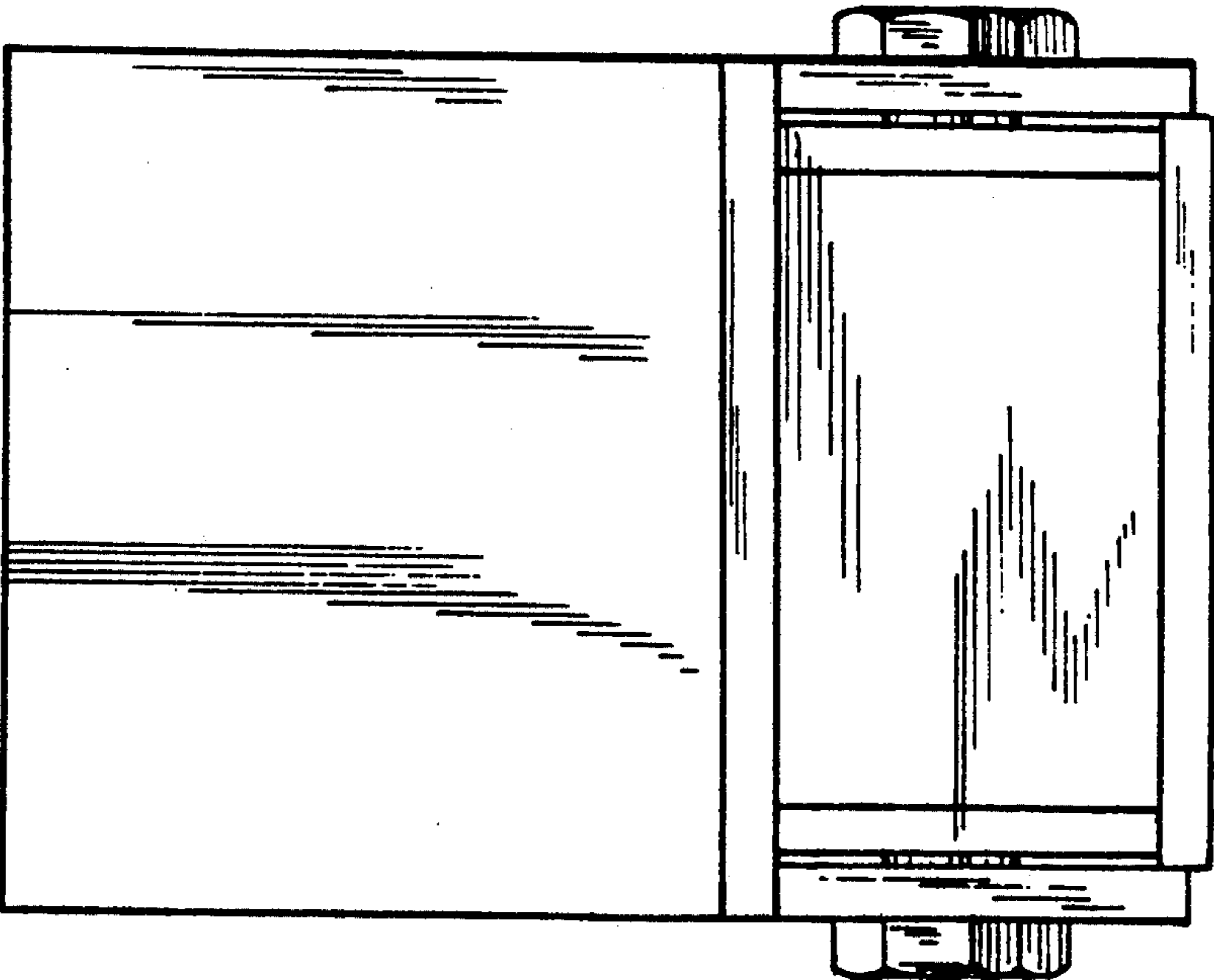

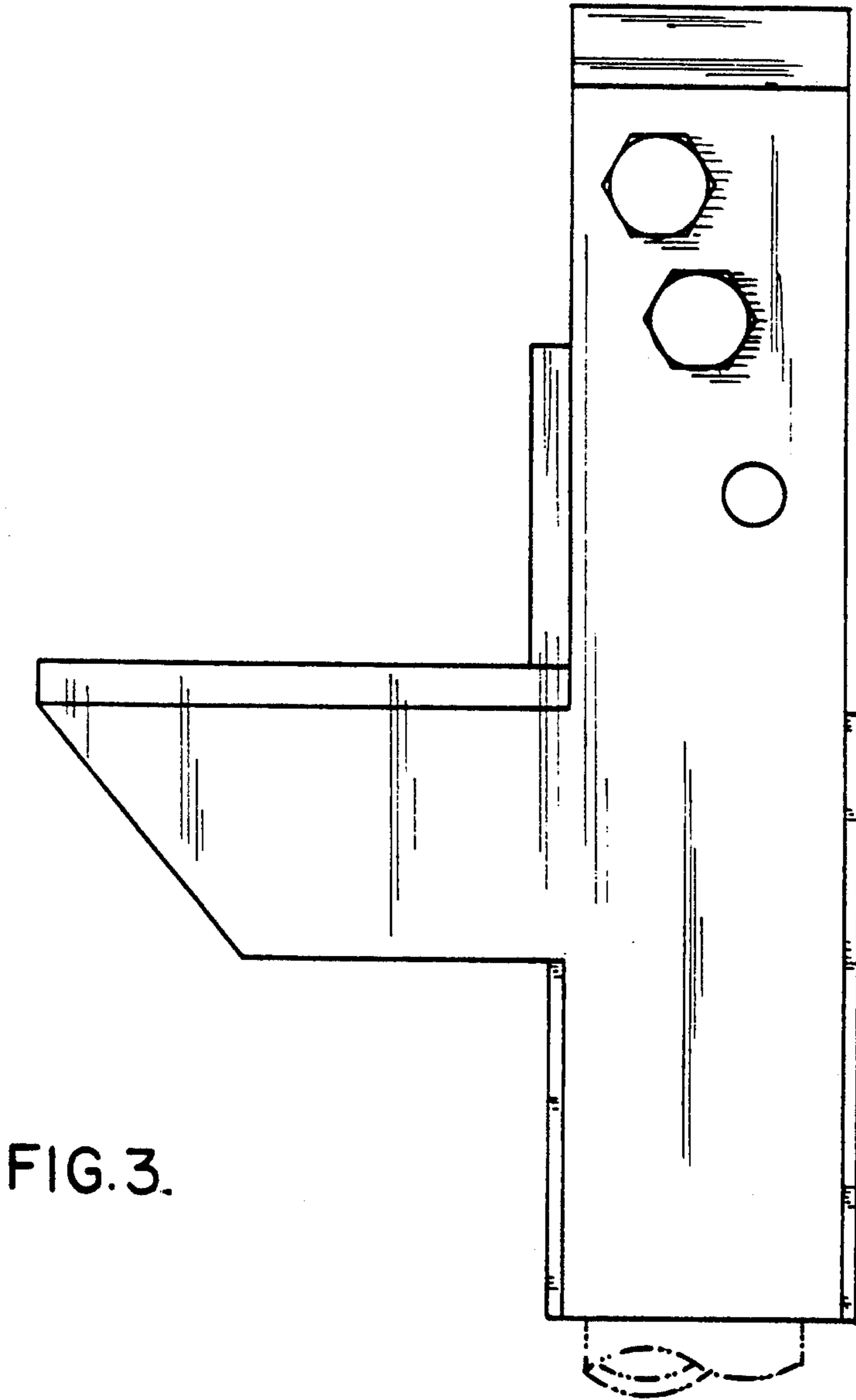

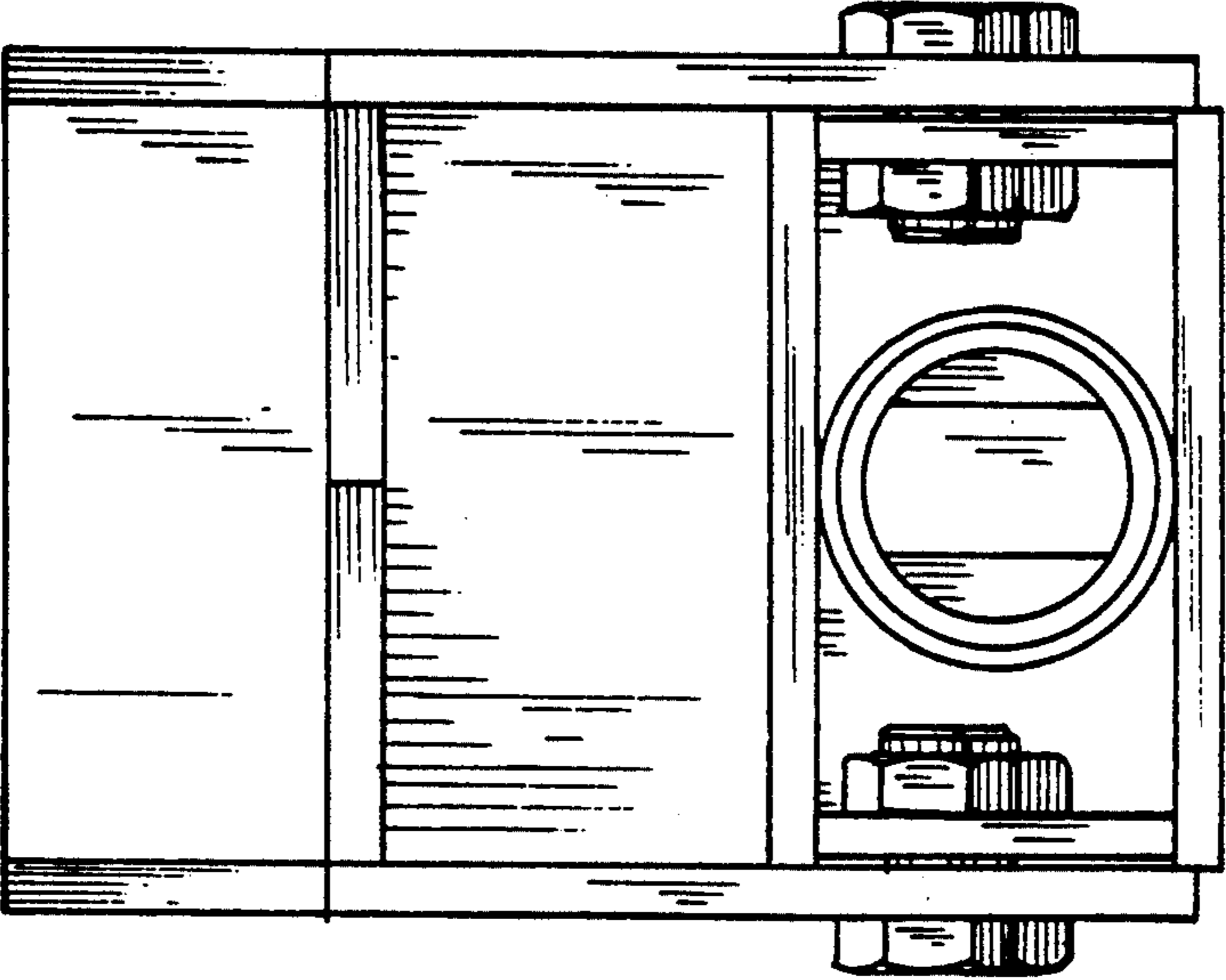

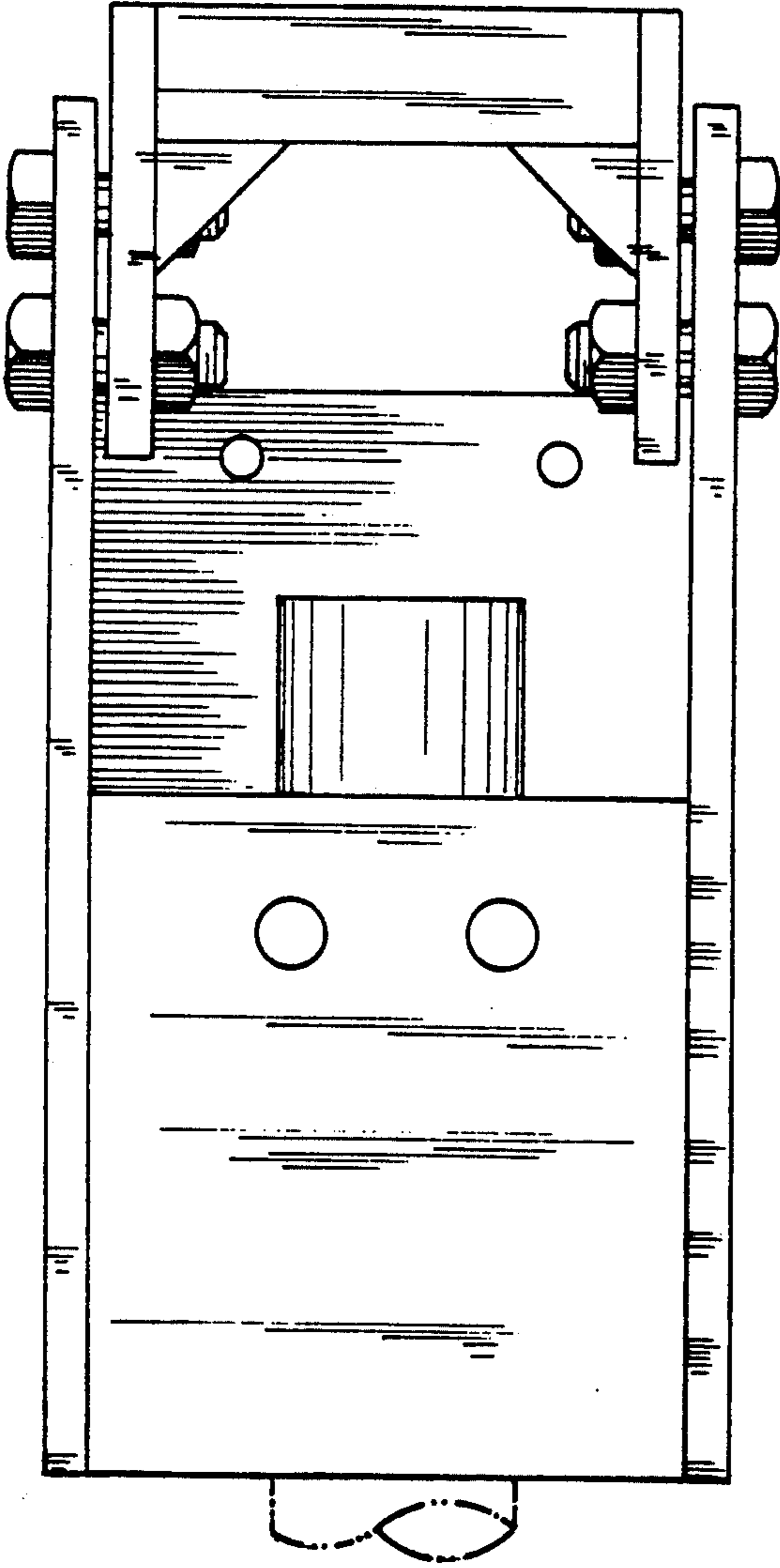

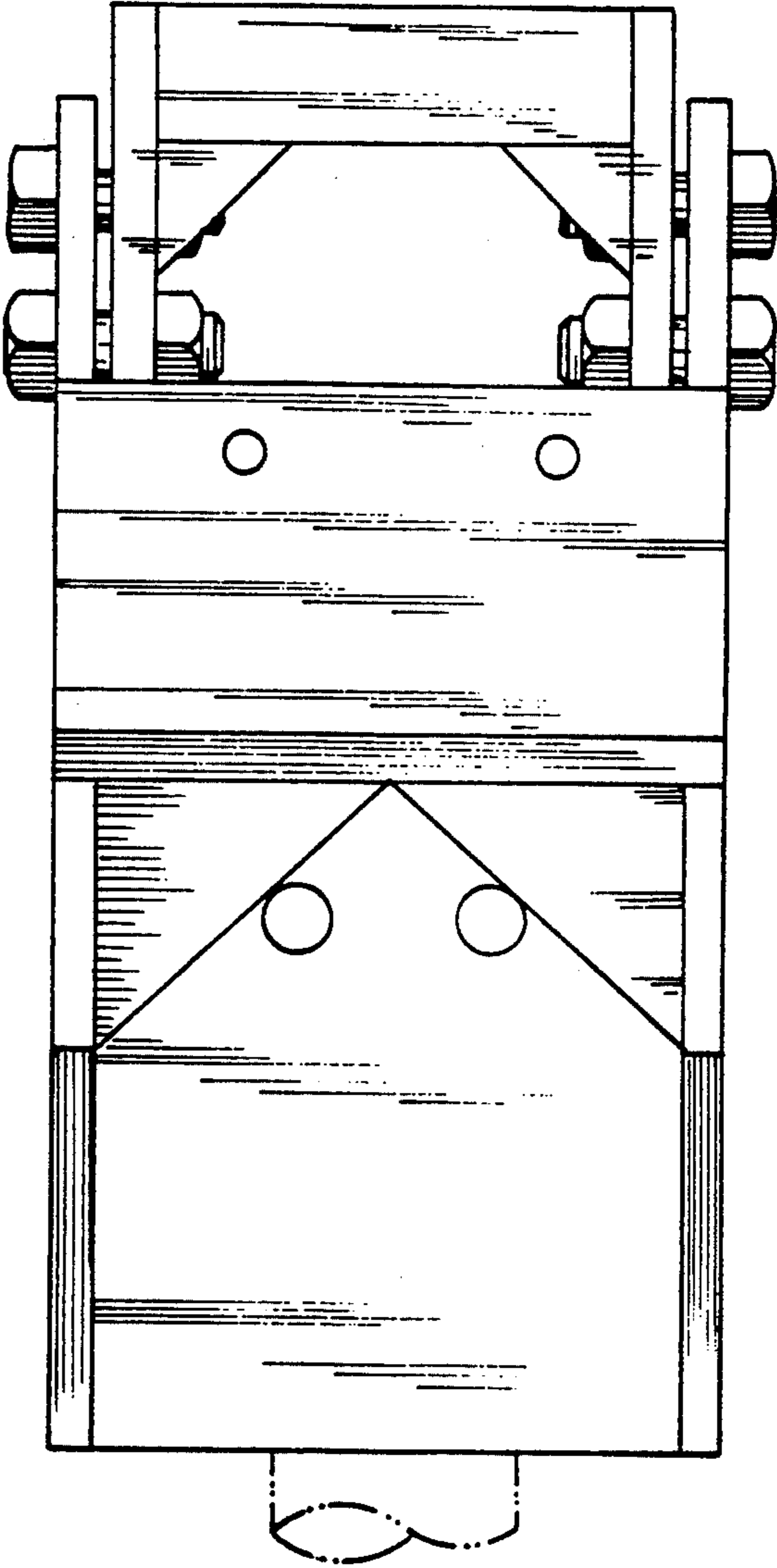
