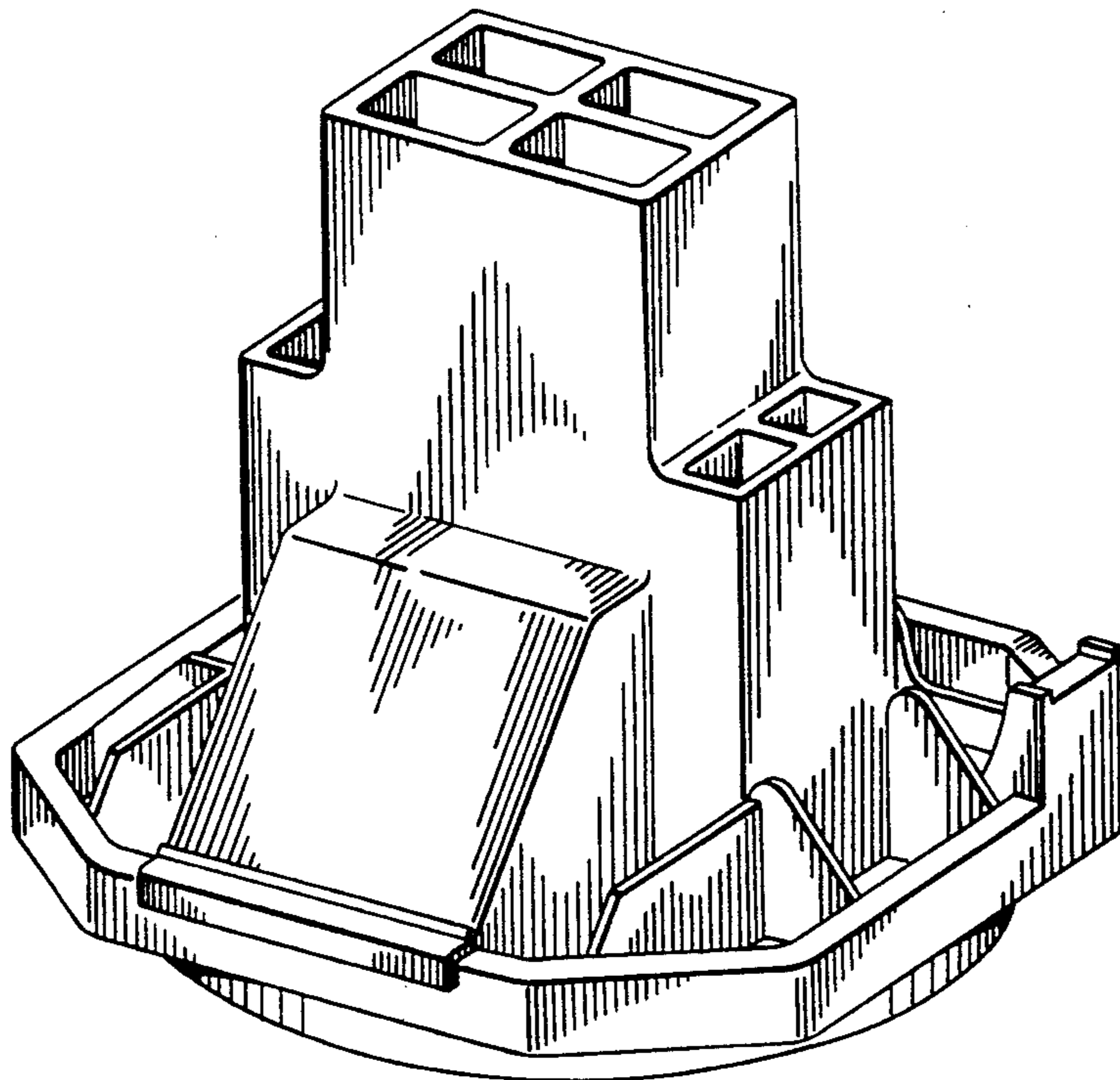

[57] **CLAIM**

The ornamental design for a compartmented organizer for office supplies, as shown and described.

DESCRIPTION

FIG. 1 is a top, right front perspective view of a compartmented organizer for office supplies showing my new design; FIG. 2 is a front elevational view; FIG. 3 is a rear elevational view; FIG. 4 is a right side elevational view; FIG. 5 is a left side elevational view; FIG. 6 is a top plan view; and, FIG. 7 is a bottom plan view thereof. FIGS. 2 through 7 have been drawn to an enlarged scale with respect to FIG. 1.



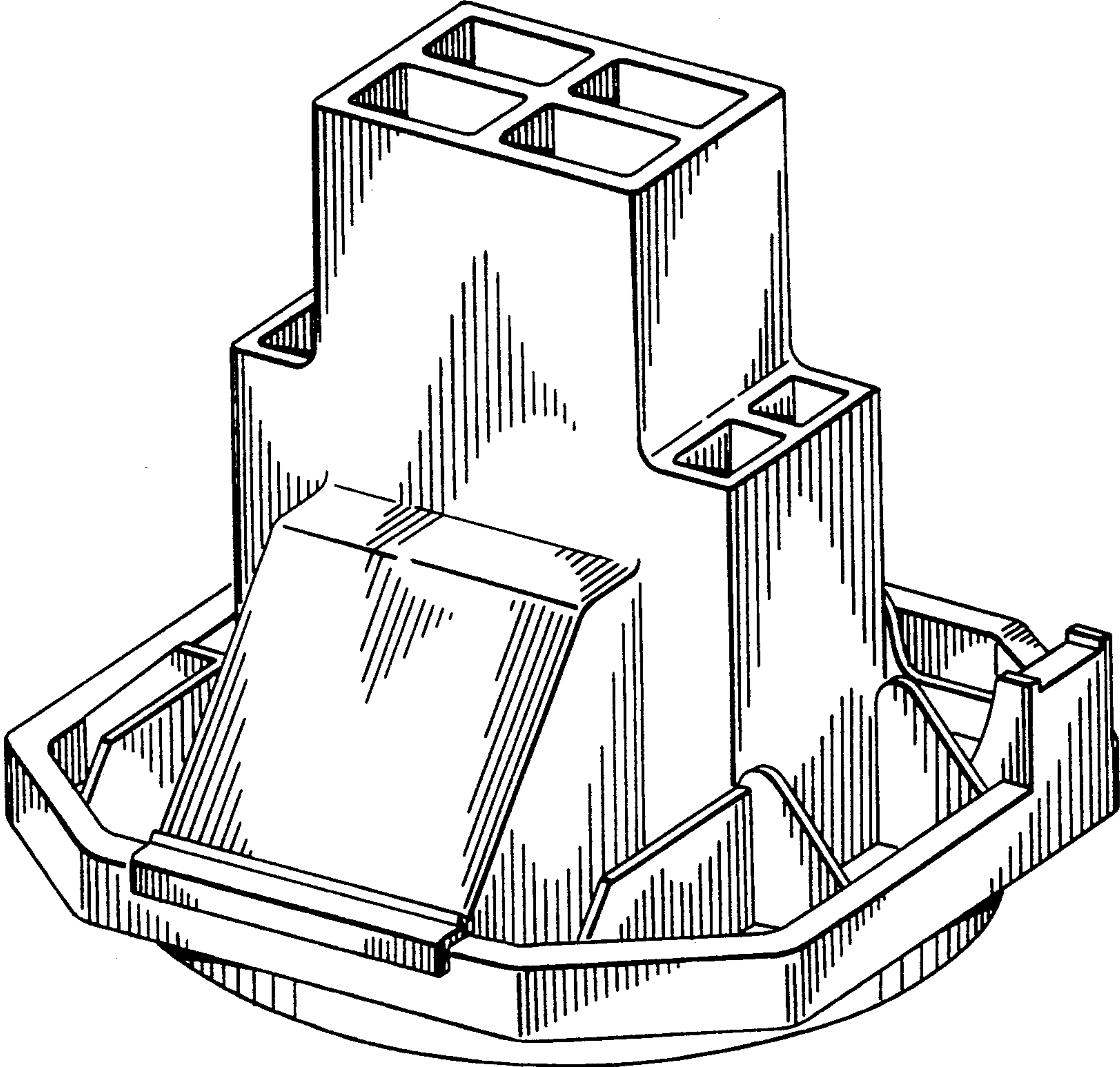

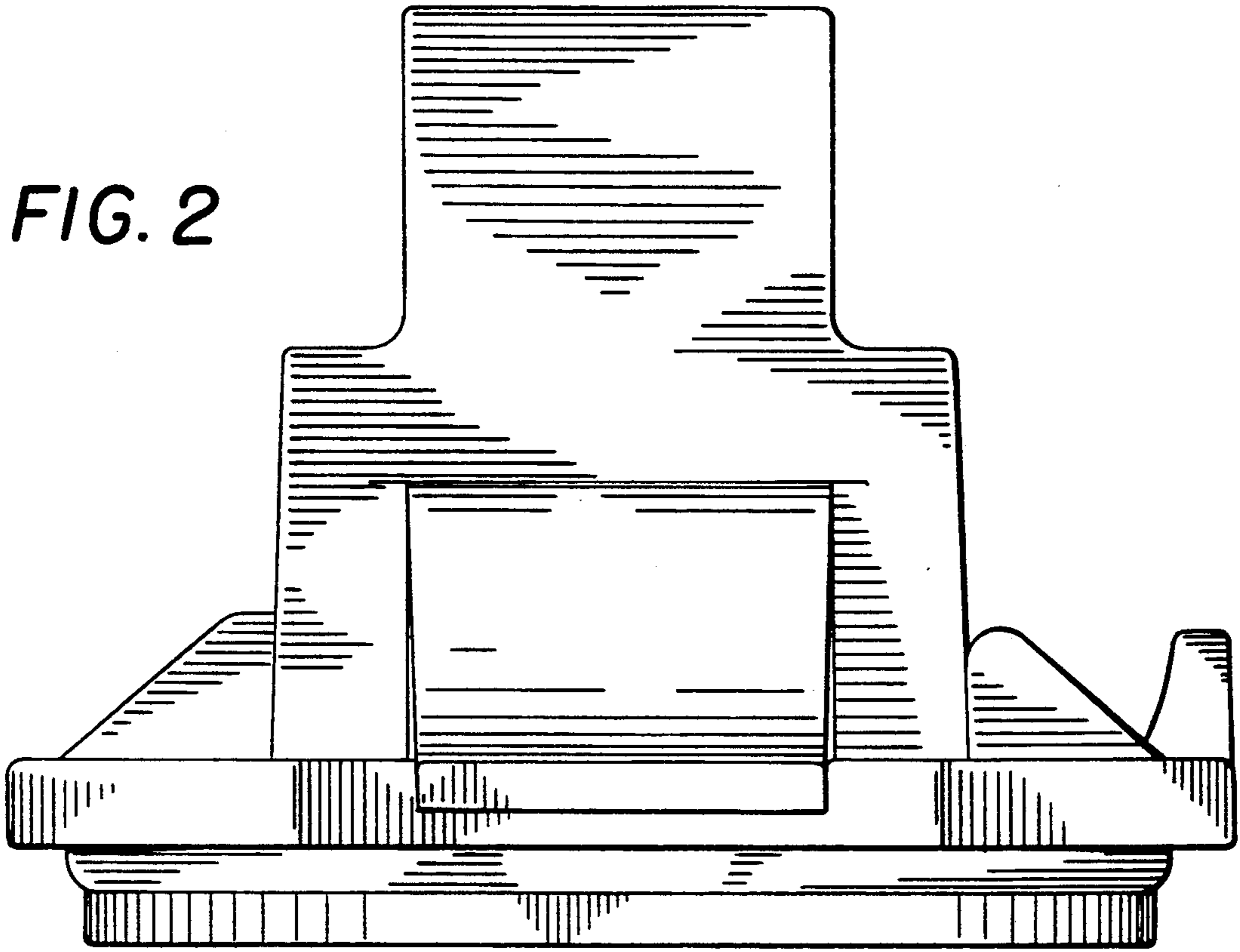

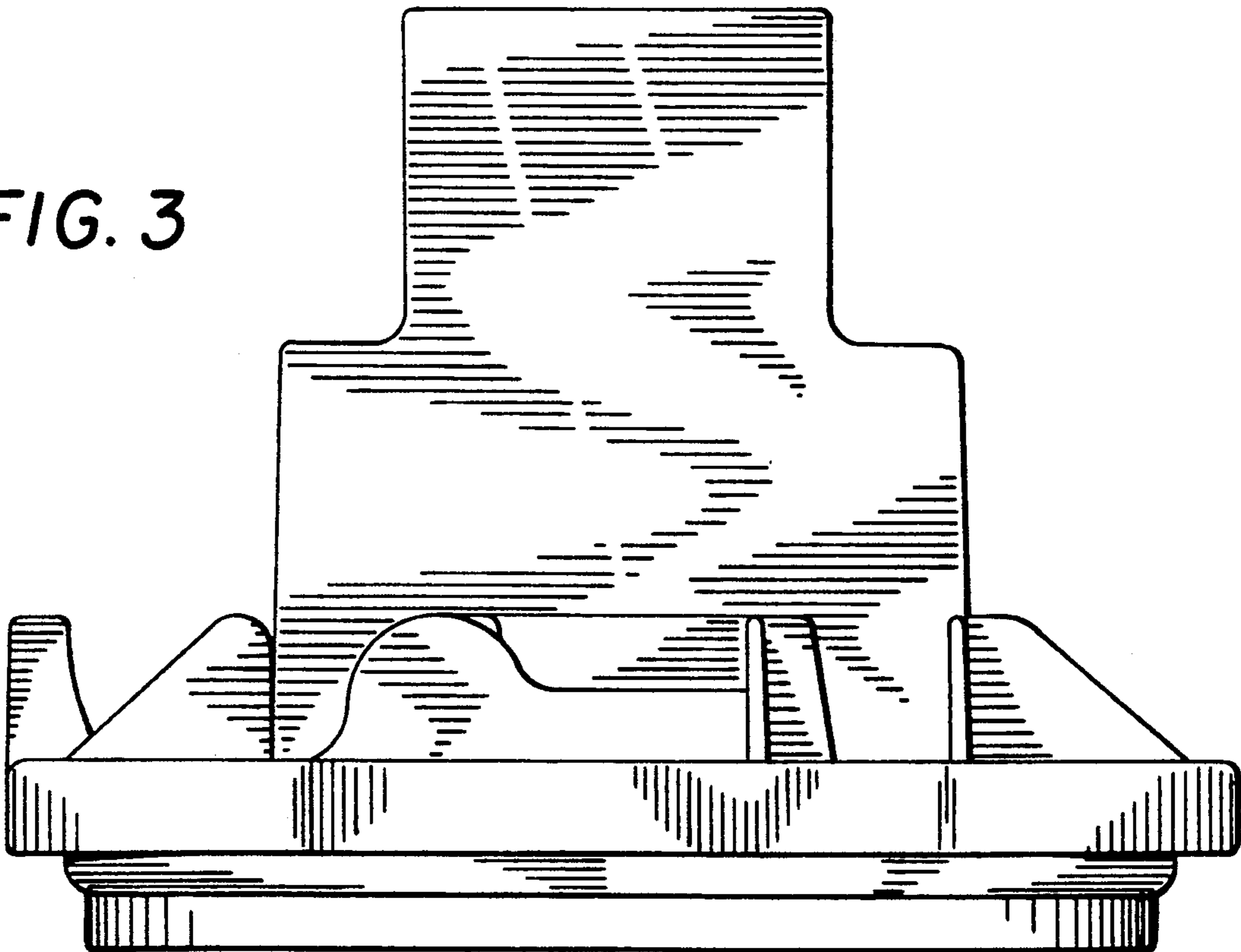

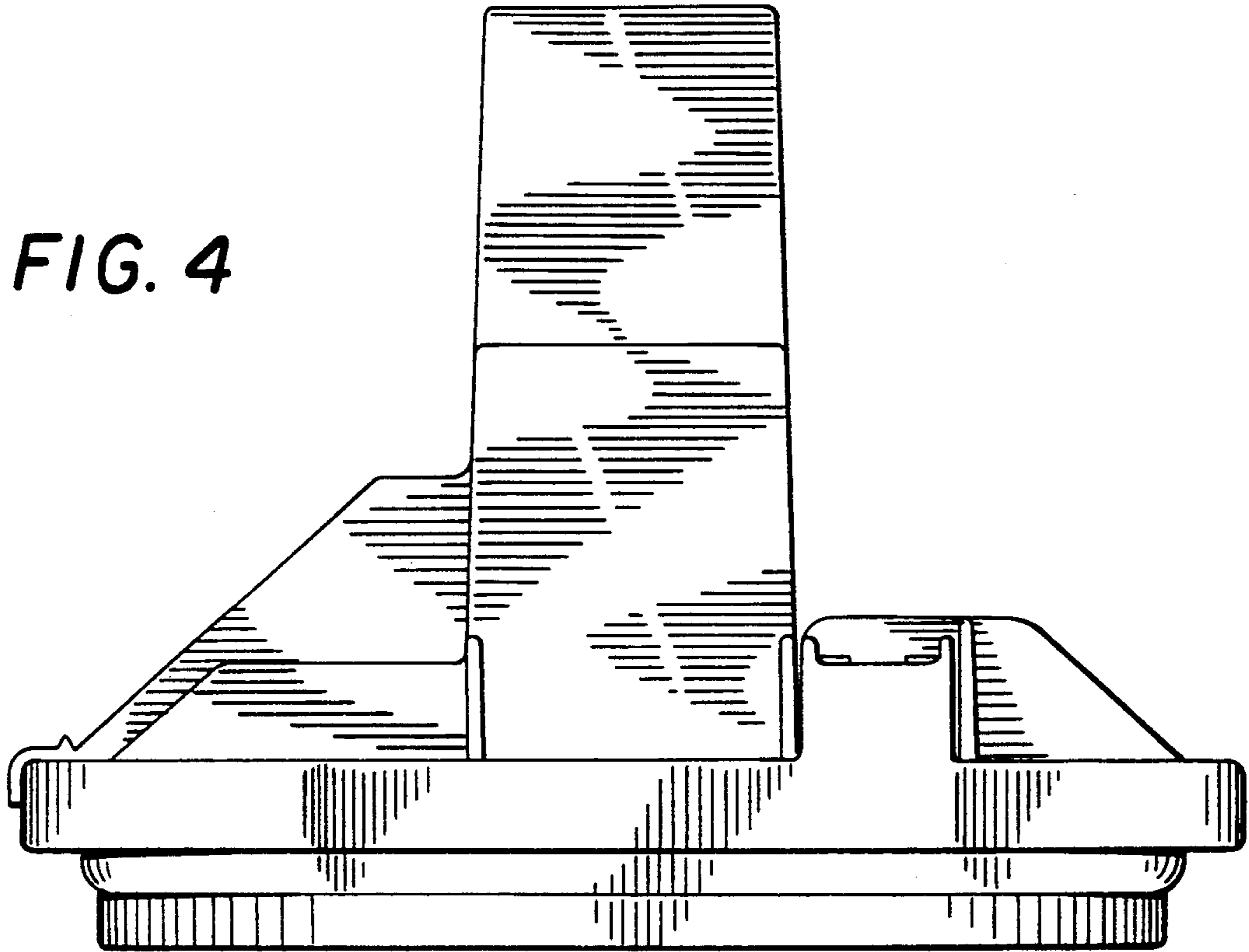
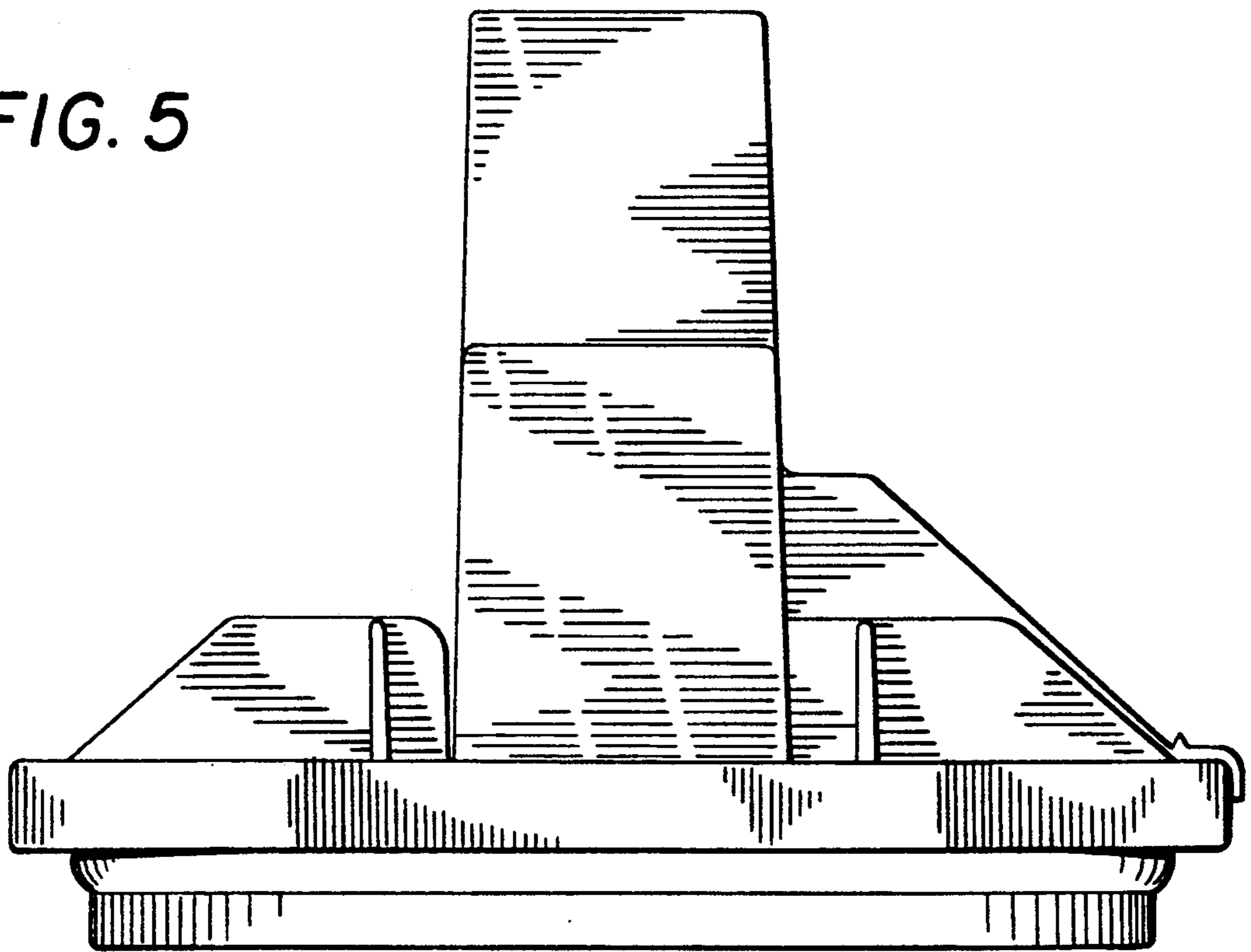

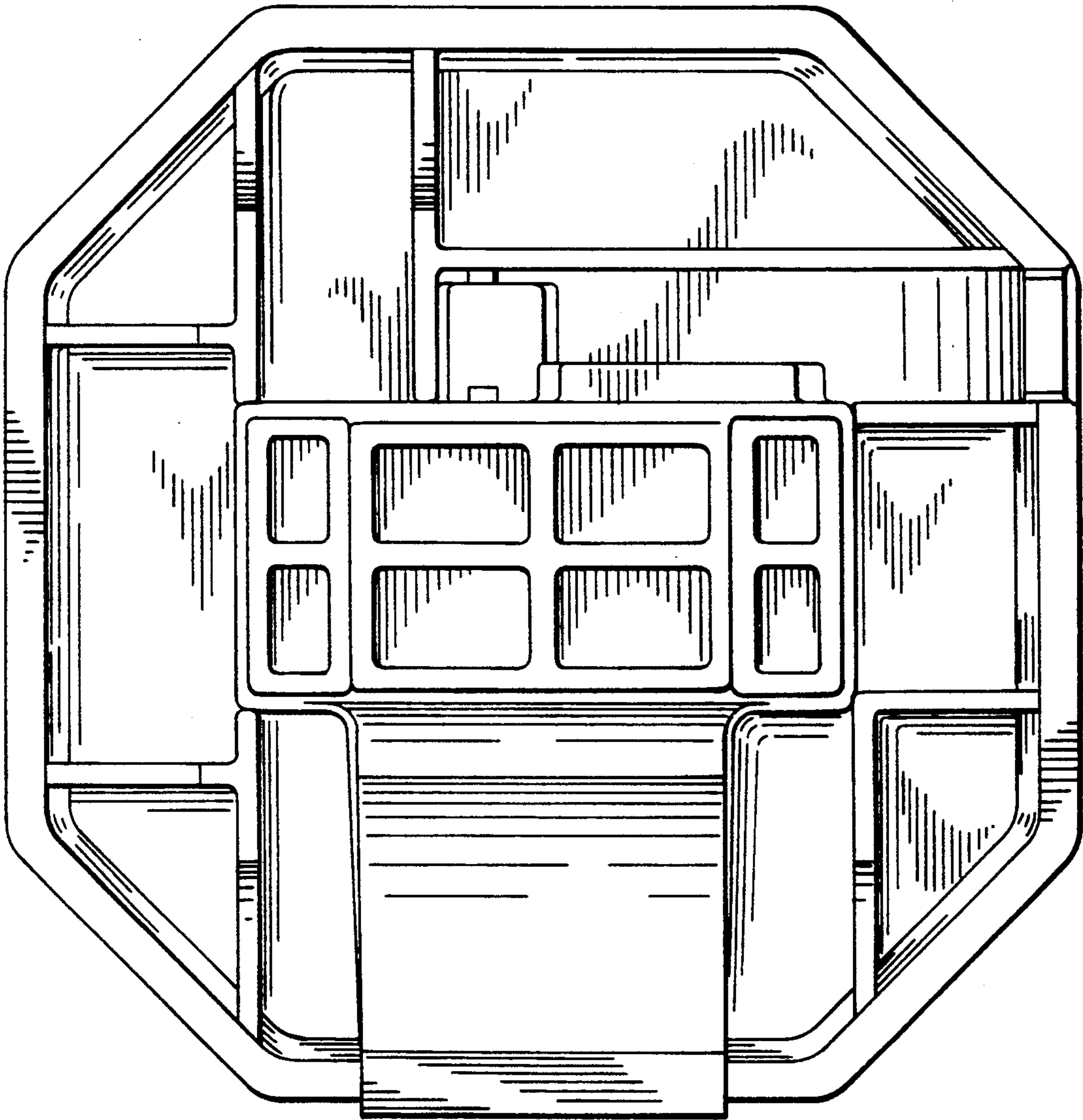

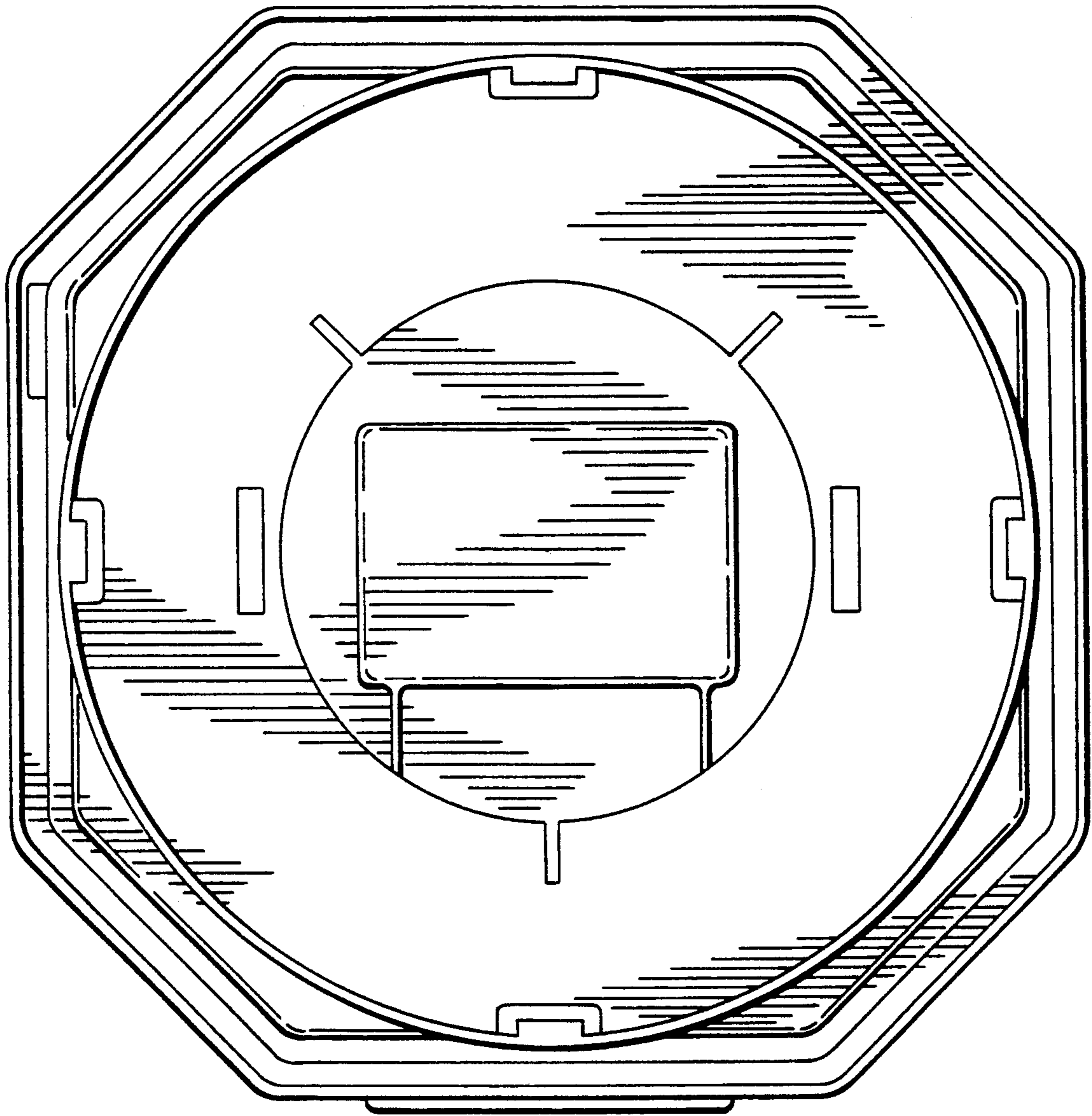
