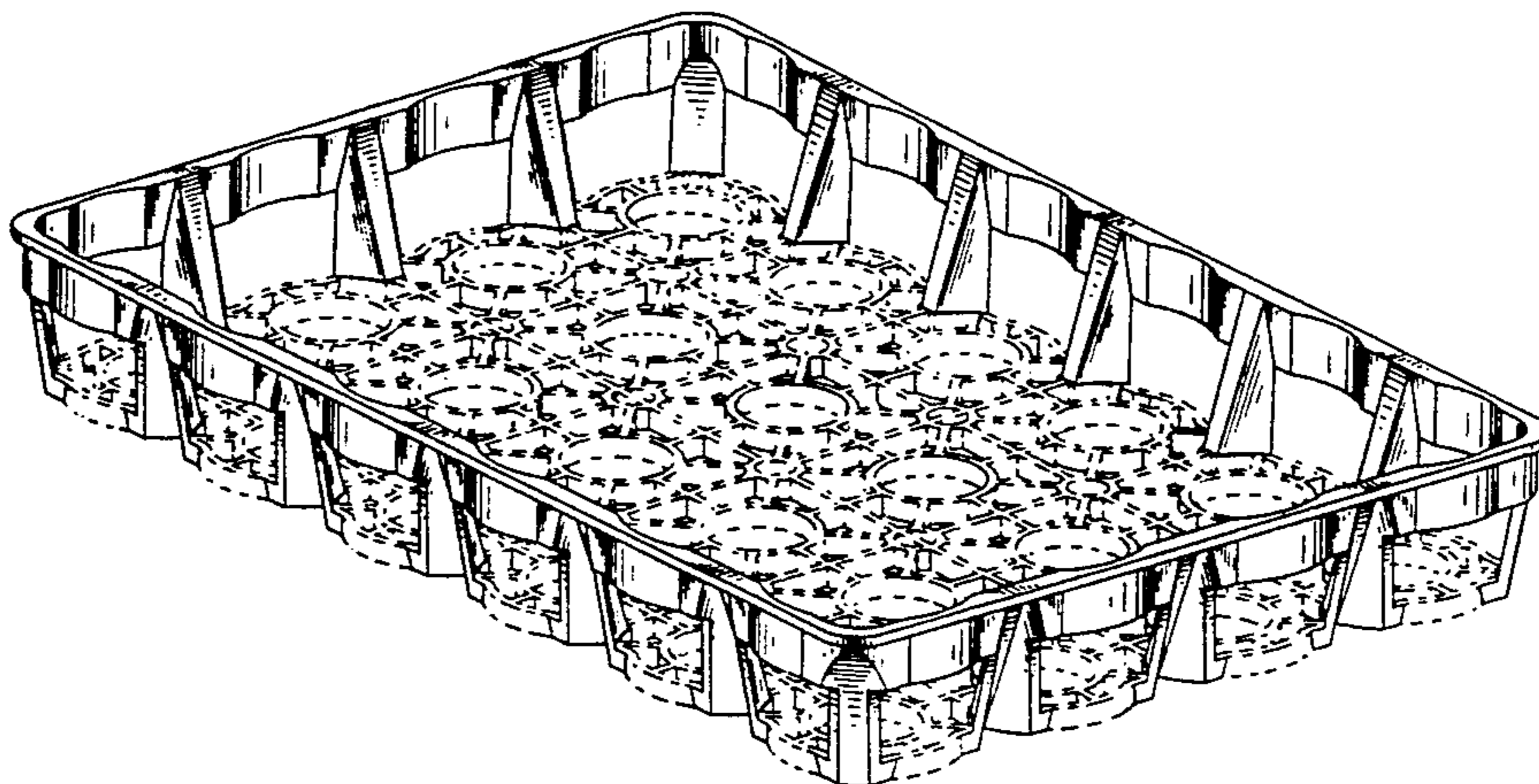

[57] CLAIM

The ornamental design for an outer wall structure for a nestable tray, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an outer wall structure for a nestable tray showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a front elevational view thereof; the rear elevational view being a mirror image thereof;

FIG. 5 is a left side elevational view thereof; the right side elevational view being a mirror image thereof;

FIG. 6 is a perspective view of a second embodiment of FIG. 1;

FIG. 7 is a top plan view of FIG. 6;

FIG. 8 is a bottom plan view of FIG. 6;

FIG. 9 is a front elevational view of FIG. 6; the rear elevational view being a mirror image thereof;

FIG. 10 is a left side elevational view of FIG. 6; the right side elevational view being a mirror image thereof;

FIG. 11 is a perspective view of a third embodiment of FIG. 1;

FIG. 12 is a top plan view of FIG. 11;

FIG. 13 is a bottom plan view of FIG. 11;

FIG. 14 is a front elevational view of FIG. 11; the rear elevational view being a mirror image thereof;

FIG. 15 is a left side elevational view of FIG. 11; the right side elevational view being a mirror image thereof;

FIG. 16 is a perspective view of a fourth embodiment of FIG. 1;

FIG. 17 is a top plan view of FIG. 16;

FIG. 18 is a bottom plan view of FIG. 16;

FIG. 19 is a front elevational view of FIG. 16, the rear elevational view being a mirror image thereof; and,

FIG. 20 is a left side elevational view of FIG. 16; the right side elevational view being a mirror image thereof.

The broken line showing of a tray floor structure in FIGS. 1, 6, 11 and 16 is for an environmental purpose only and forms no part of the claim.

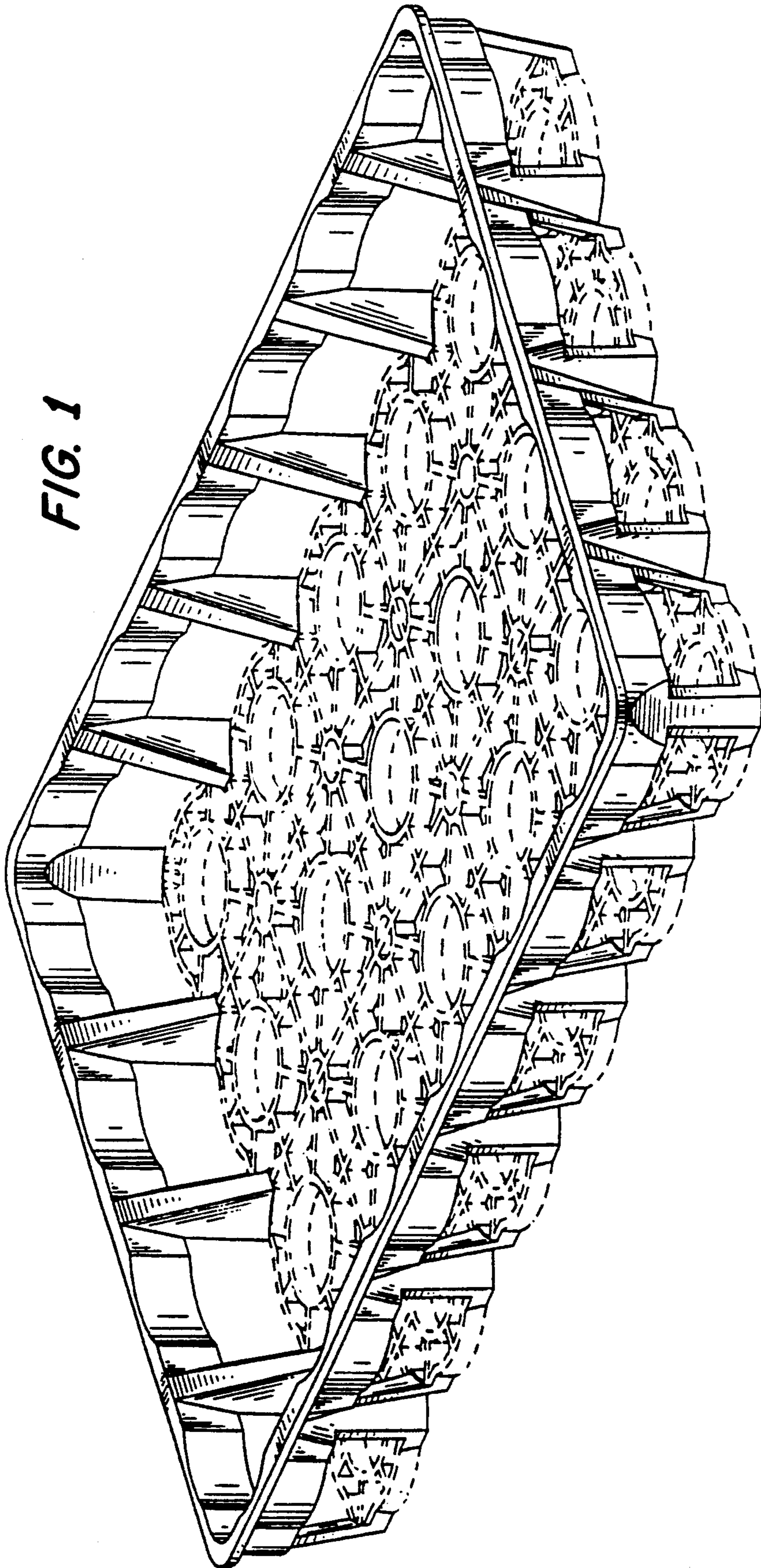

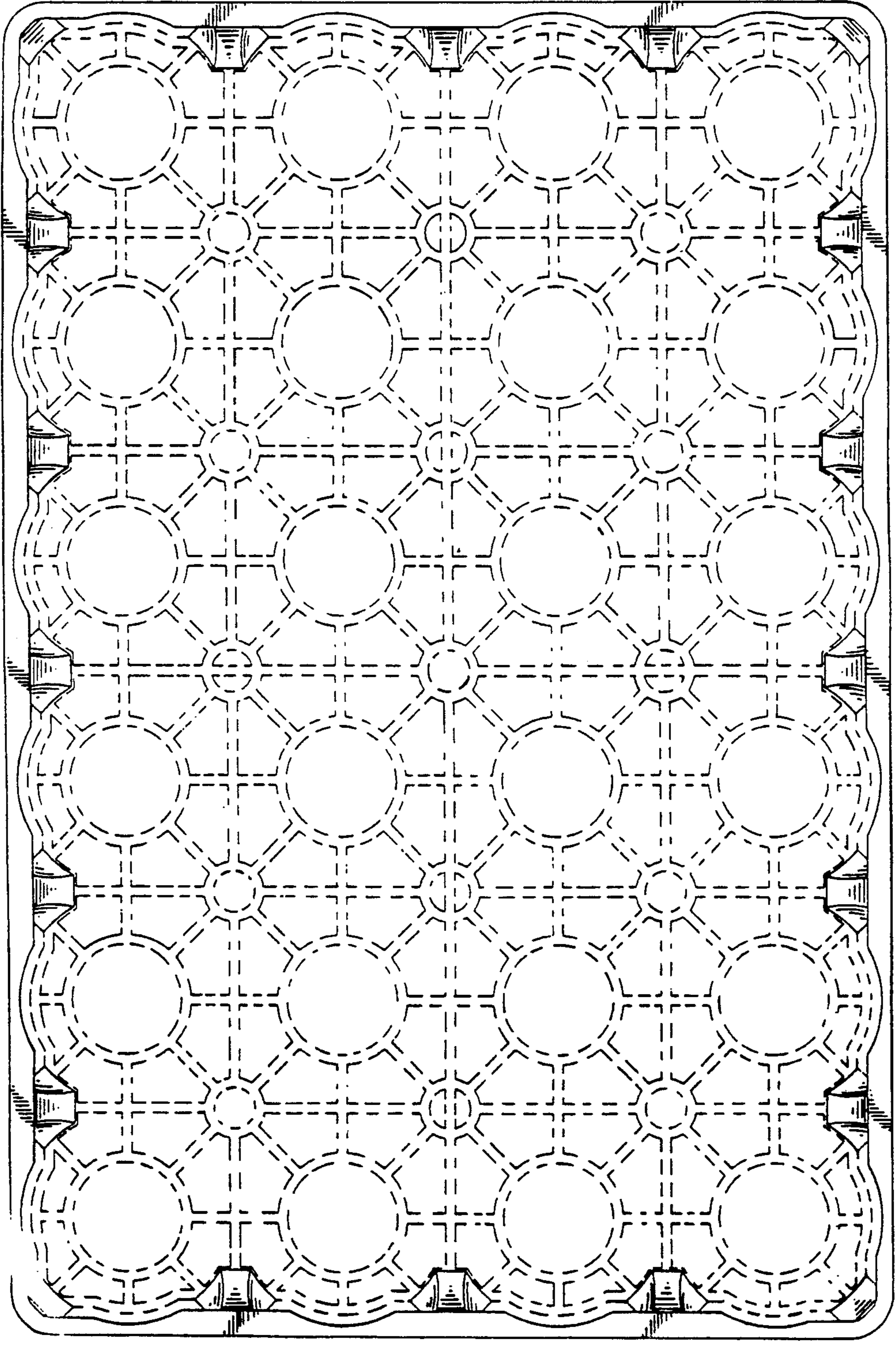

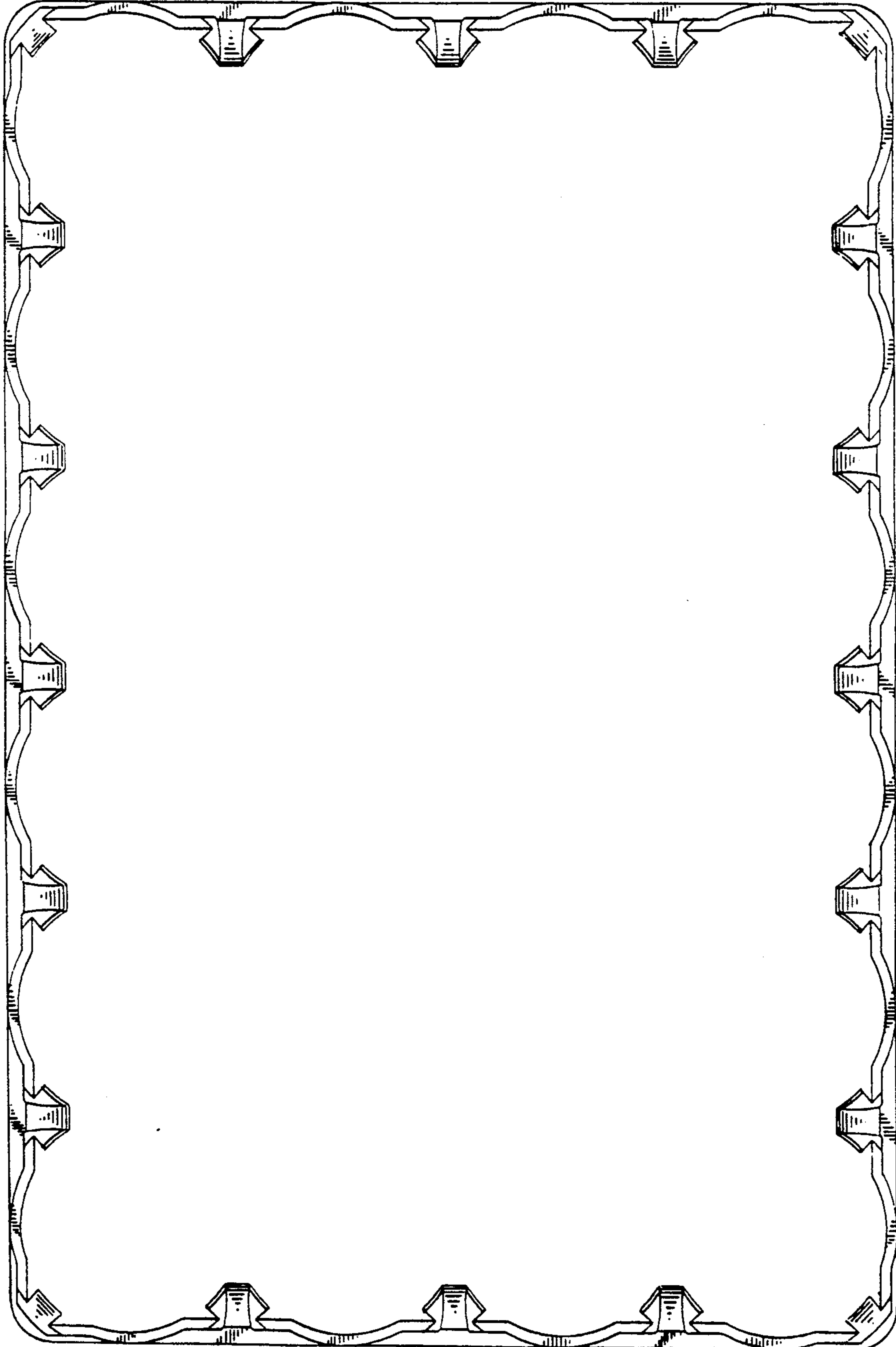

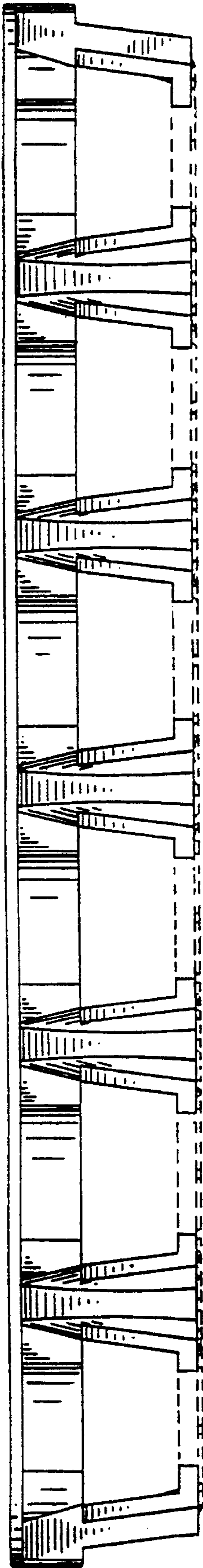

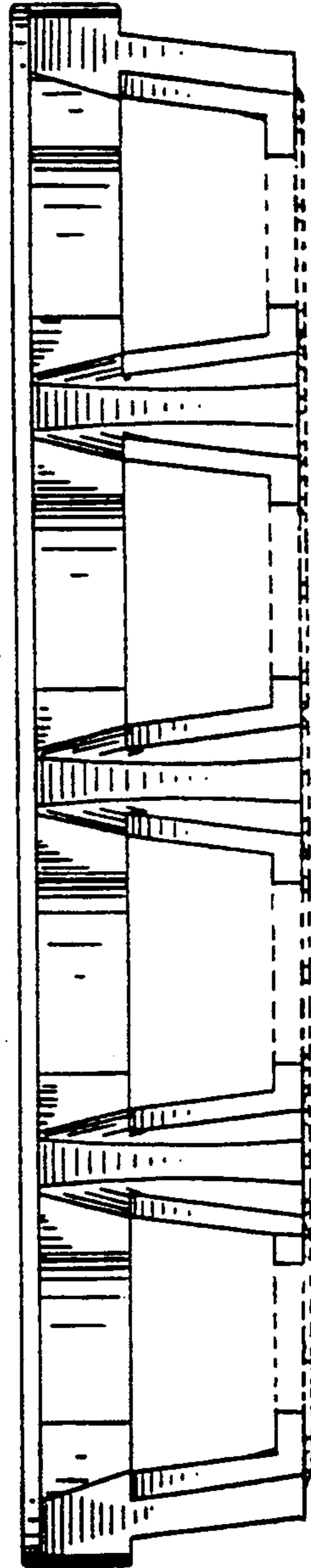

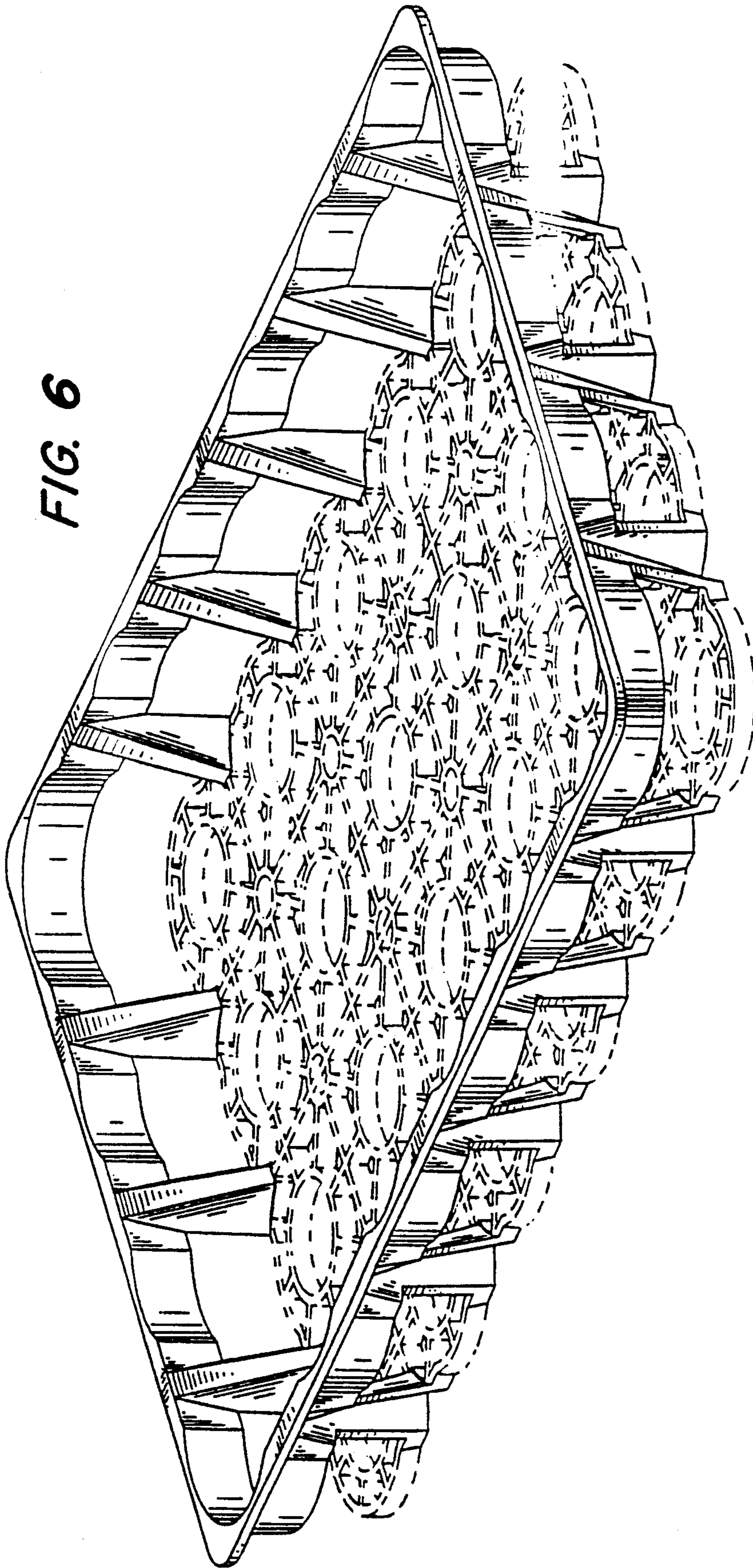

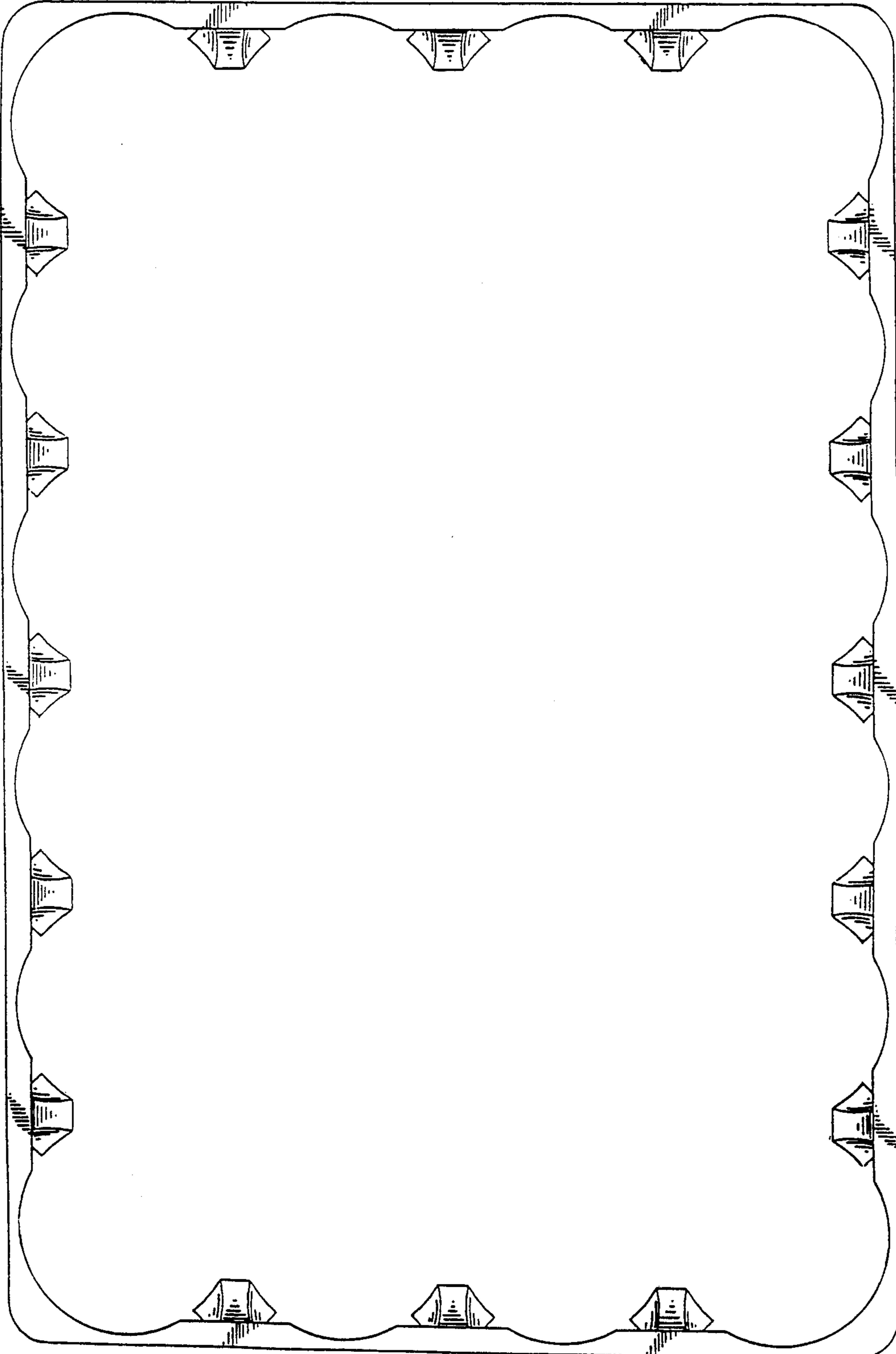

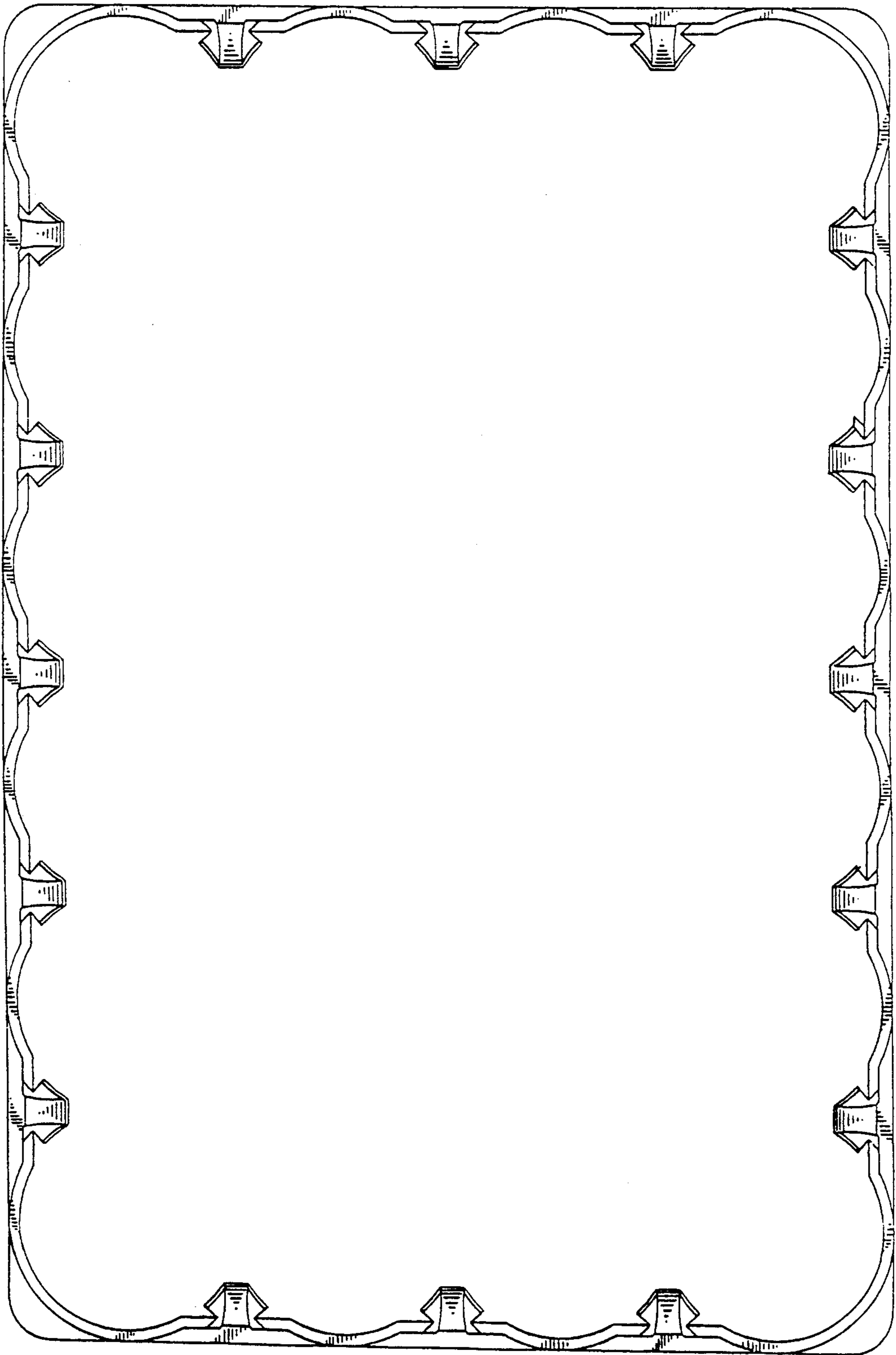

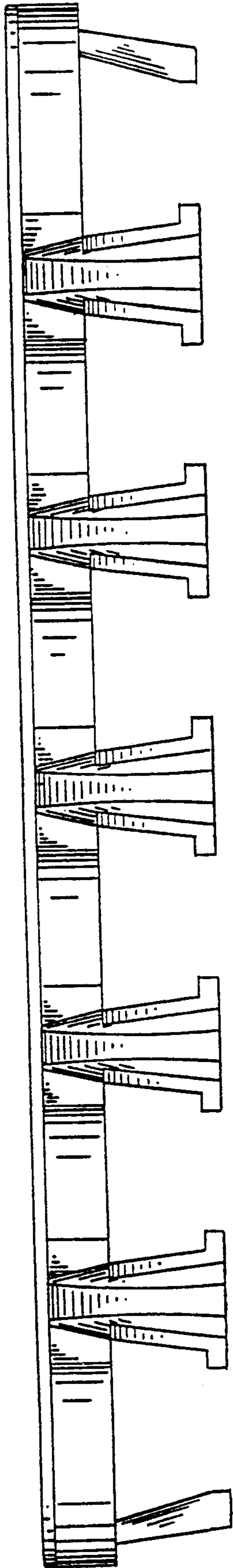

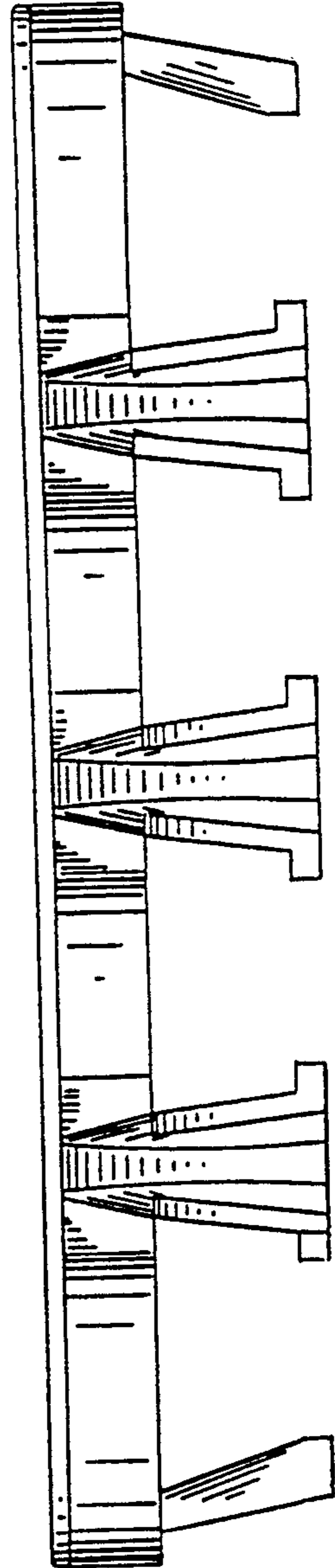

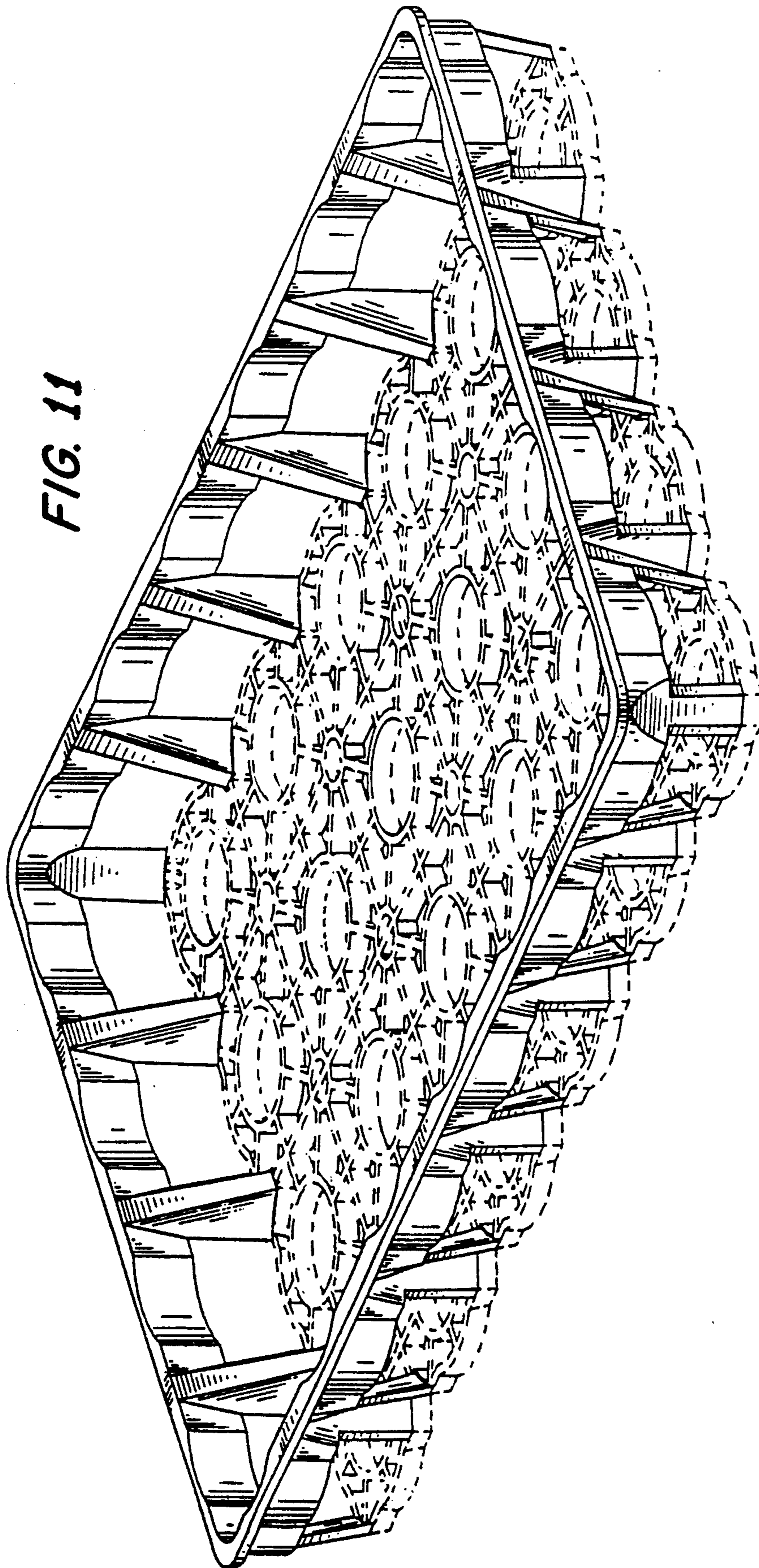

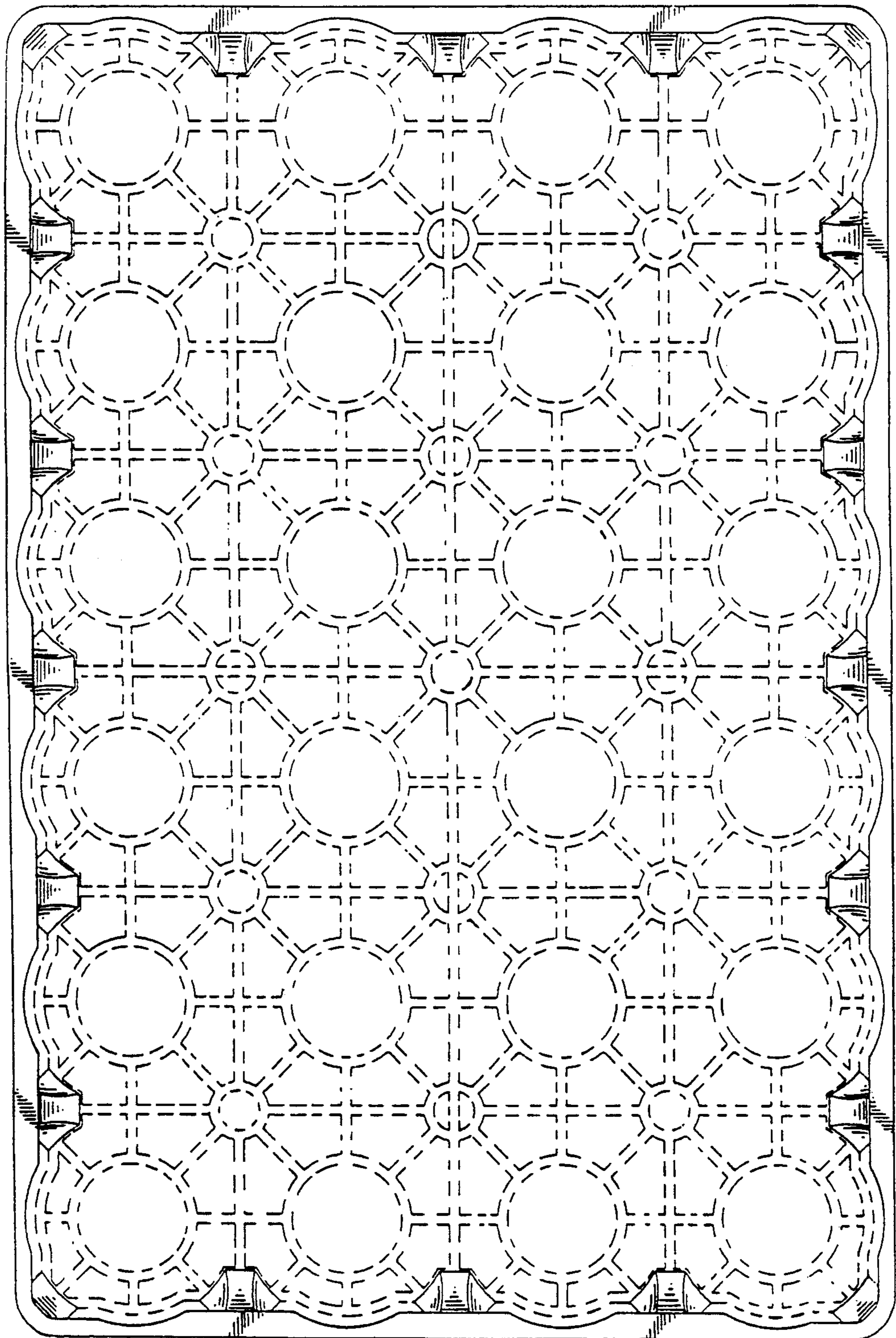

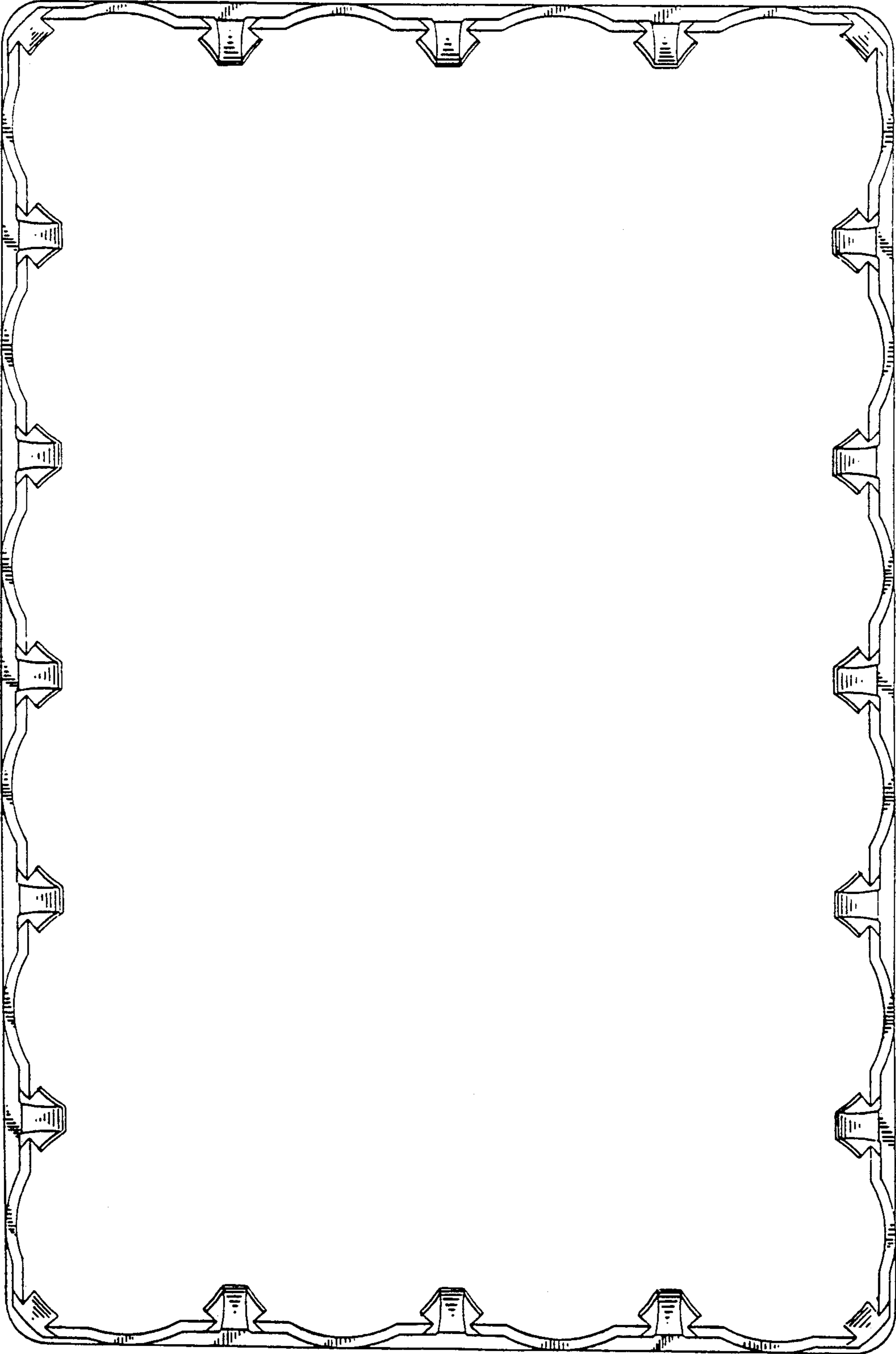

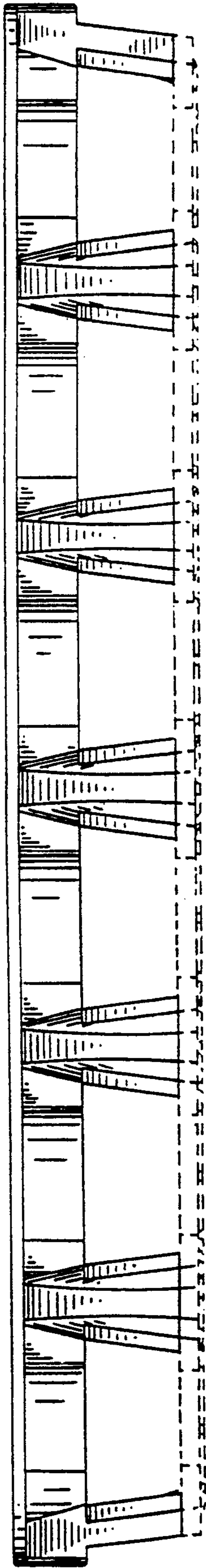
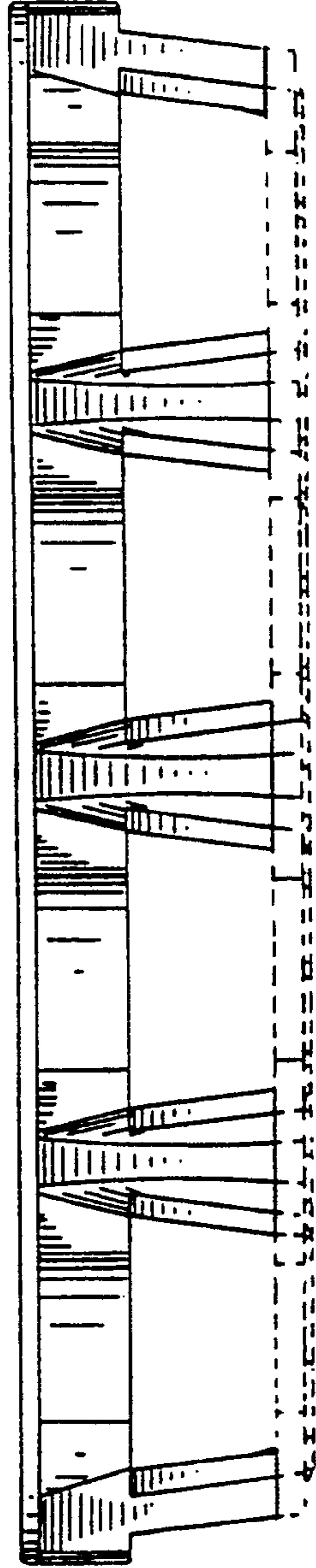

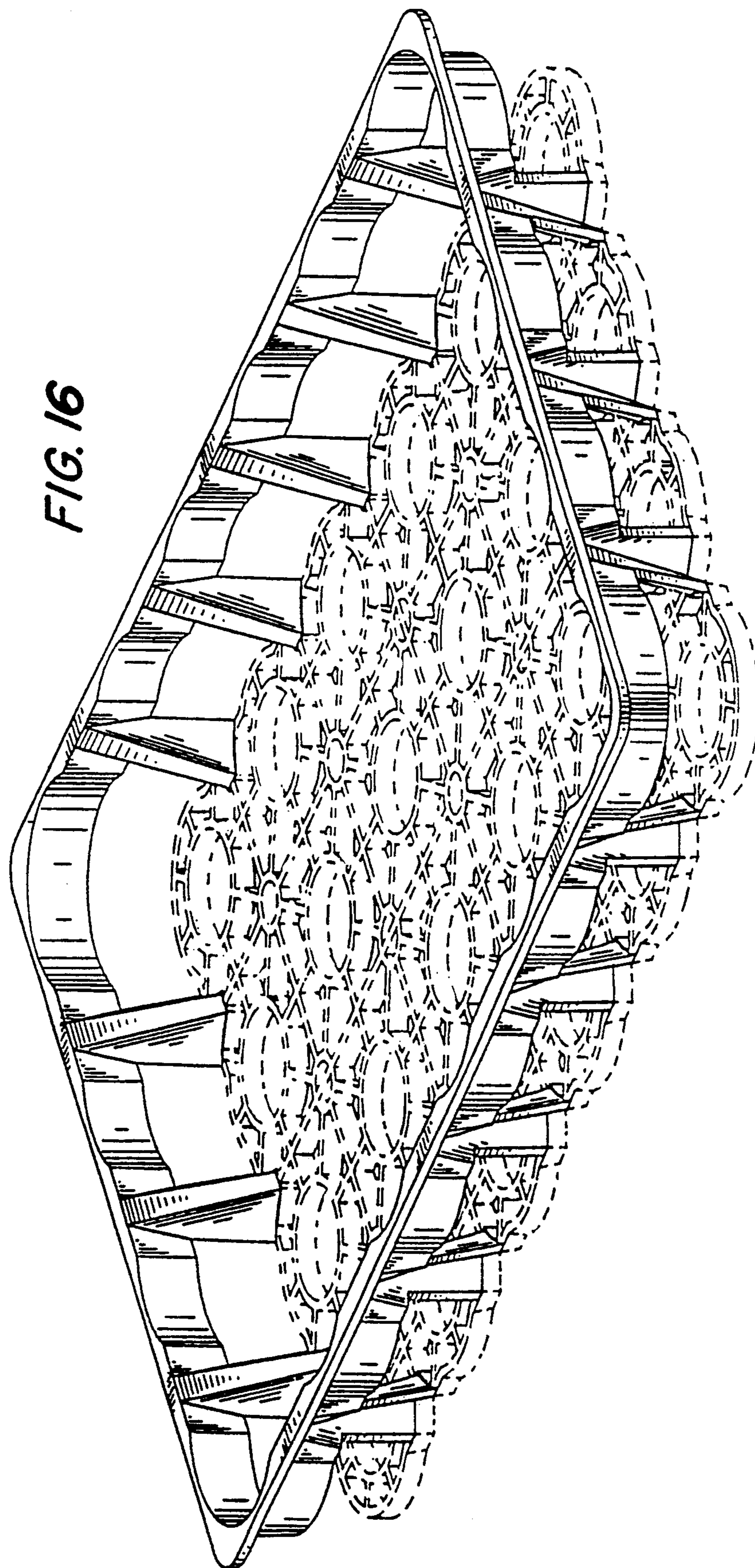

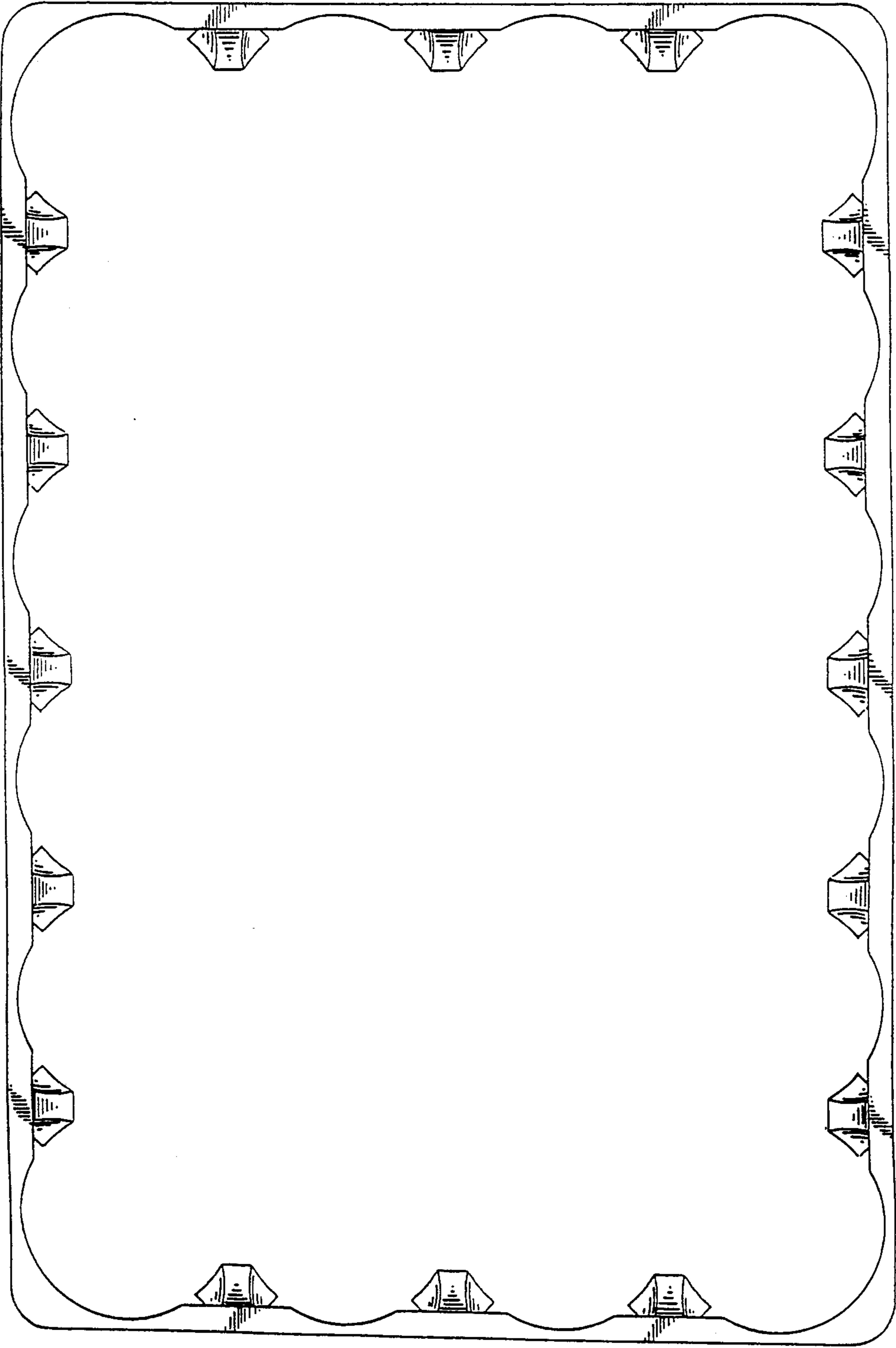

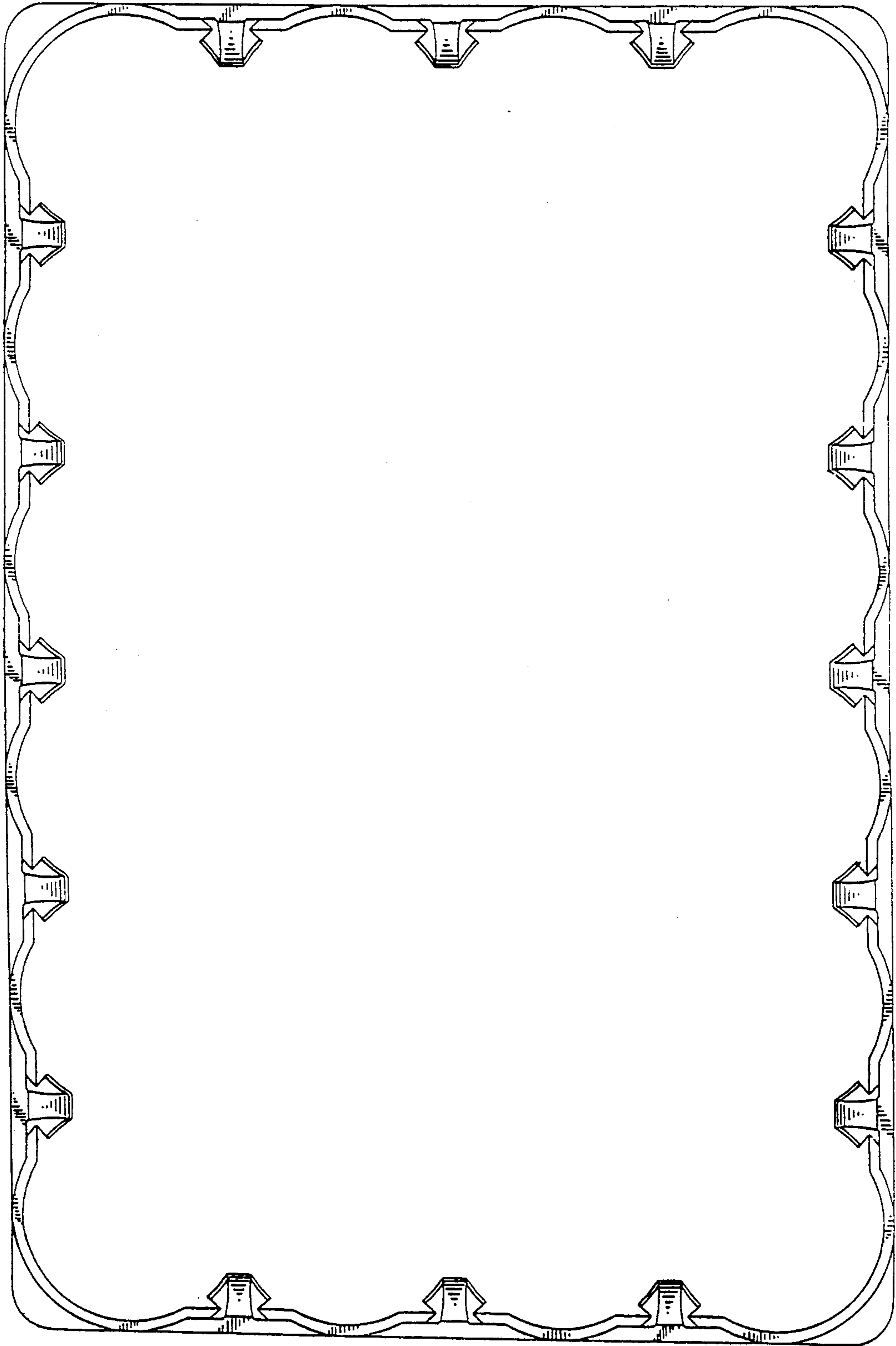

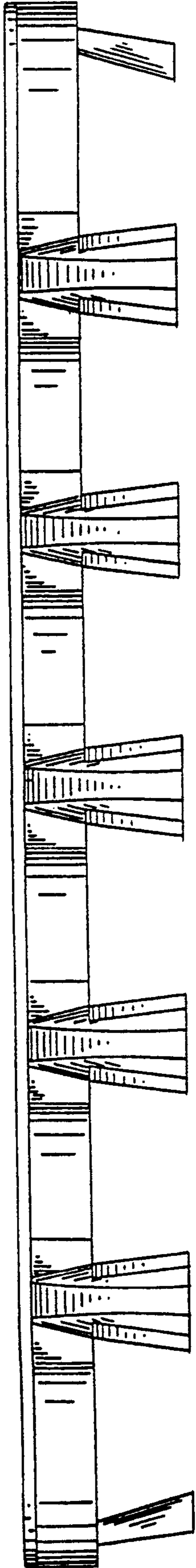
