## [57] CLAIM

The ornamental design for a cup shaped shoe sole, as shown and described.

## DESCRIPTION

FIG. 1 is a bottom plan view of a cup shaped shoe sole showing our new design;

FIG. 2 is a side view of the cup shaped shoe sole shown in FIG. 1;

FIG. 3 is a side view of the other side of the cup shaped shoe sole shown in FIG. 1;

FIG. 4 is a front elevational view of the cup shaped shoe sole shown in FIG. 1;

FIG. 5 is a rear elevational view of the cup shaped shoe sole shown in FIG. 1;

FIG. 6 is a partial cross section taken along line 6—6 of FIG. 1;


FIG. 7 is a partial cross section taken along line 7—7 of FIG. 1;


FIG. 8 is a partial cross section taken along line 8—8 of FIG. 1;

The broken line showing of a shoe upper shown in FIGS. 2-5 is for illustrative purposes only and forms no part of the claimed design.













*FIG. 10**FIG. 9**FIG. 3*
