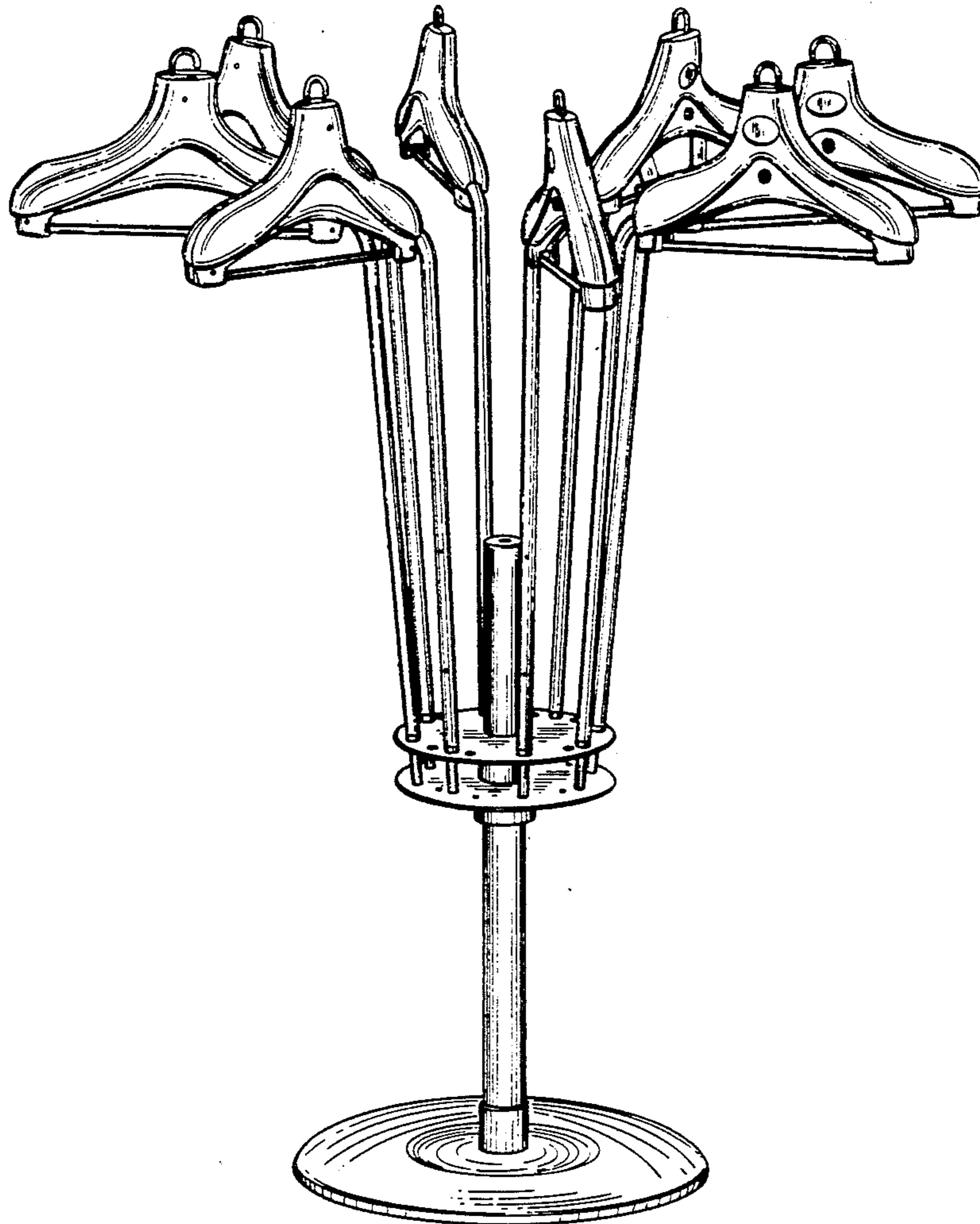

FIG. 1 is a perspective view of a display stand for apparel showing my new design; and, FIG. 2 is a top plan view thereof.



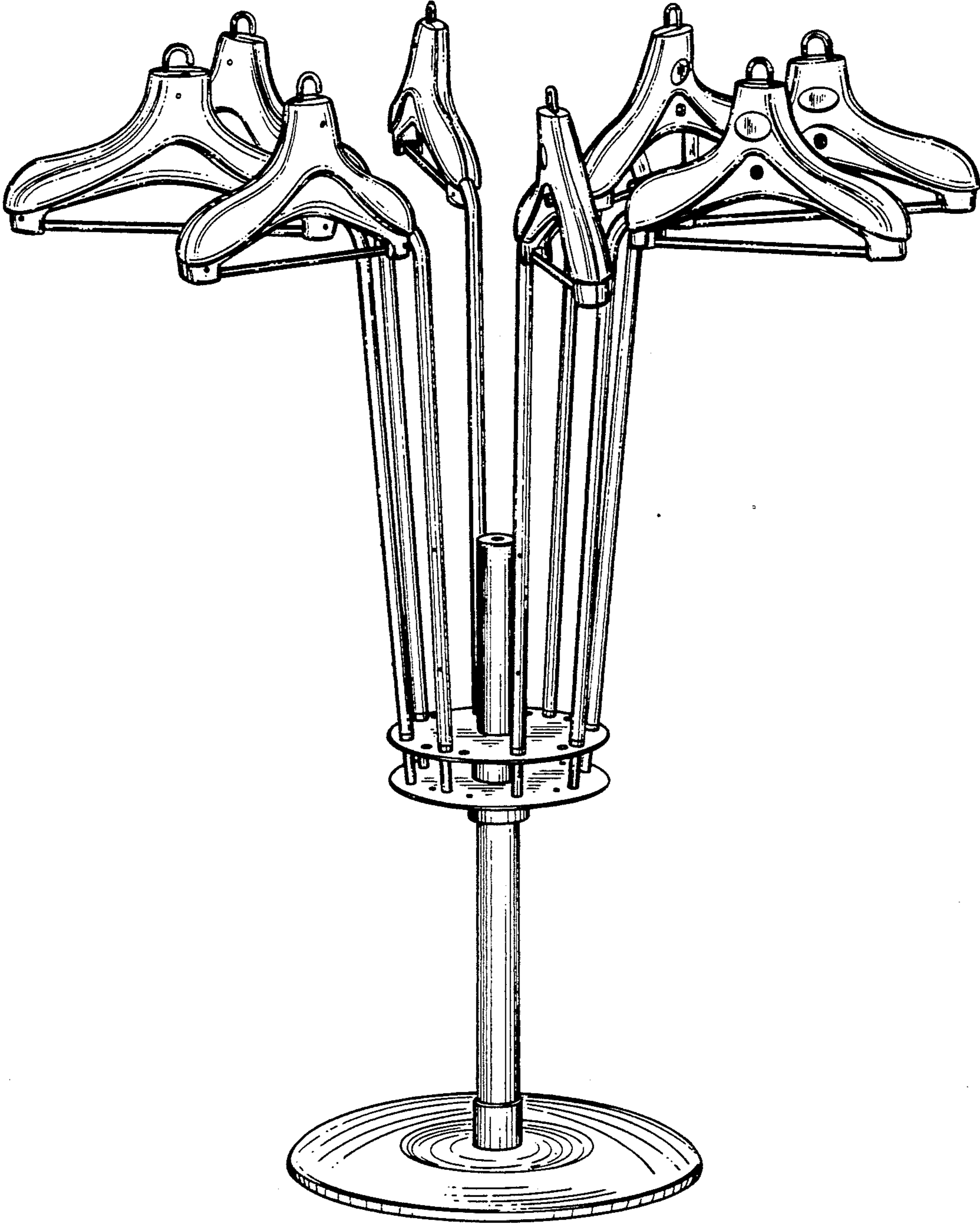

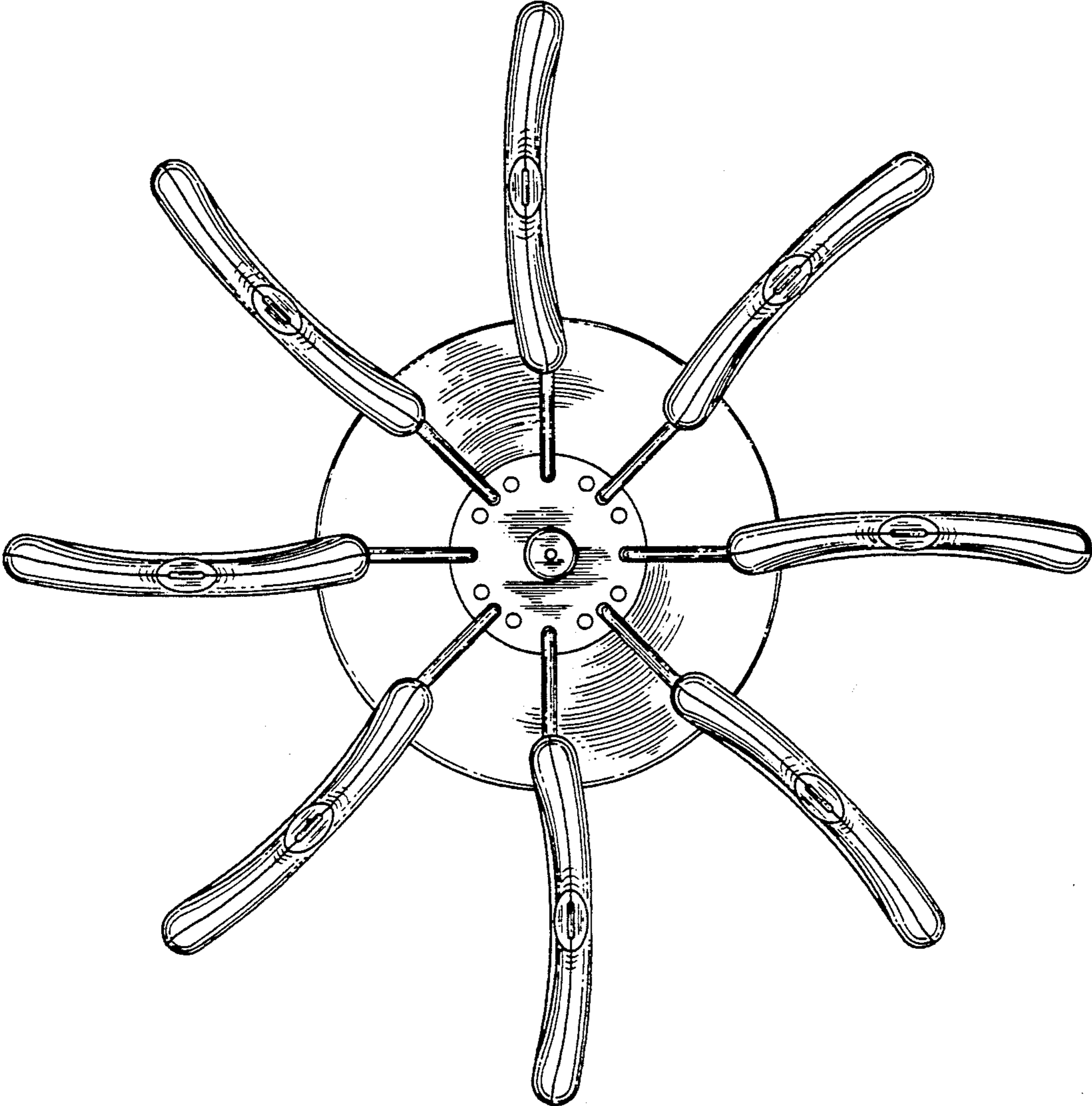
