DESCRIPTION

FIG. 1 is a front elevational view of a drinking straw showing our new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a bottom plan view thereof;
 FIG. 4 is a left side elevational view thereof;

 FIG. 6 is a rear elevational view thereof.

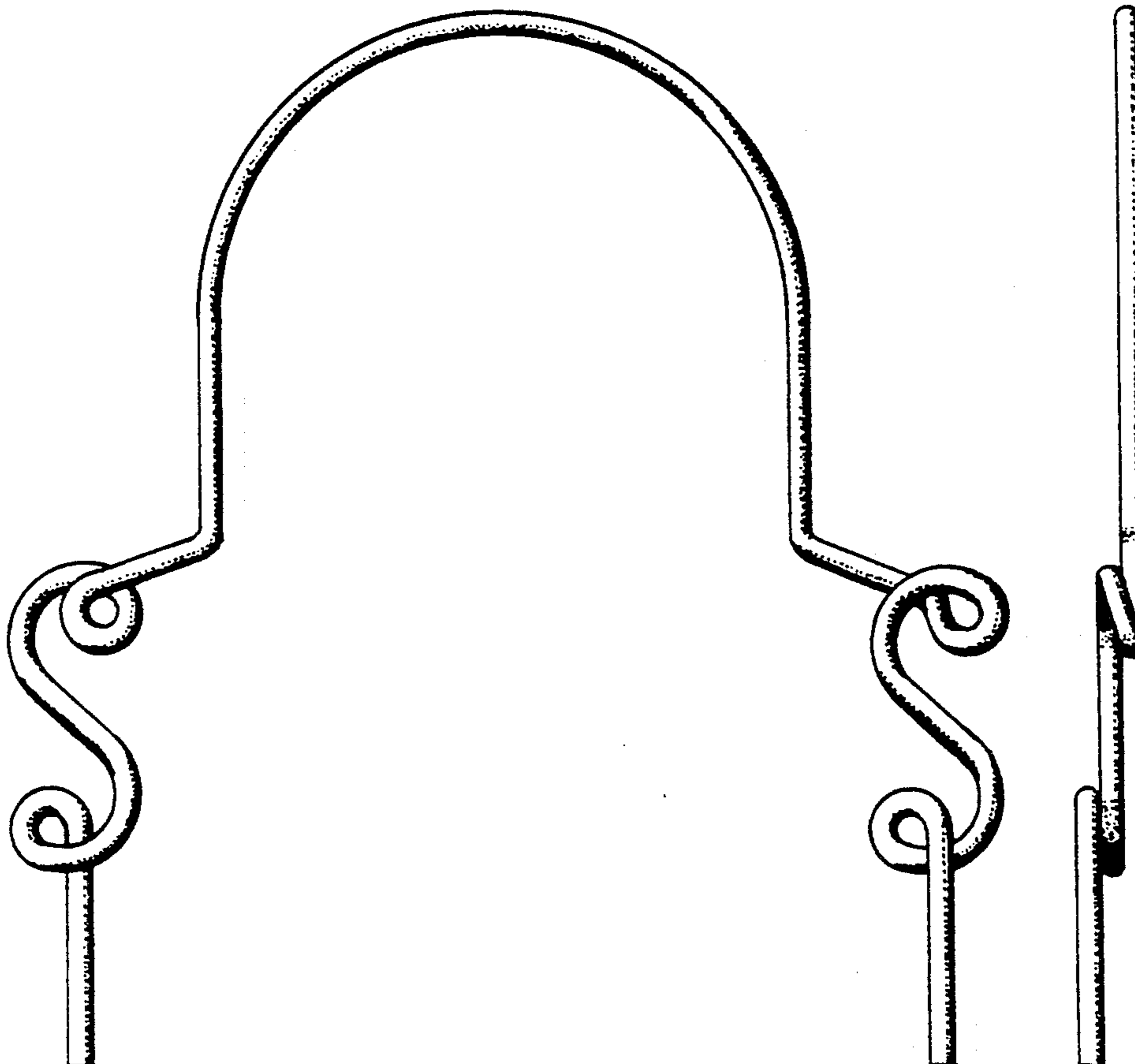

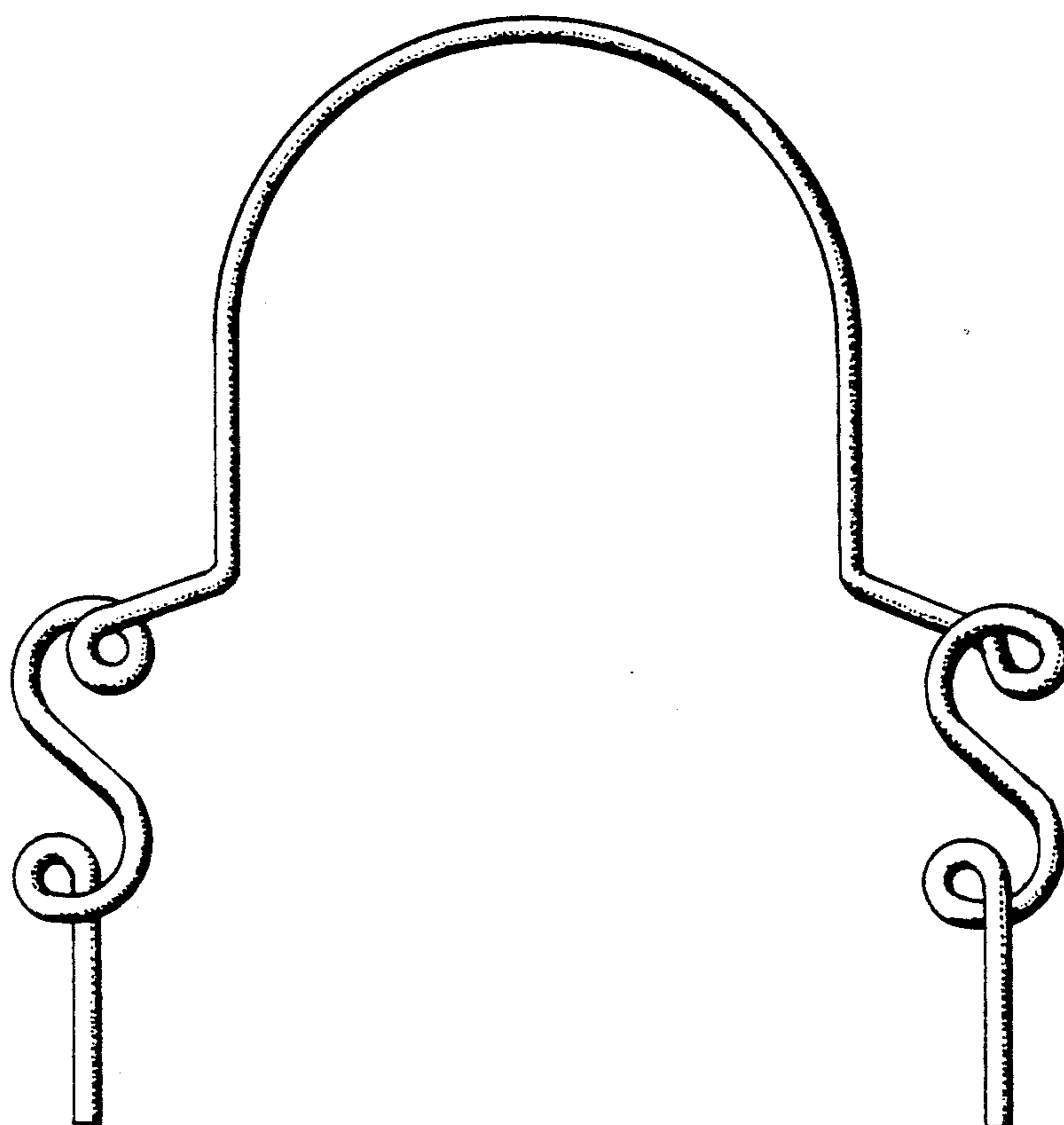
