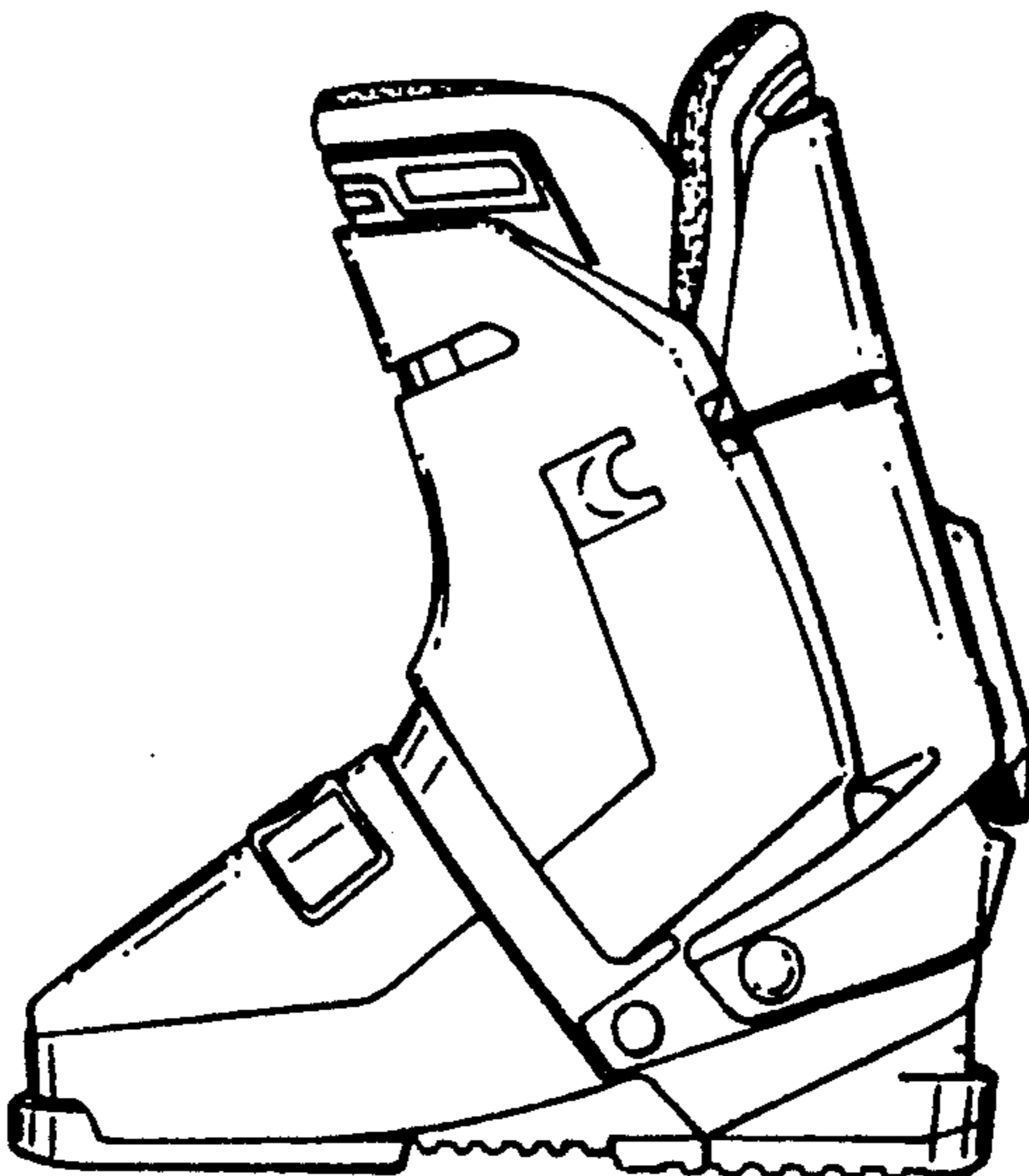

DESCRIPTION

FIG. 1 is a left side elevational view of a ski boot showing our new design;
FIG. 2 is a right side elevational view thereof;
FIG. 3 is a front end elevational view thereof;
FIG. 4 is a rear end elevational view thereof;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a bottom plan view thereof.



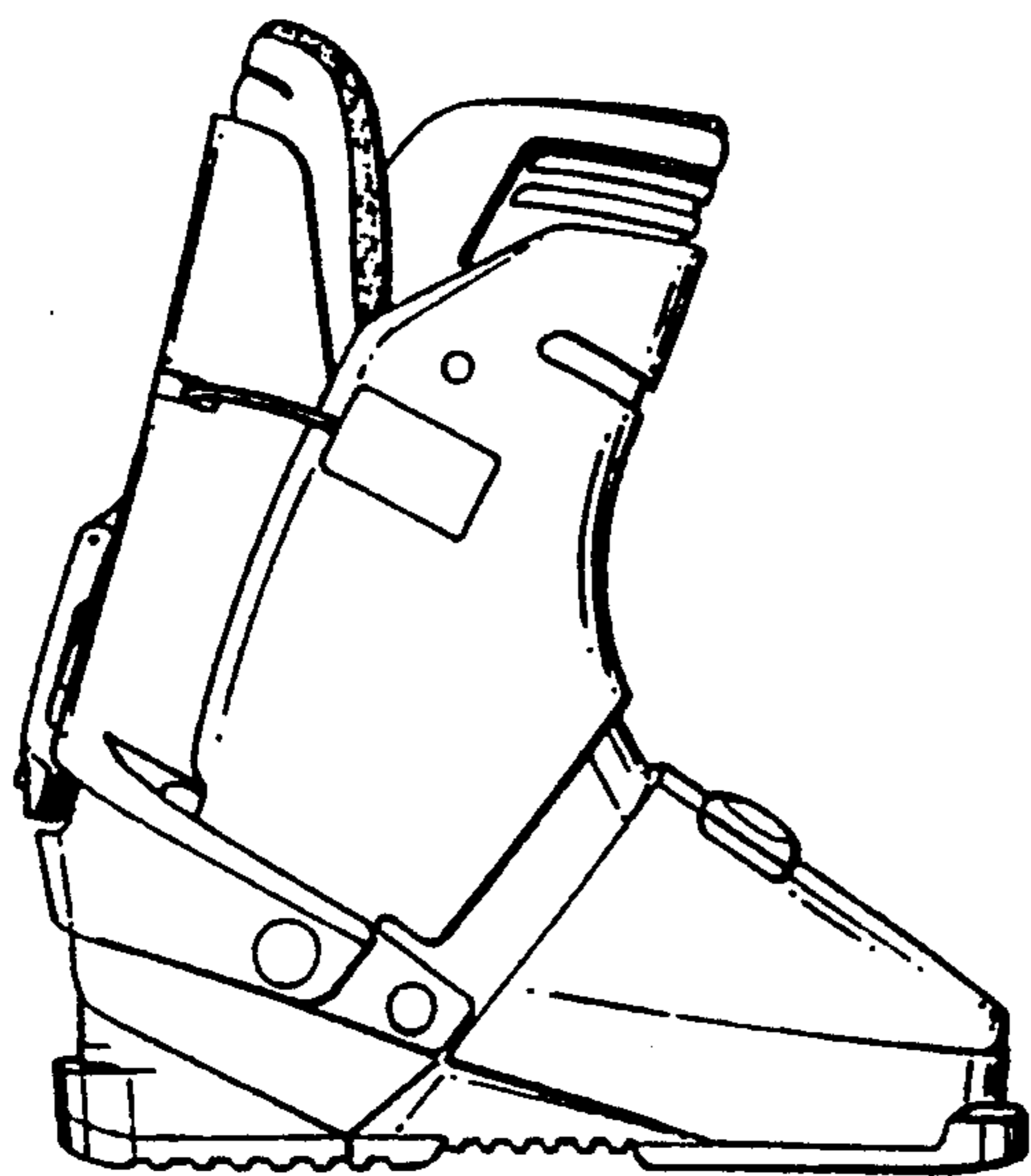

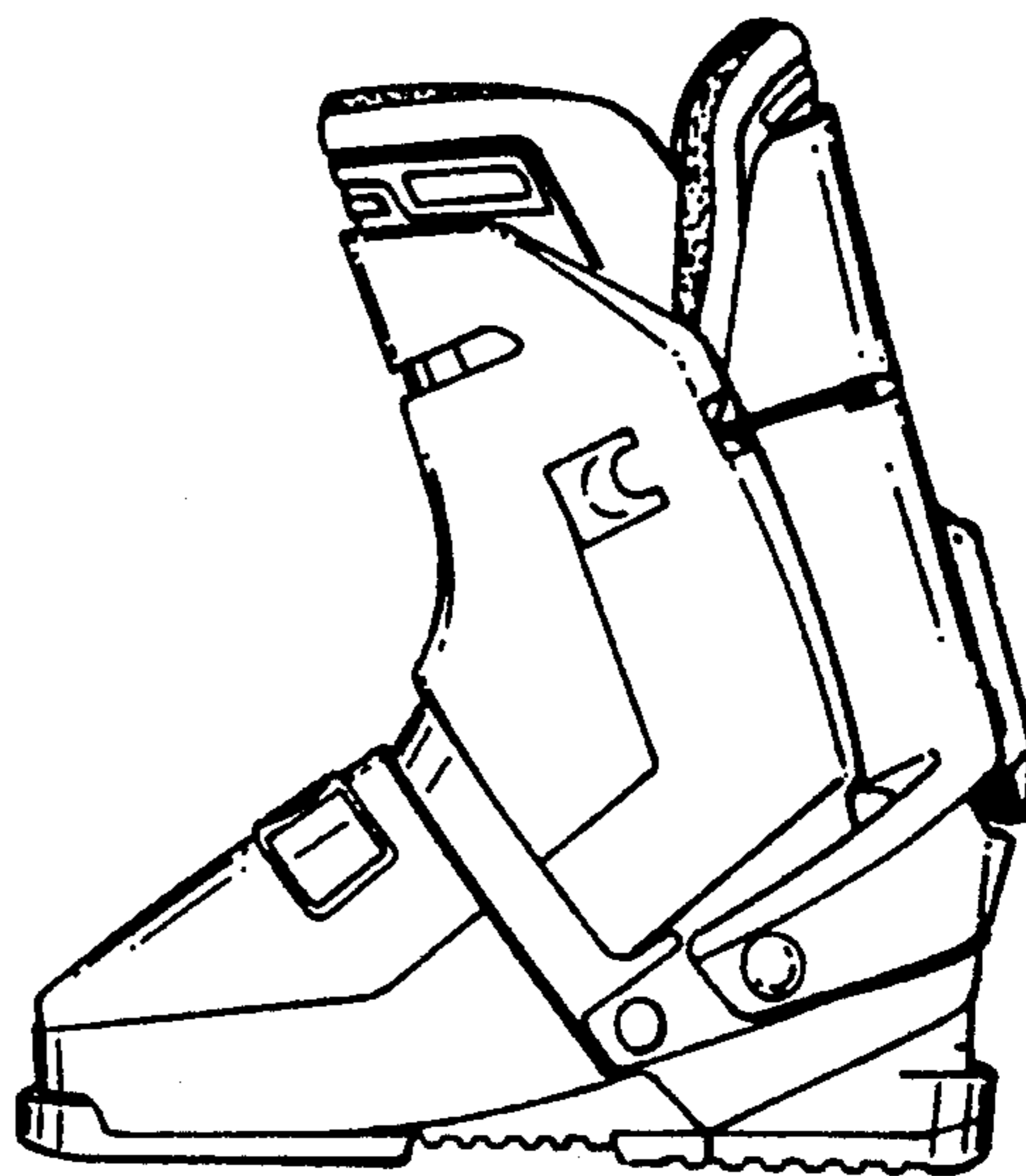

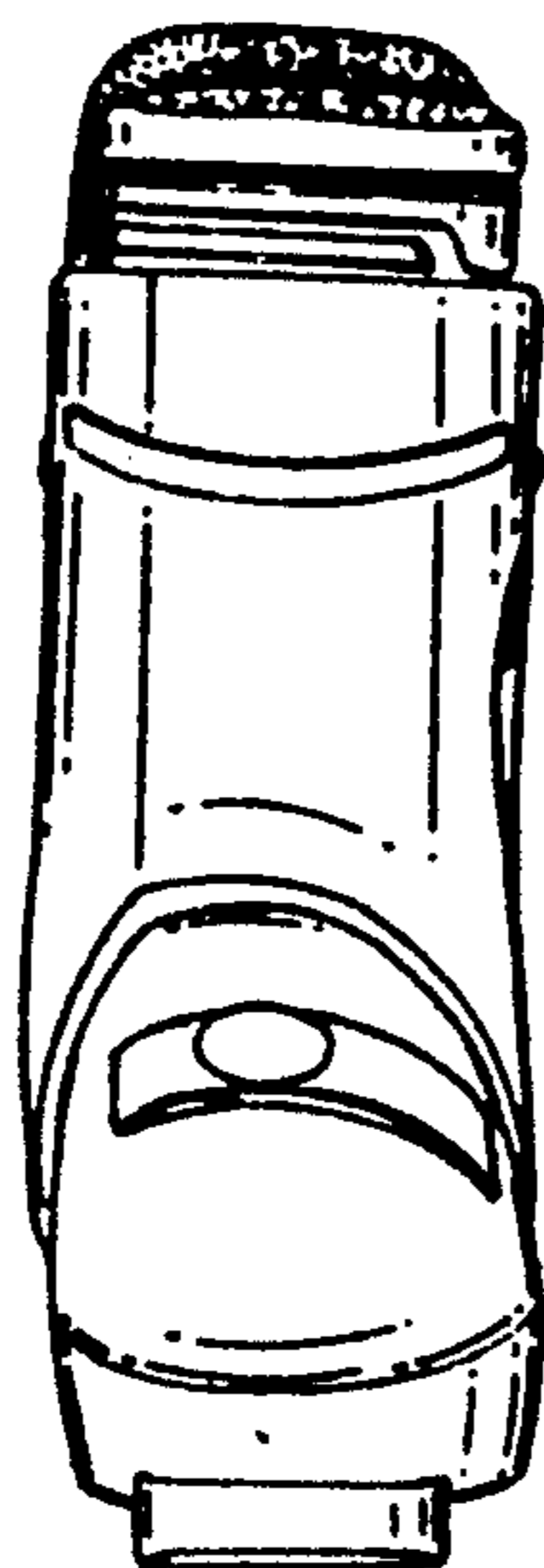

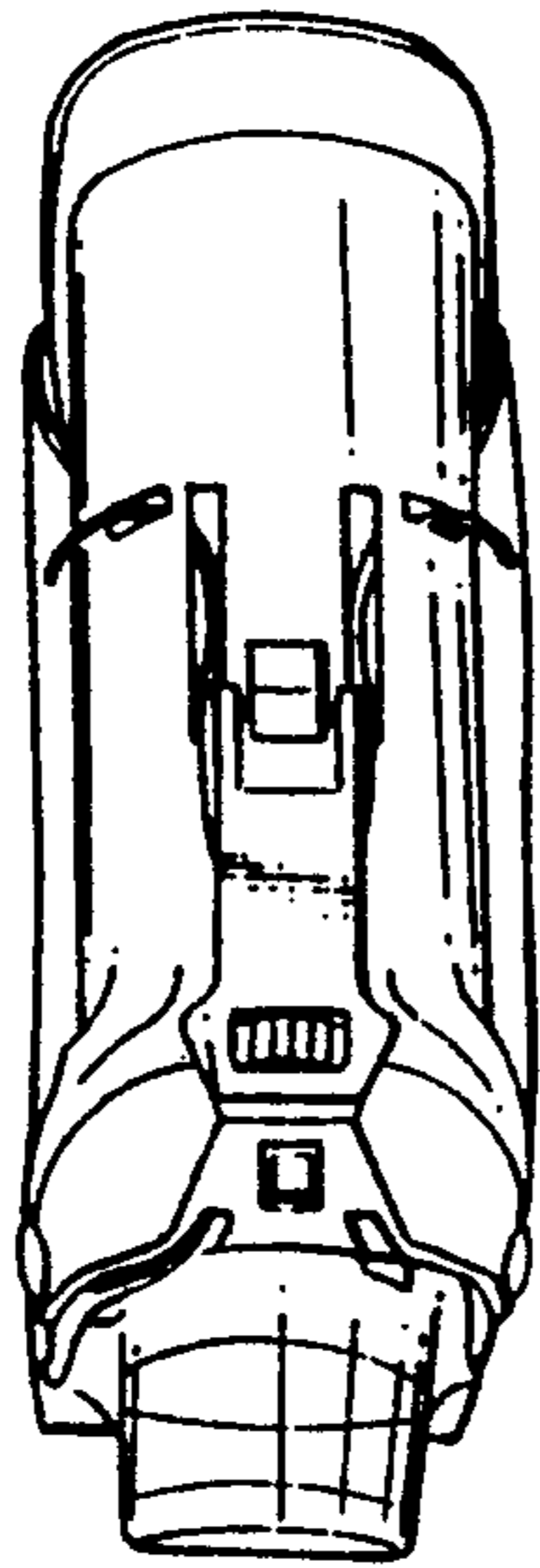

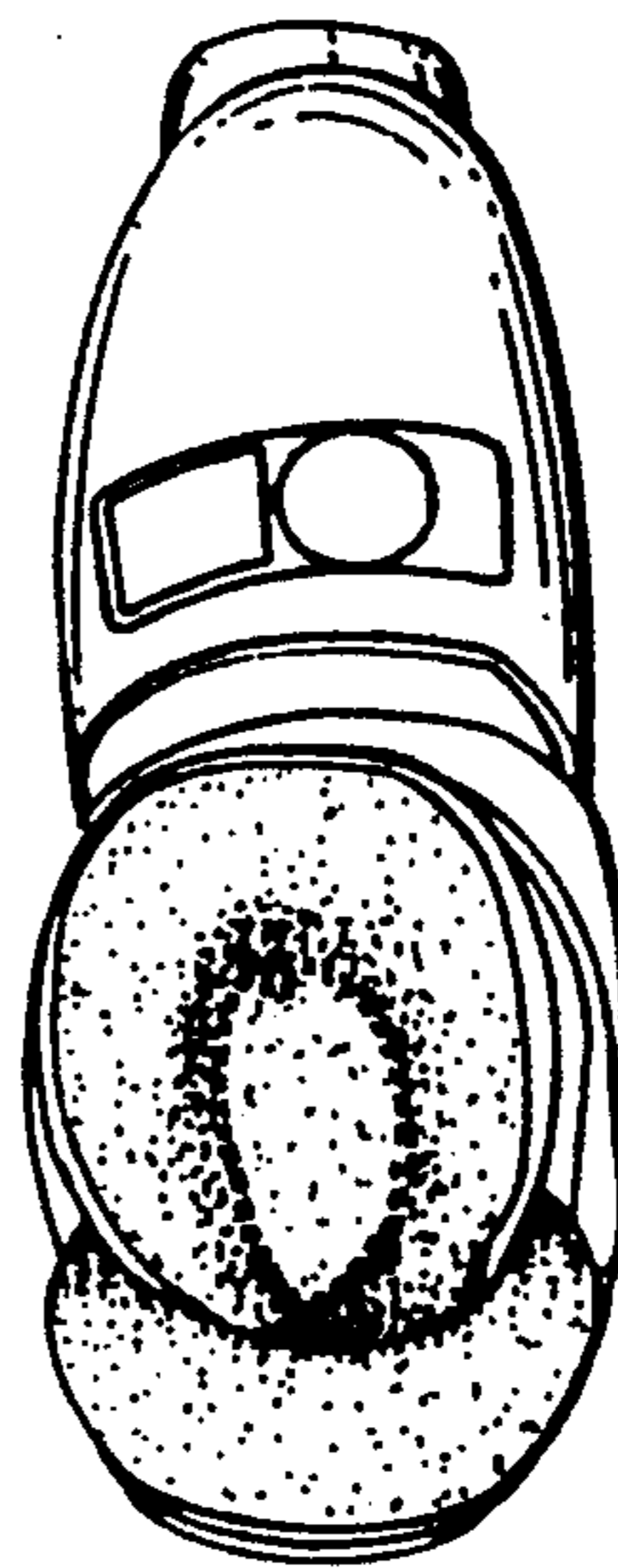
