The ornamental design for a cigarette lighter, as shown and described.

DESCRIPTION

FIG. 9 is a perspective view thereof.

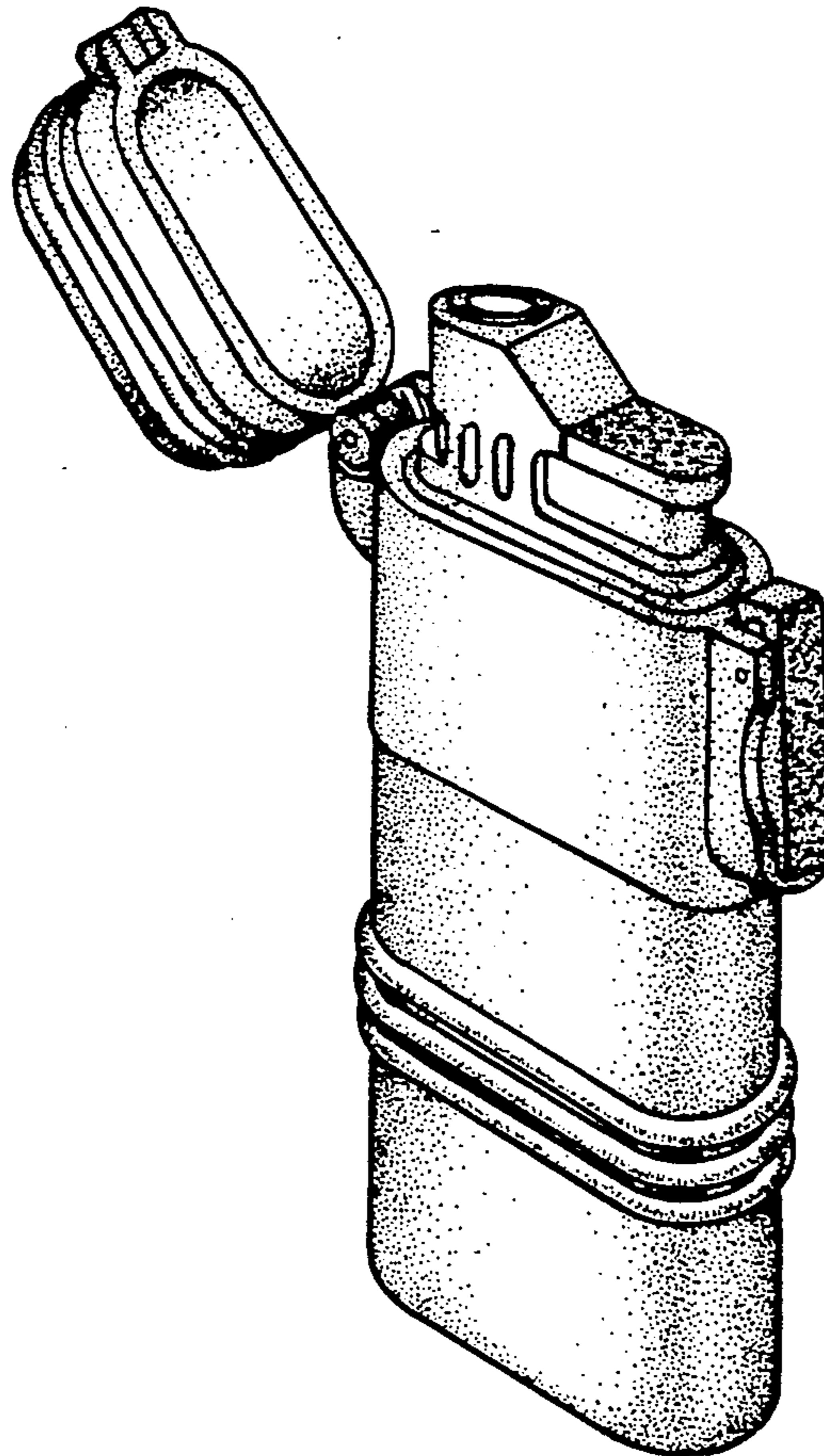

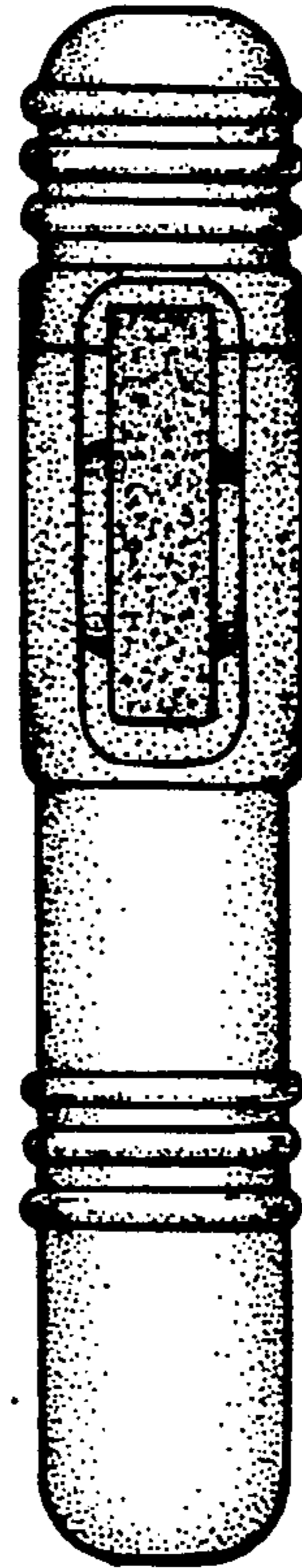
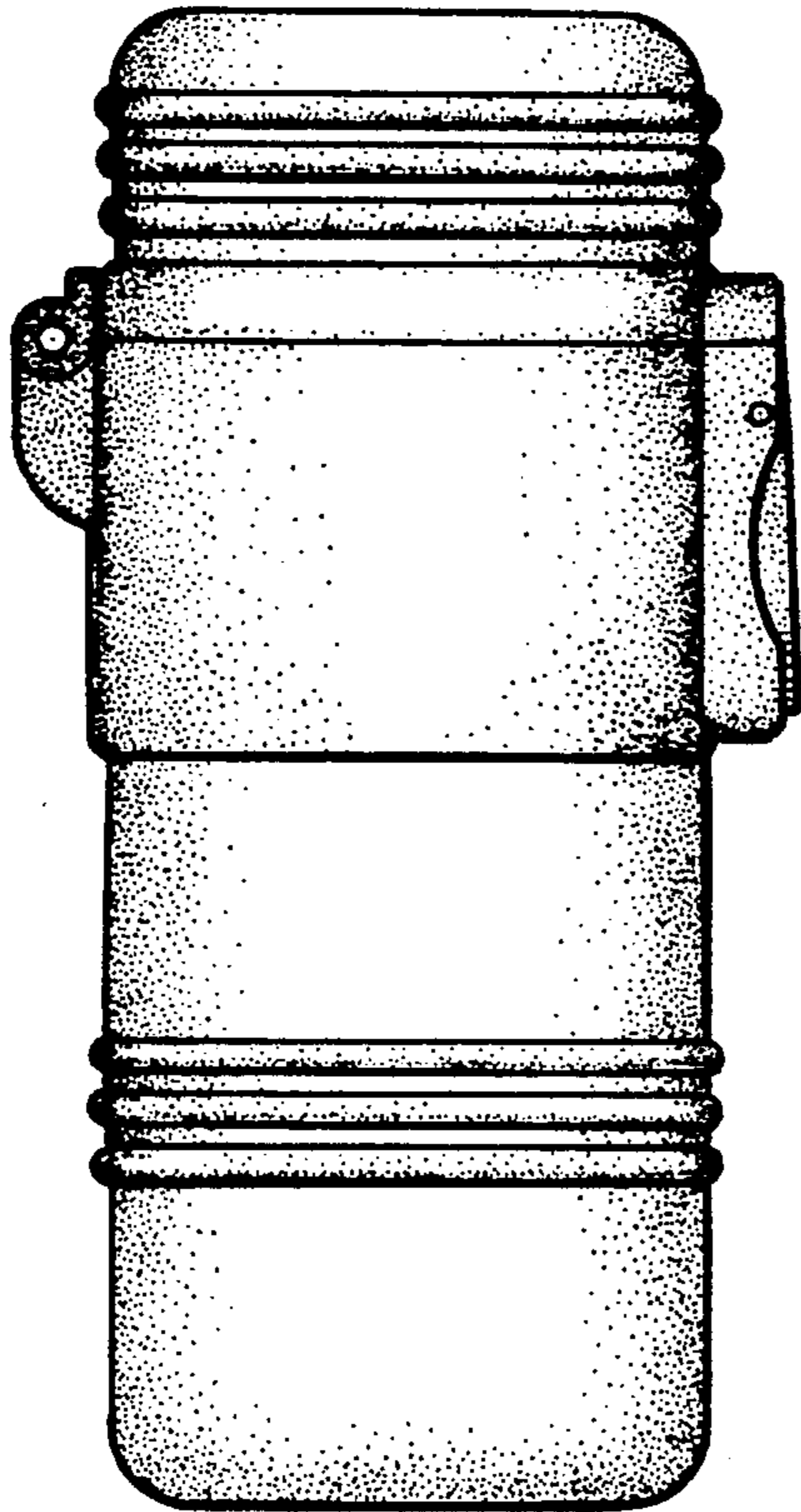

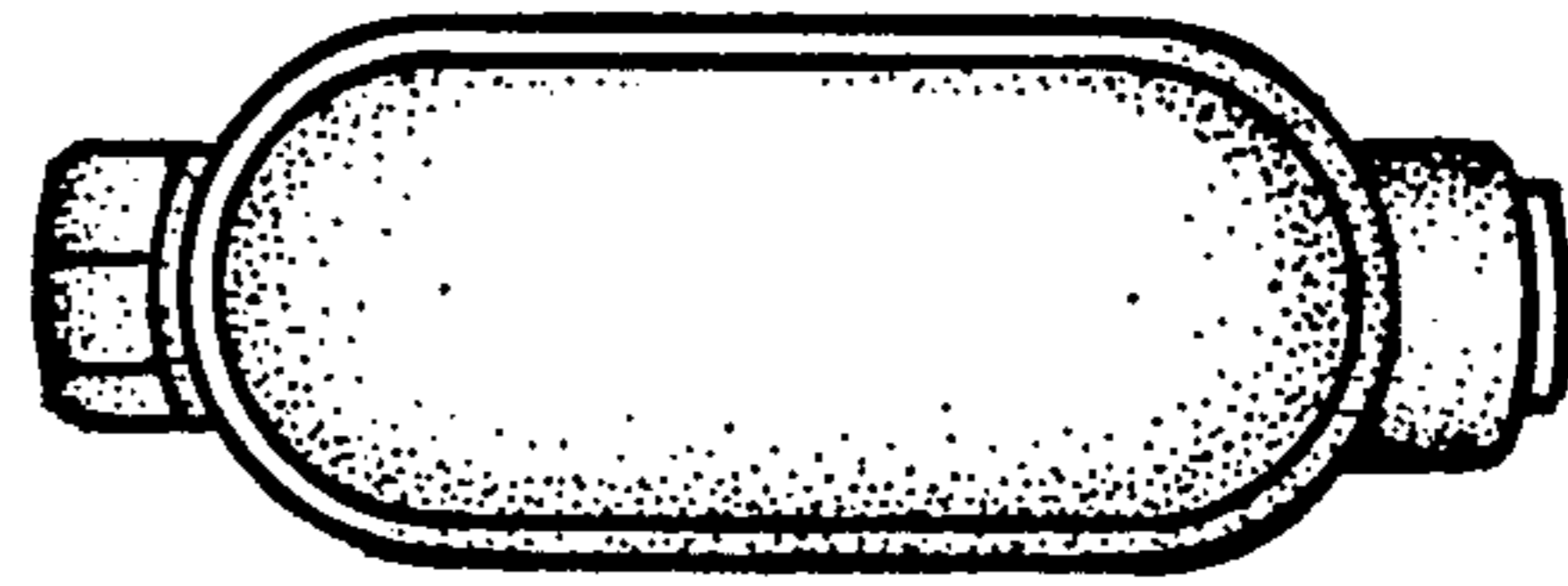
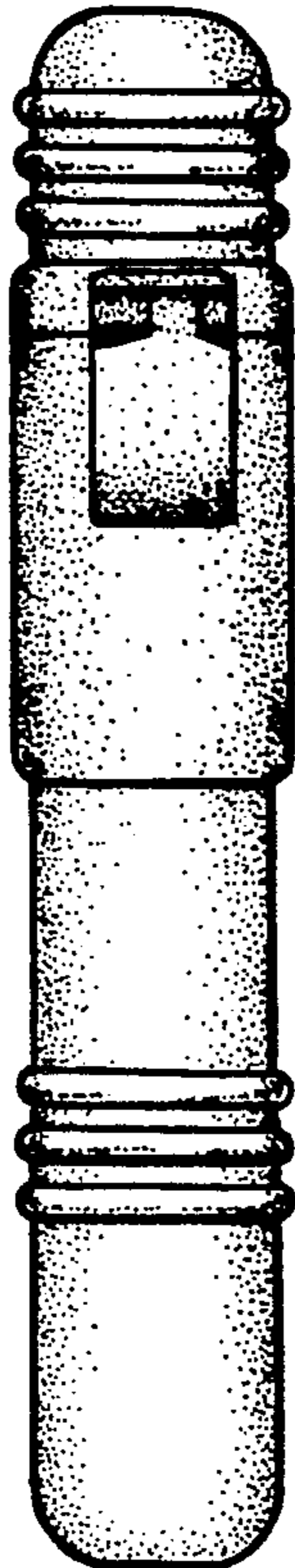

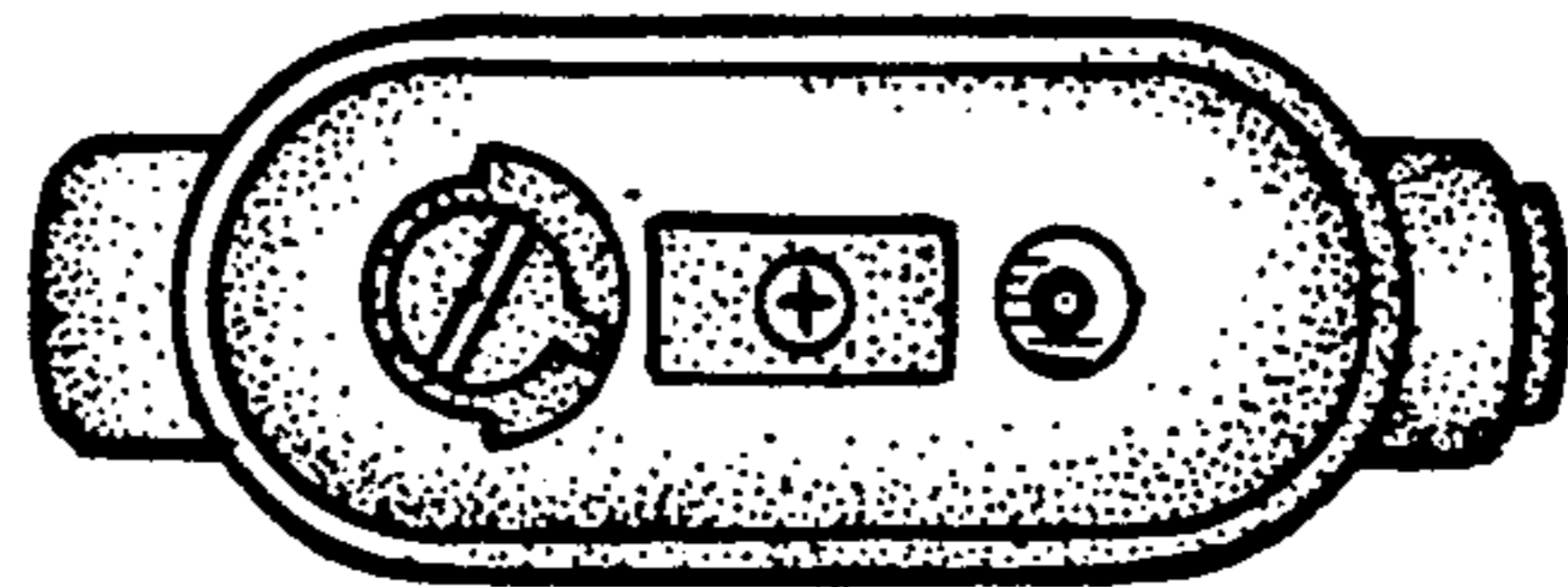

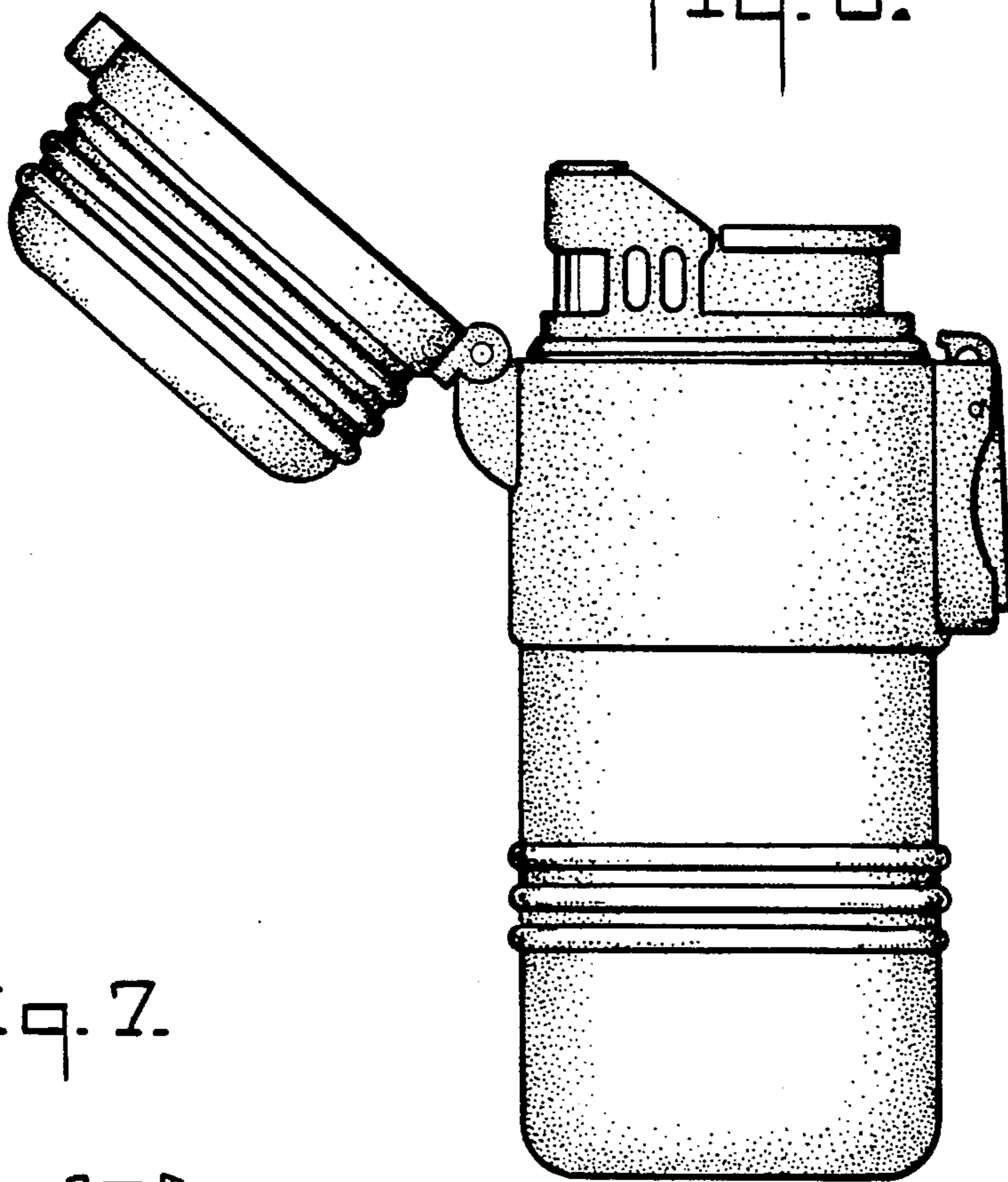

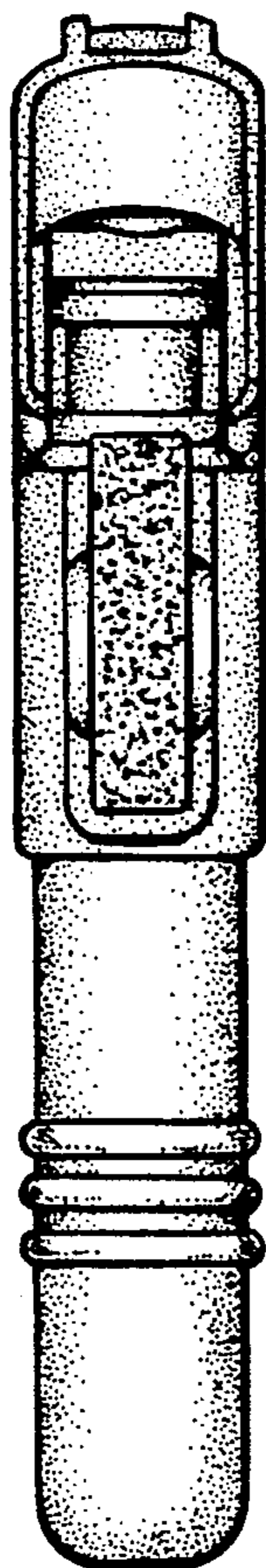
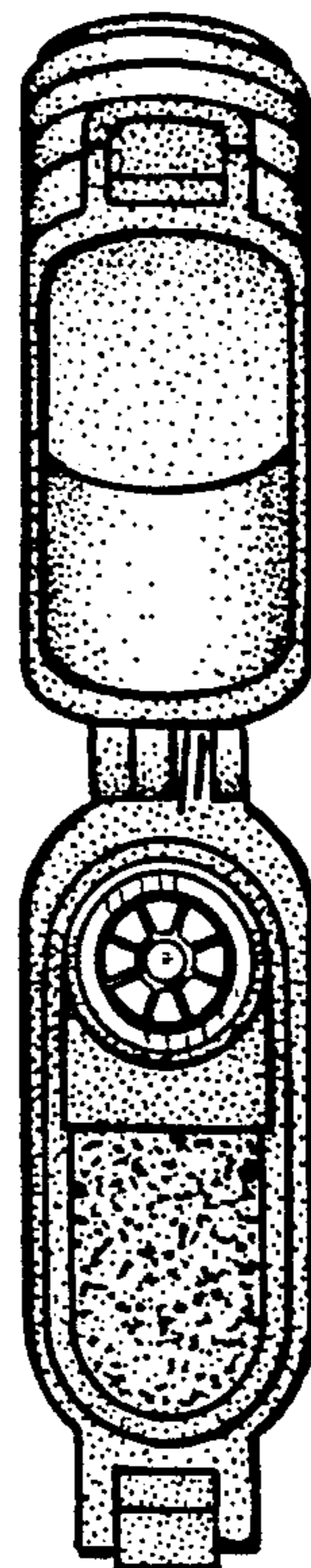

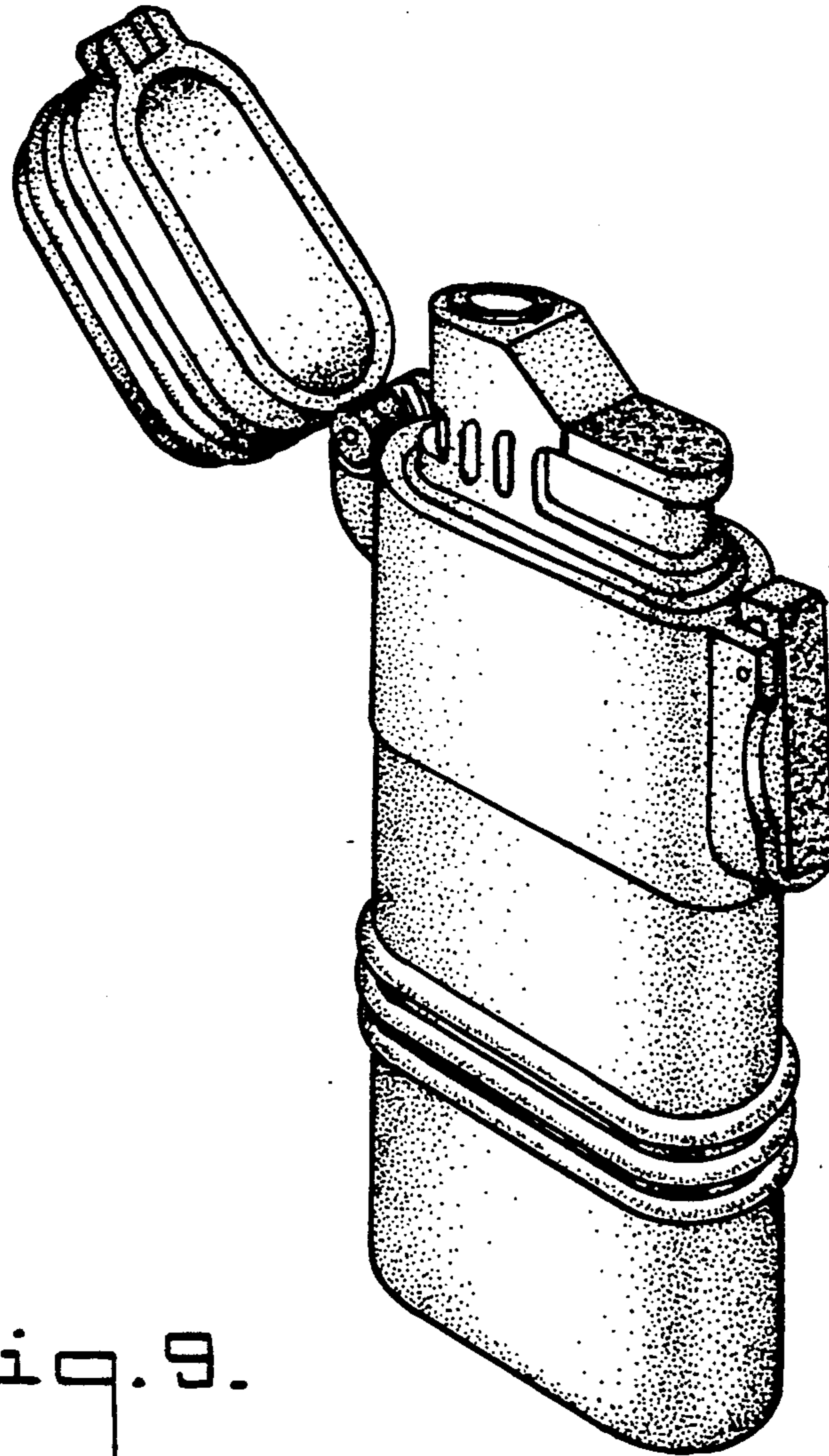
