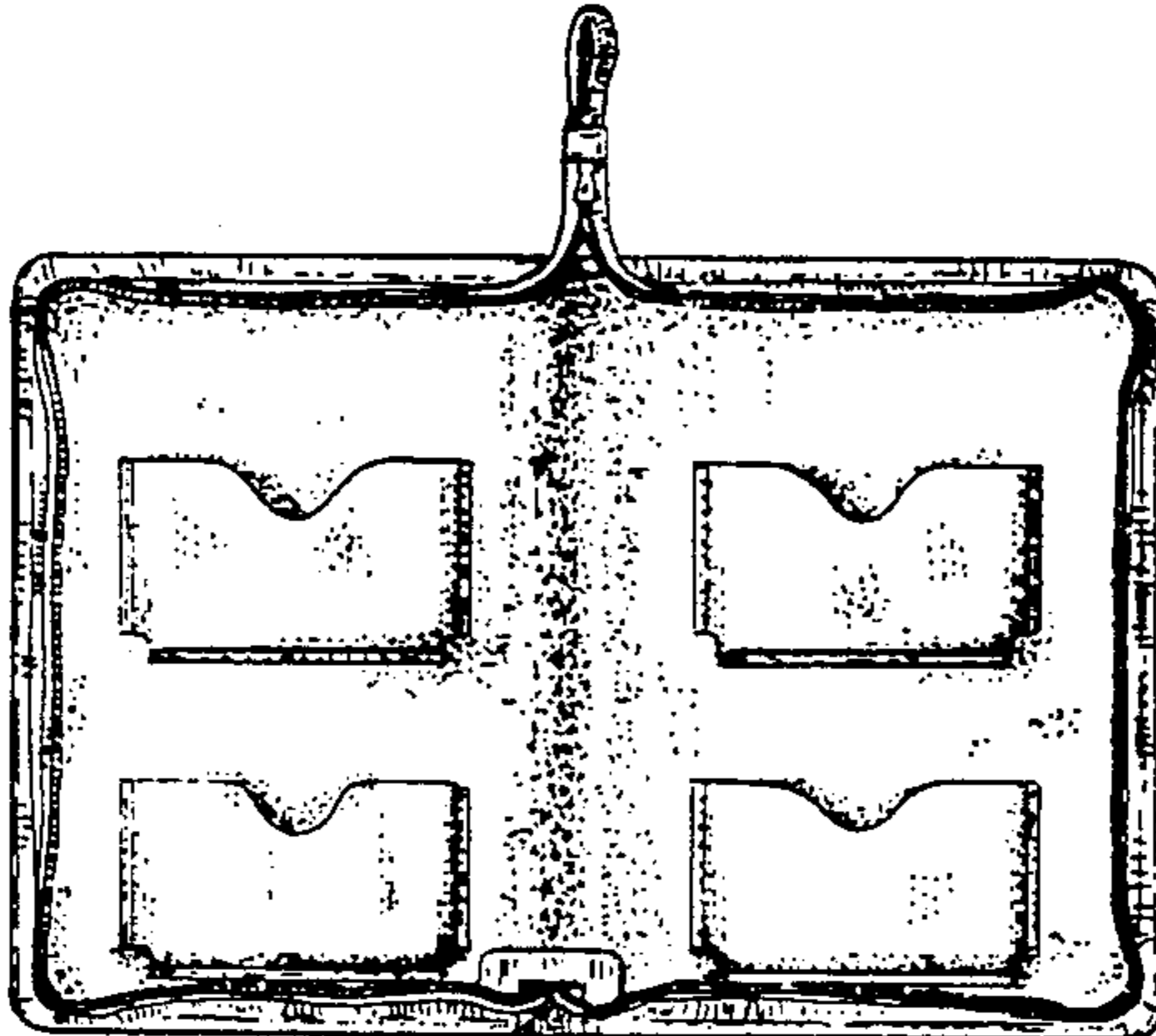
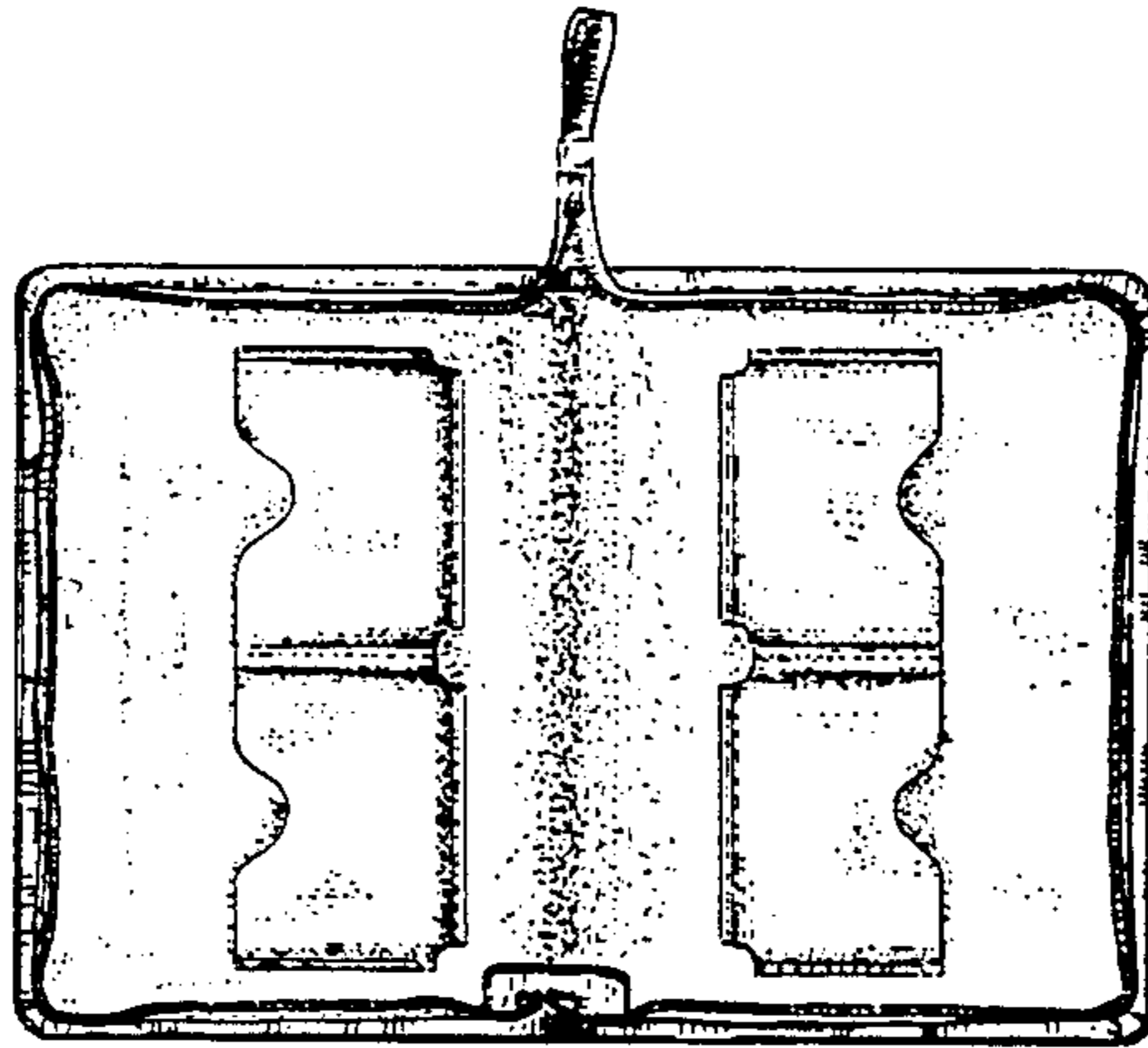

FIG. 6 is a front elevational view of an alternate embodiment of the design shown in FIG. 1.



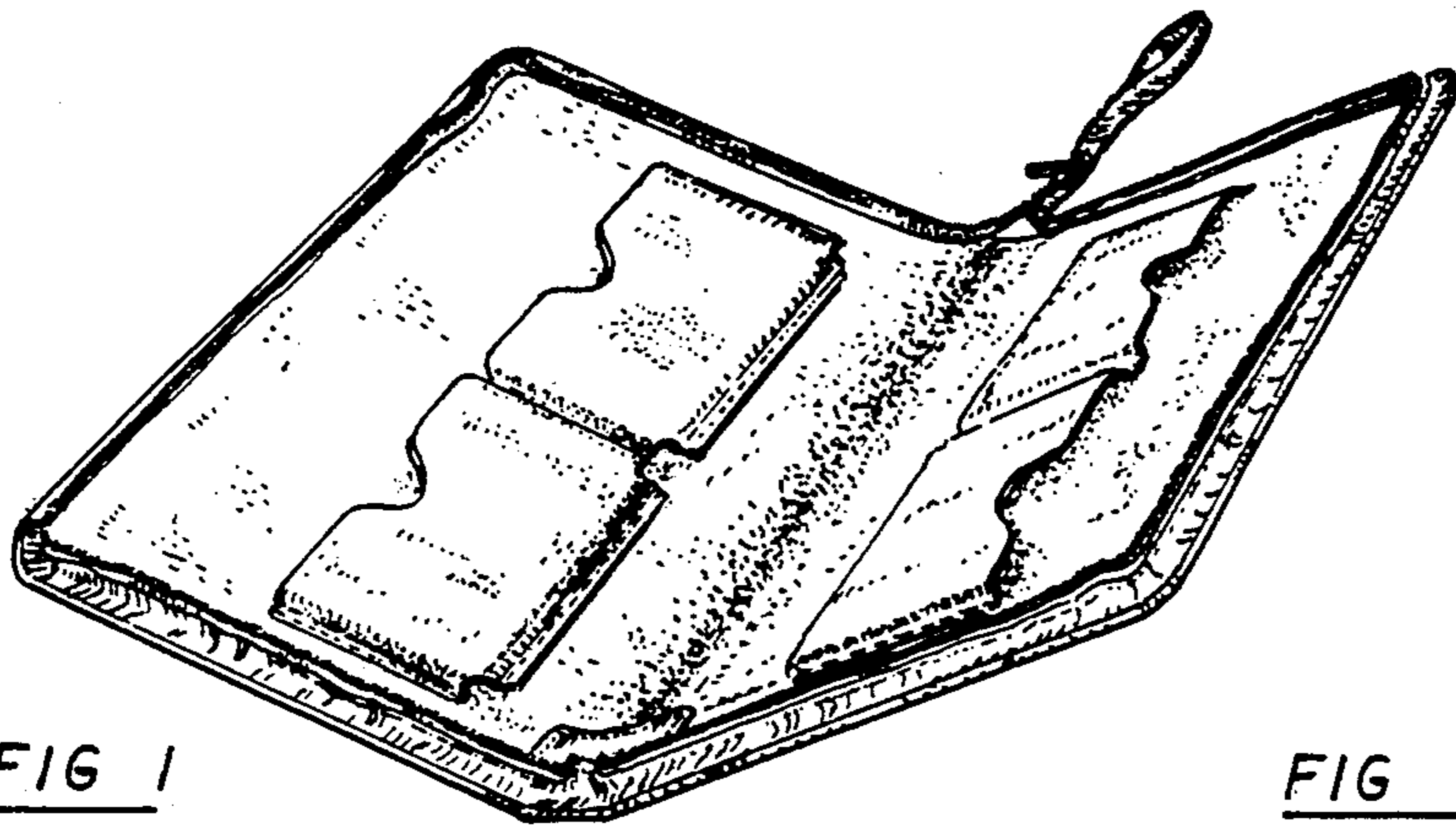

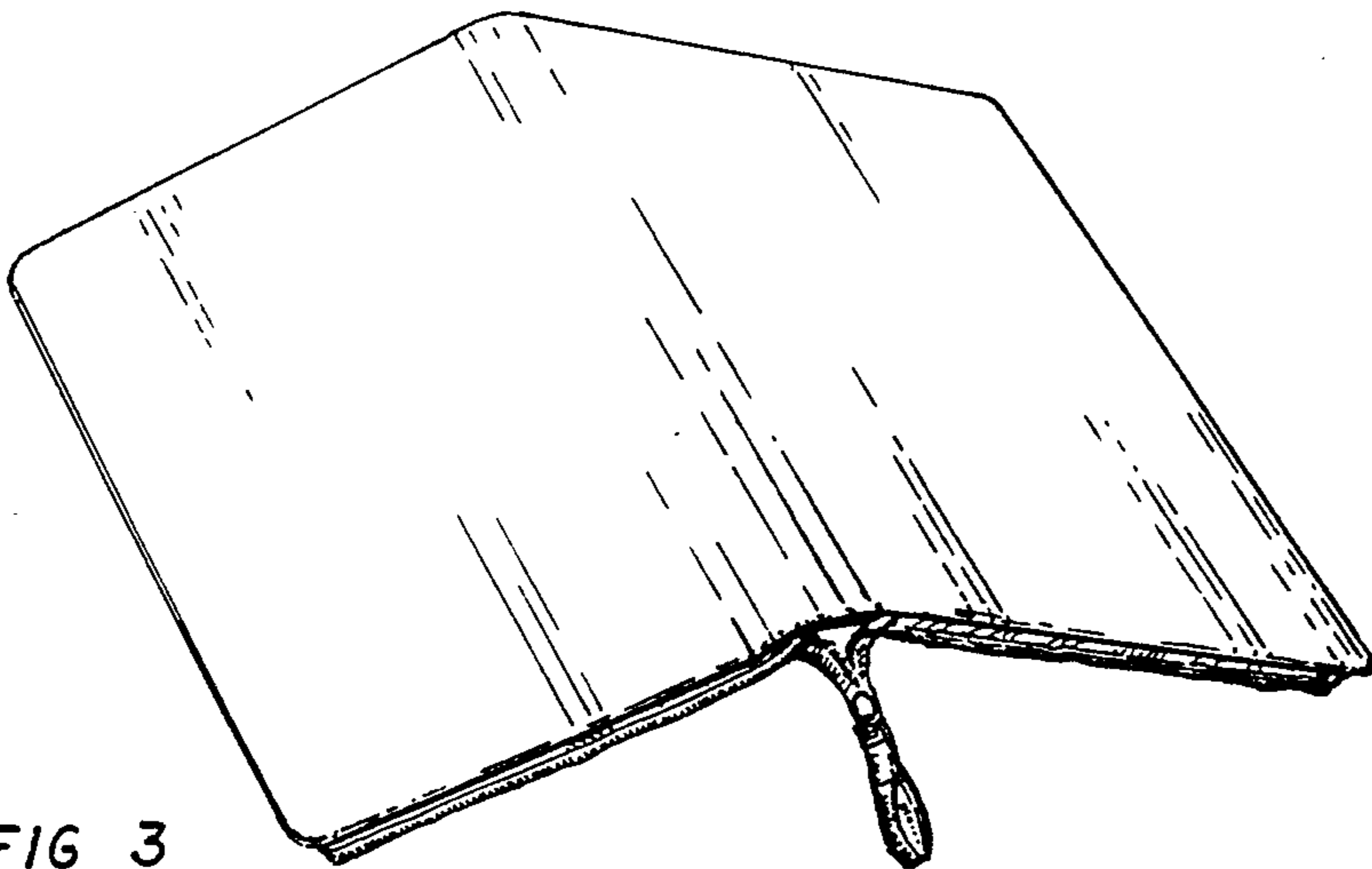

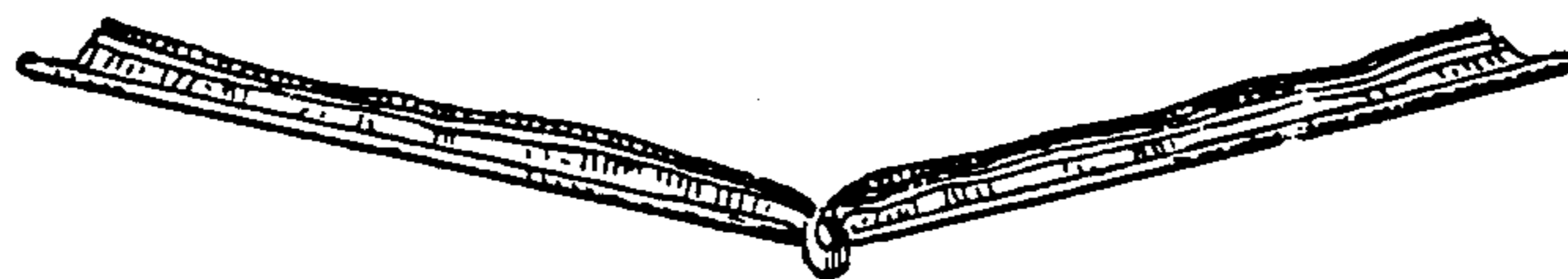

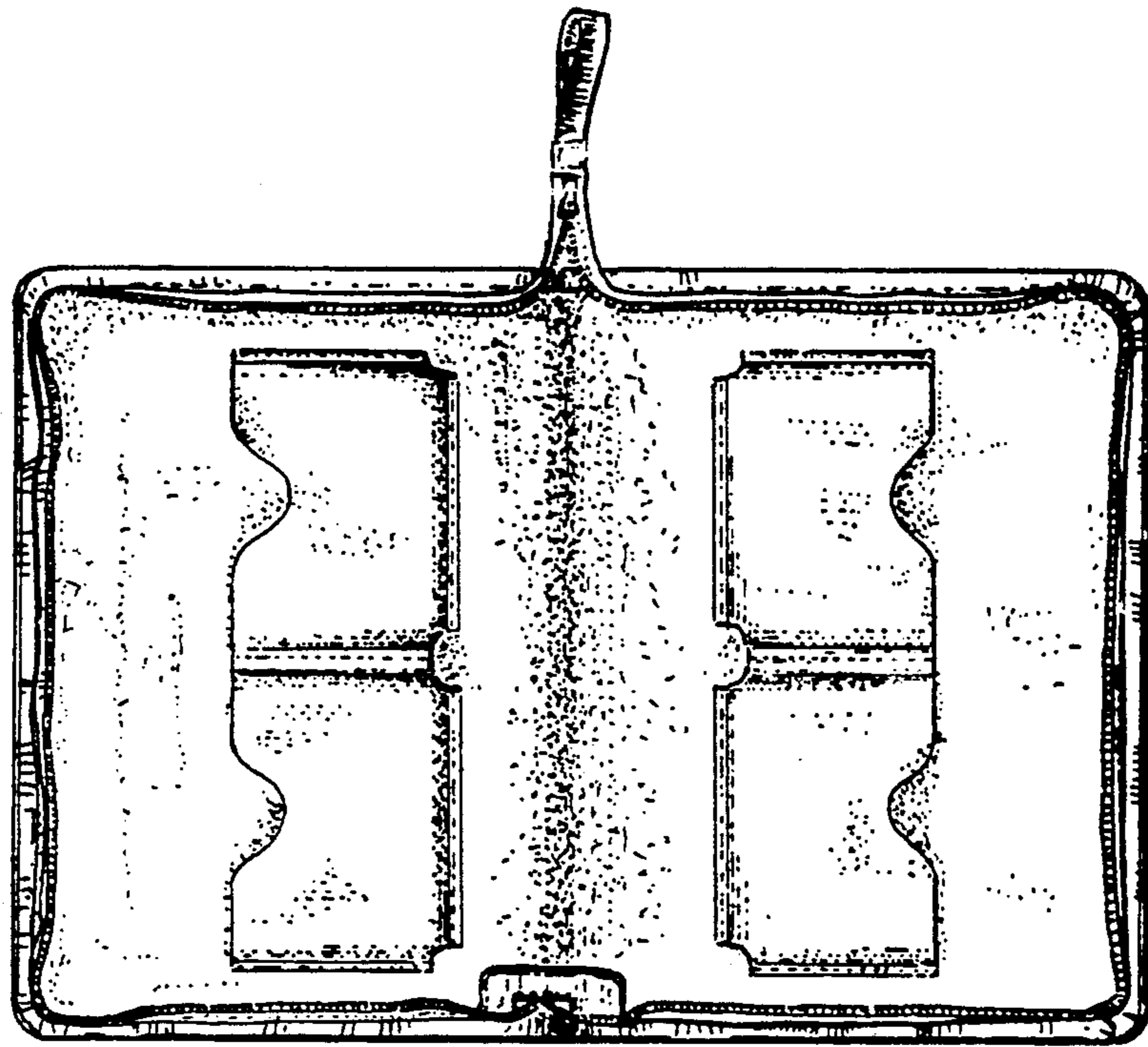

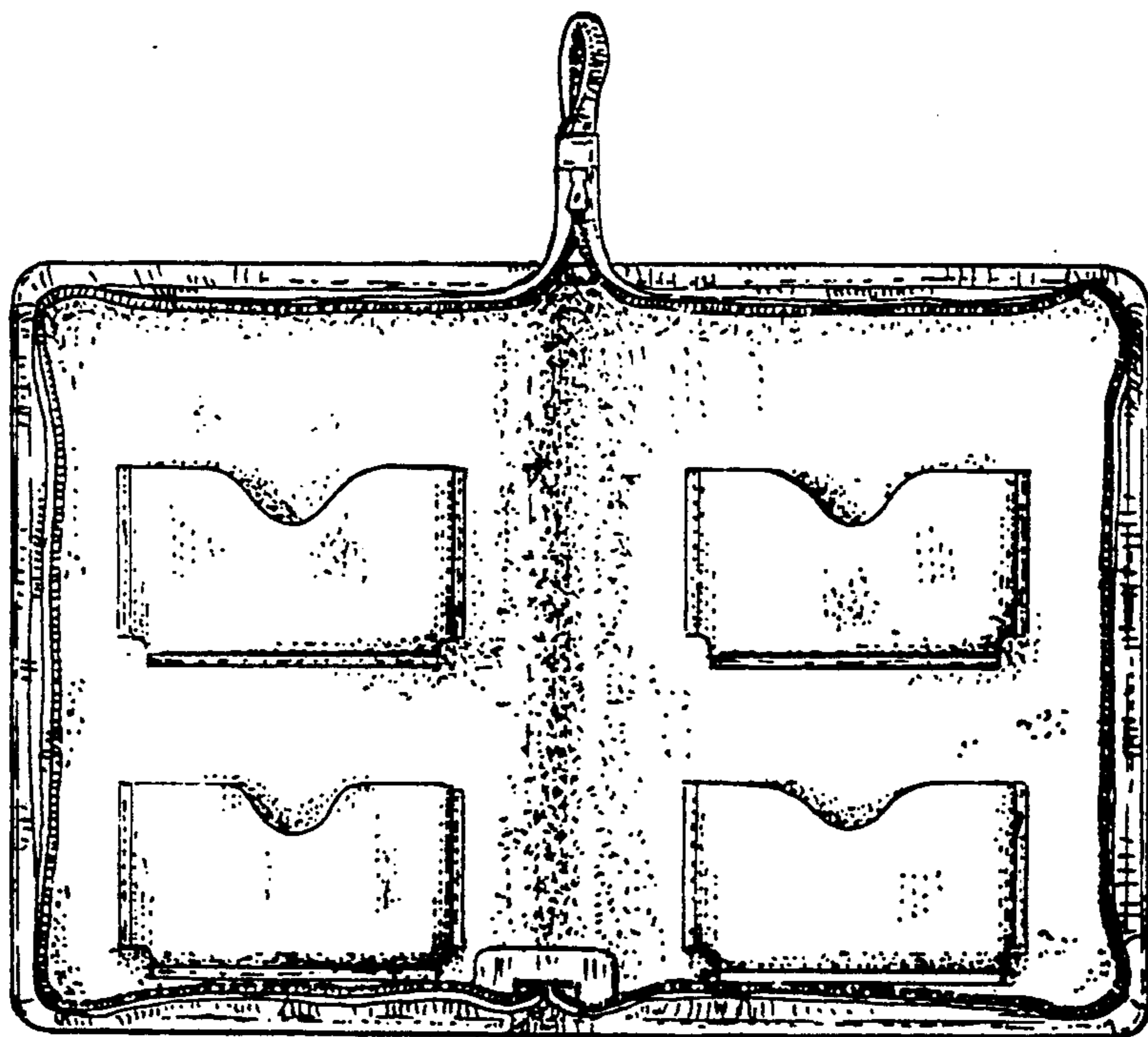
