The ornamental design for a container, as shown and described.

**DESCRIPTION**

FIG. 1 is an exploded perspective view of the right side of the container showing my new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a right side elevational view thereof; the opposite side being a mirror image thereof;  
FIG. 4 is a front elevational view thereof;  
FIG. 5 is a bottom plan view thereof;  
FIG. 6 is a rear elevational view thereof;  
FIG. 7 is a sectional elevational view thereof; taken along line 7—7 of FIG. 6; and,  
FIG. 8 is a right side perspective view thereof.

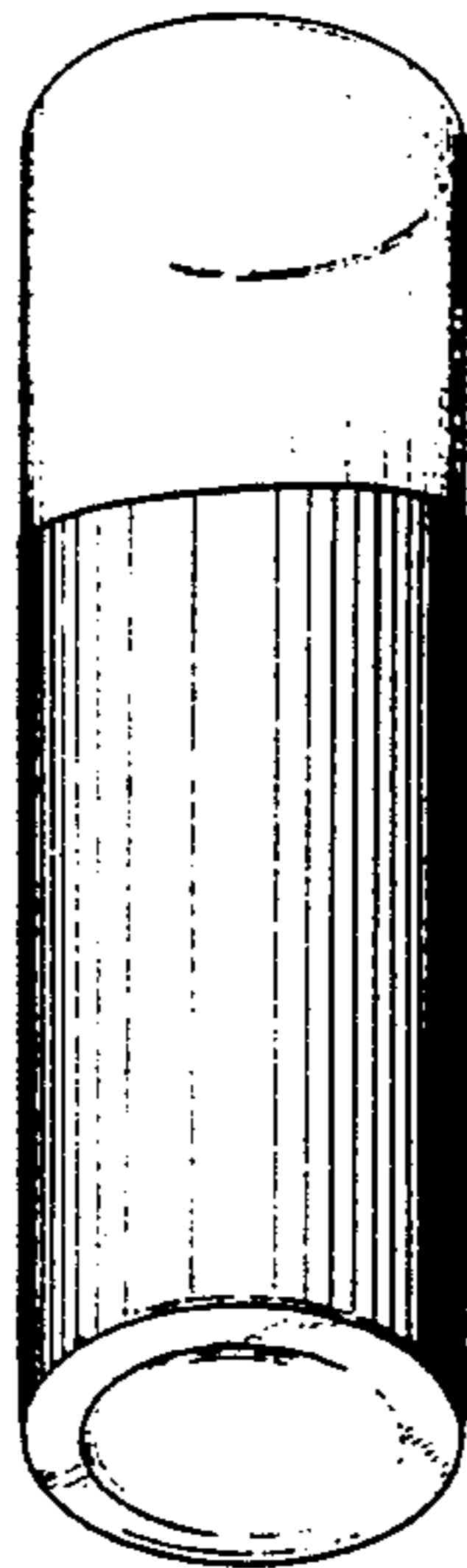
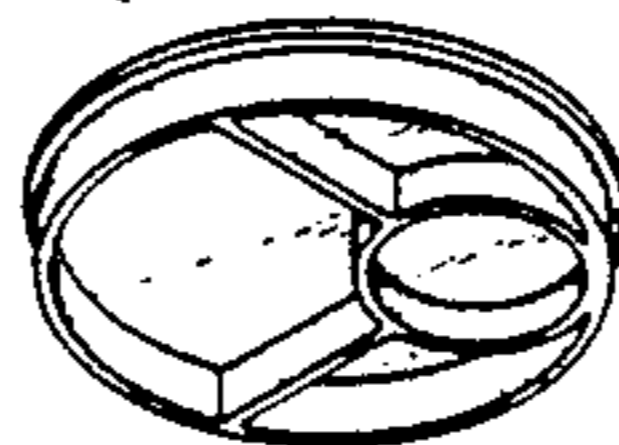

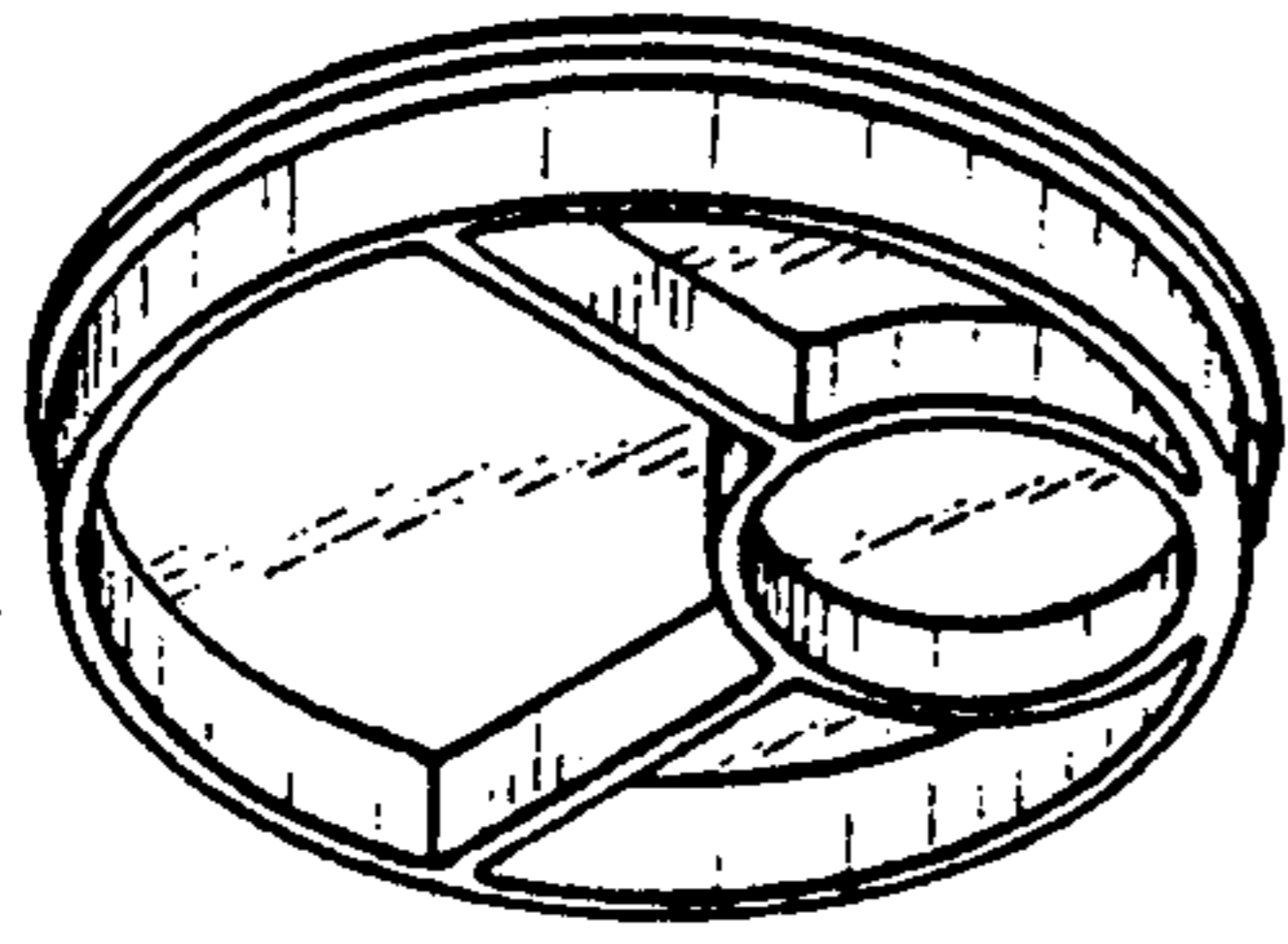

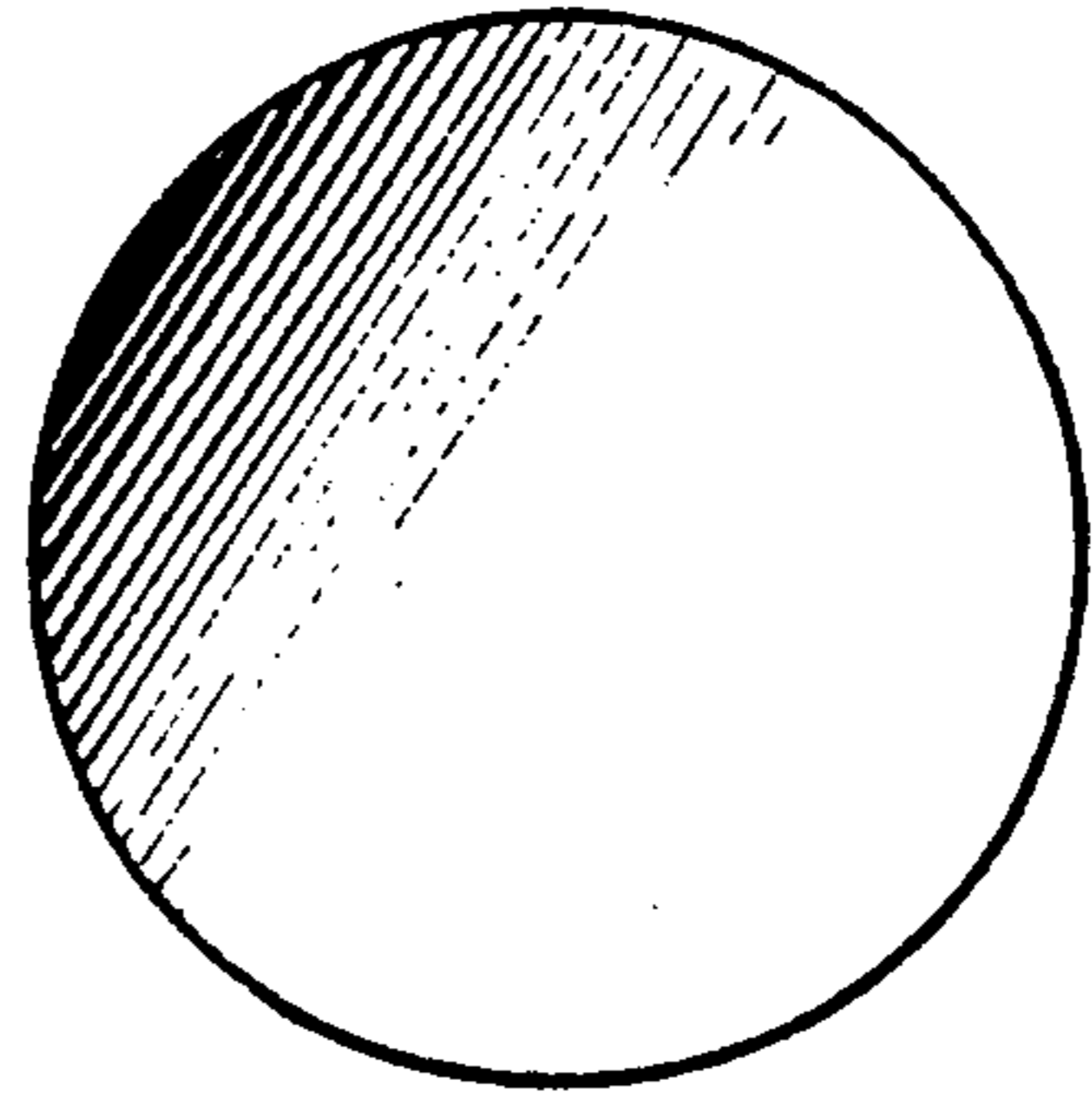

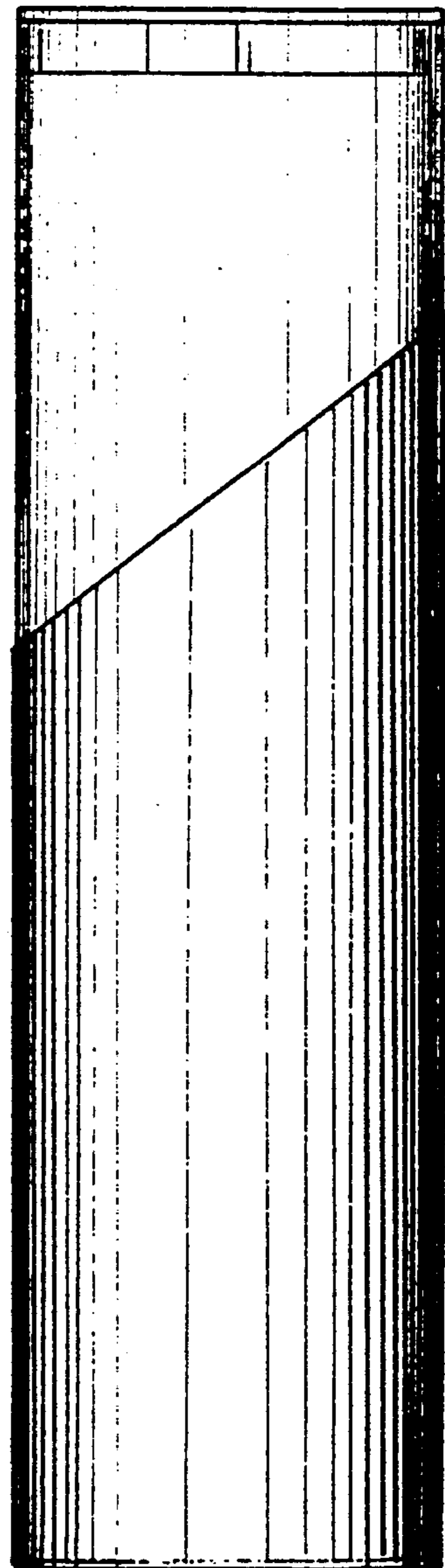
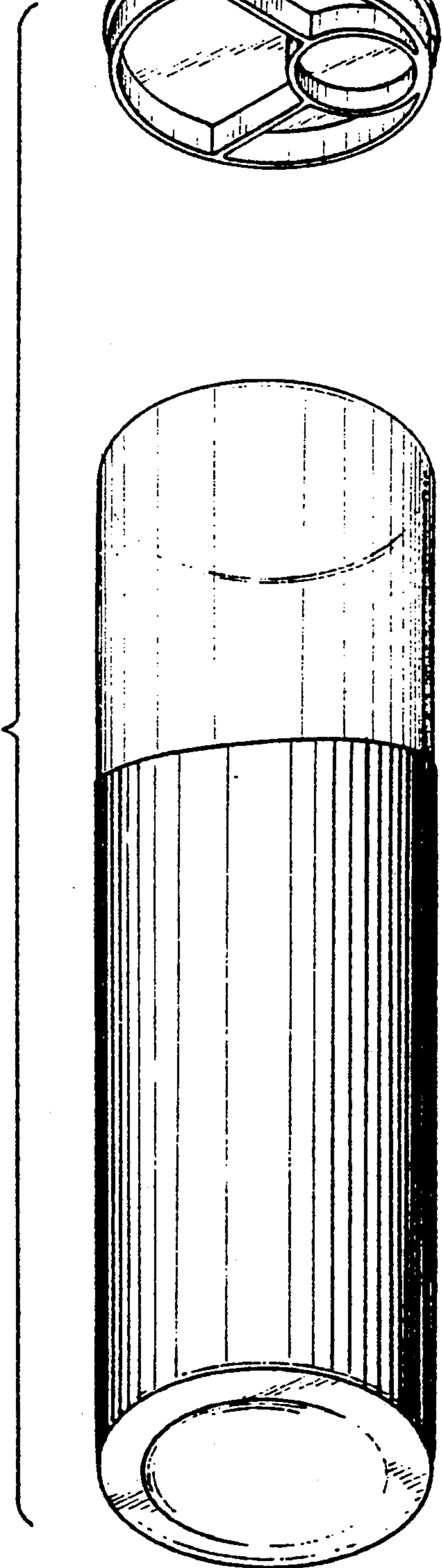

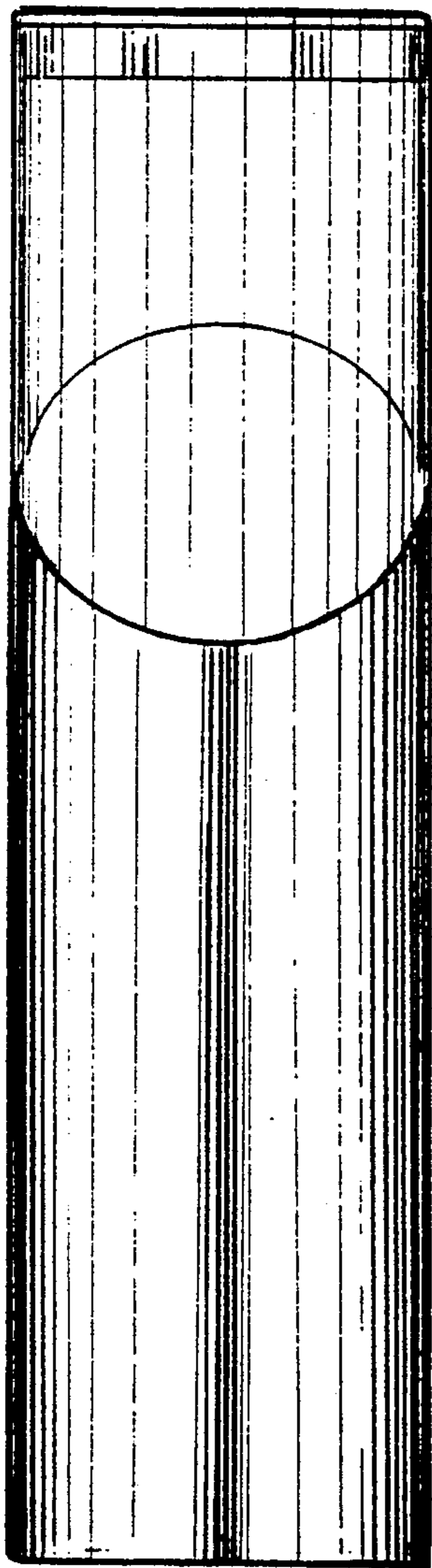

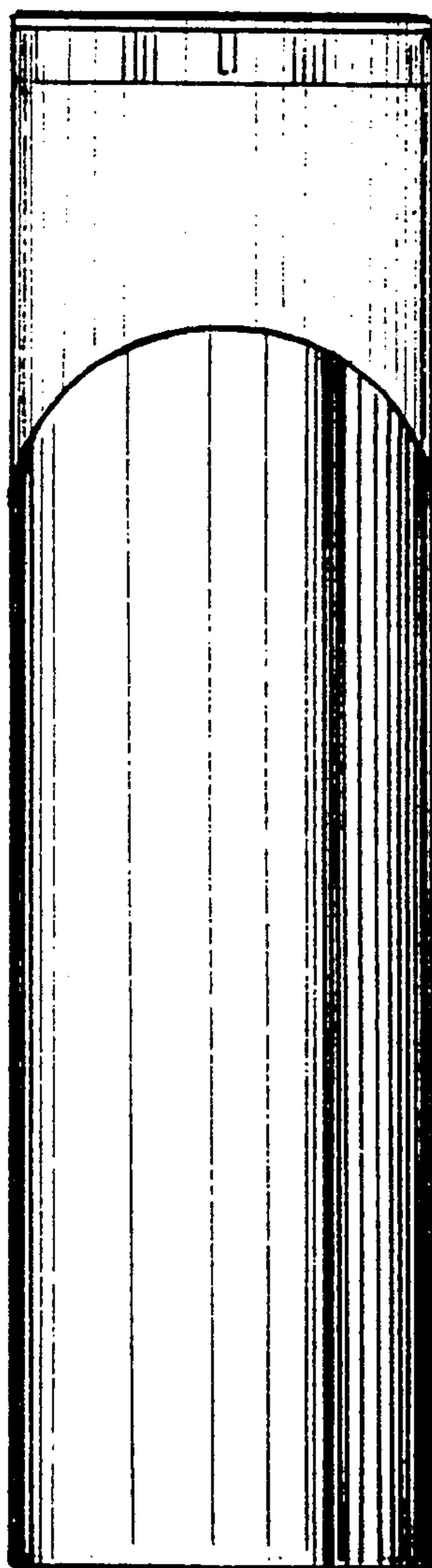

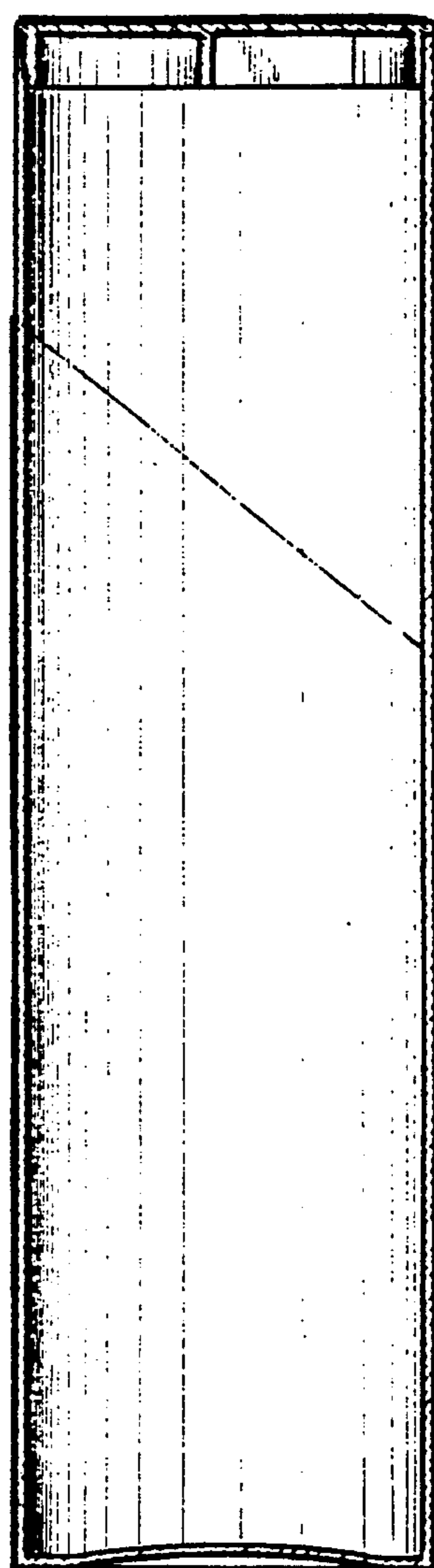
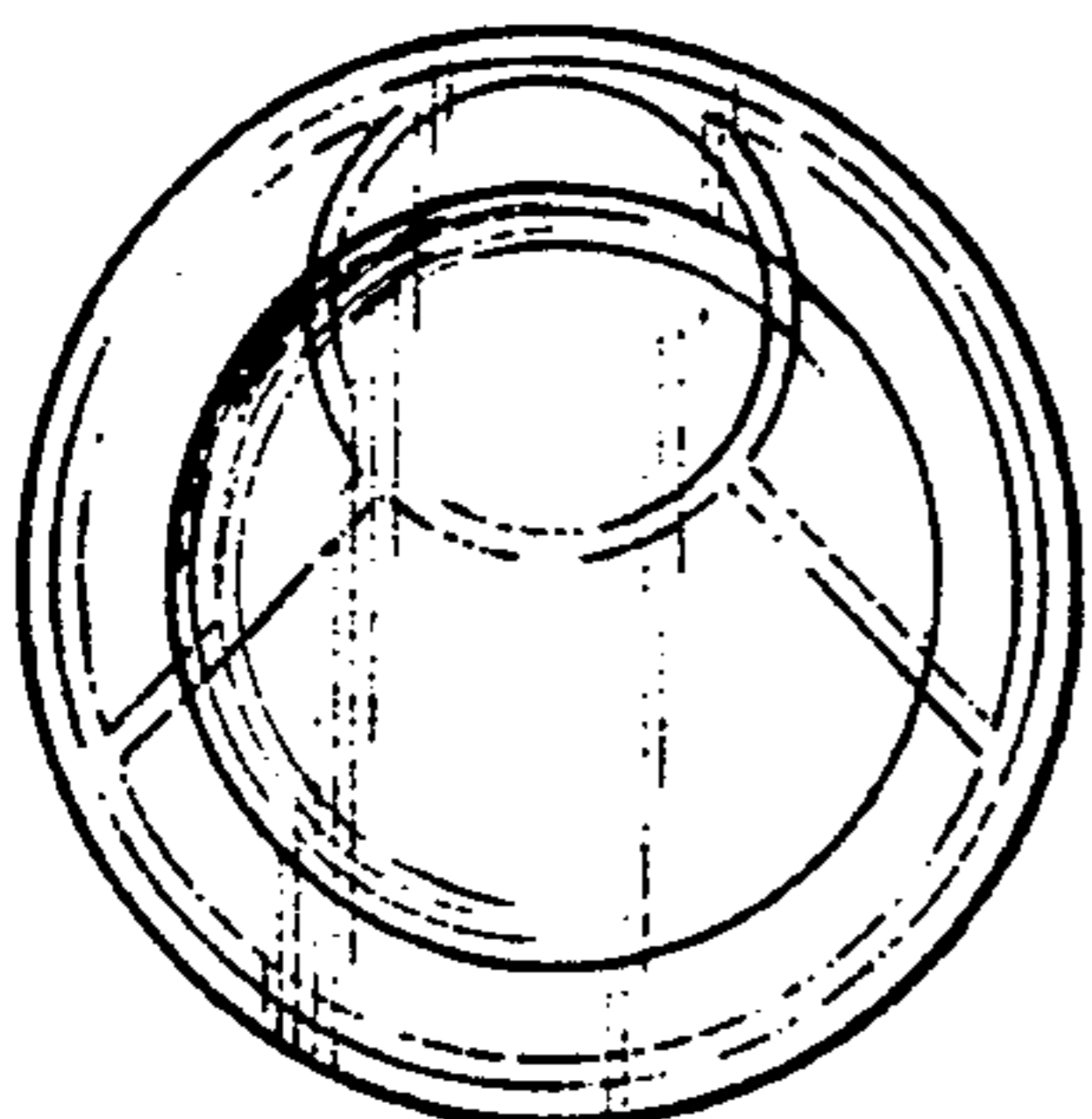
