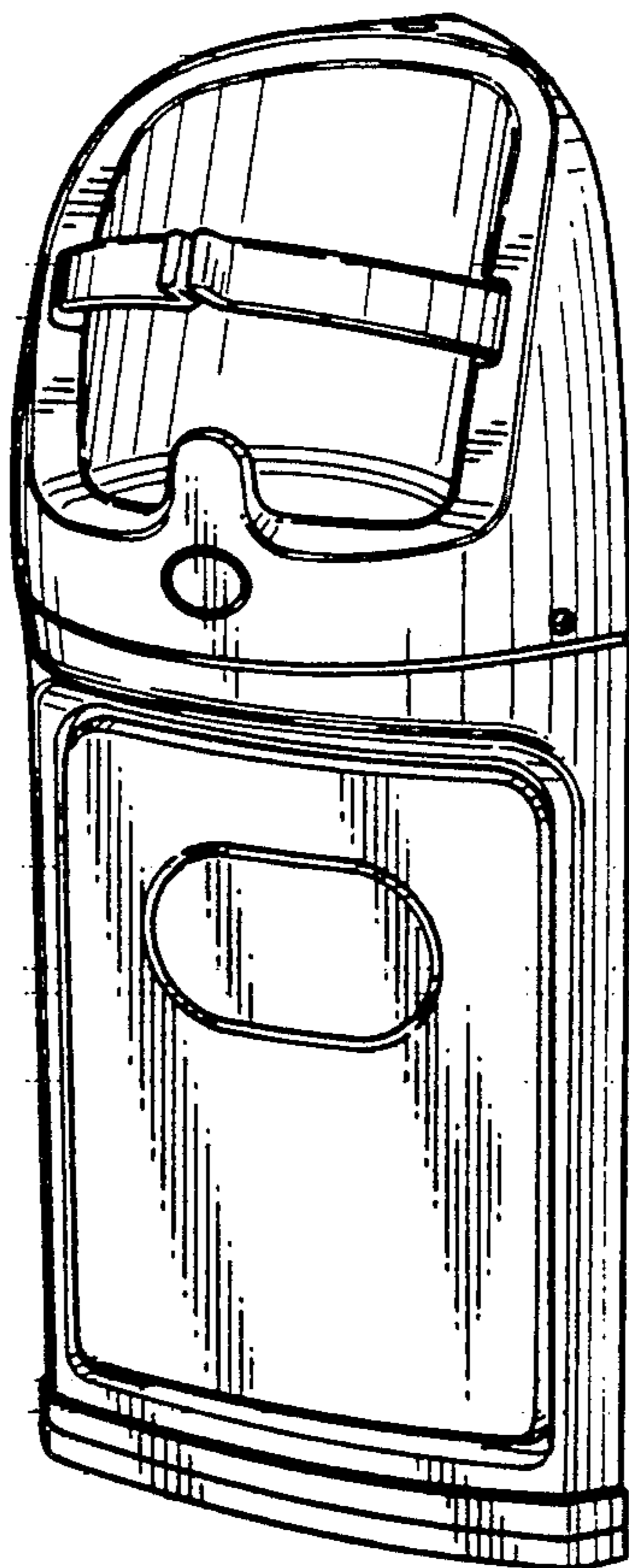
## [57] CLAIM

The ornamental design for a child's chair, as shown and described.

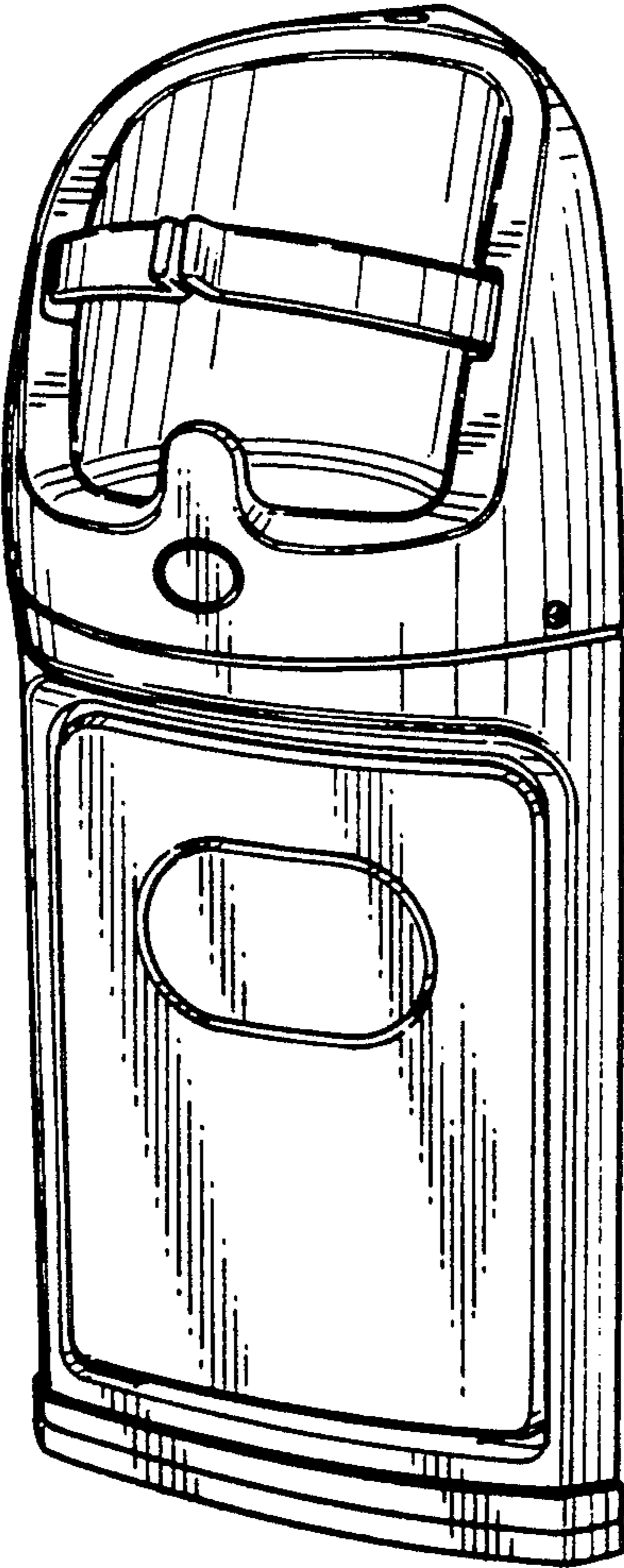
## DESCRIPTION

FIG. 1 is a front perspective view of a child's chair showing our new design;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a rear elevational view thereof;  
 FIG. 4 is a top plan view thereof;  
 FIG. 5 is a bottom plan view thereof;  
 FIG. 6 is a left side elevational view thereof;  
 FIG. 7 is a right side elevational view thereof; and,  
 FIG. 8 is a front perspective view with the safety bars in a retracted position thereof.  
 FIGS. 2 through 7 have been drawn on a enlarged scale with respect to FIG. 1.

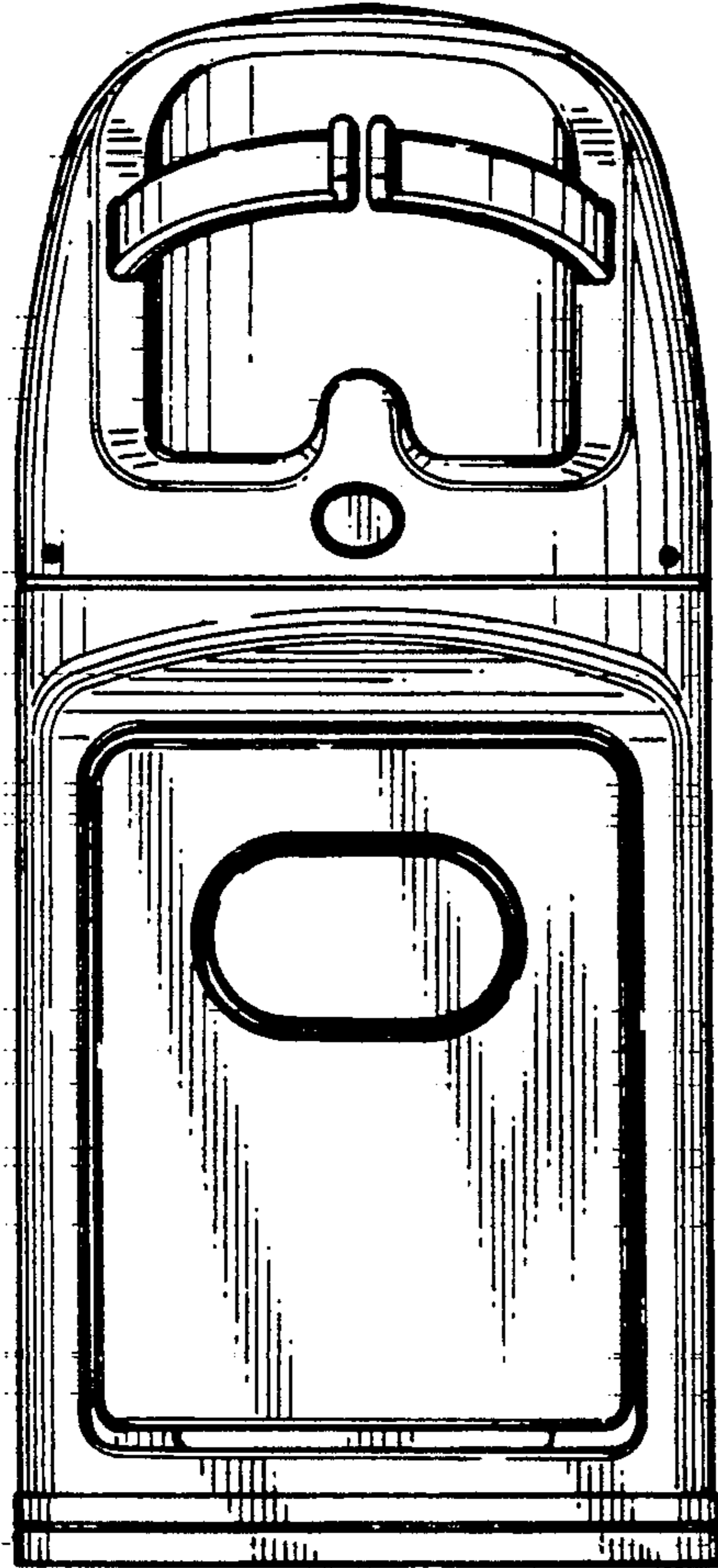

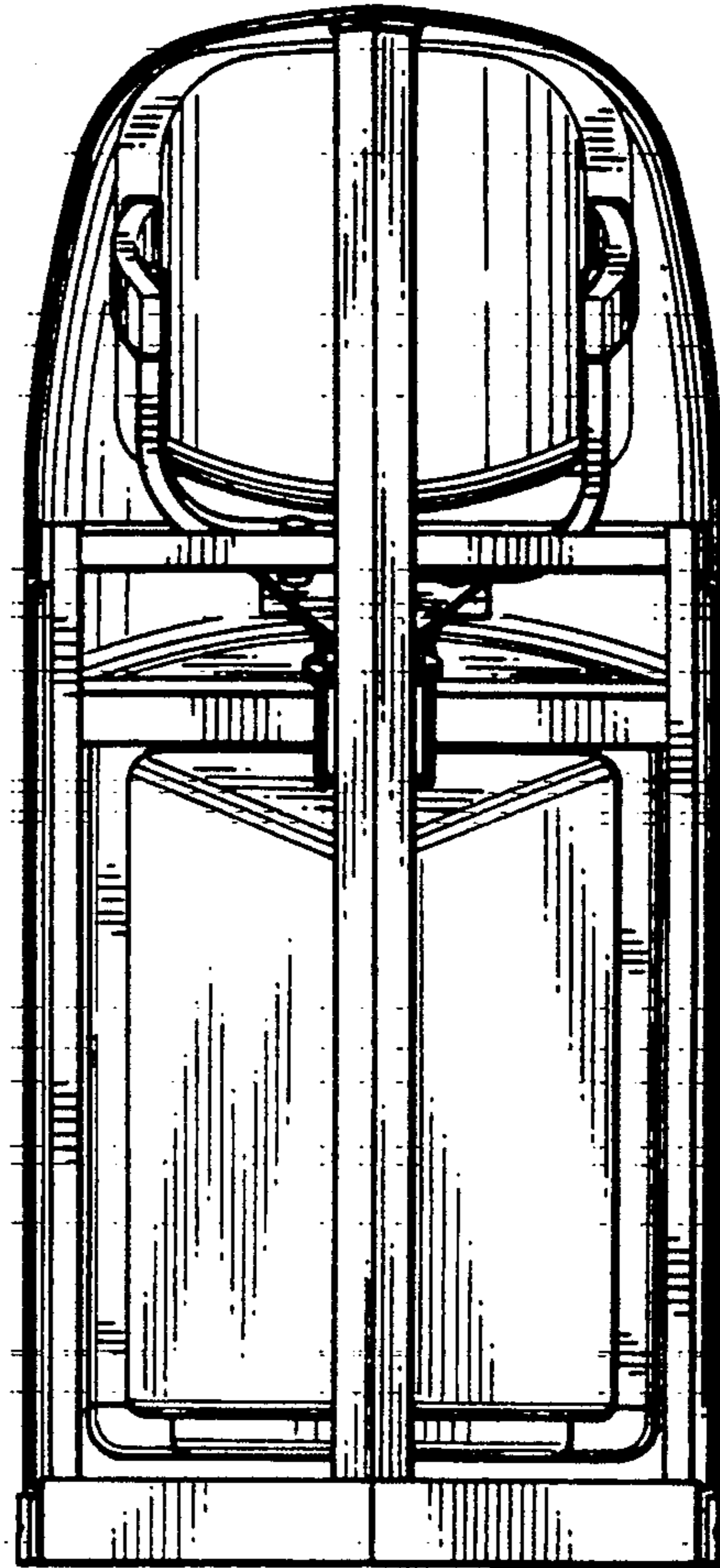

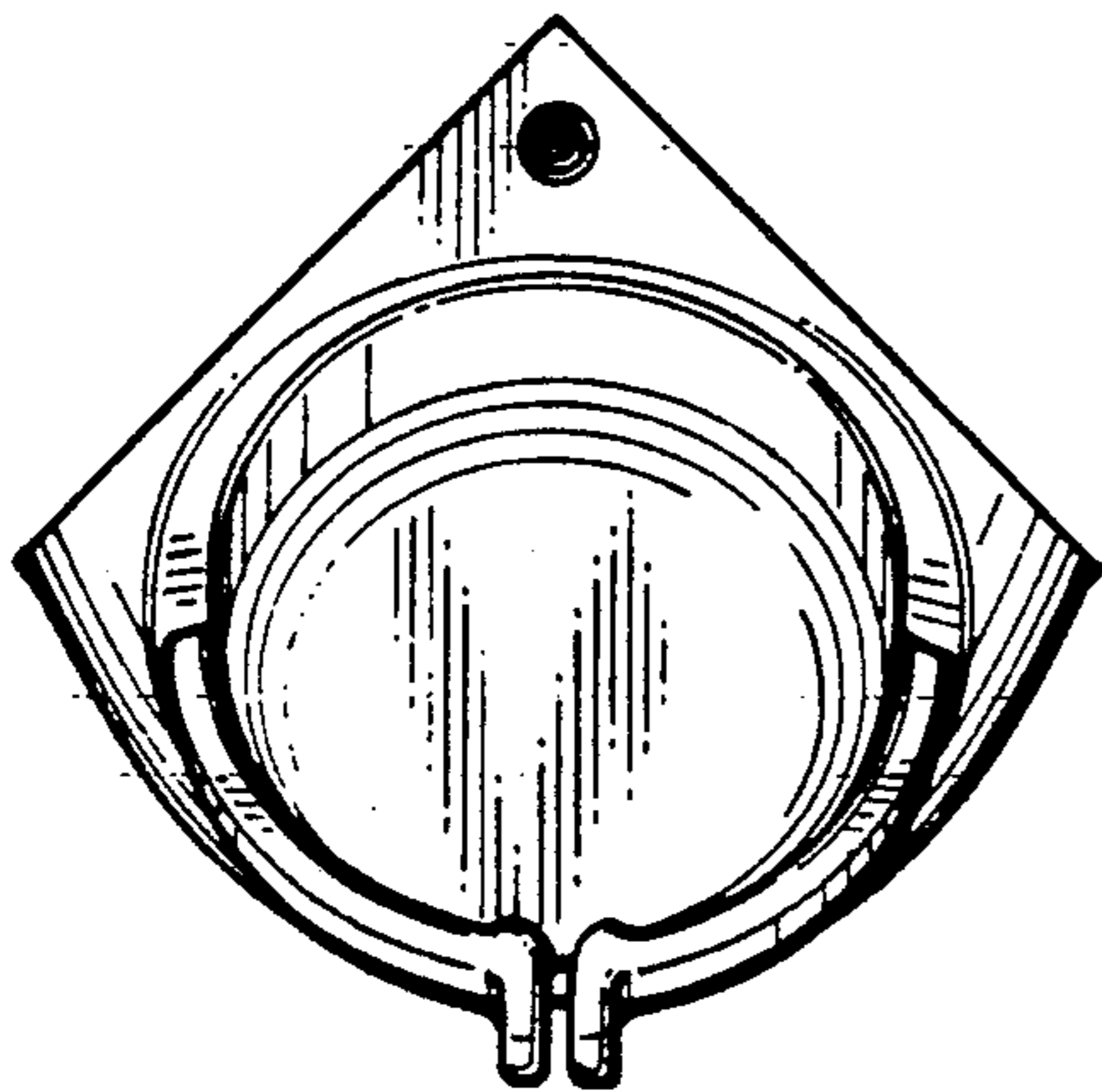

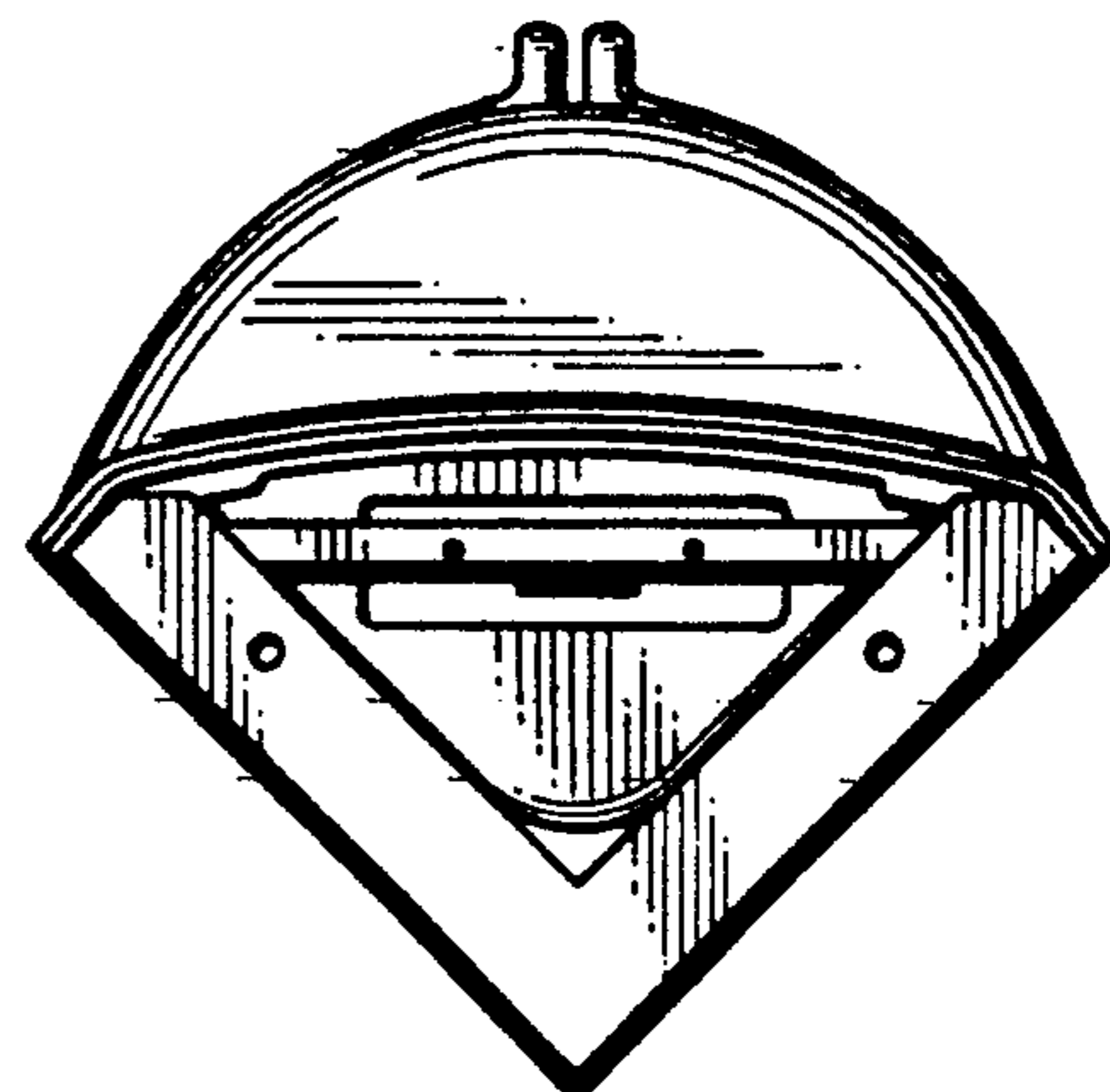

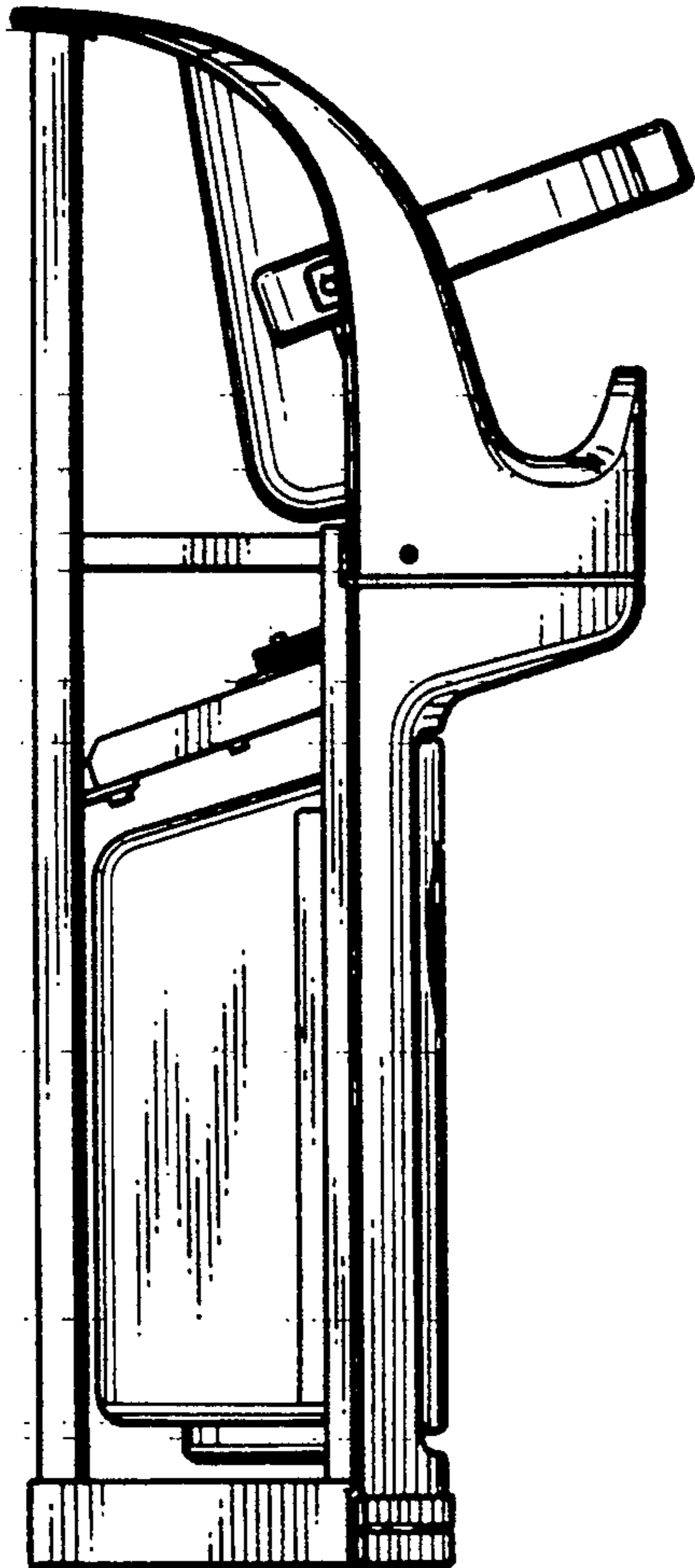

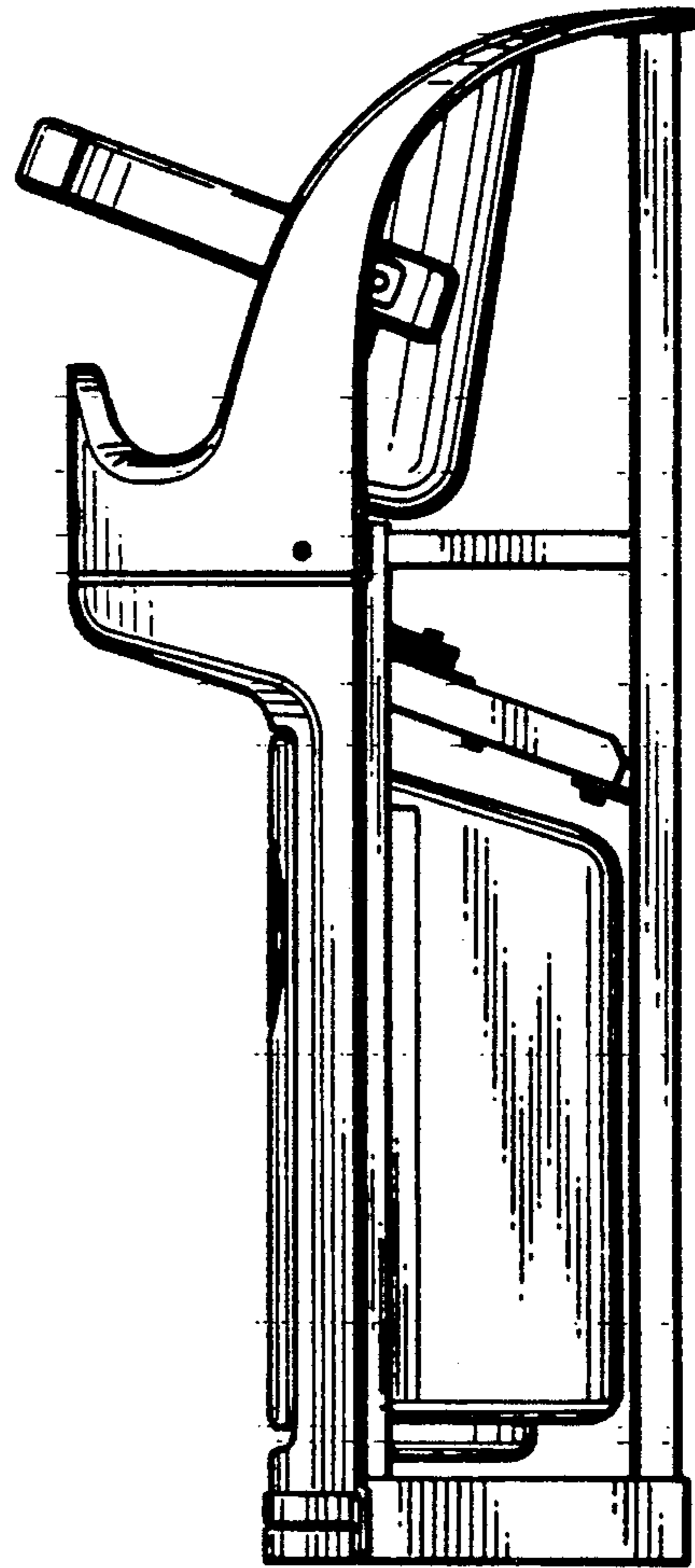
