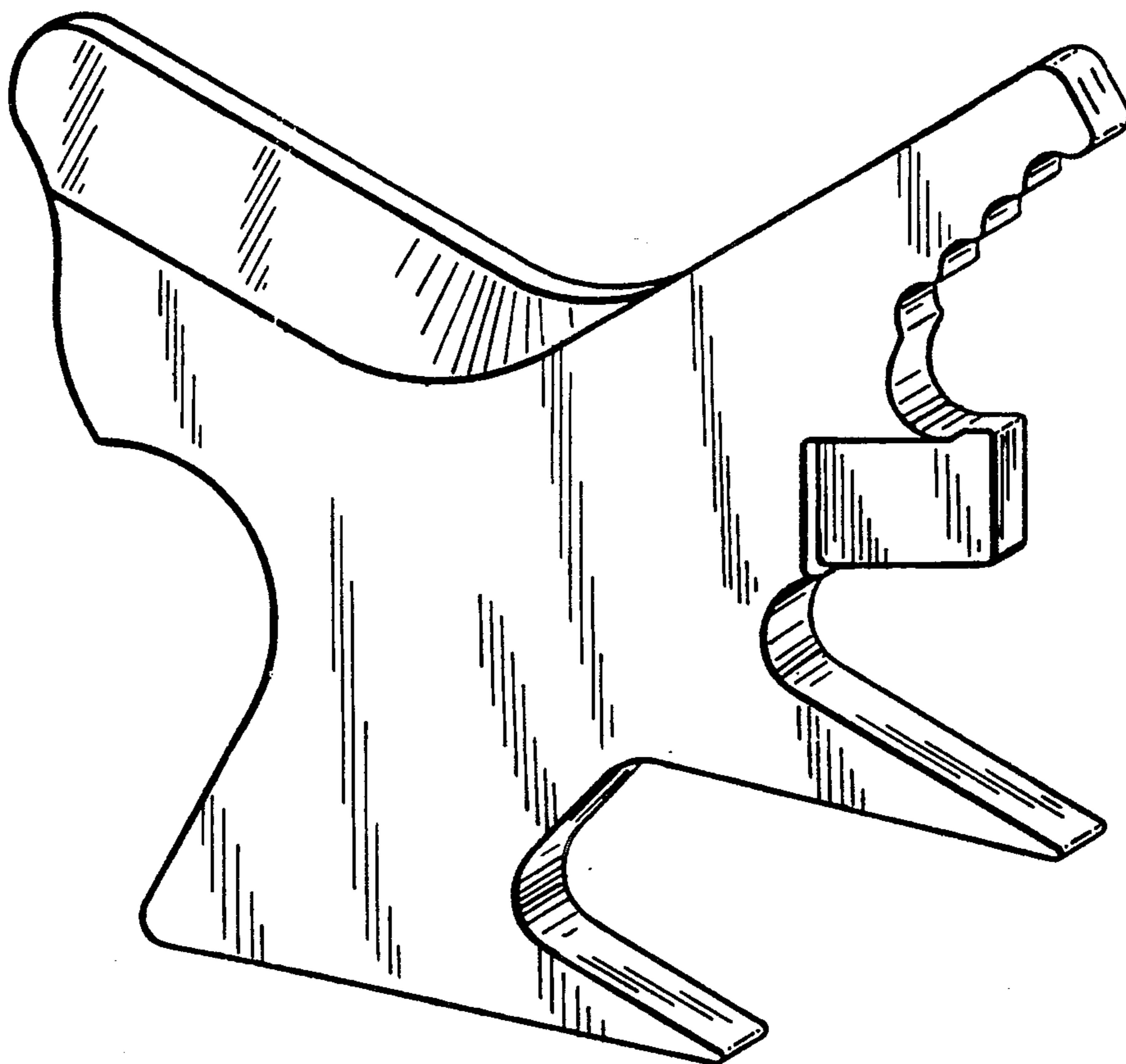

DESCRIPTION

FIG. 1 is a top front perspective view of a guitar body showing my new design;
 FIG. 2 is a top rear perspective view thereof;
 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a top plan view;
 FIG. 5 is a left side elevational view thereof;
 FIG. 6 is a bottom plan view thereof;

 FIG. 14 is a right side elevational view thereof.



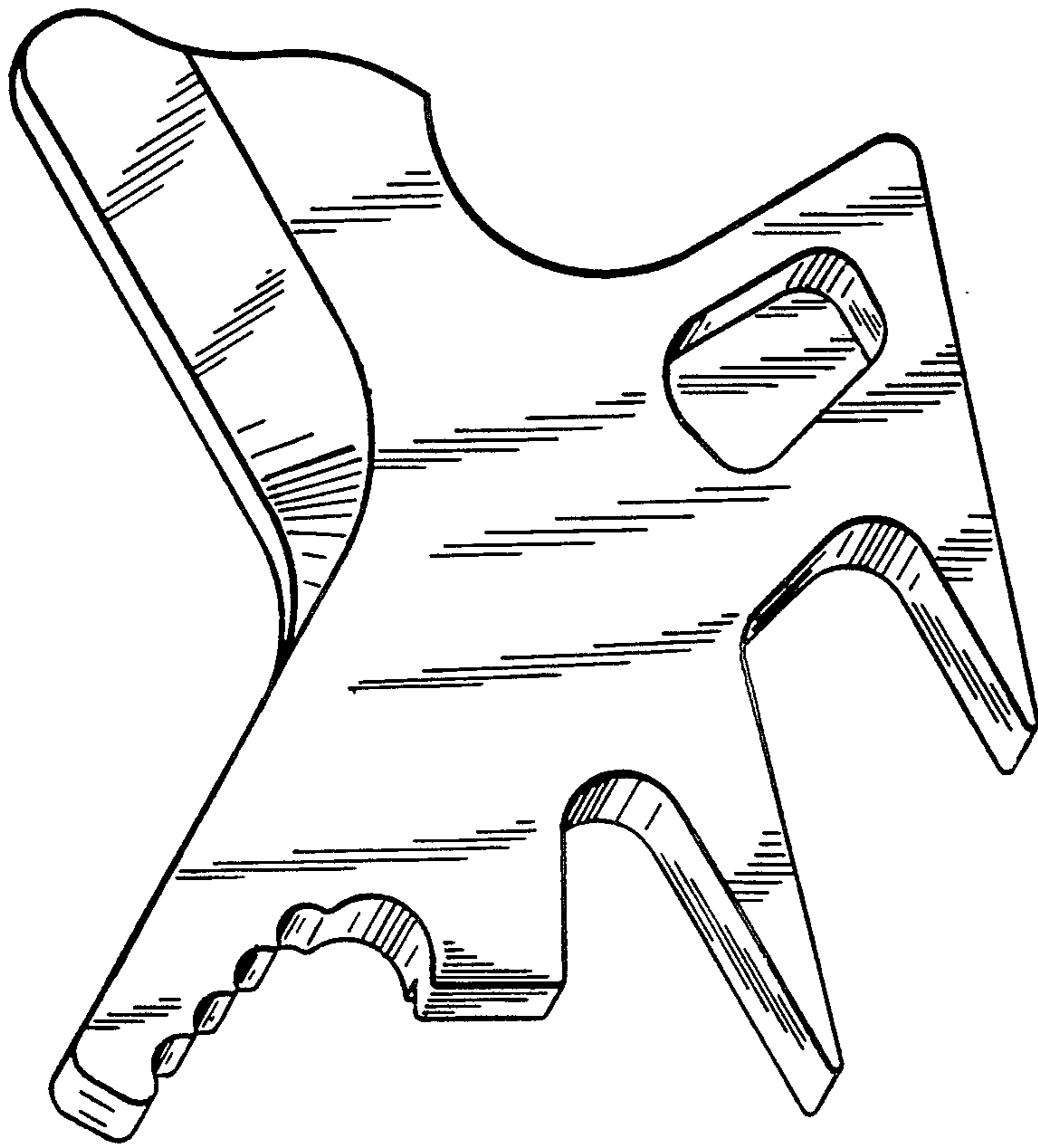

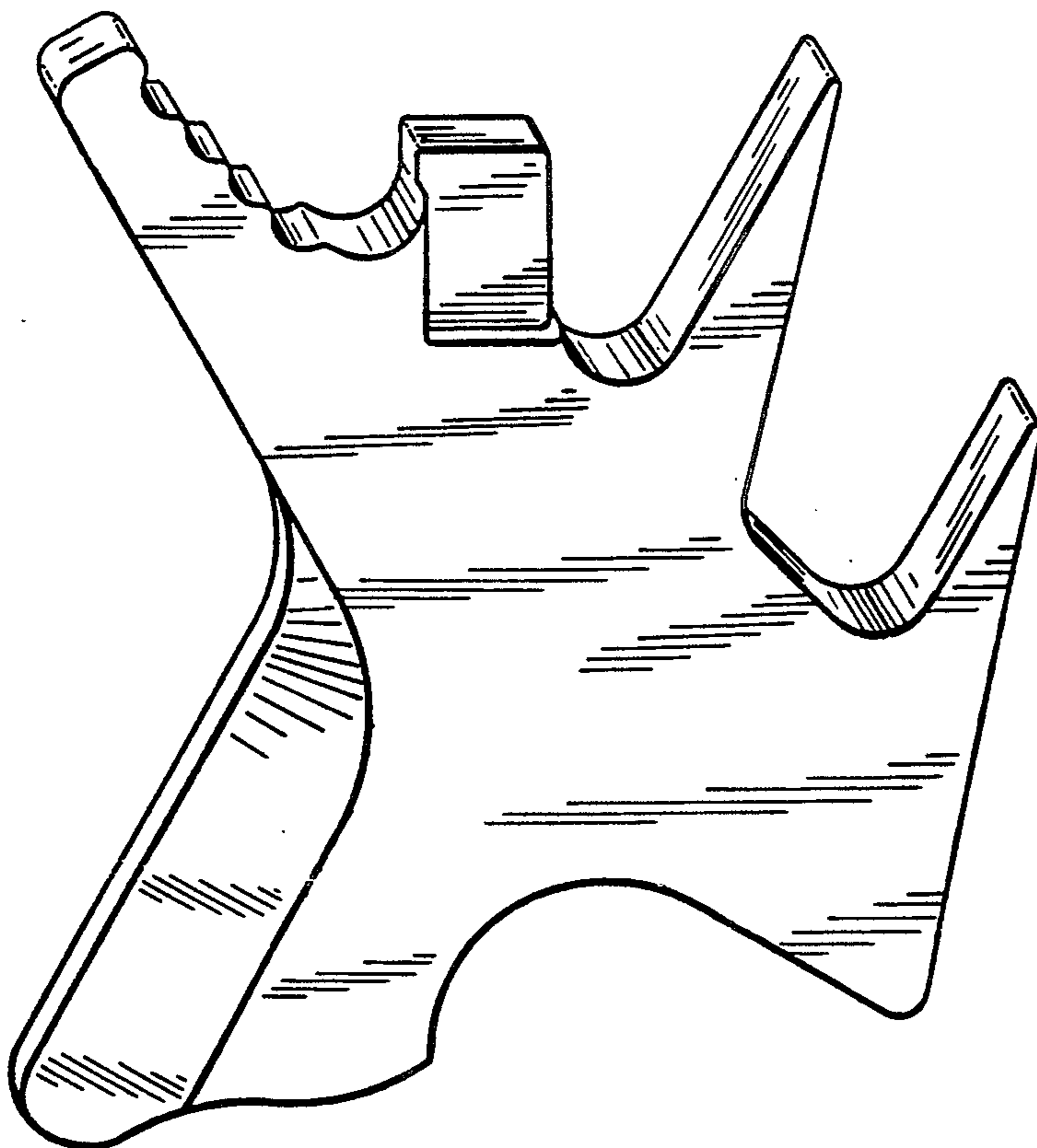

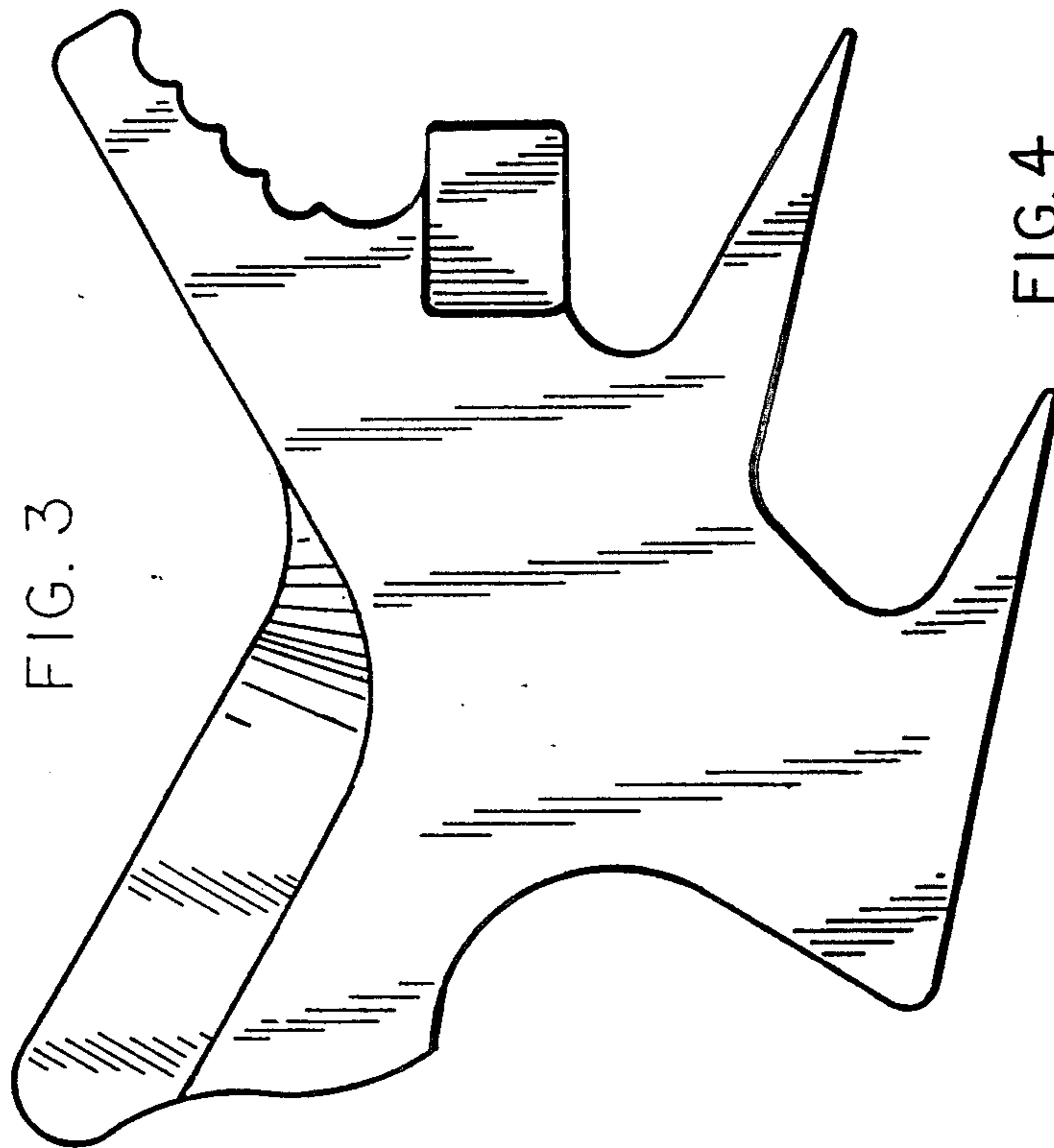

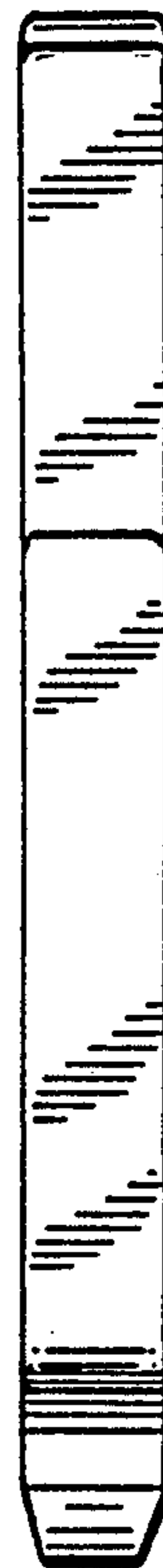

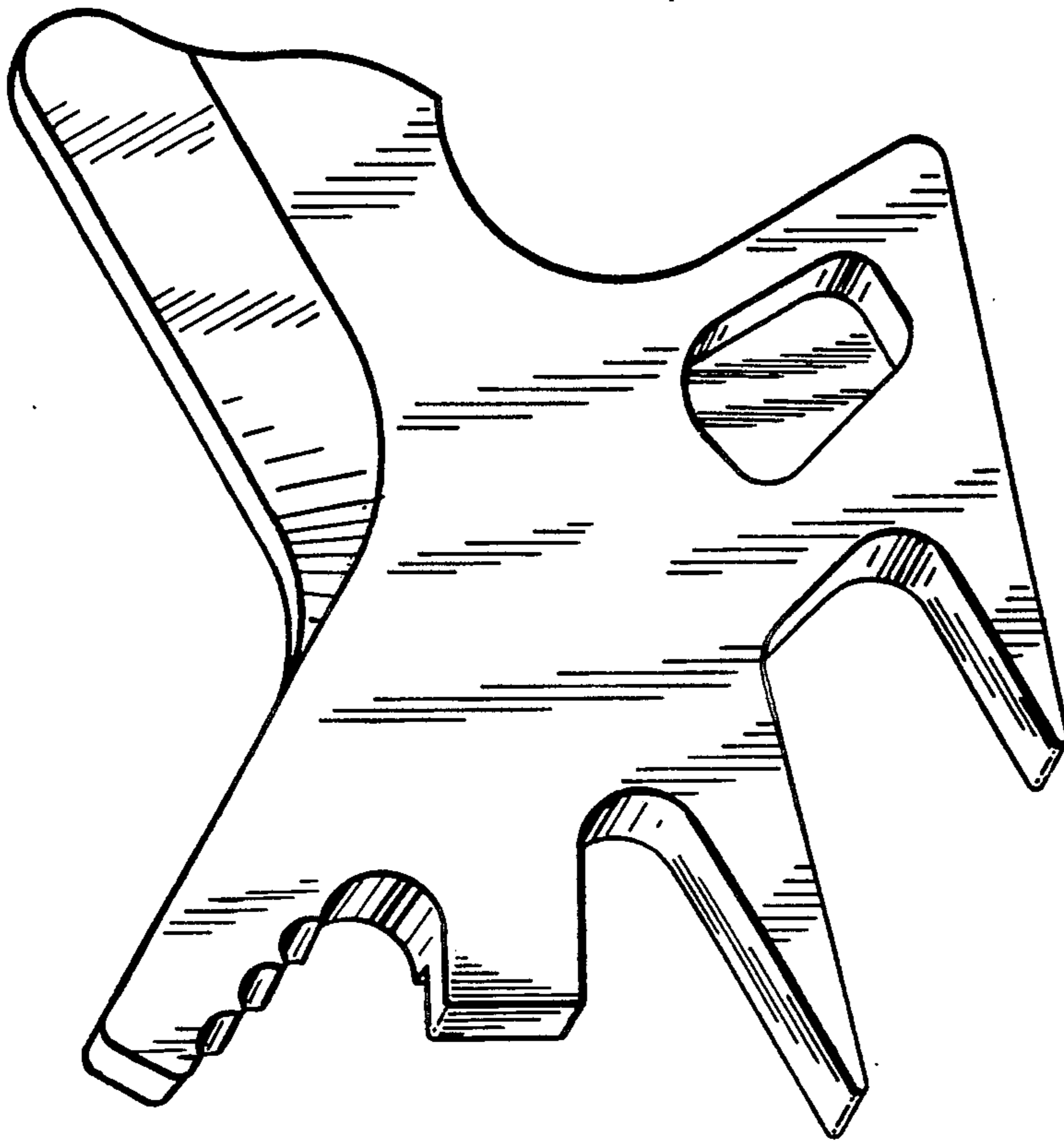

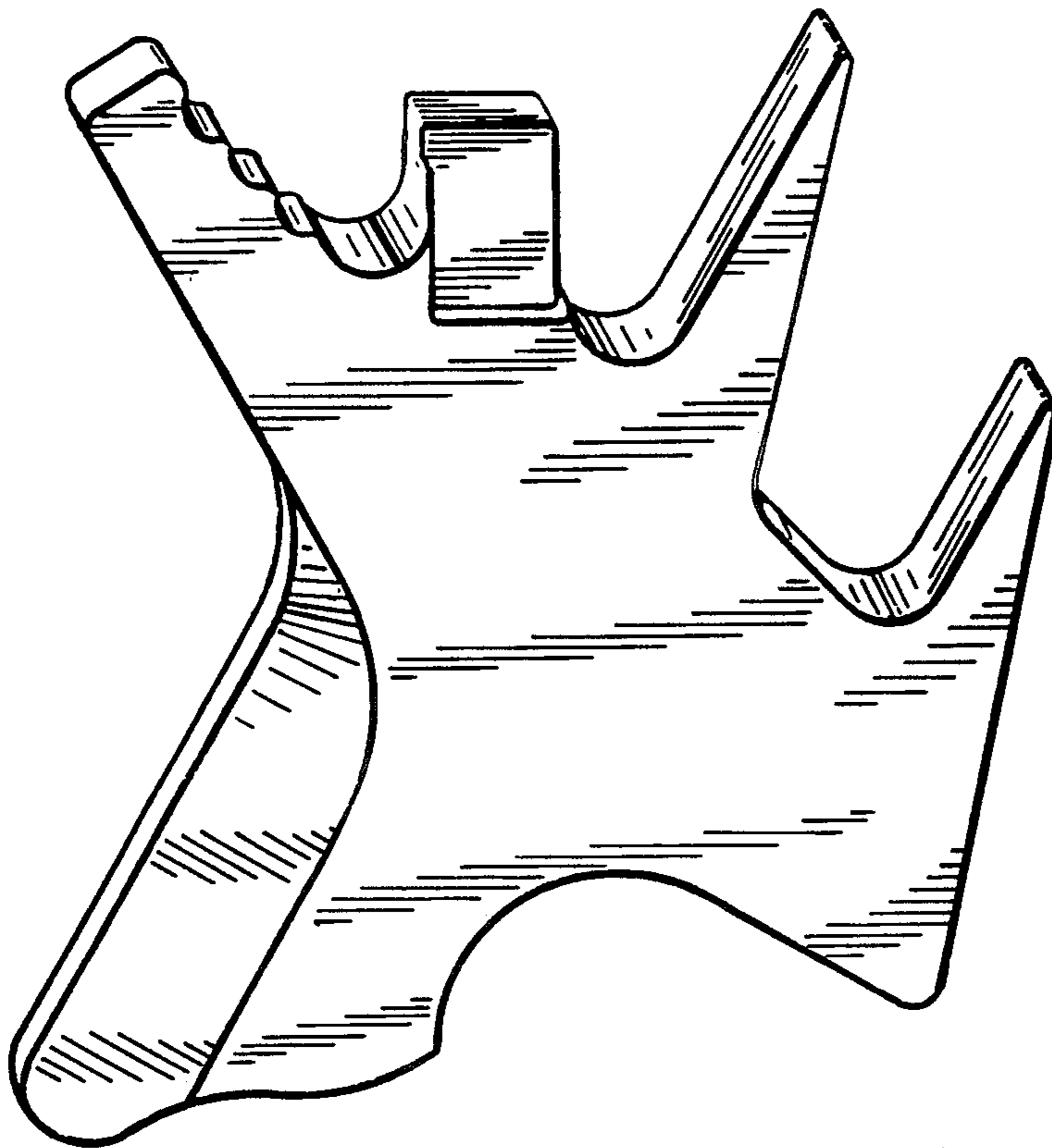

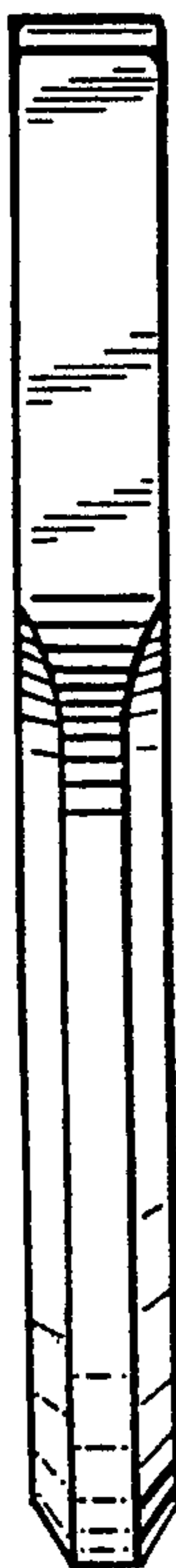

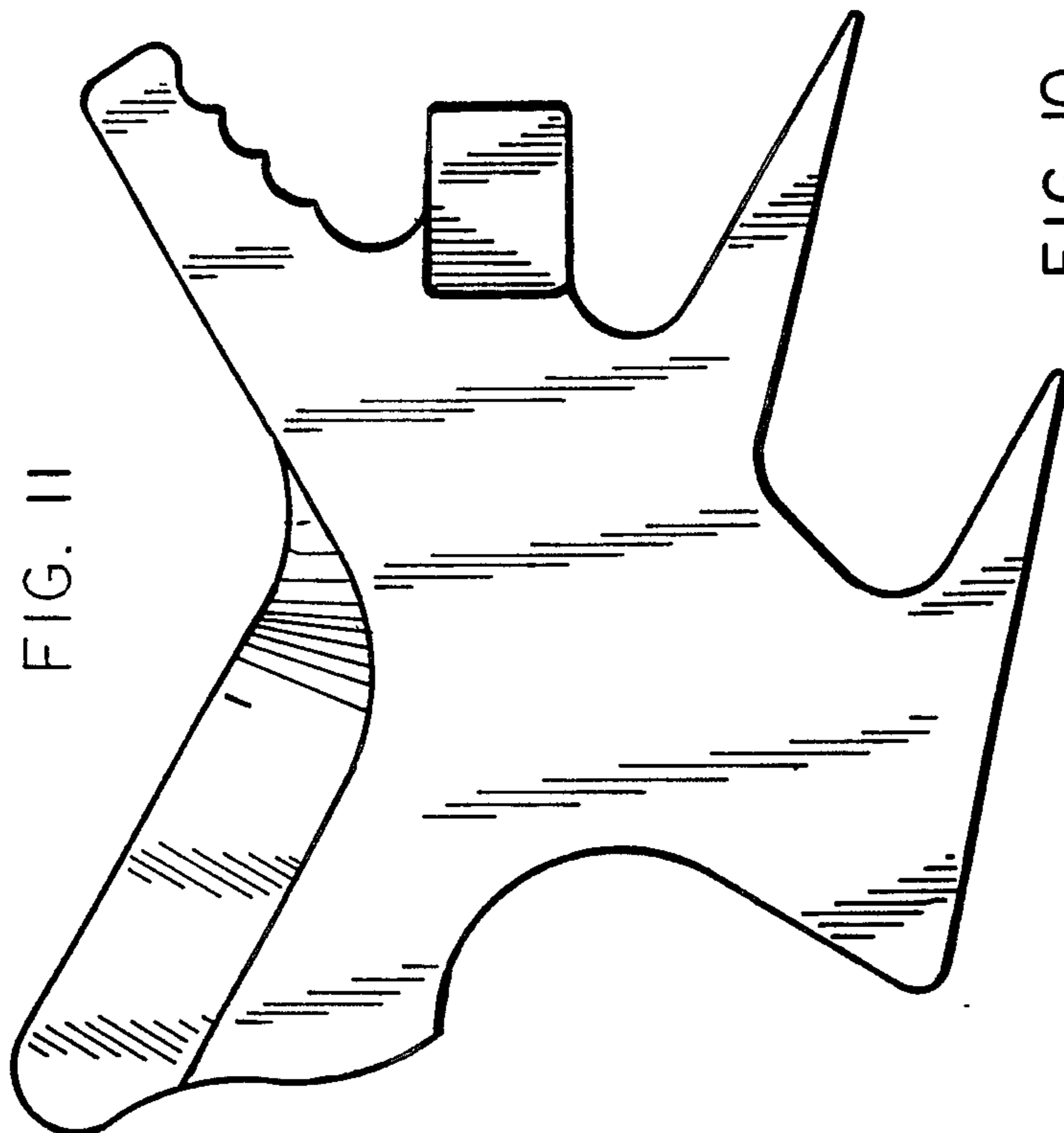
