[57] **CLAIM**

The ornamental design for a combined amusement tube slide and an enclosing structure, as shown and described.

DESCRIPTION

FIG. 2 is a front elevational view thereof;

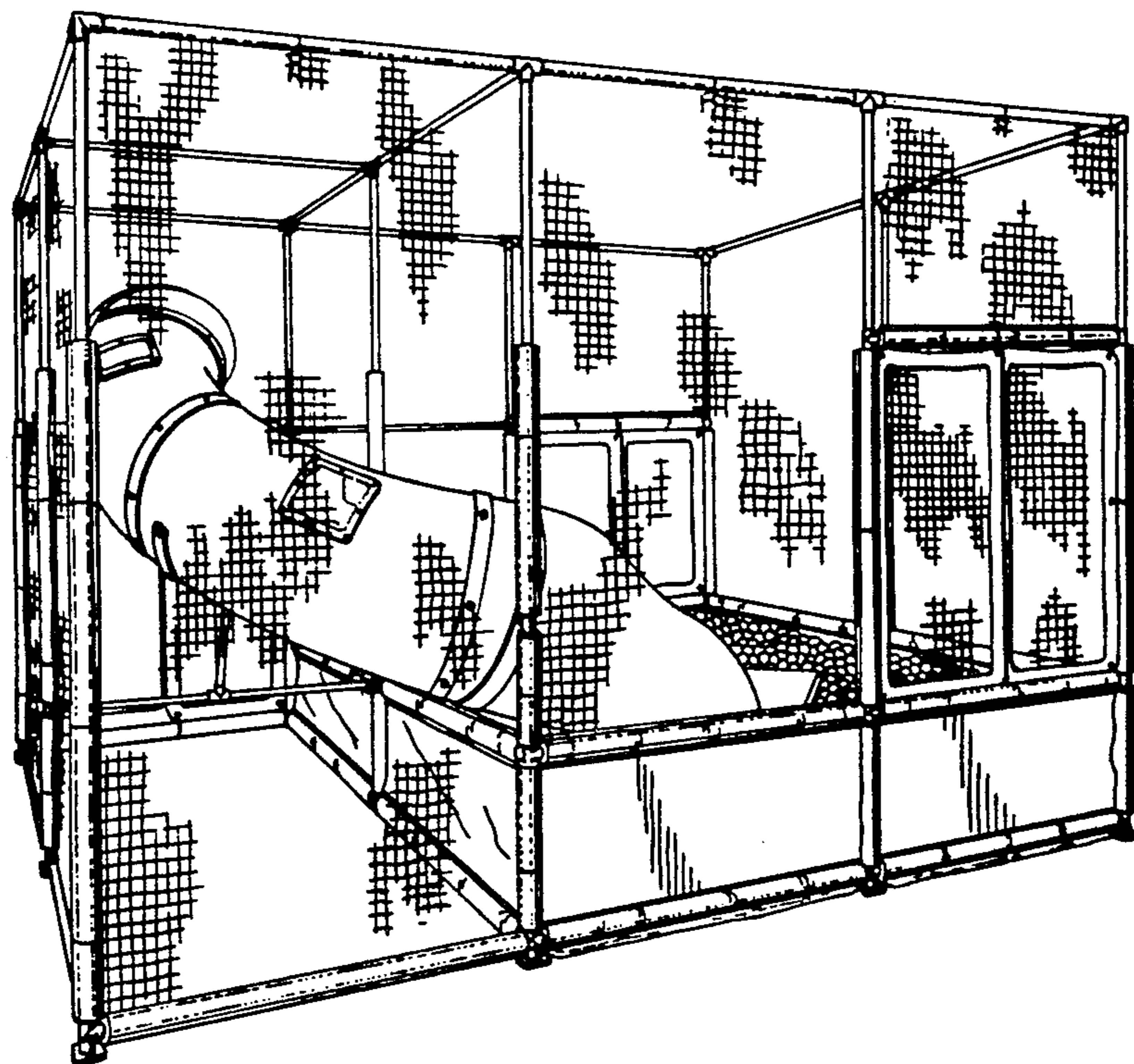
FIG. 3 is a rear elevational view thereof;

FIG. 7 is a bottom plan view thereof.



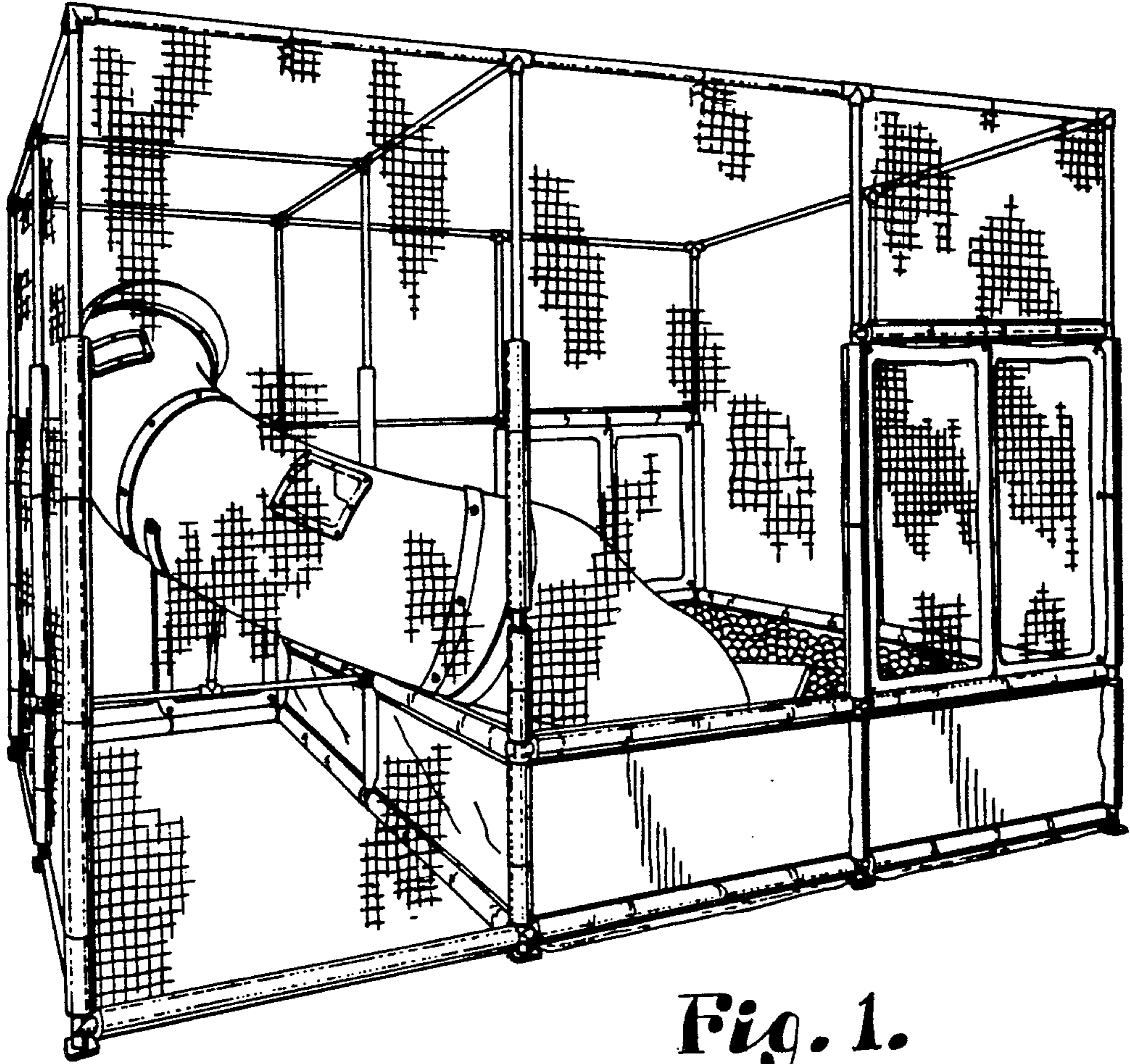

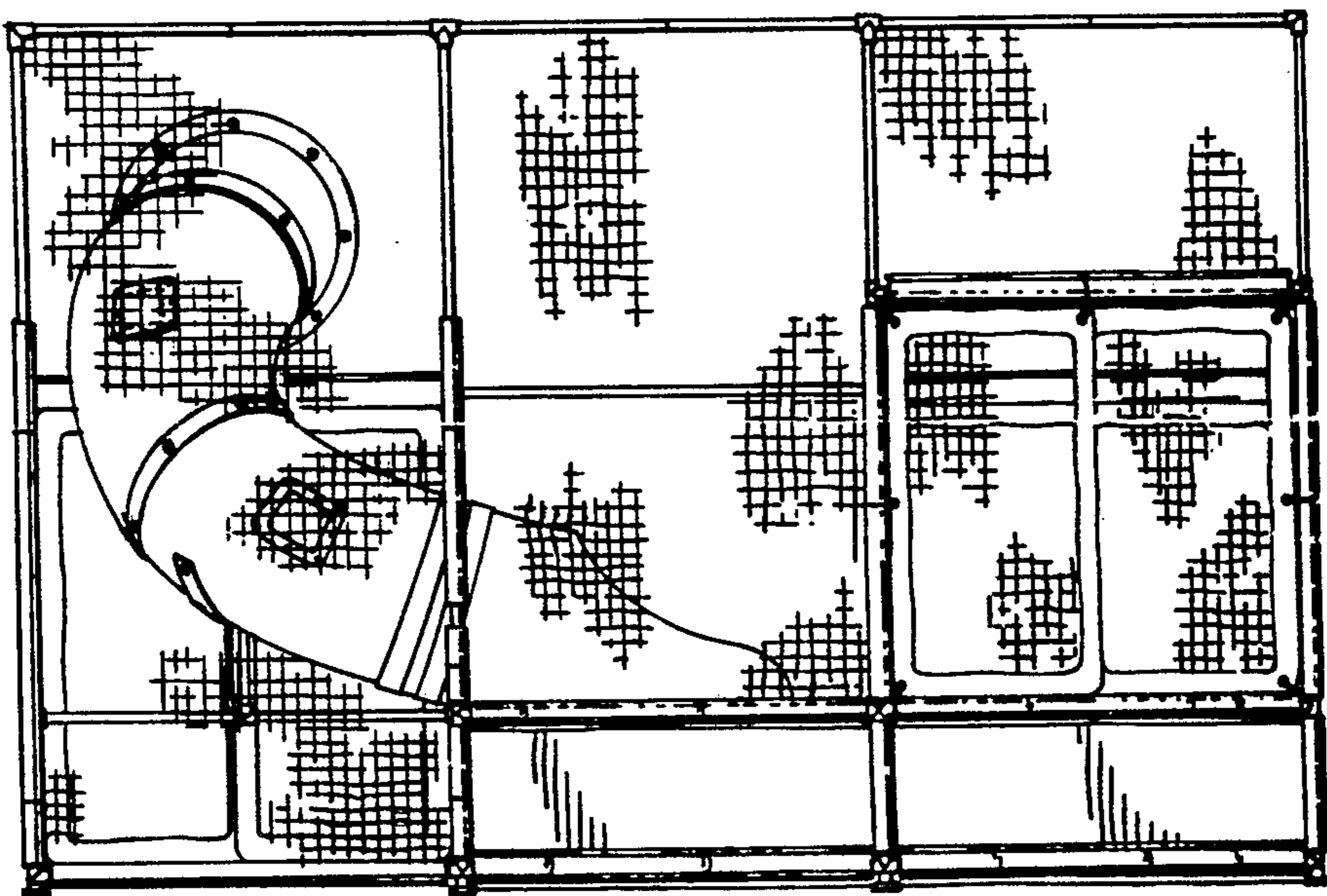

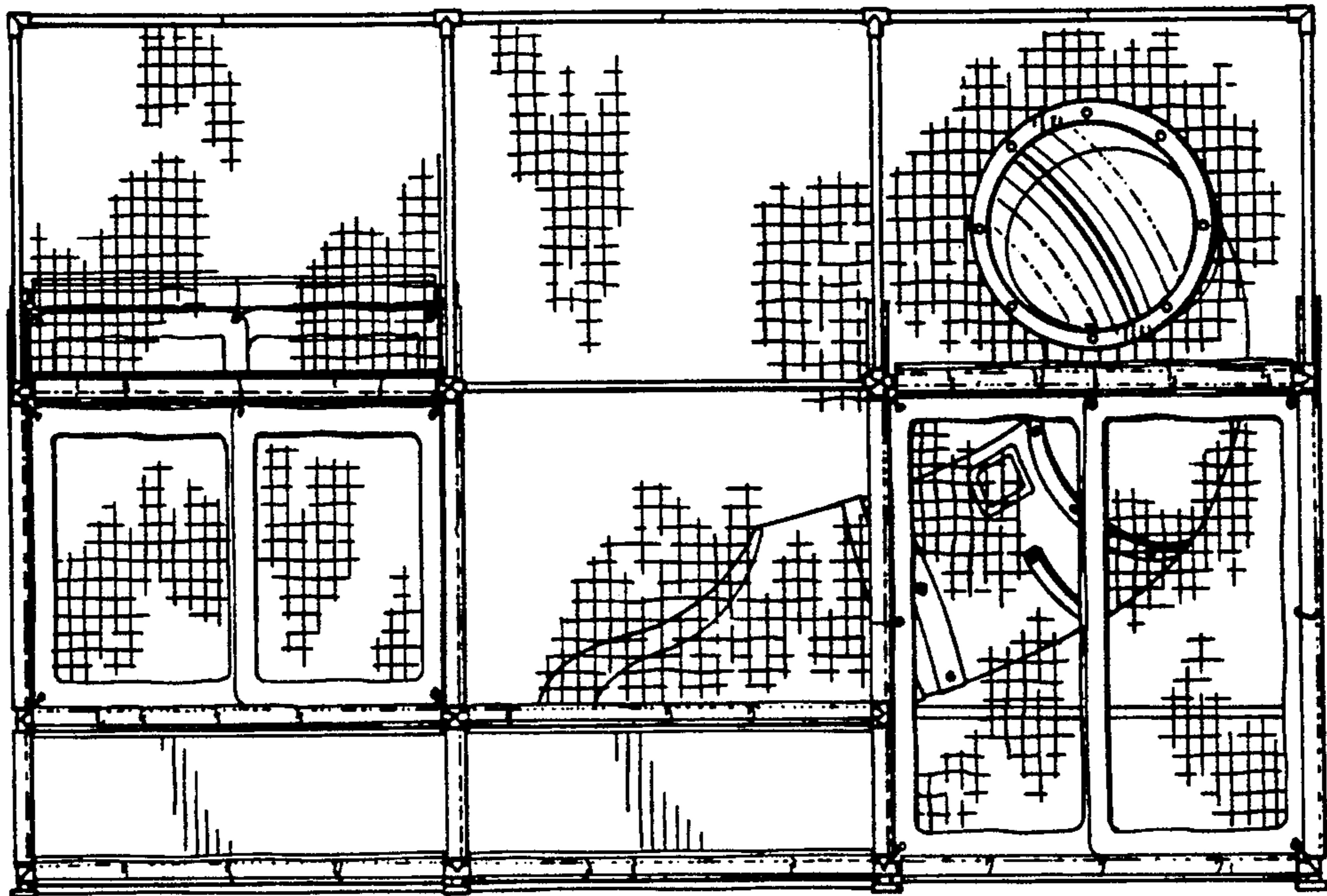

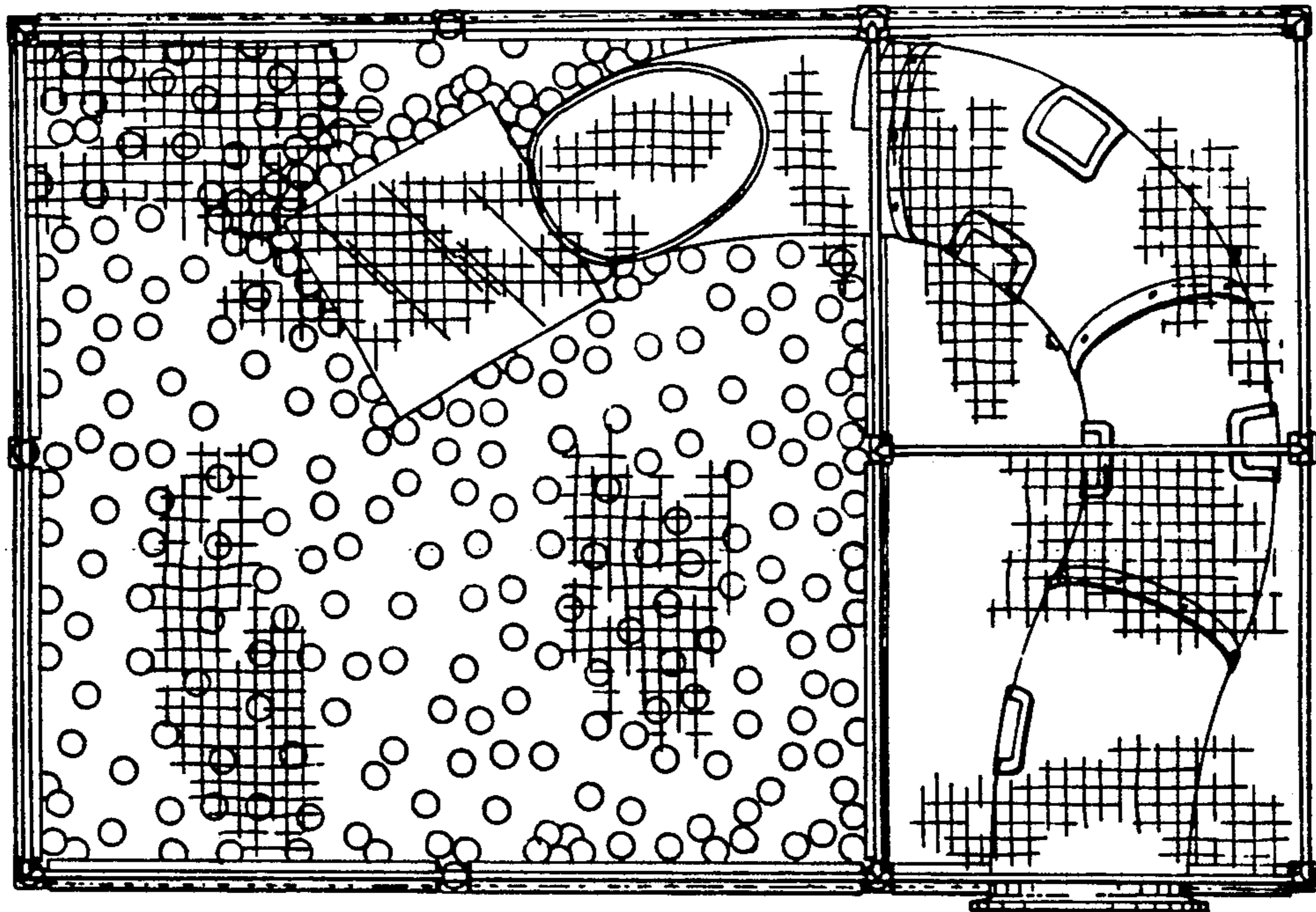

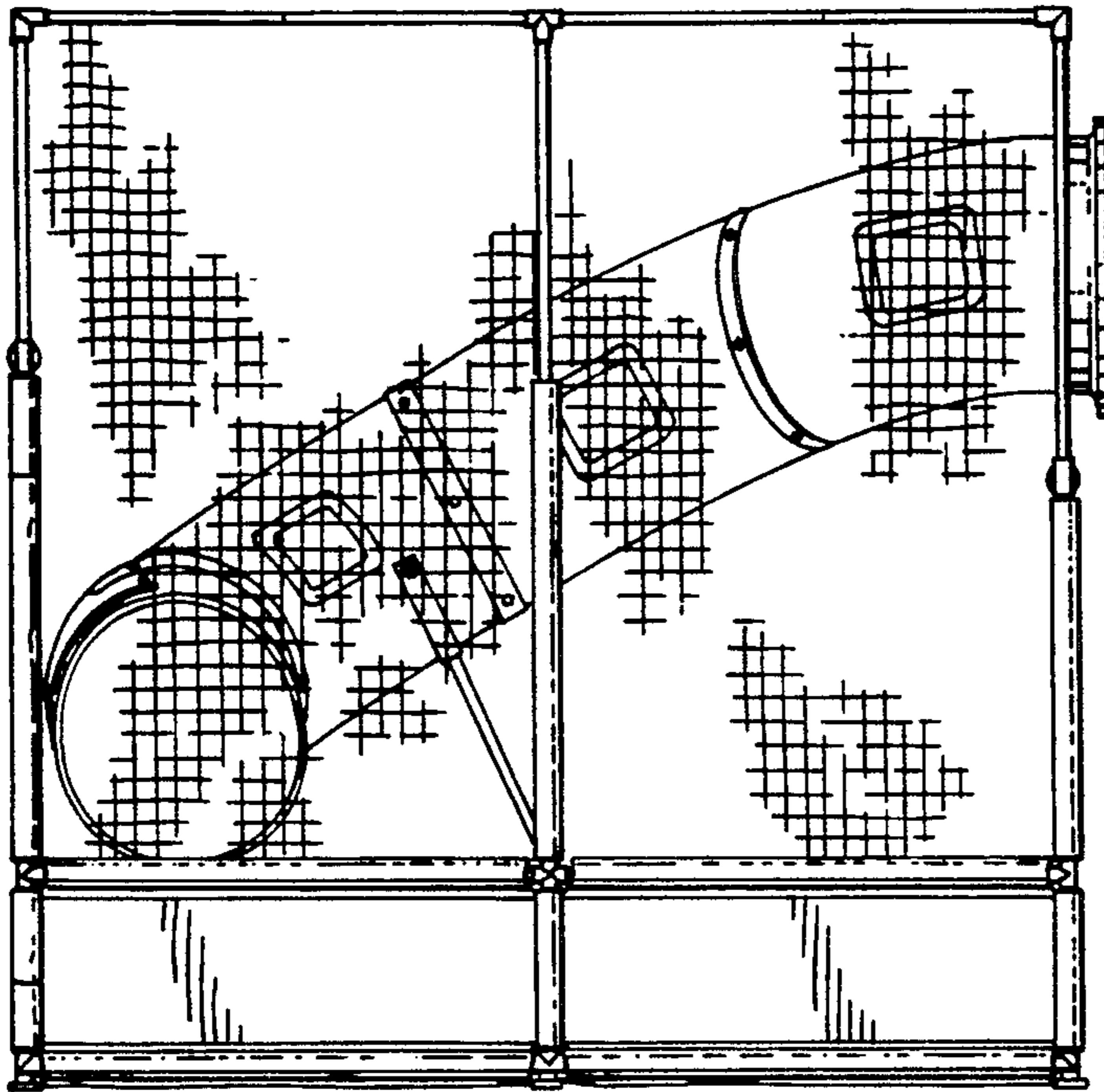

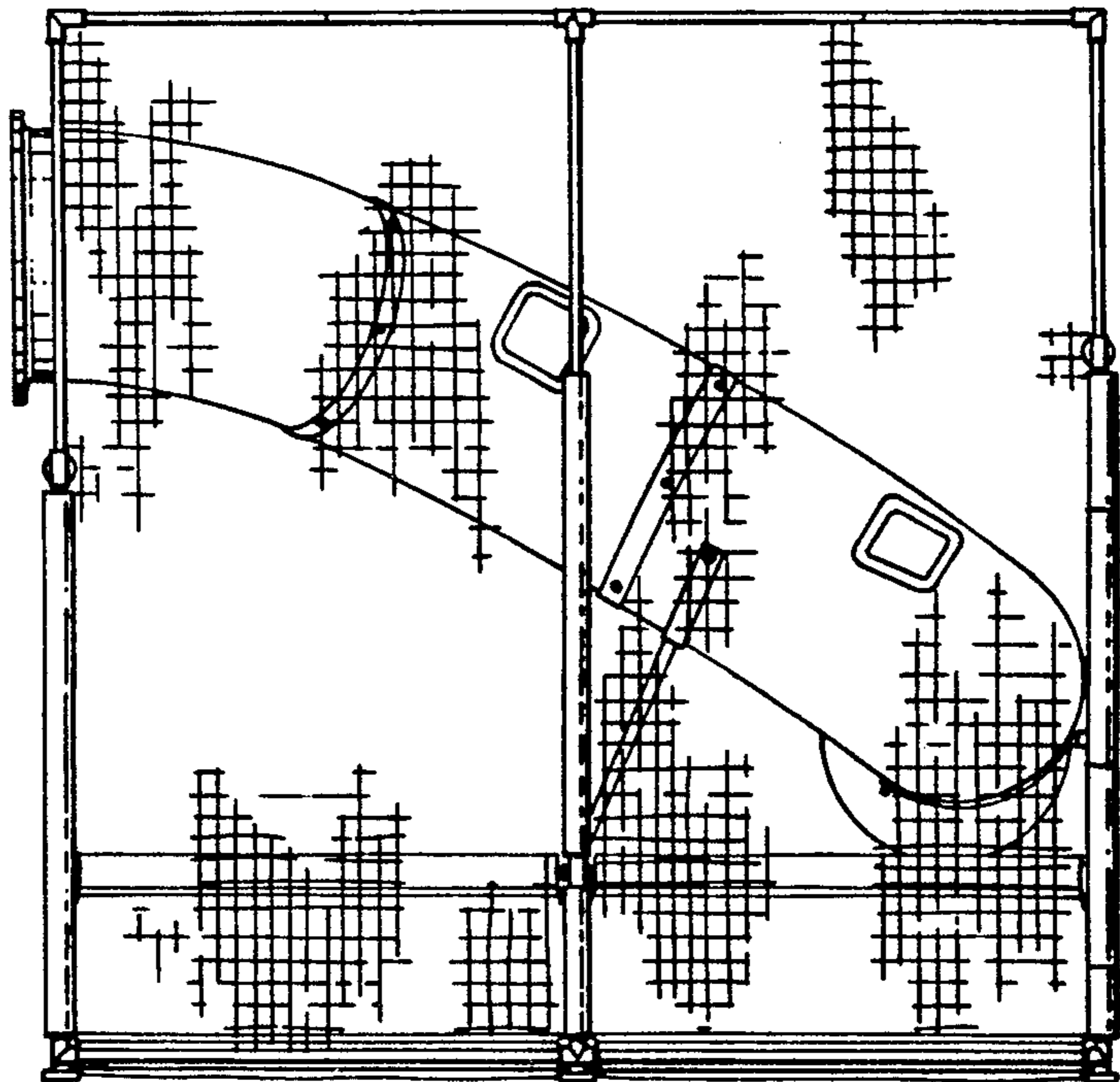
