[57] CLAIM

The ornamental design for a combined hair pick and comb, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a combined hair pick and comb showing our new design;

FIG. 2 is a front elevational view thereof, the side opposite being a mirror image of the side shown;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a perspective view of a second modified embodiment;

FIG. 8 is a front elevational view thereof, the side opposite being a mirror image of the side shown;

FIG. 9 is a left side elevational view thereof;

FIG. 10 is a right side elevational view thereof;

FIG. 11 is a top plan view thereof;

FIG. 12 is a bottom plan view thereof; and,

FIG. 13 is an enlarged cross sectional view taken along line 13—13 of FIG. 2.

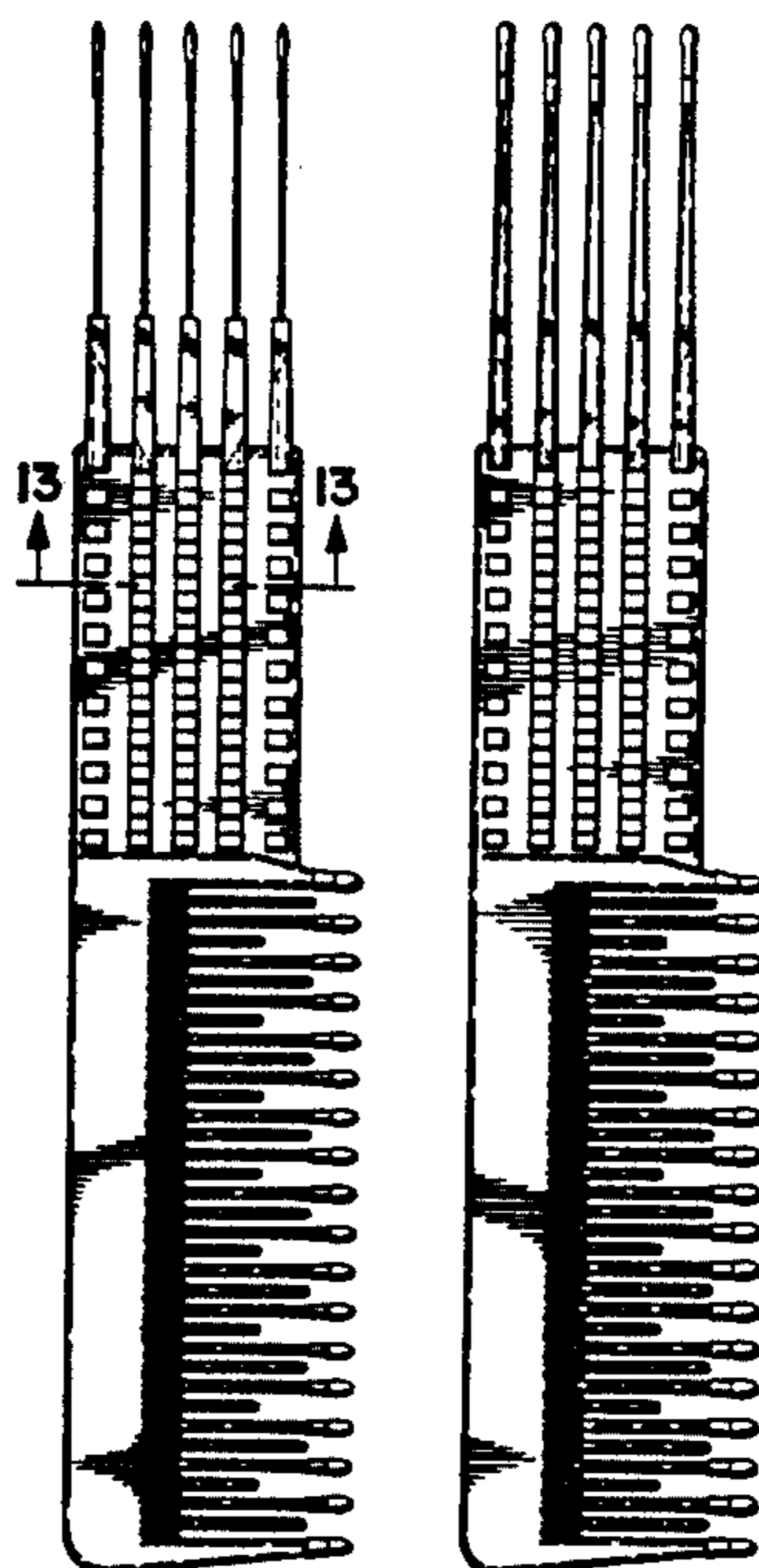

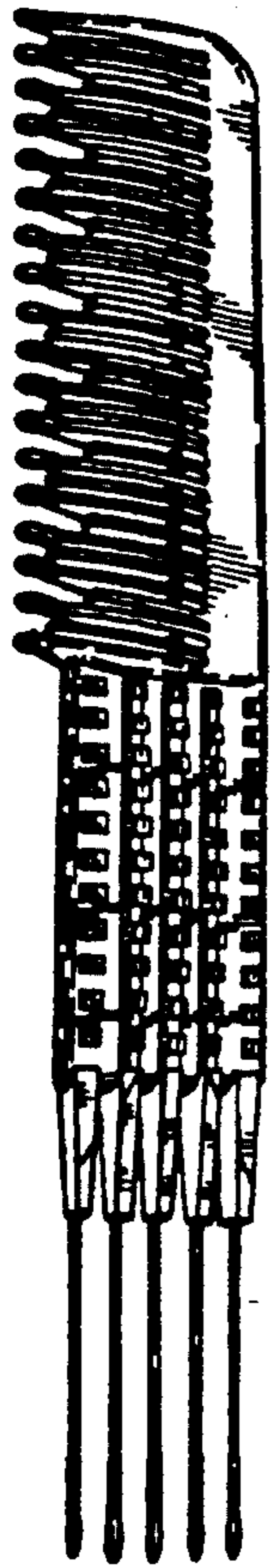

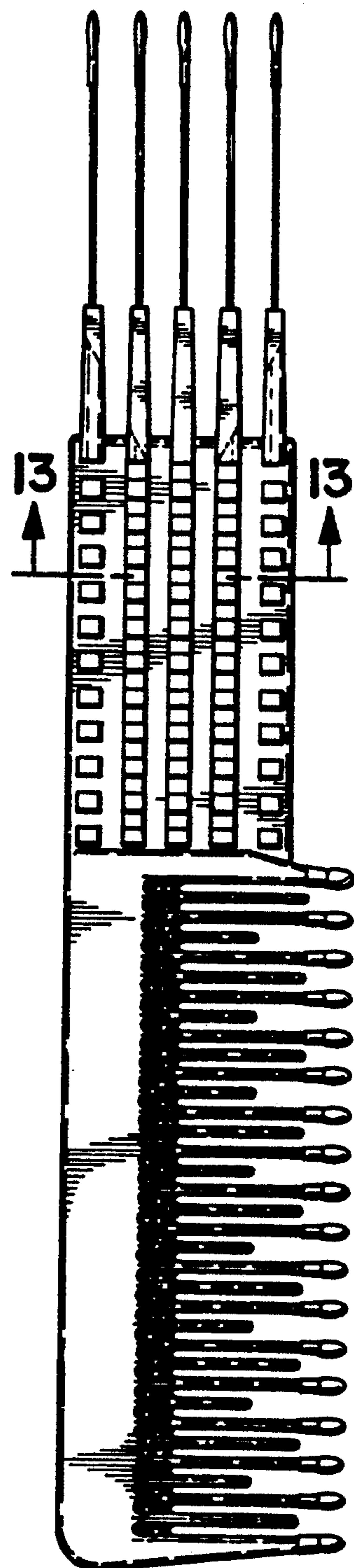

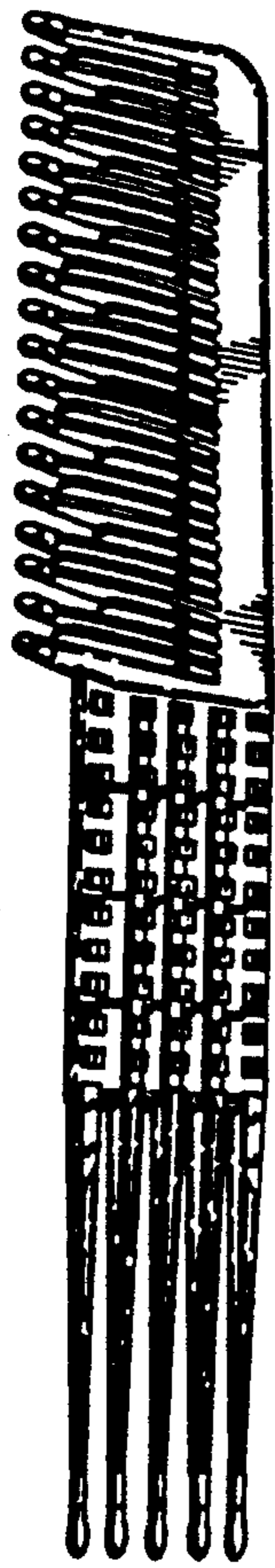

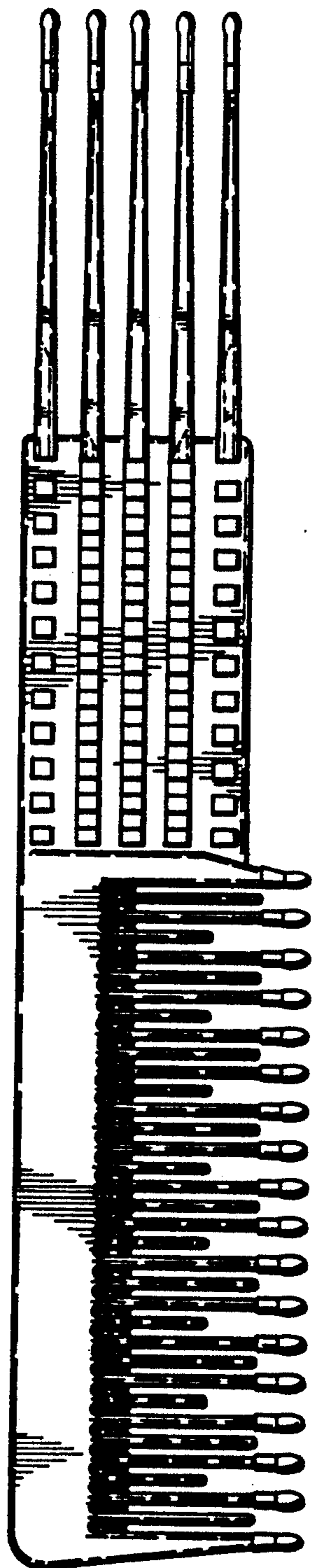

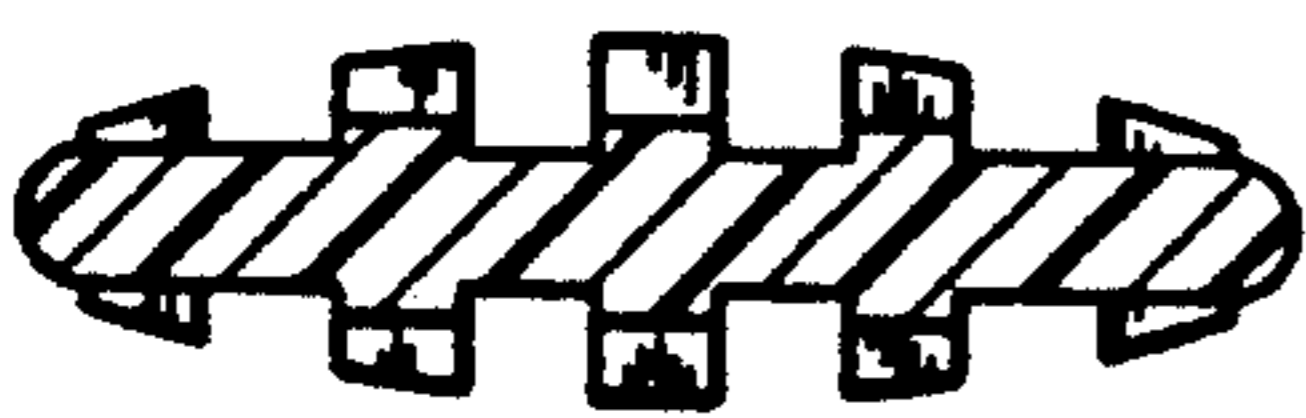
