[57] CLAIM

The ornamental design for a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a bottom plan view of a shoe outsole showing my new design;

FIG. 2 is a side view of the shoe outsole shown in FIG. 1;

FIG. 3 is a side view of the the other side of the shoe outsole shown in FIG. 1;

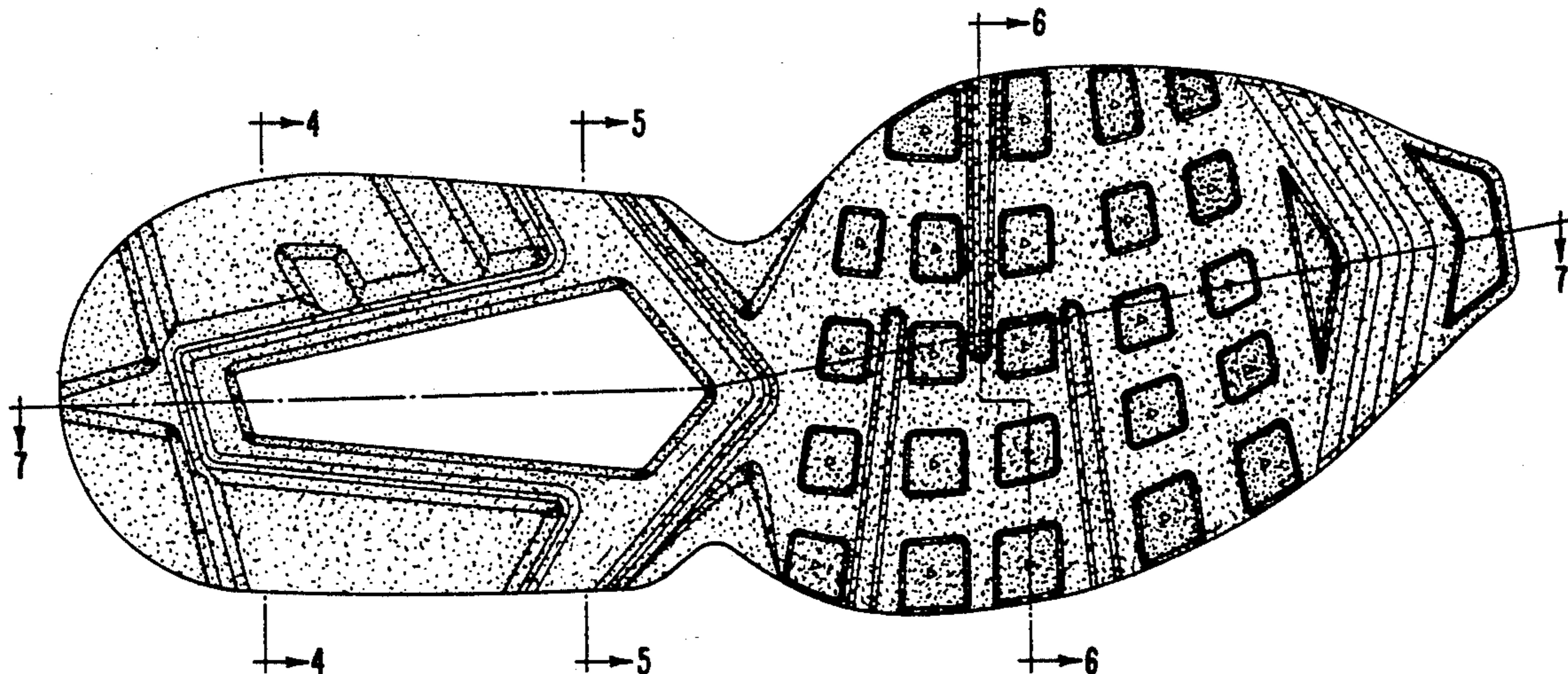
FIG. 4 is a cross section taken along line 4-4 of FIG. 1;

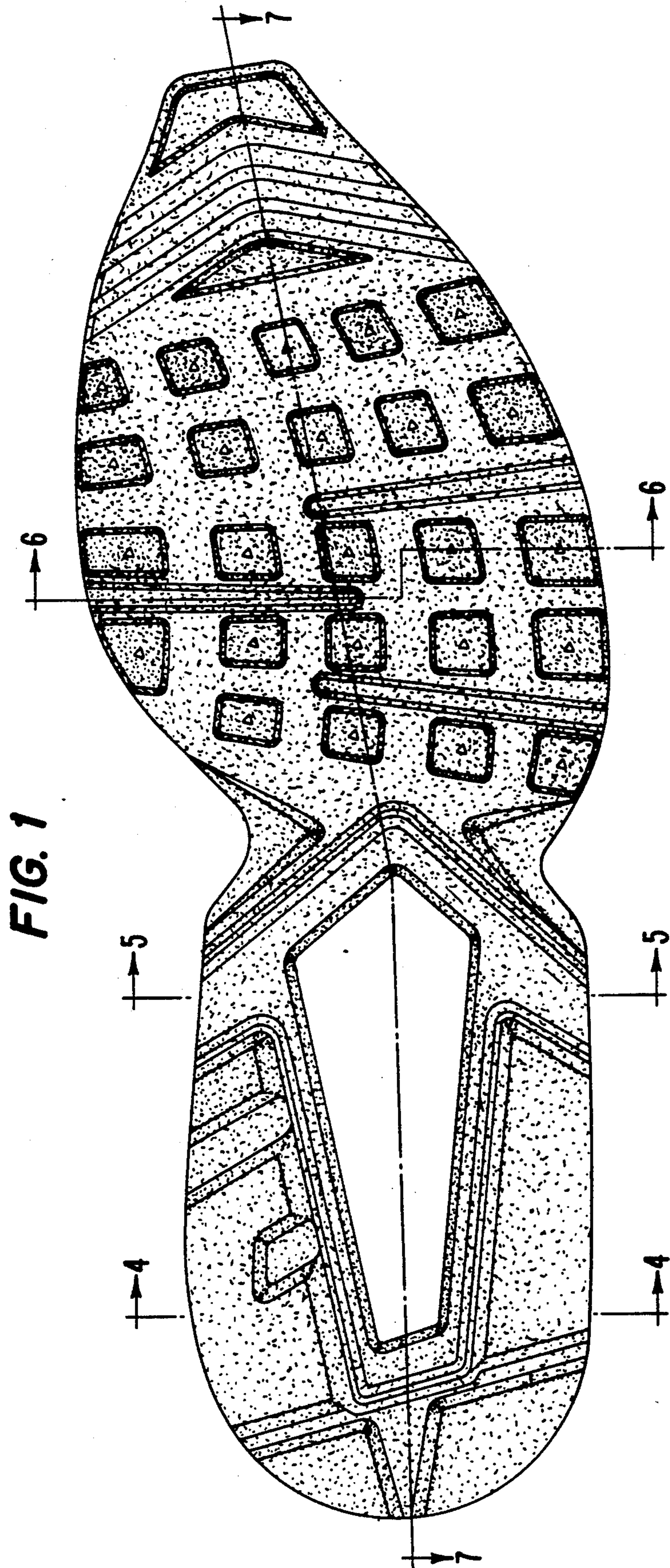
FIG. 5 is a cross section taken along line 5-5 of FIG. 1;

The broken line showing of an upper in FIGS. 2 and 3 is for illustrative purposes only and forms no part of the claimed design.





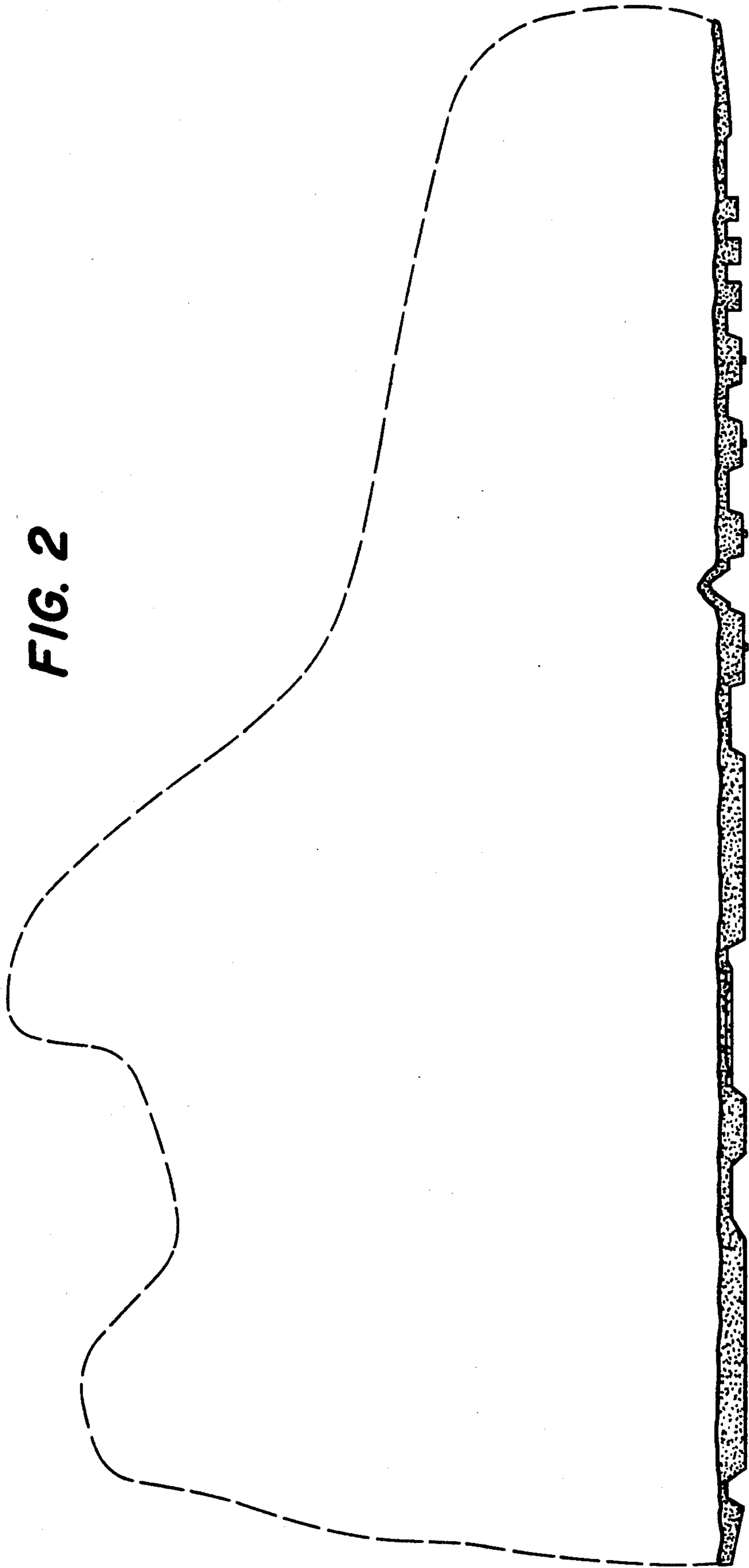

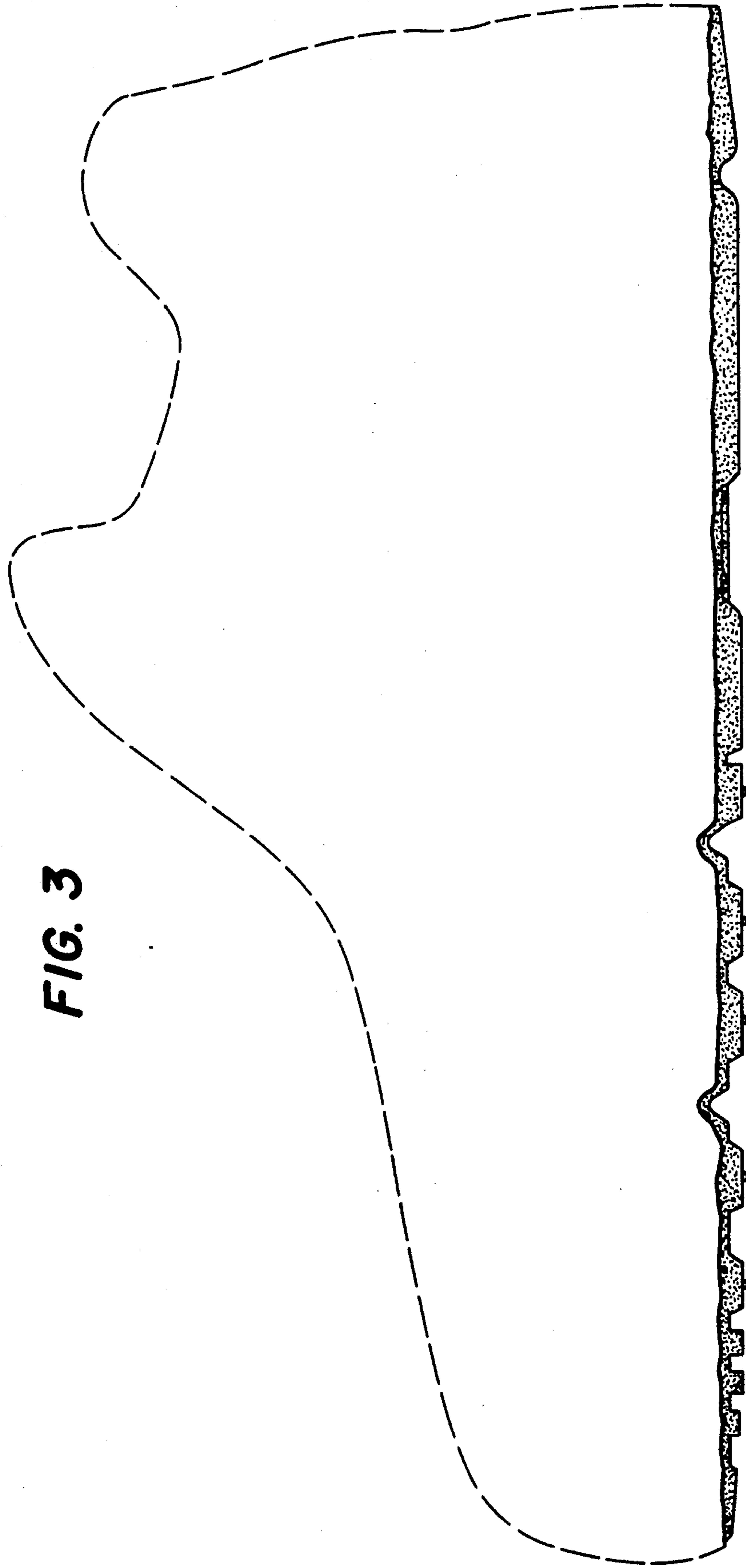
