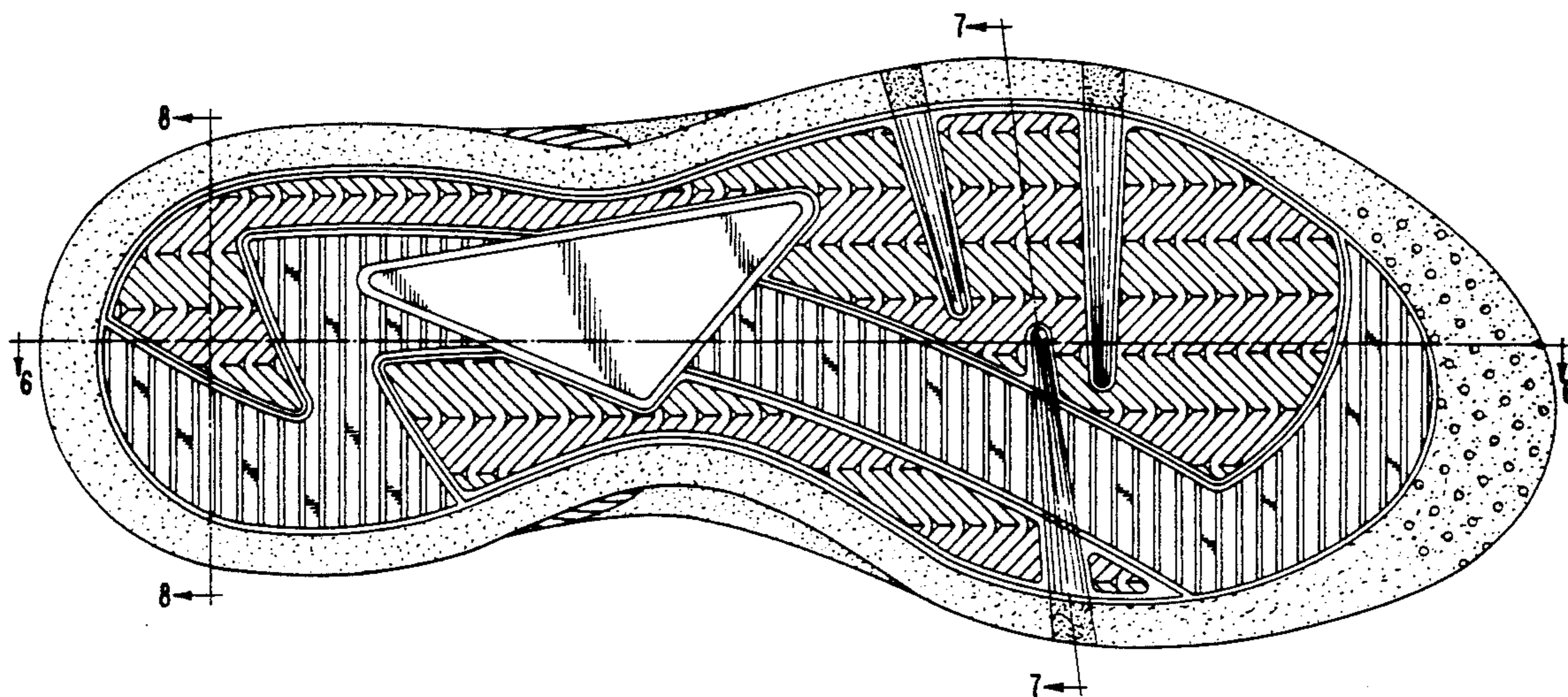

[57] **CLAIM**
 The ornamental design for a cup shaped shoe sole, as shown and described.

DESCRIPTION
 FIG. 1 is a side elevational view of one side of a cup shaped shoe sole showing my new design;
 FIG. 2 is a side elevational view of the other side of the cup shaped shoe sole shown in FIG. 1;
 FIG. 3 is a front elevational view of the cup shaped shoe sole shown in FIG. 1;
 FIG. 4 is a rear elevational view of the cup shaped shoe sole shown in FIG. 1;
 FIG. 5 is a bottom plan view of the cup shaped shoe sole of FIG. 1;
 FIG. 6 is a cross-sectional view along the line 6—6 in FIG. 5;
 FIG. 7 is a cross-sectional view along the line 7—7 in FIG. 5; and
 FIG. 8 is a cross-sectional view along the line 8—8 in FIG. 5.
 The broken line showing of a shoe upper in FIGS. 1-4 is for illustrative purposes only and forms no part of the claimed design.



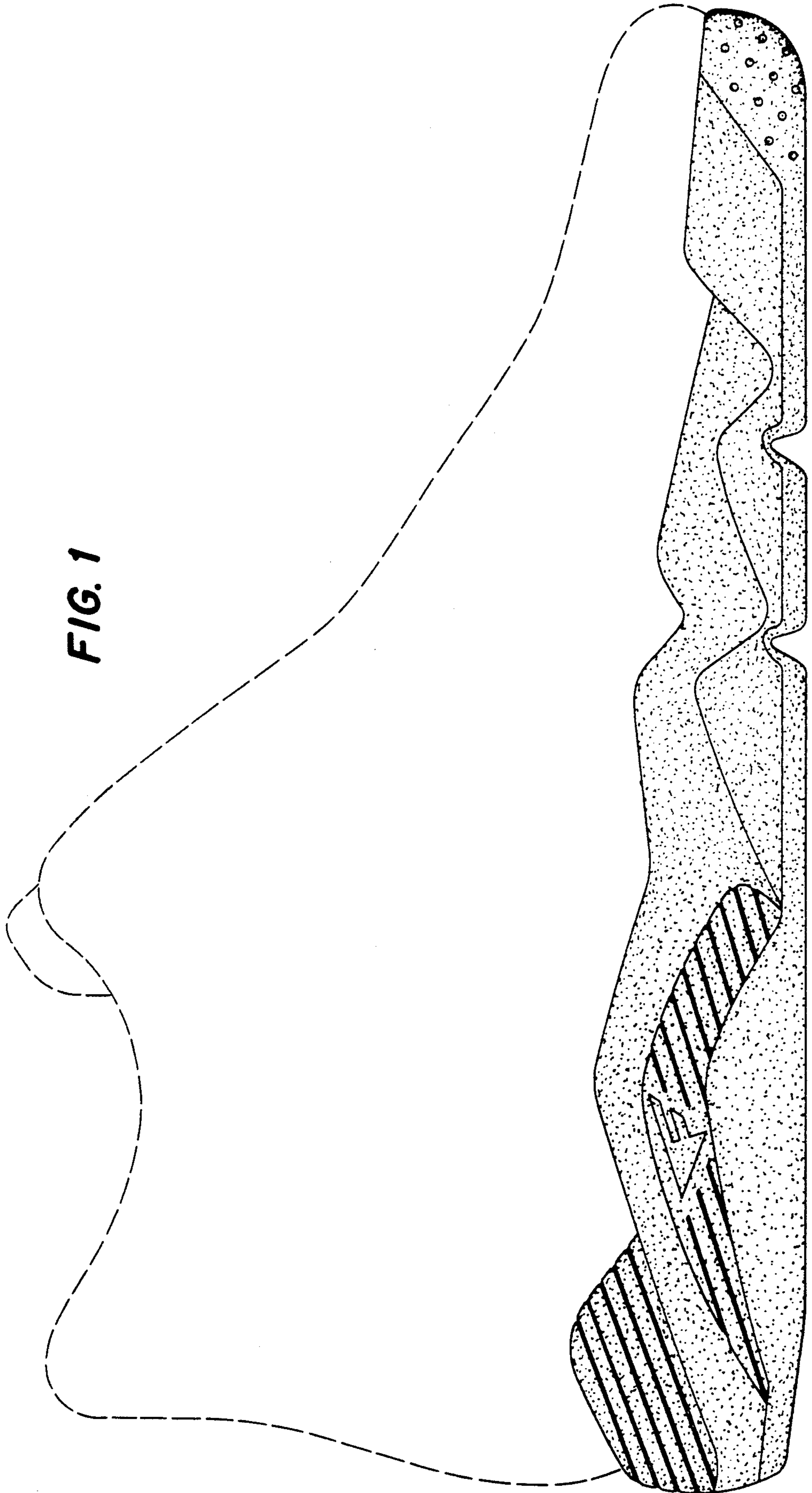

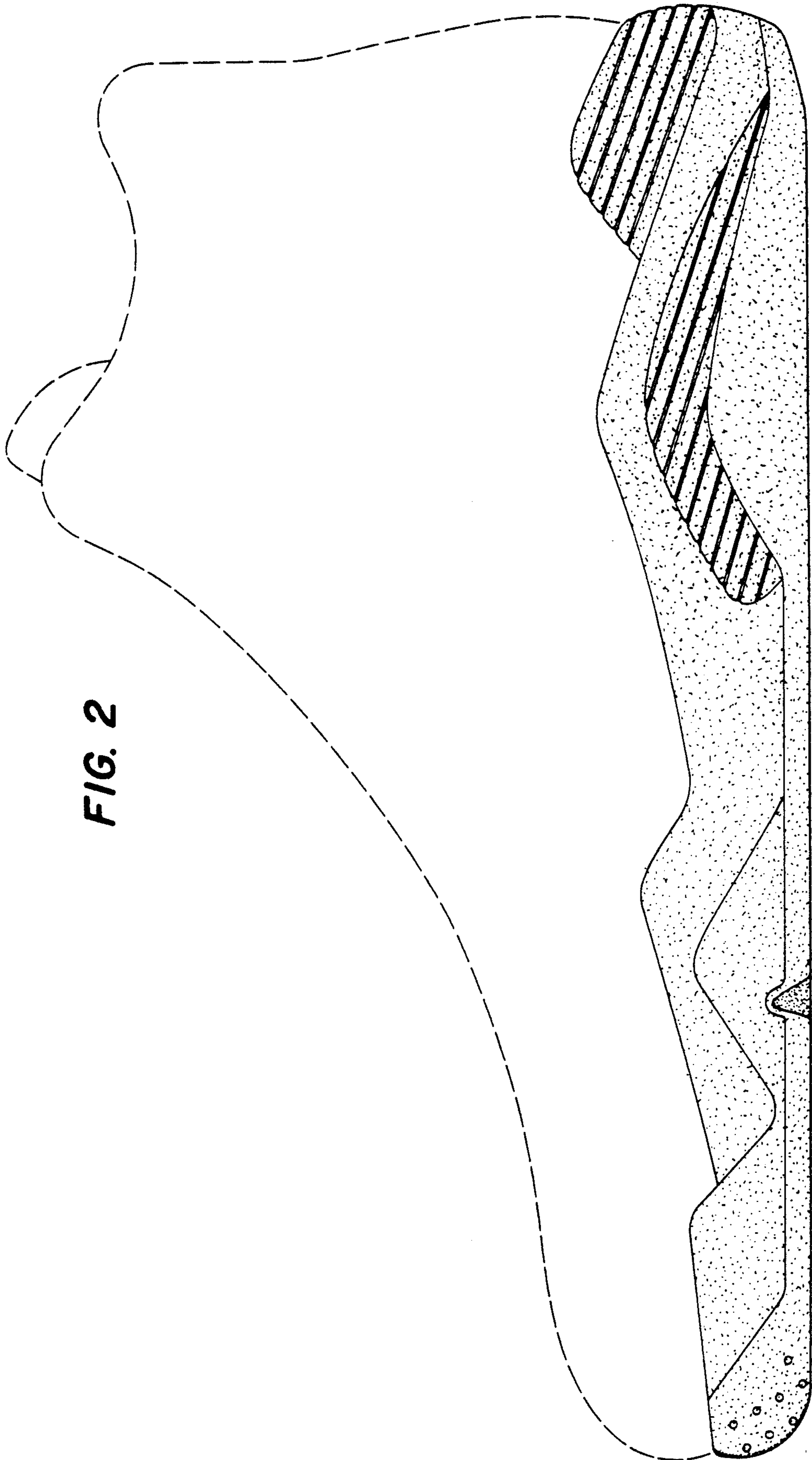

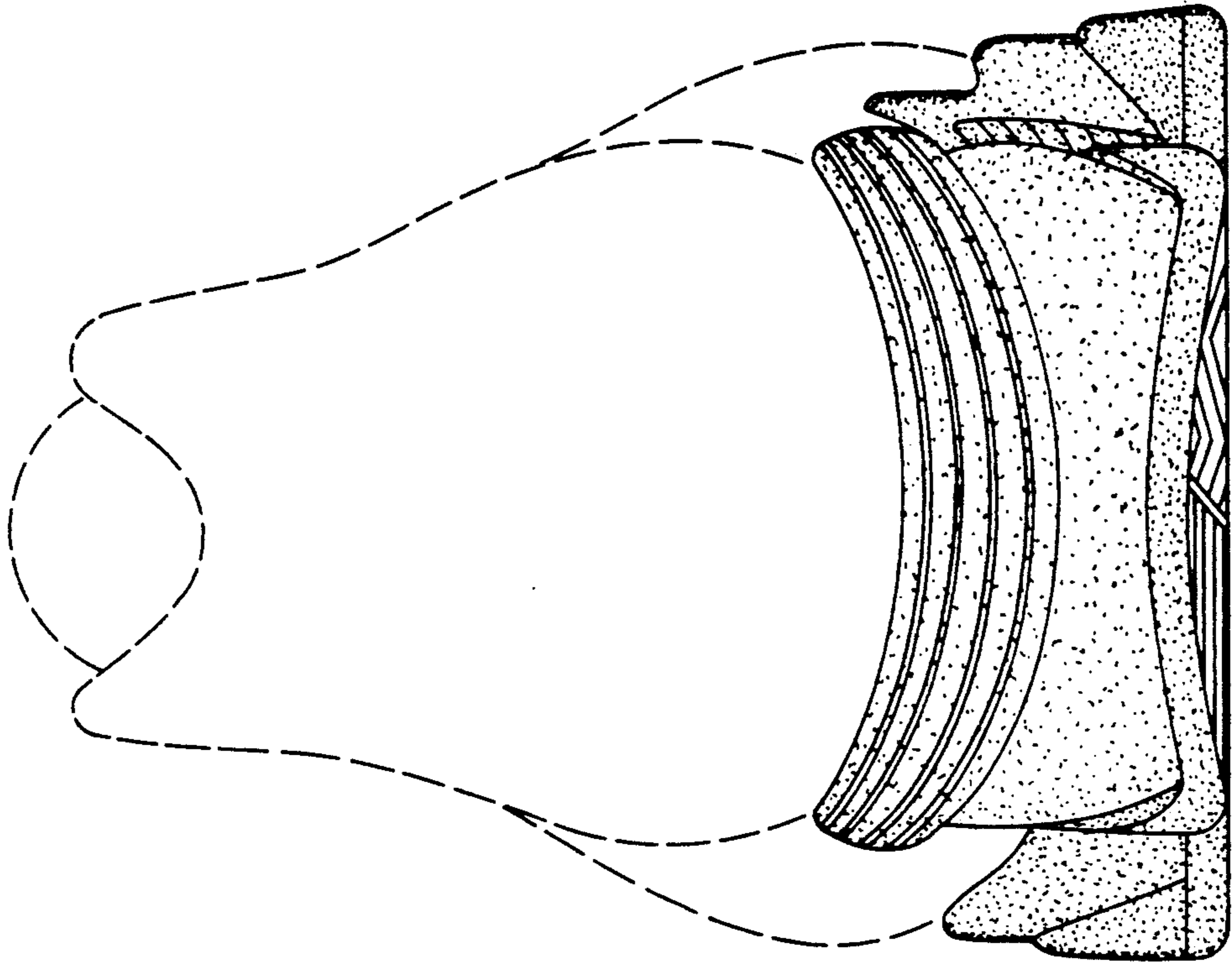

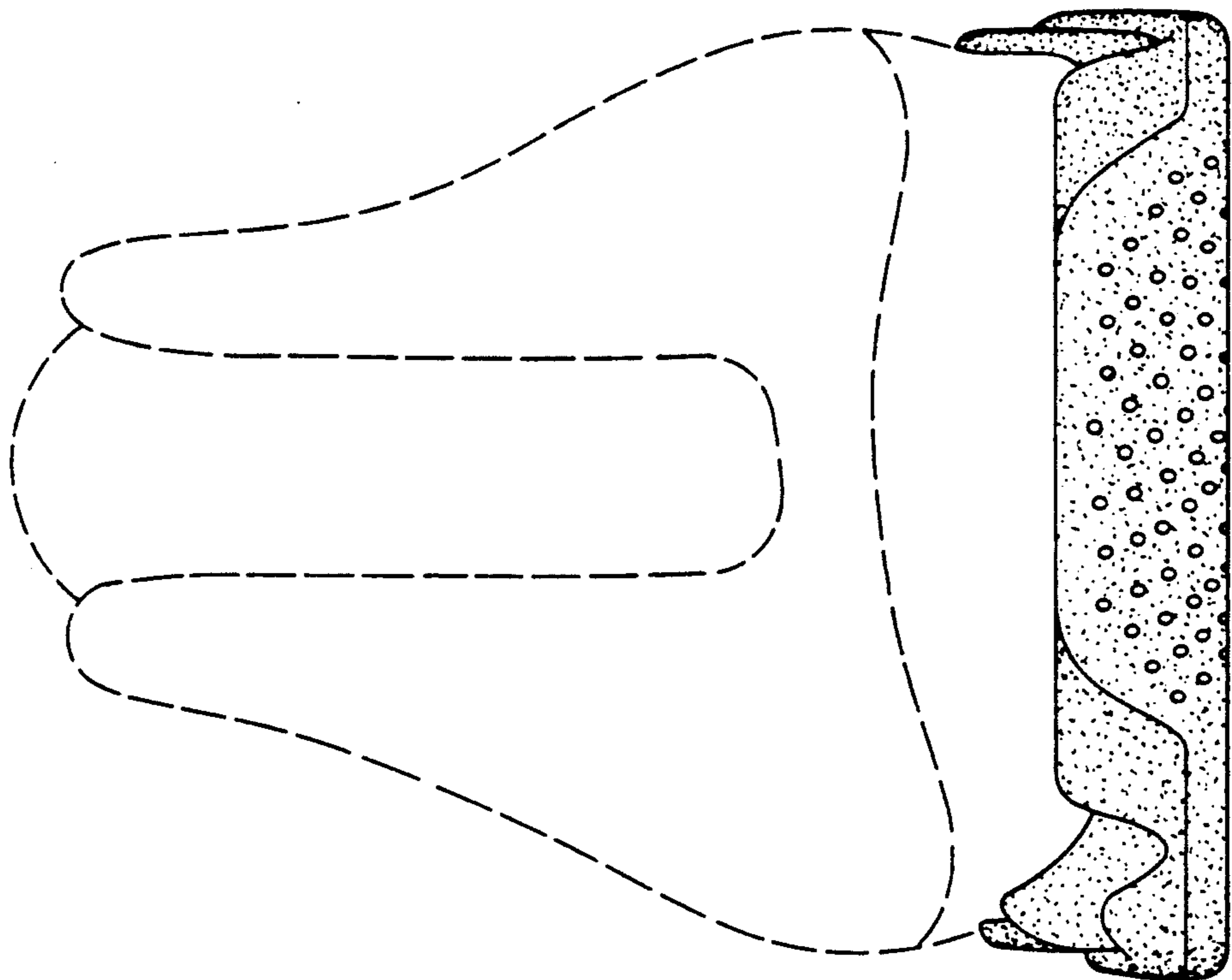
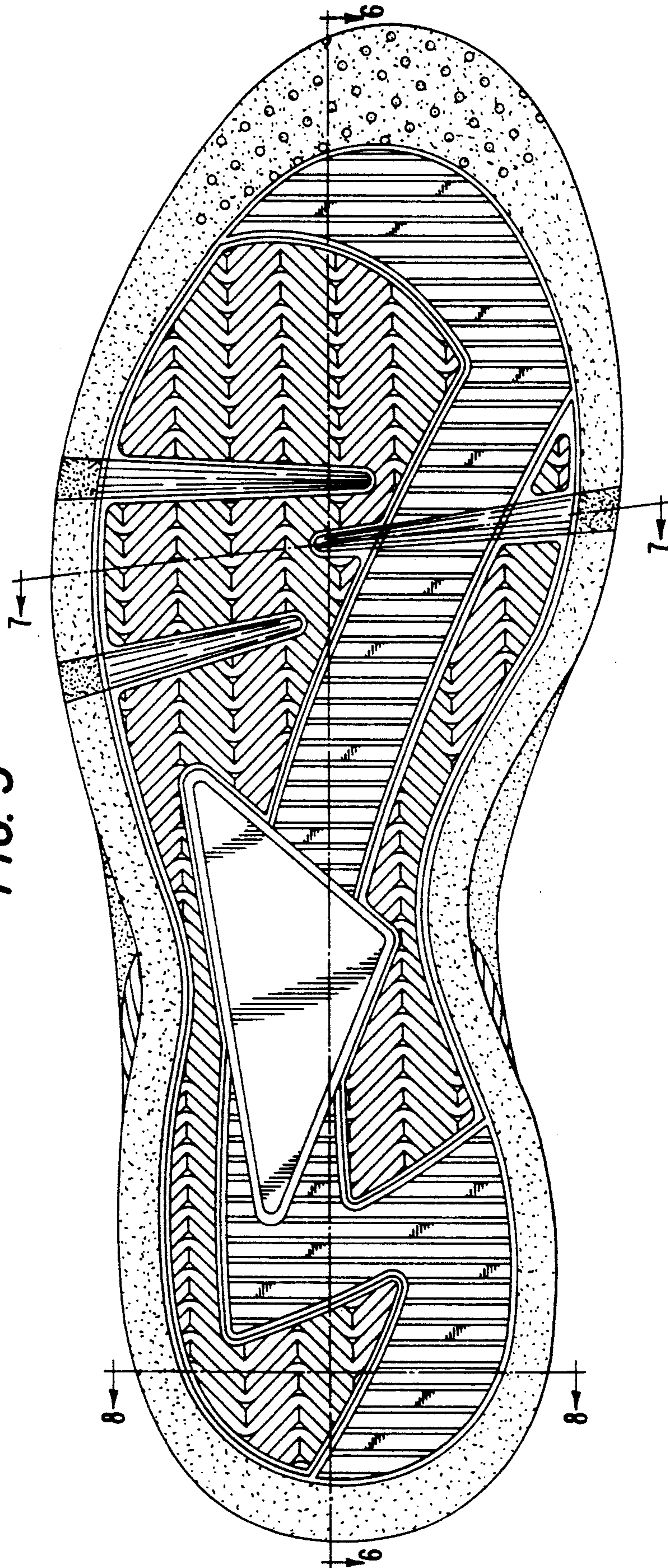

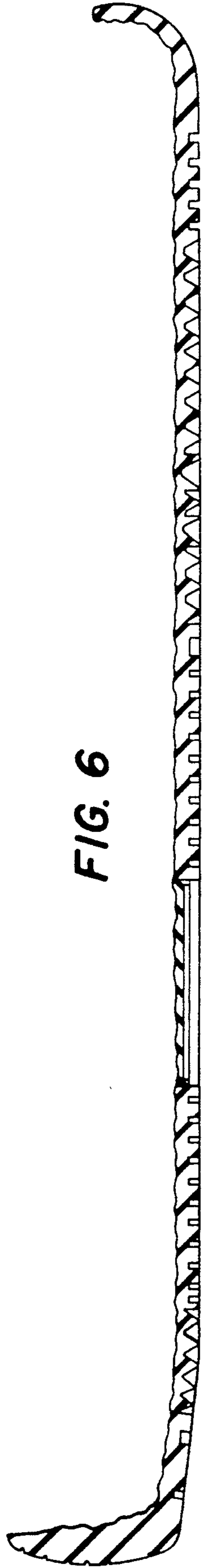

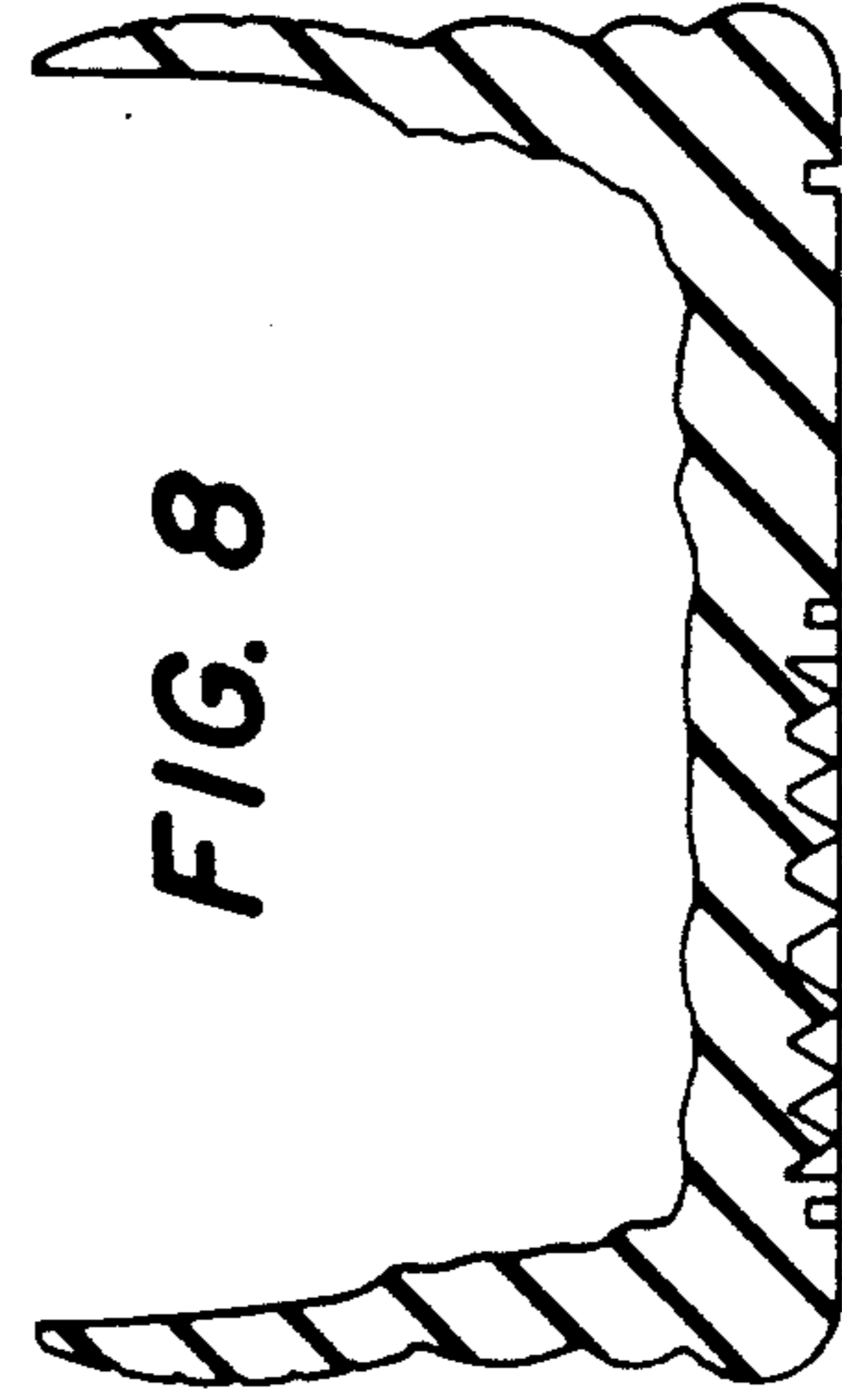
