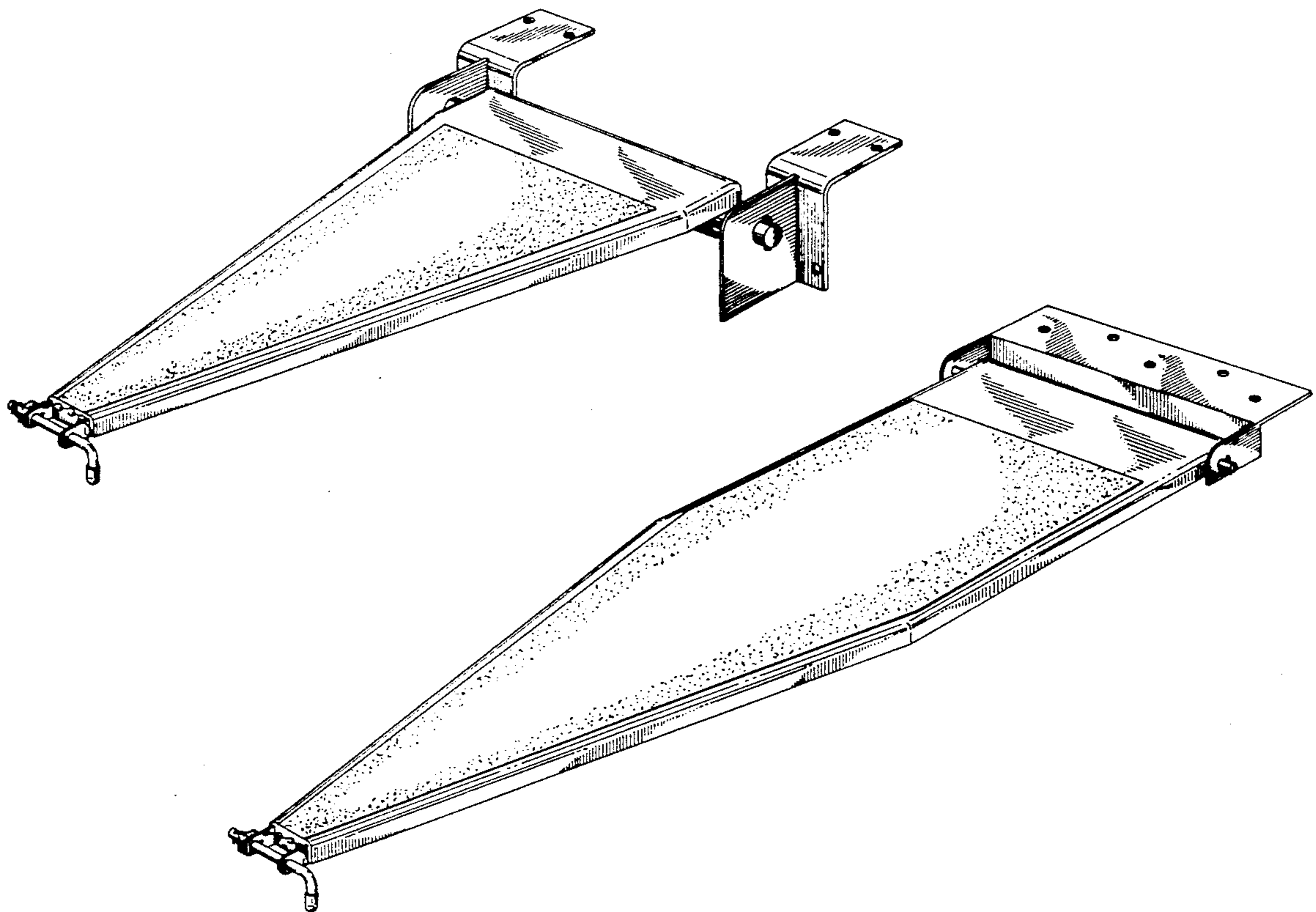

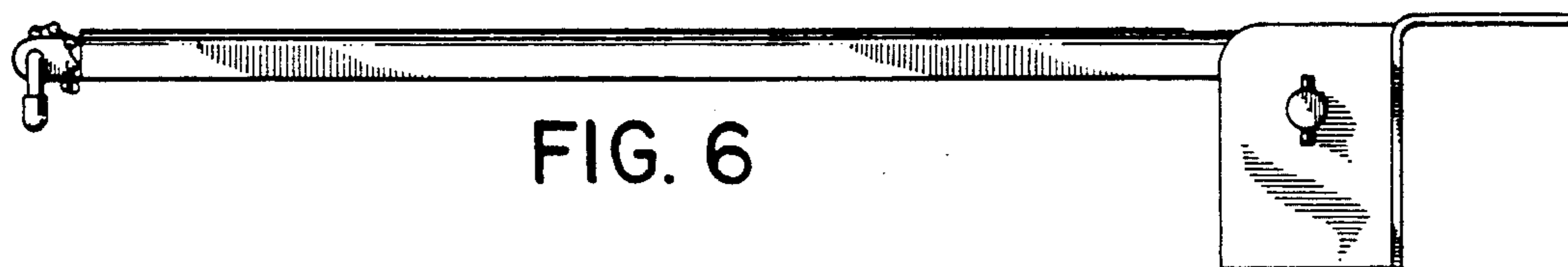
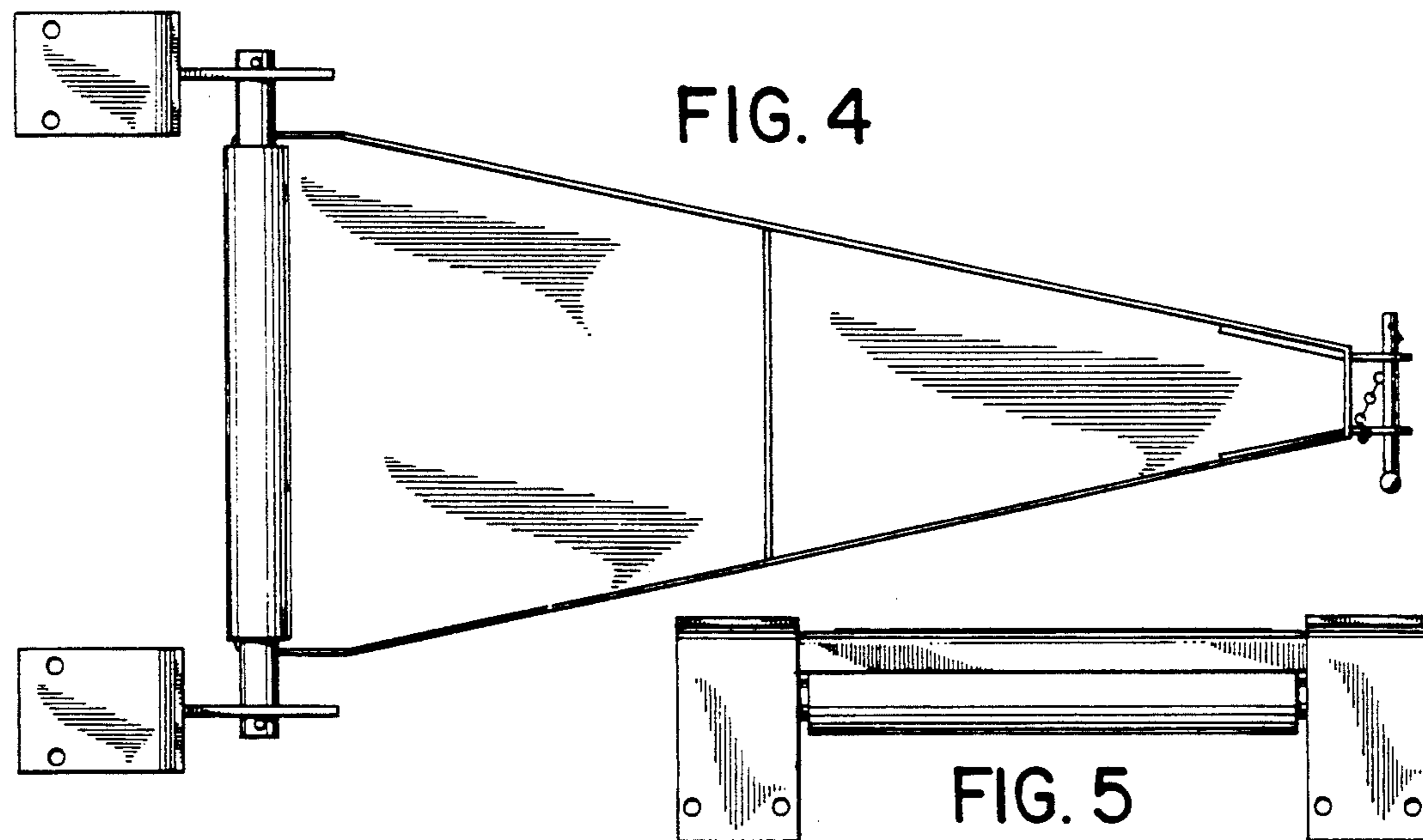
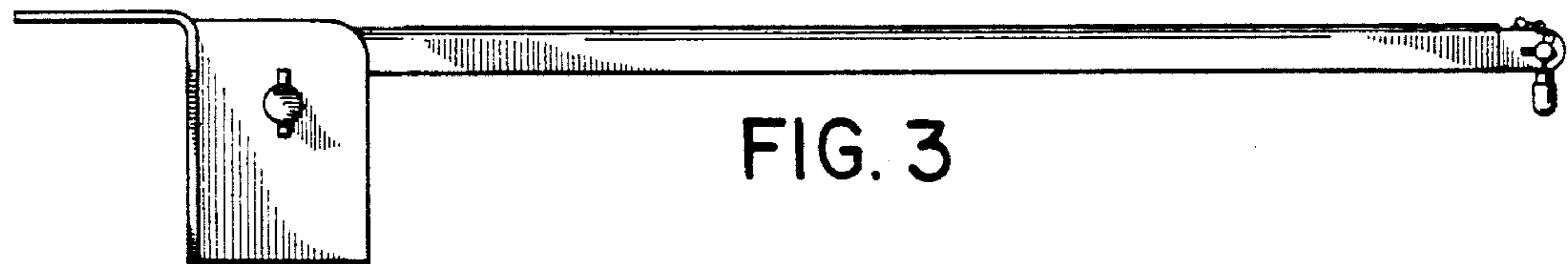
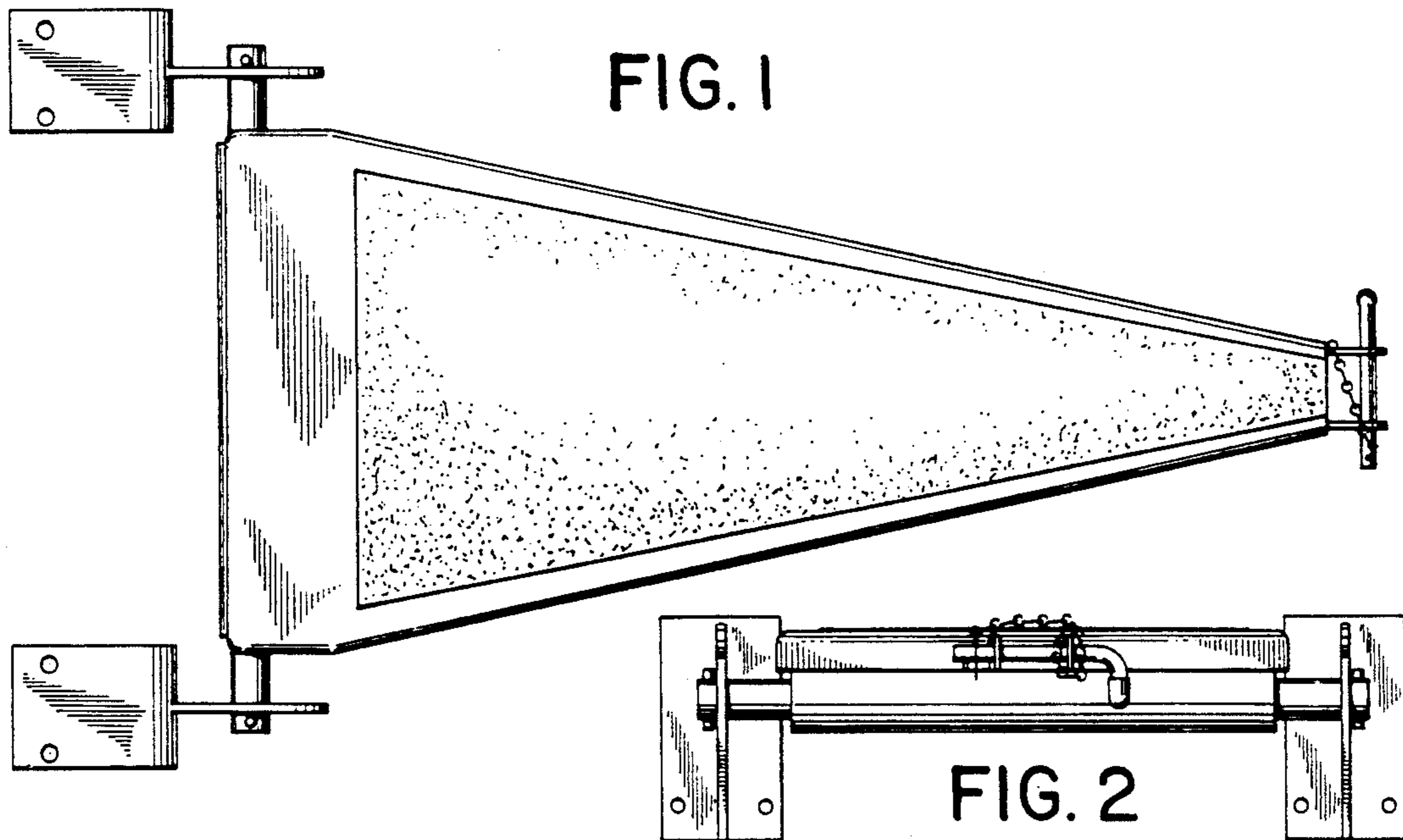
[57] **CLAIM**

The ornamental design for a boat boarding ramp, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a boat boarding ramp showing my new design;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a right side elevational view thereof;  
 FIG. 4 is a bottom plan view thereof;  
 FIG. 5 is a rear elevational view thereof;  
 FIG. 6 is a left side elevational view thereof;  
 FIG. 7 is a perspective view thereof;  
 FIG. 8 is a top plan view of a second embodiment of the design shown in FIG. 1;  
 FIG. 9 is a front elevational view thereof;  
 FIG. 10 is a right side elevational view thereof;

 FIG. 14 is a perspective view thereof.





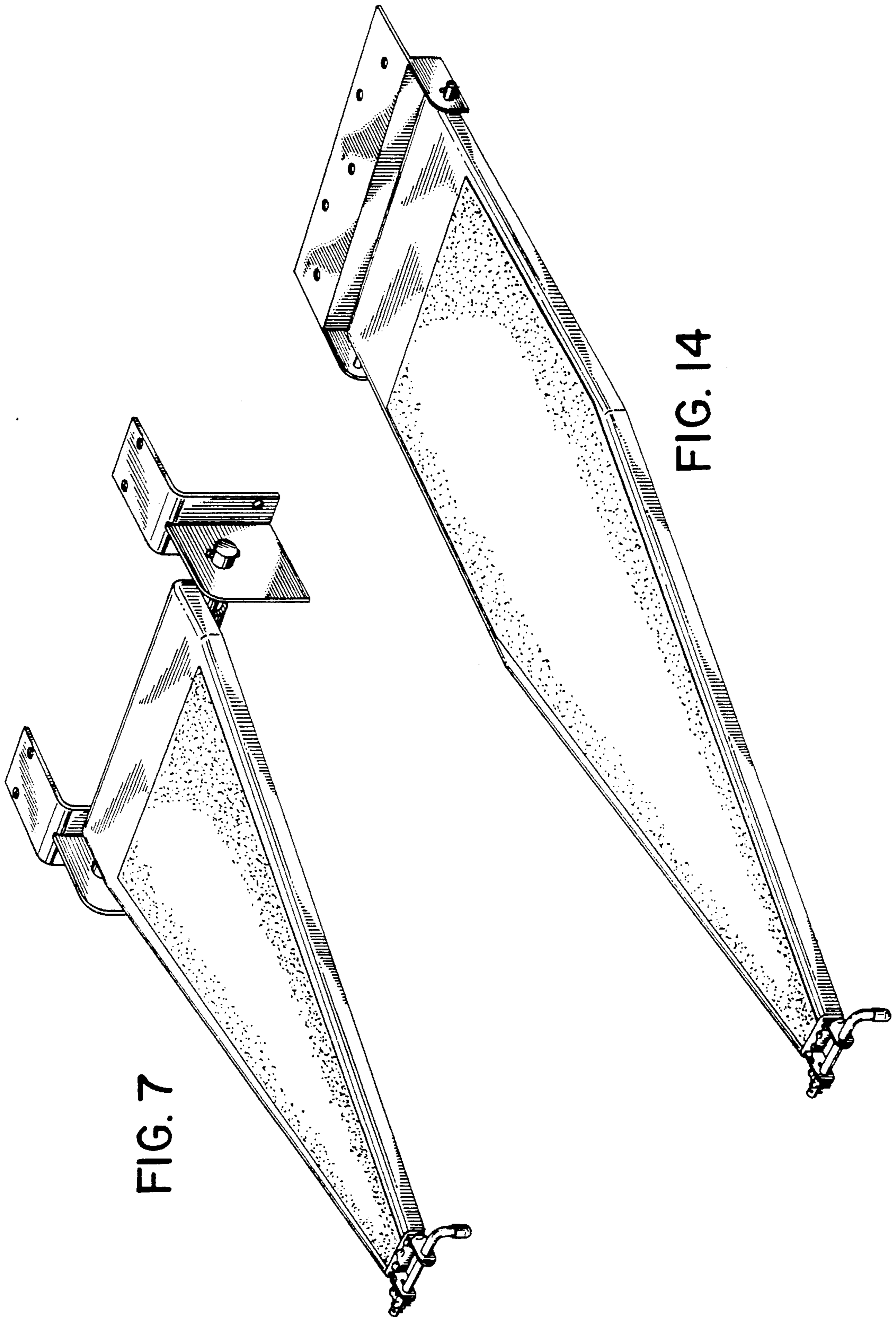
