The ornamental design for a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevational view of a shoe upper showing my new design;

 FIG. 10 is a rear elevational view thereof;
 FIG. 11 is a right side elevational view of a shoe upper showing still another embodiment of my new design;
 FIG. 12 is a left side elevational view thereof;
 FIG. 13 is a top plan view thereof;
 FIG. 14 is a front elevational view thereof;
 FIG. 15 is a rear elevational view thereof;
 FIG. 16 is a right side elevational view thereof of a shoe upper showing yet another embodiment of my new design;
 FIG. 17 is a left side elevational view thereof;
 FIG. 18 is a top plan view thereof;
 FIG. 19 is a front elevational view thereof; and,
 FIG. 20 is a rear elevational view thereof.
 The broken line drawing of a shoe sole in FIGS. 1-20 is for illustrative purposes only and forms no part of the claimed design.

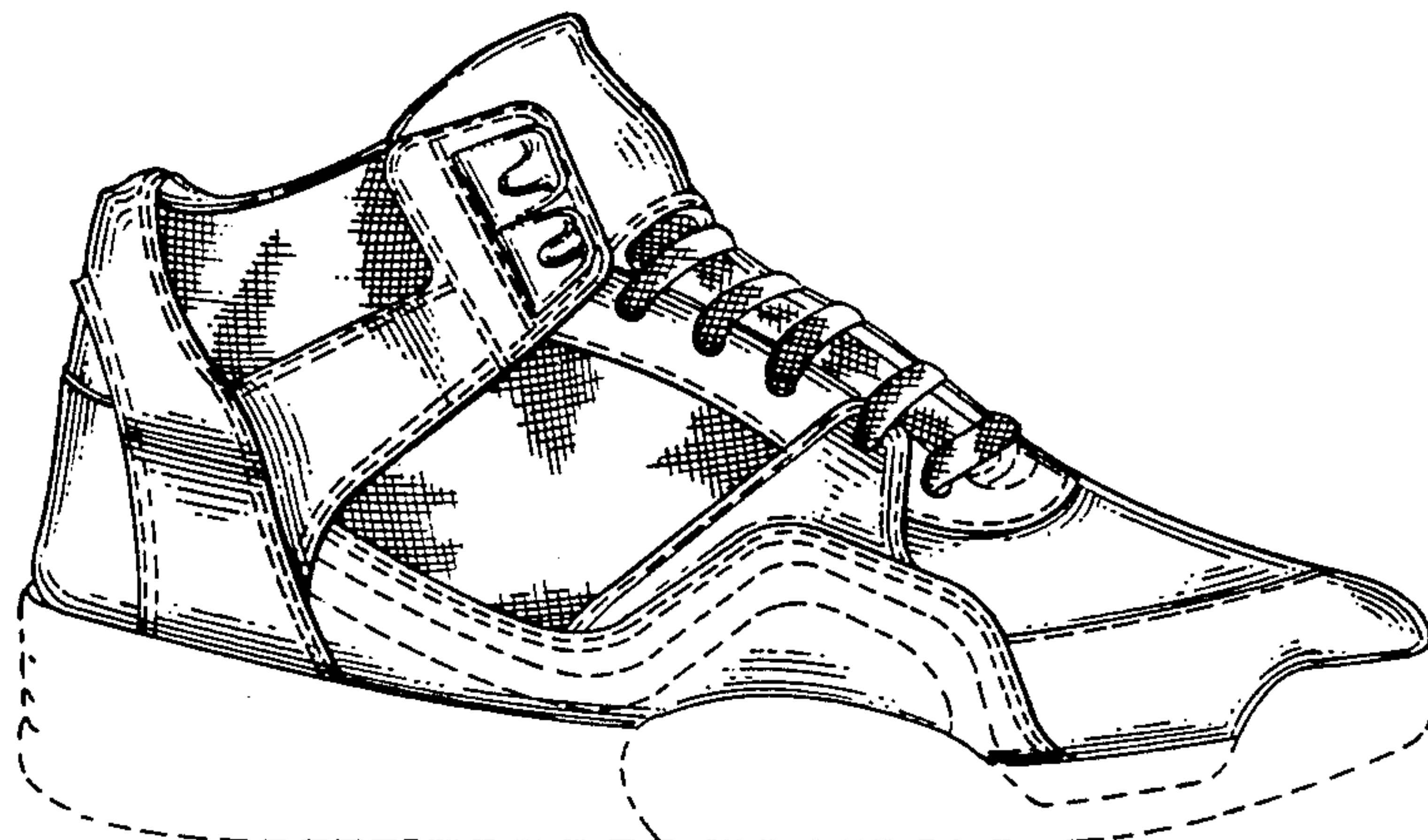
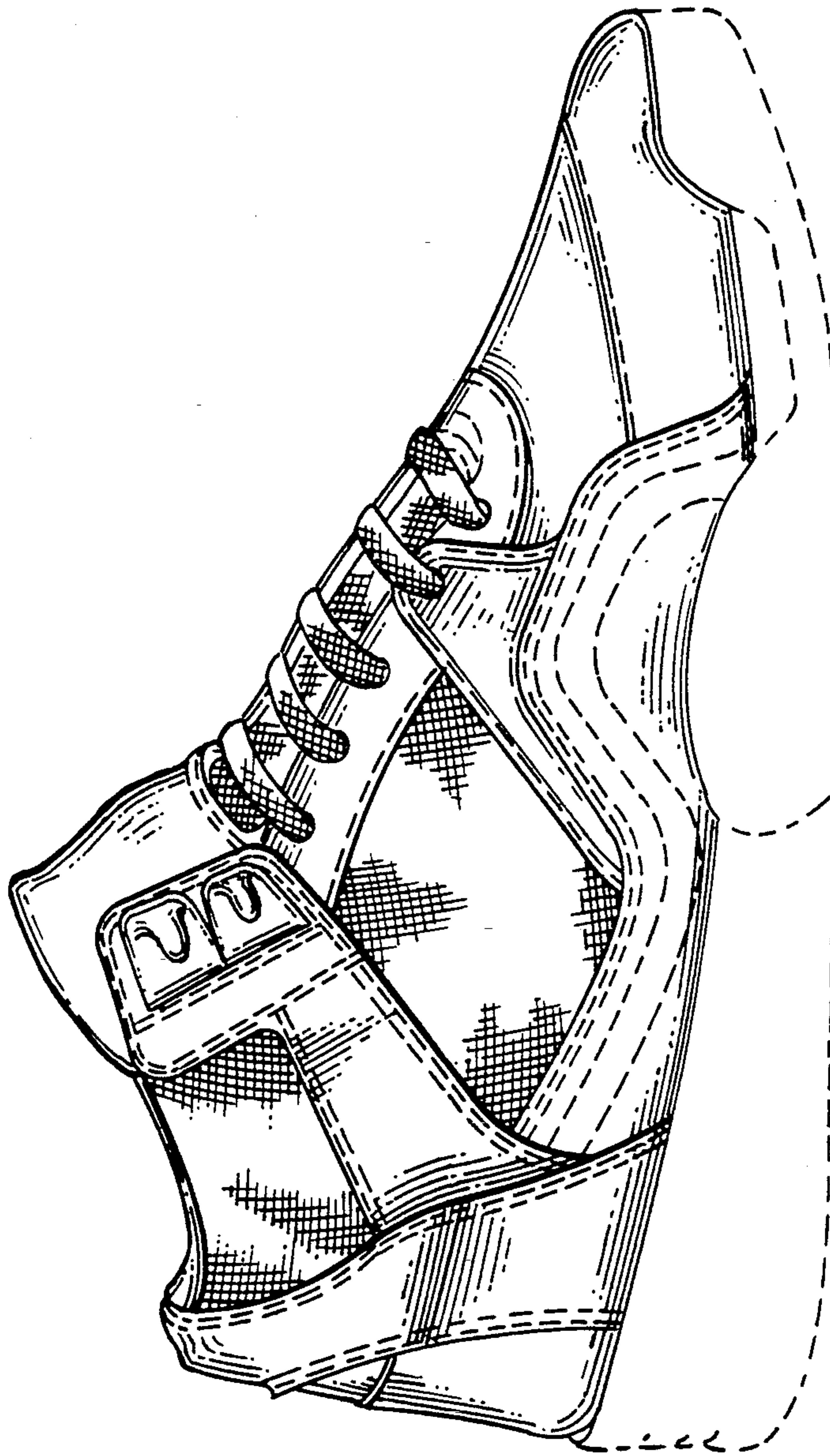

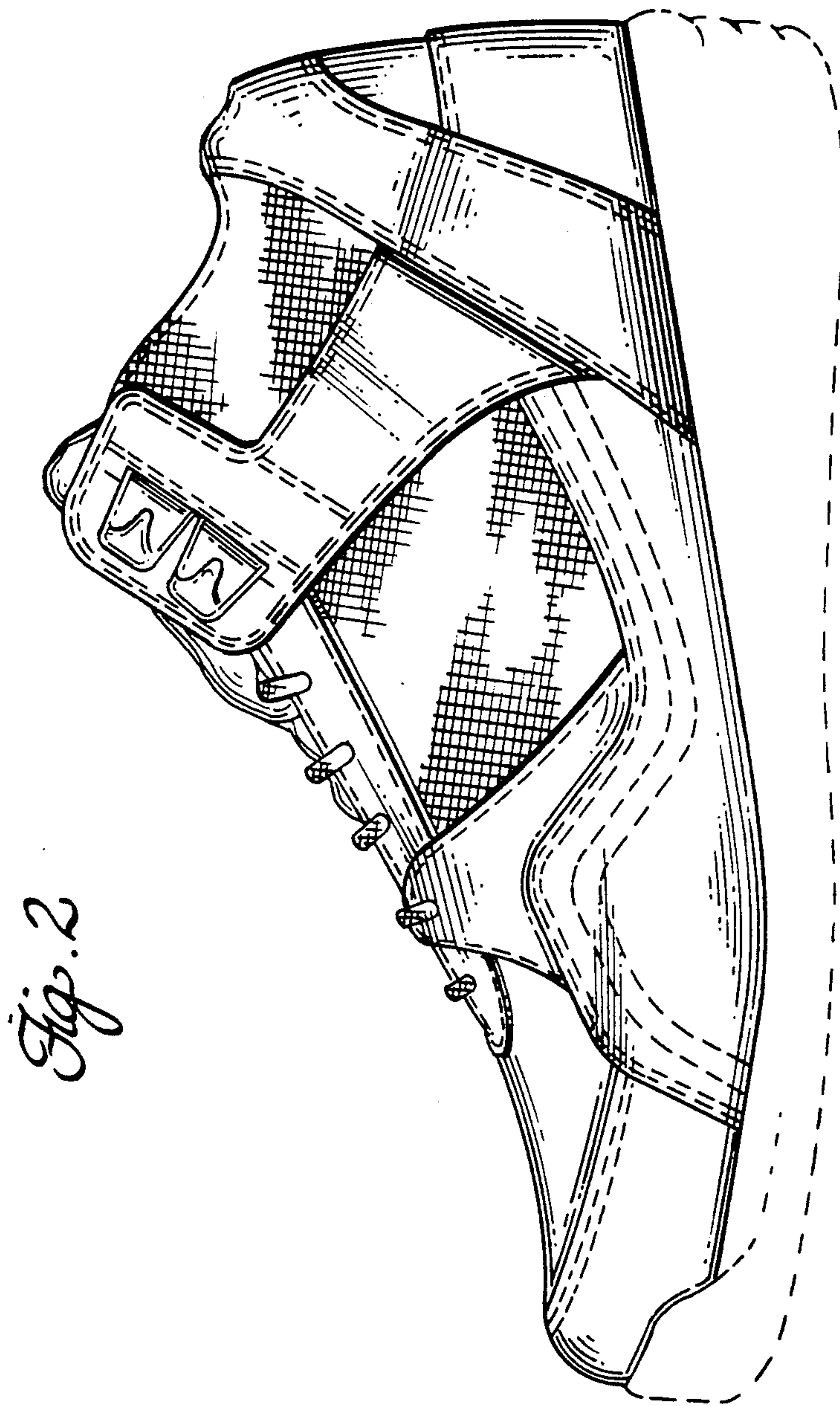

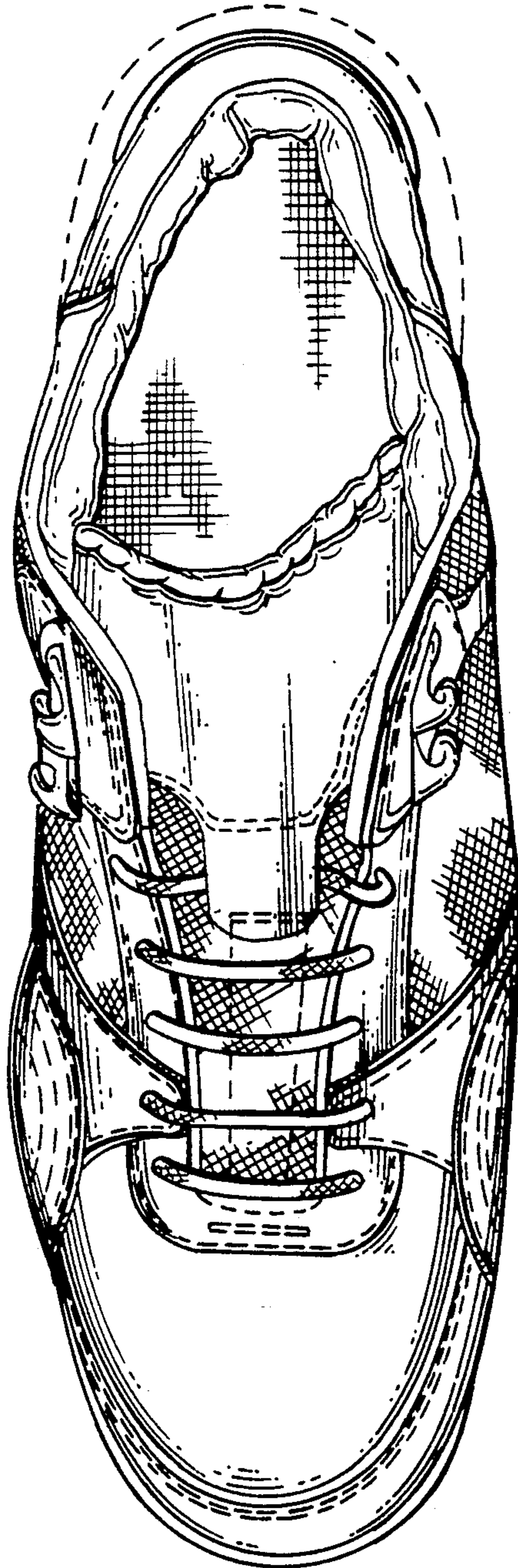

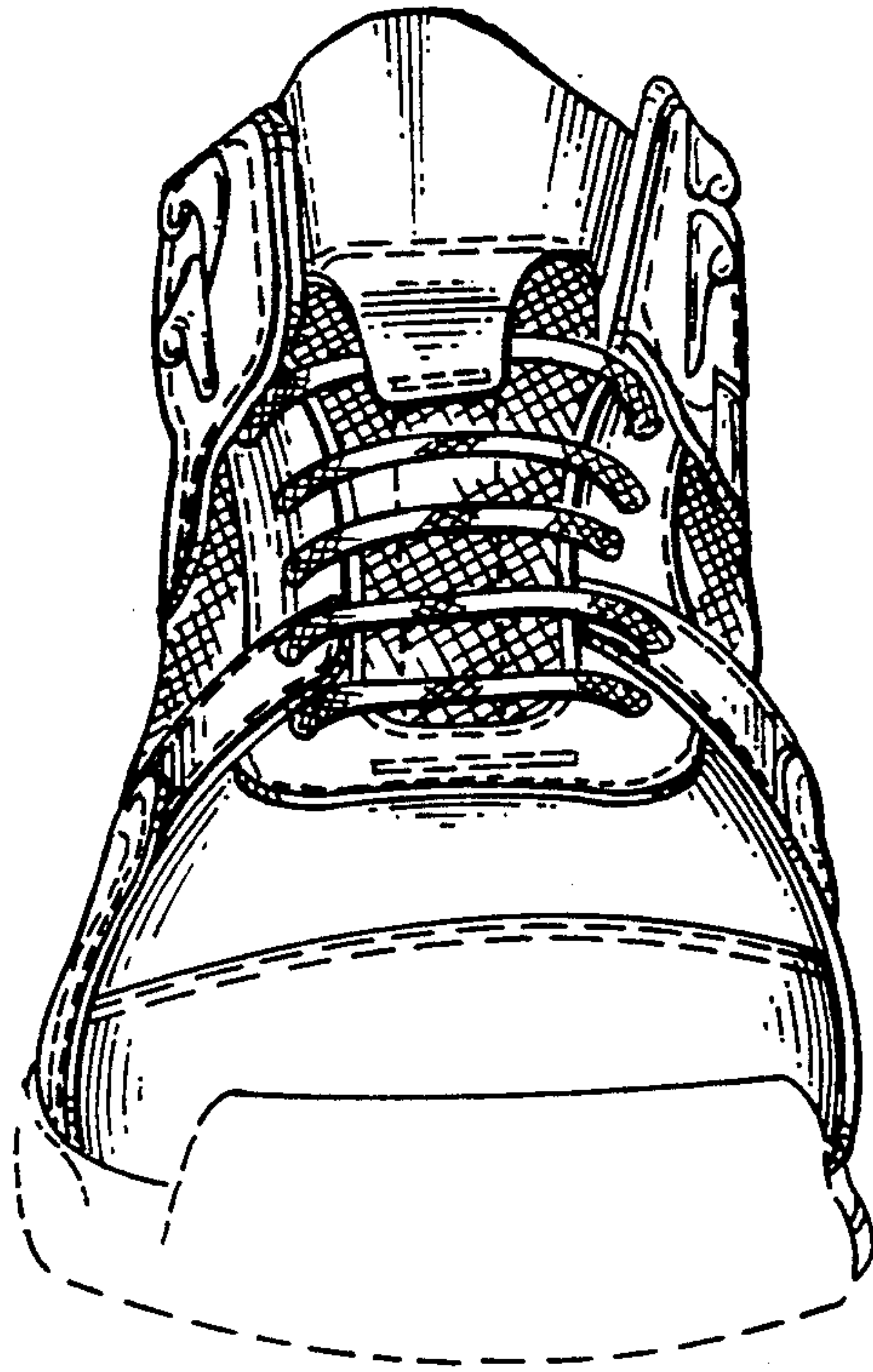

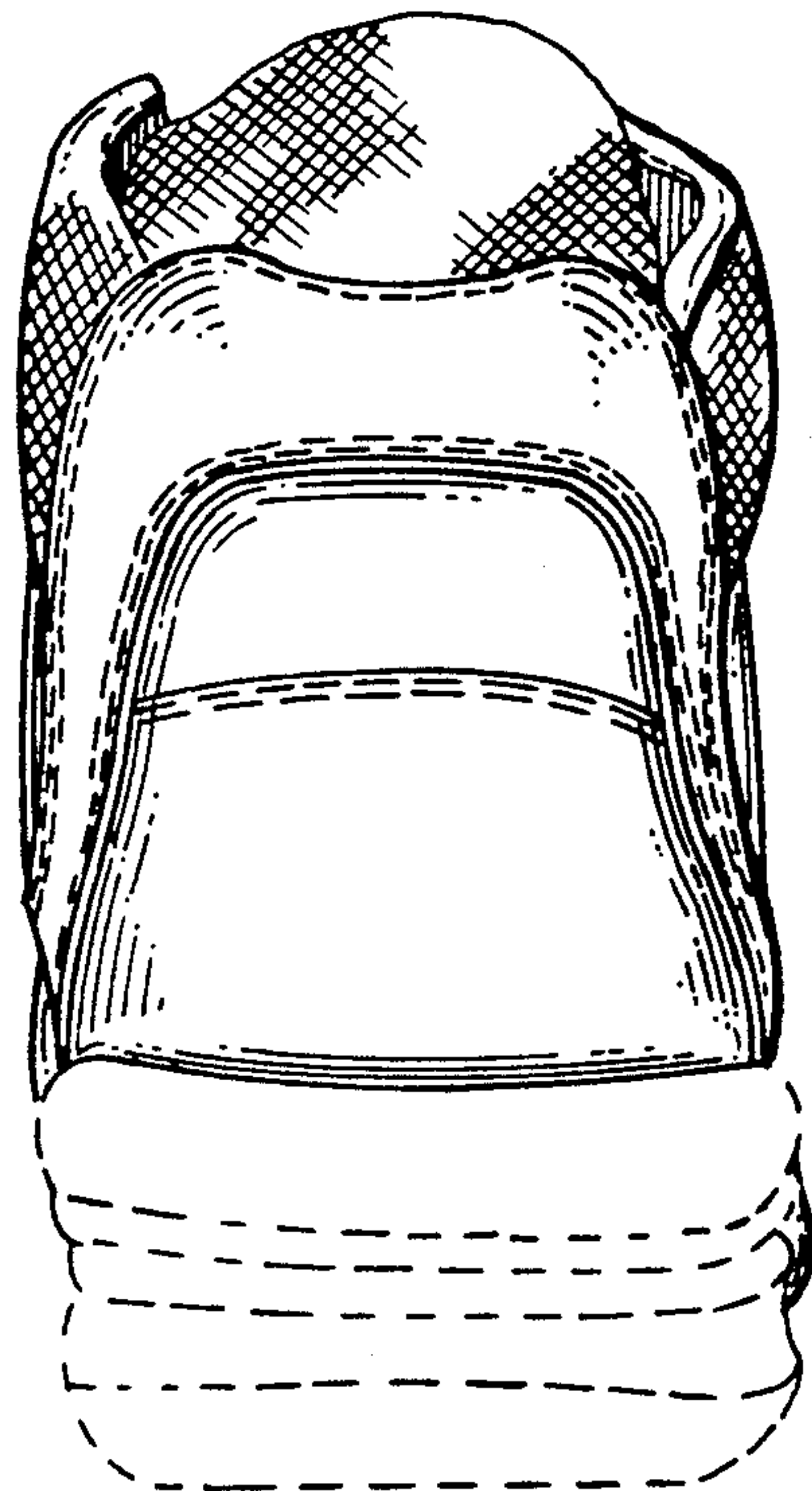
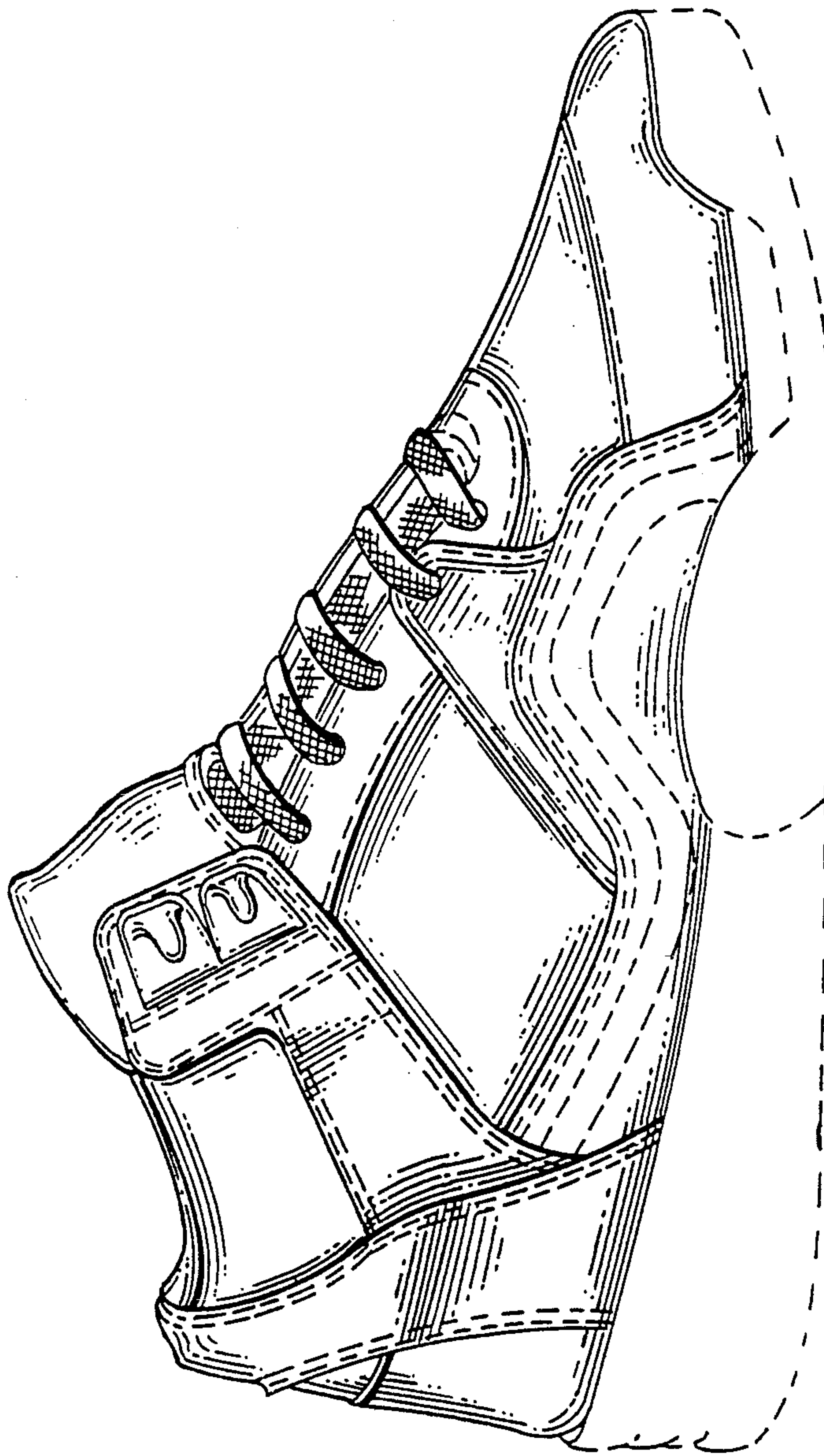

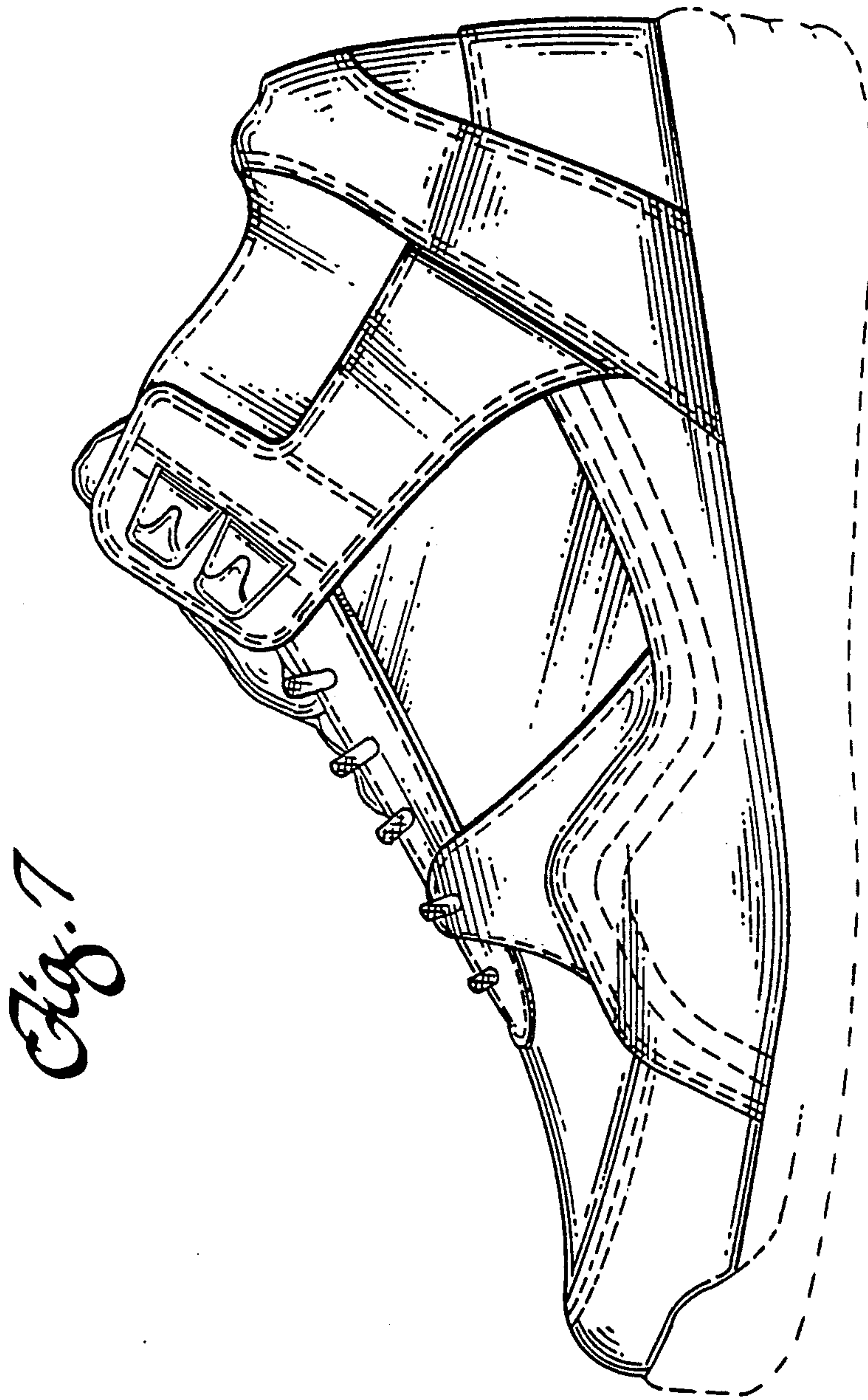

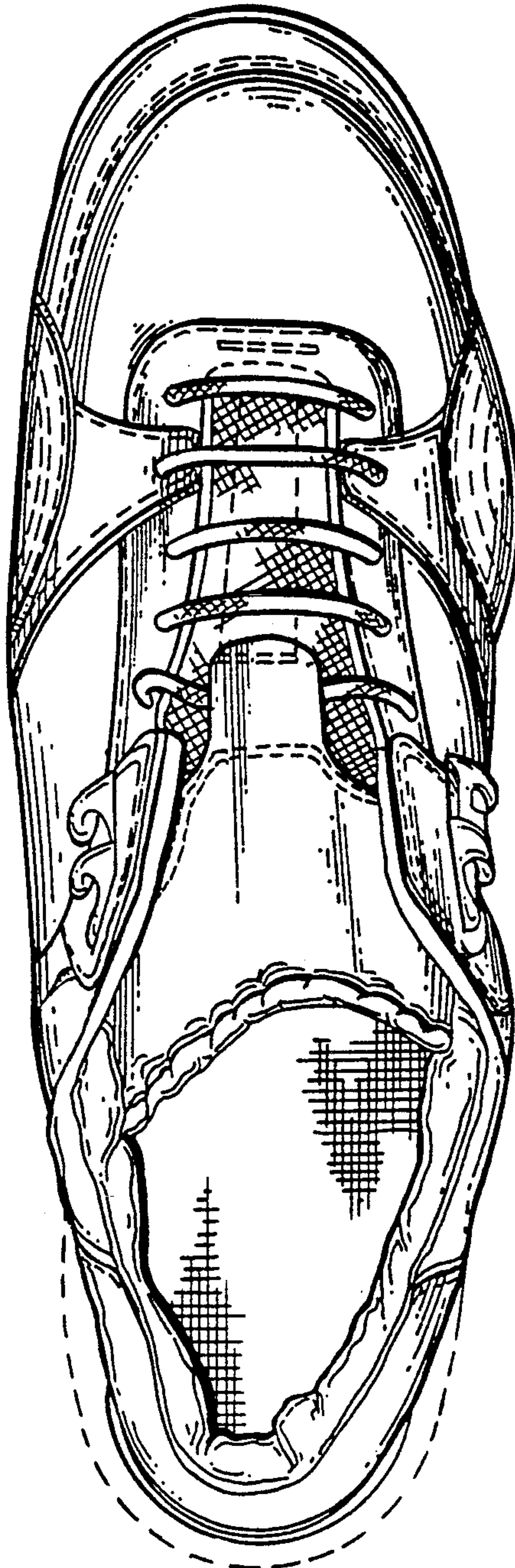

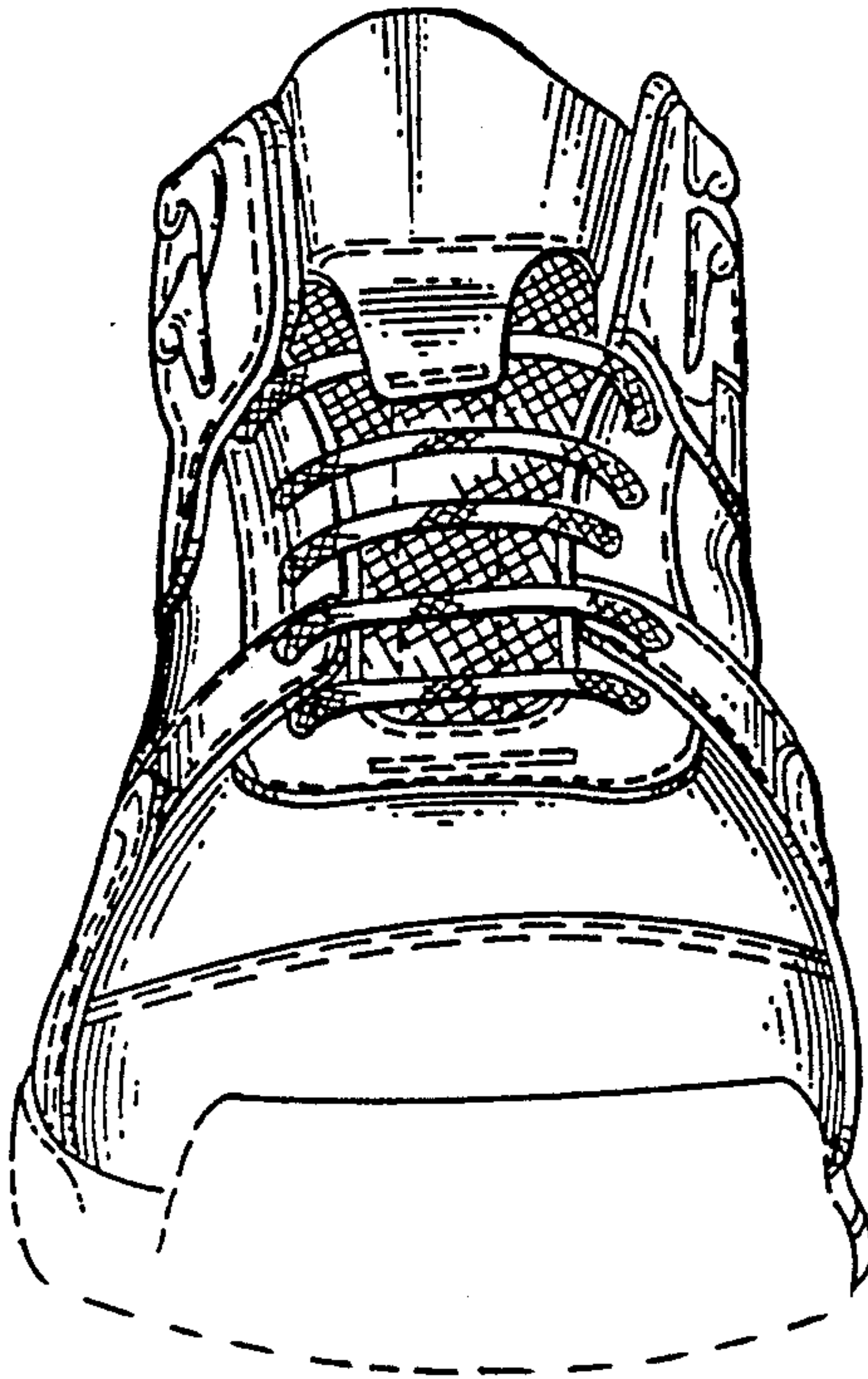

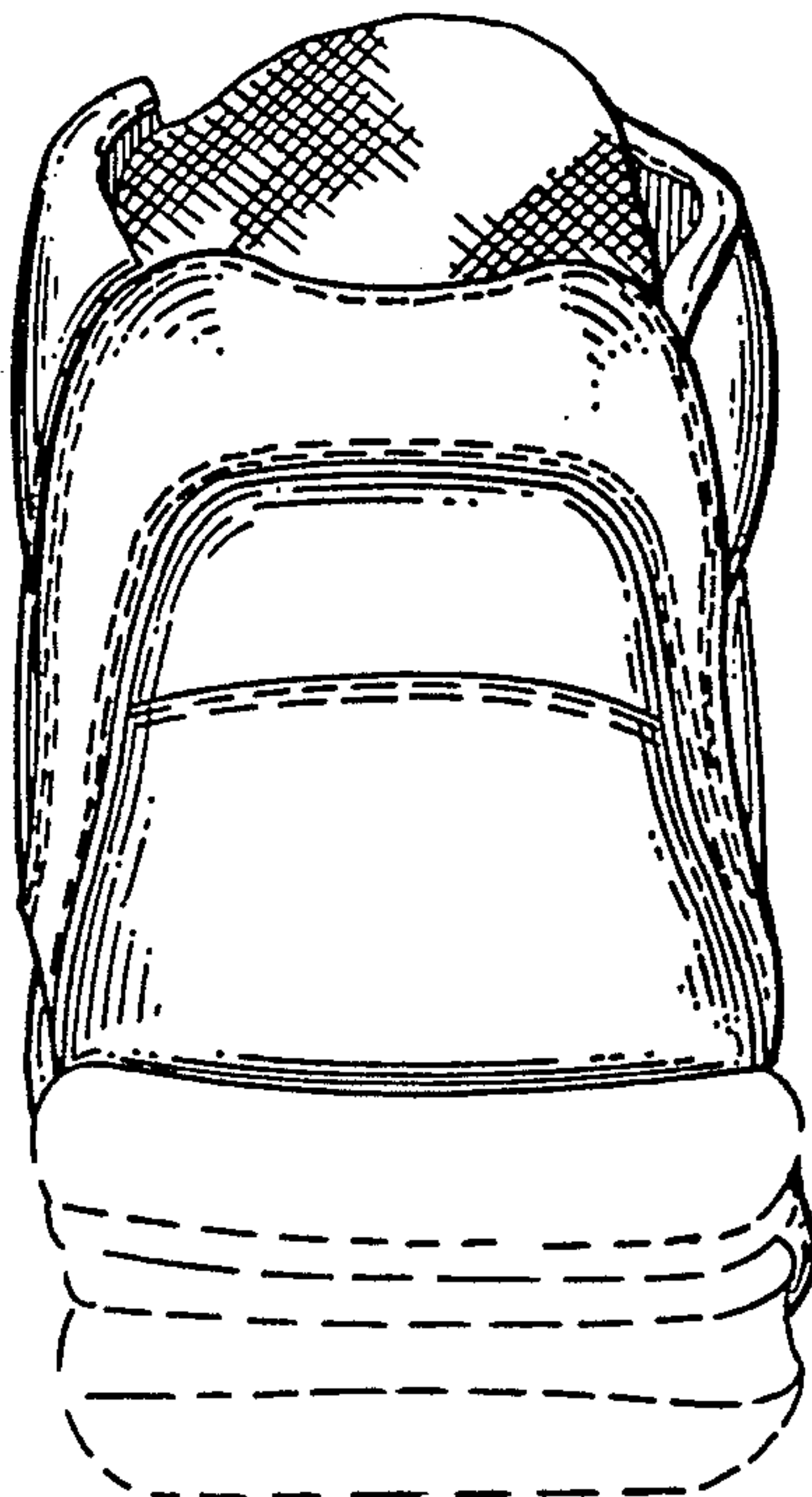

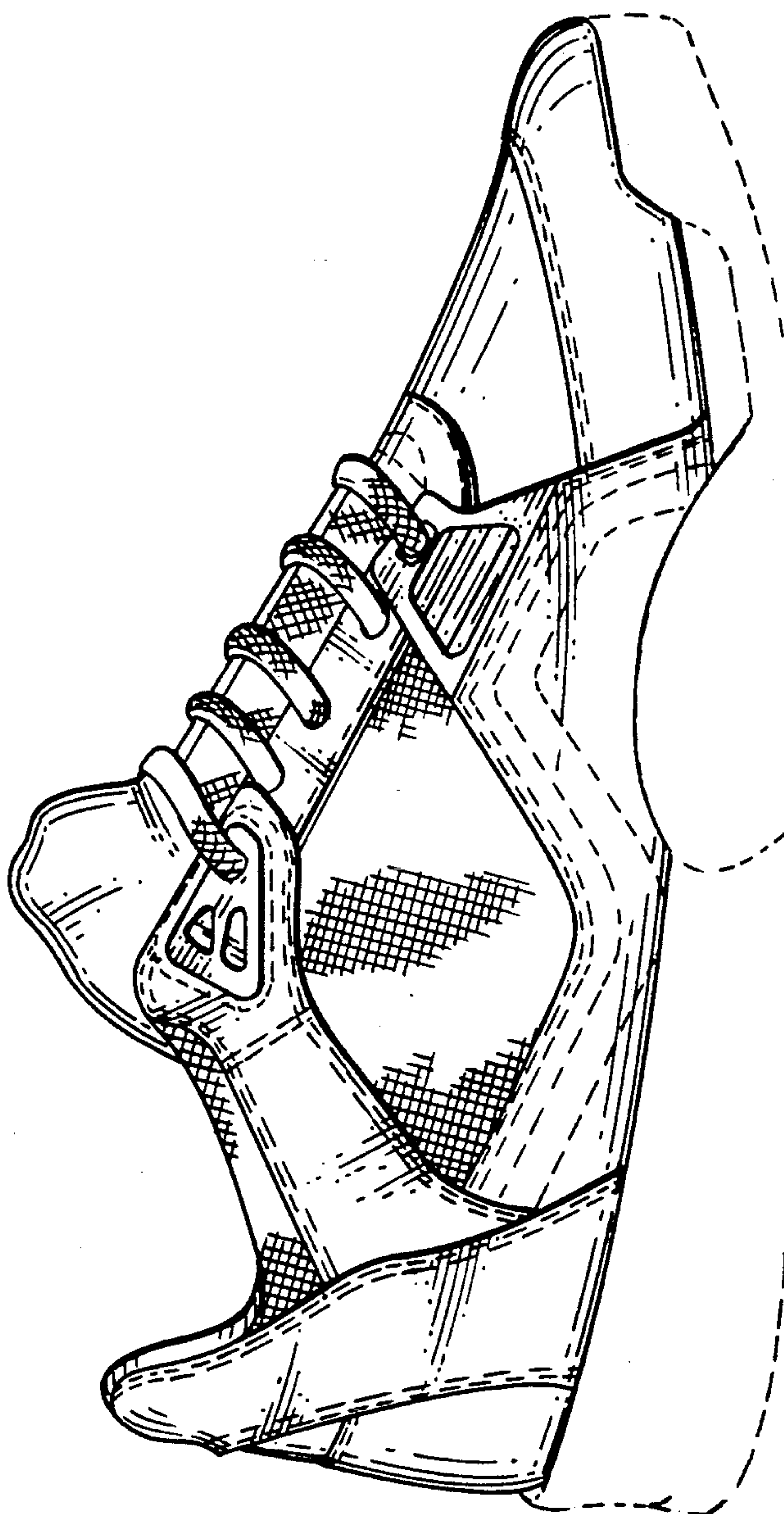

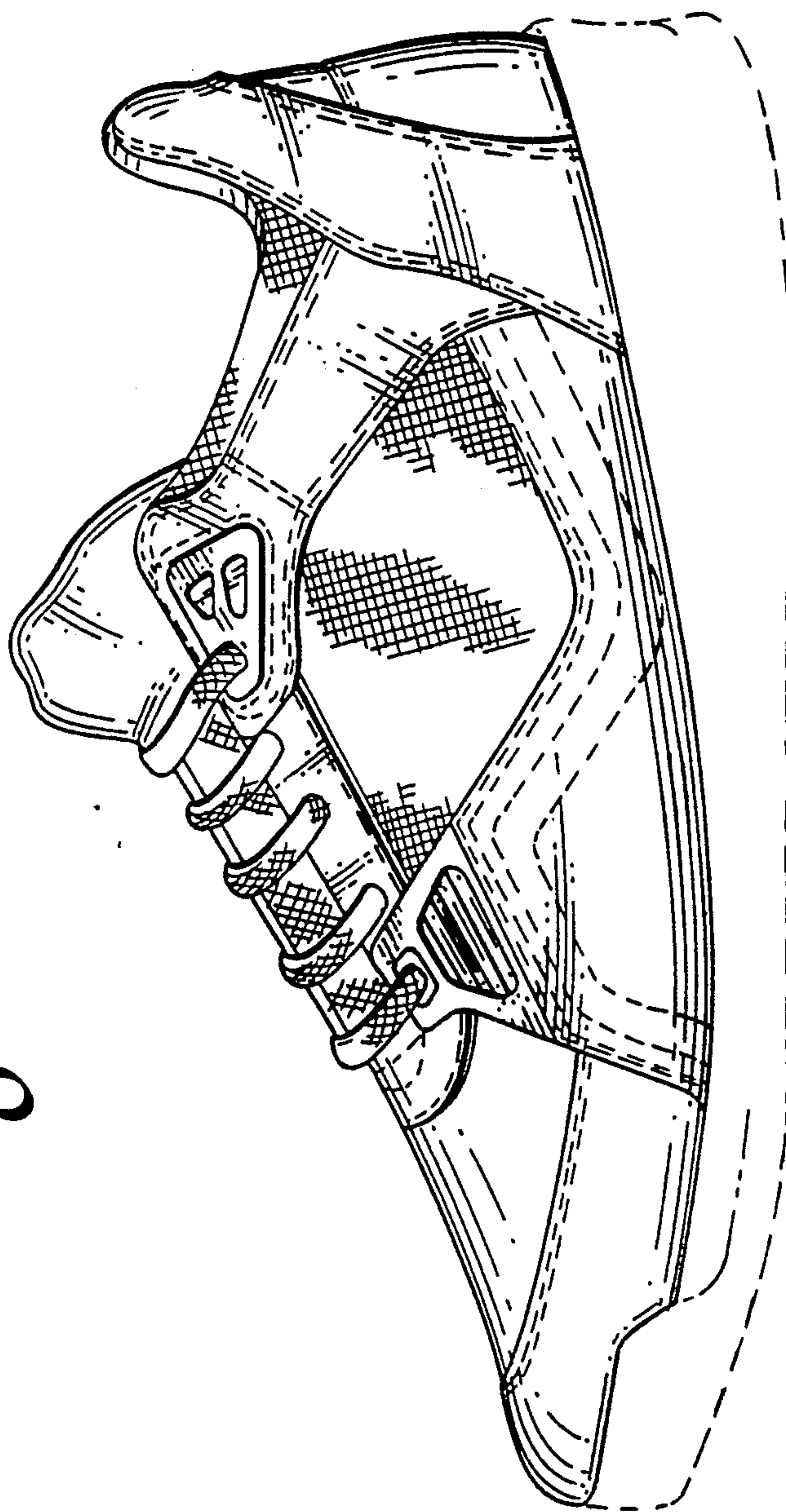

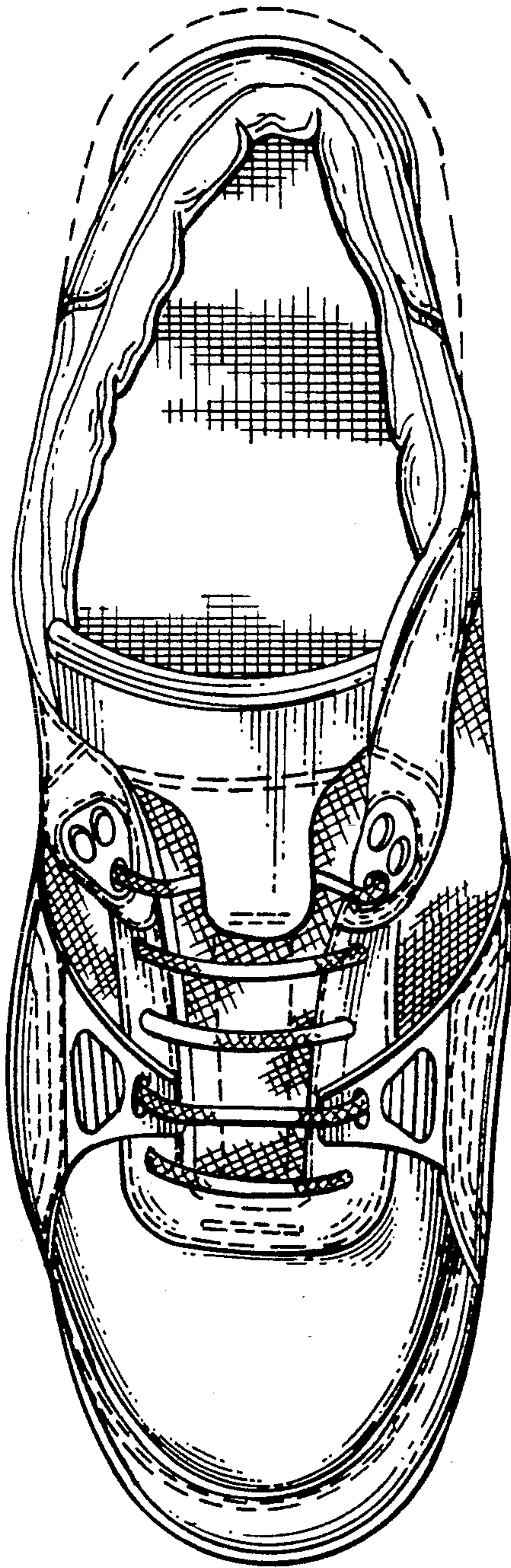

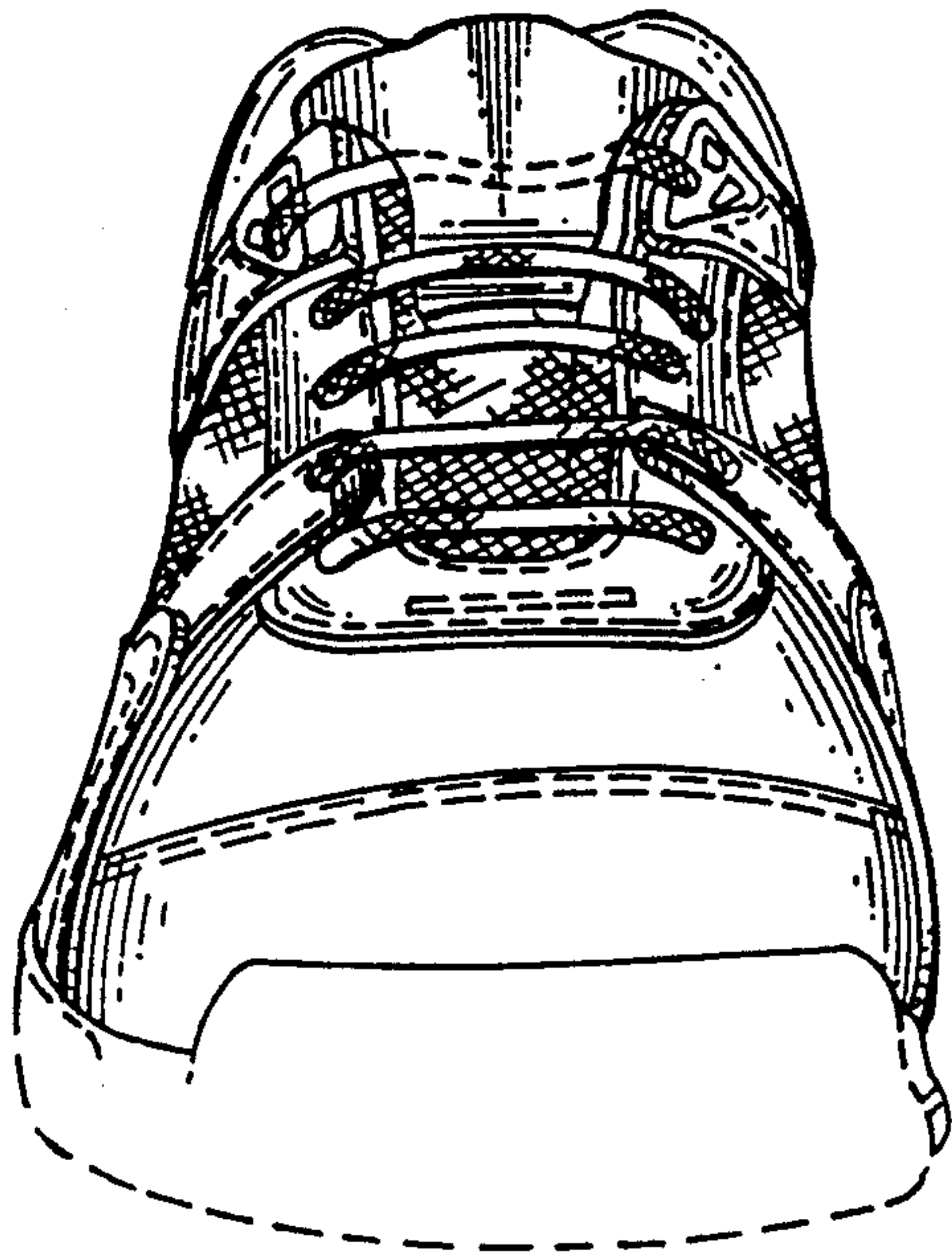

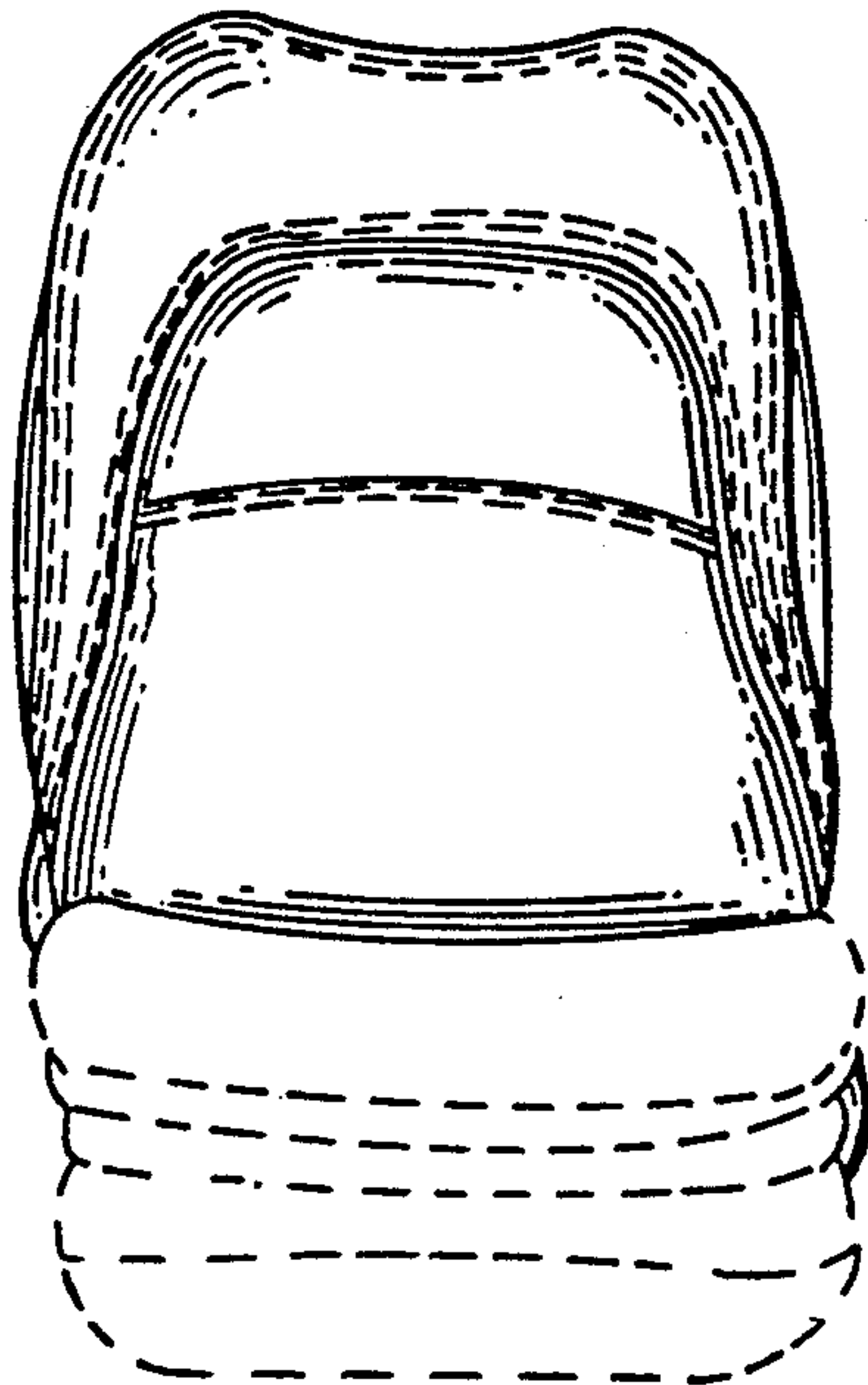

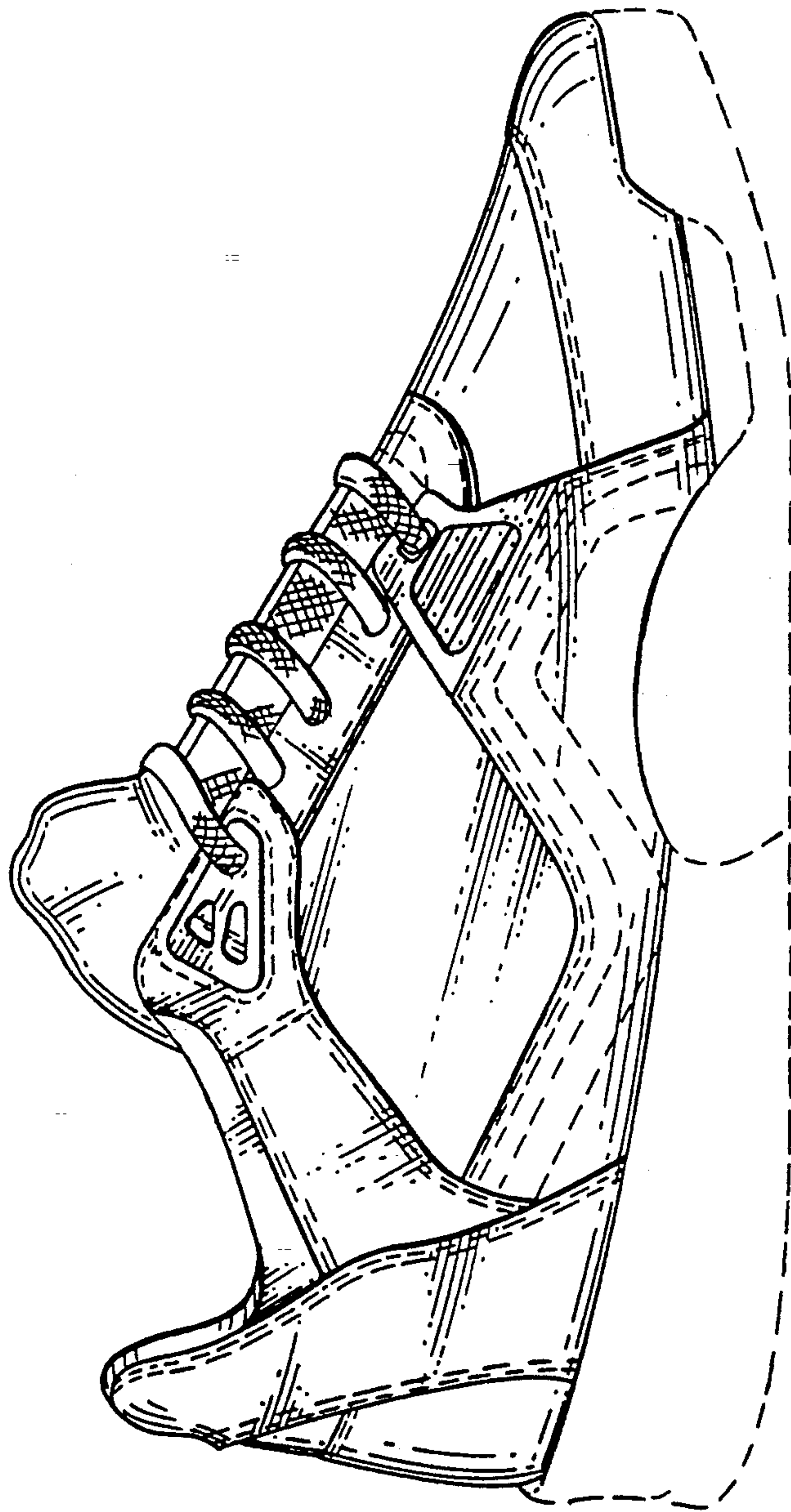

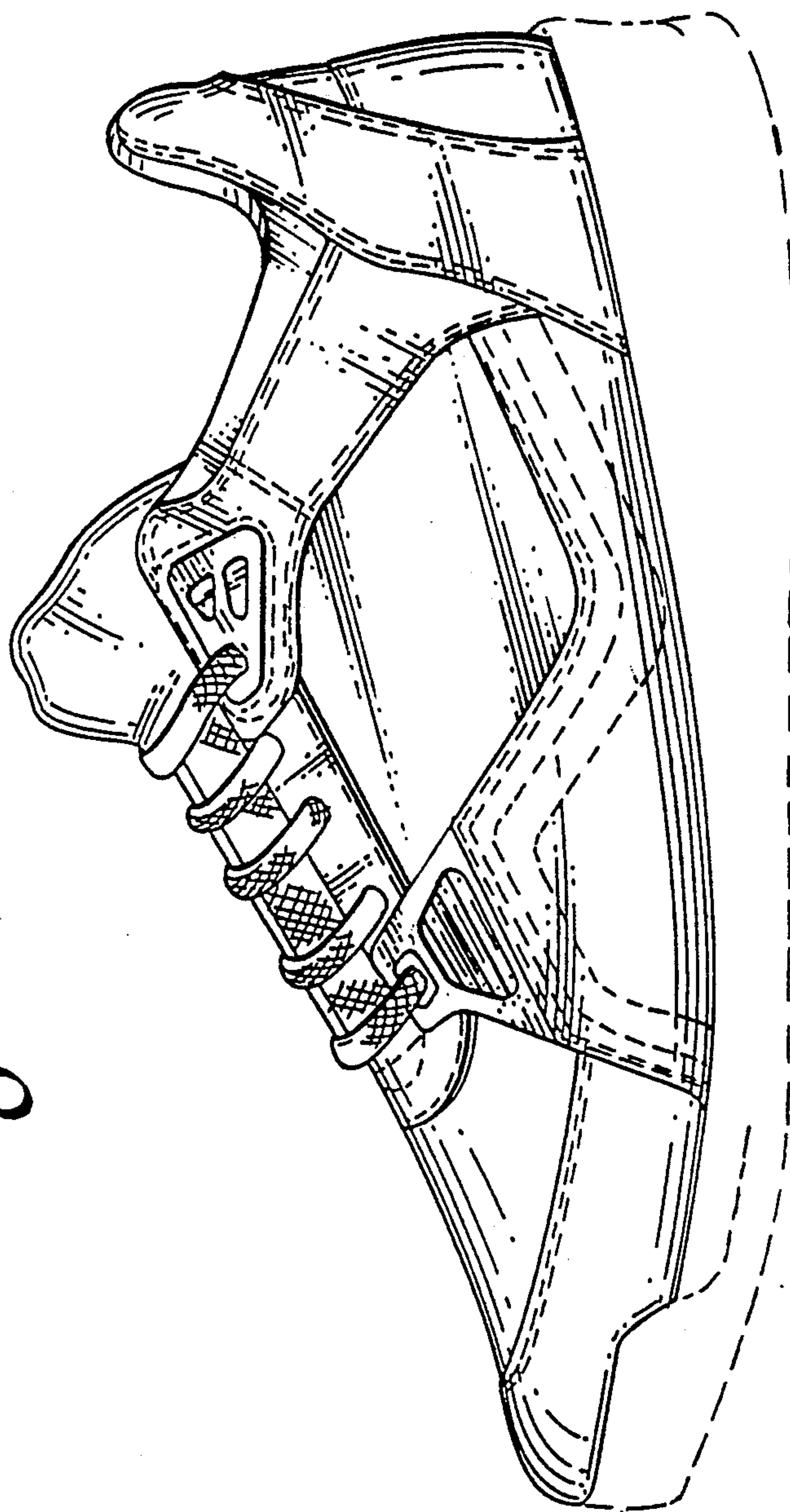

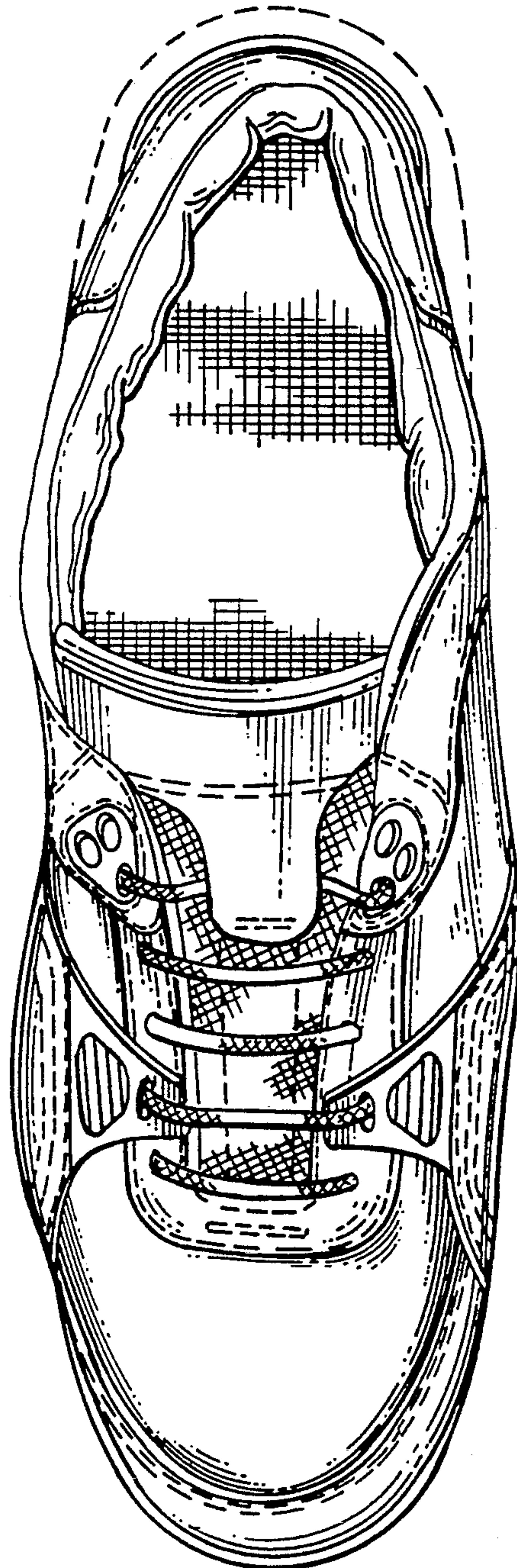

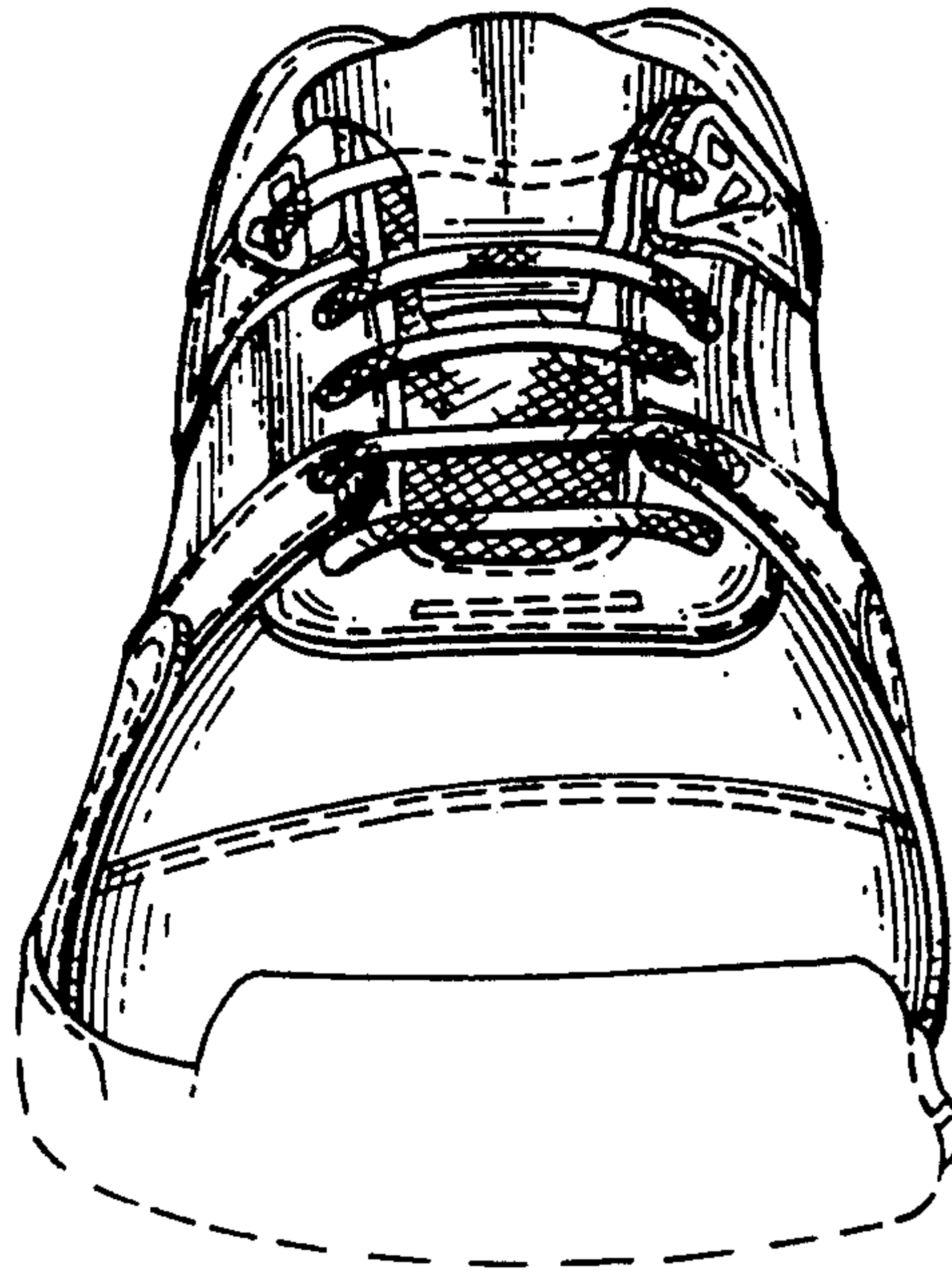
