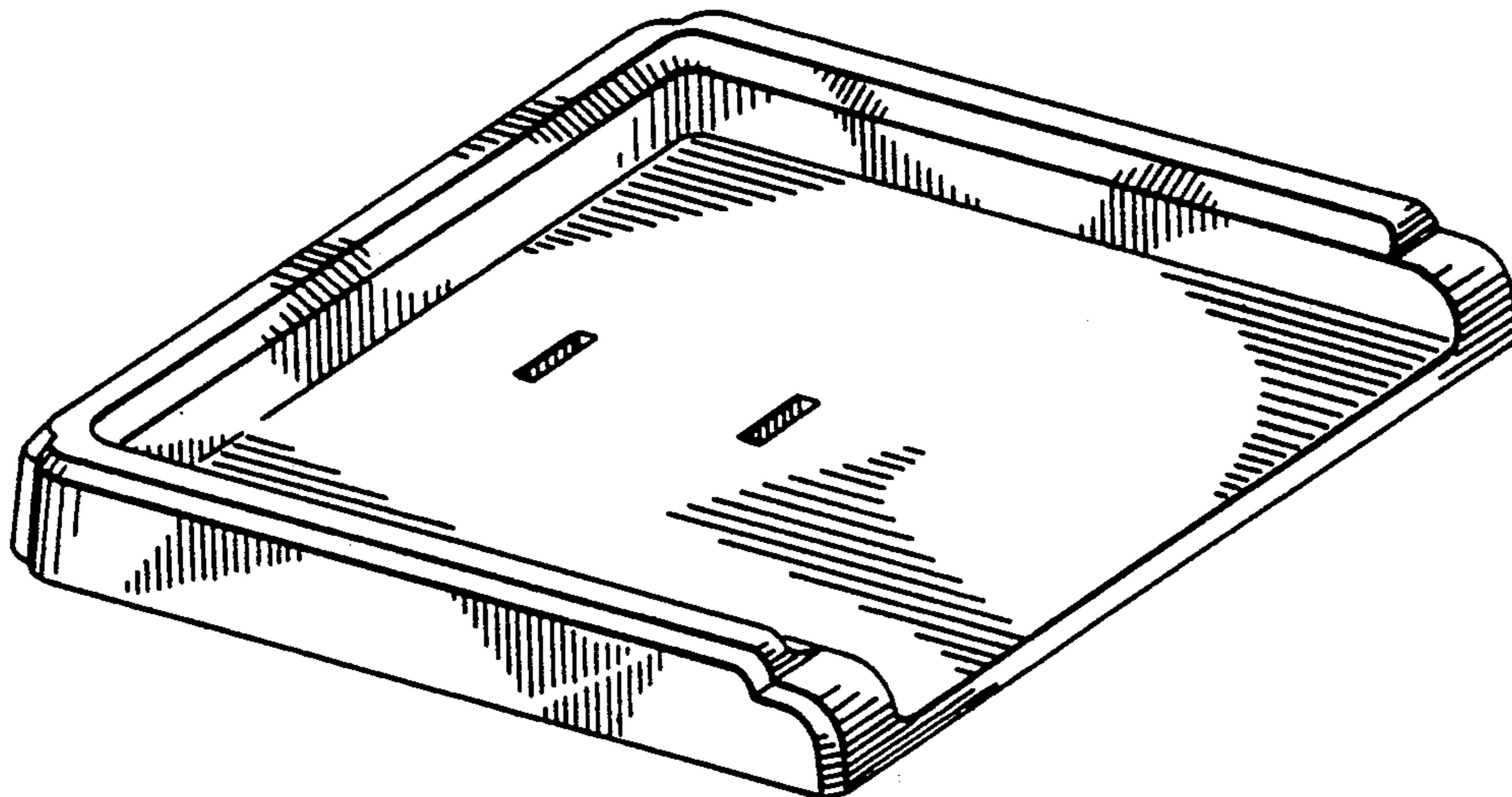

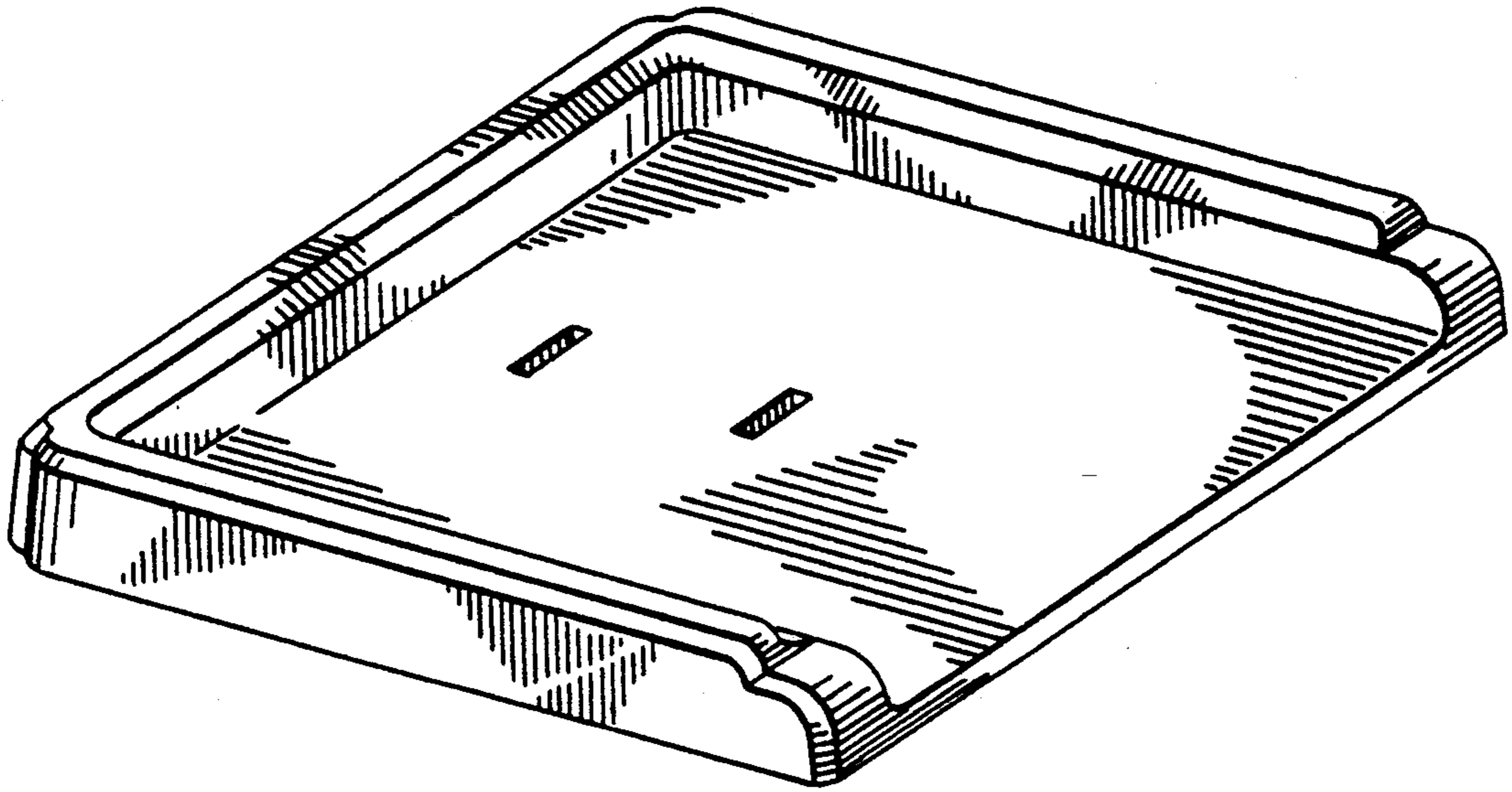
[57] **CLAIM**

The ornamental design for a desk pad holder, as shown and described.

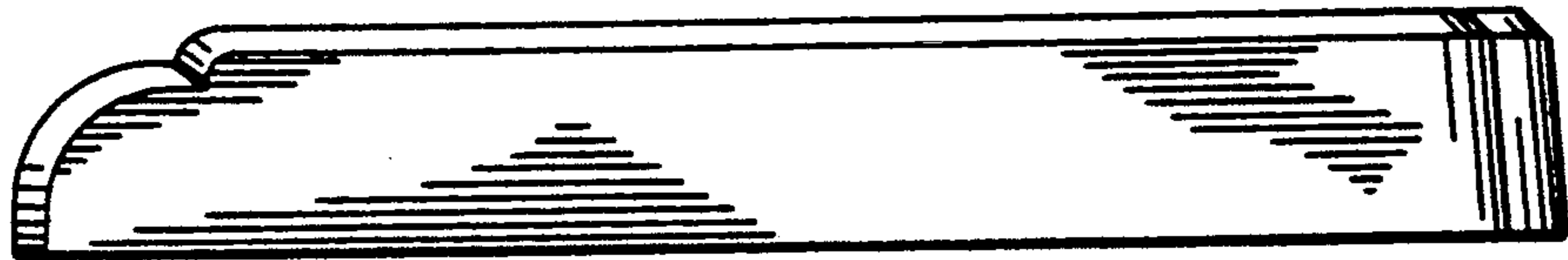
**DESCRIPTION**

FIG. 1 is a top, left front perspective view of a desk pad holder our new design;  
 FIG. 2 is a right side elevational view, the left side being a mirror image thereof;  
 FIG. 3 is a top plan view thereof;  
 FIG. 4 is a front elevational view thereof;  
 FIG. 5 is a bottom plan view thereof; and,  
 FIG. 6 is a rear elevational view thereof.  
 FIGS. 2 through 6 have been drawn to an enlarged scale with respect to FIG. 1.

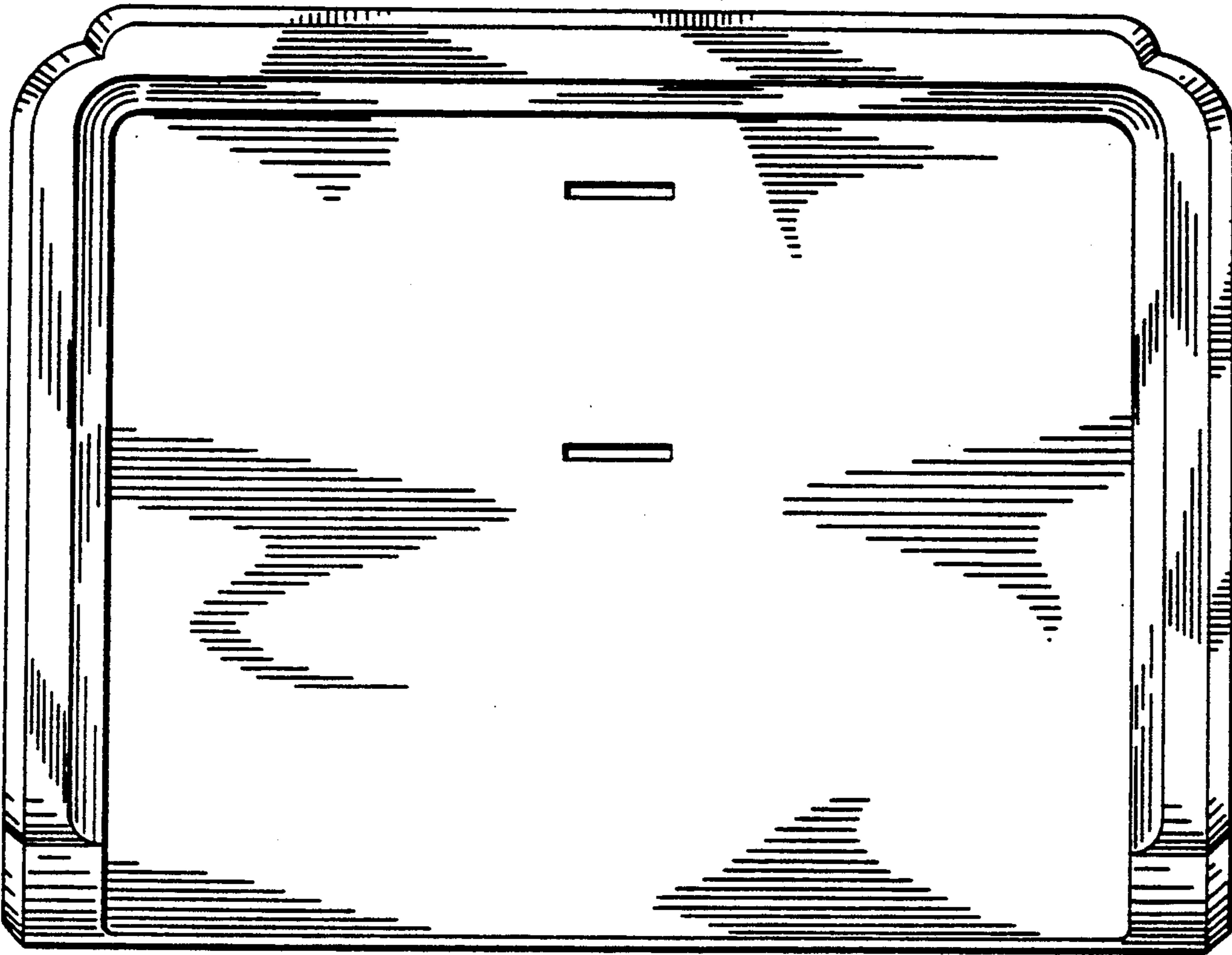

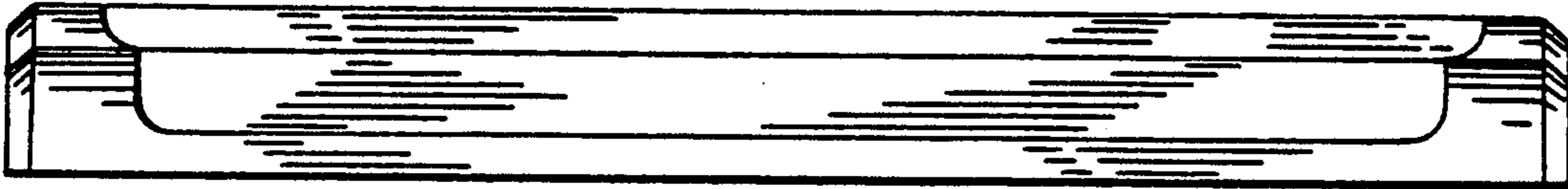

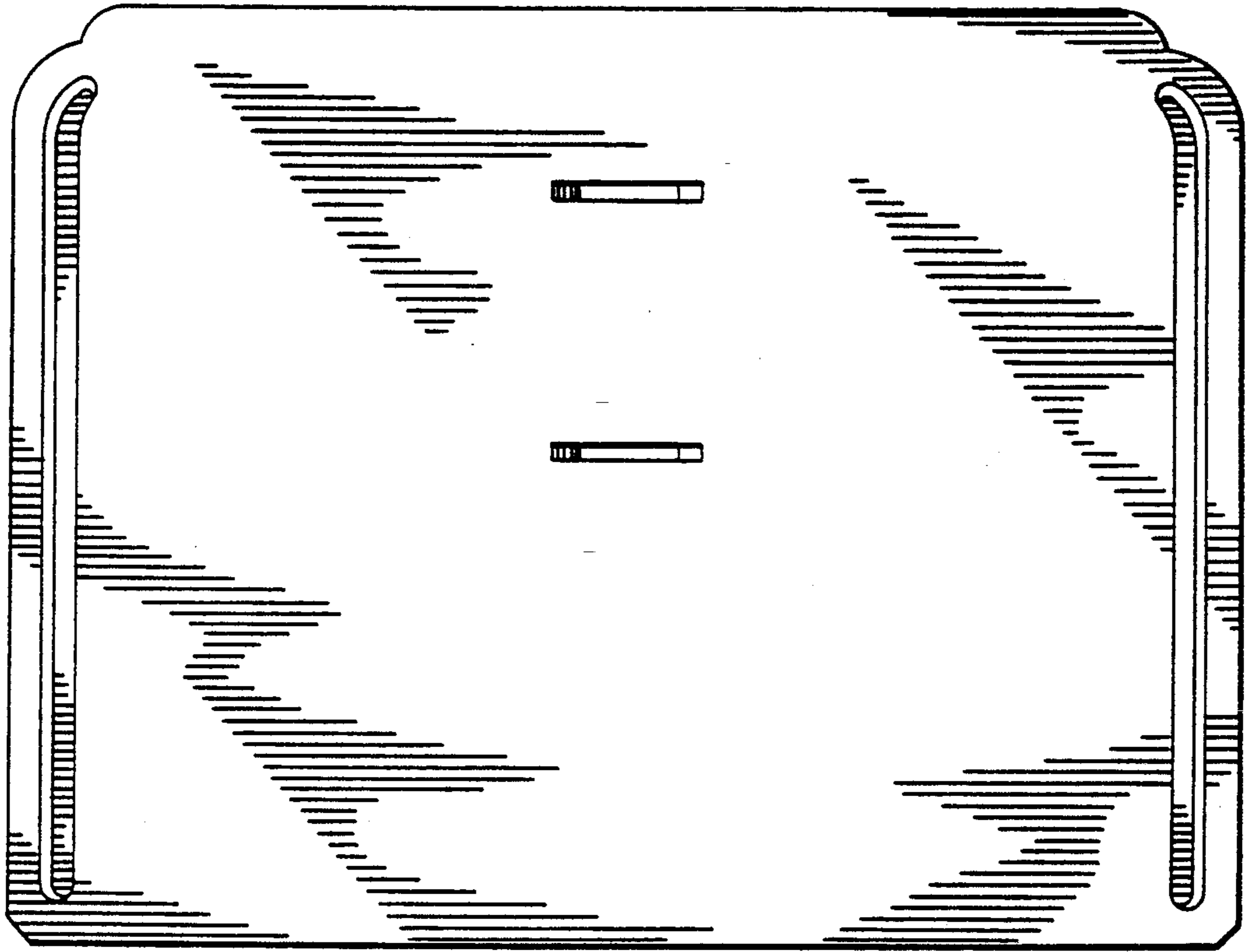

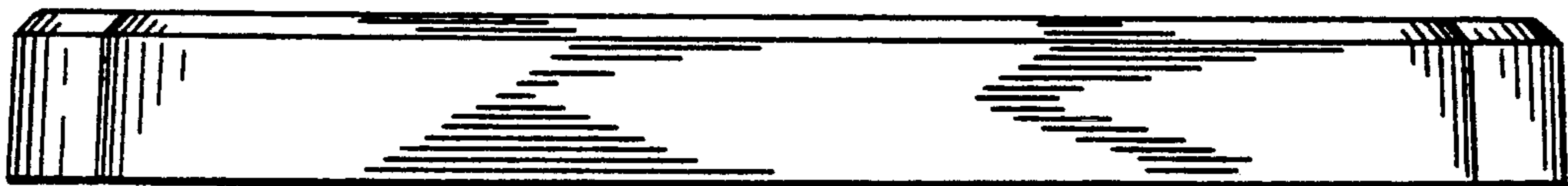
