[57] CLAIM

The ornamental design for an arched lawnmower ramp, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an arched lawnmower ramp showing our new design;

FIG. 2 is an enlarged left side elevational view thereof;

FIG. 10 is an enlarged front elevational view thereof;

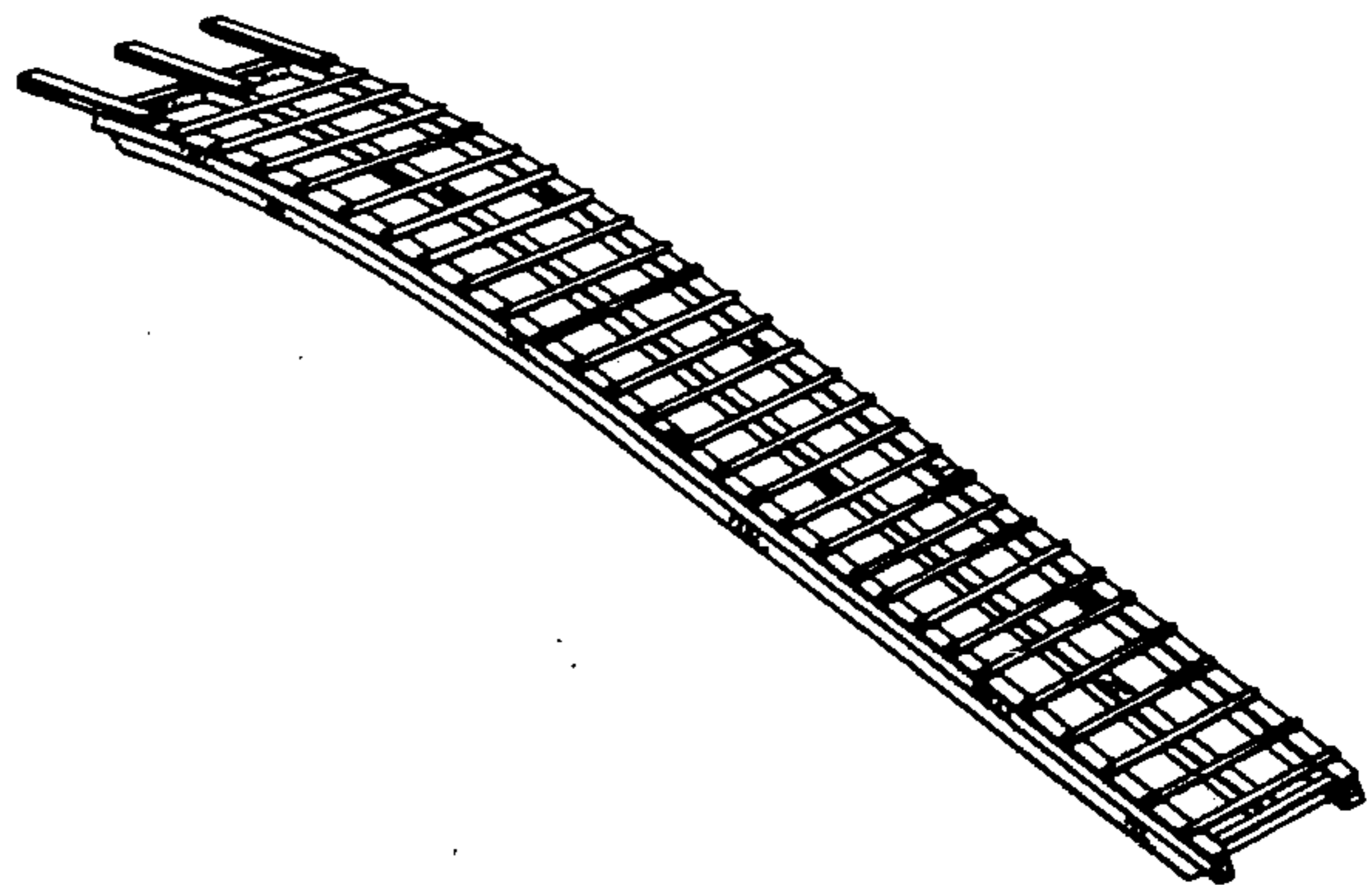
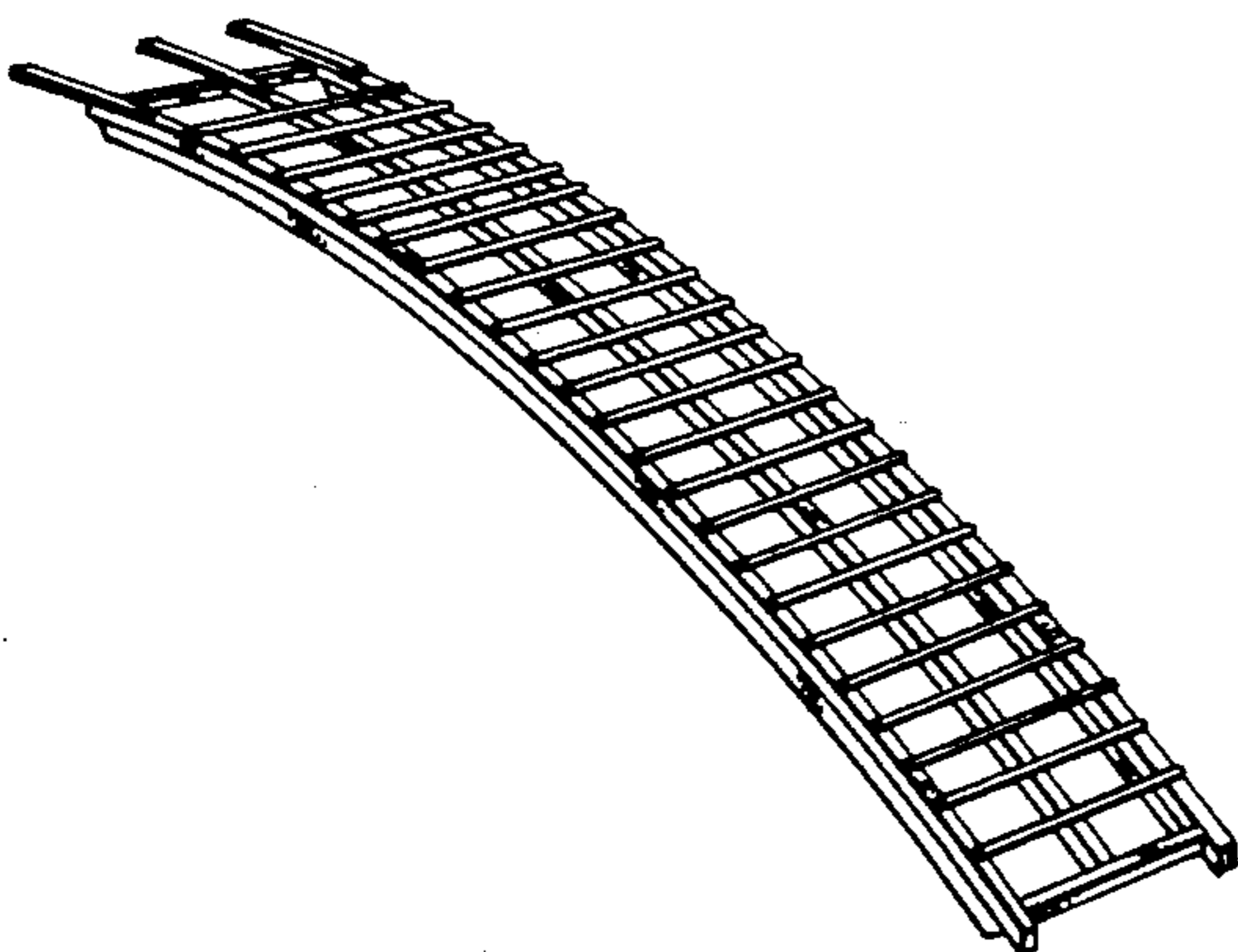
FIG. 11 is an enlarged top plan view thereof; and,

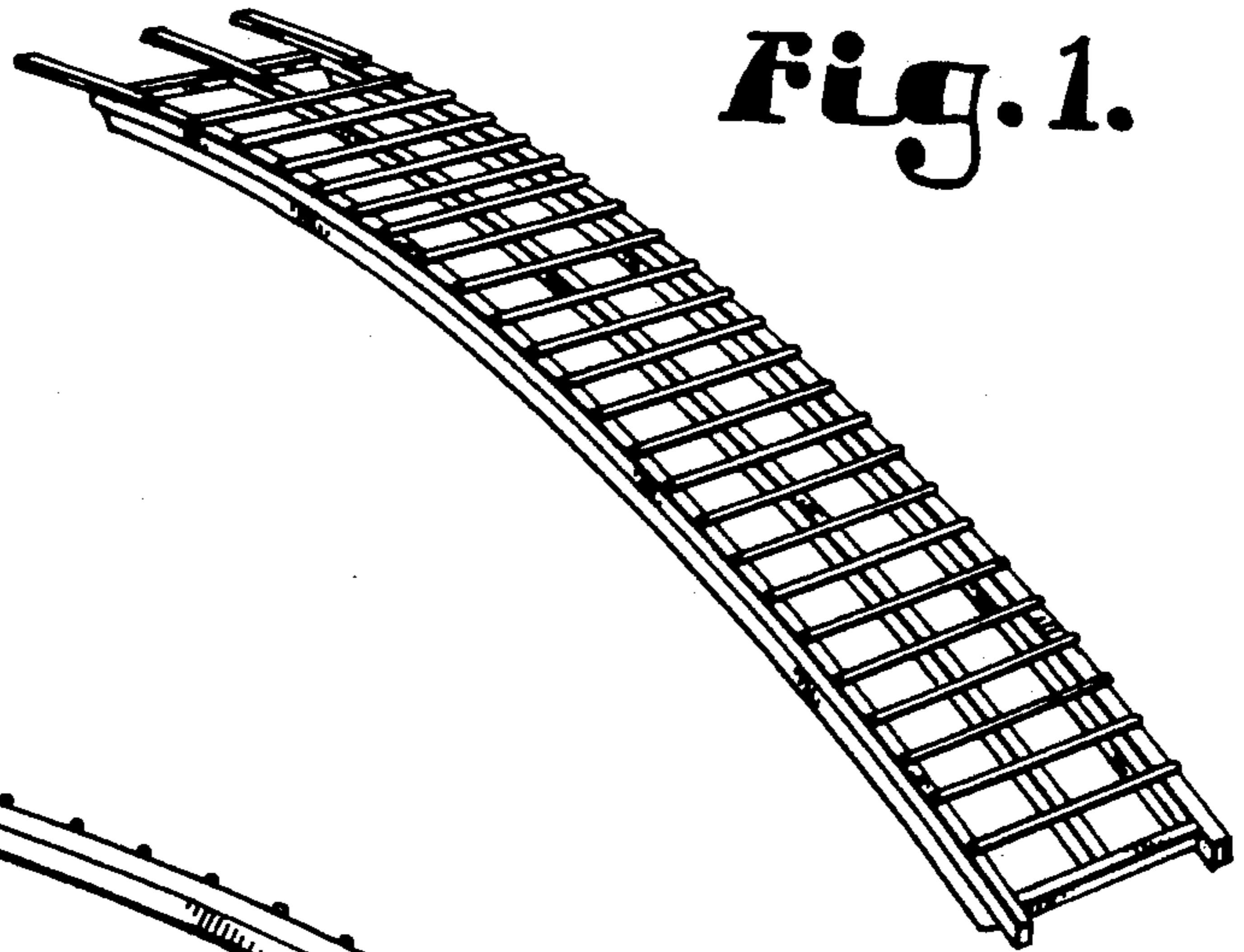

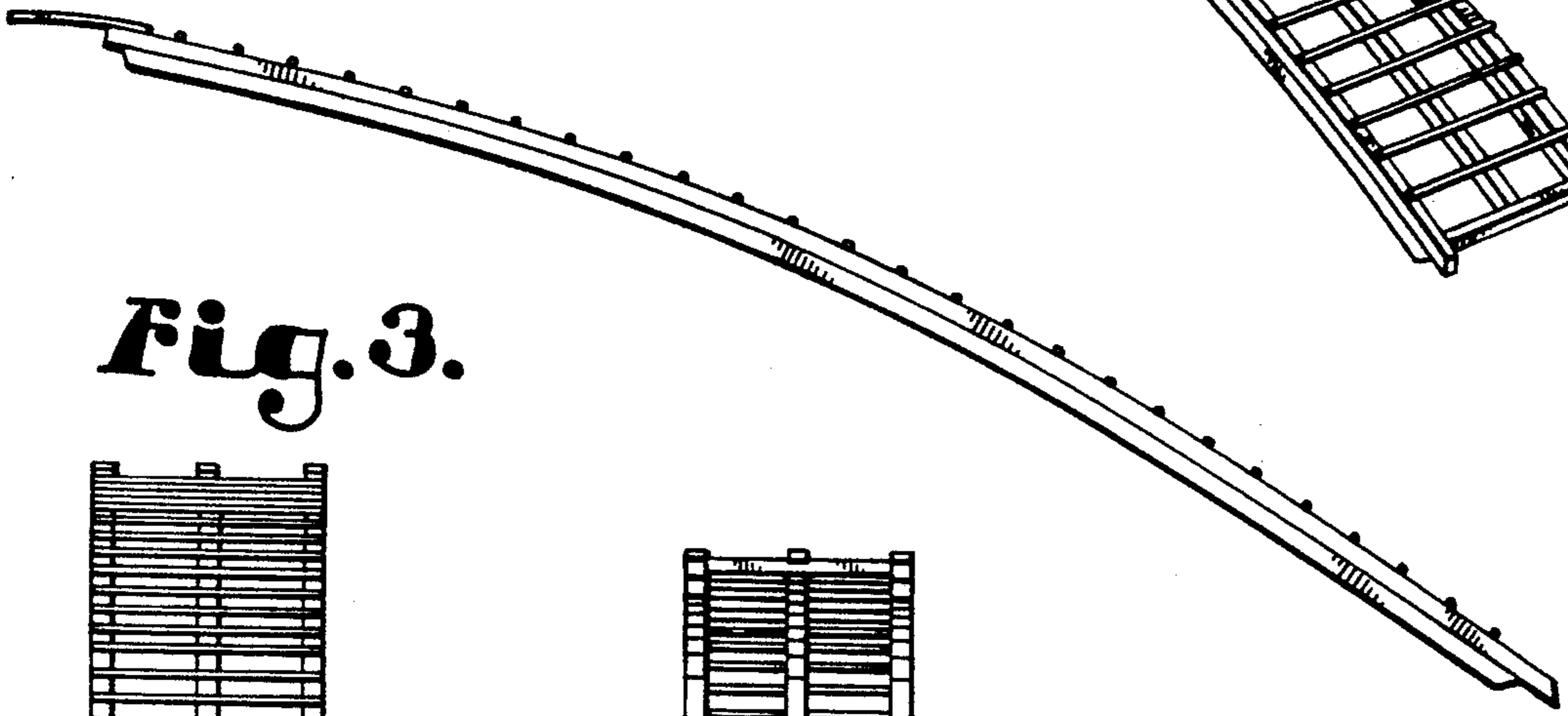

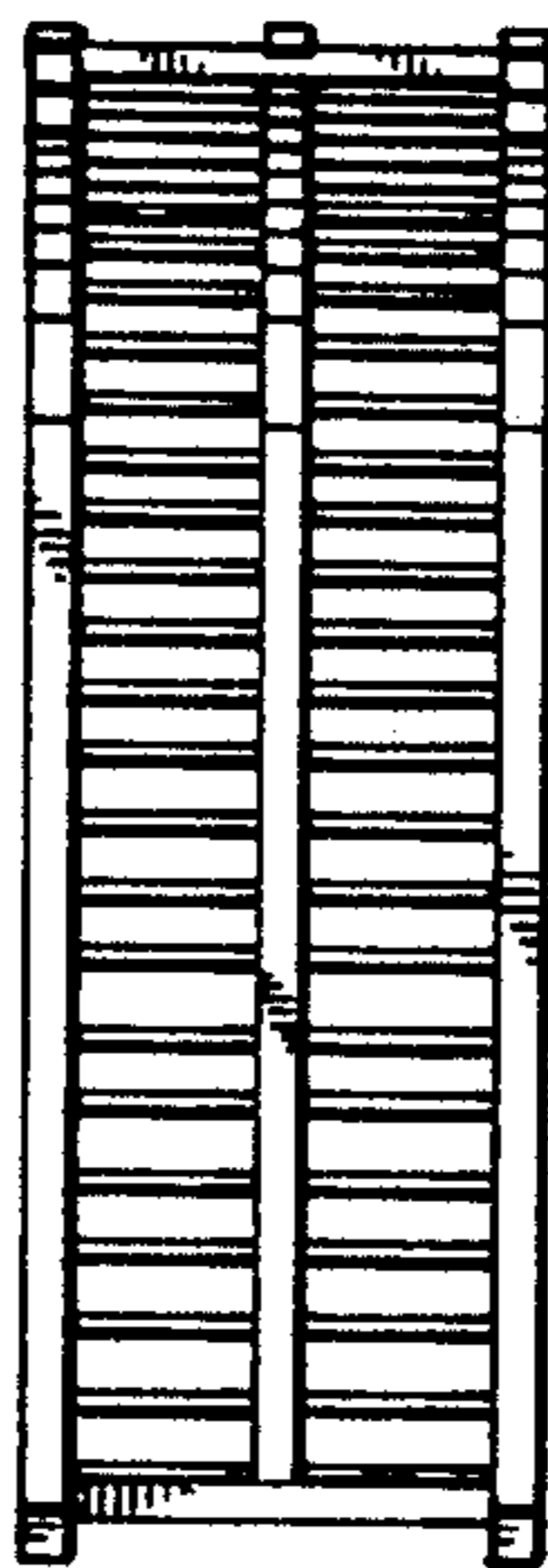
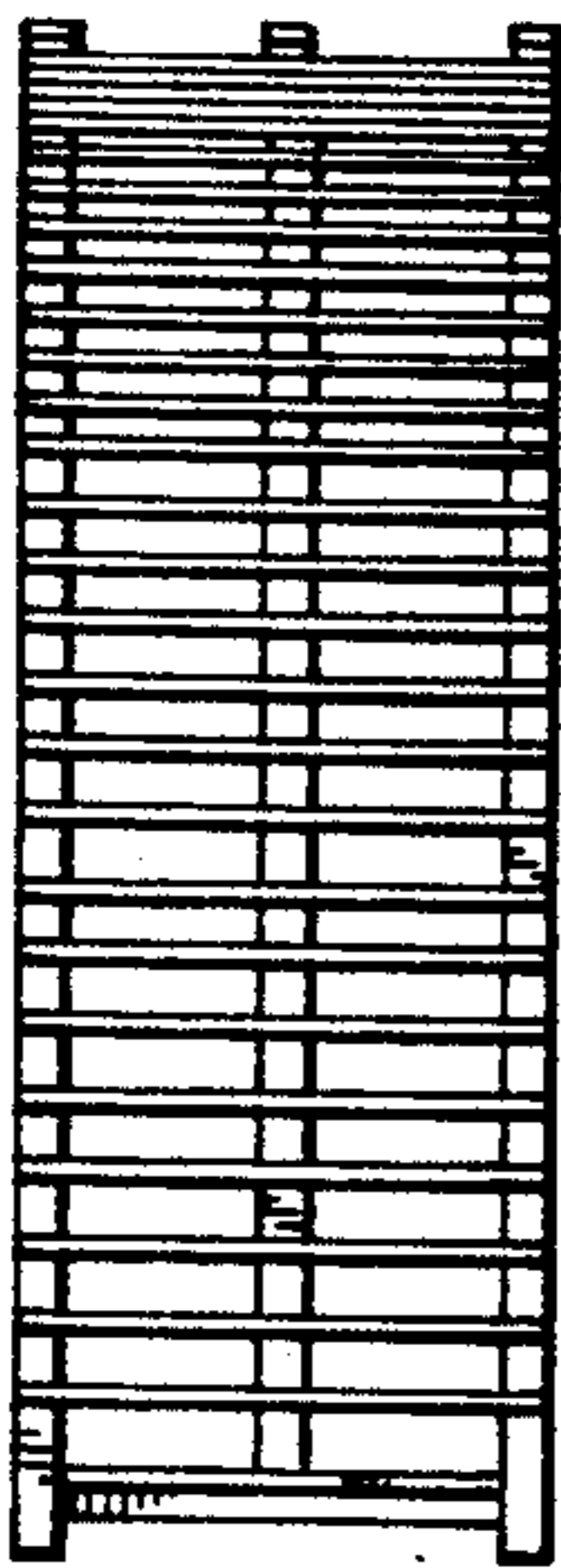

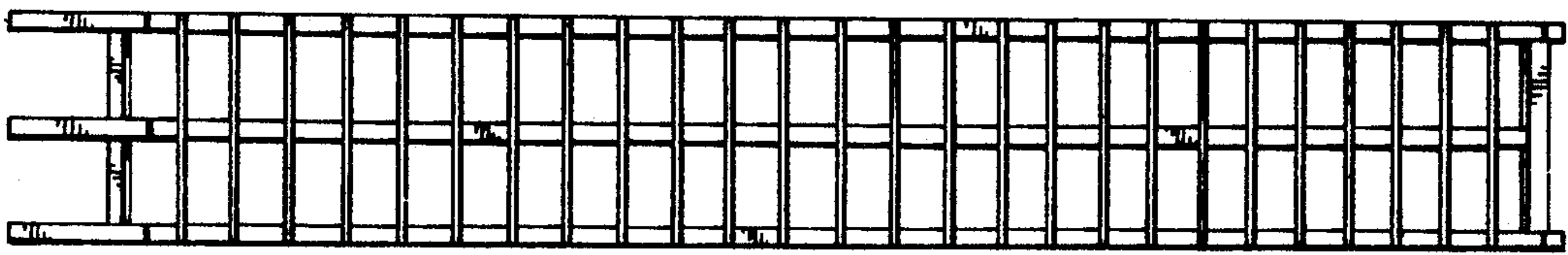

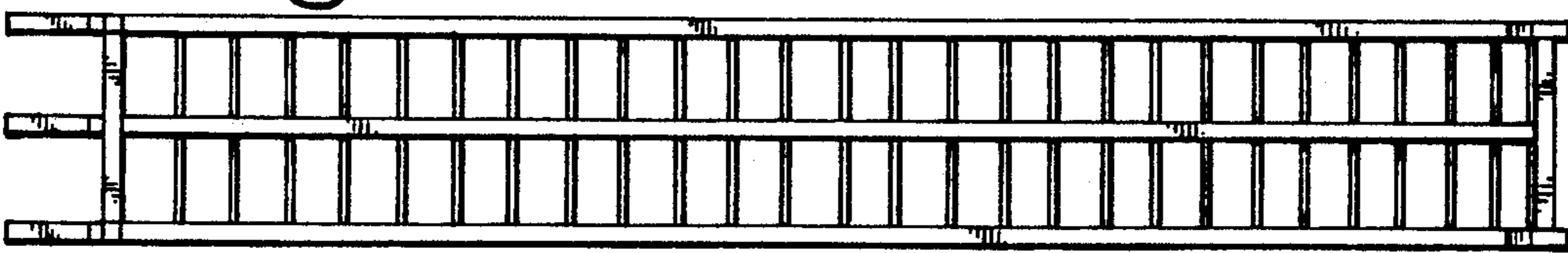

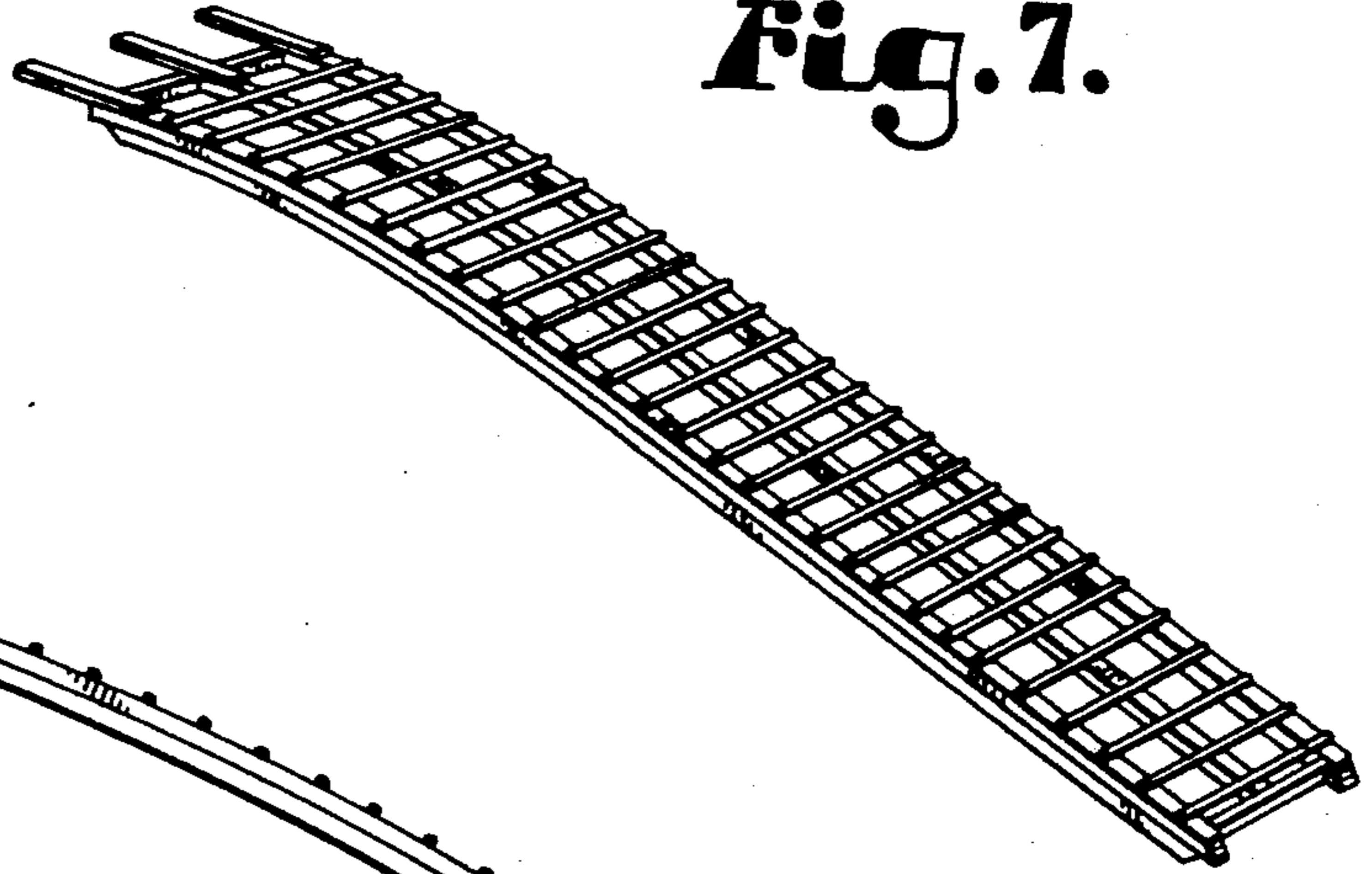

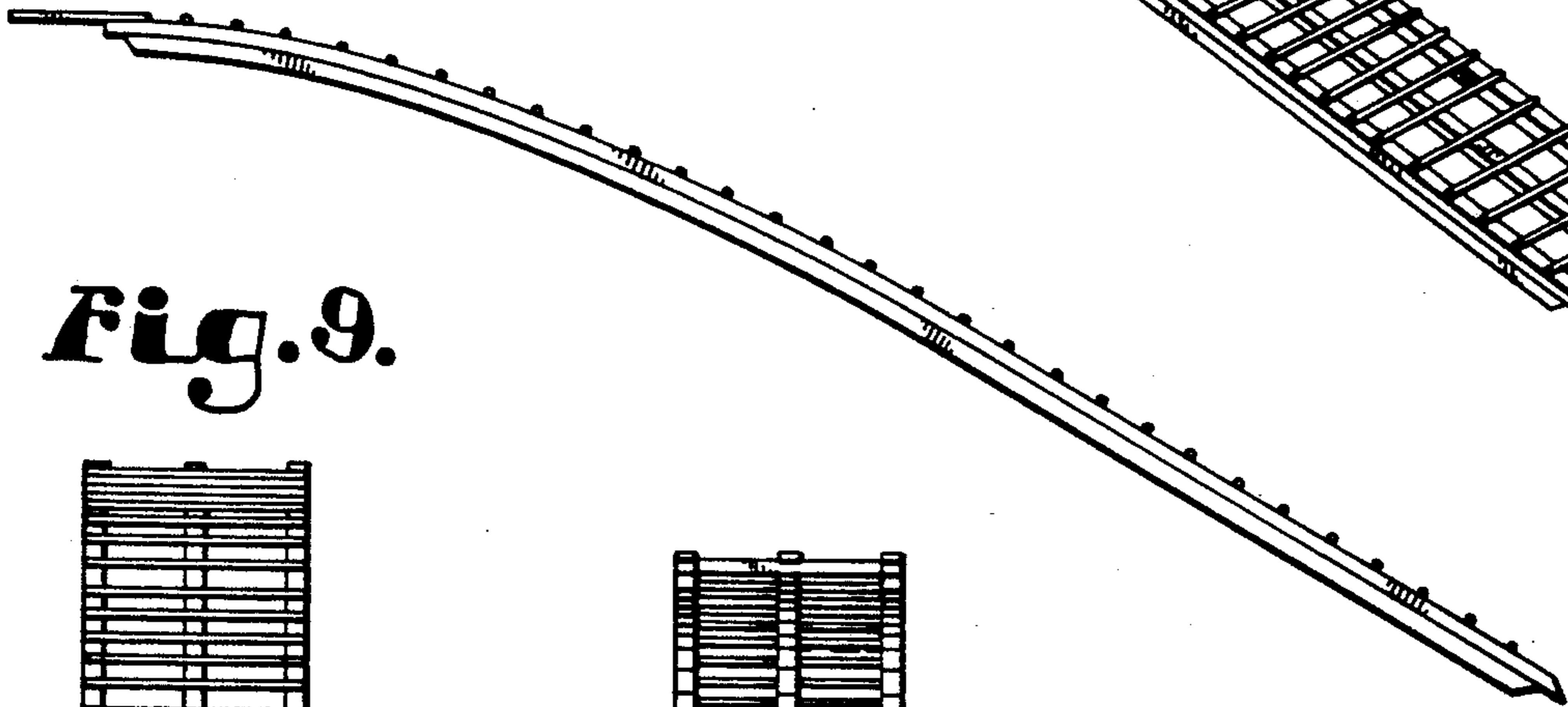

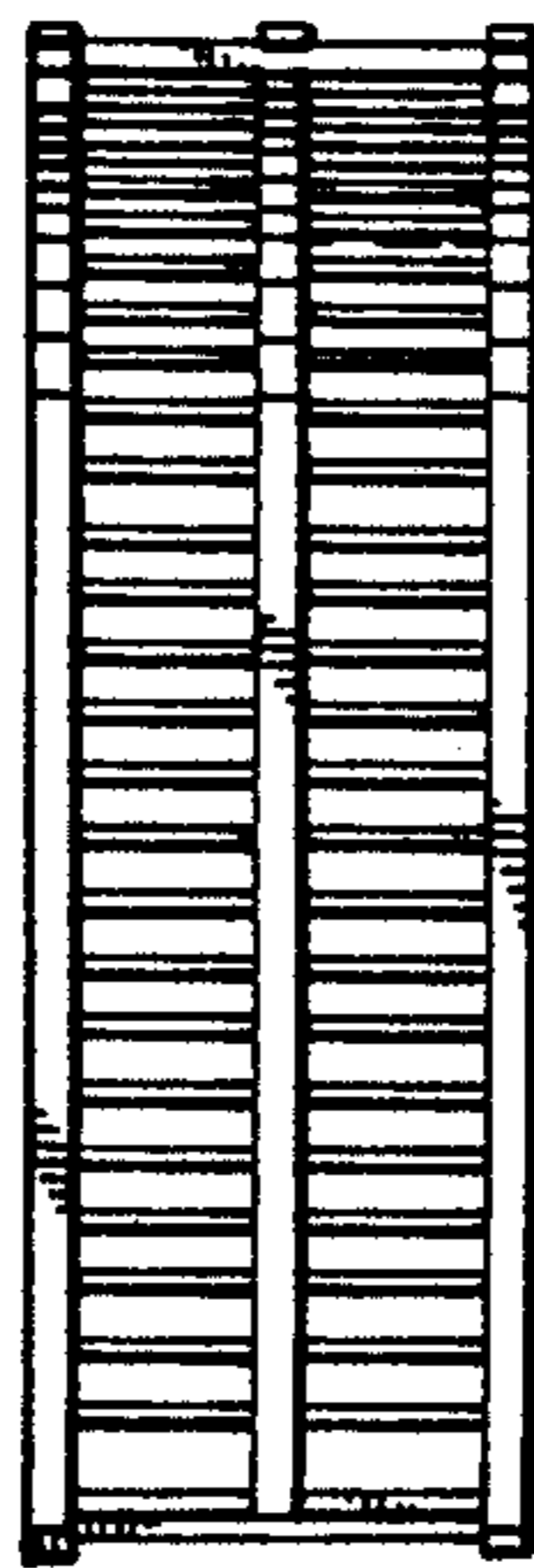
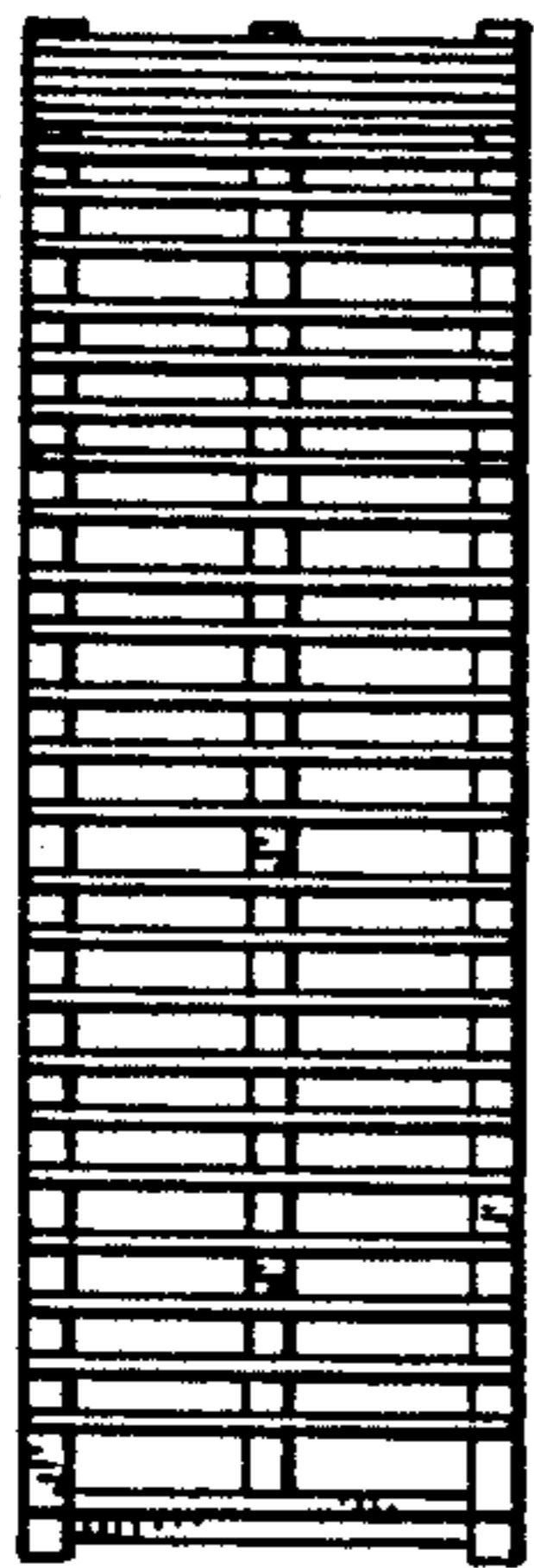
