[57] **CLAIM**

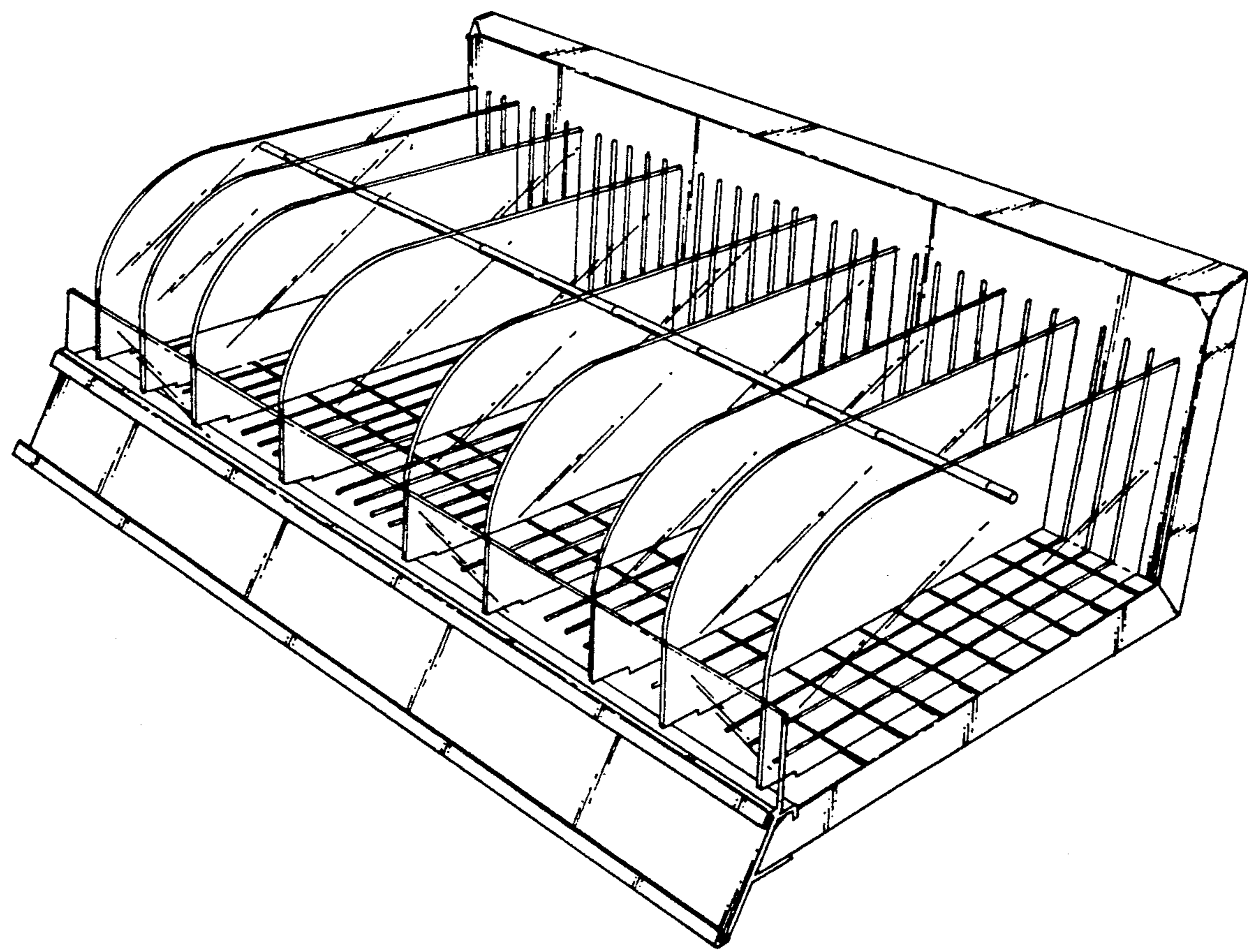
The ornamental design for a merchandise display stand, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of merchandise display stand showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a right side elevational view thereof; and, FIG. 5 is a left side elevational view thereof. The rear and bottom surfaces are plain and unornamented. FIGS. 2-5 have been shown on an enlarged scale with respect to FIG. 1.

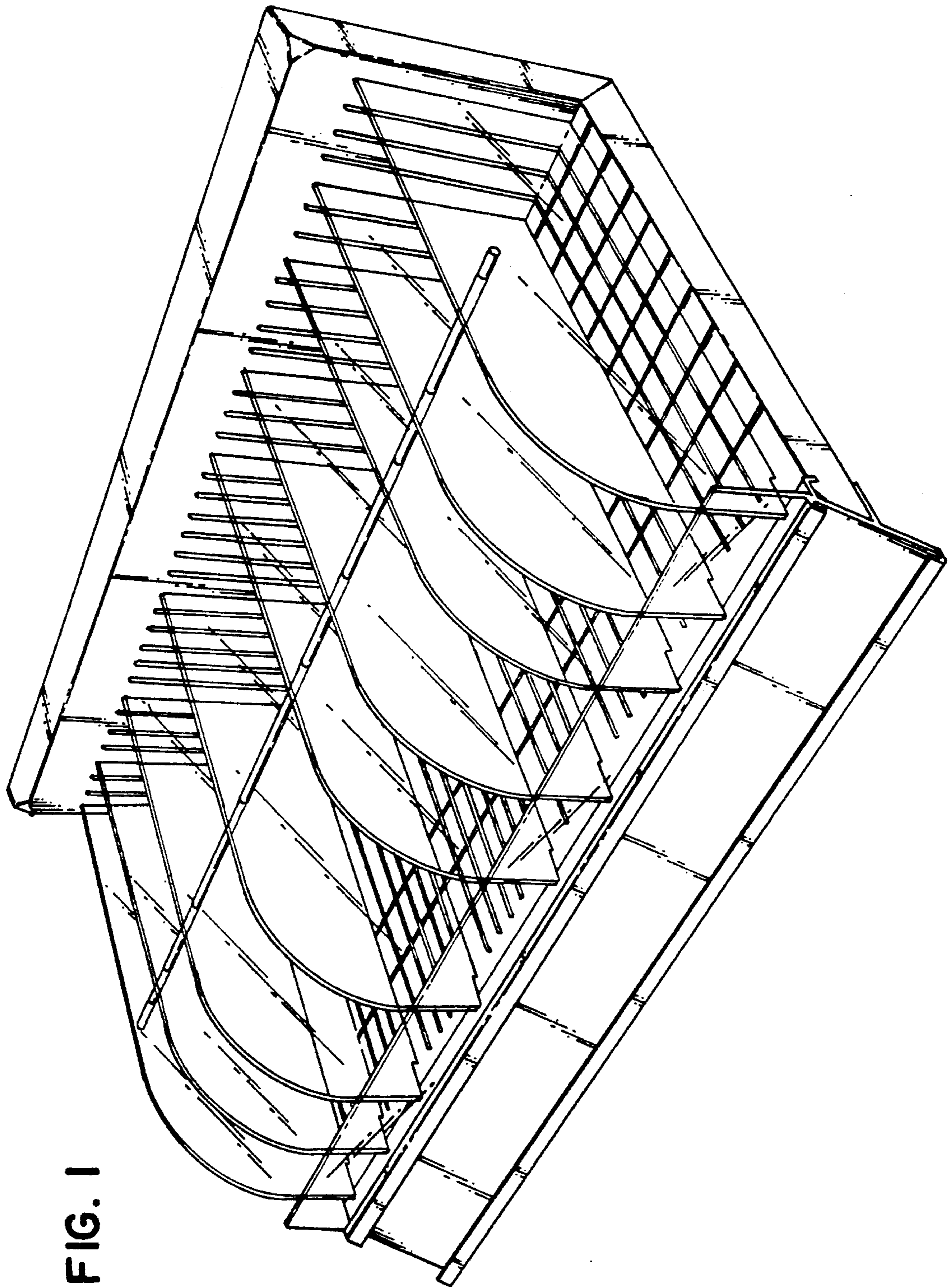

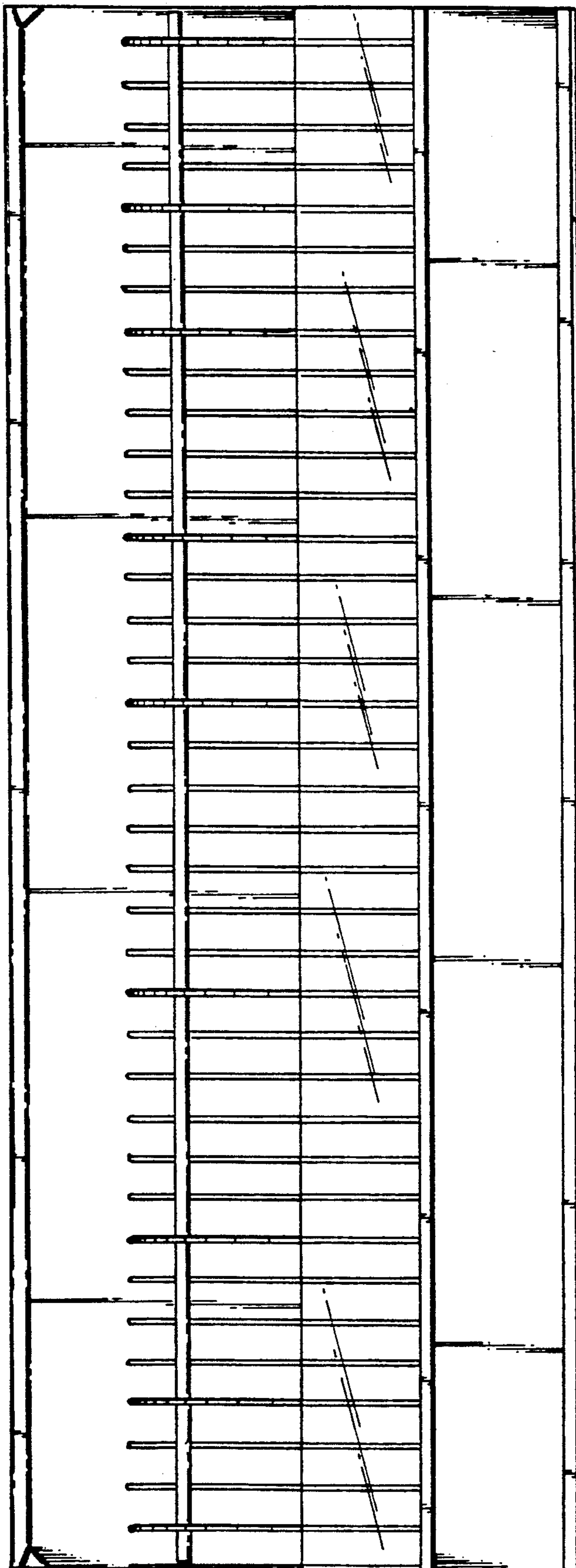

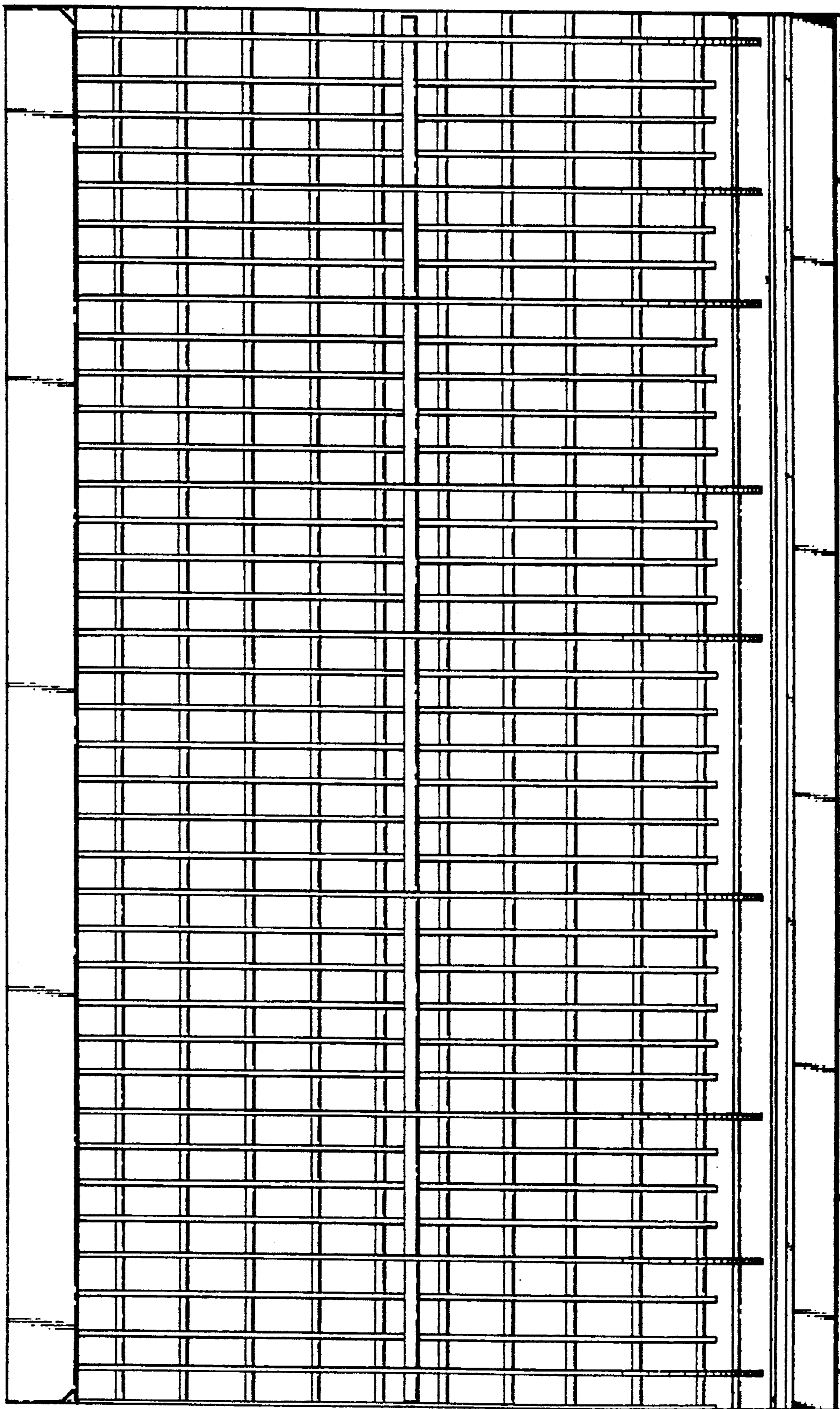

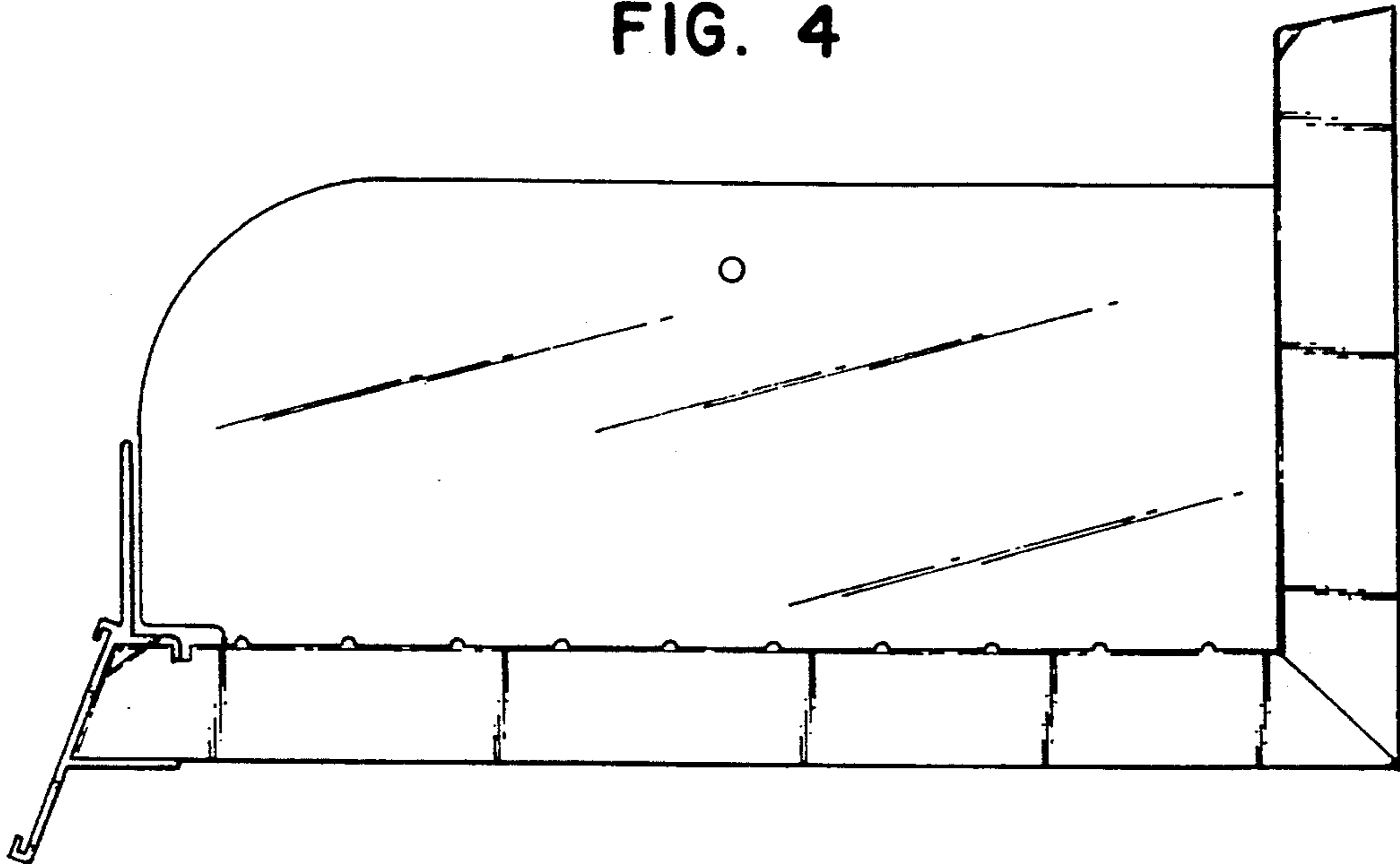
