[57] CLAIM

The ornamental design for a hook for supporting Christmas lights adjacent roofing shingles, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of a hook for supporting Christmas lights adjacent roofing shingles showing my new design, the side opposite being a mirror image; FIG. 2 is a bottom plan view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a back elevational view thereof; and, FIG. 6 is a perspective view thereof.

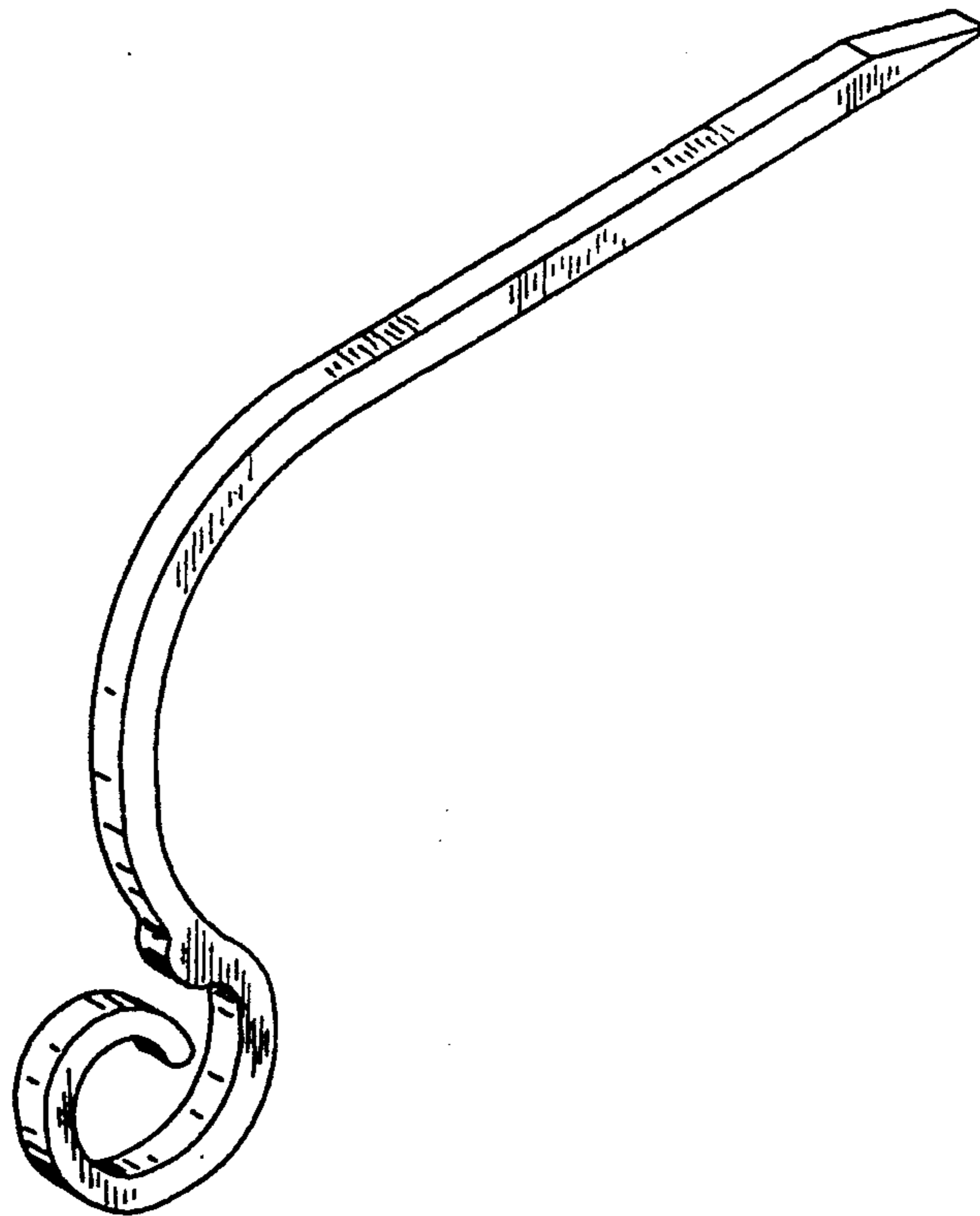

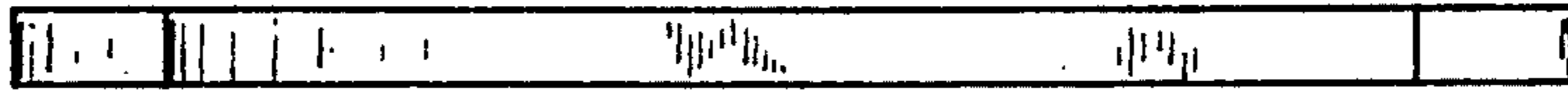

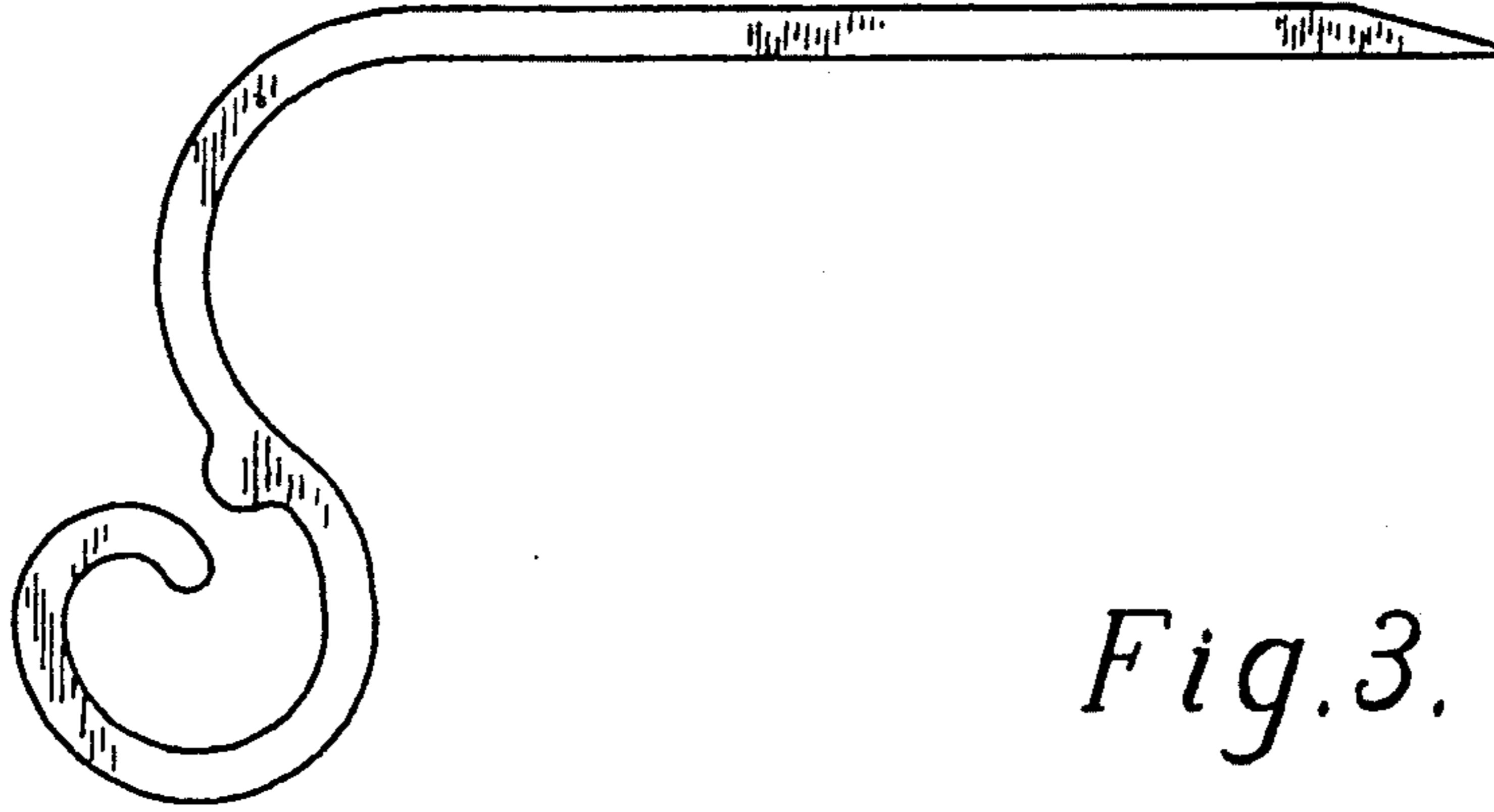

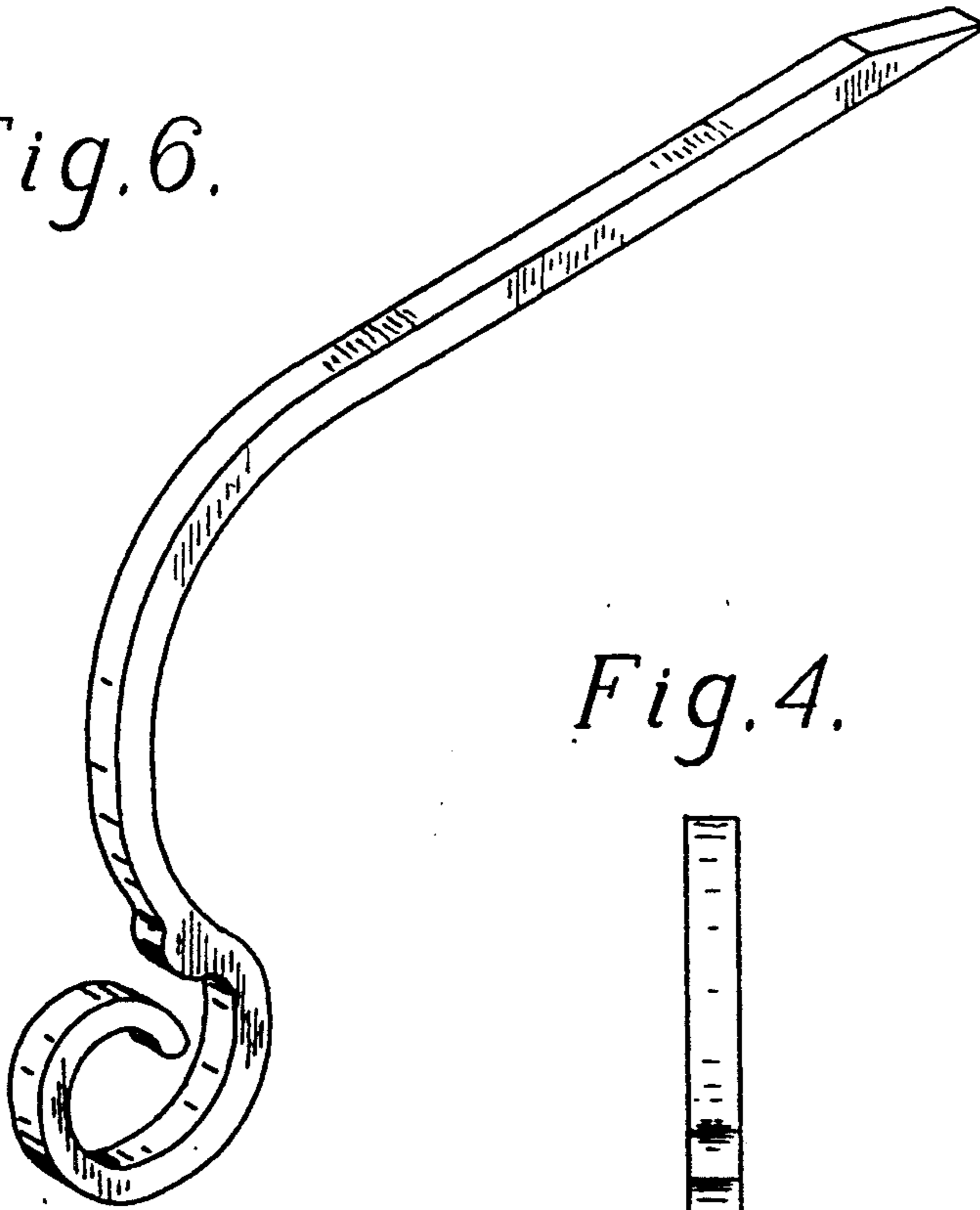
