[57] CLAIM

The ornamental design for a combination book end and wine rack, as shown and described.

DESCRIPTION

FIG. 1 is a front, top, and right side perspective view of a combination book end and wine rack showing my new design;

FIG. 2 is a rear elevational view;

FIG. 3 is a left side elevational view;

FIG. 4 is a bottom plan view;

FIG. 5 is a front, top and right side perspective view of a second embodiment of that shown in FIG. 1;

FIG. 6 is a rear elevational view;

FIG. 7 is a left side elevational view; and,

FIG. 8 is a bottom plan view thereof.

The broken line showings of a wine bottle and books are for illustrative purposes only and form no part of the claimed design.

FIGS. 1-4 are shaded to show a dark to light contrast between the corner connectors and the tubular stretchers.

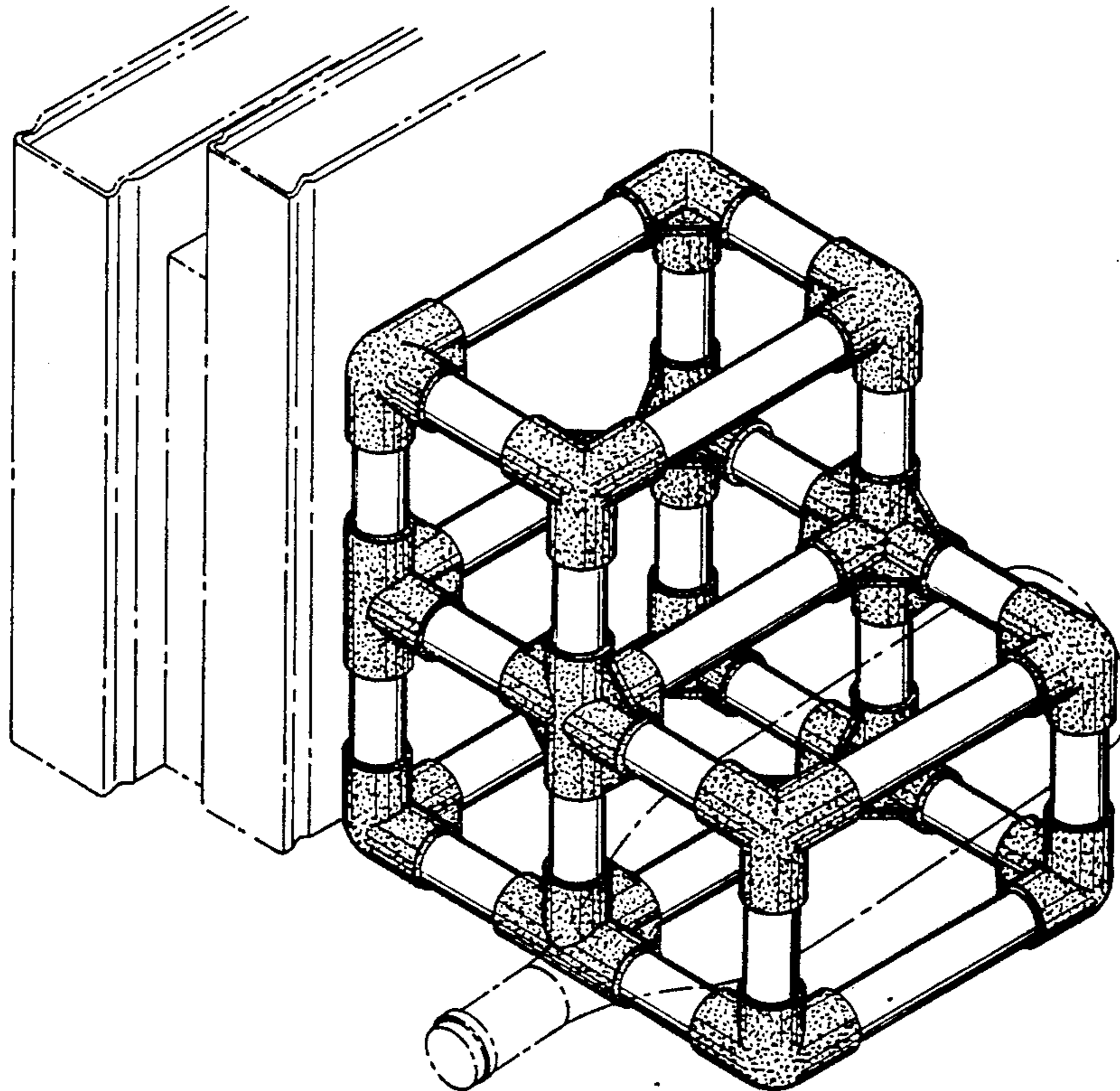

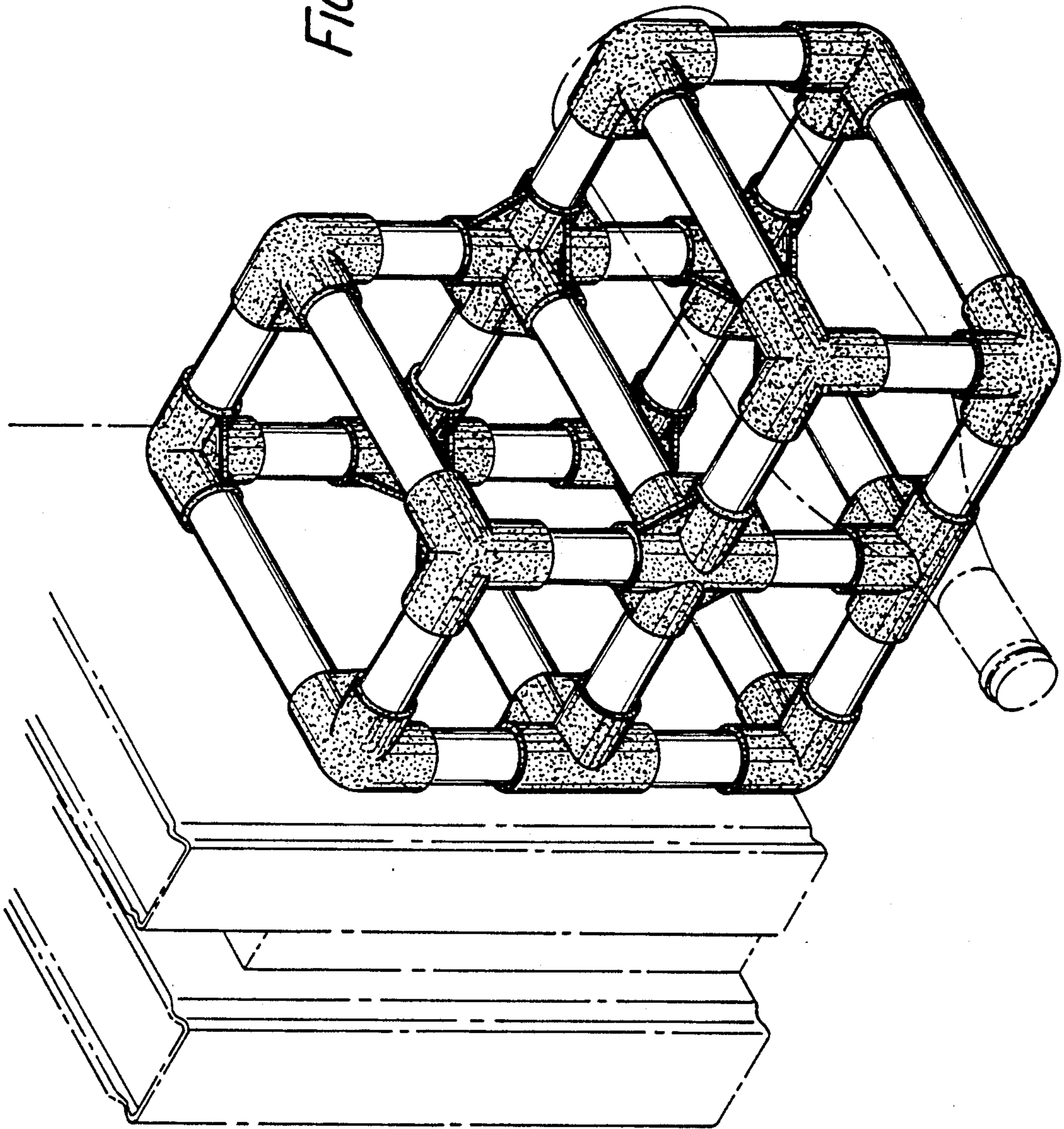

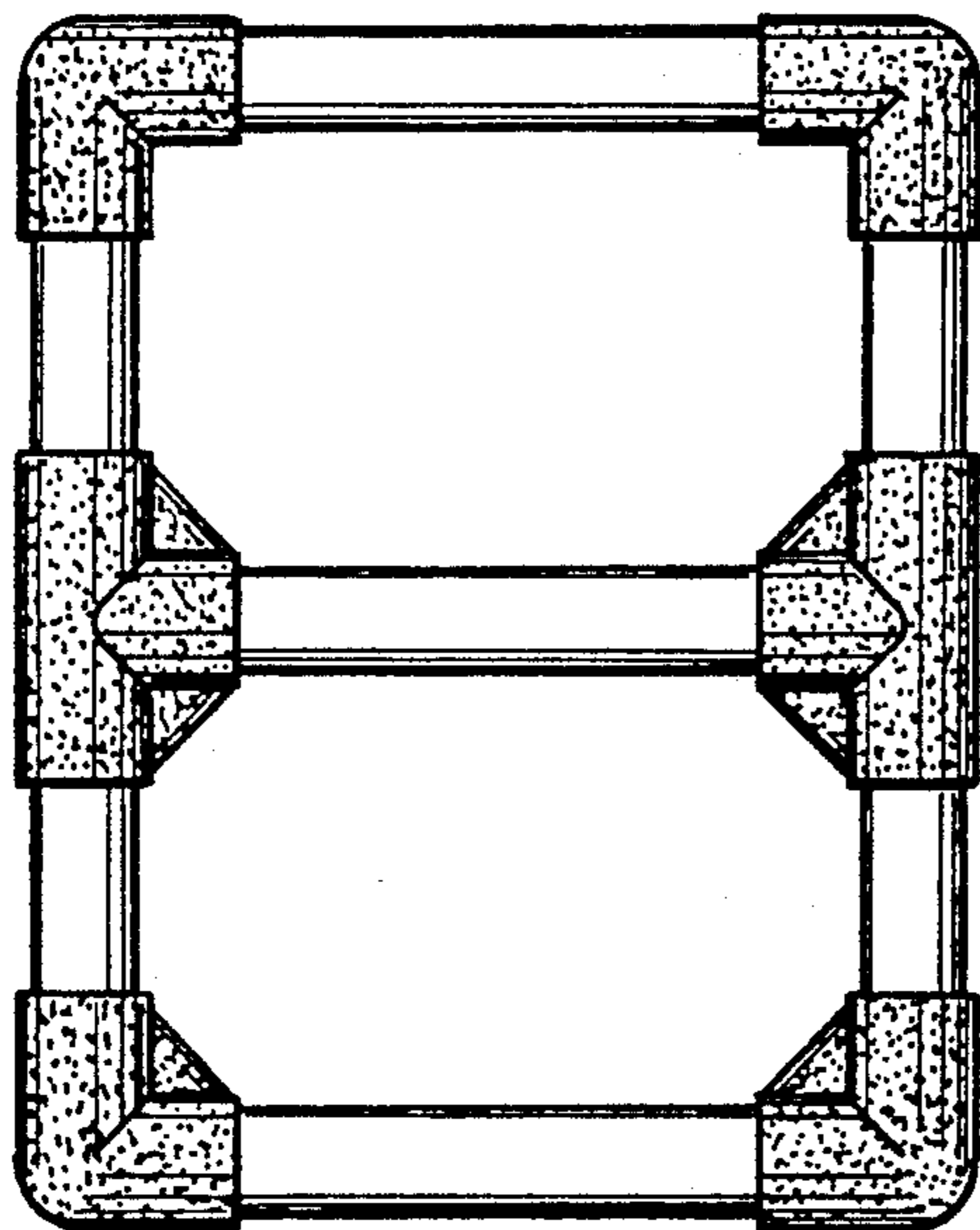
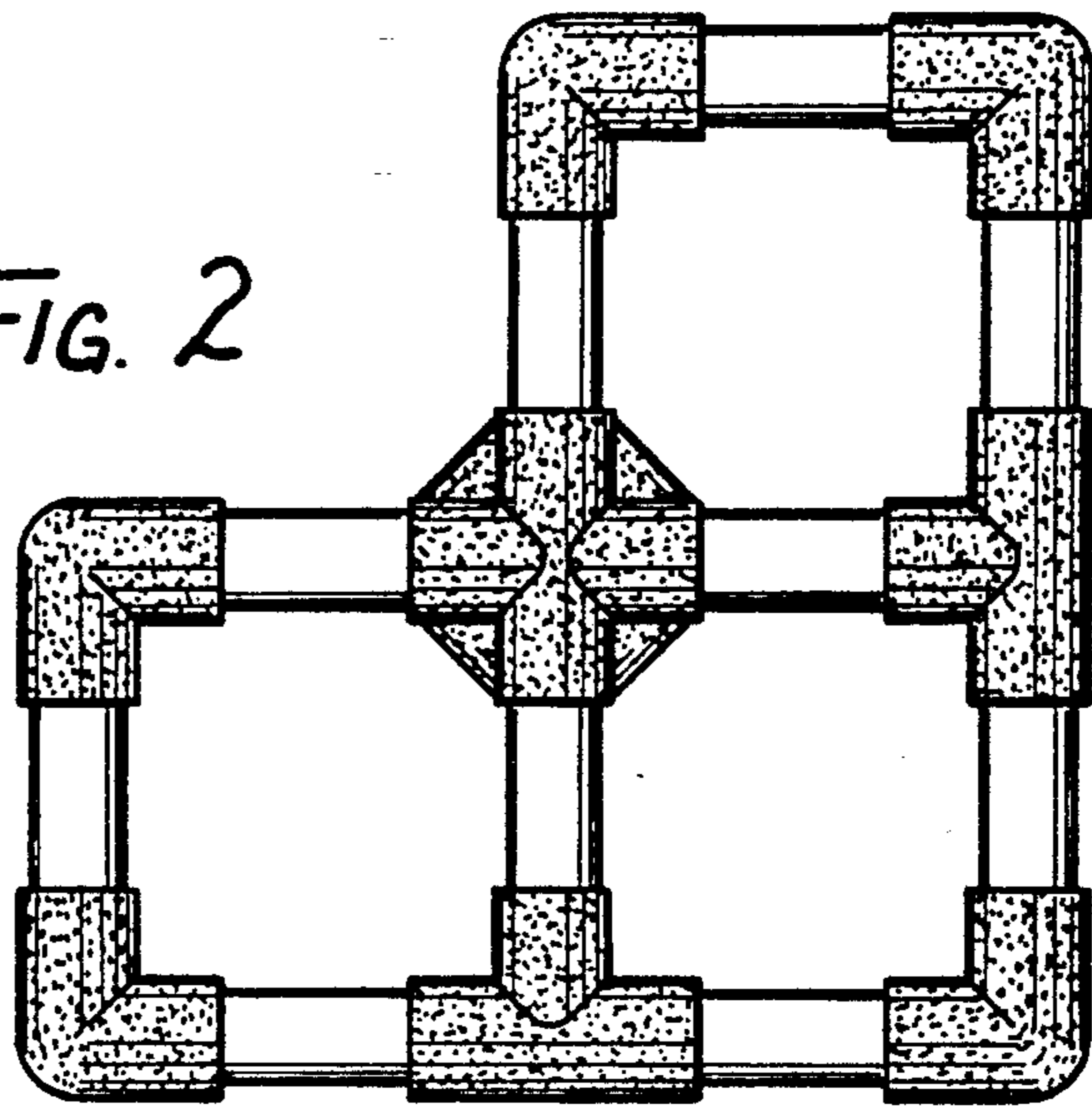
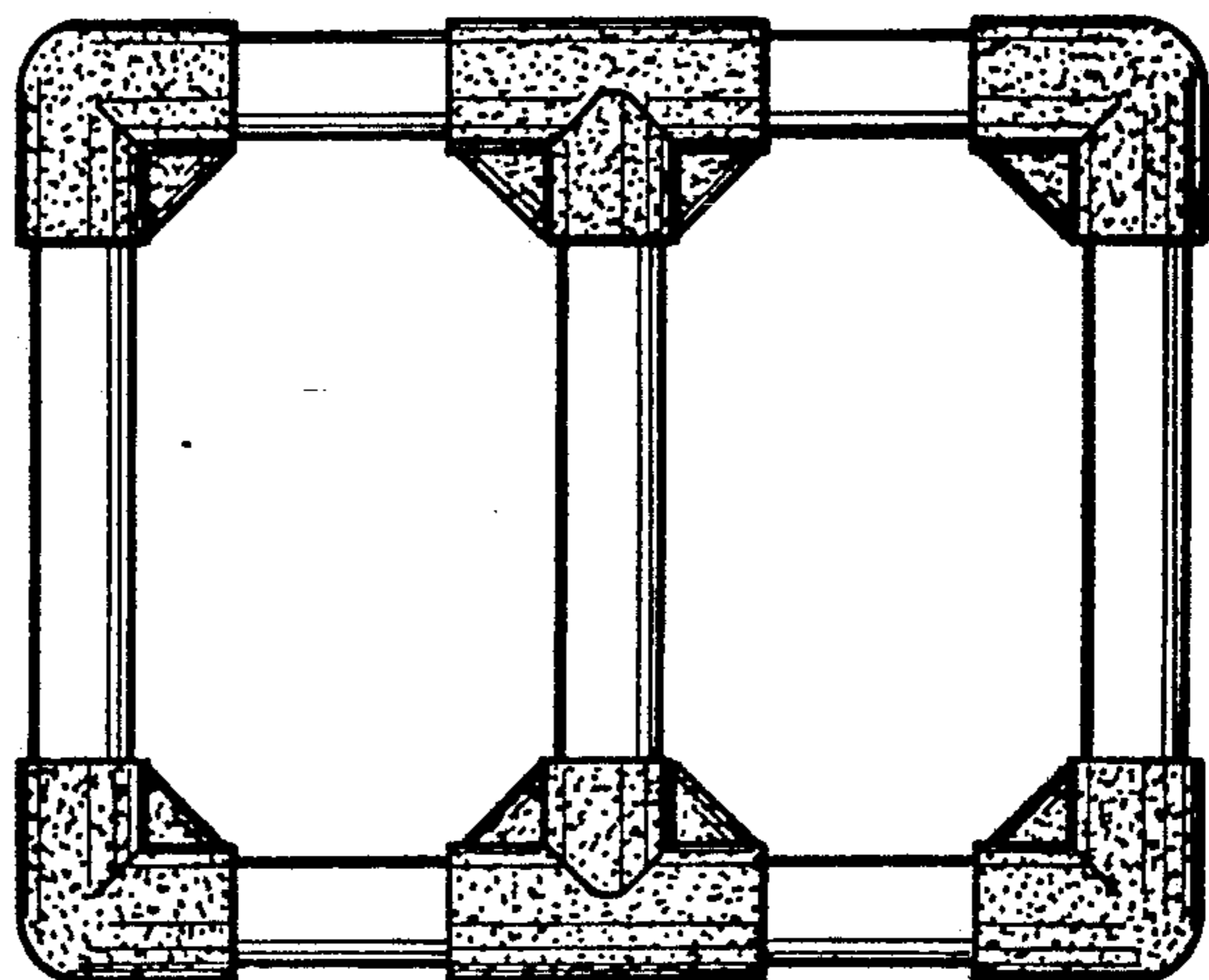

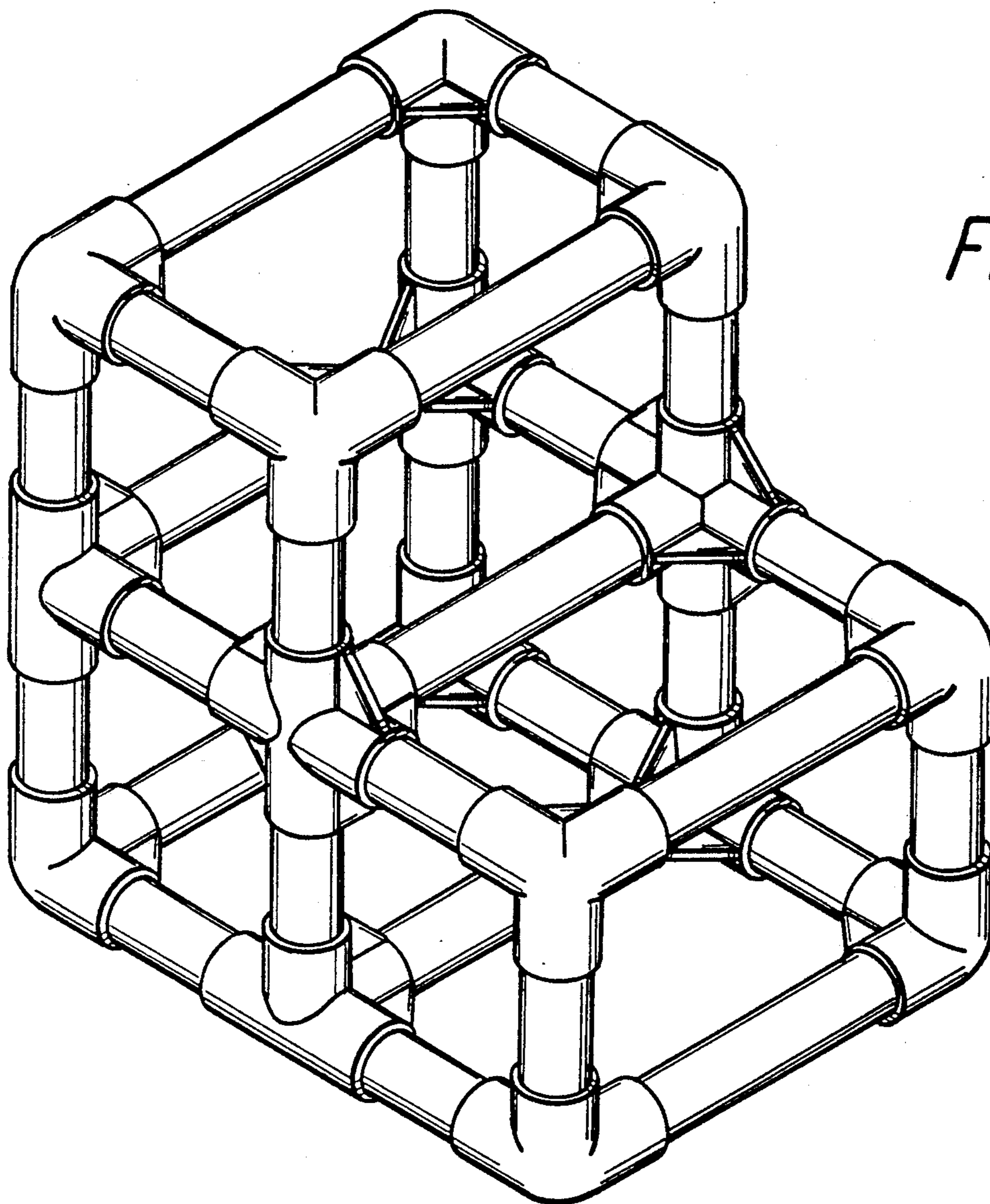

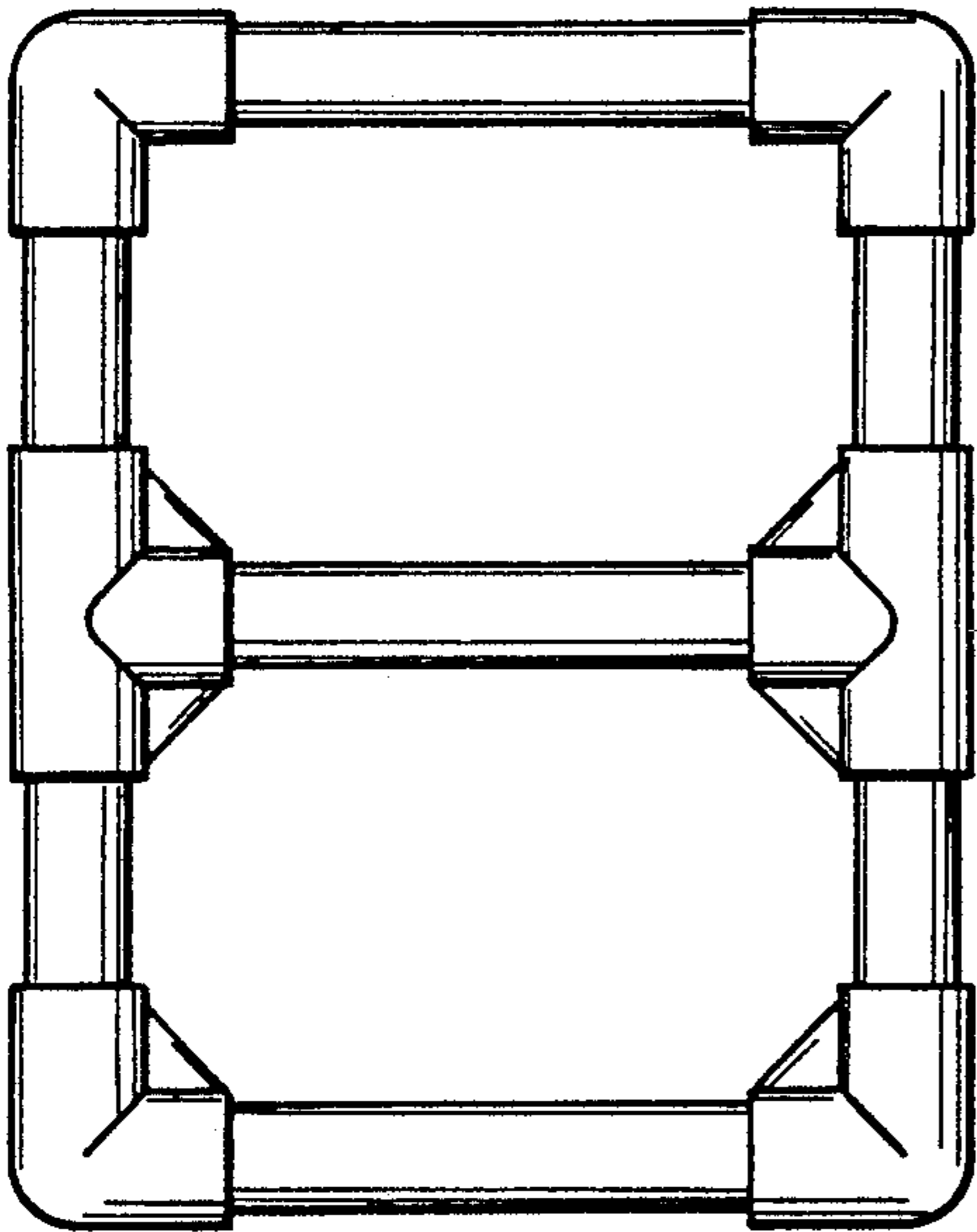
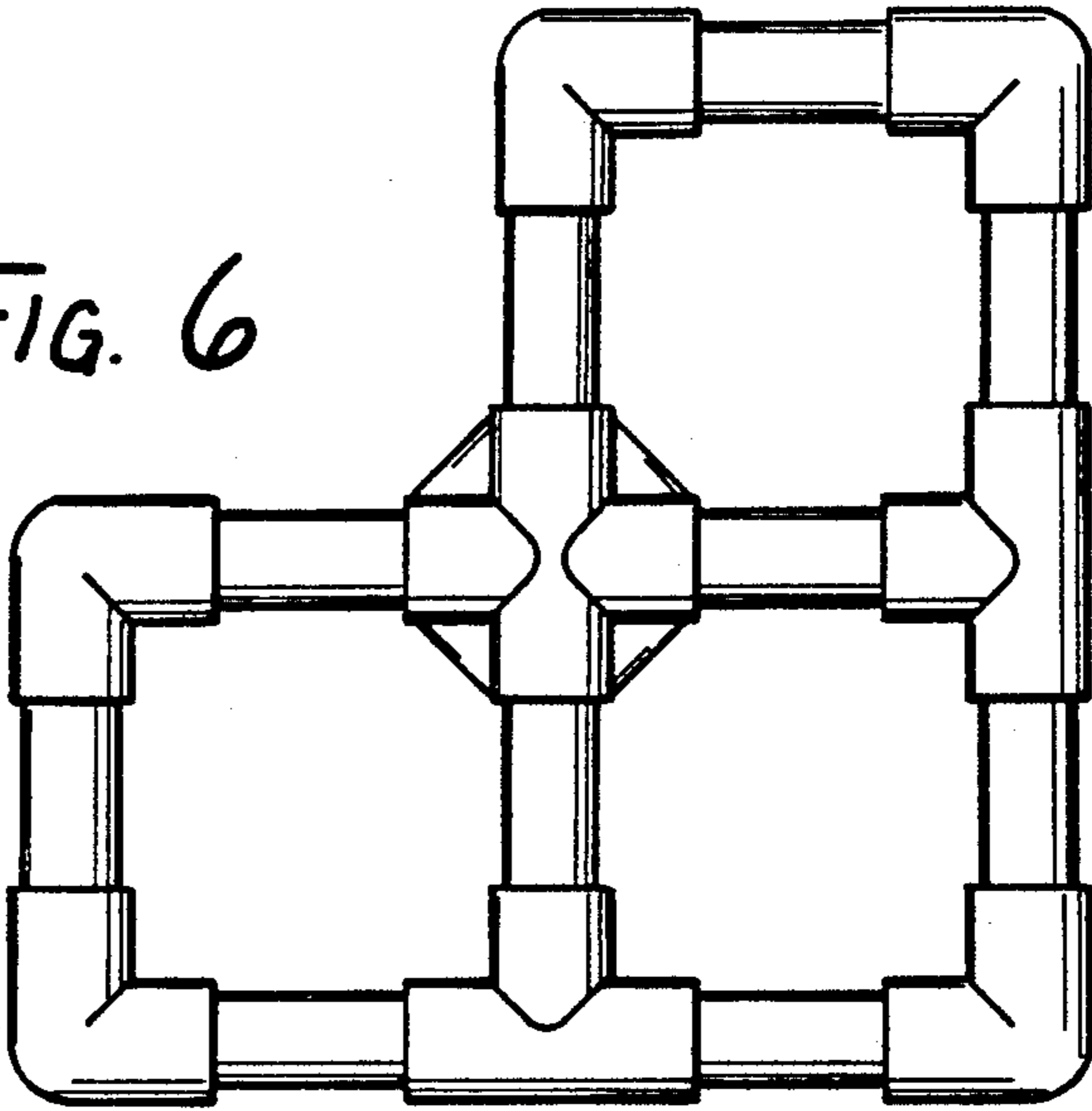
