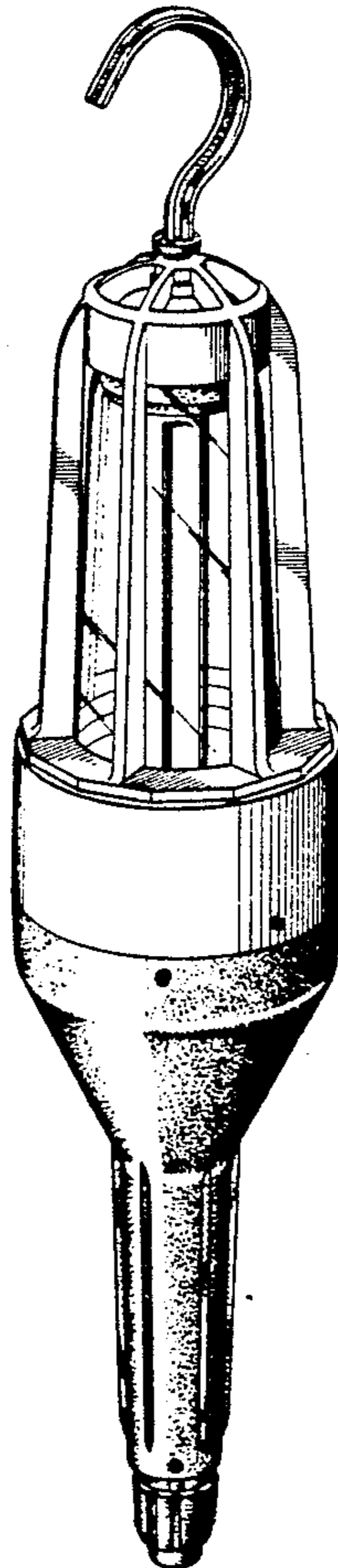

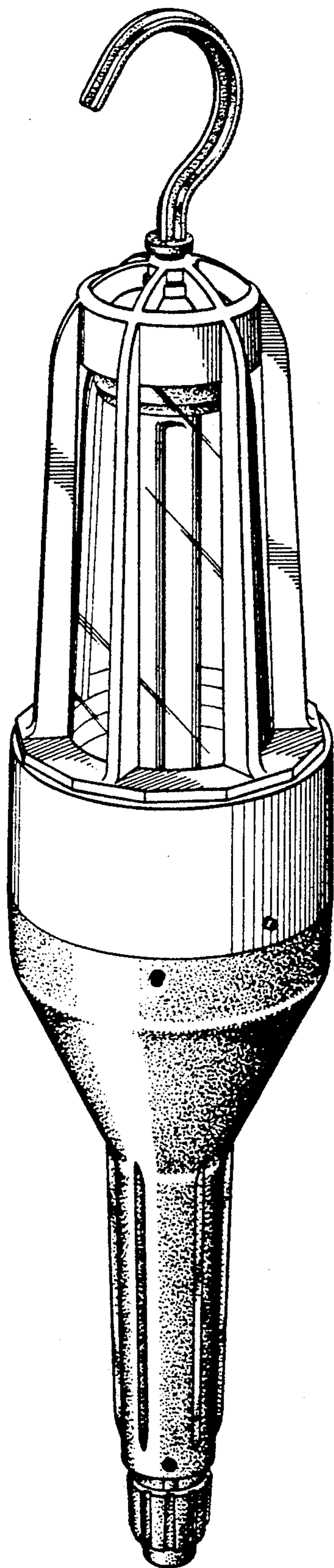
FIG. 1 is a front perspective view of a portable trouble lamp showing my new design;

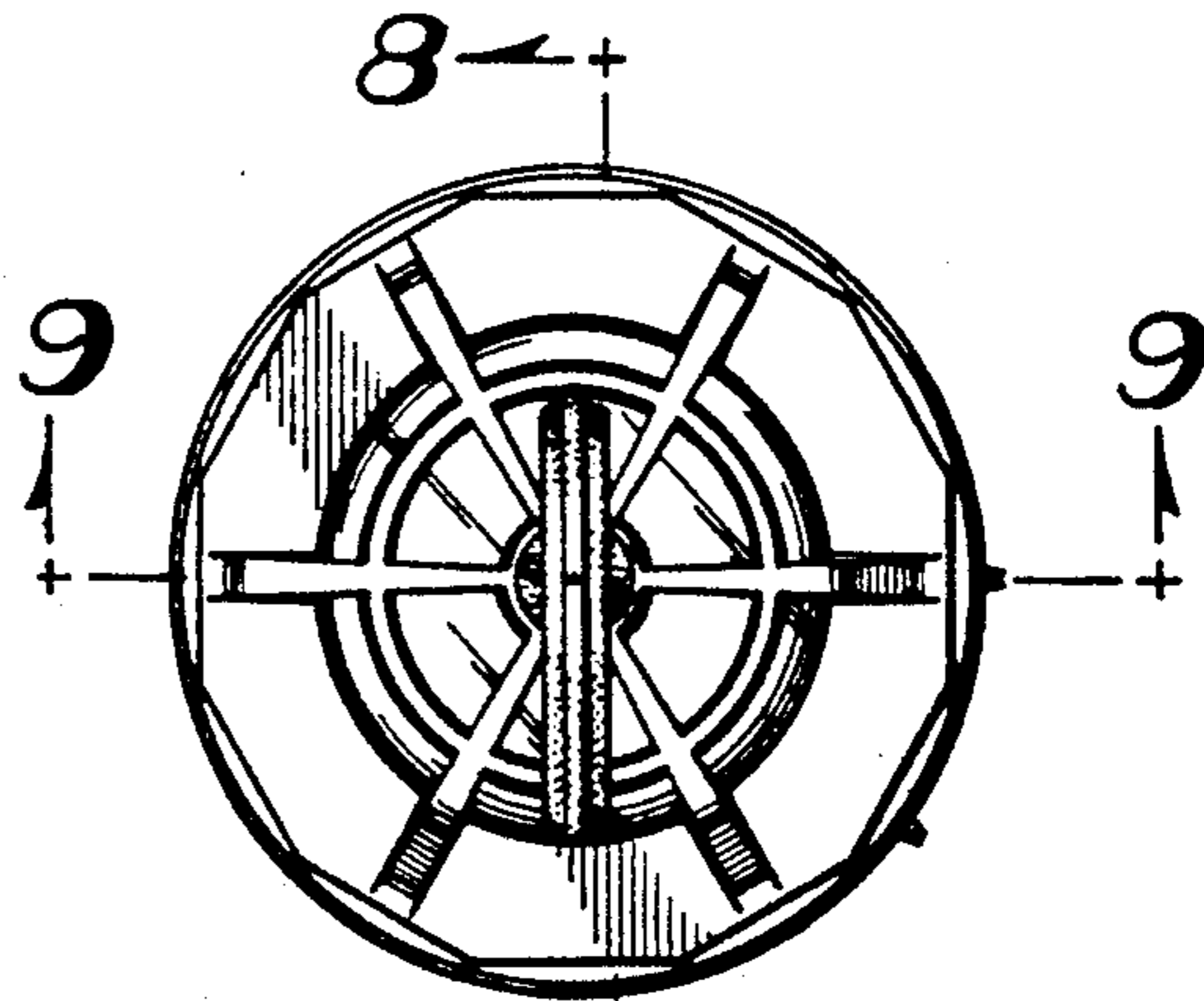

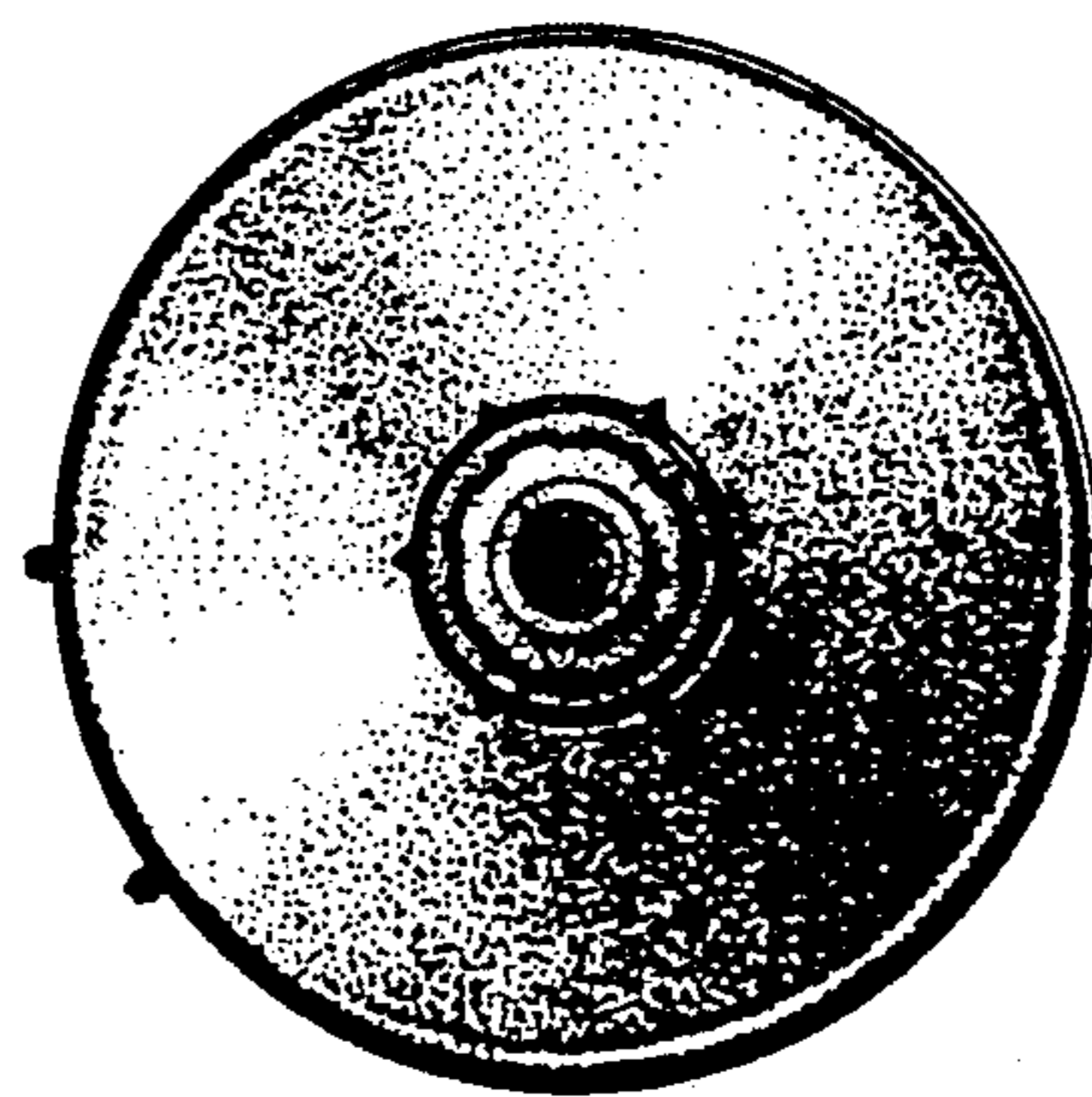




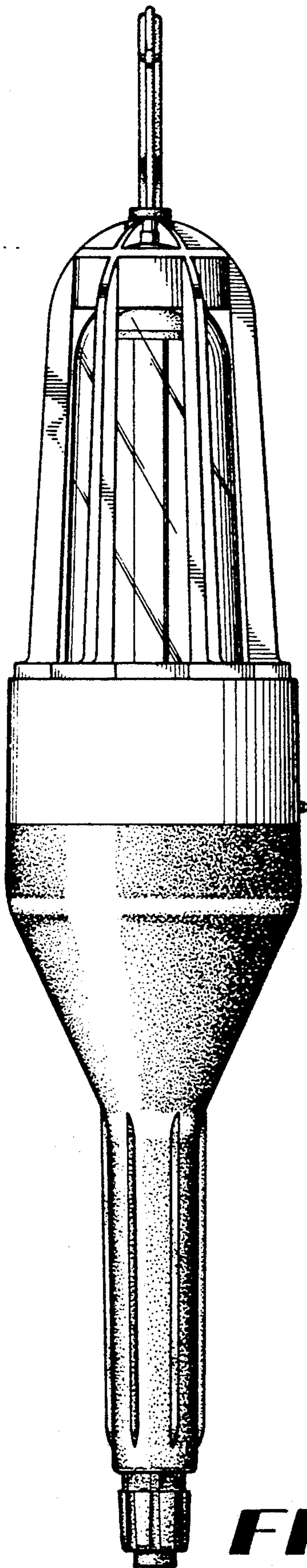

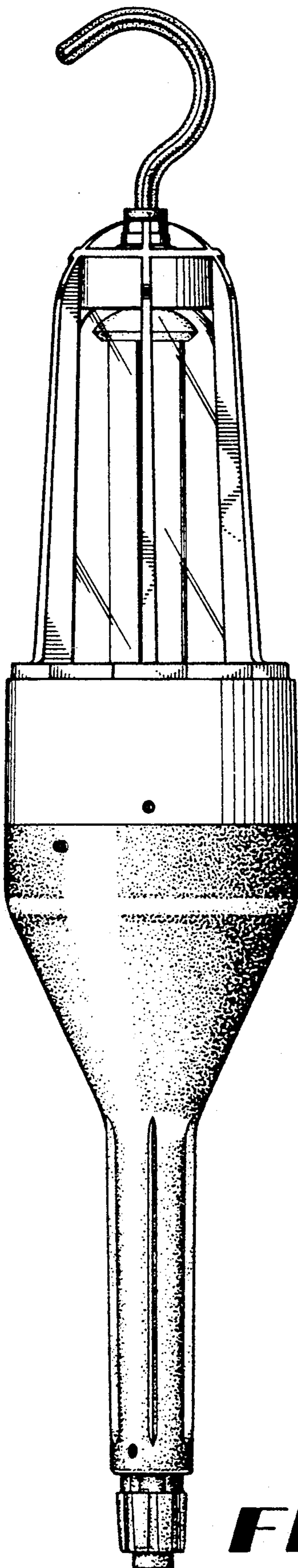

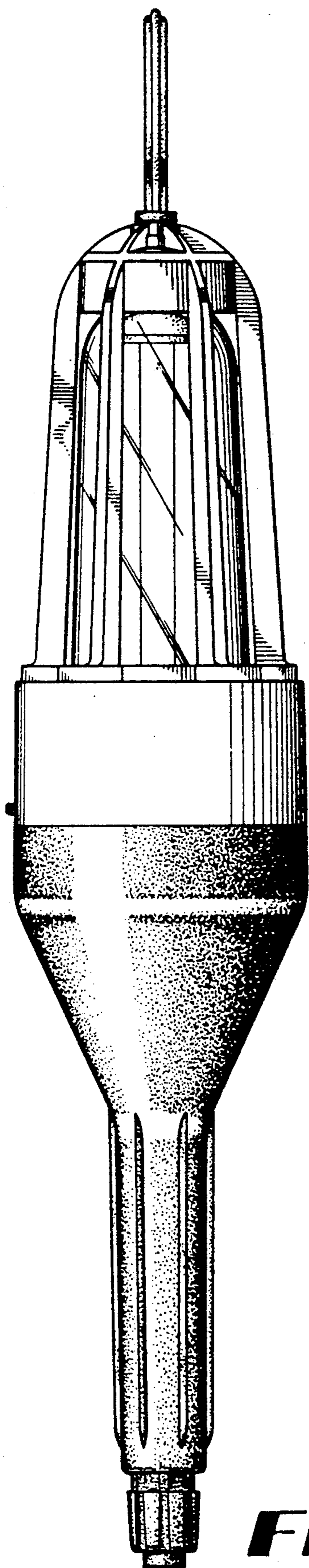

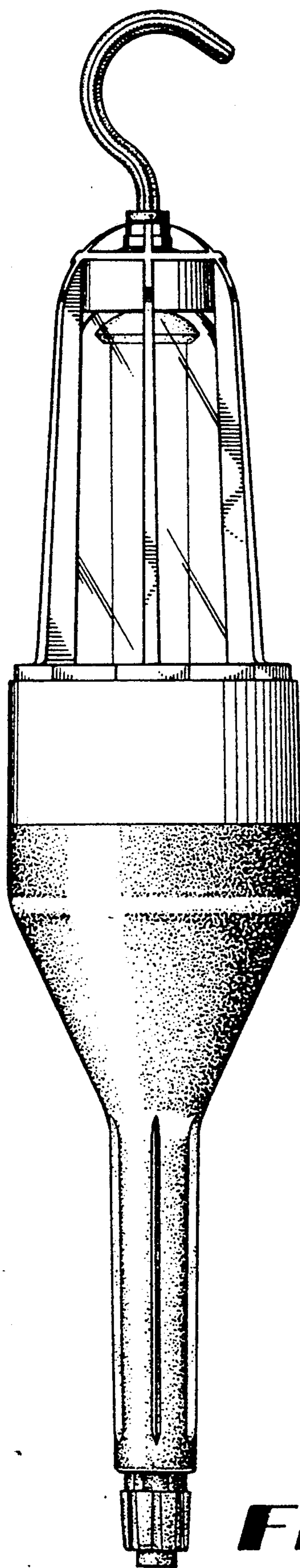

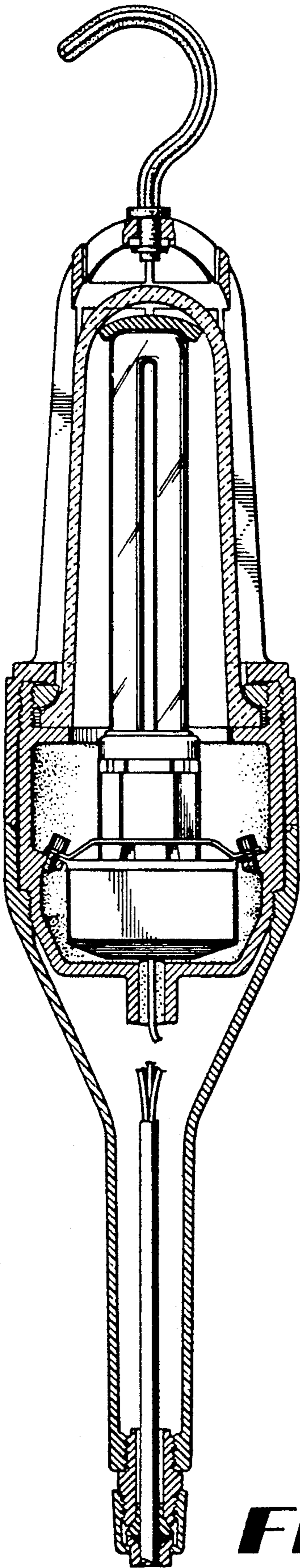

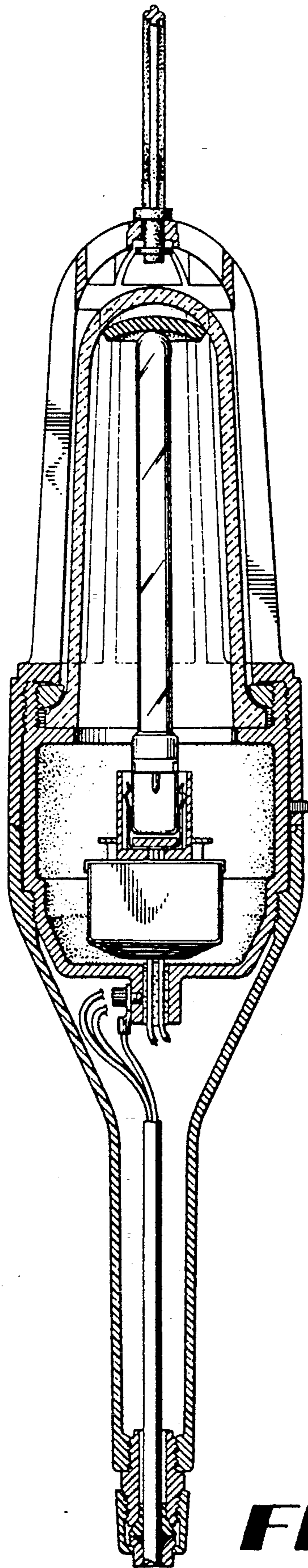
