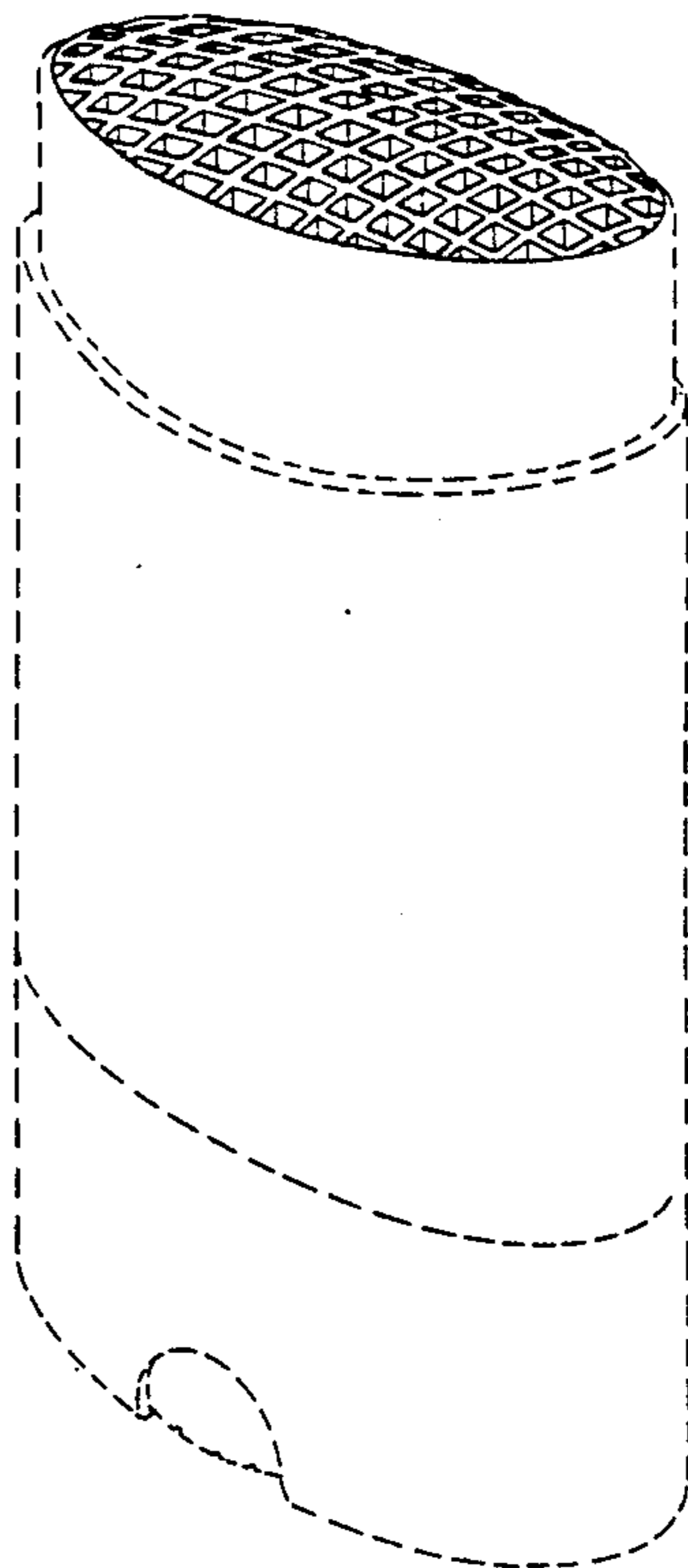

FIG. 1 is a perspective view of an applicator head for a cosmetic product dispenser showing my new design; FIG. 2 is a side elevational view thereof, the side opposite being identical to the side shown; FIG. 3 is an end elevational view thereof, the side opposite being identical to the side shown; FIG. 4 is a top plan view thereof; FIG. 5 is a sectional view taken along the line 5—5 of FIG. 4; and, FIG. 6 is an enlarged fragmentary perspective view of the portion of the applicator delineated by the oval in FIG. 4.

The broken lines showing of a cosmetic package is for illustrative purposes only and forms no part of the claimed design.



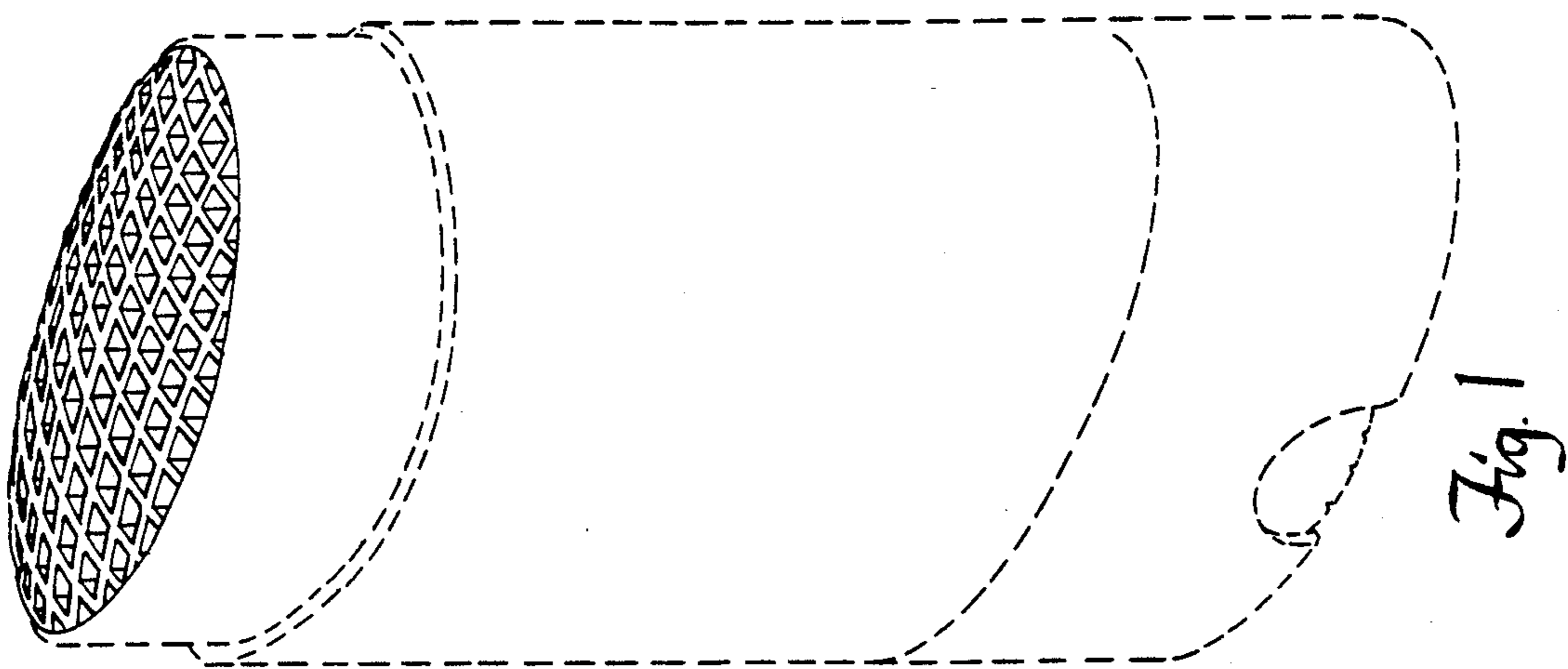

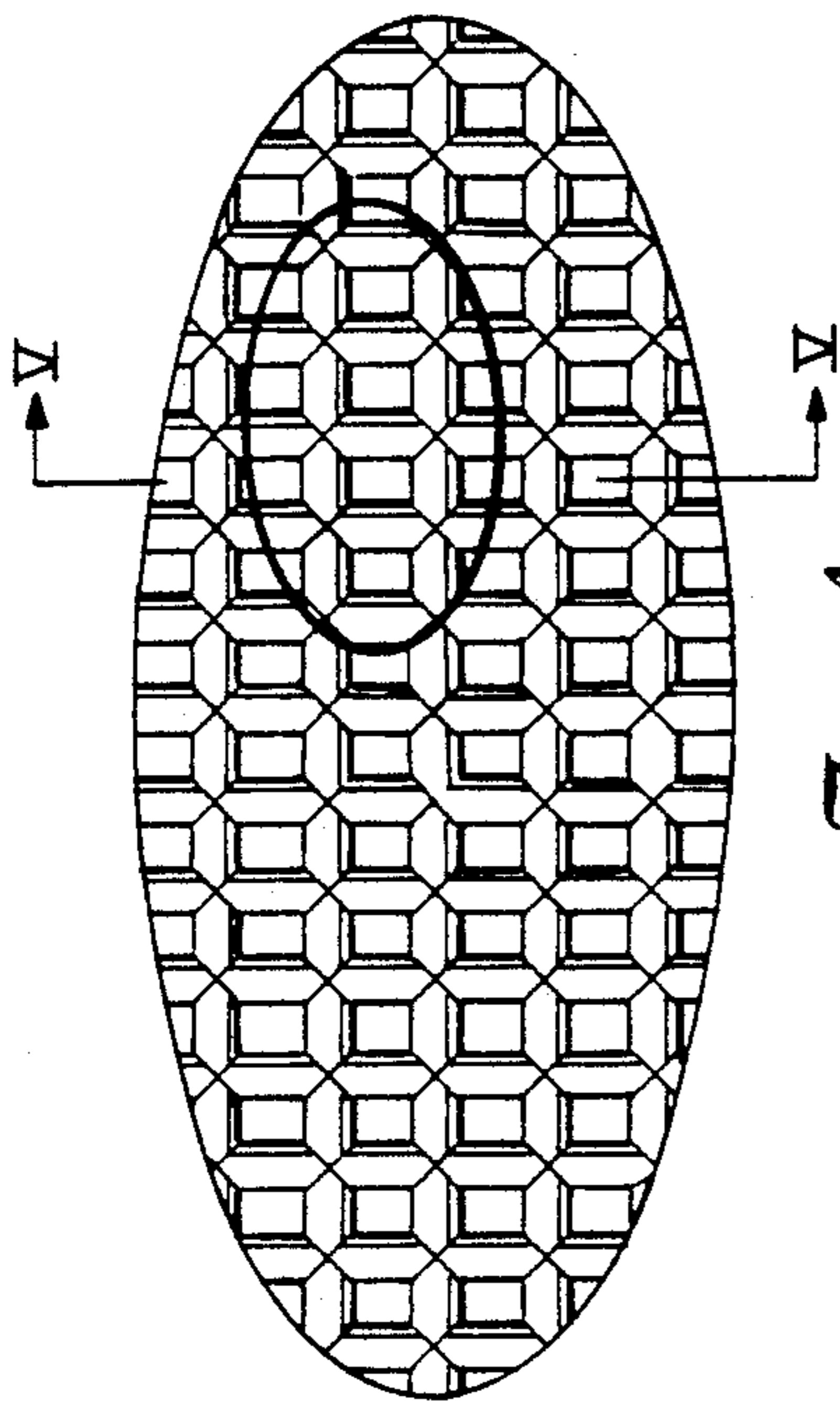

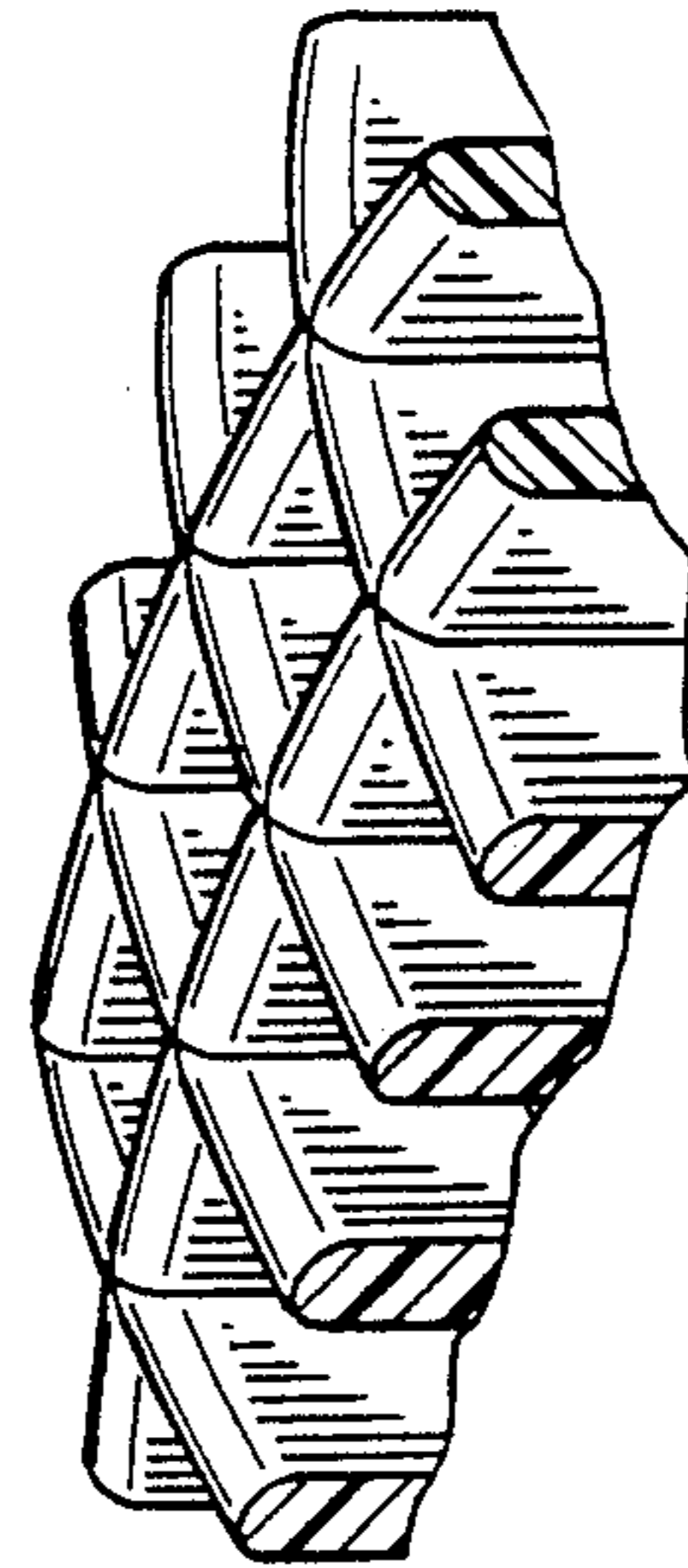
