The ornamental design for a combined storage box for cat toys and playhouse for cats, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a combined storage box for cat toys and playhouse for cats showing my new design;

FIG. 2 is a rear elevational view thereof;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 6 is a bottom plan view thereof.

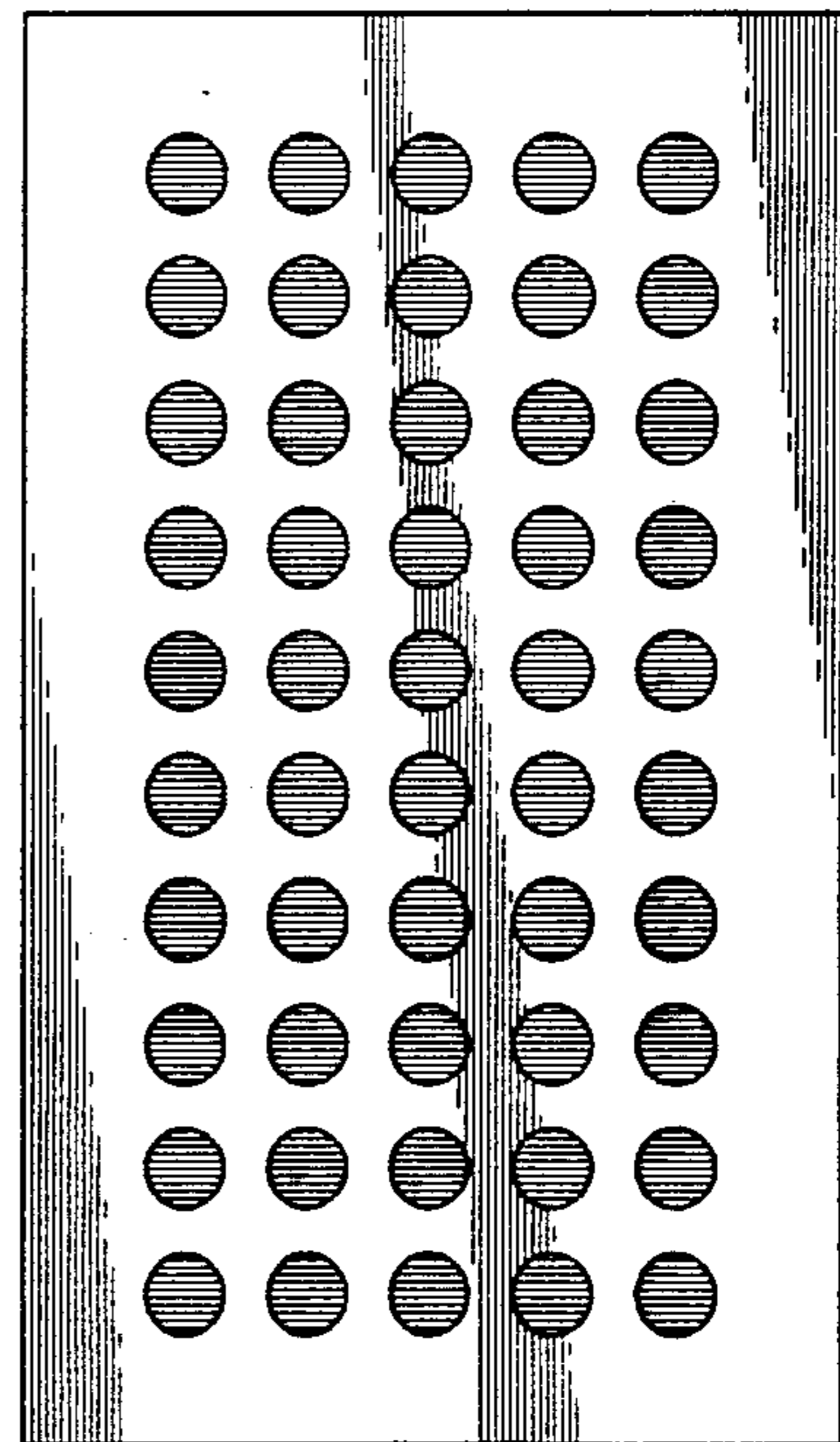
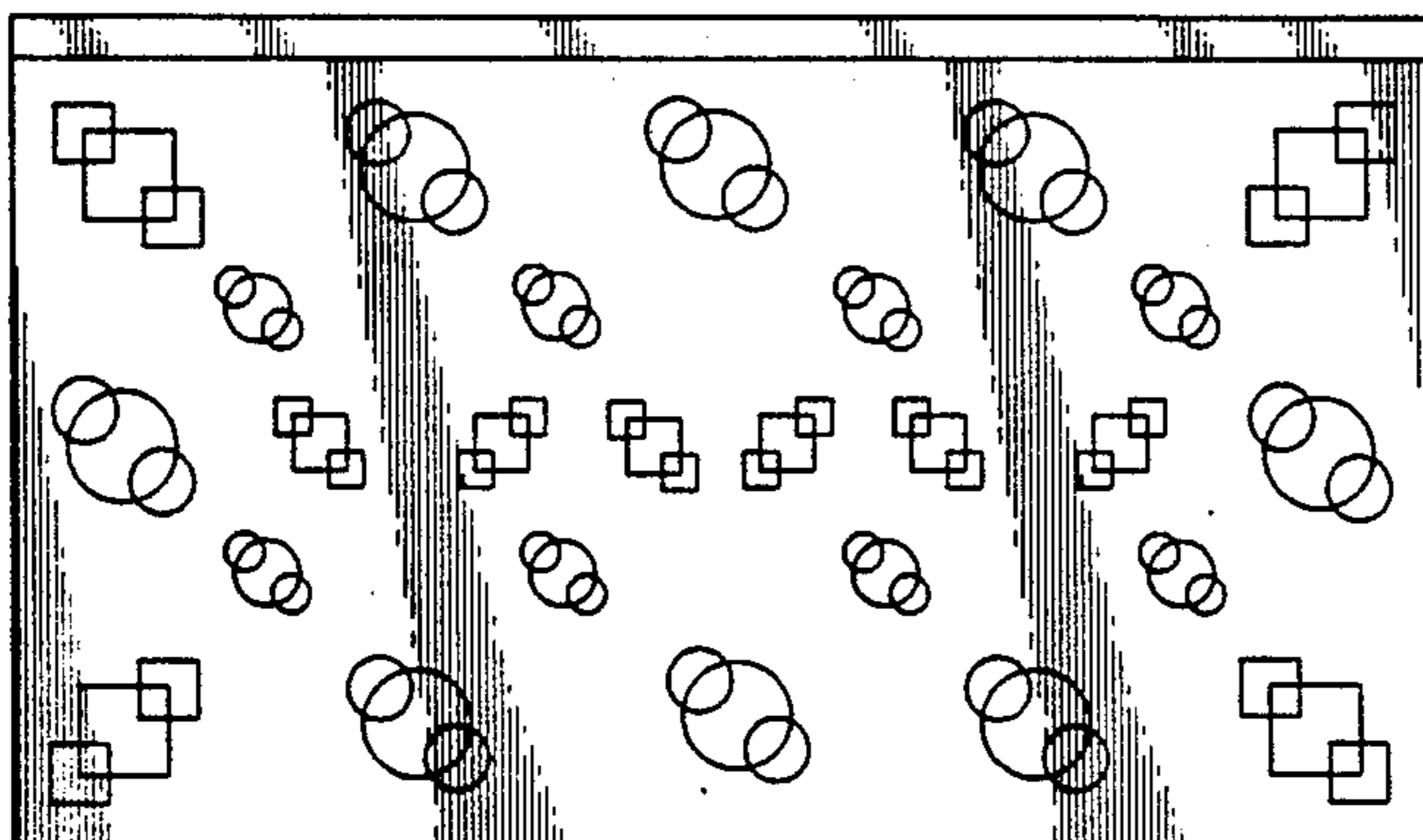
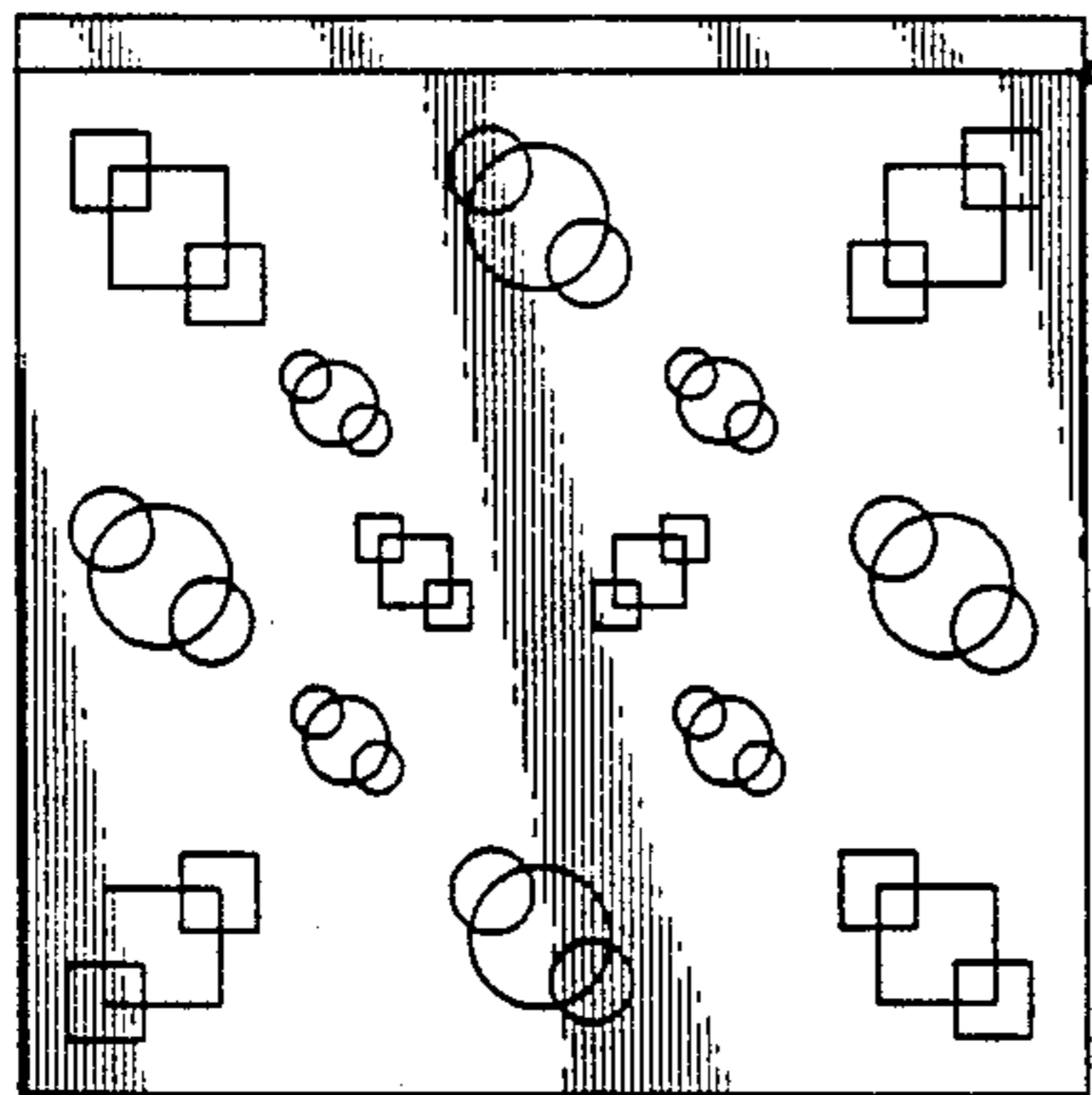

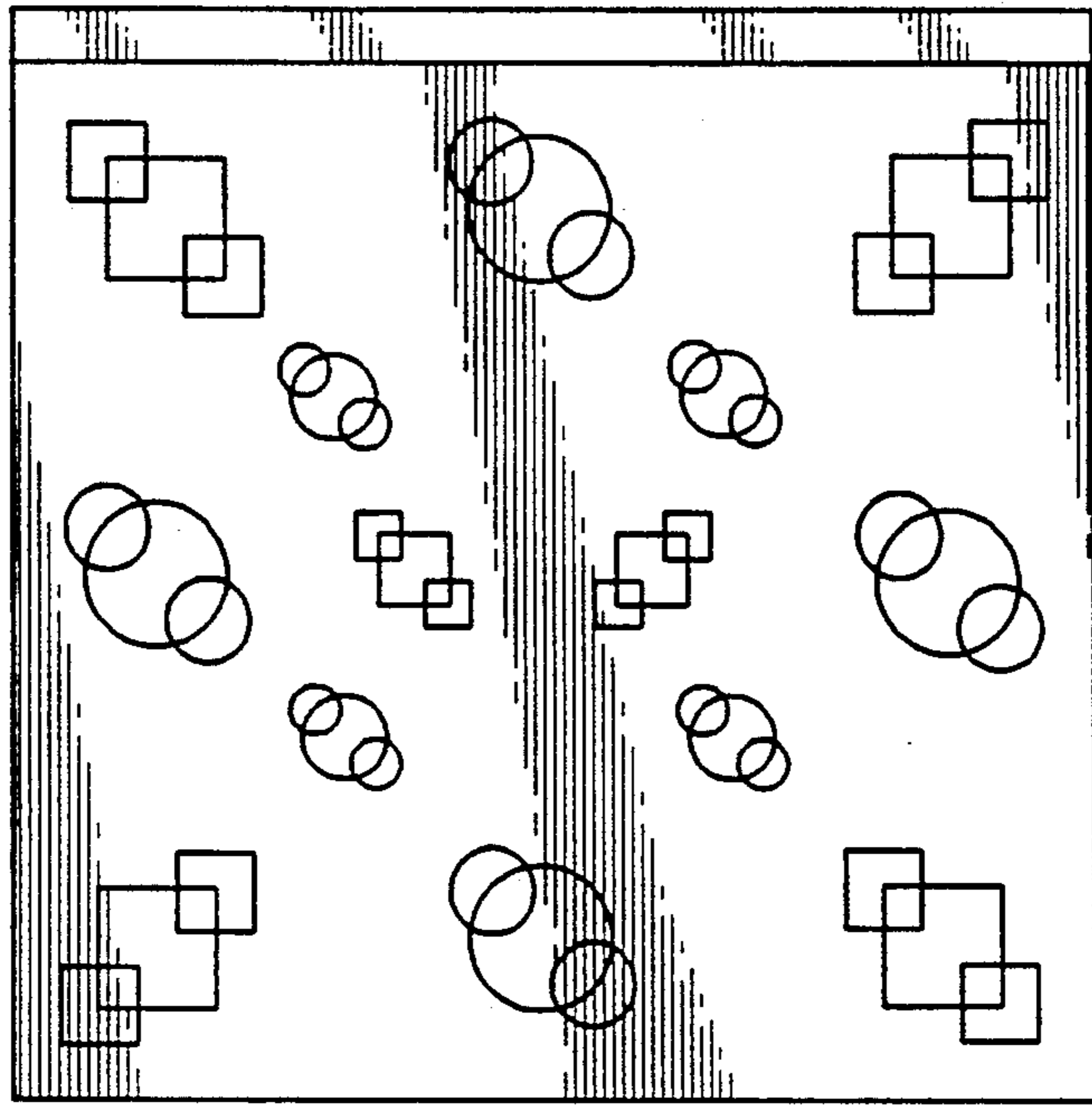

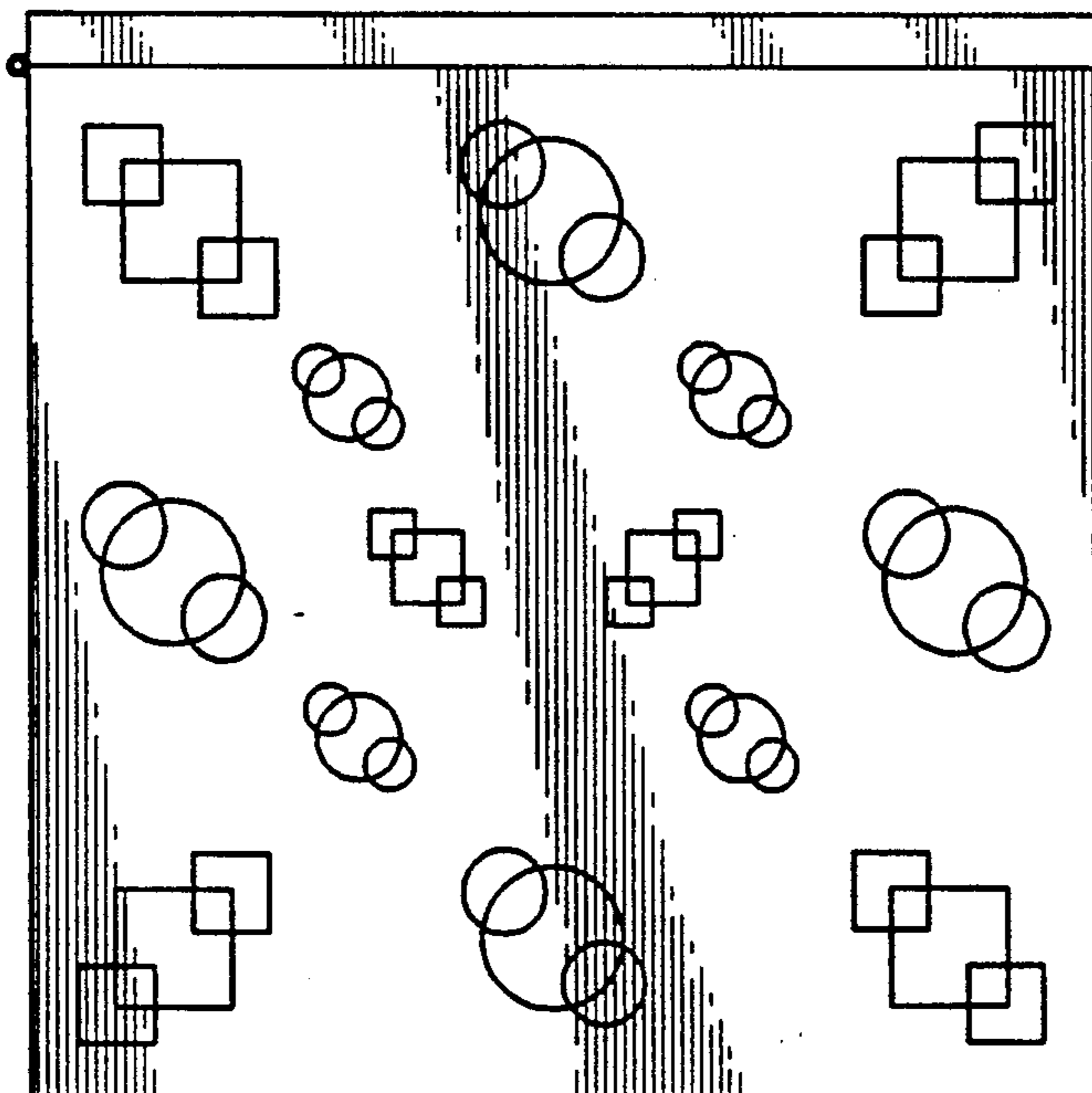

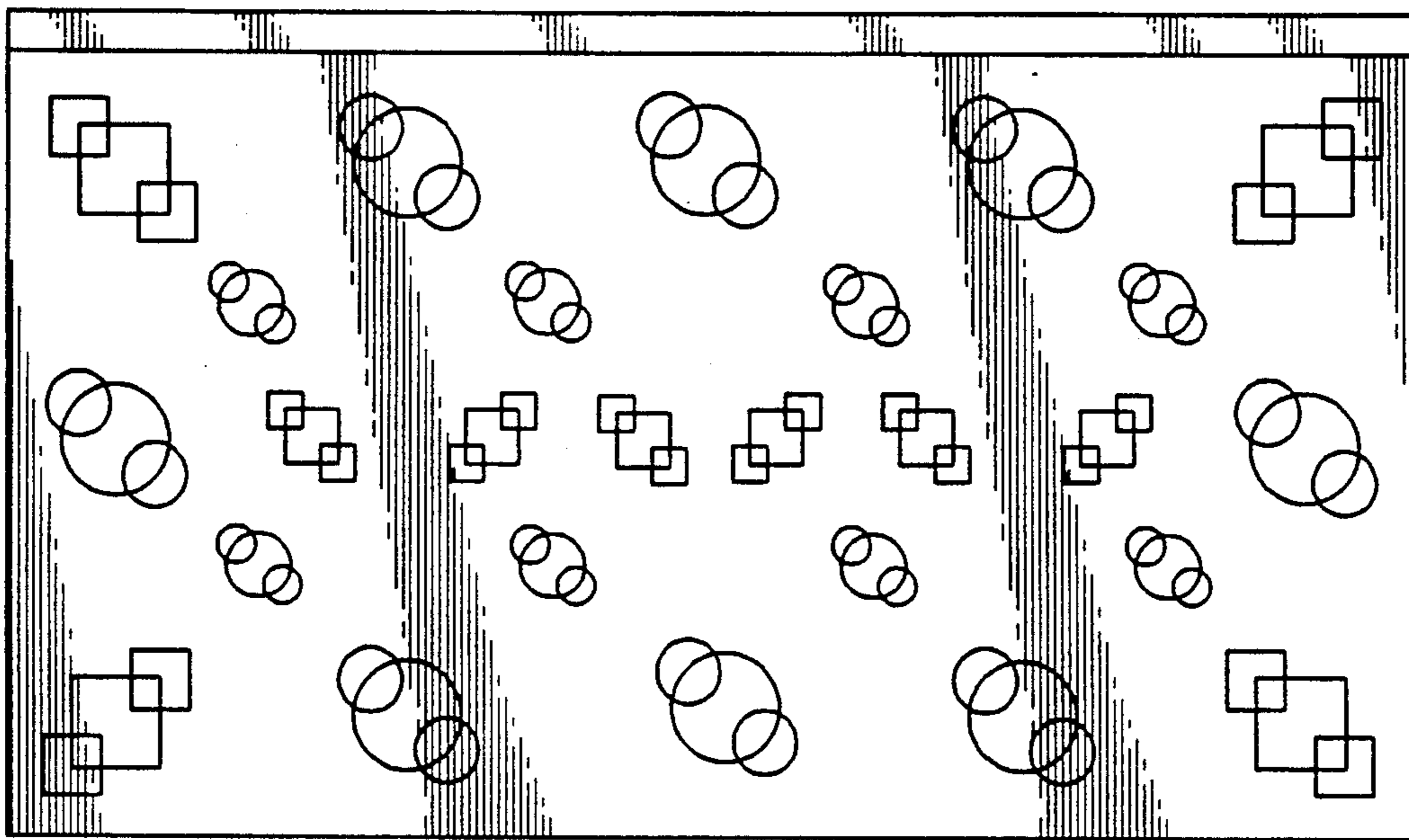

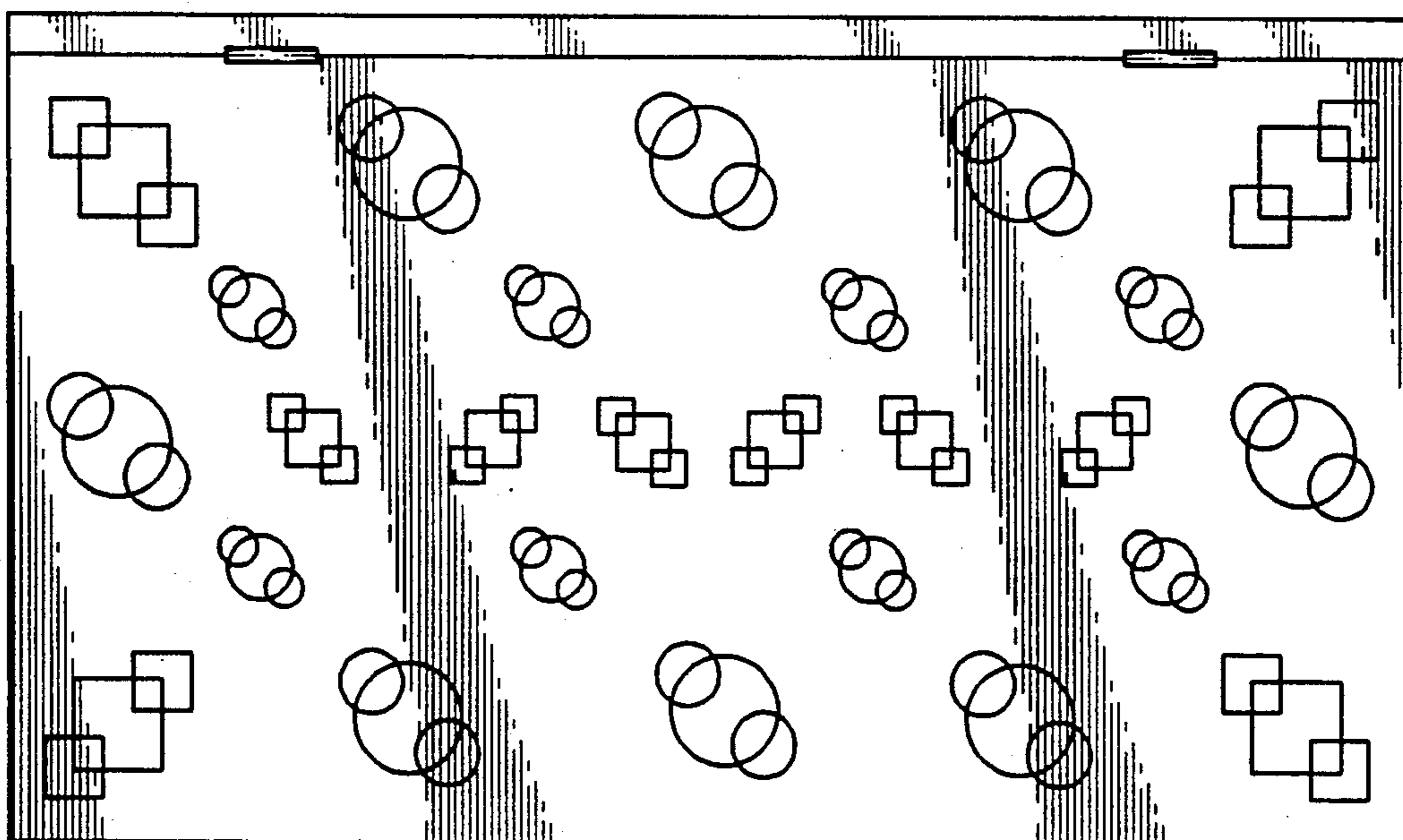

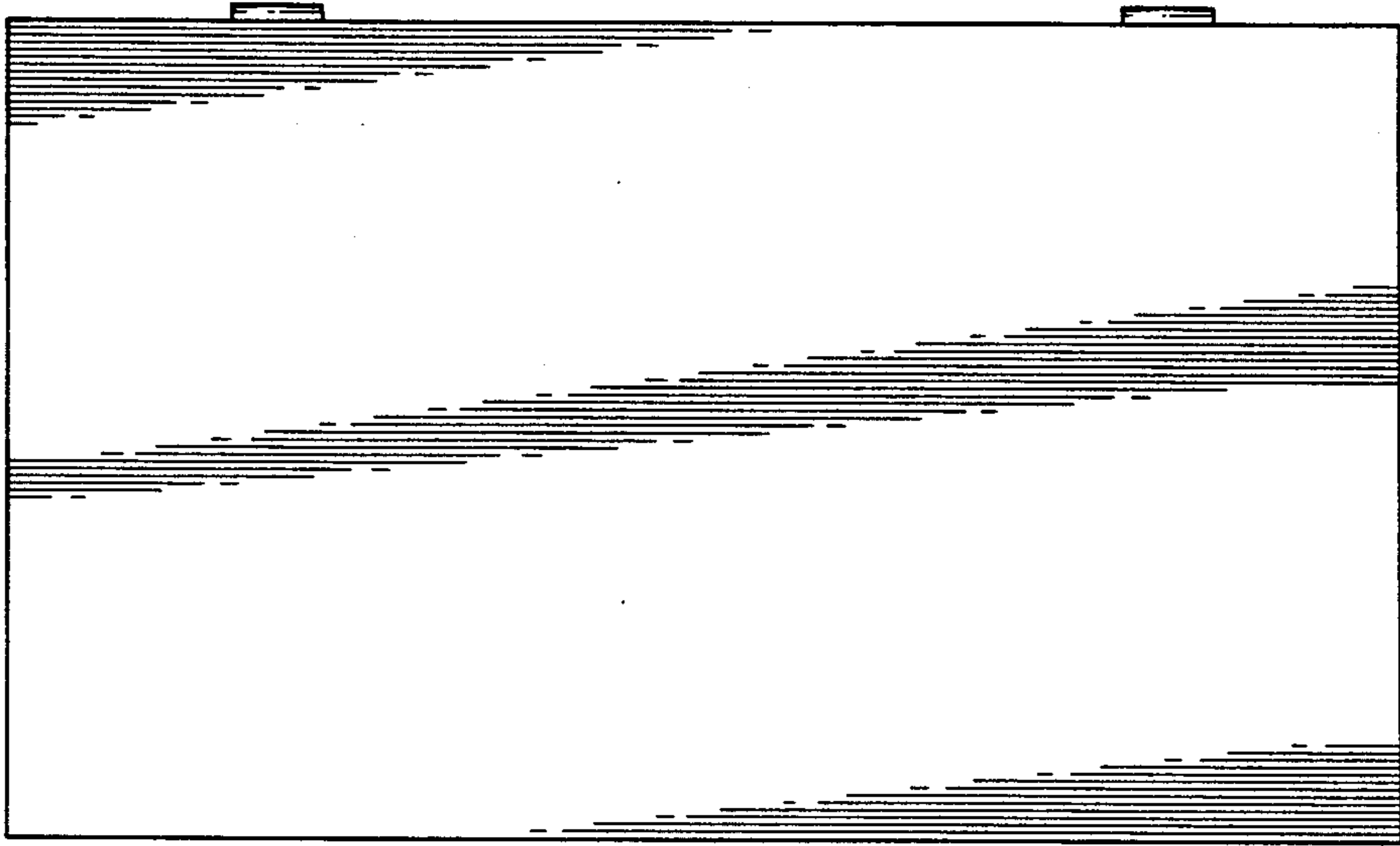
