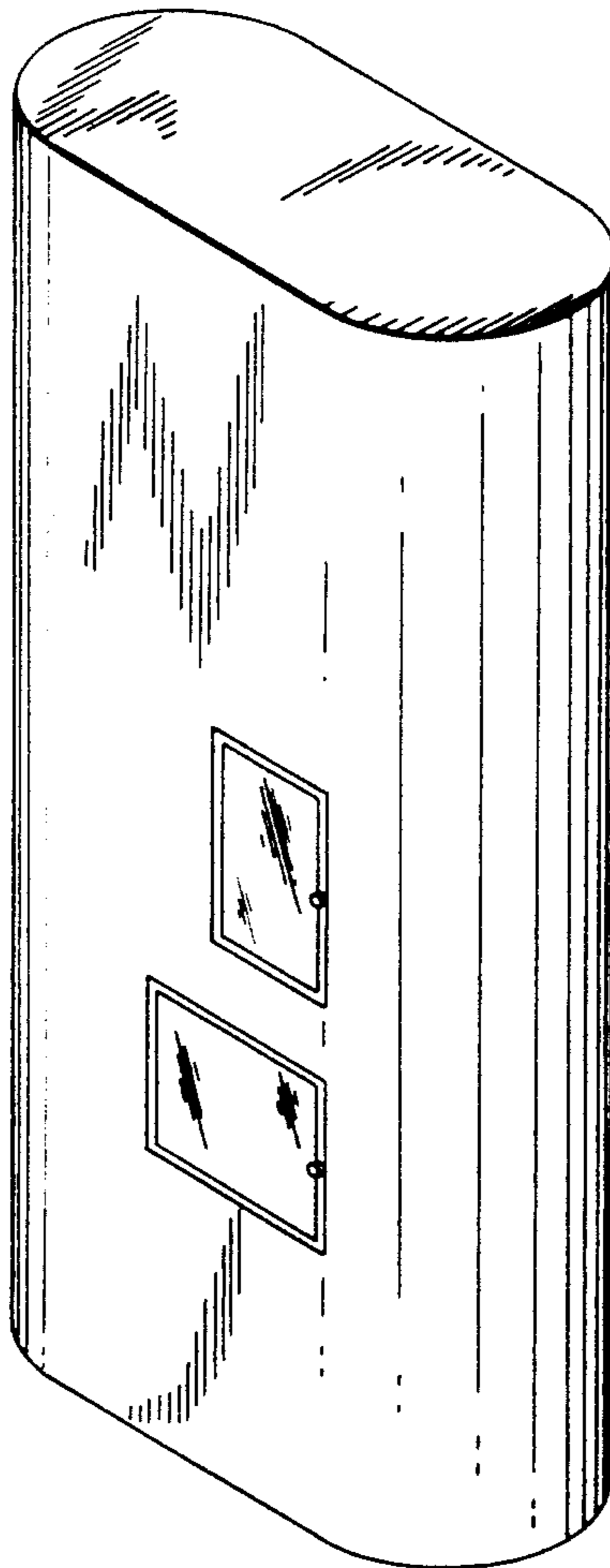

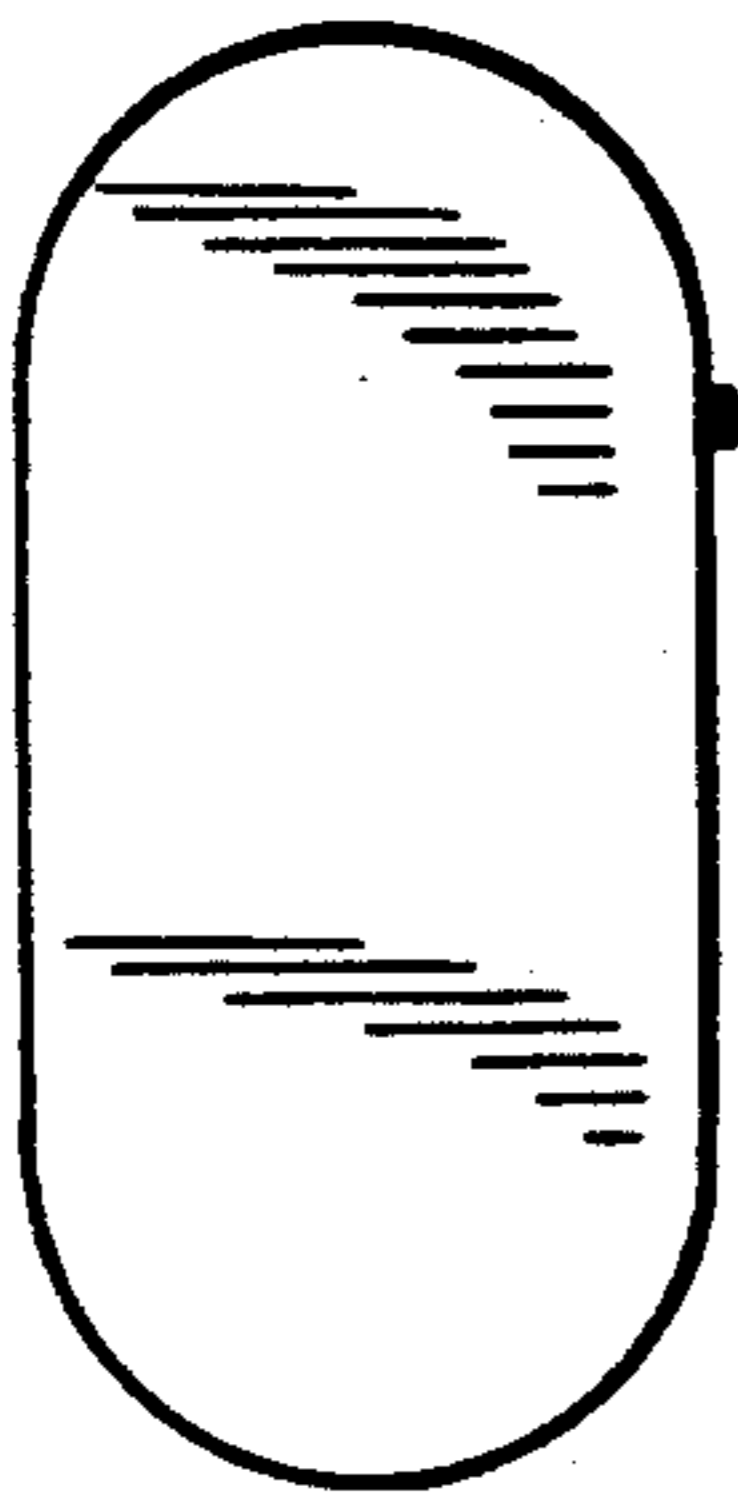
The ornamental design for a combined store partition and display cabinet, as shown and described.

**DESCRIPTION**

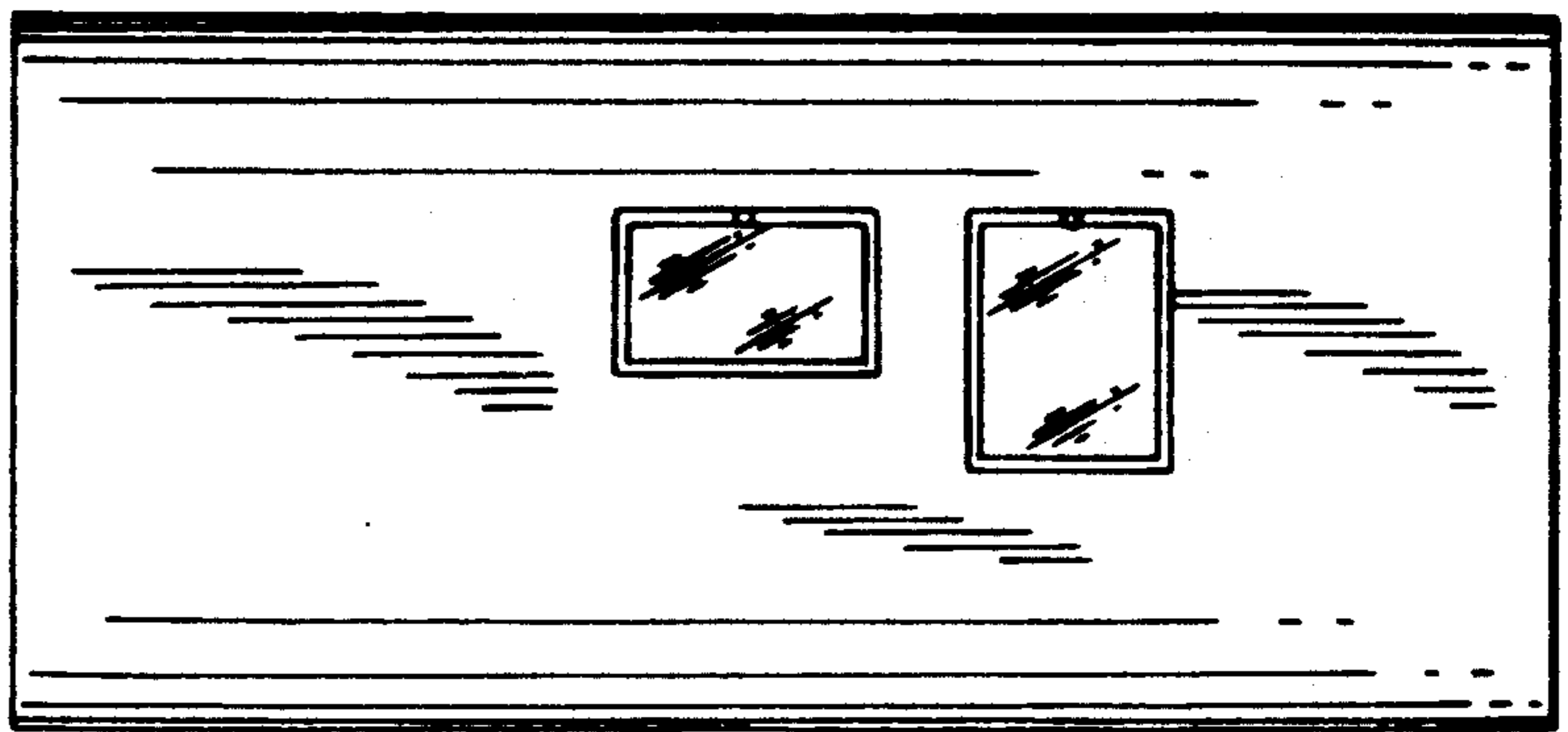
FIG. 1 is a top plan view of a combined store partition and display cabinet showing my new design;

 FIG. 5 is an enlarged perspective view thereof.



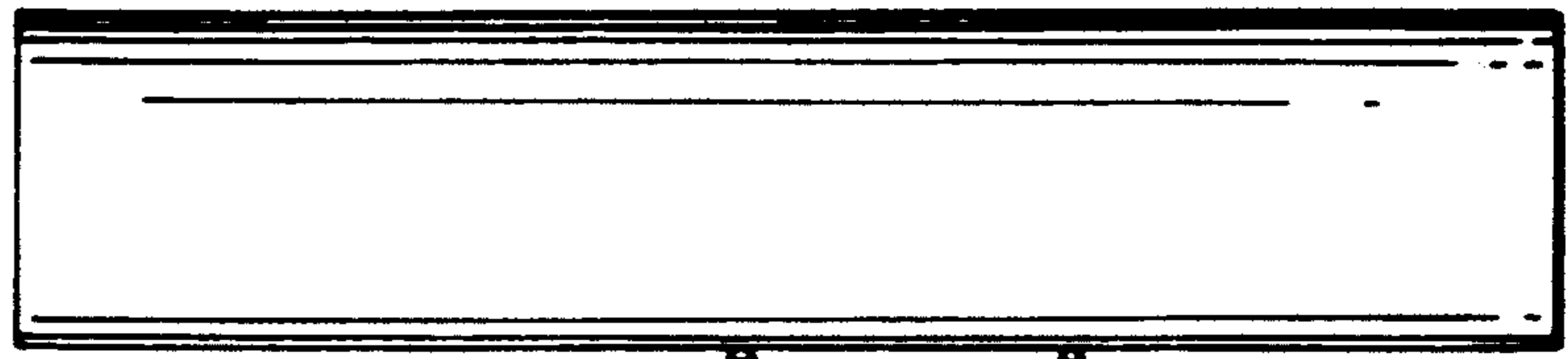

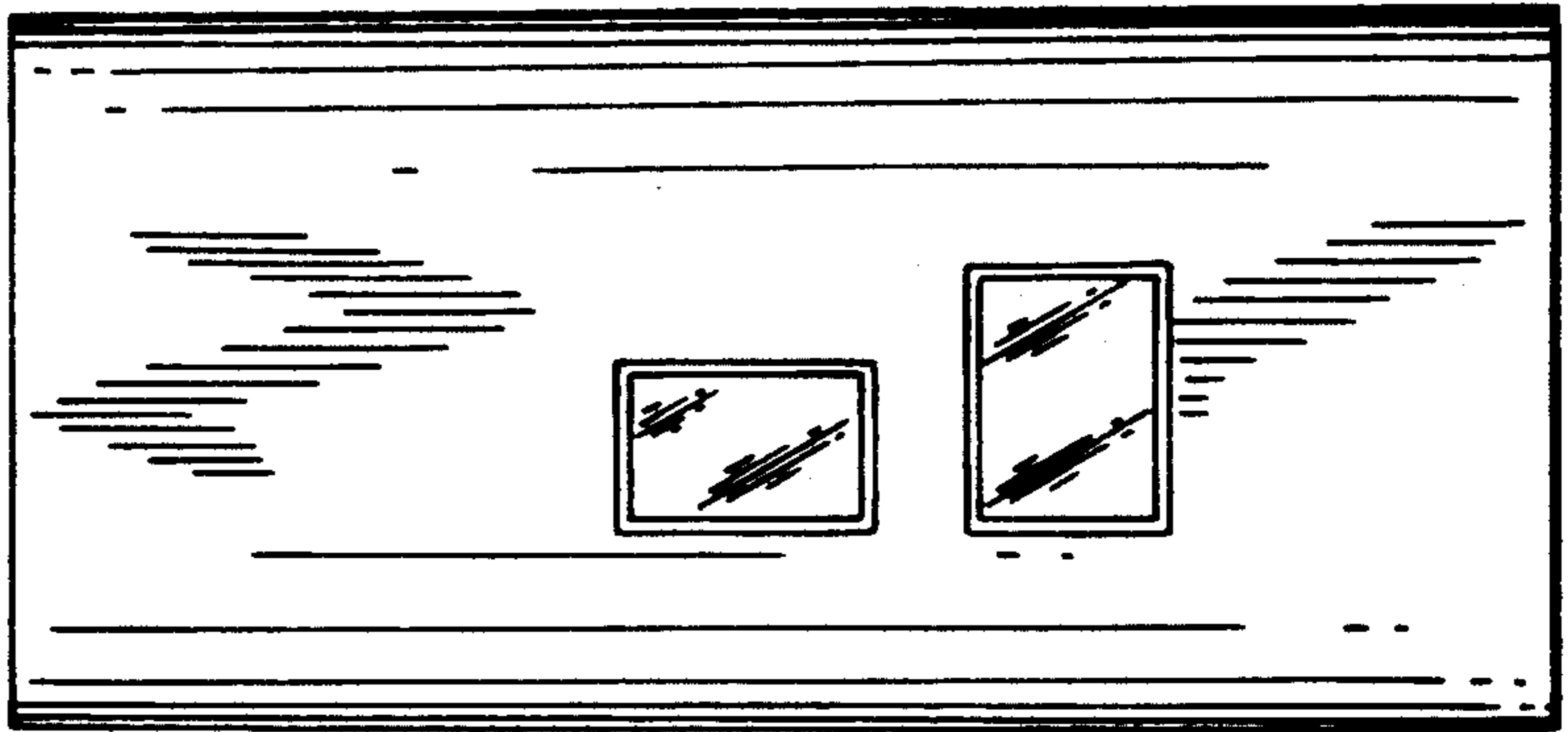
