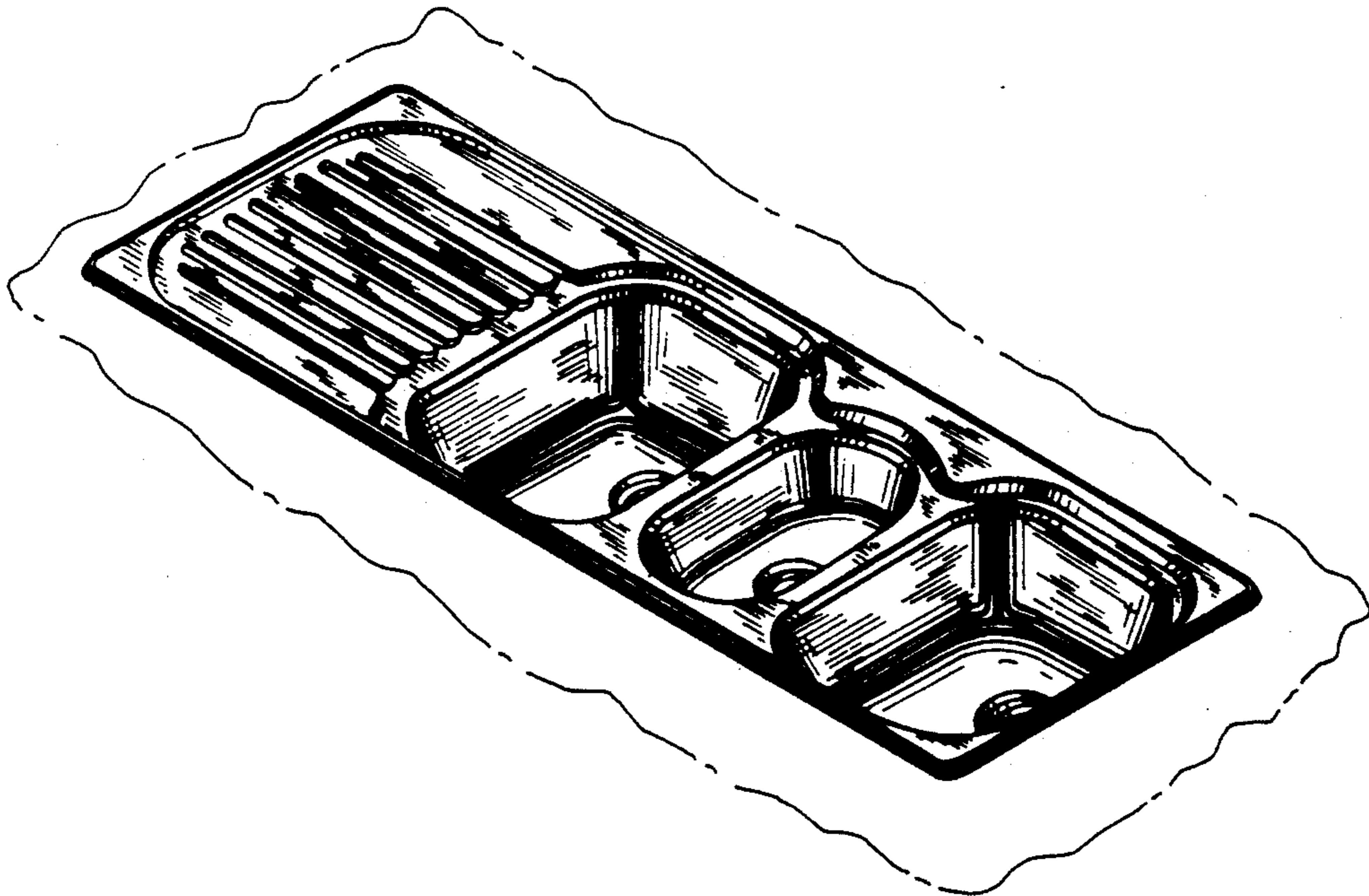

[57] **CLAIM**

The ornamental design for a sink, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view taken from the top, front and right side of a sink showing our new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a cross-sectional view taken on line 3—3 of FIG. 2;  
FIG. 4 is a cross-sectional view taken on line 4—4 of FIG. 2;  
FIG. 5 is a cross-sectional view taken on line 5—5 of FIG. 2;  
FIG. 6 is an enlarged cross-sectional view taken on line 6—6 of FIG. 2;  
FIG. 7 is a top plan view of a second embodiment thereof;  
FIG. 8 is a perspective view taken from the top, front and right side of a third embodiment thereof;  
FIG. 9 is a top plan view of FIG. 8;  
FIG. 10 is a cross-sectional view taken on line 10—10 of FIG. 9;  
FIG. 11 is a cross-sectional view taken on line 11—11 of FIG. 9; and,  
FIG. 12 is a cross-sectional view taken on line 12—12 of FIG. 9.  
The fragmentary broken line representations of countertops in FIGS. 1 and 8 are for the purpose of illustration only and form no part of the claimed design.



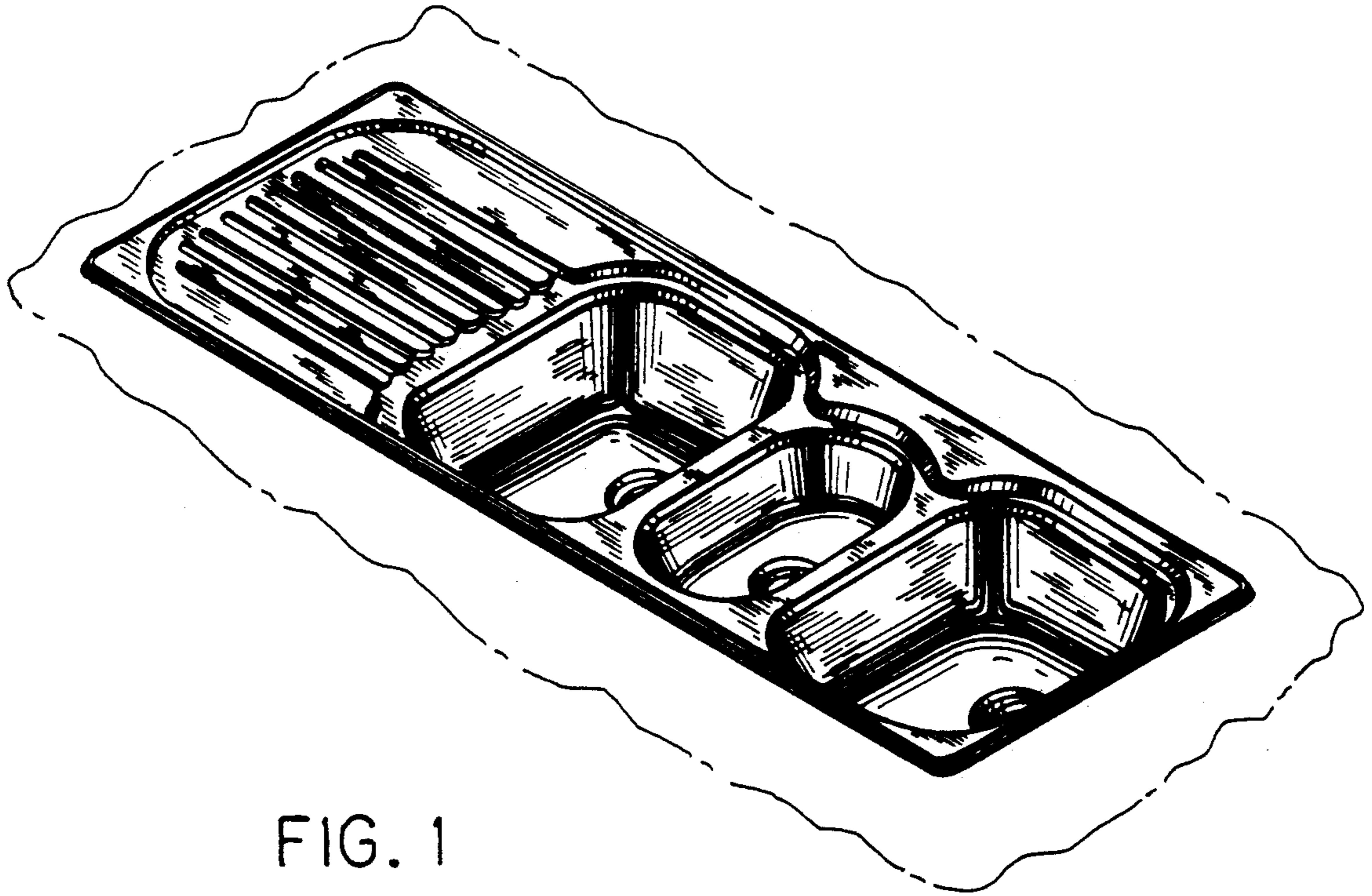
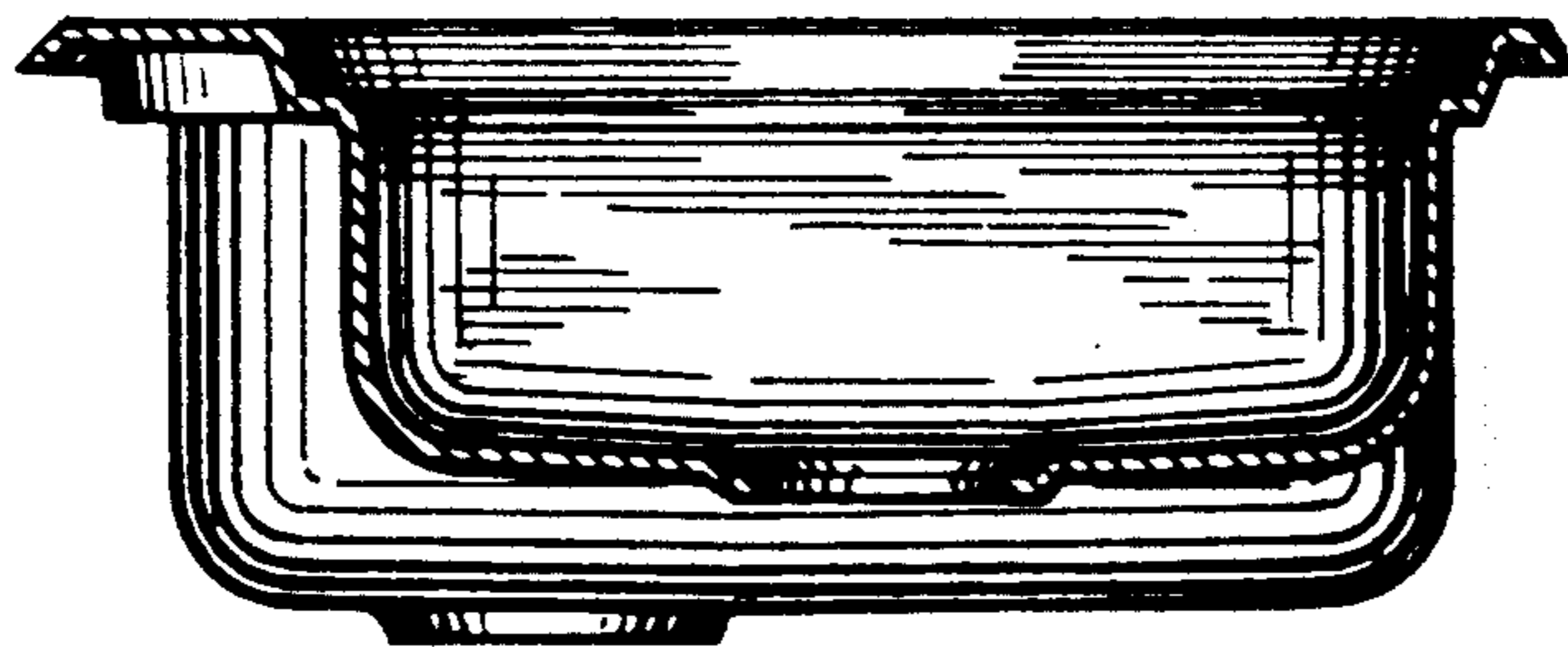

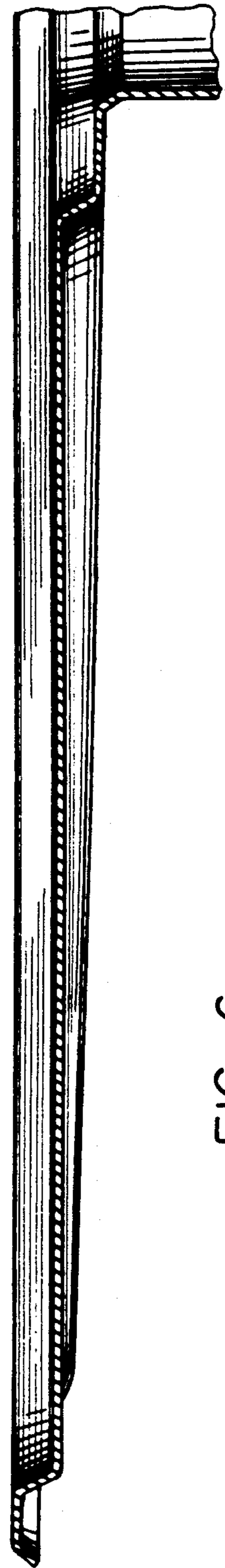
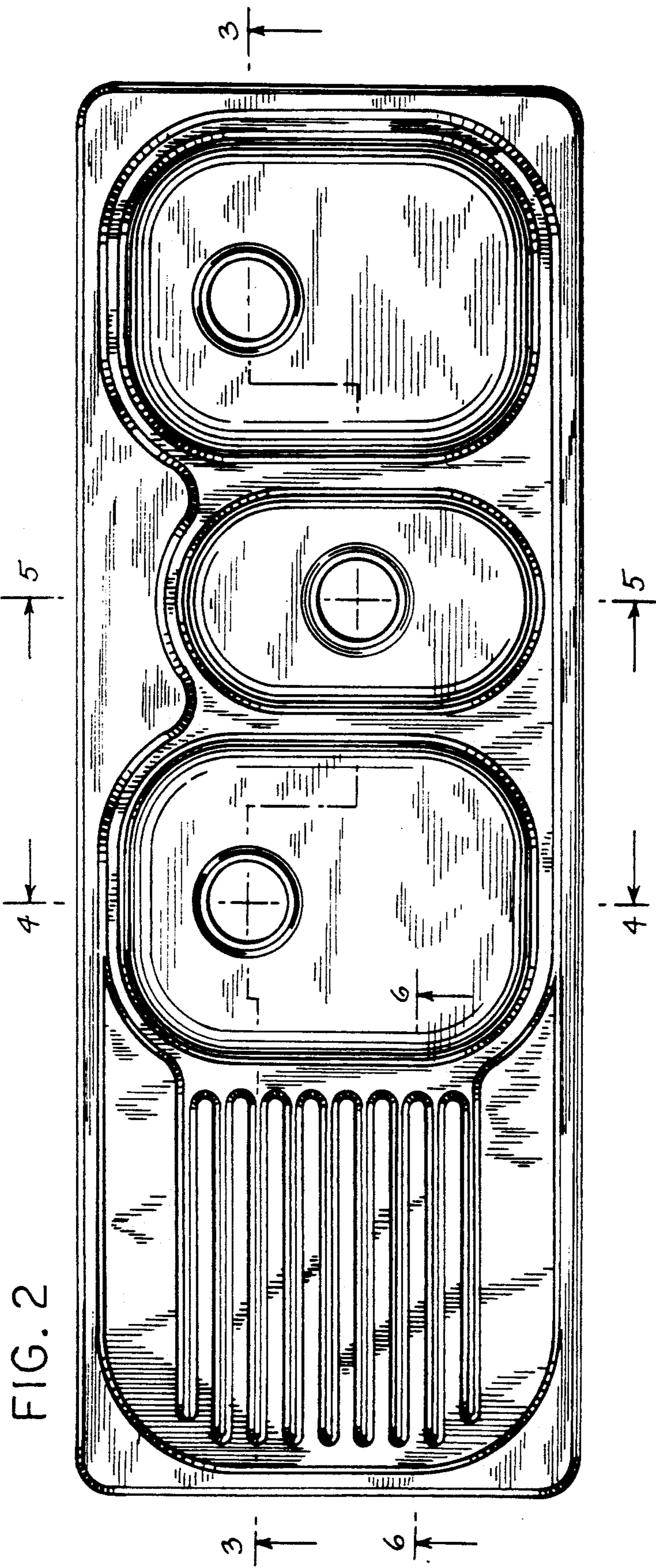

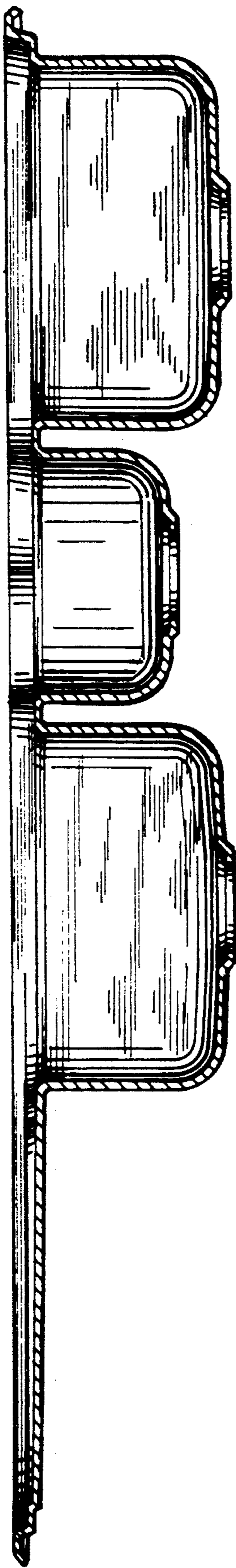

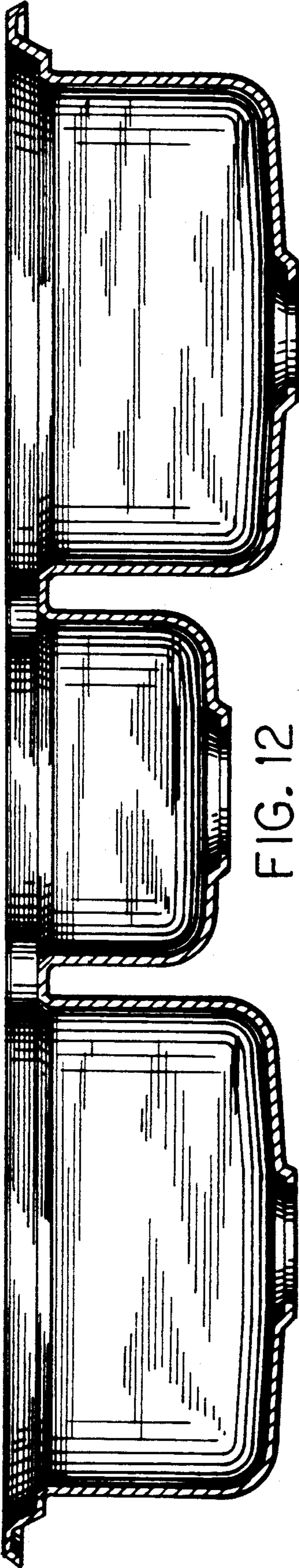
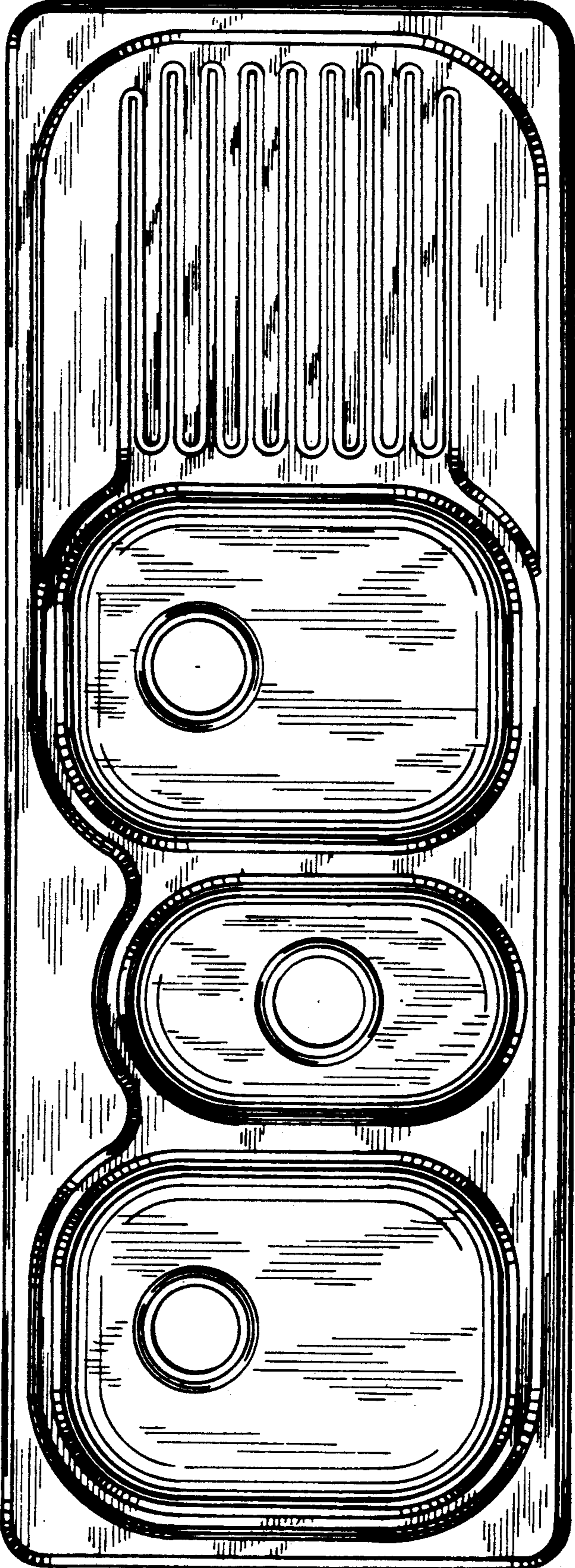

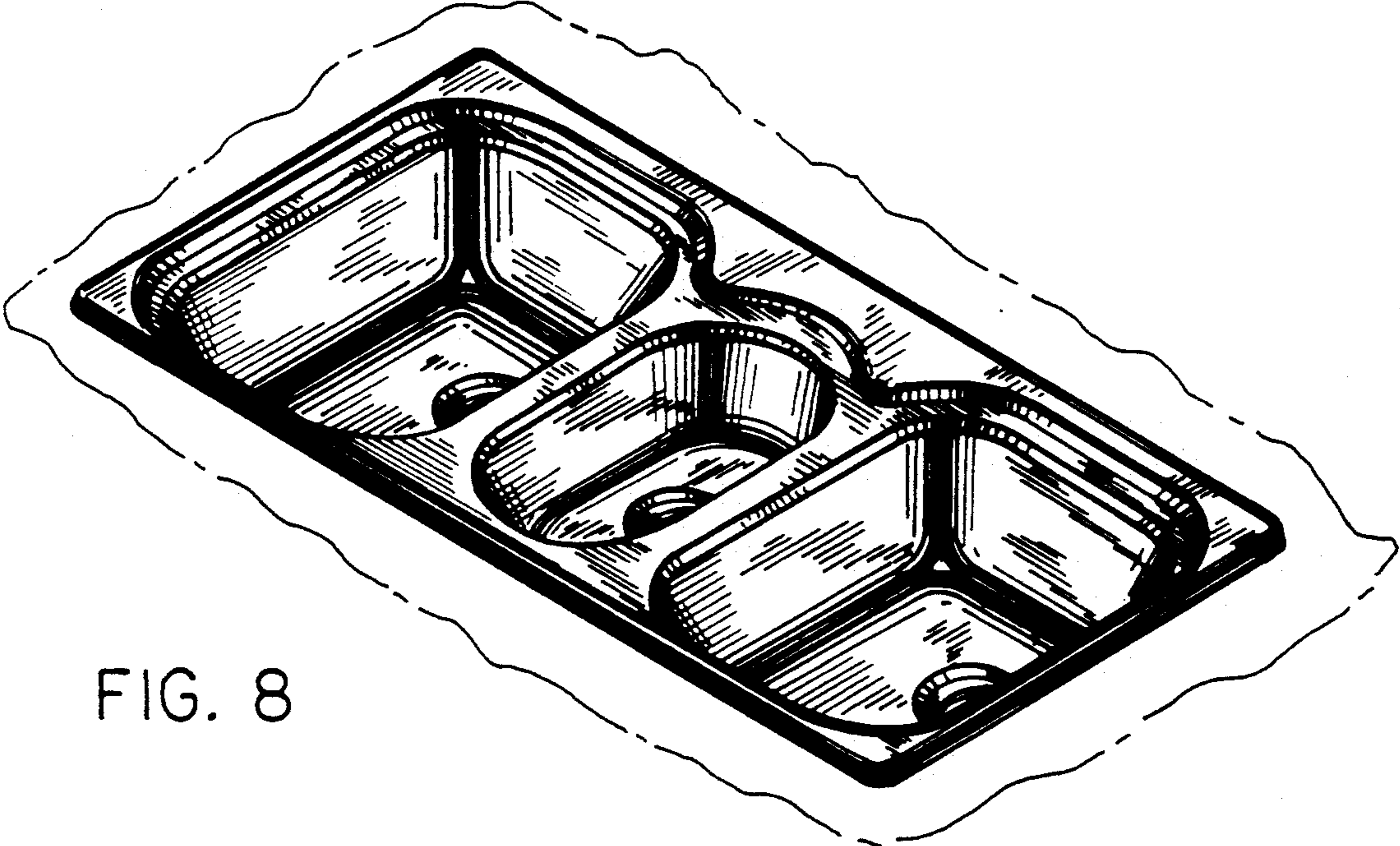

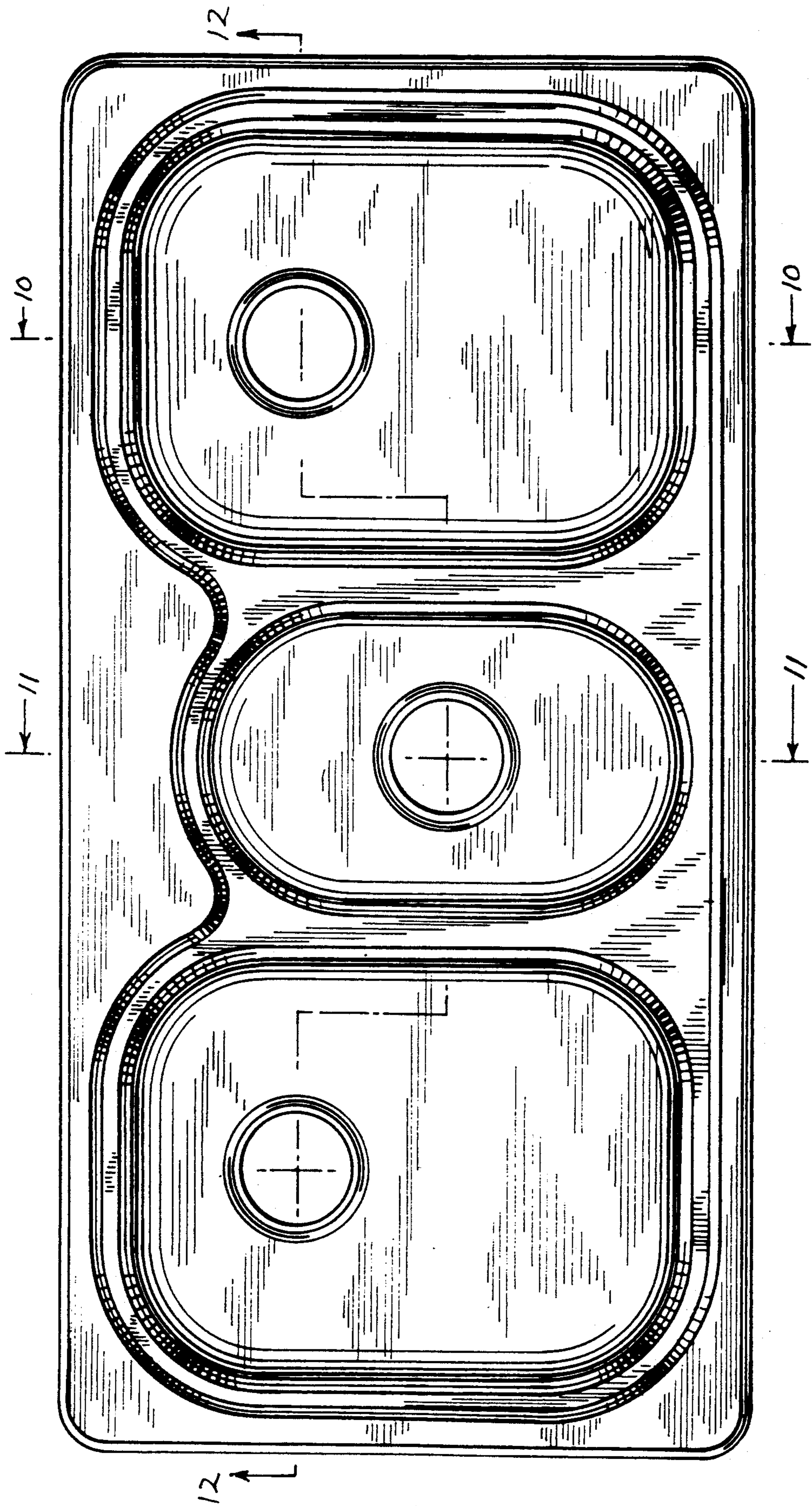
