 FIG. 33 is a bottom plan view thereof.

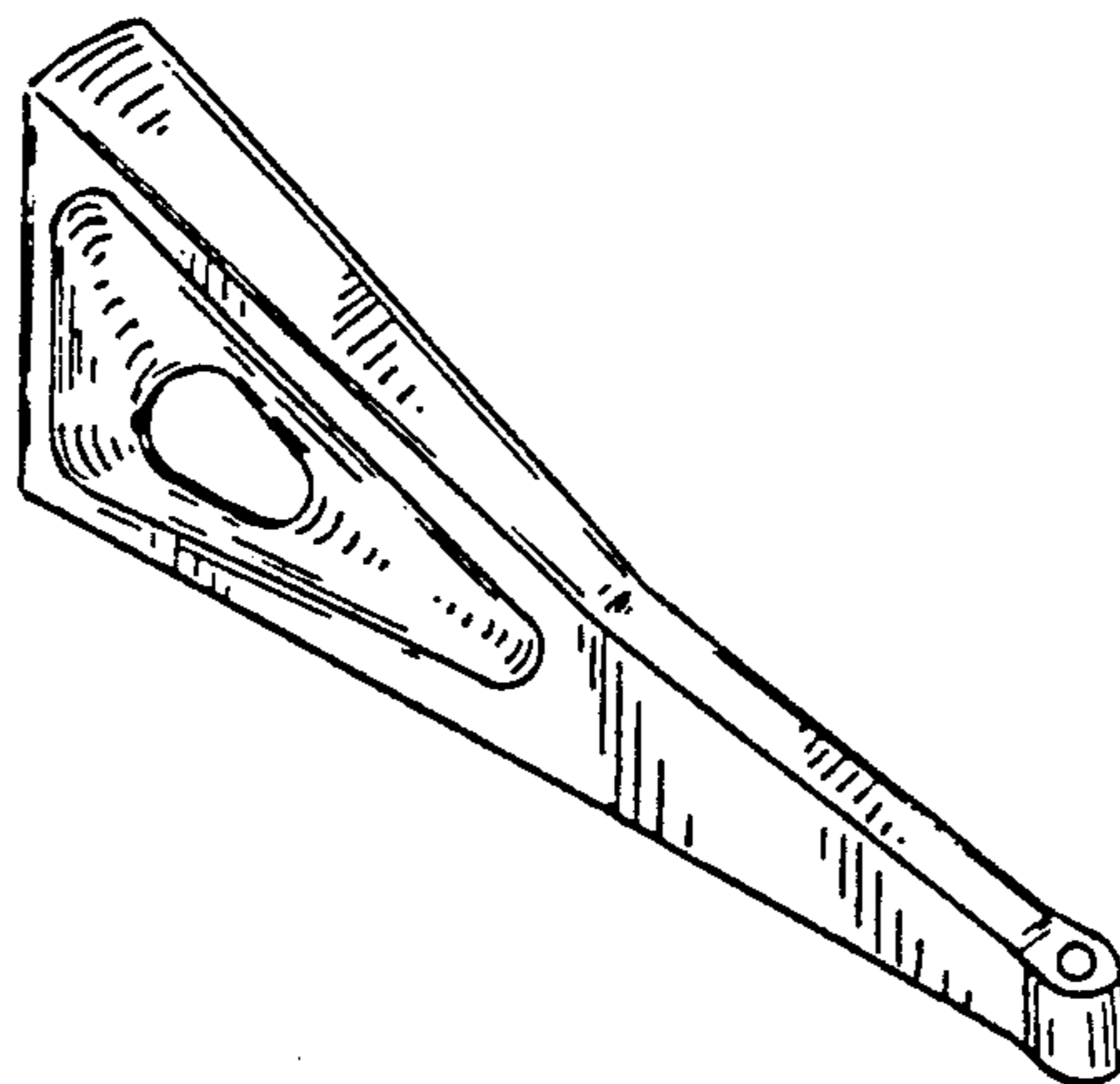

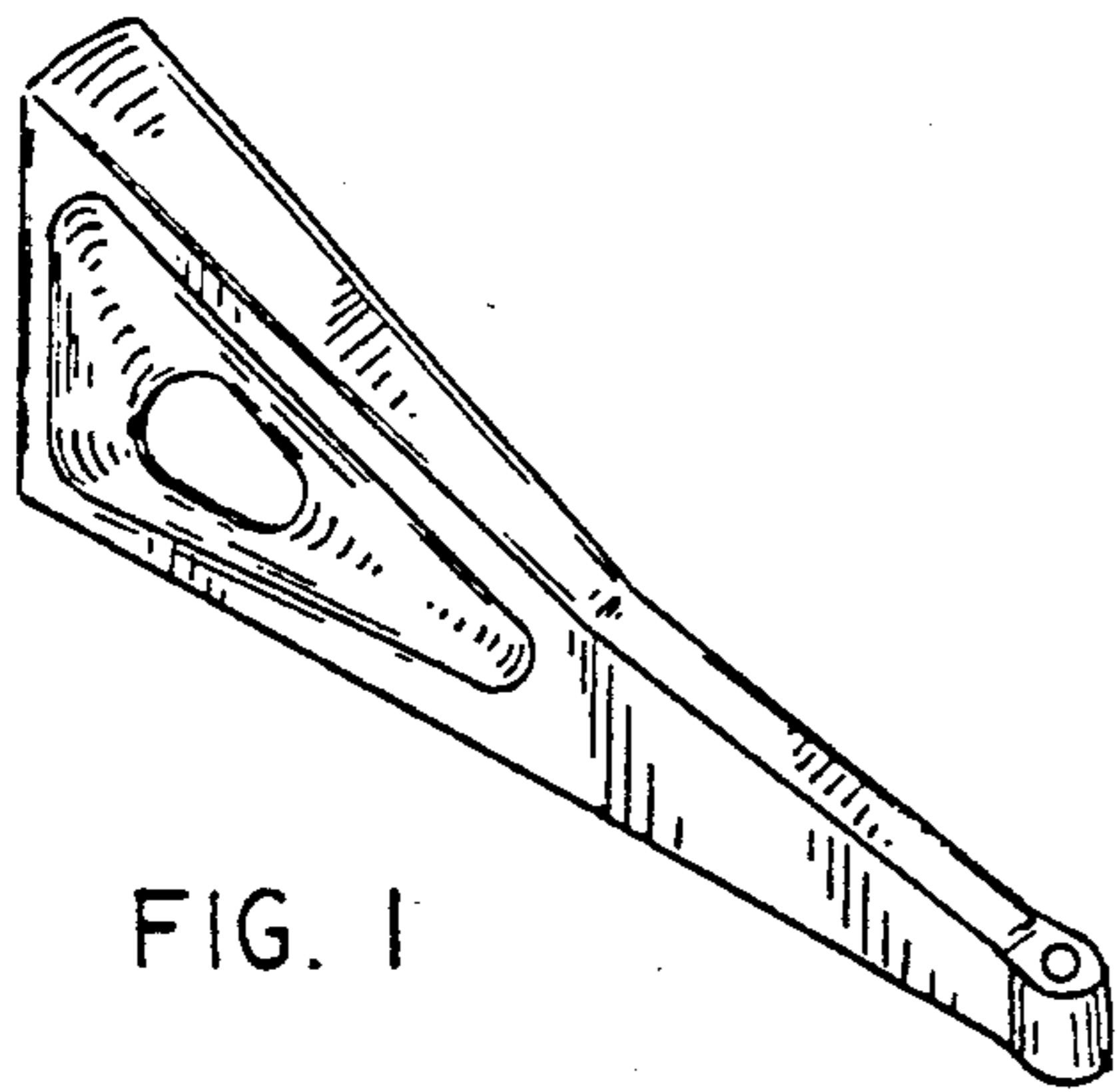

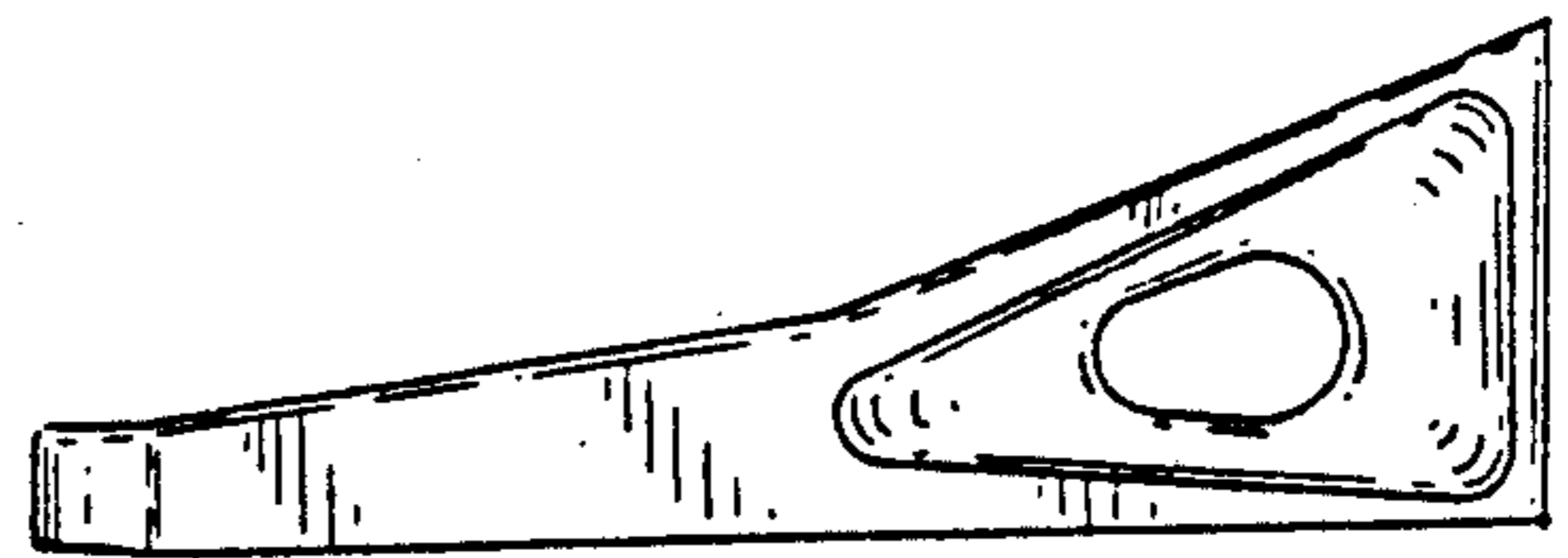

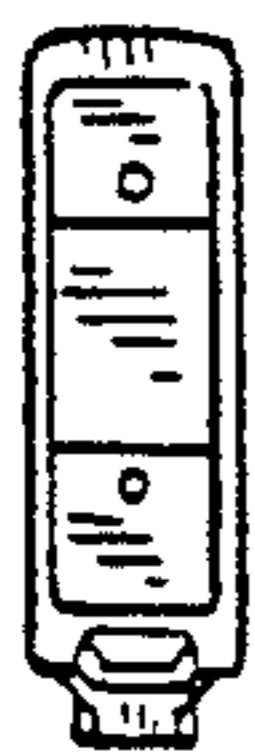

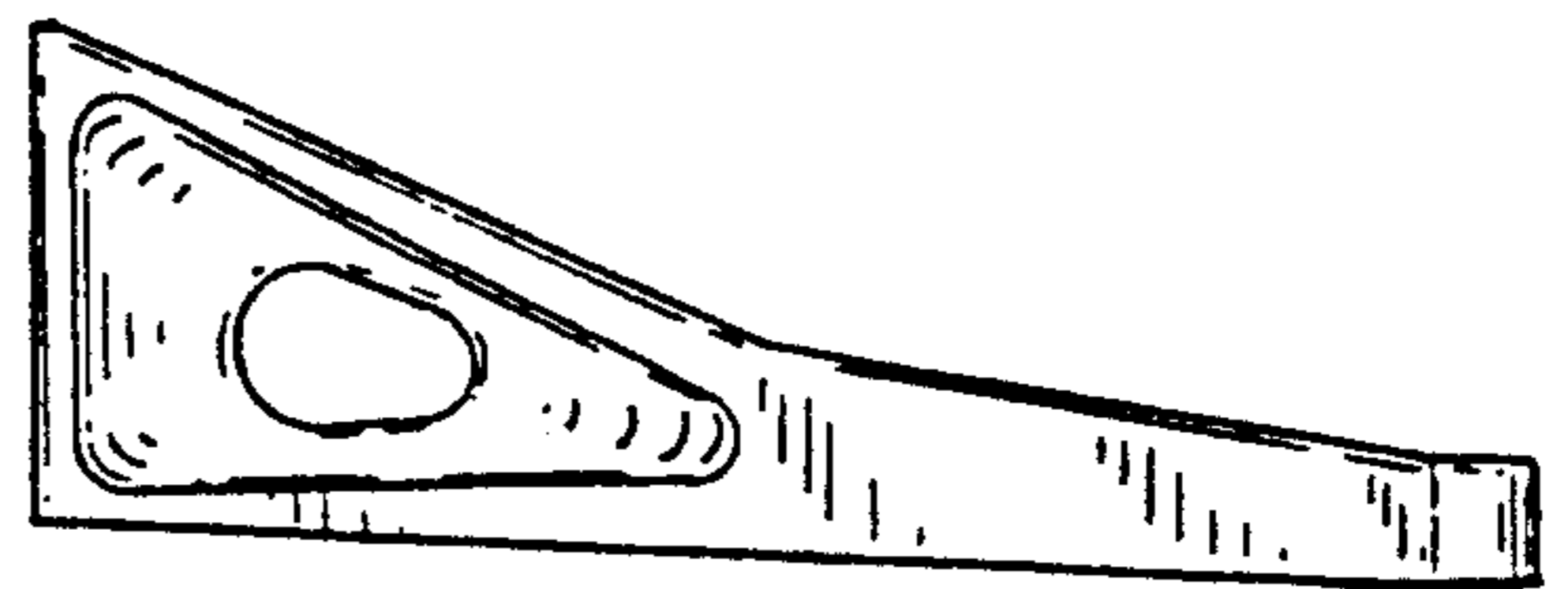

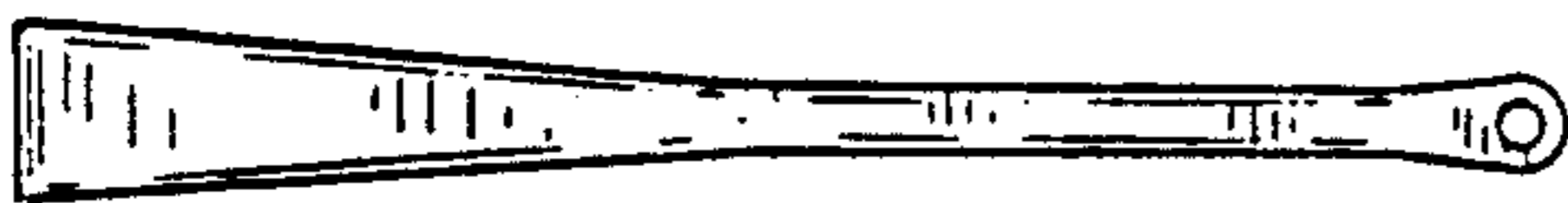

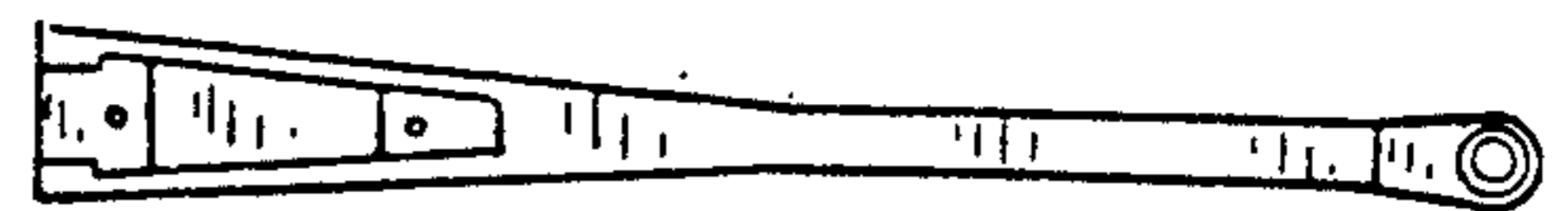

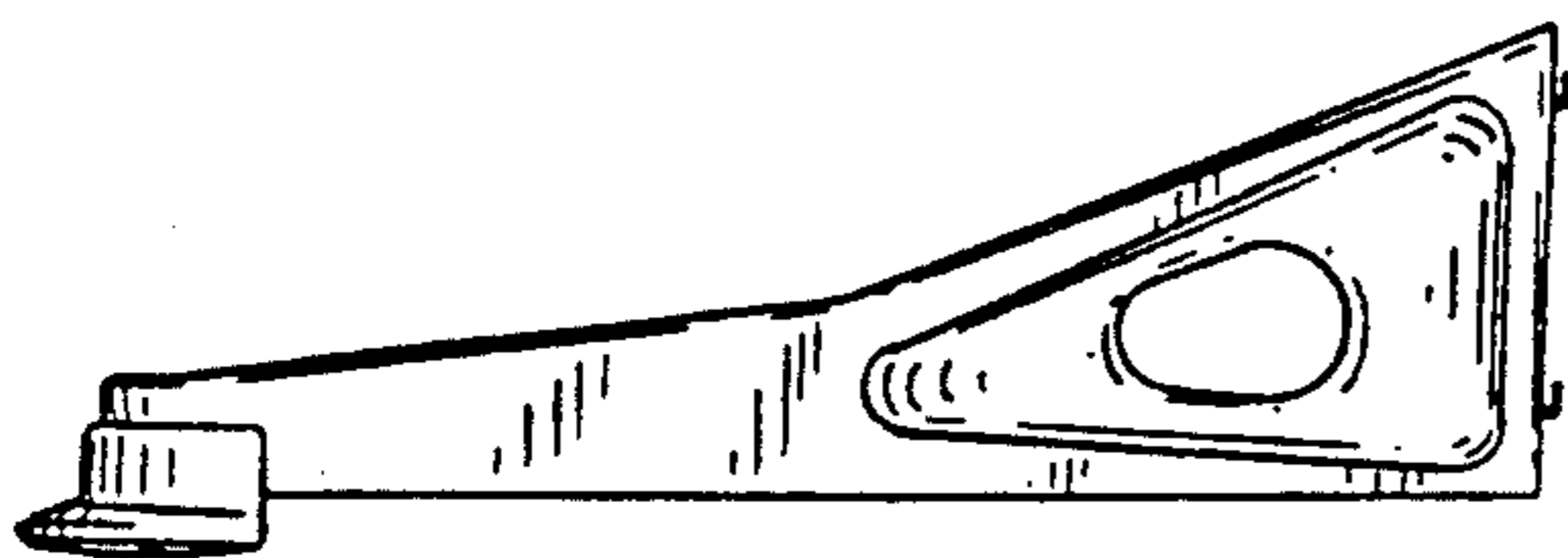

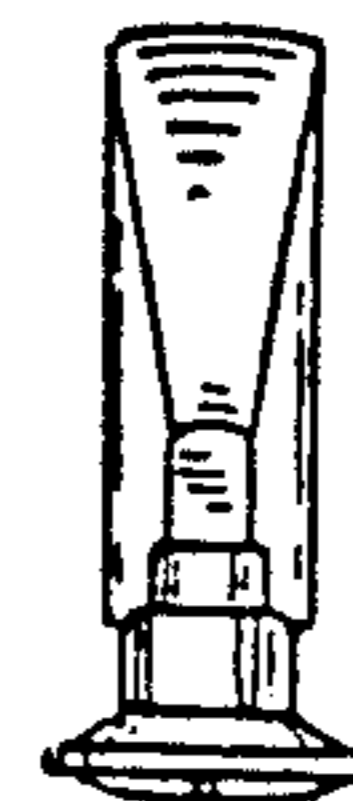

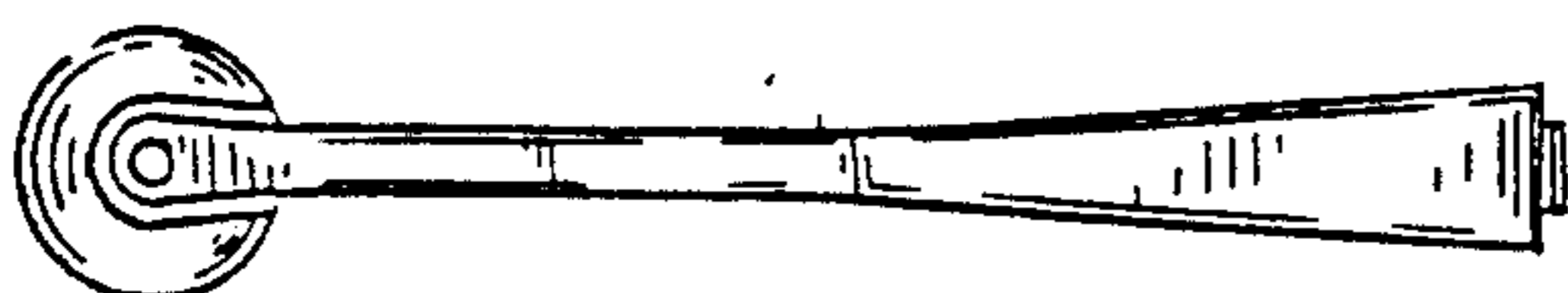

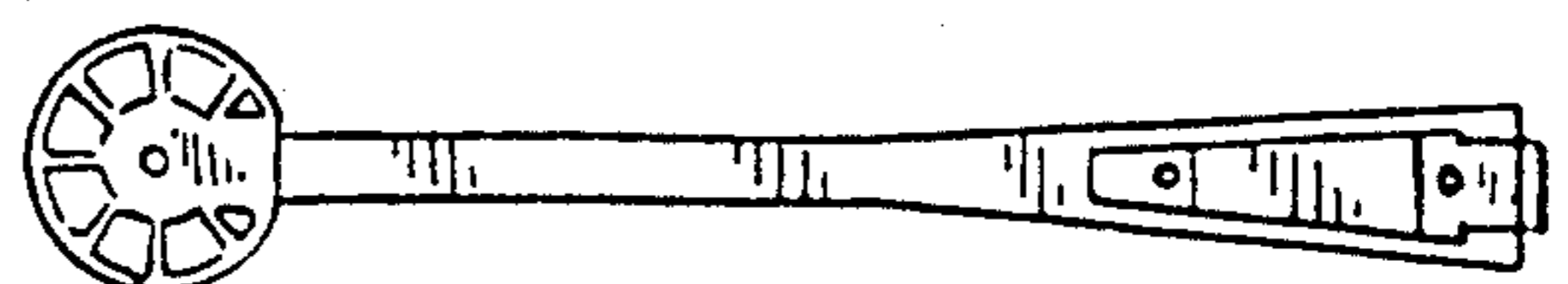

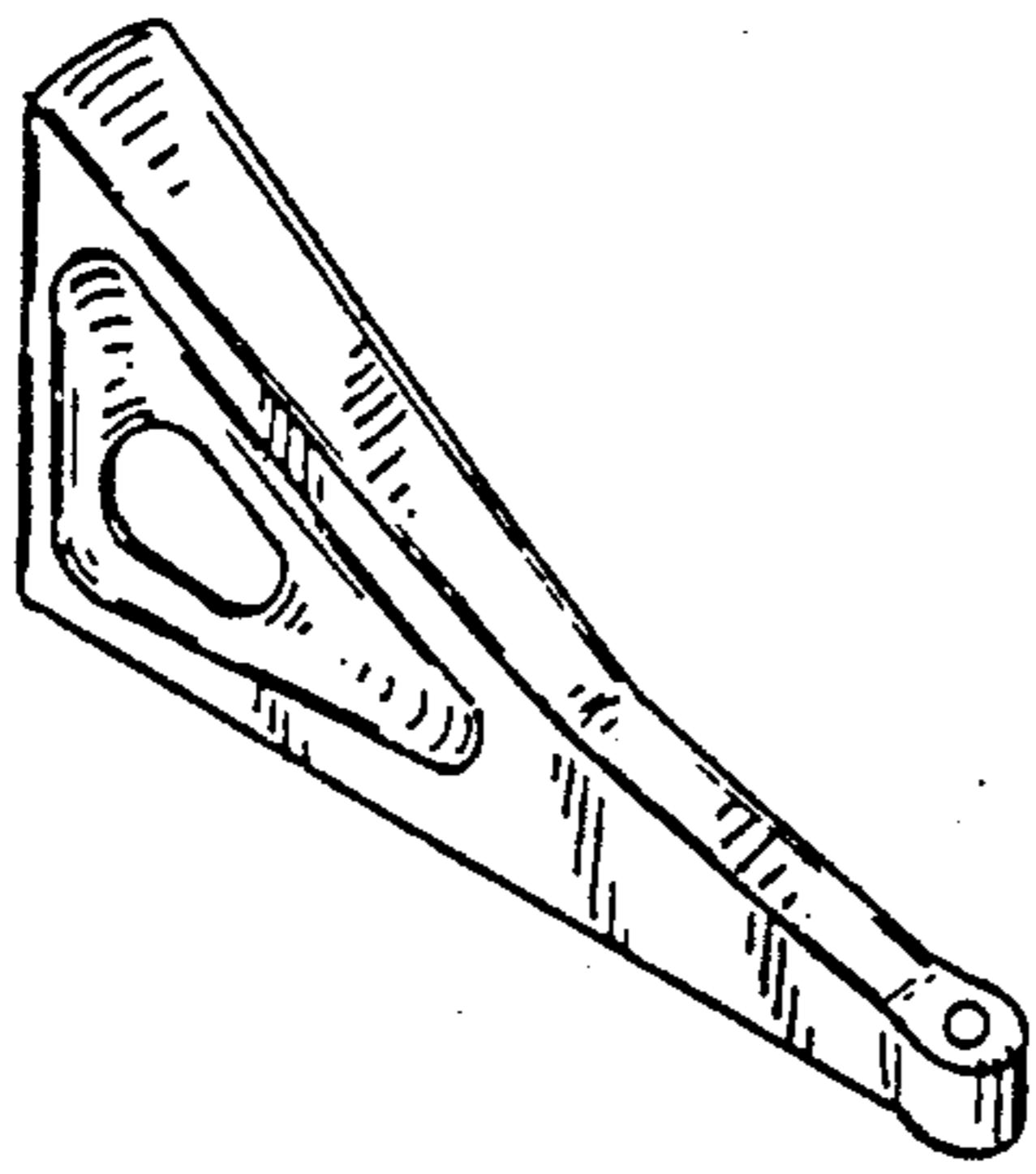

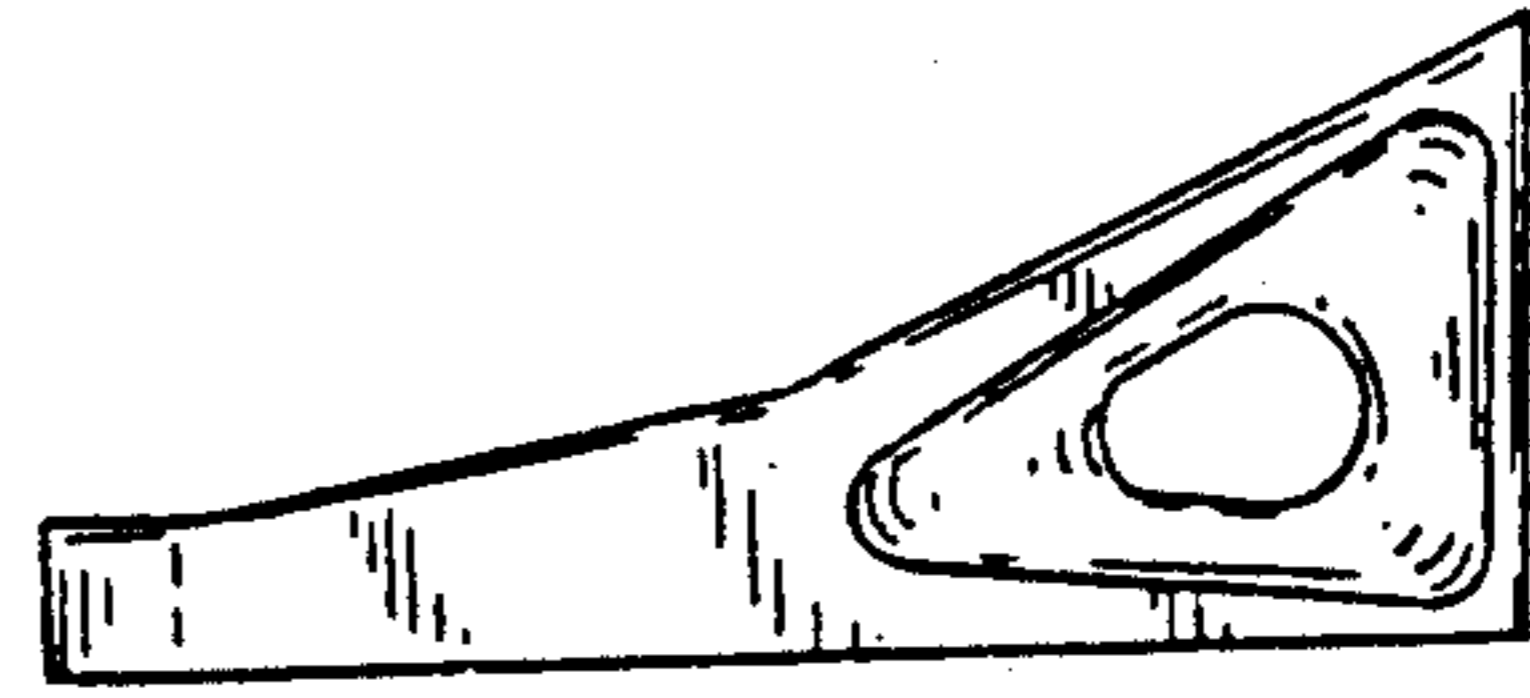

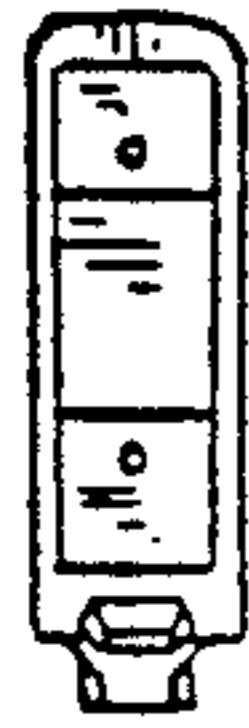

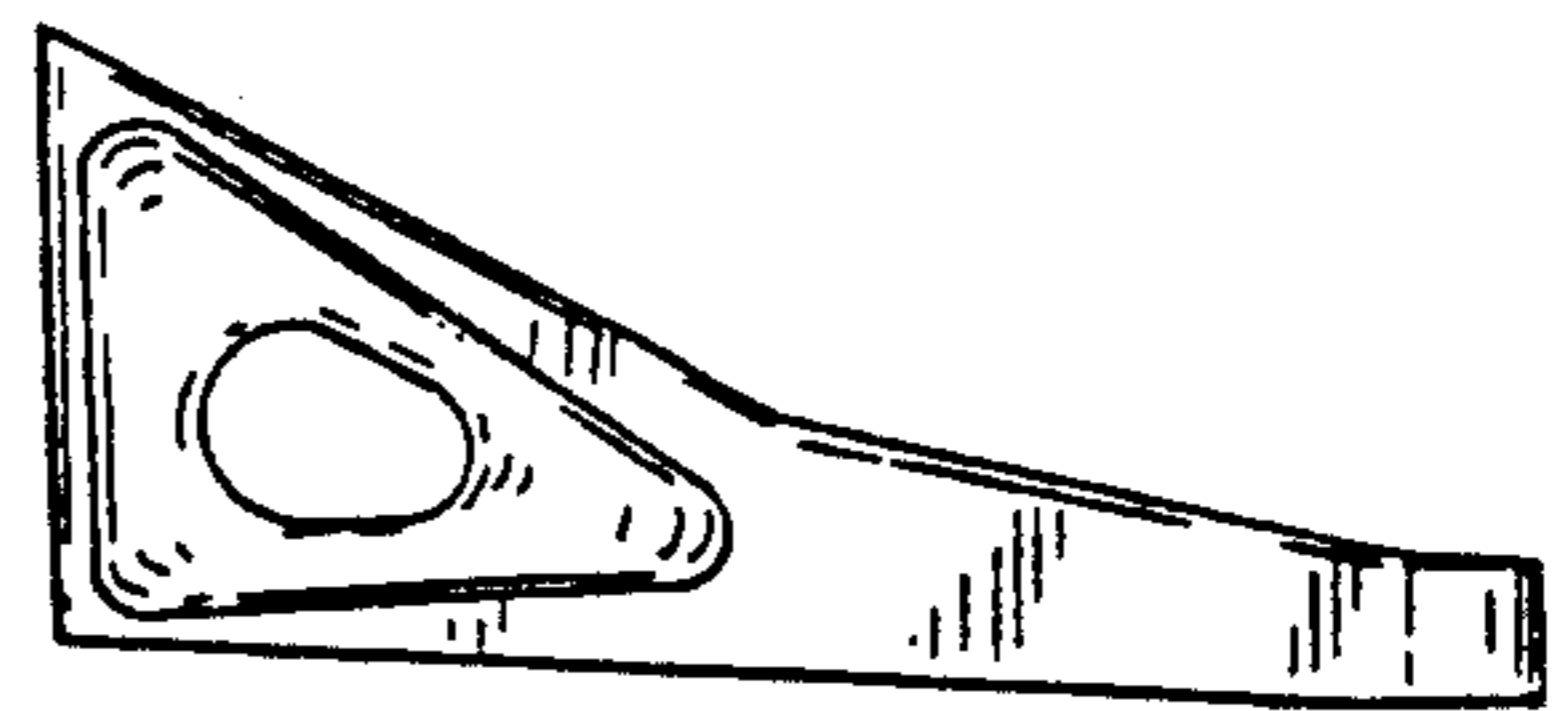

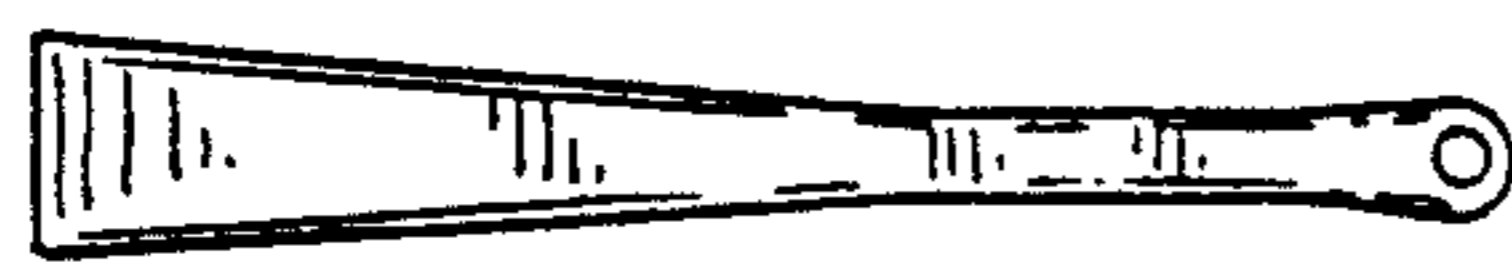

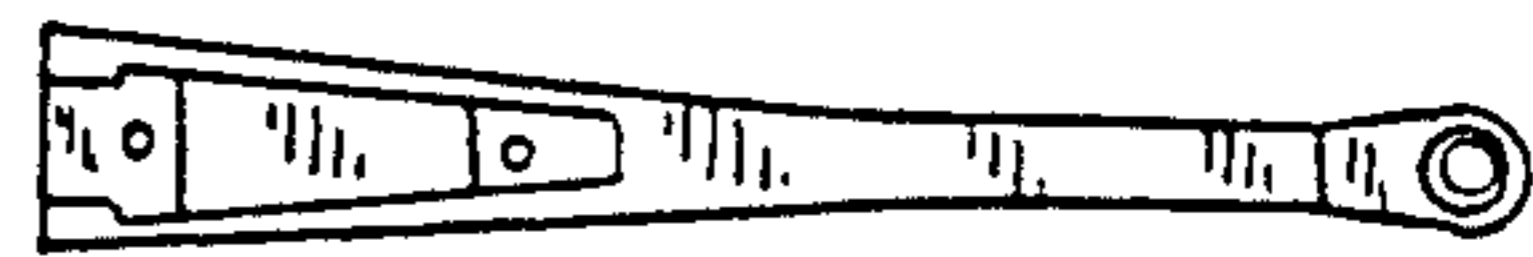

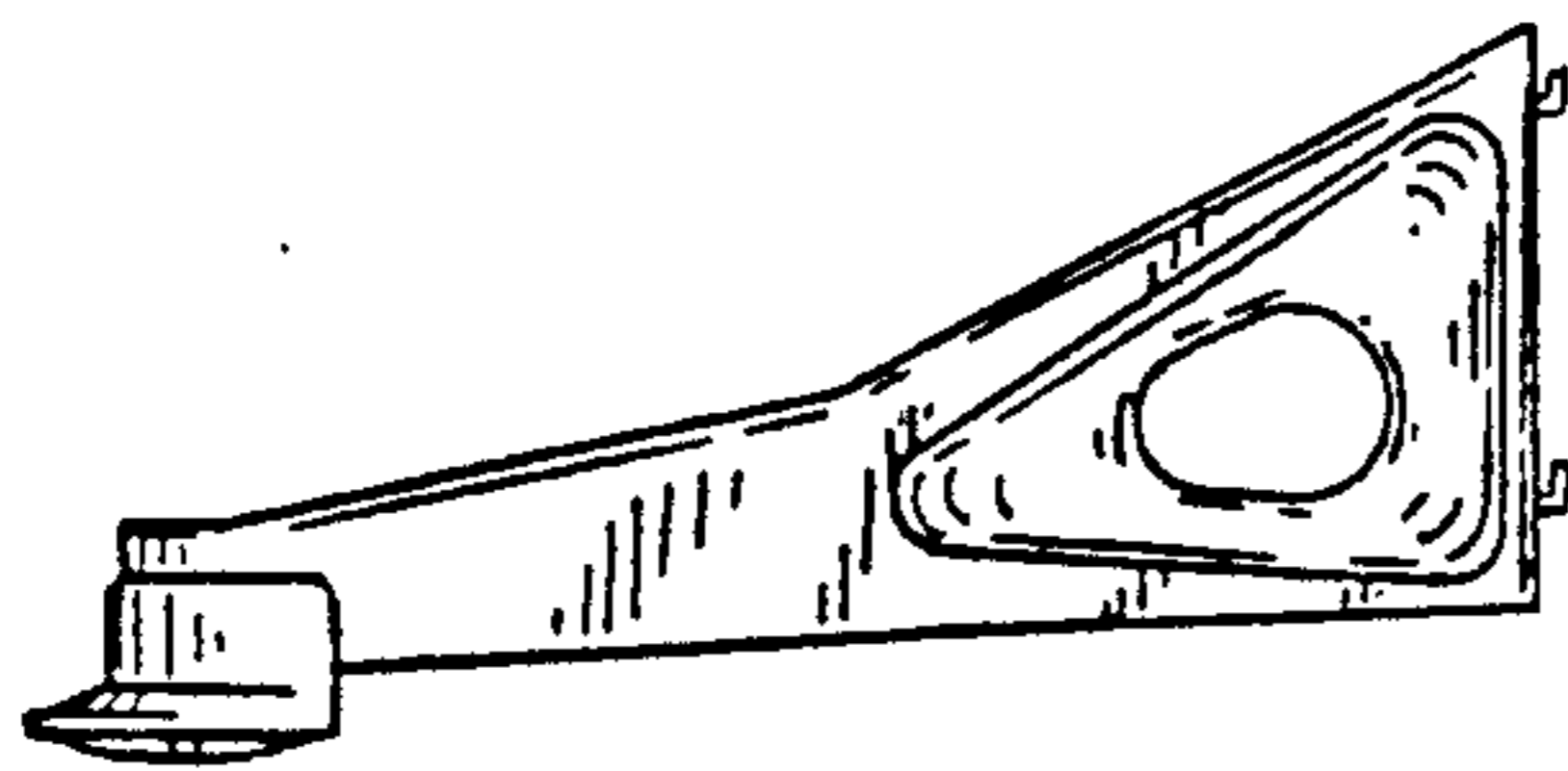

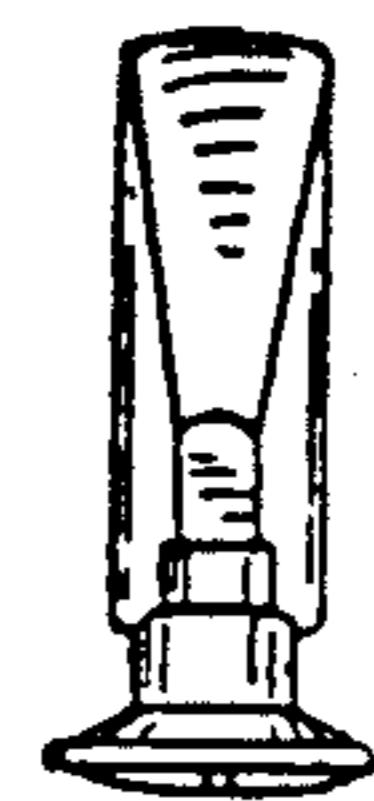

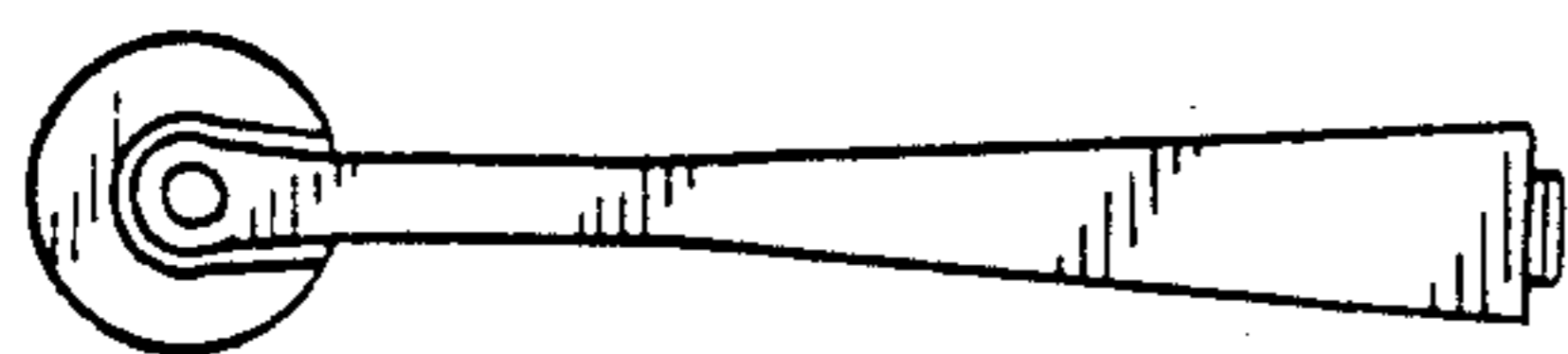

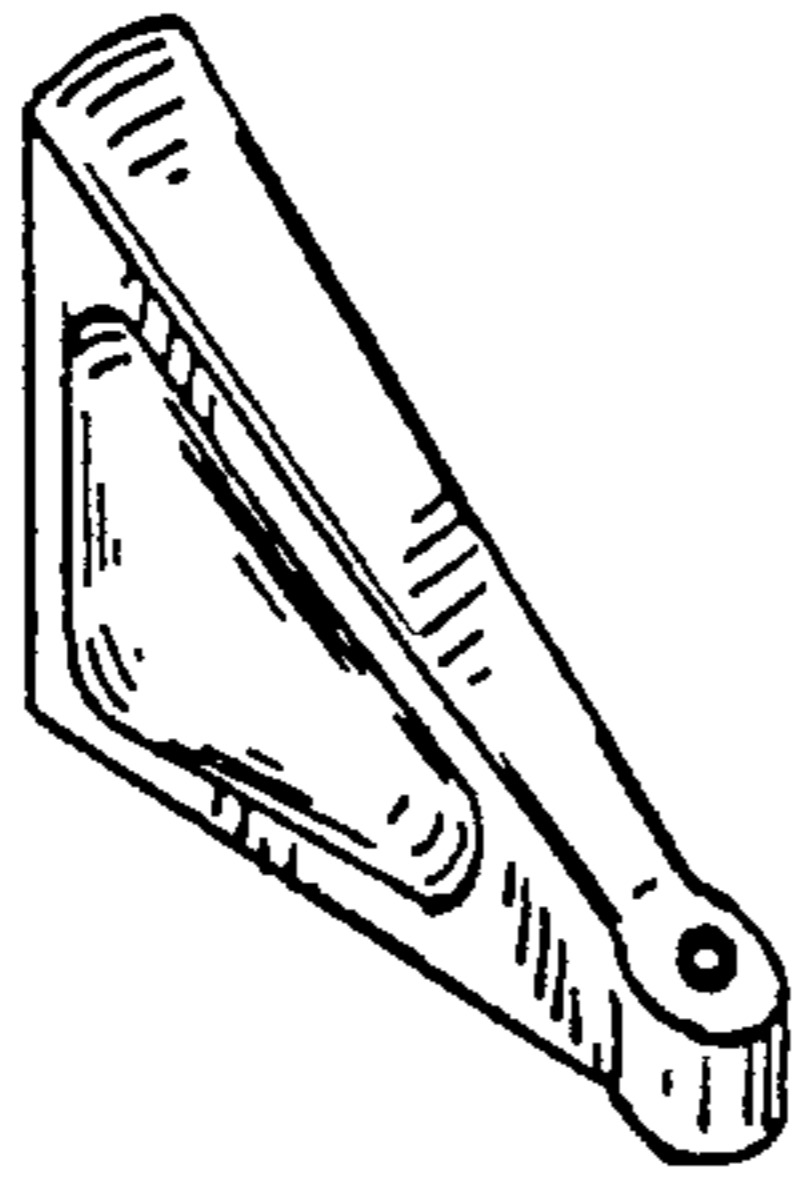

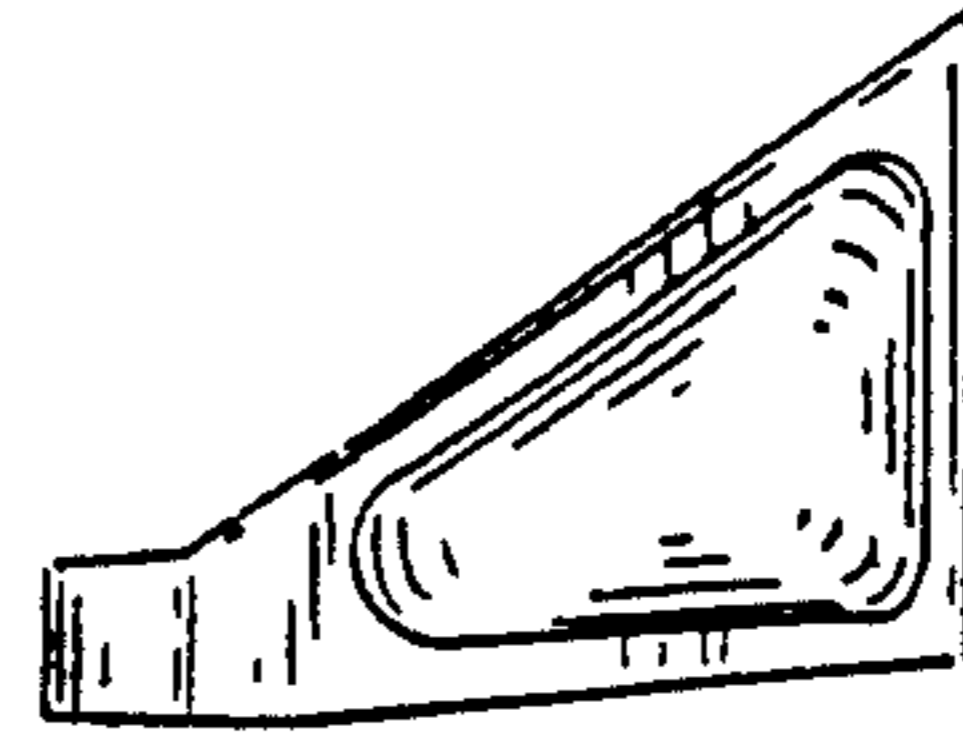

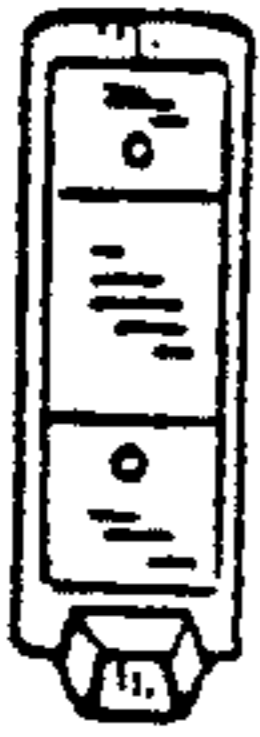

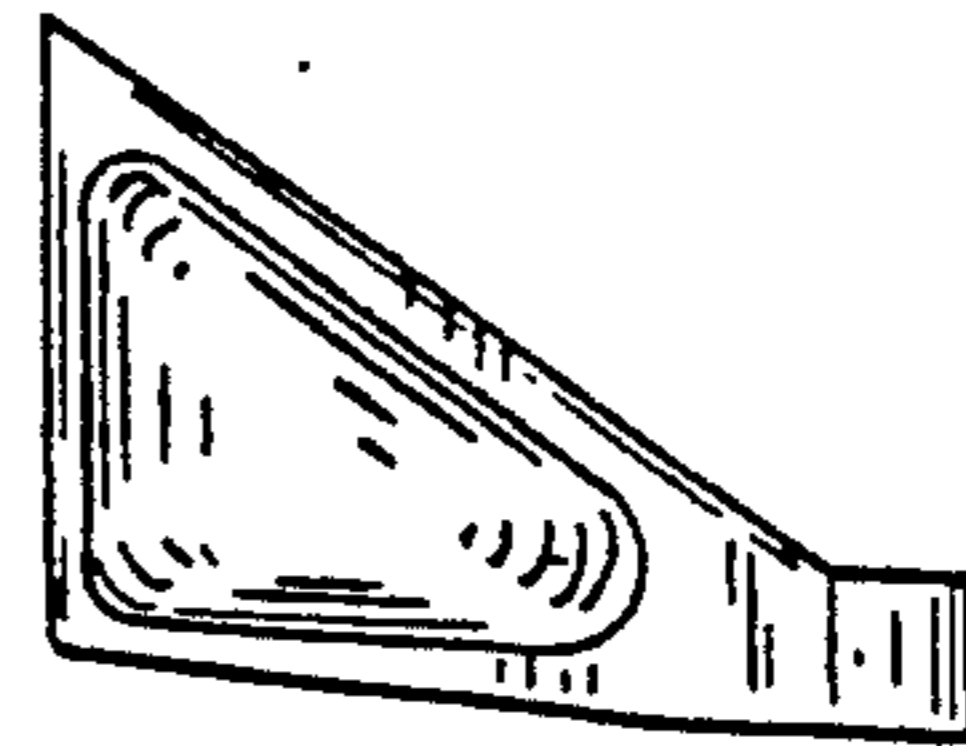

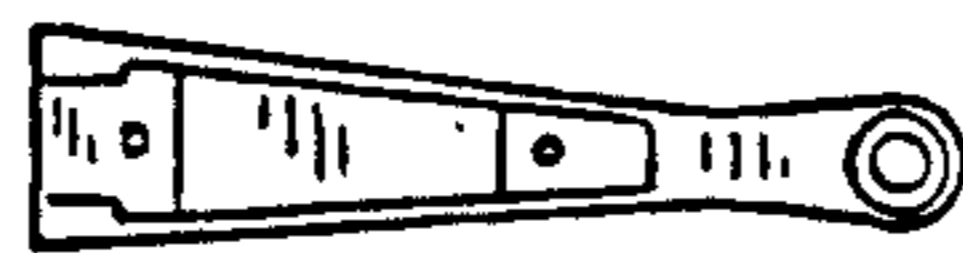

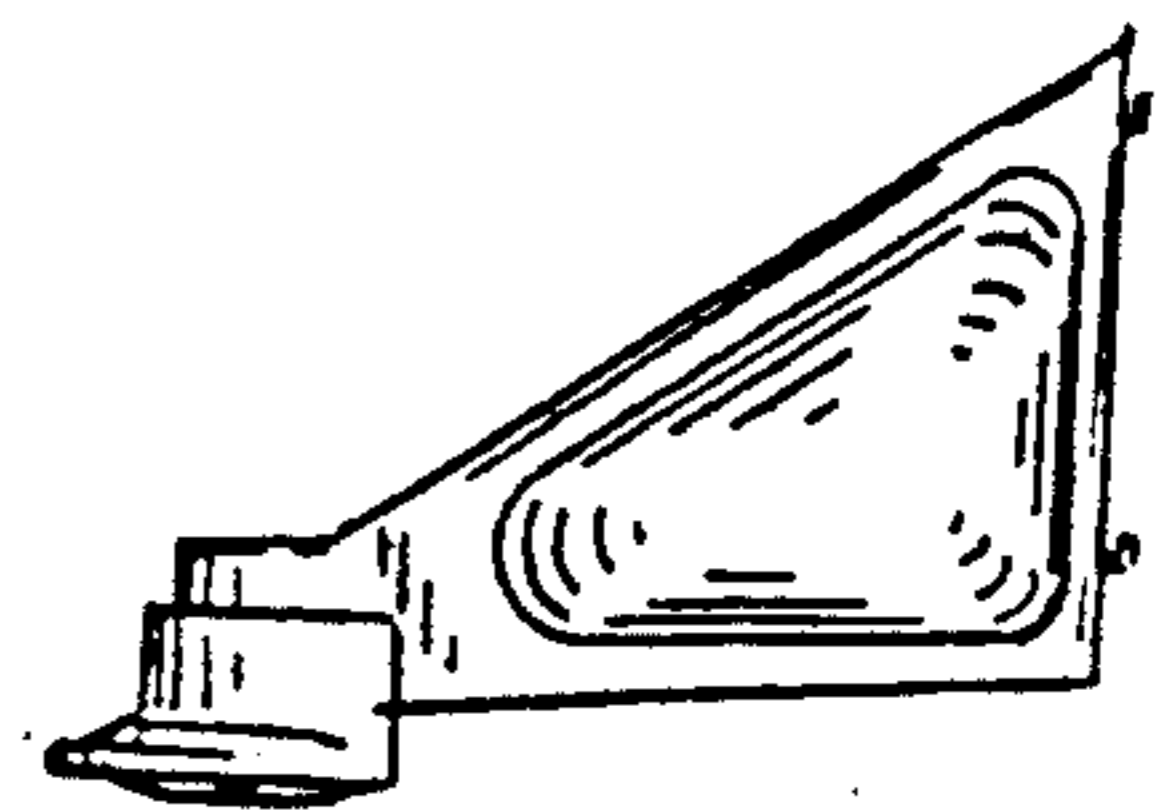

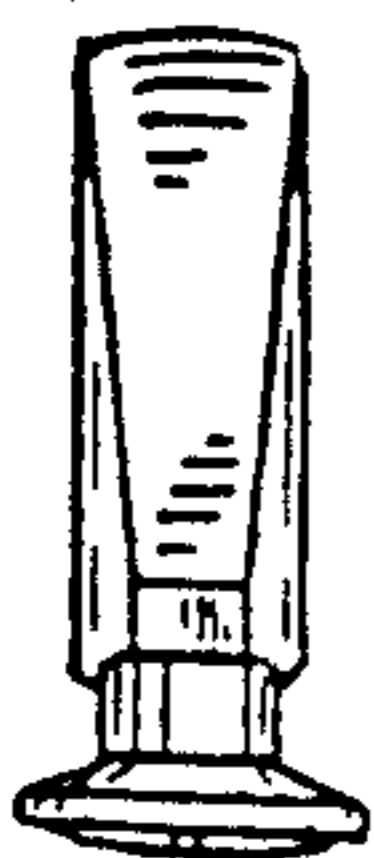

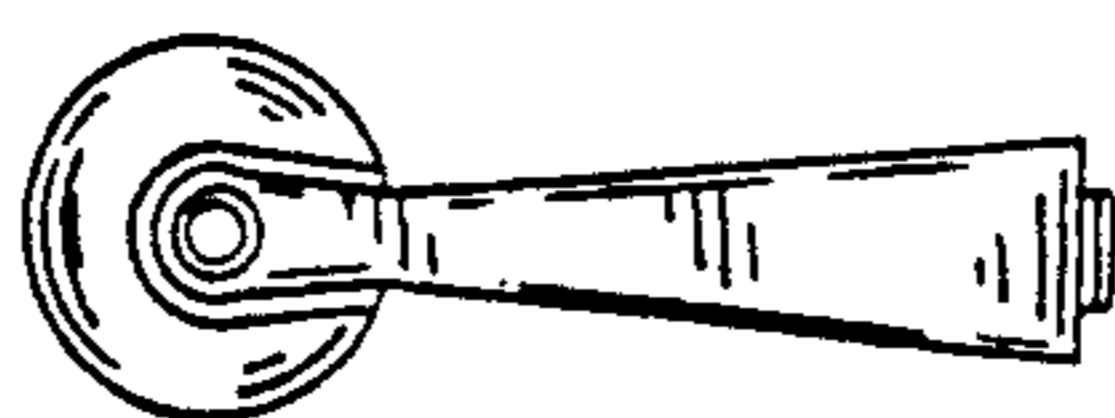

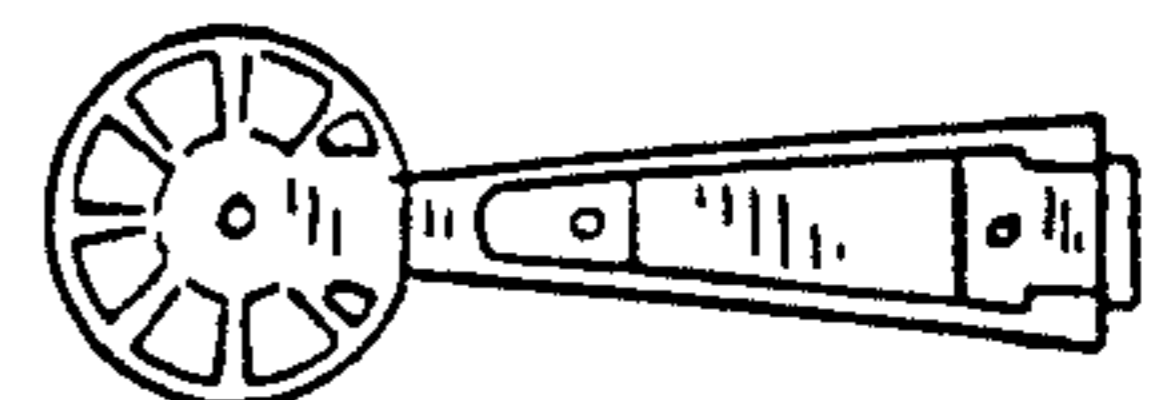
