FIG. 4 is a right side elevational view thereof;

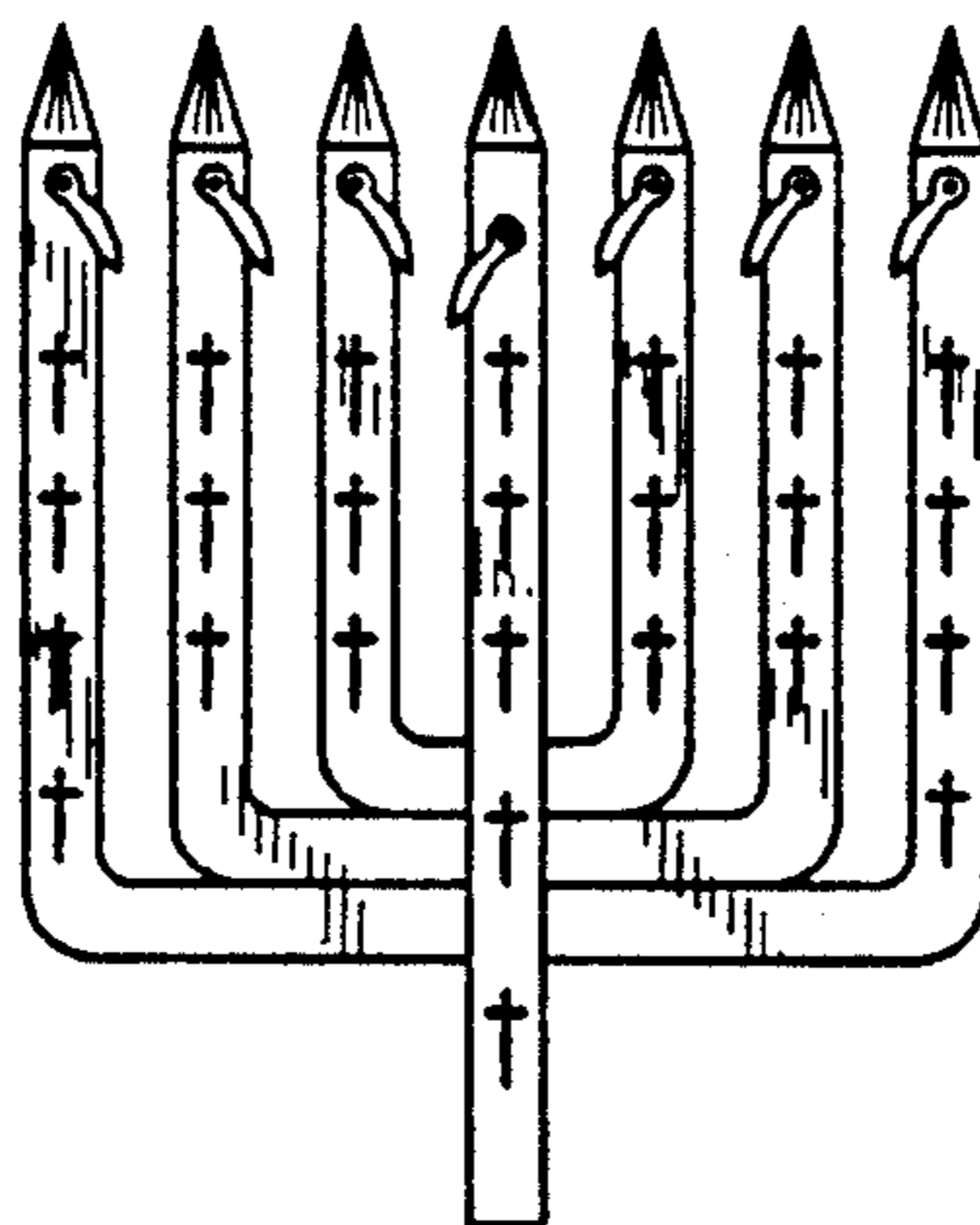
FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

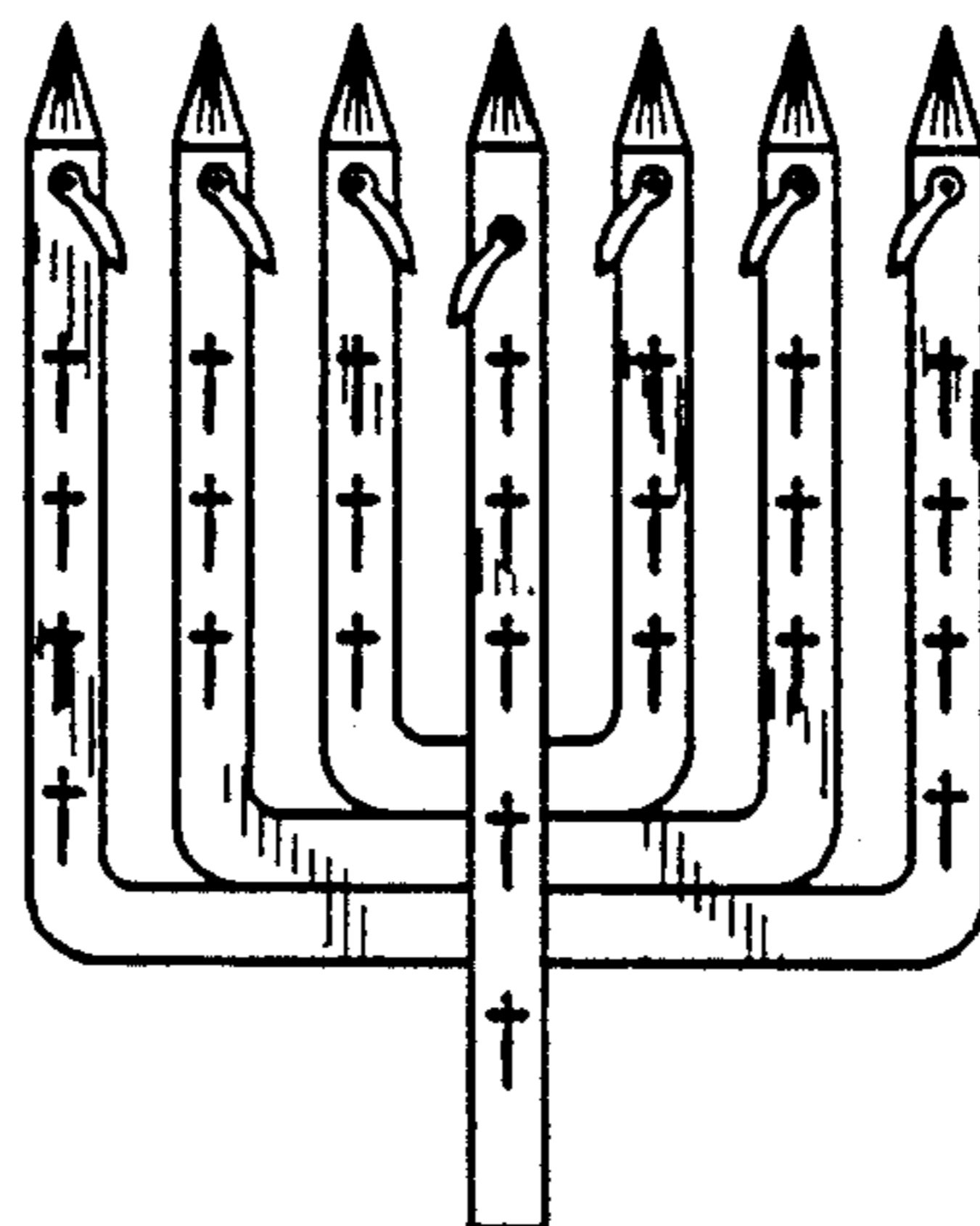
FIG. 7 is a perspective view thereof; and,

FIG. 8 is a perspective view thereof.

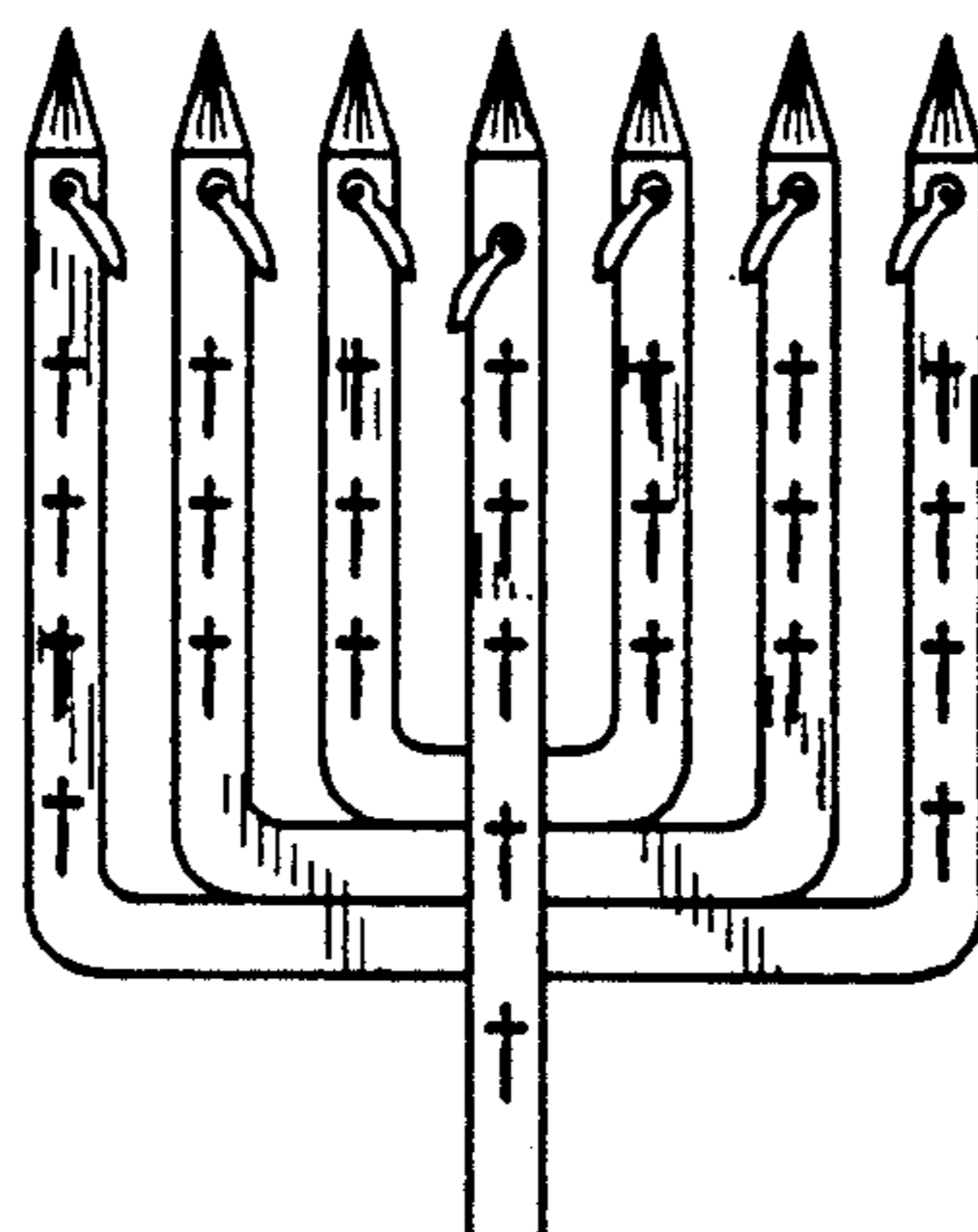
The broken line showing of a handle in FIGS. 7 and 8 is for illustrative purposes only and forms no part of the claimed design.

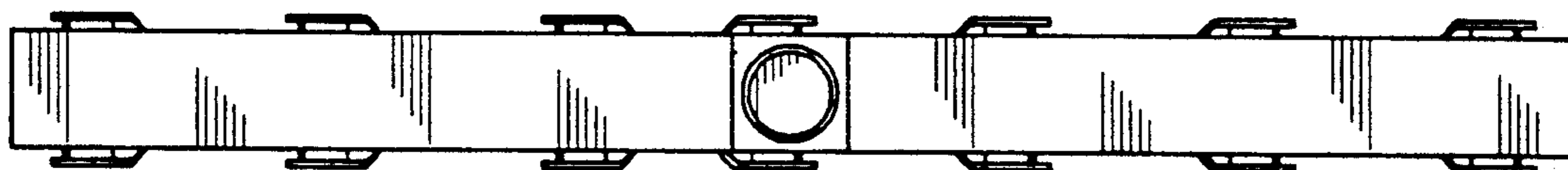
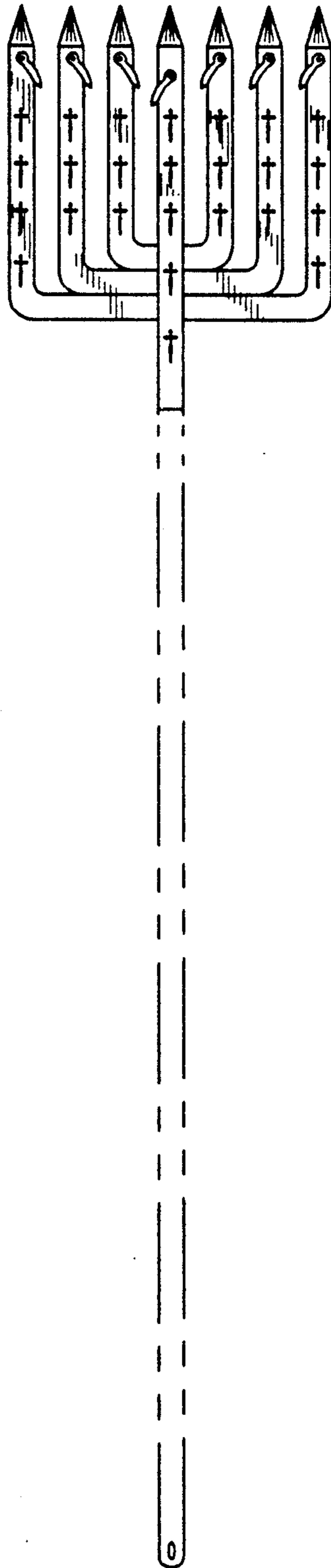
