DESCRIPTION


FIG. 1 is a top perspective view of a storage container showing my new design;

FIG. 3 is a side elevational view thereof, the opposite side being a mirror image;


FIG. 4 is a top plan view thereof; and,


FIG. 5 is a bottom plan view thereof.





