[57] CLAIM

The ornamental design for an automatic feeder for animals, including livestock, household pets, and aquatic life, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an automatic feeder for animals, including livestock, household pets, and aquatic life showing our new design; FIG. 2 is an enlarged front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a top plan view thereof; and, FIG. 6 is a side elevational view thereof, the side opposite being a mirror image of the side shown.

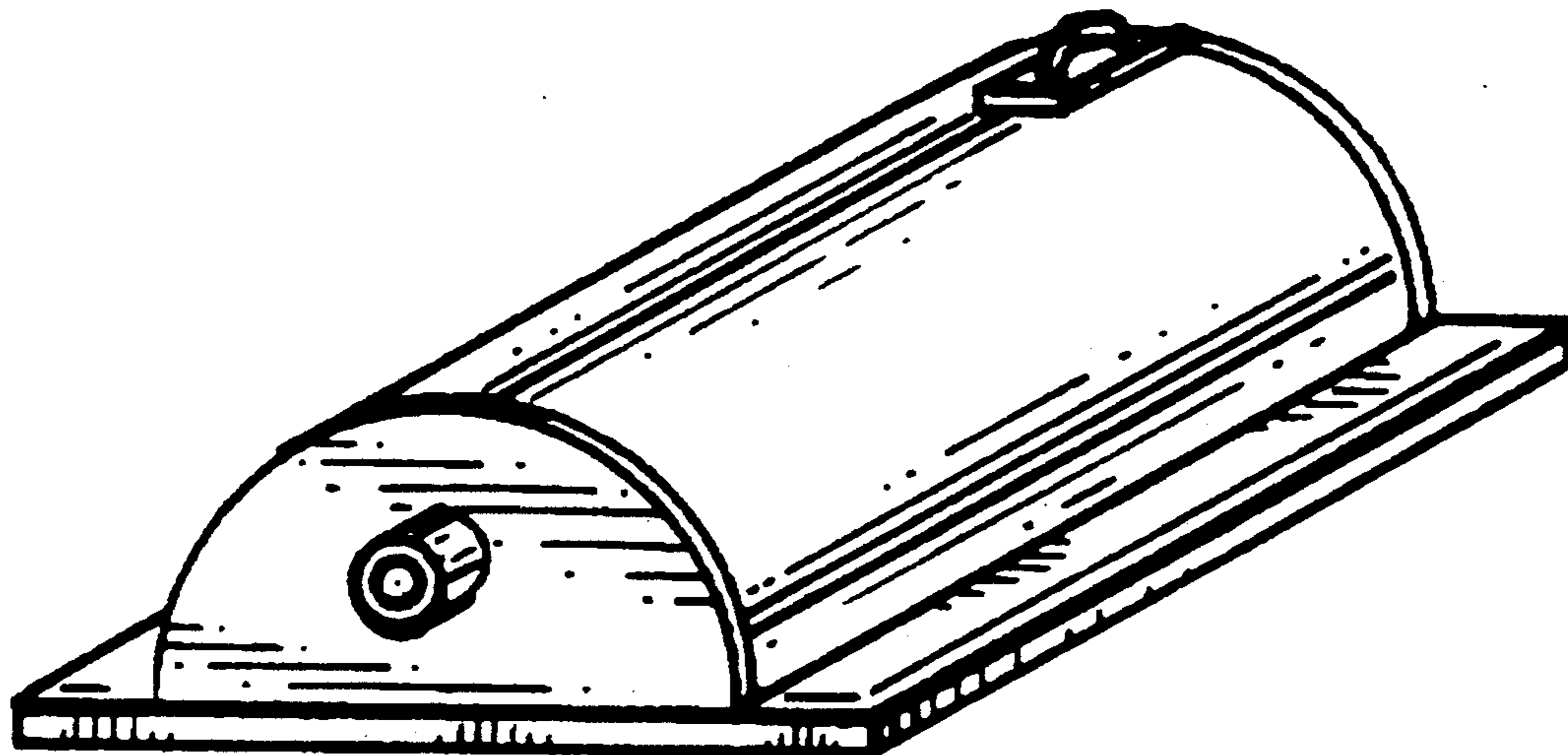

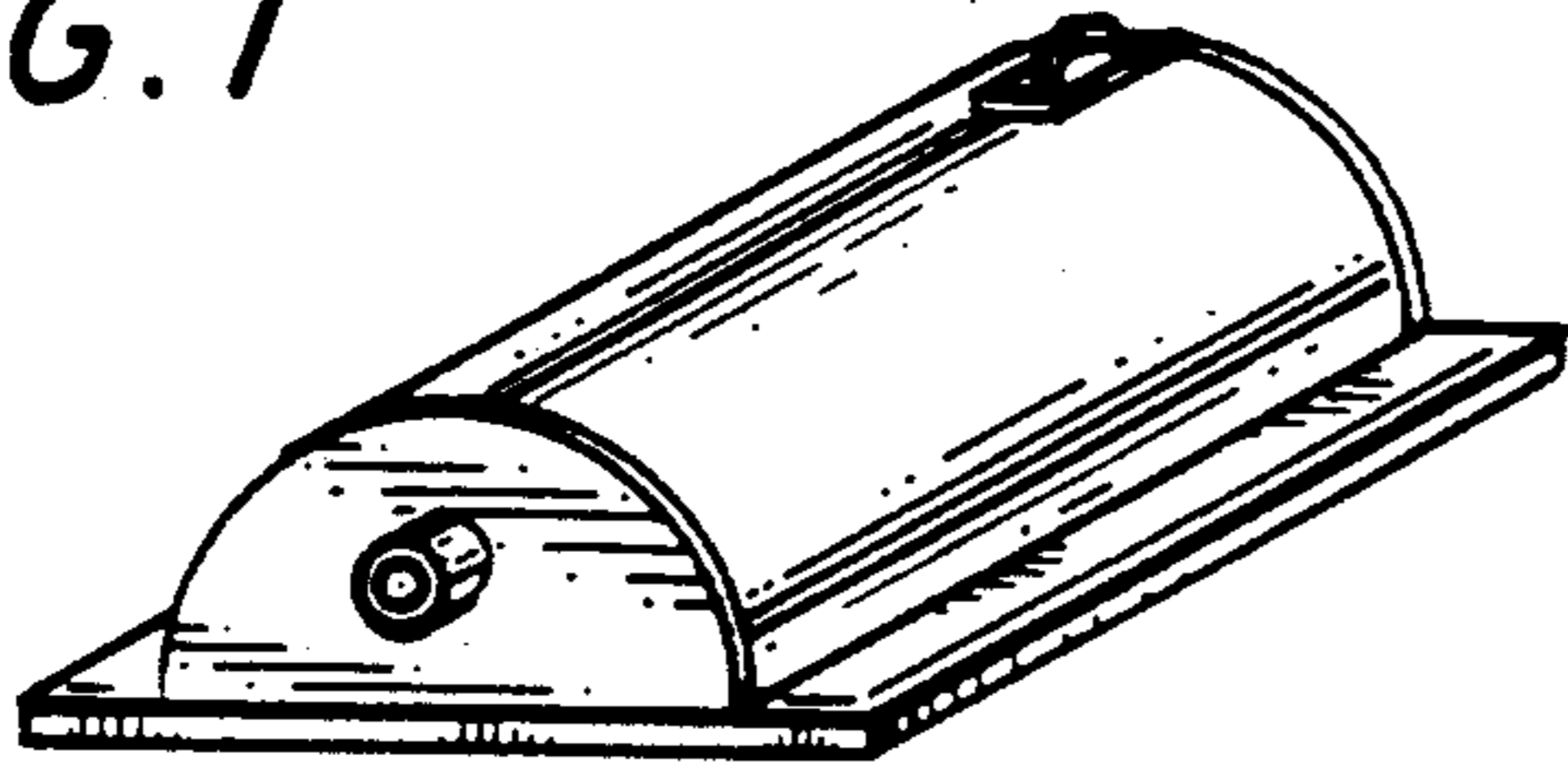

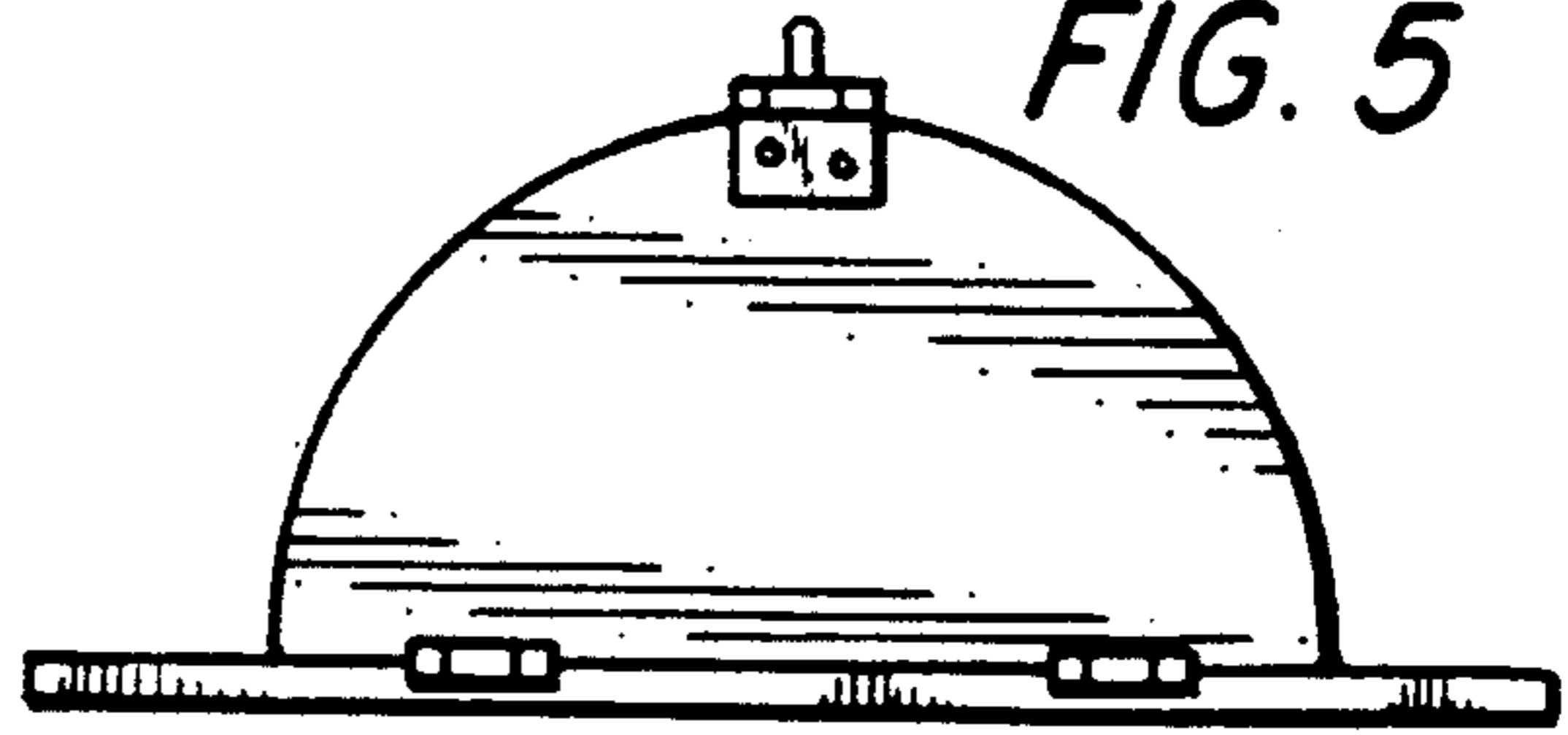

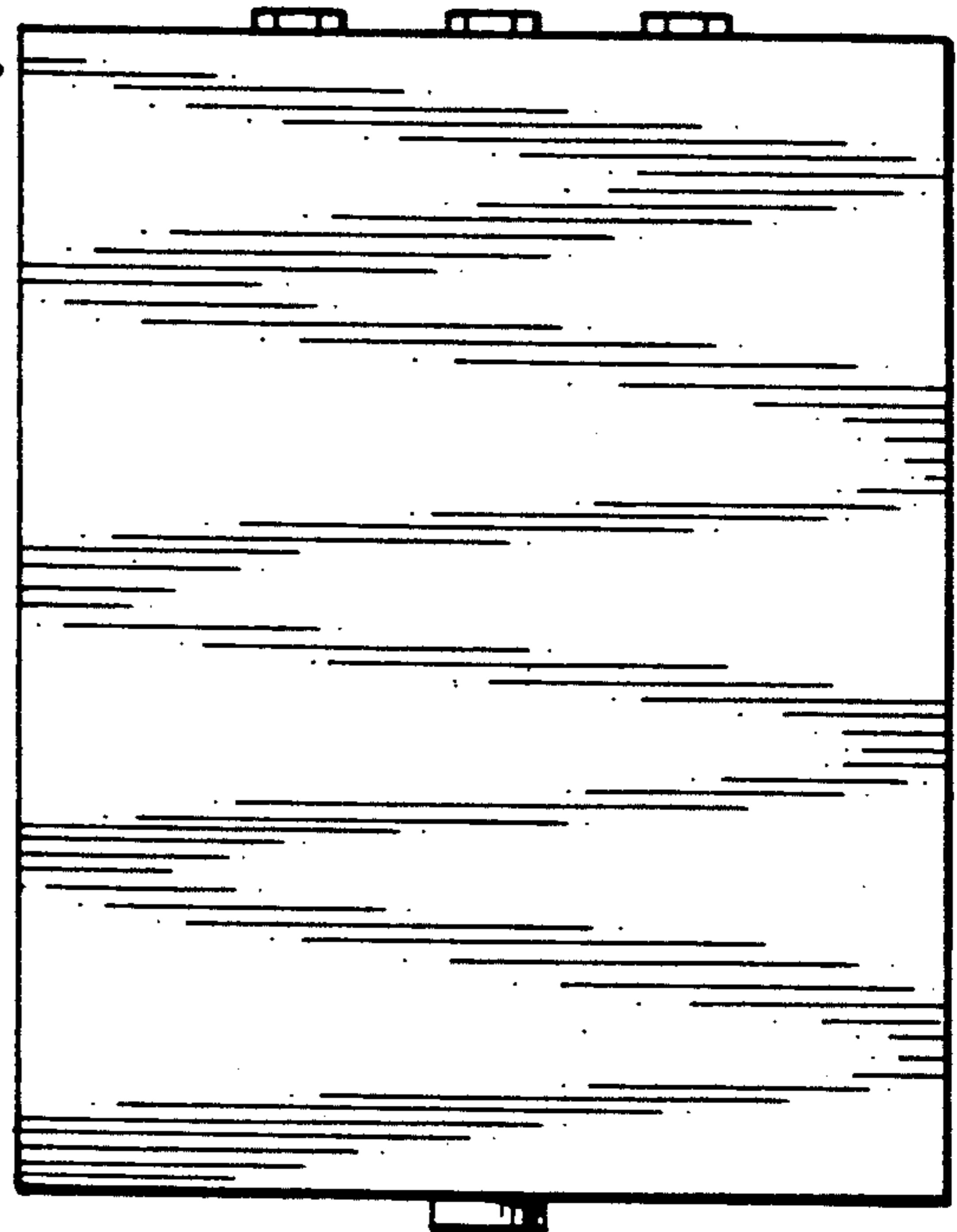

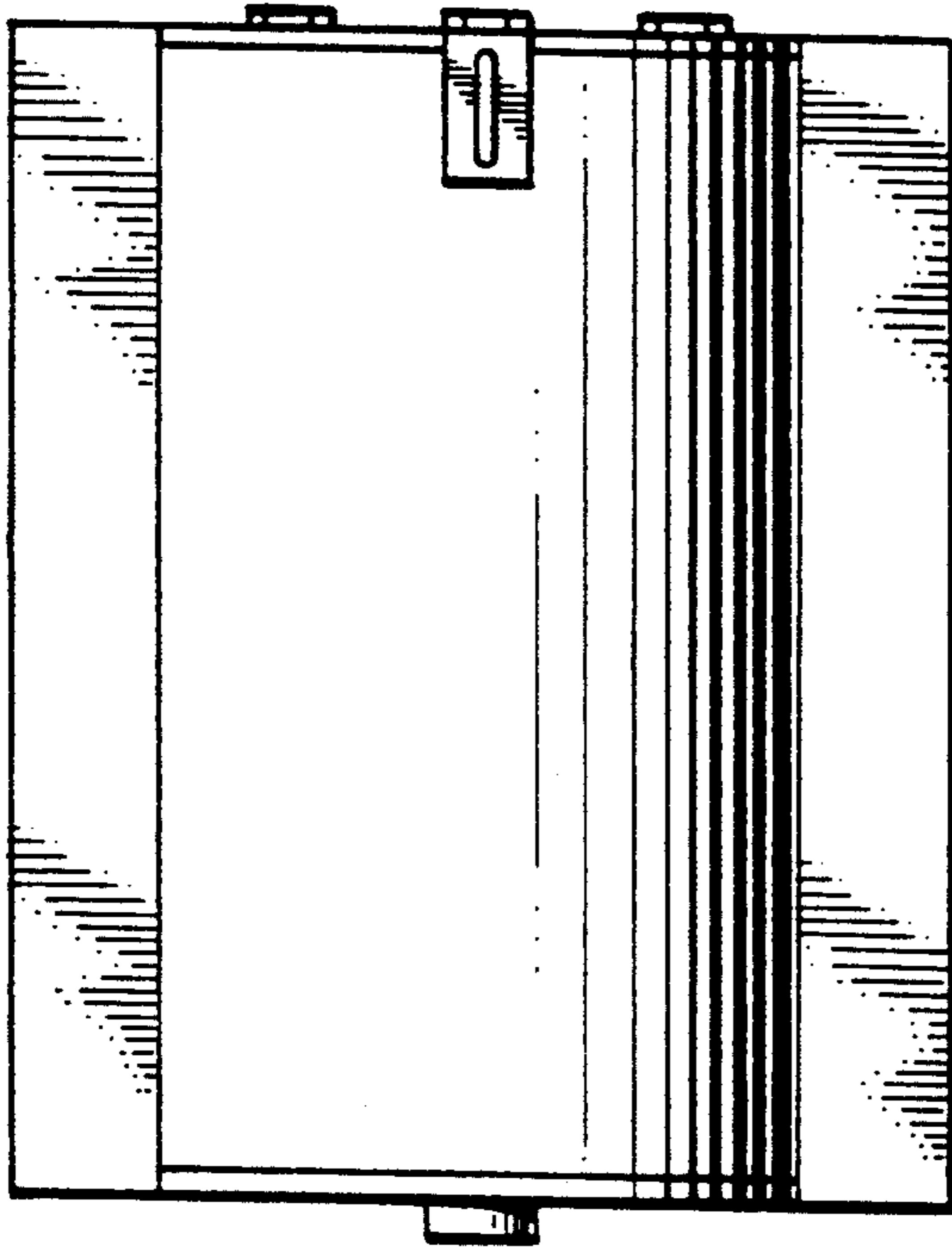

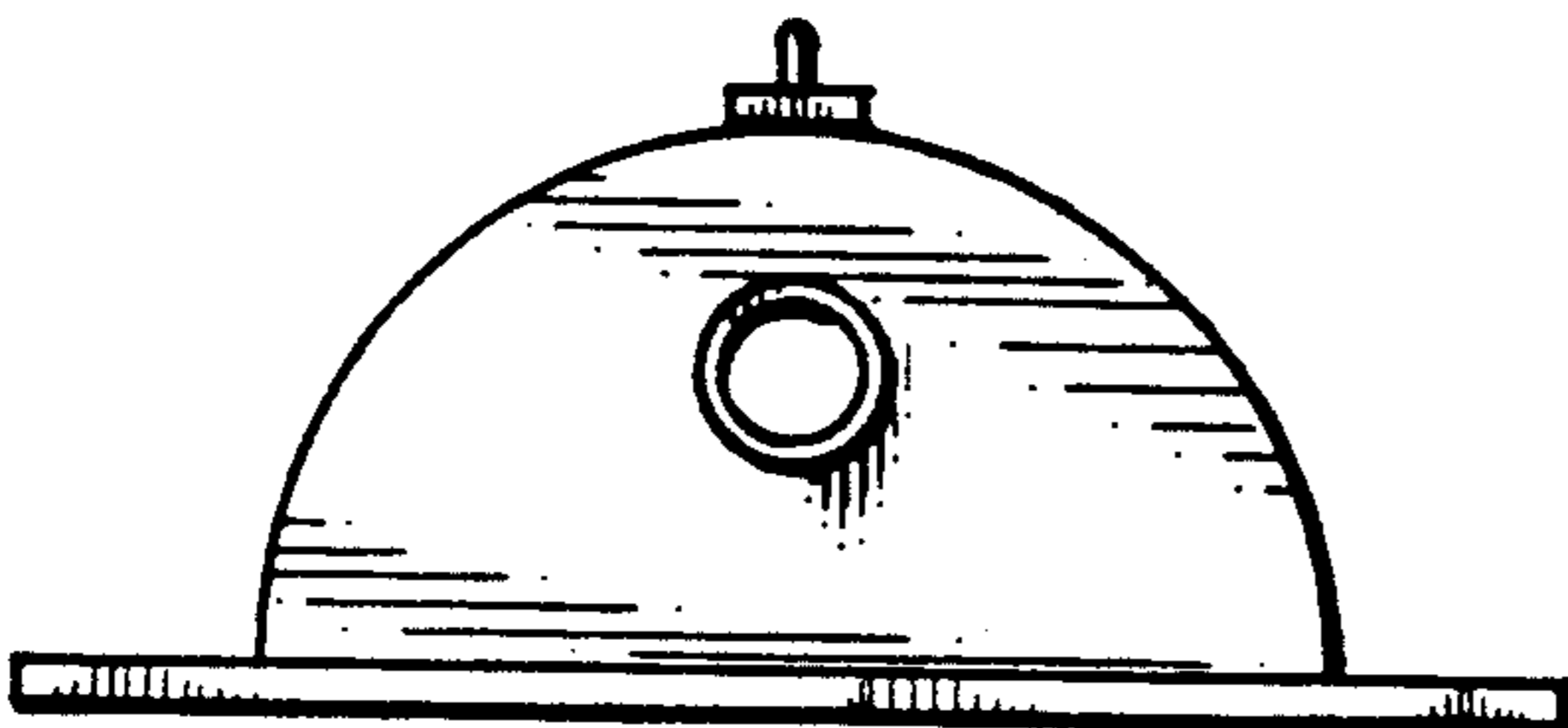
