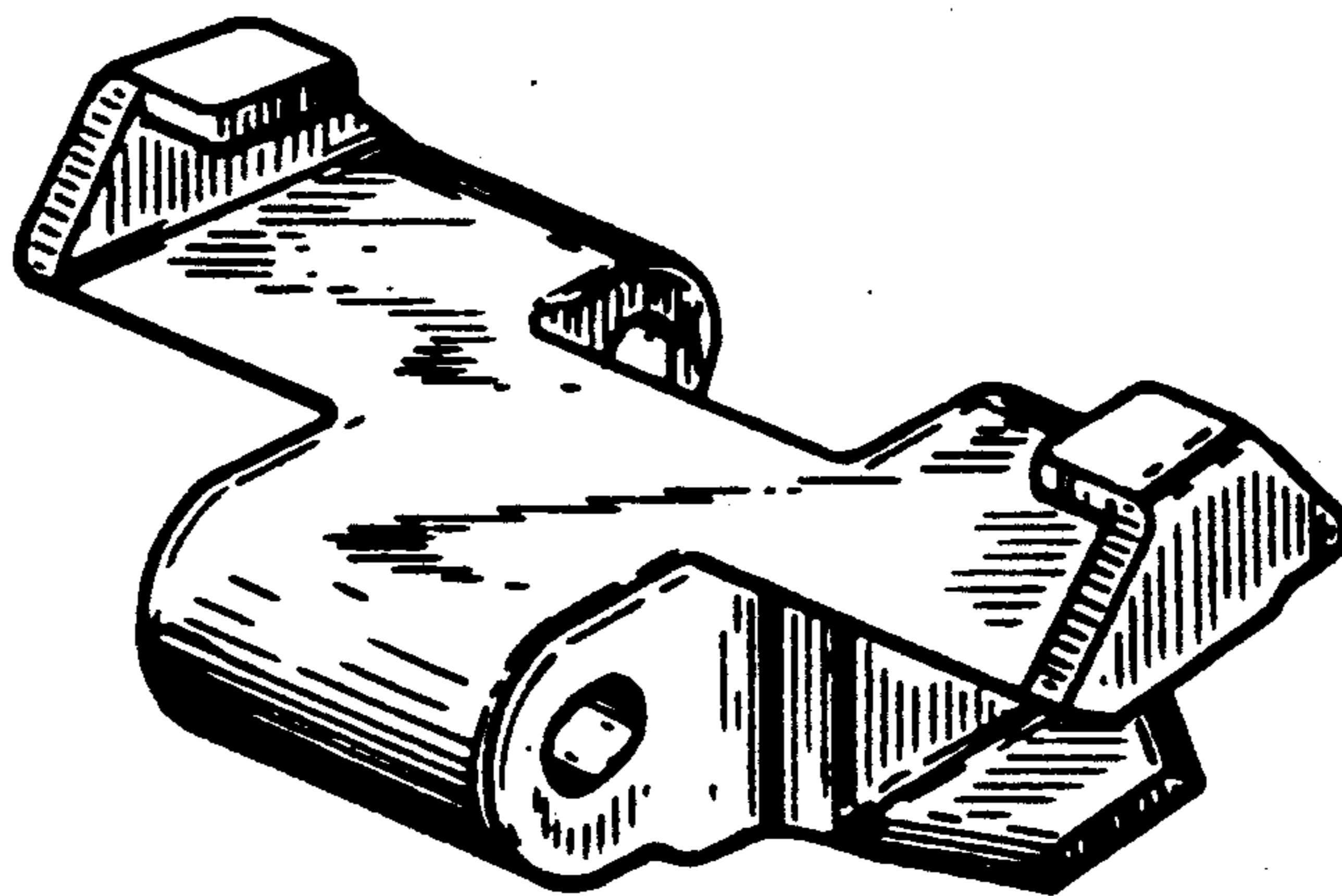

[57] **CLAIM**

The ornamental design for a conveyor chain link, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a conveyor chain link showing our new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a right side elevational view thereof with the opposite side being a mirror image thereof;
FIG. 5 is a bottom plan view thereof; and,
FIG. 6 is a front elevational view thereof.



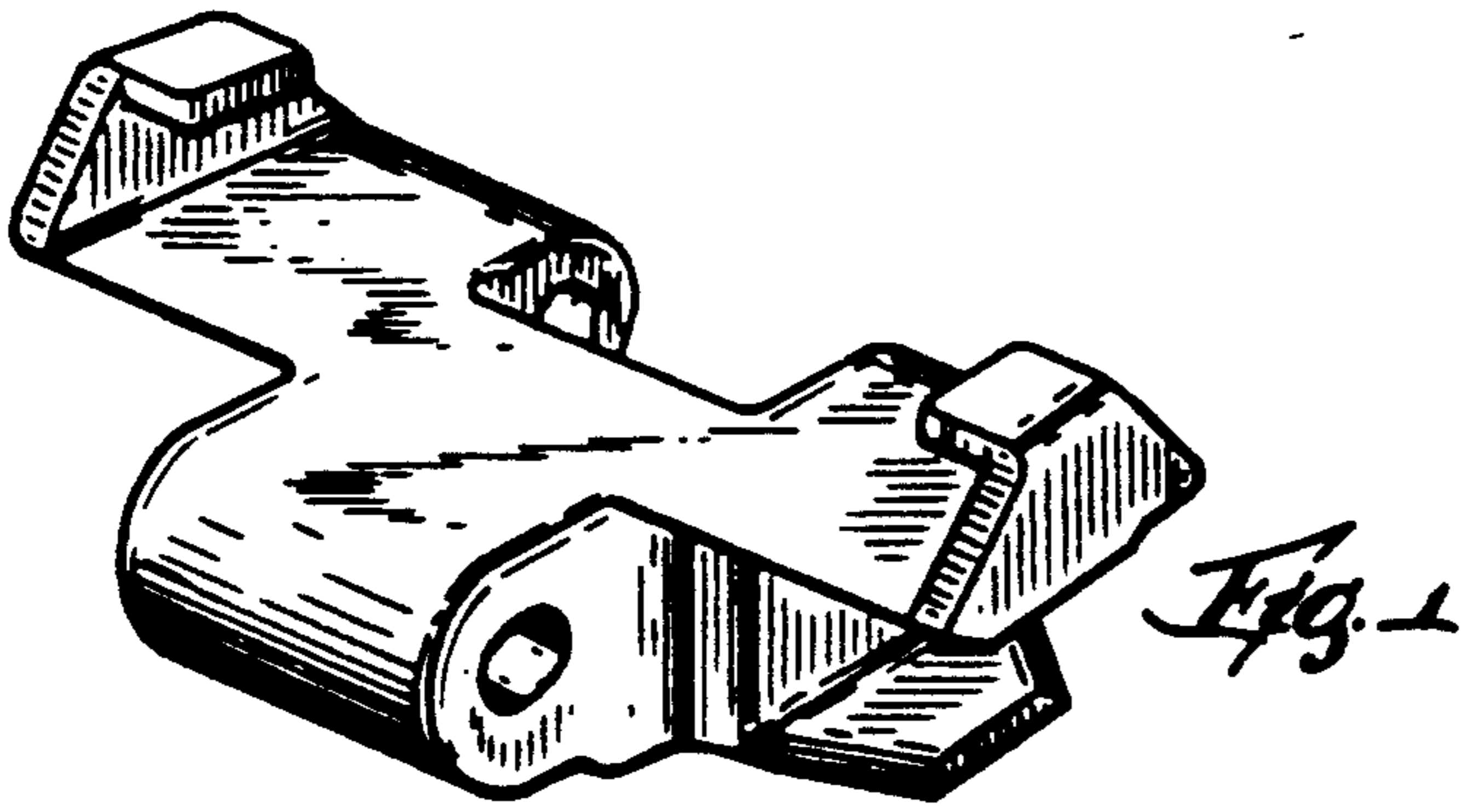

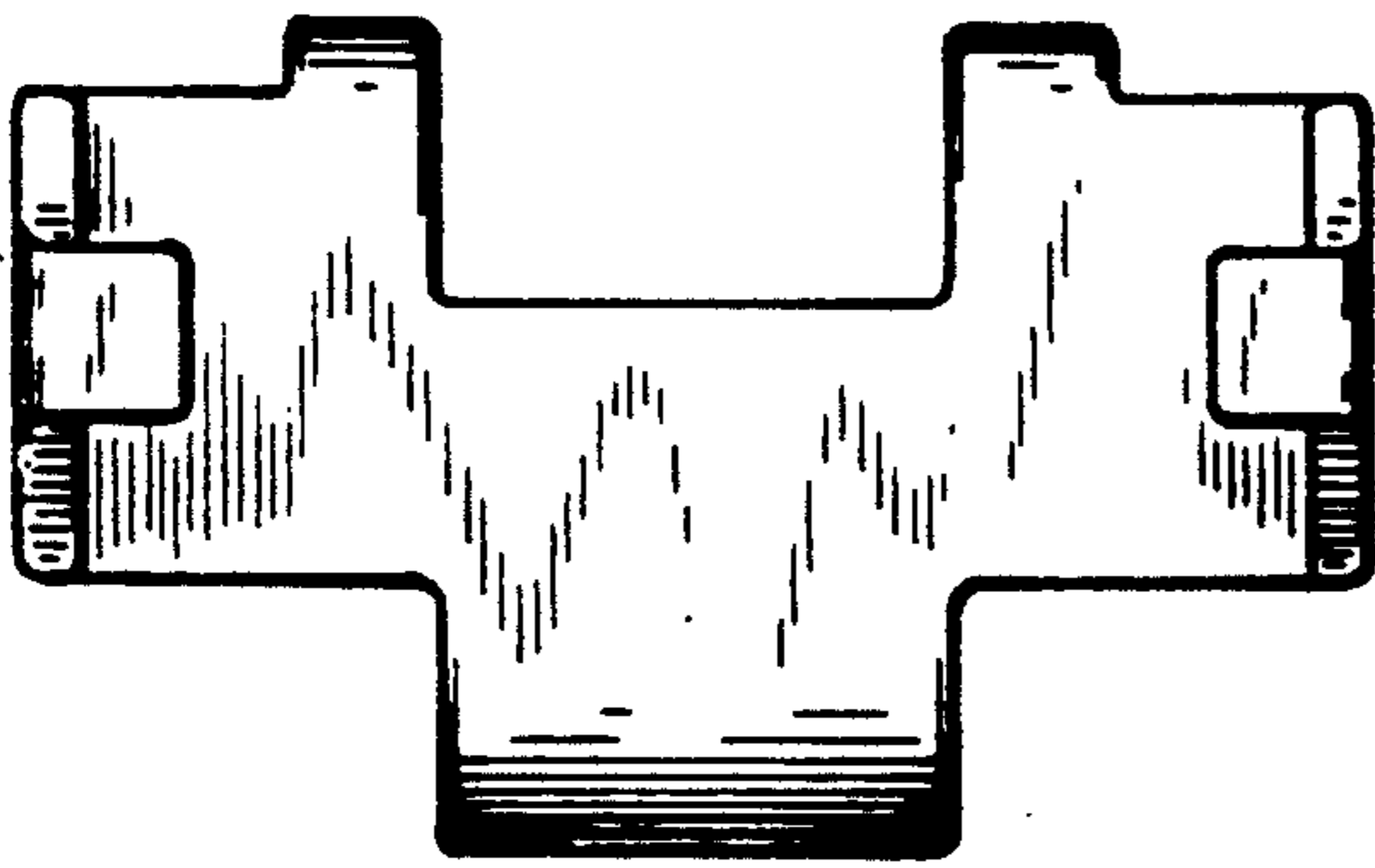

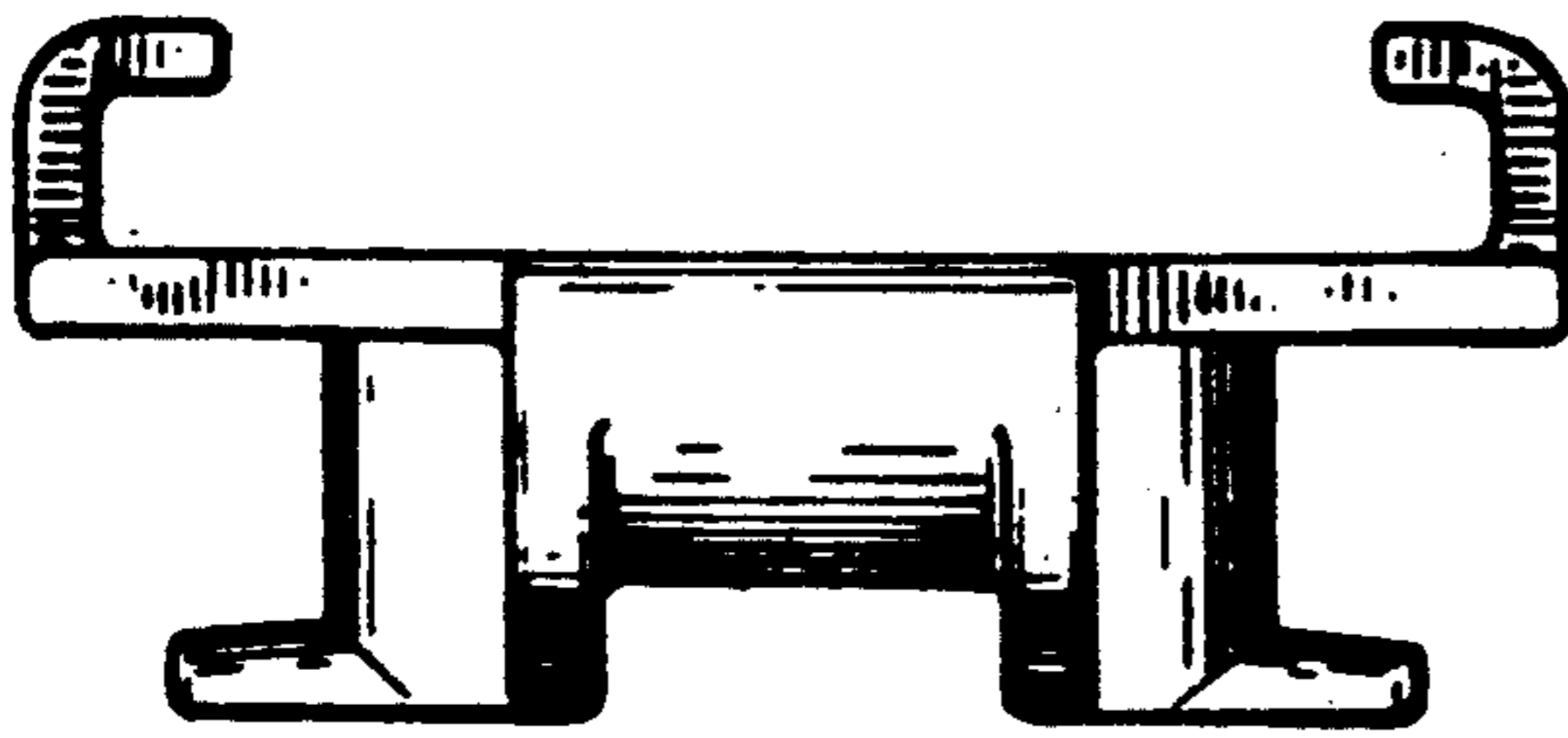

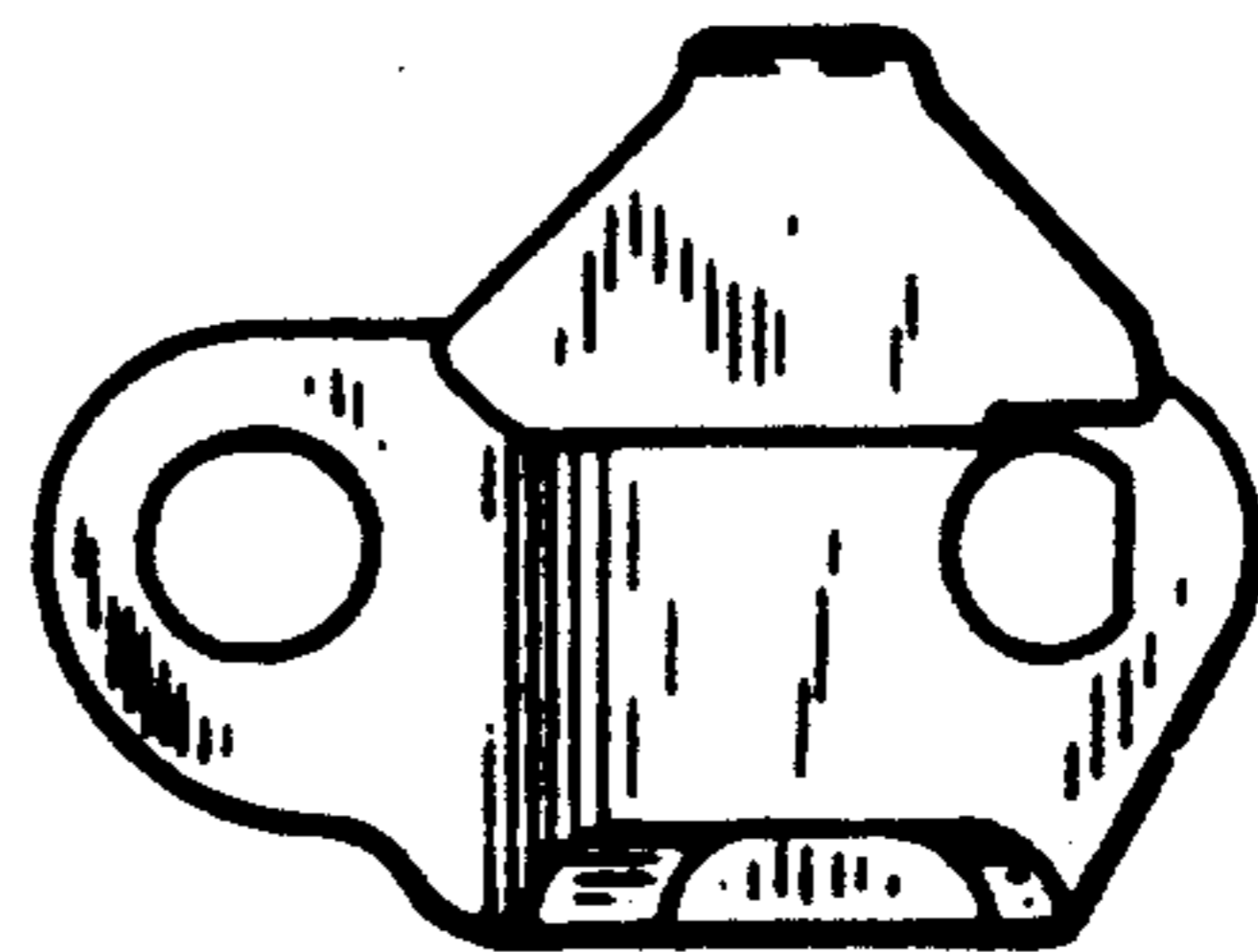

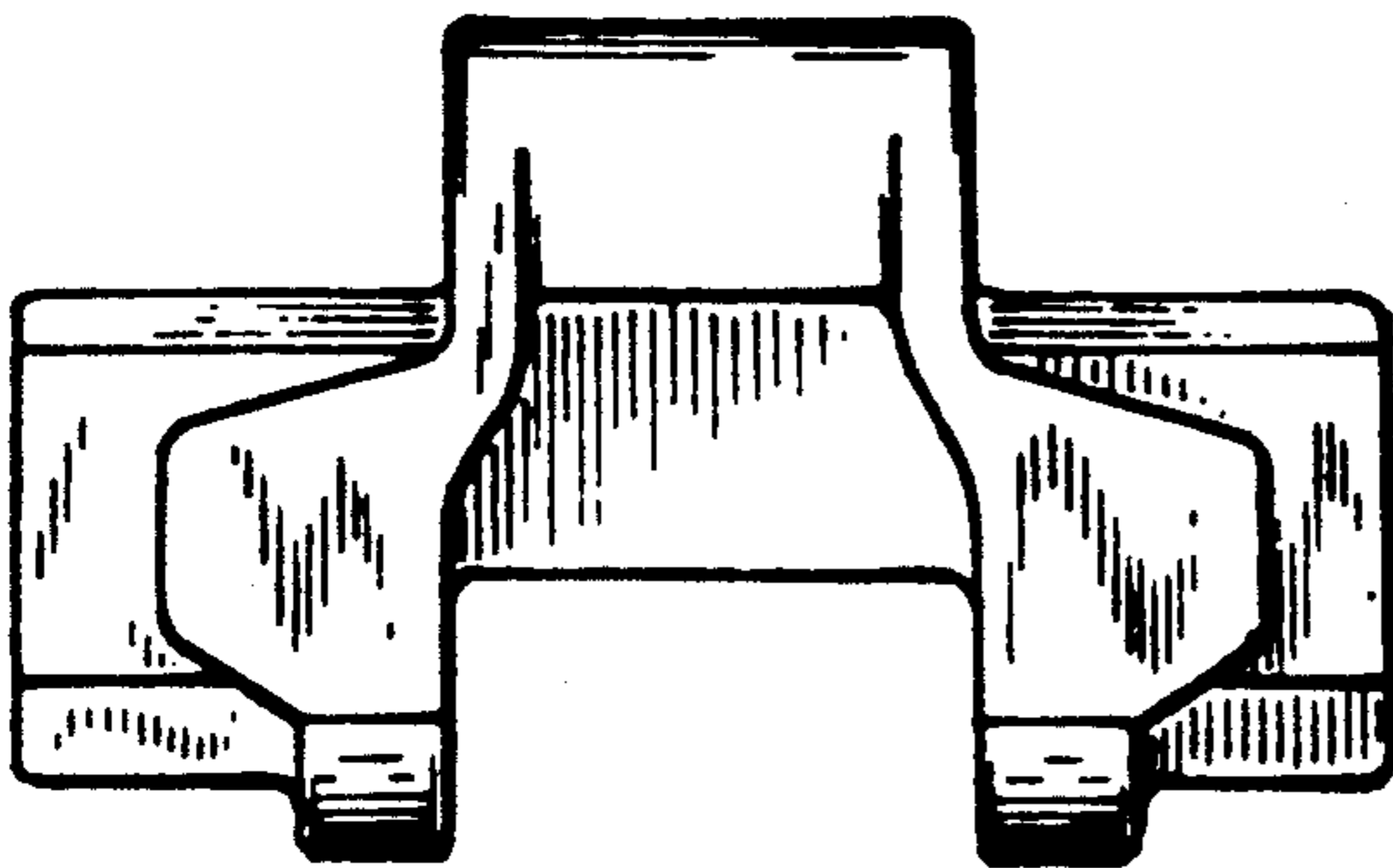

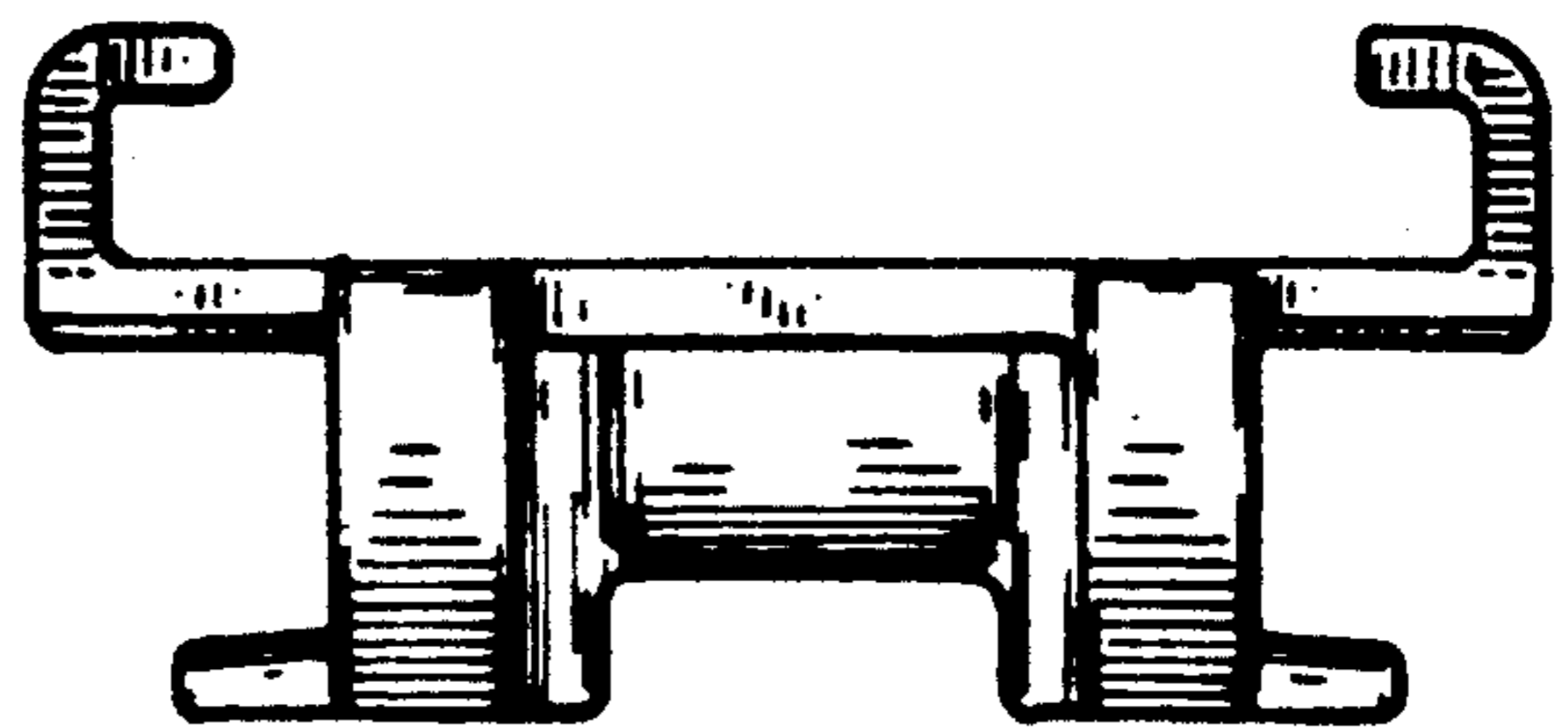
