[57] CLAIM

The ornamental design for a combined crayon dispenser and sharpener holder, as shown and described.

DESCRIPTION

FIG. 1 is a left perspective view of a combined crayon dispenser and sharpener holder showing my new design;
FIG. 2 is a right perspective view thereof; the flap being shown partially open;
FIG. 3 is a left side elevational view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a front elevational view thereof; and,
FIG. 8 is a rear elevational view thereof.

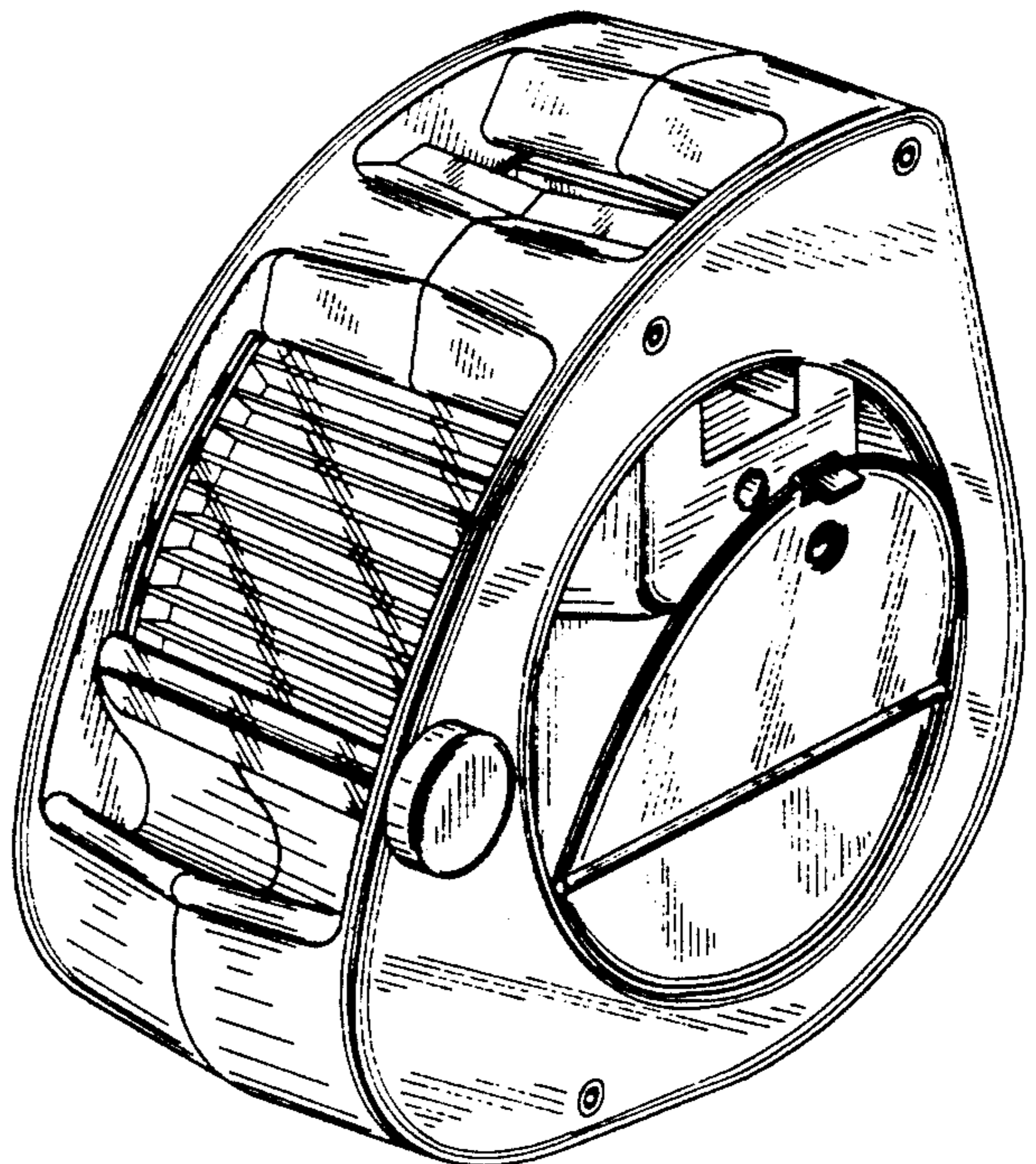
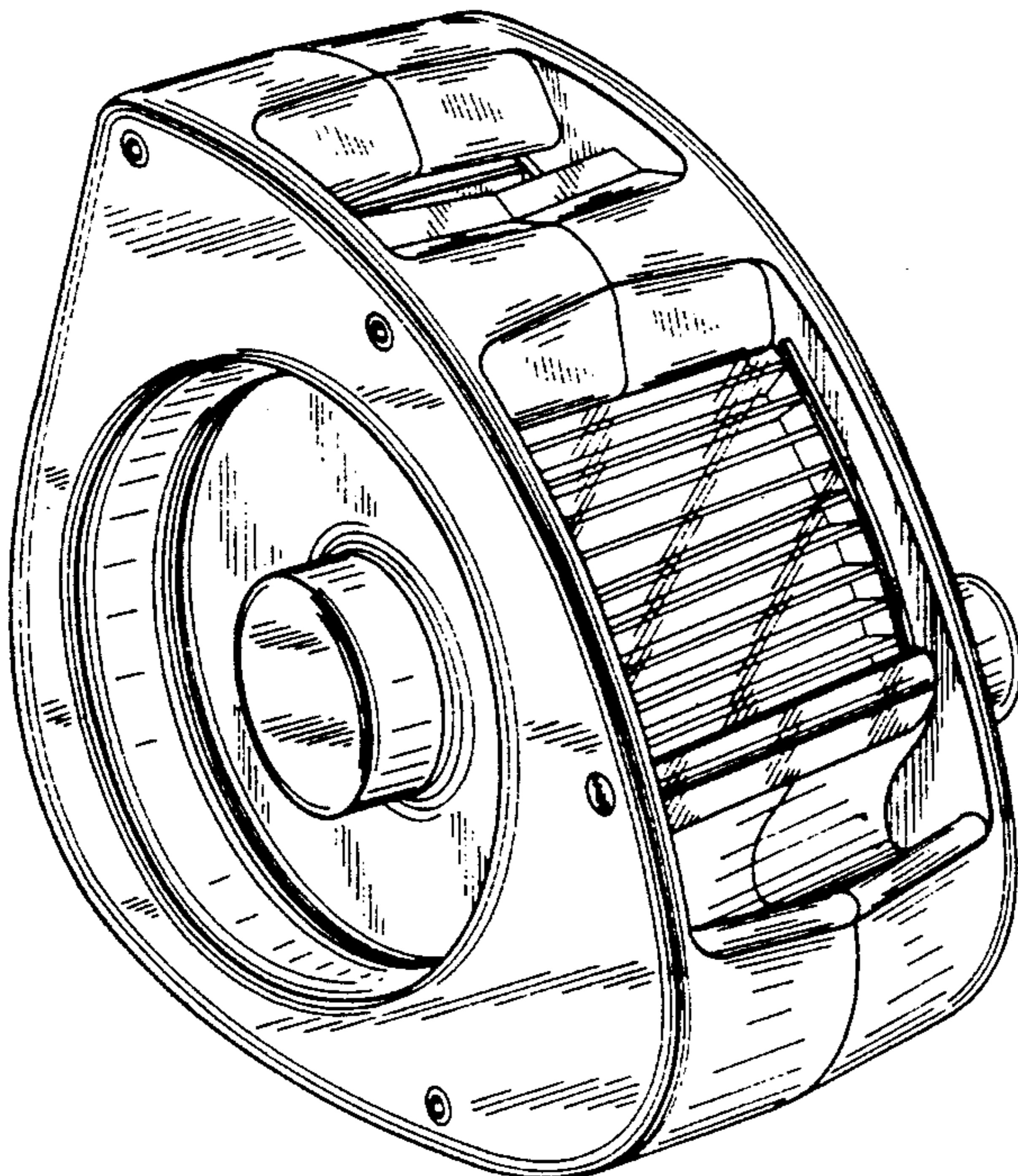

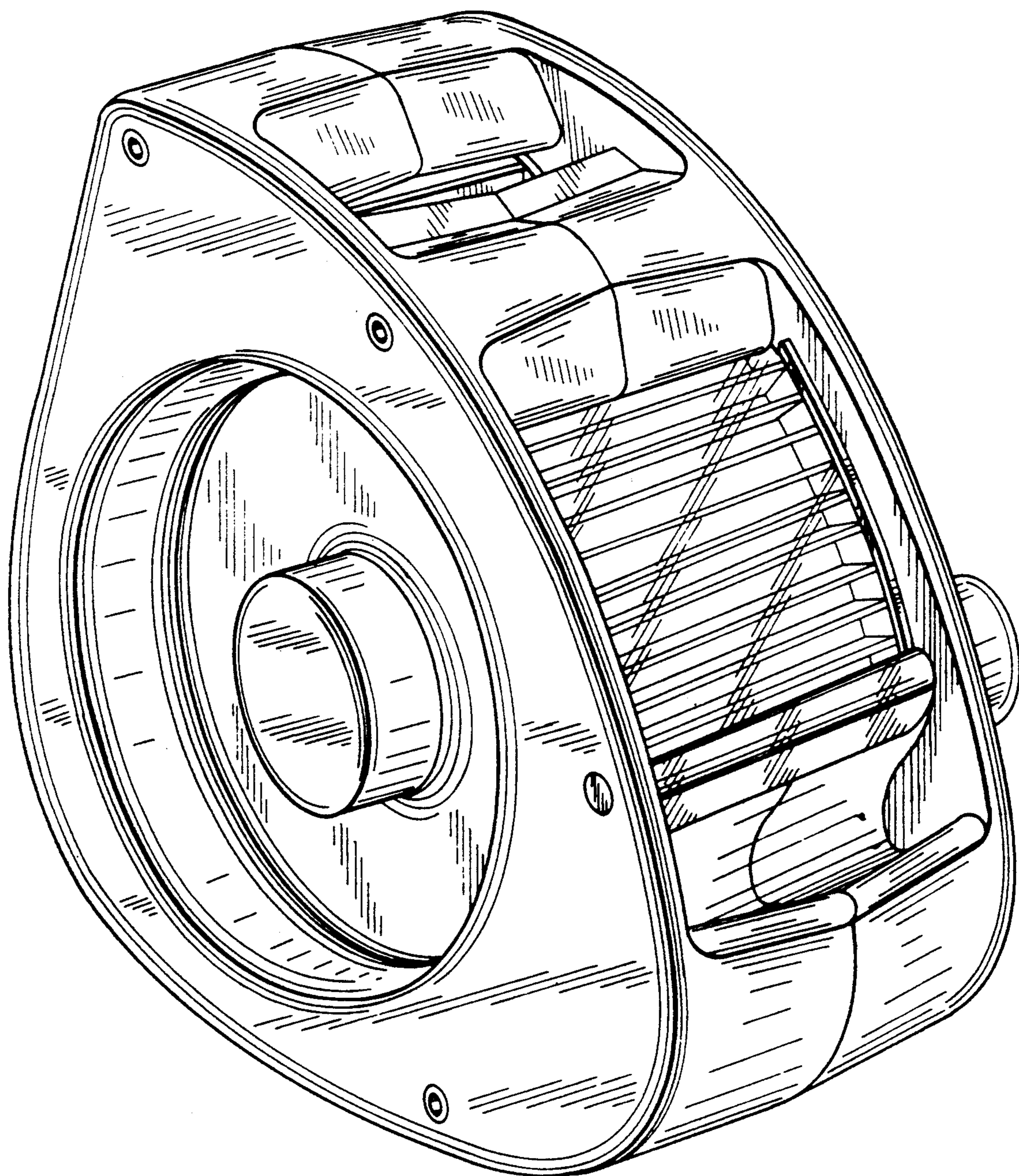

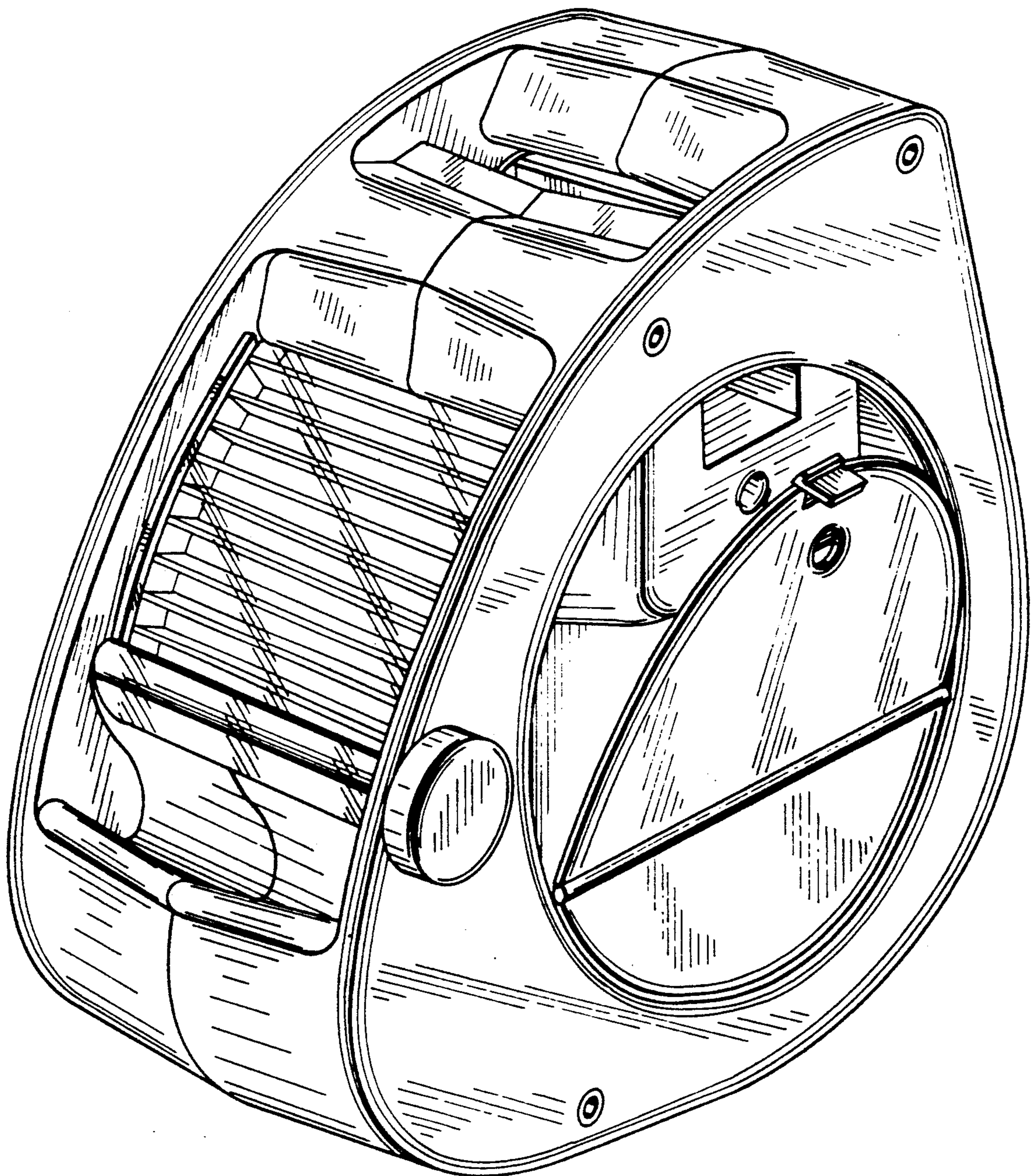

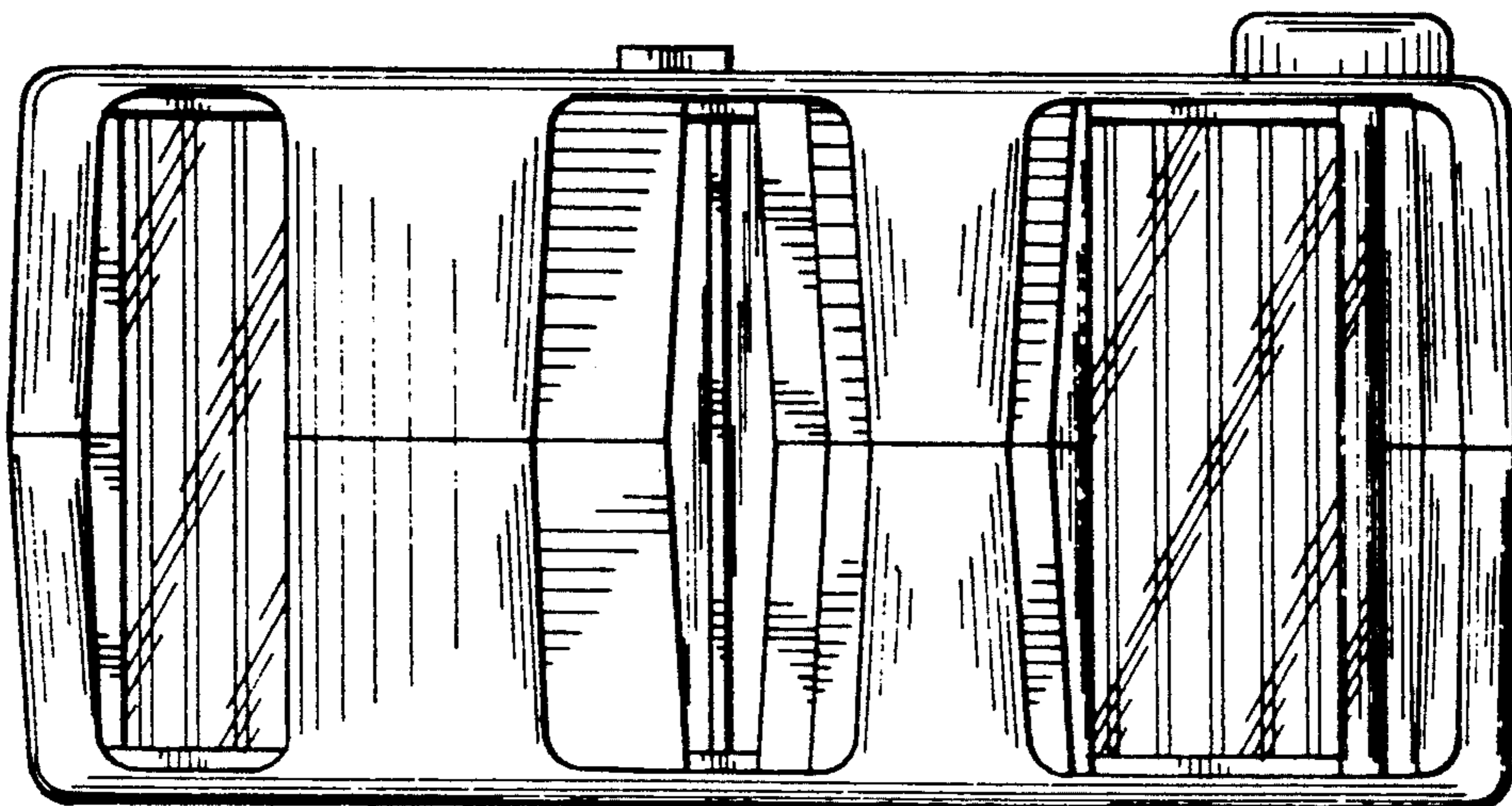
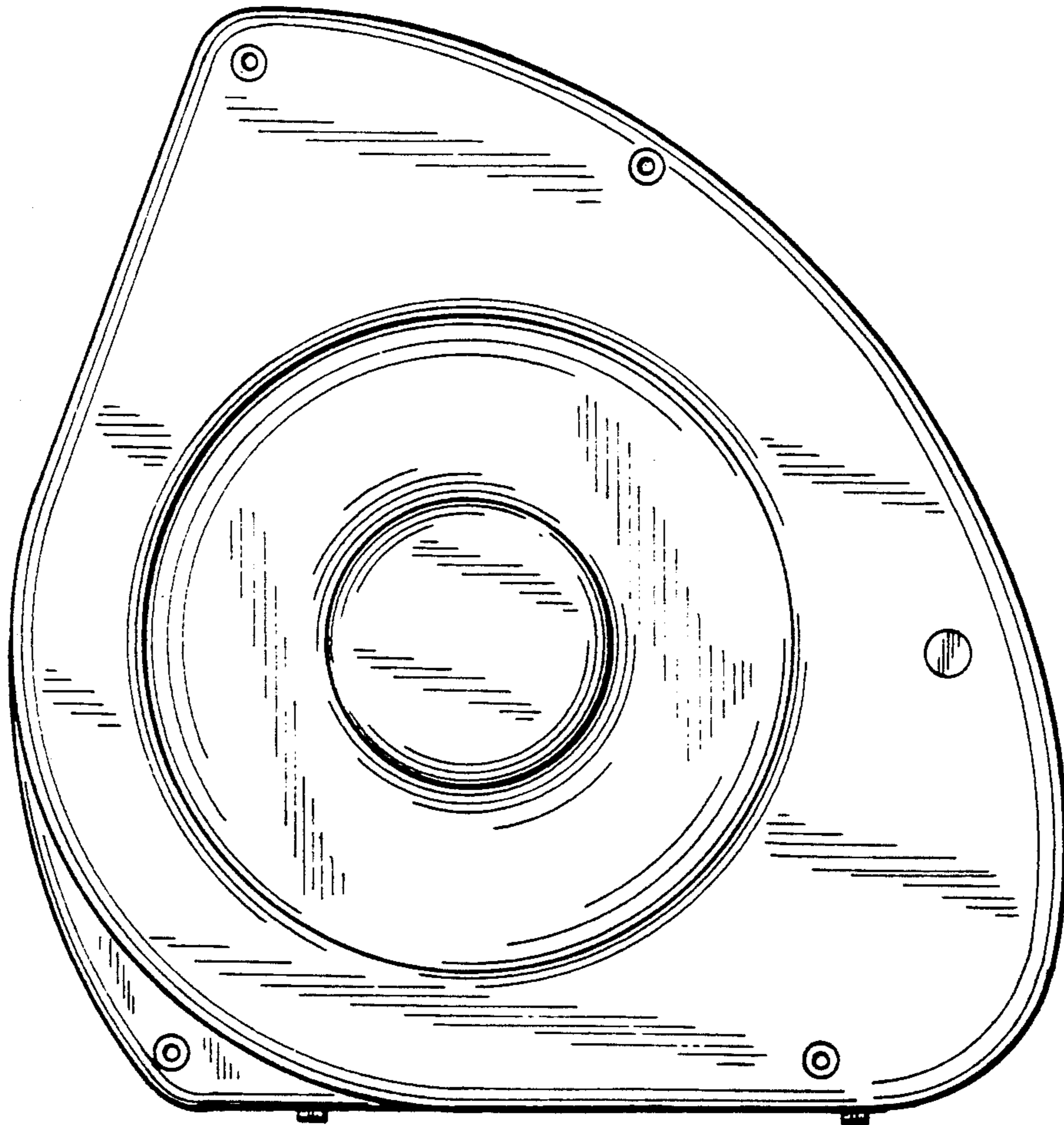

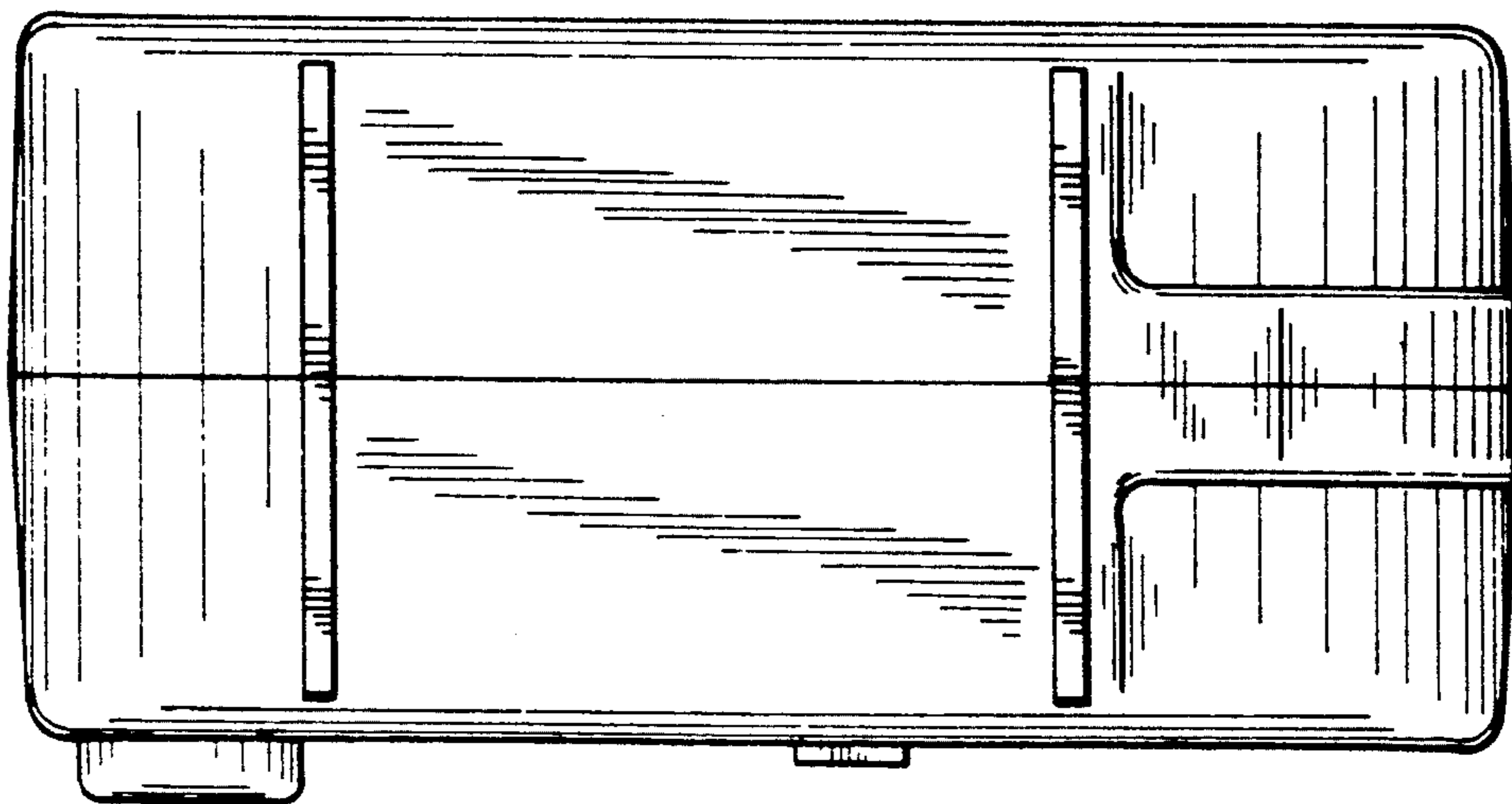
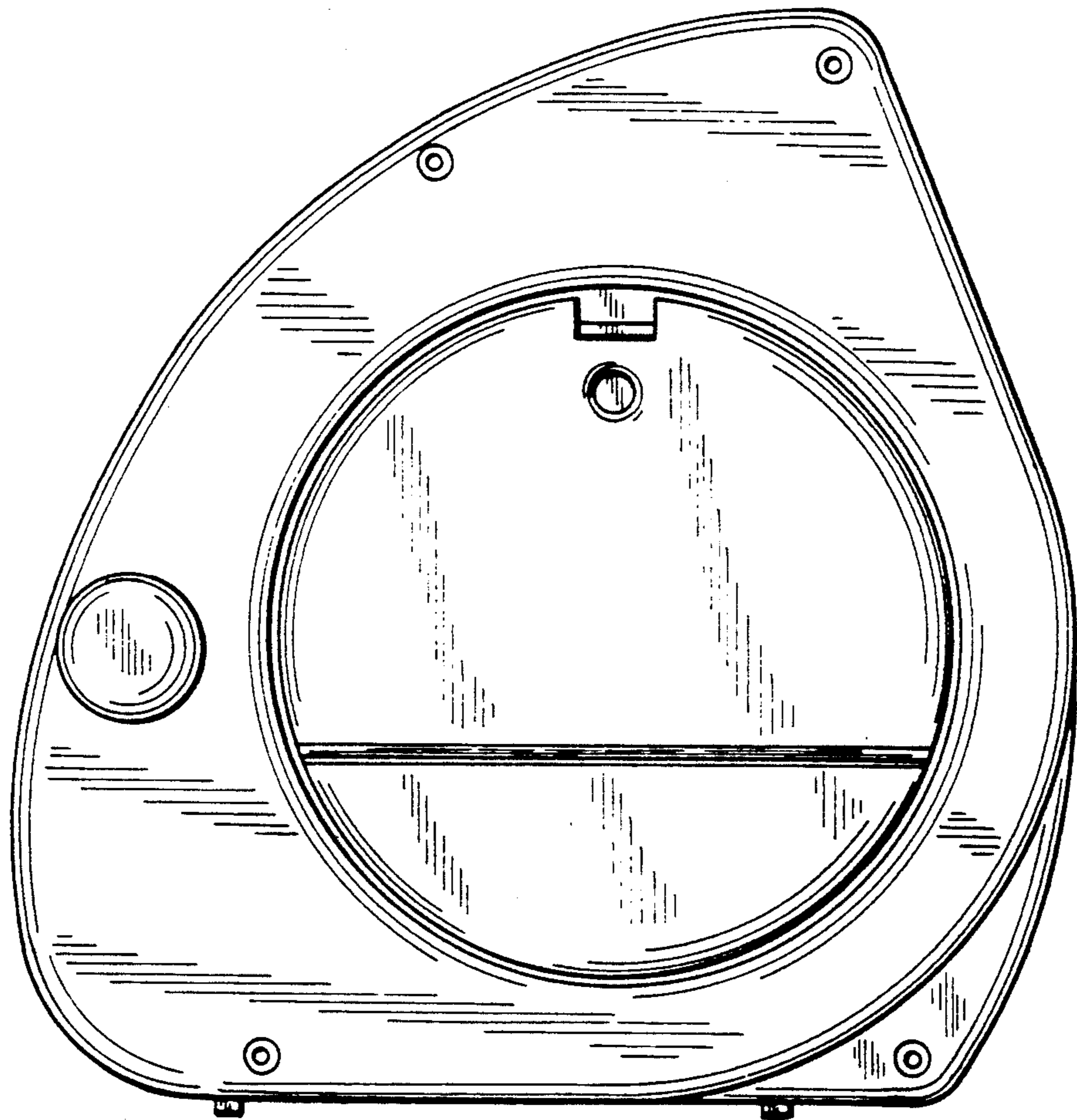

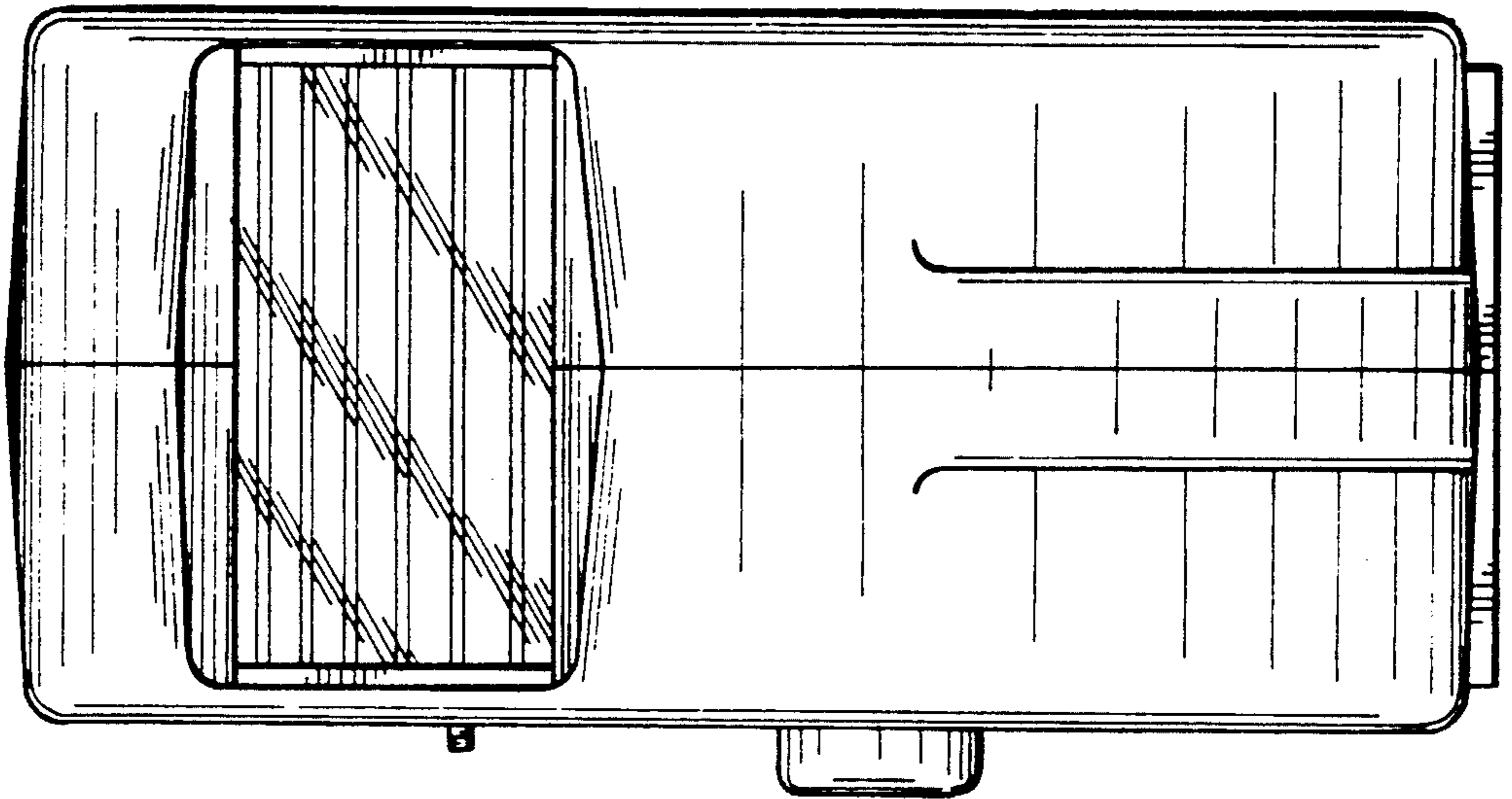
