## DESCRIPTION

FIG. 1 is a top, front, left perspective view of a no spill drinking vessel showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a front elevational view, the rear elevation view and left and right side elevational views, being mirror images thereof;

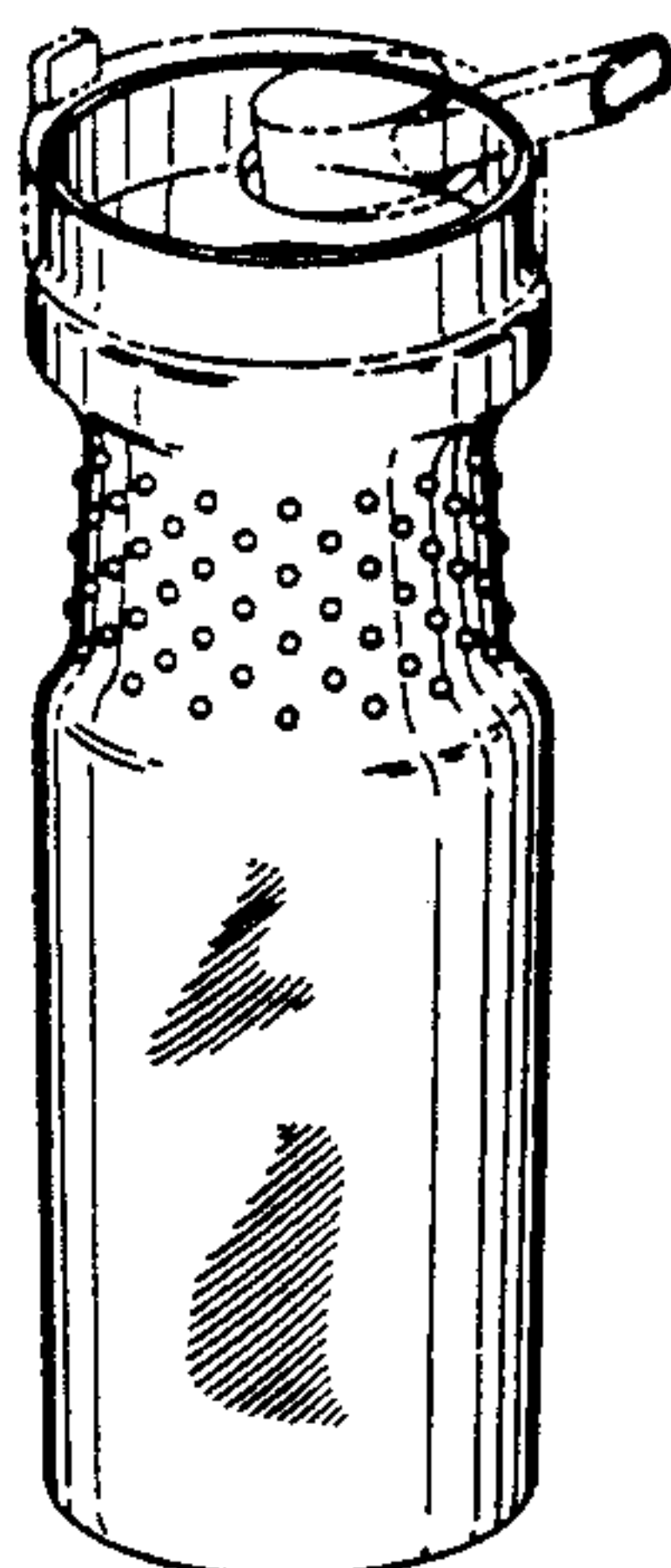
FIG. 5 is a top, front, left perspective view of a no spill drinking vessel showing a second embodiment of my new design;

The broken line showing of a lid in FIG. 1 is for illustrative purposes only and forms no part of the claimed design.



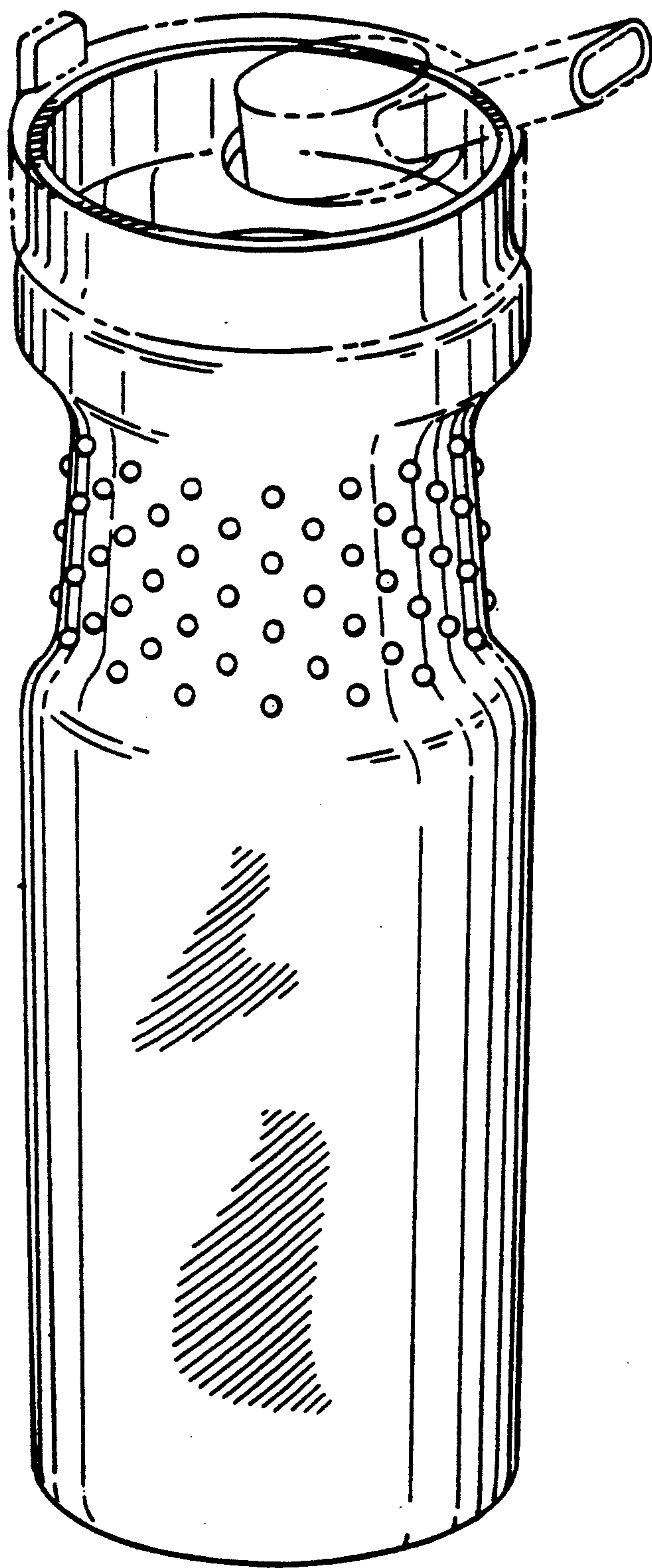
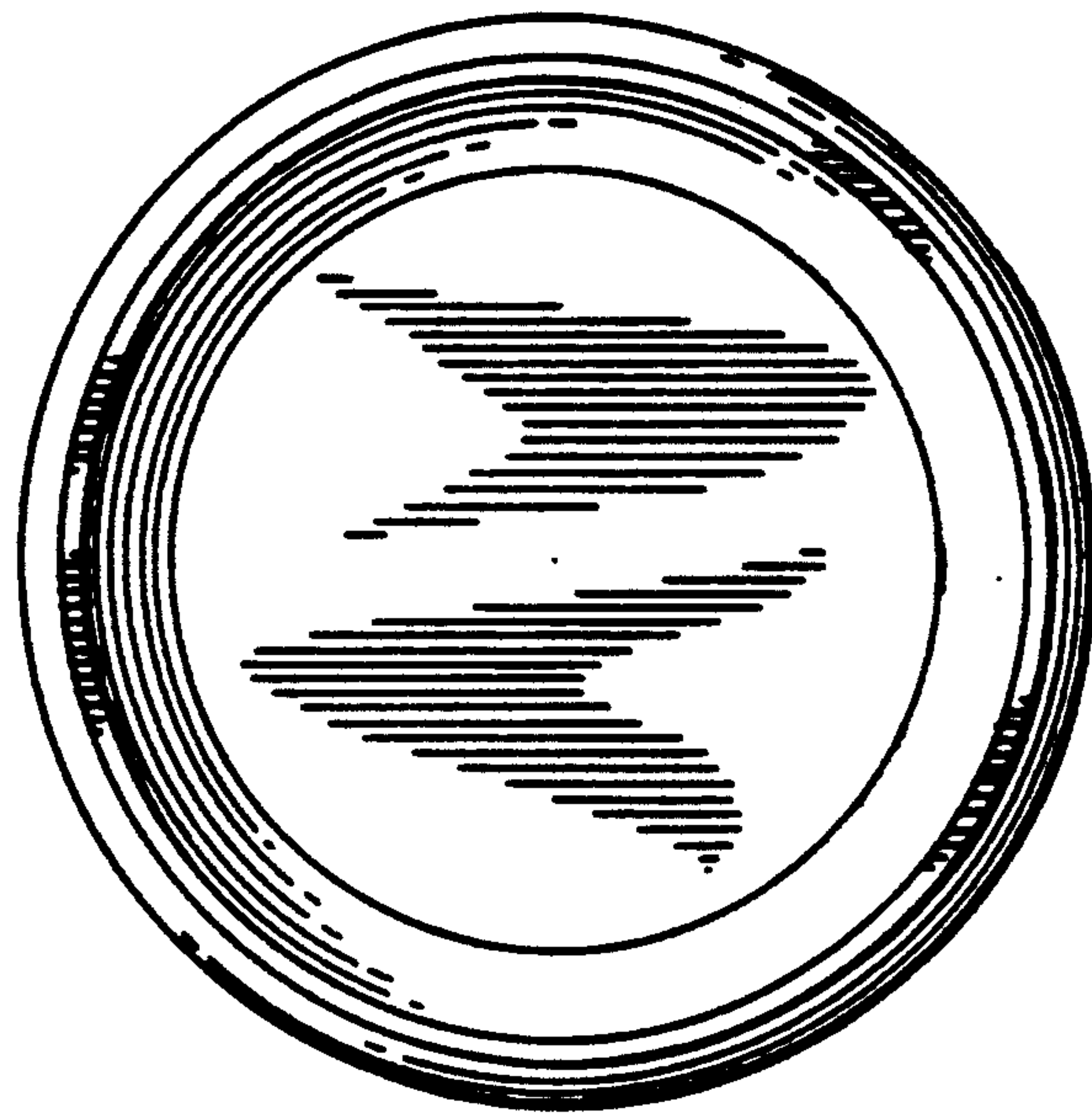
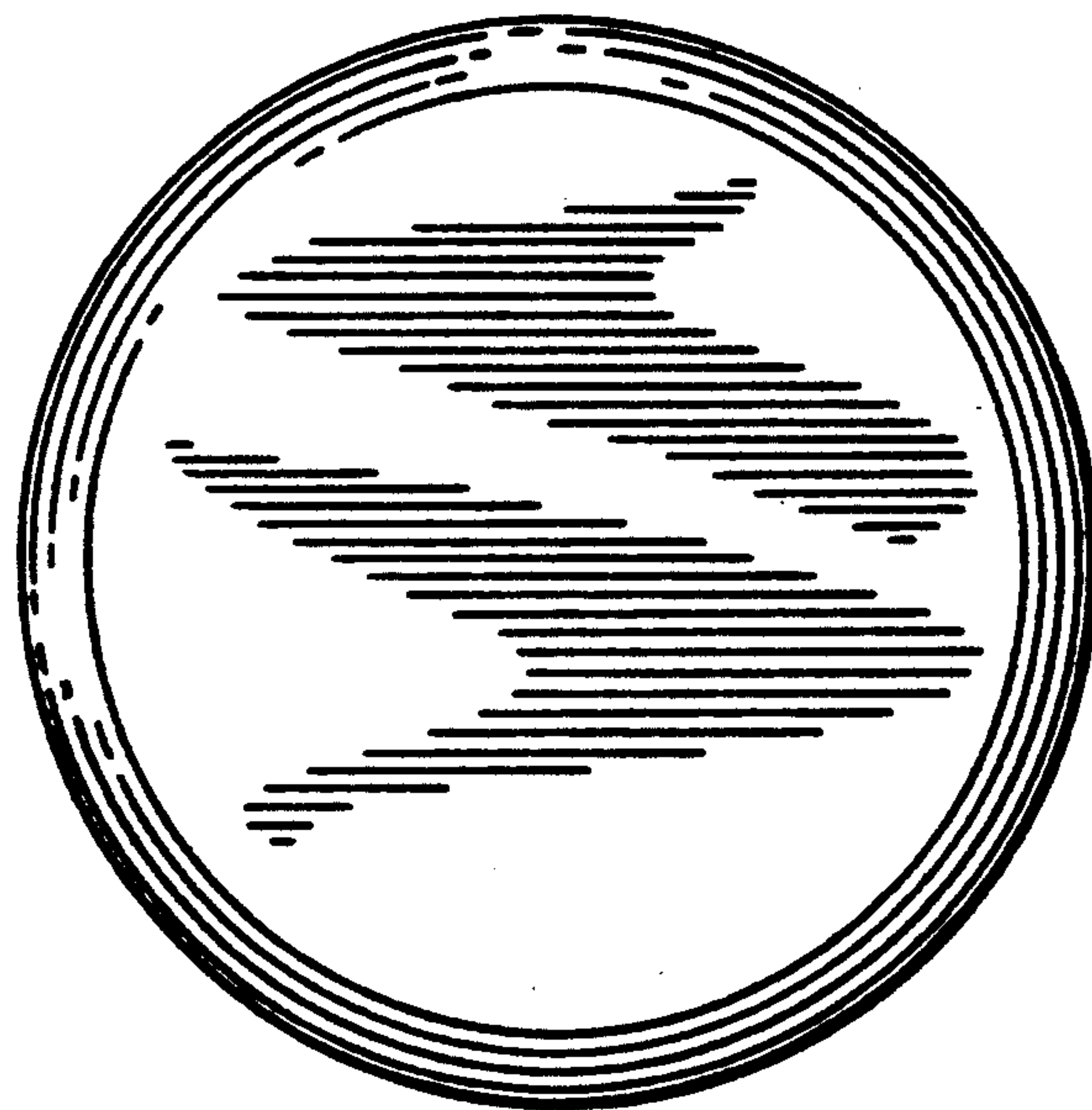

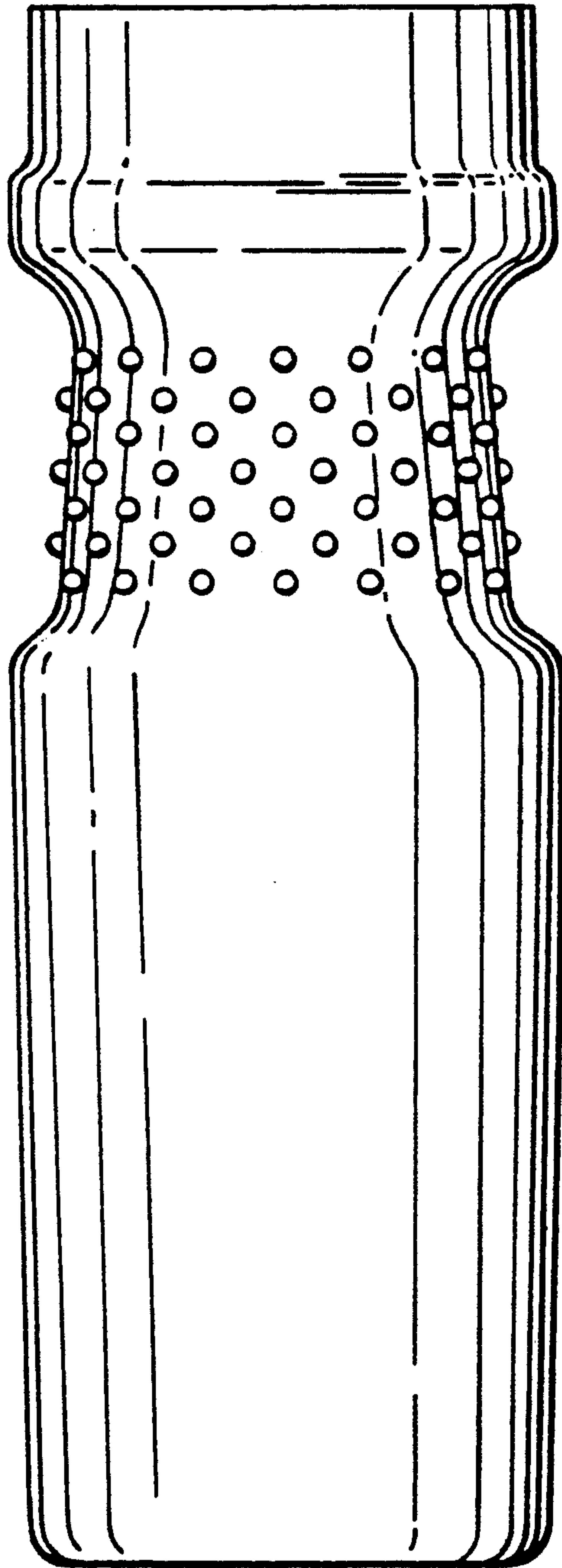

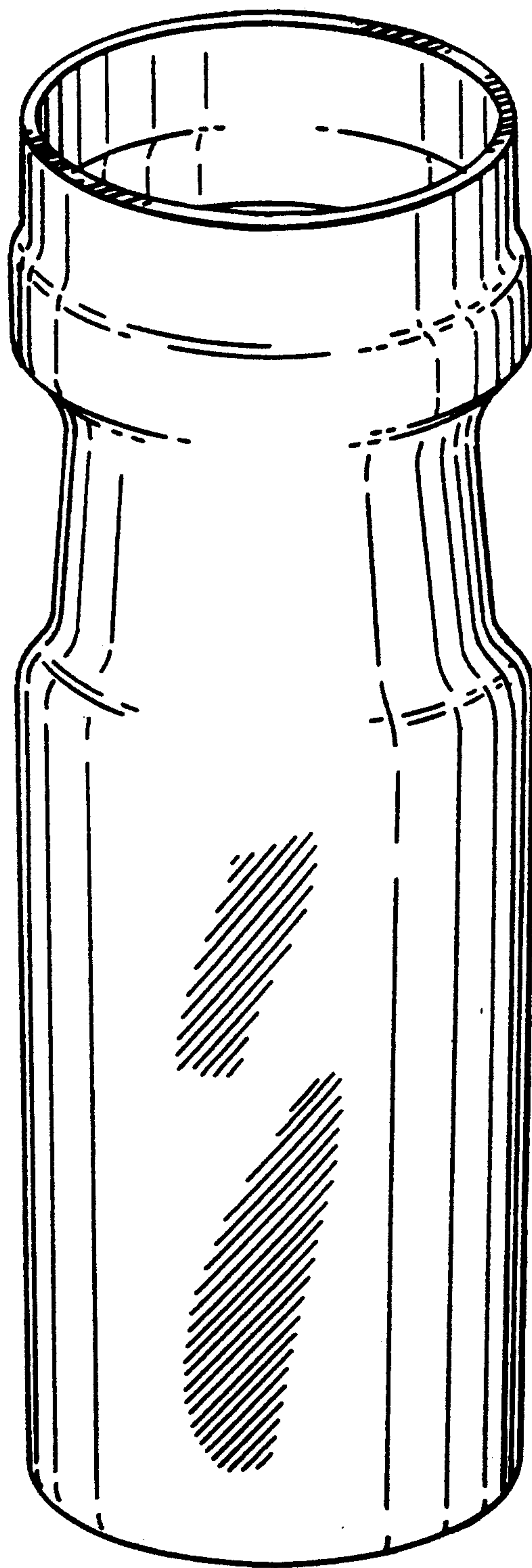

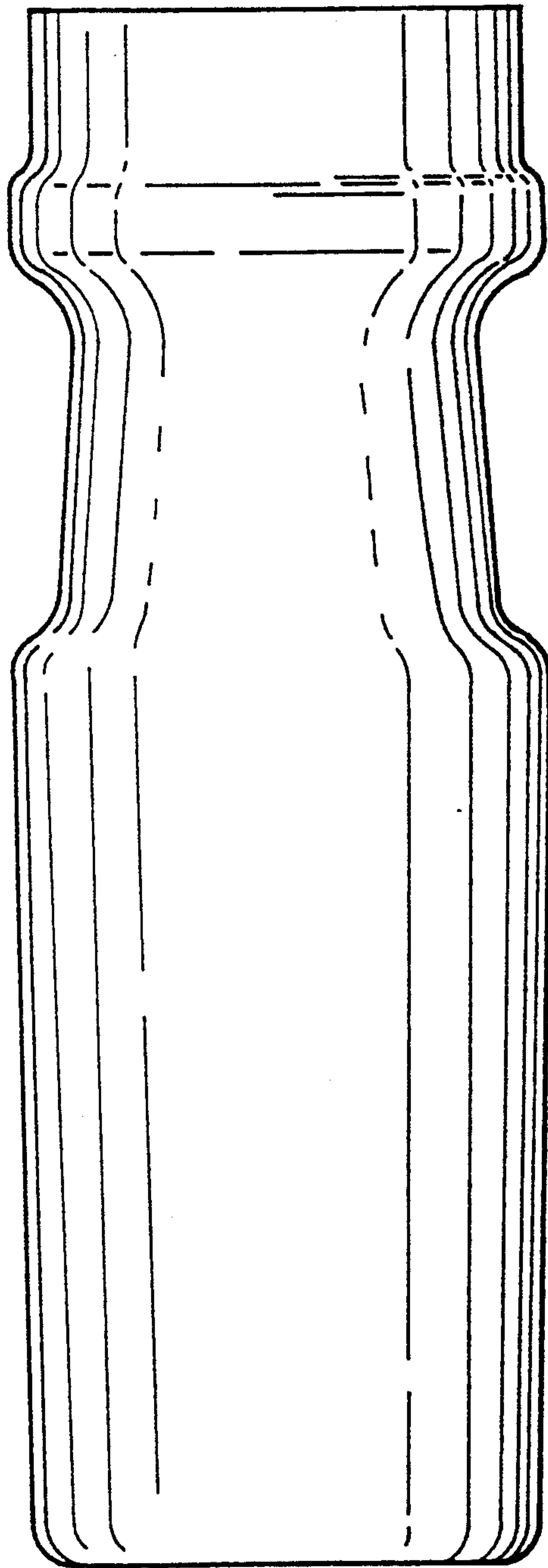




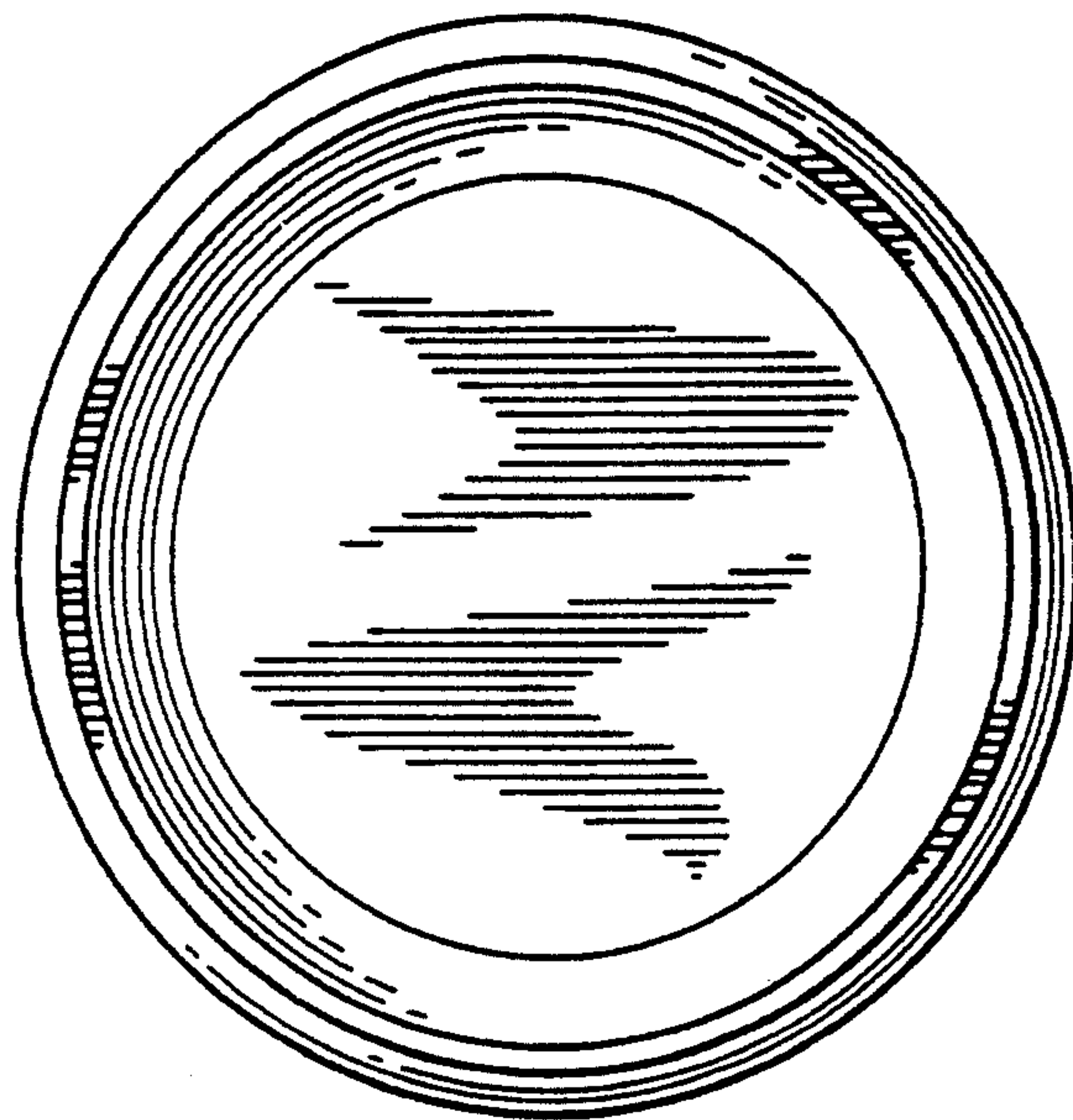

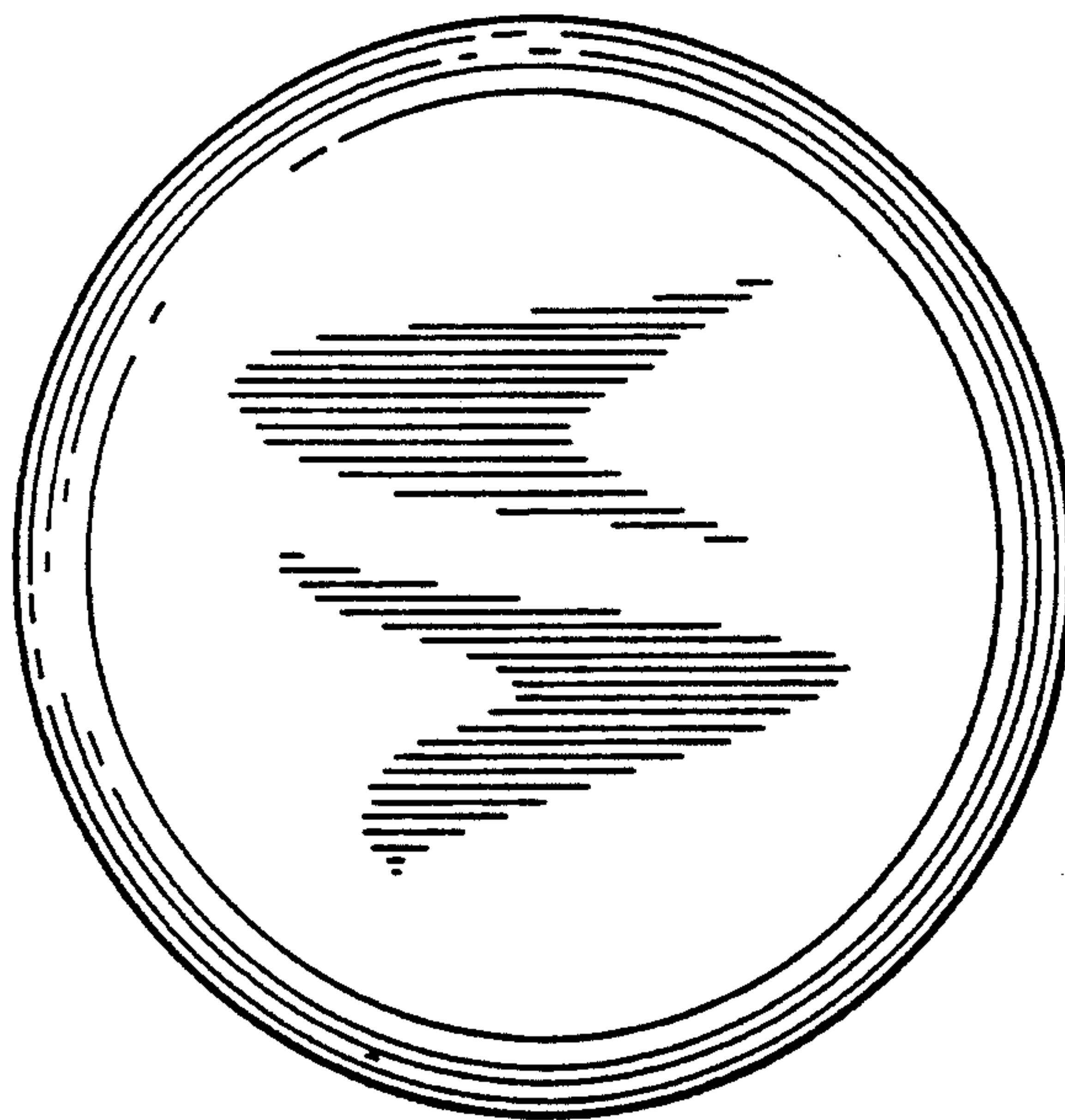
