DESCRIPTION

FIG. 1 is a perspective view of a vial shipping container showing our new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof; the rear elevational view being a mirror image thereof;

FIG. 4 is a left side elevational view thereof; the right side elevational view being a mirror image thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a top plan view of a modified form of FIG. 2; and,

FIG. 7 is a perspective view thereof; with vials shown in broken lines.

The broken line showing of vial in FIG. 7 is for illustrative purpose only and forms no part of the claim.

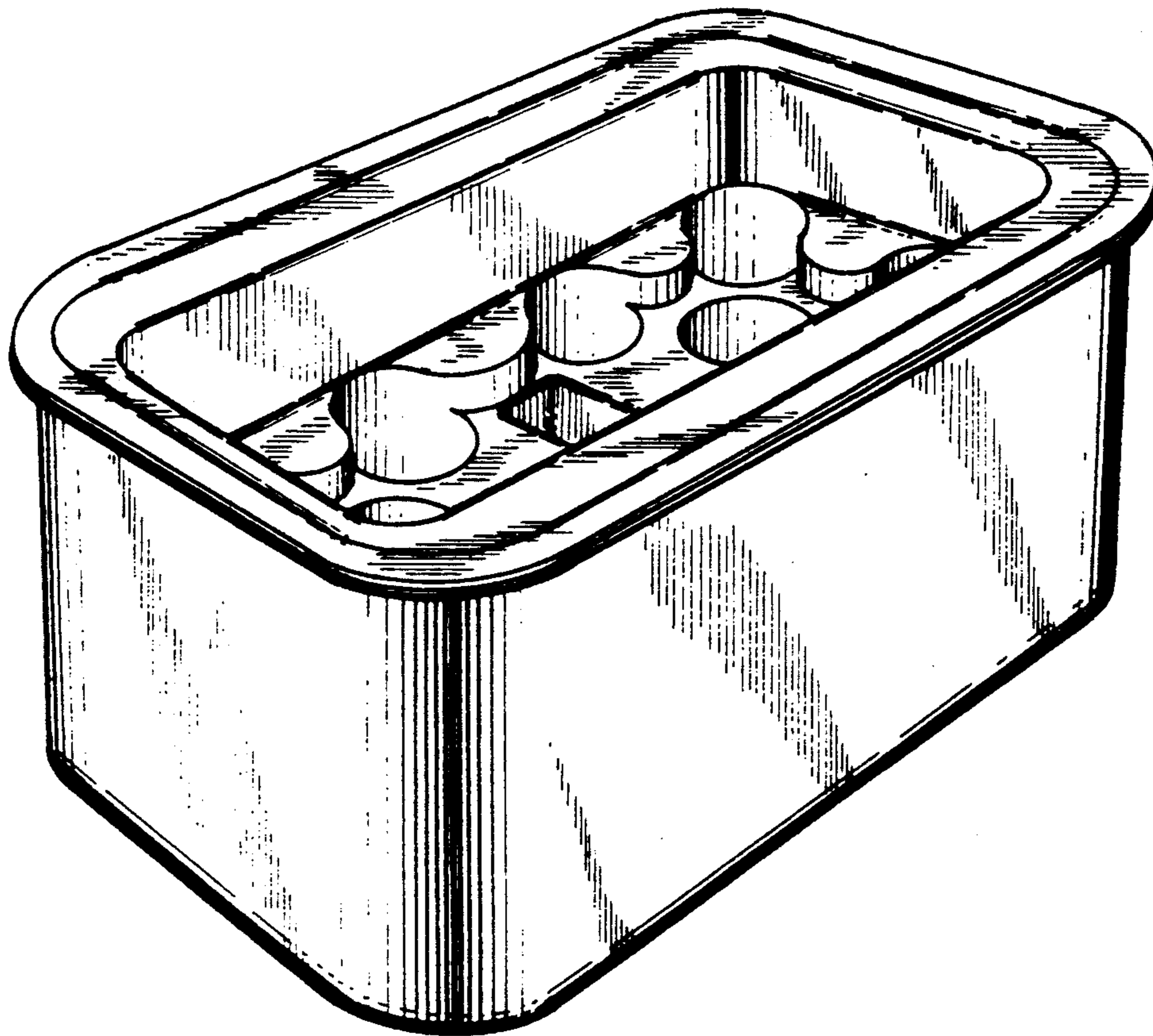

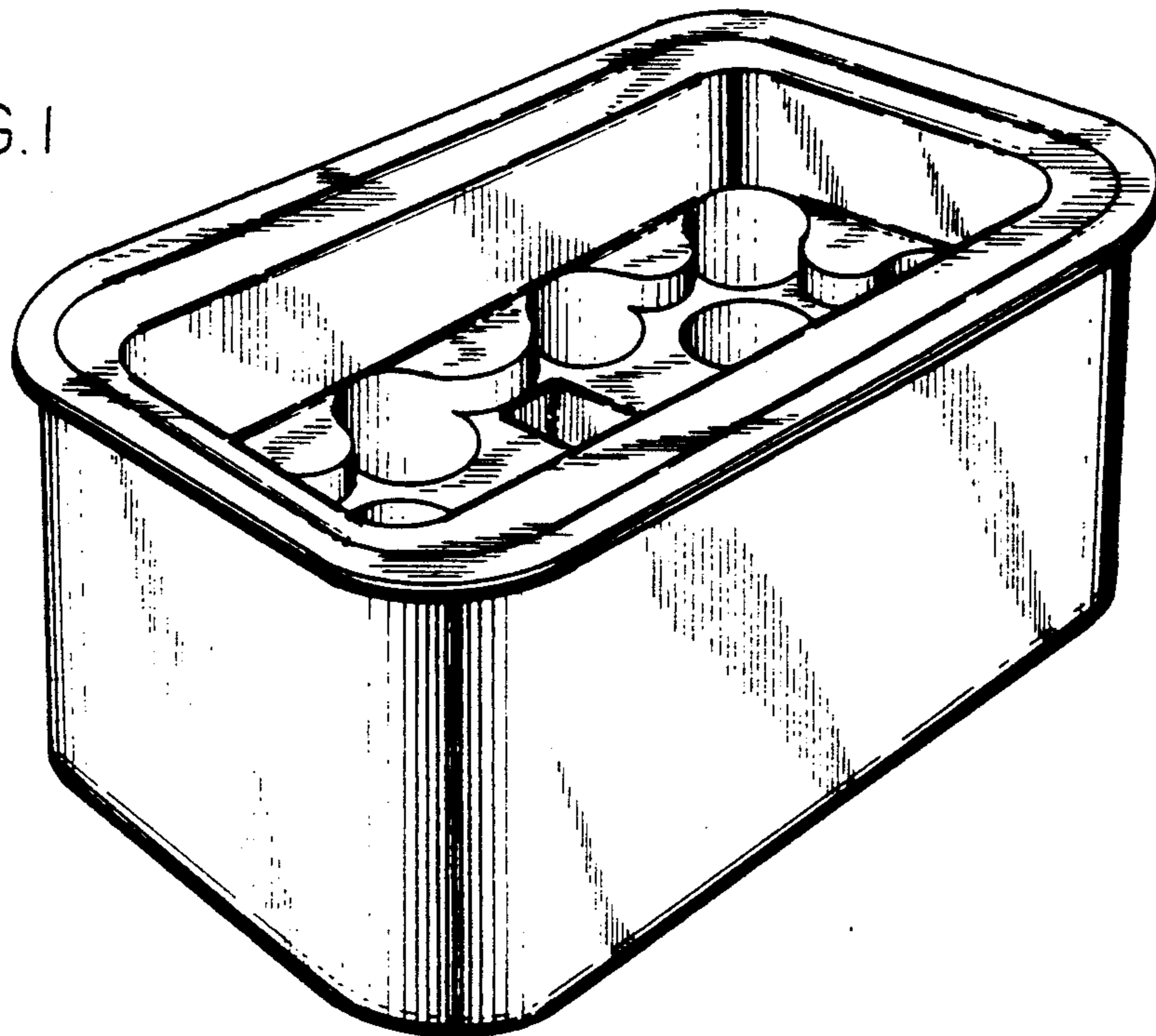

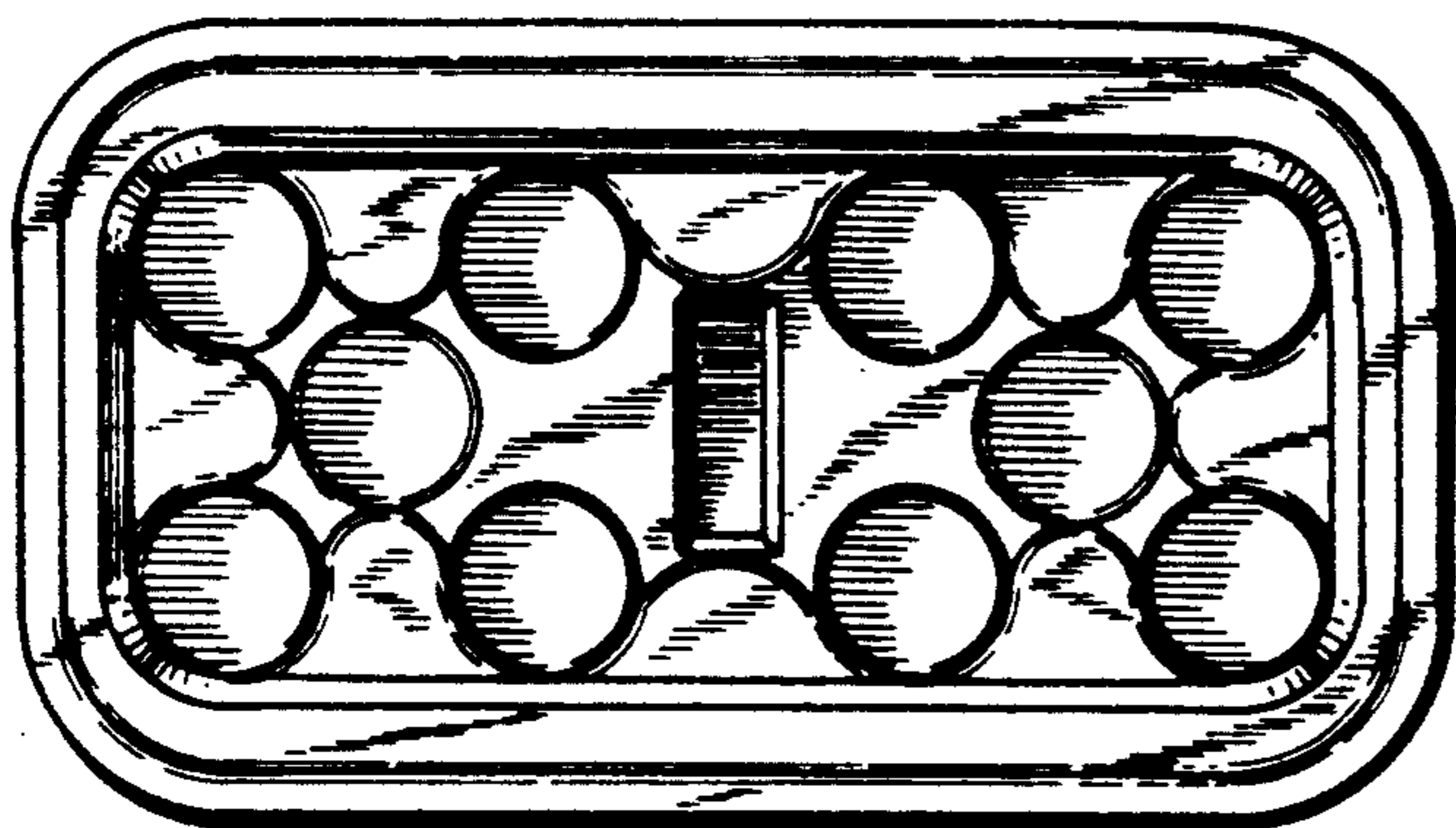

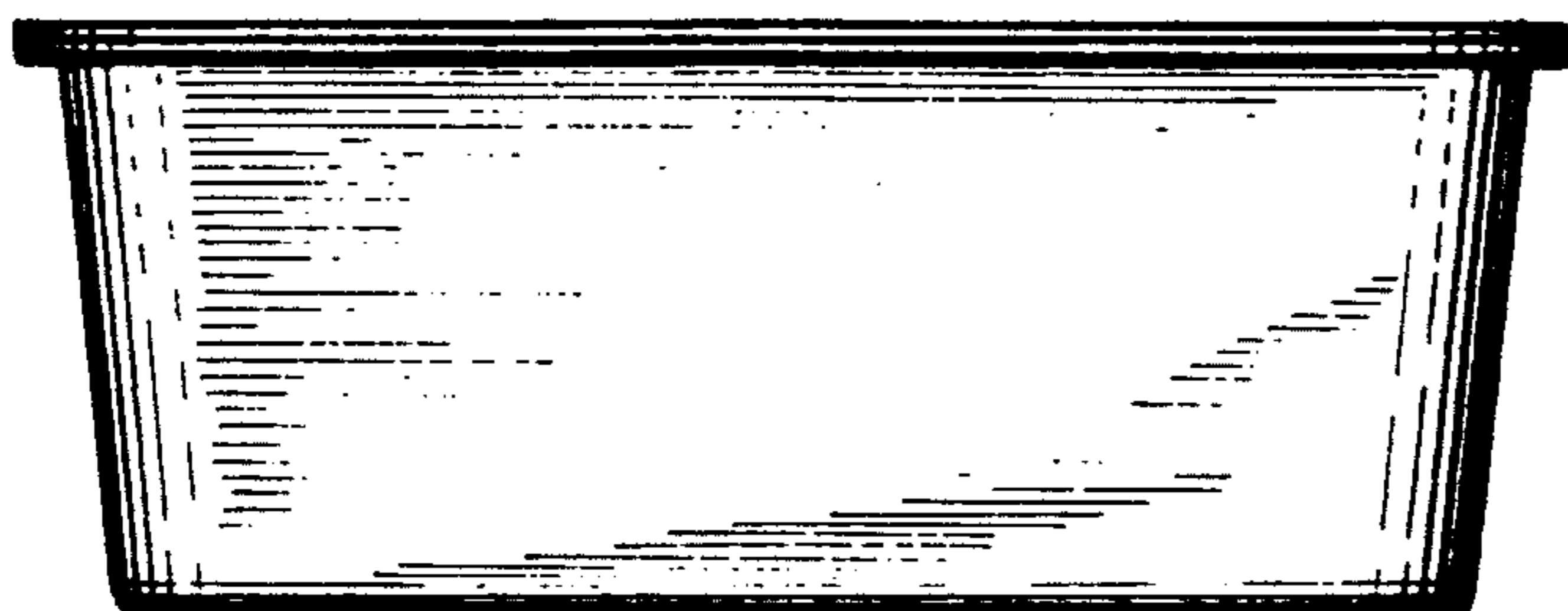

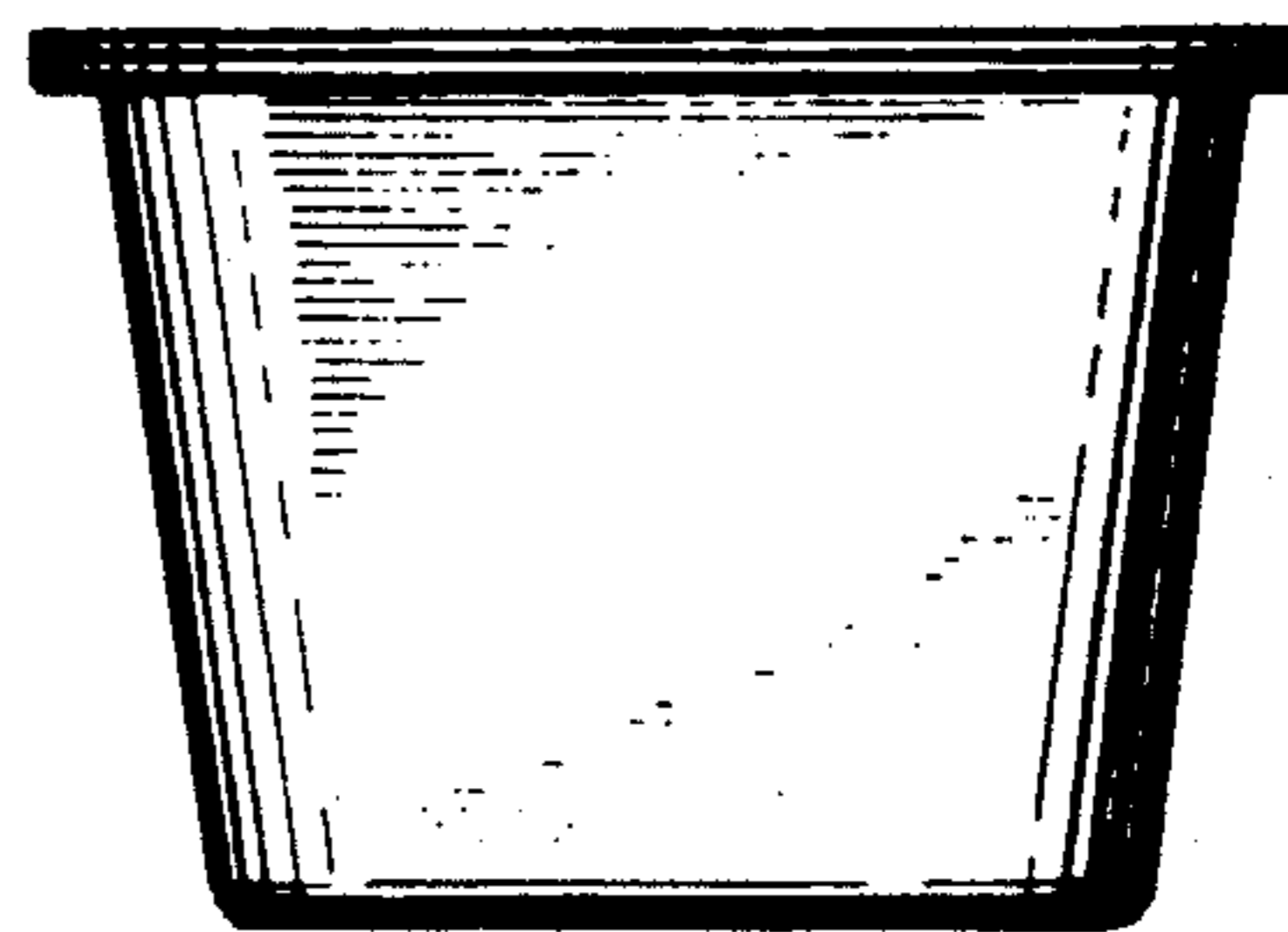

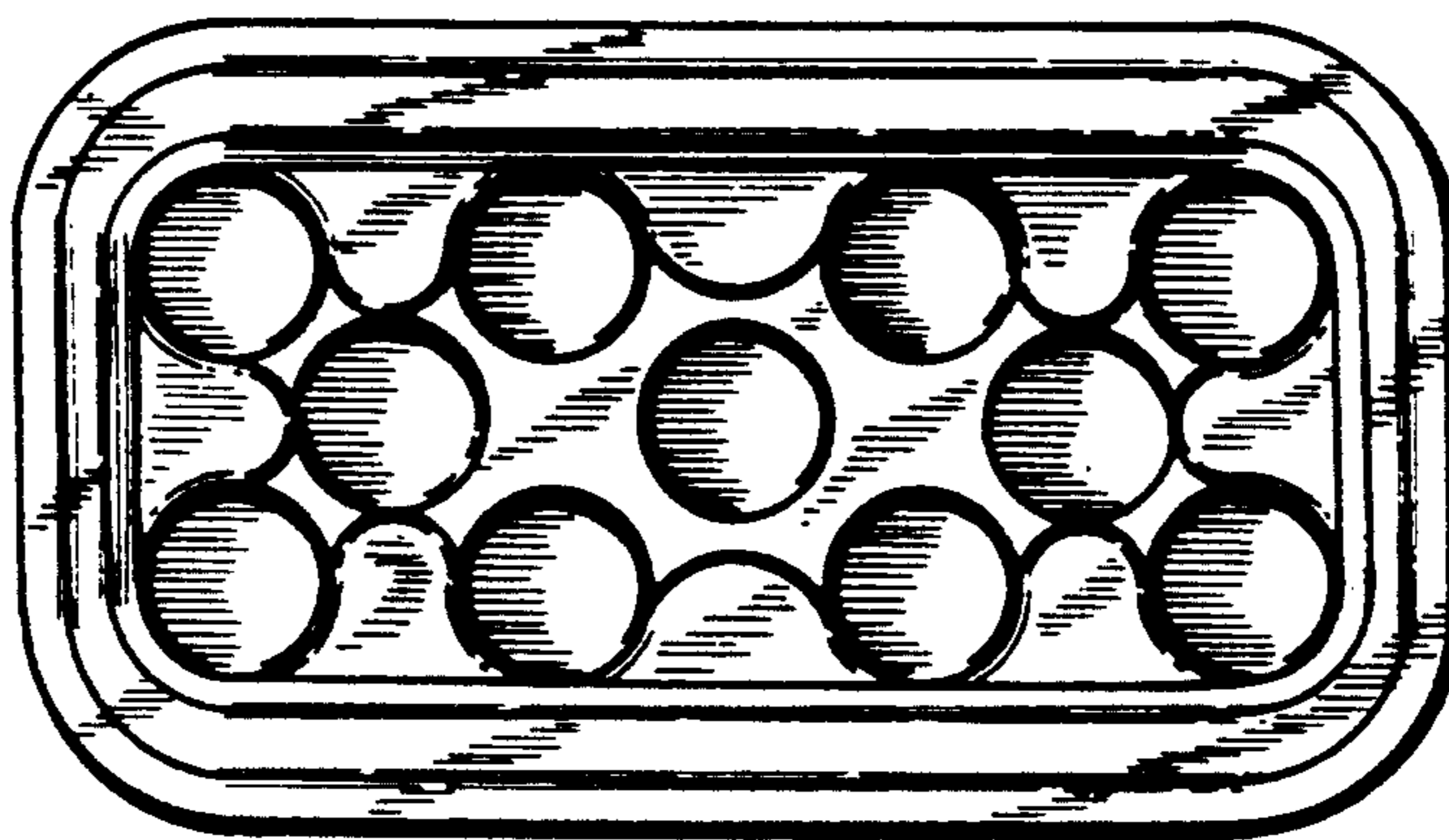
